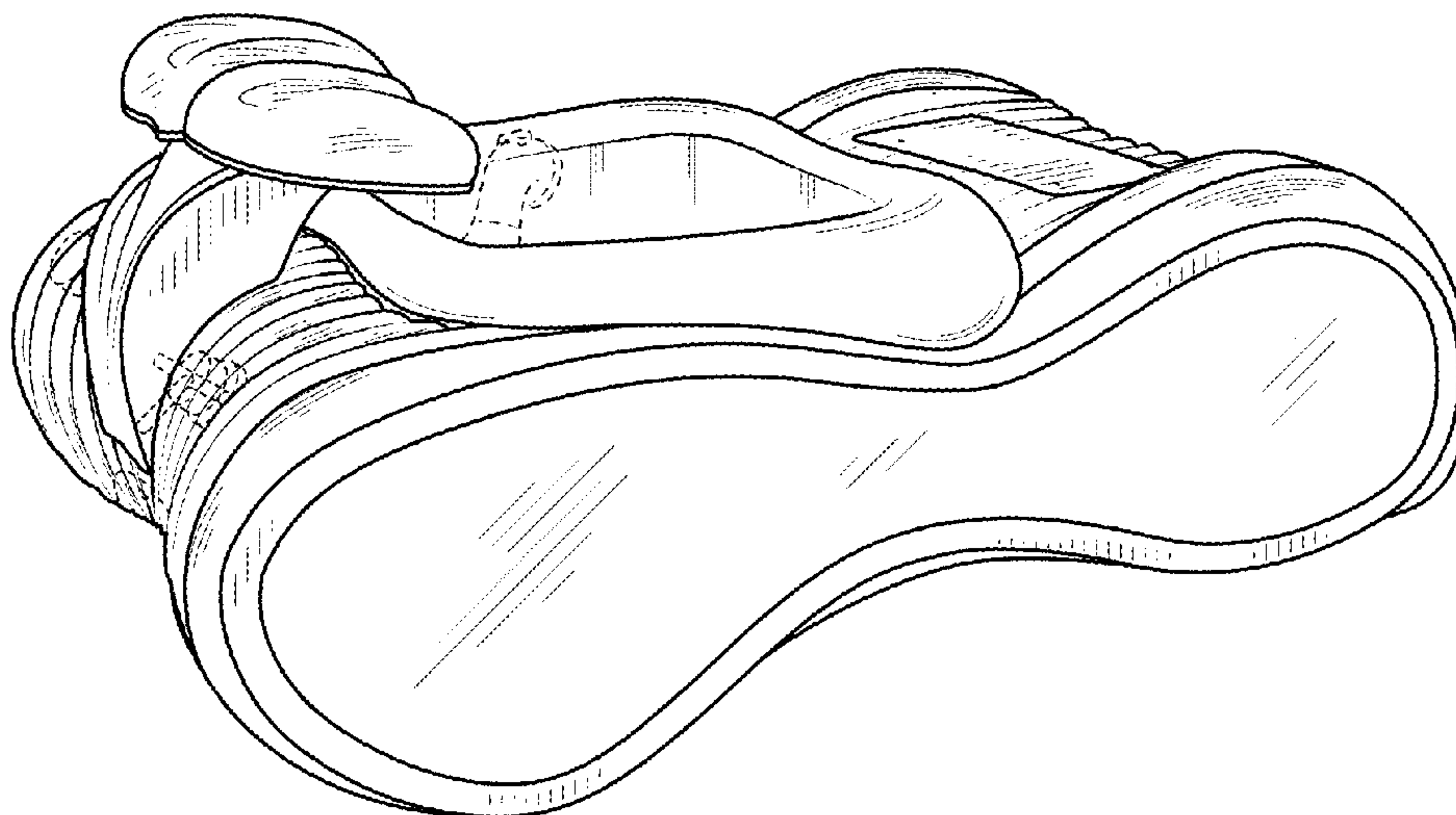
(57) **CLAIM**

The ornamental design for a pedicure spa, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a pedicure spa showing my new design;
FIG. 2 is a left side elevational view thereof;
FIG. 3 is a right side elevational view thereof;
FIG. 4 is a front elevational view thereof;
FIG. 5 is a rear elevational view thereof;
FIG. 6 is a top plan view thereof;
FIG. 7 is a bottom plan view thereof; and,
FIG. 8 is a front perspective environmental view thereof.
The broken lines depicting the circular and rectangular elements in FIGS. 5-7 illustrate portions of the pedicure spa that form no part of the claimed design, and all other broken lines represent environment. The broken lines form no part of the claimed design.

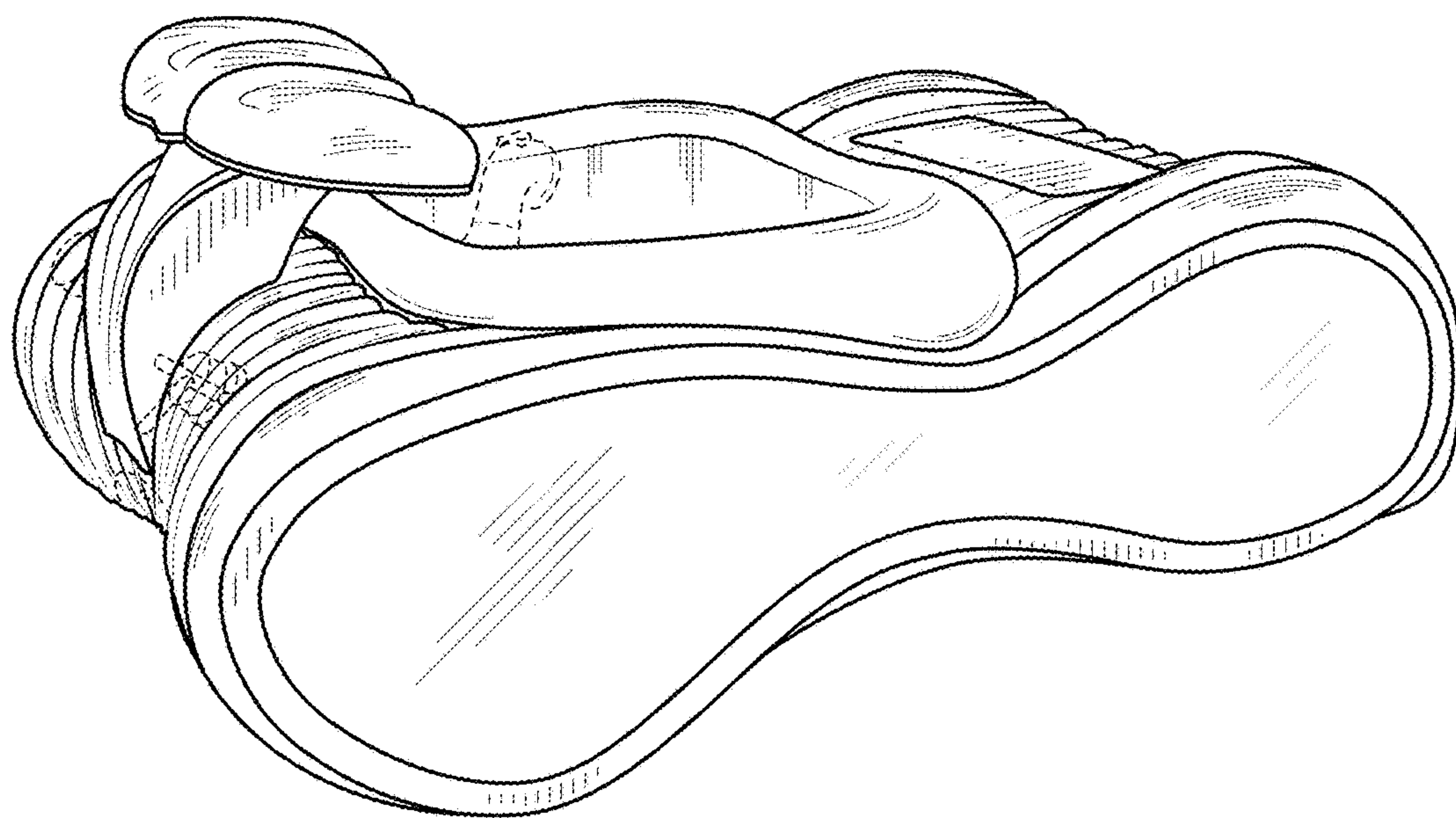

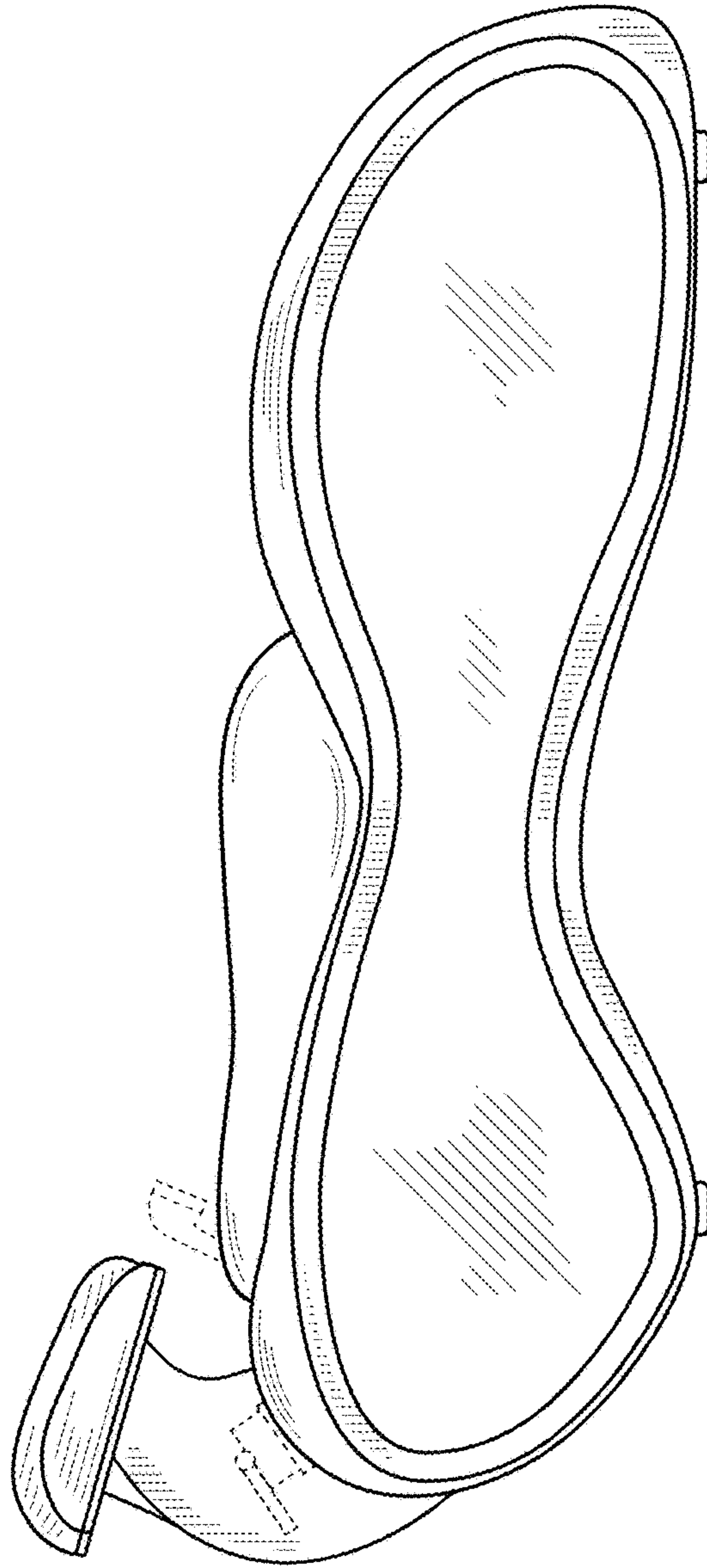

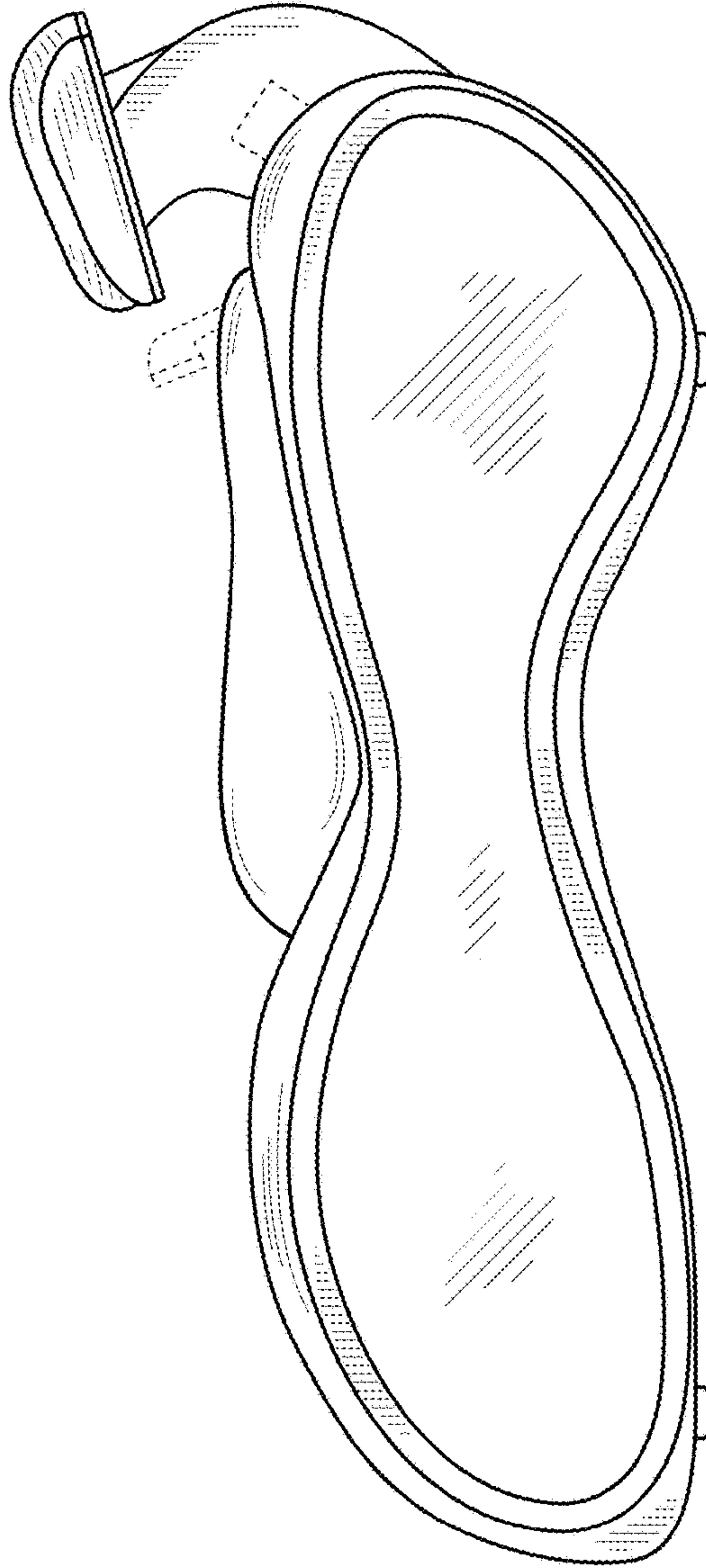

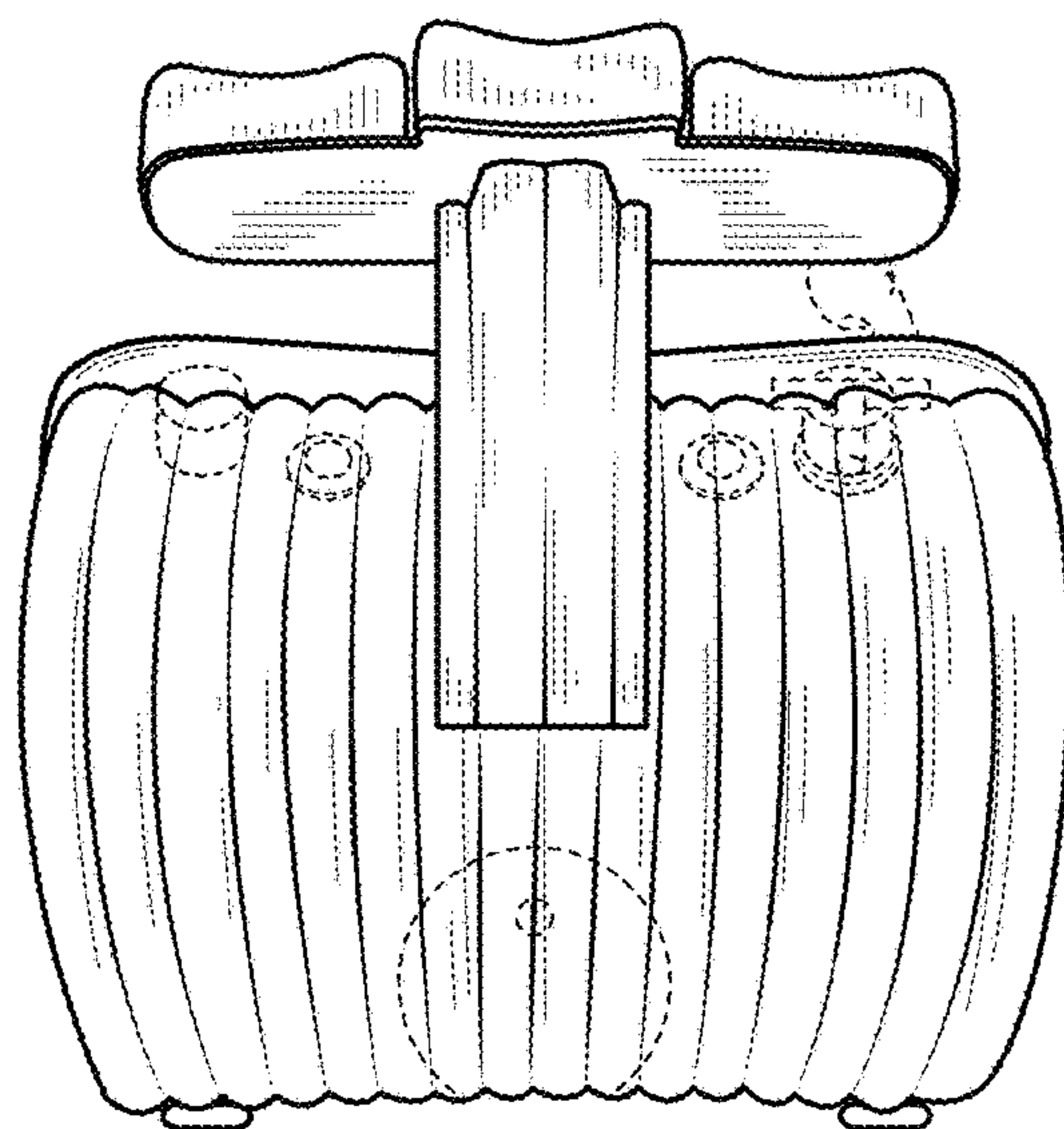

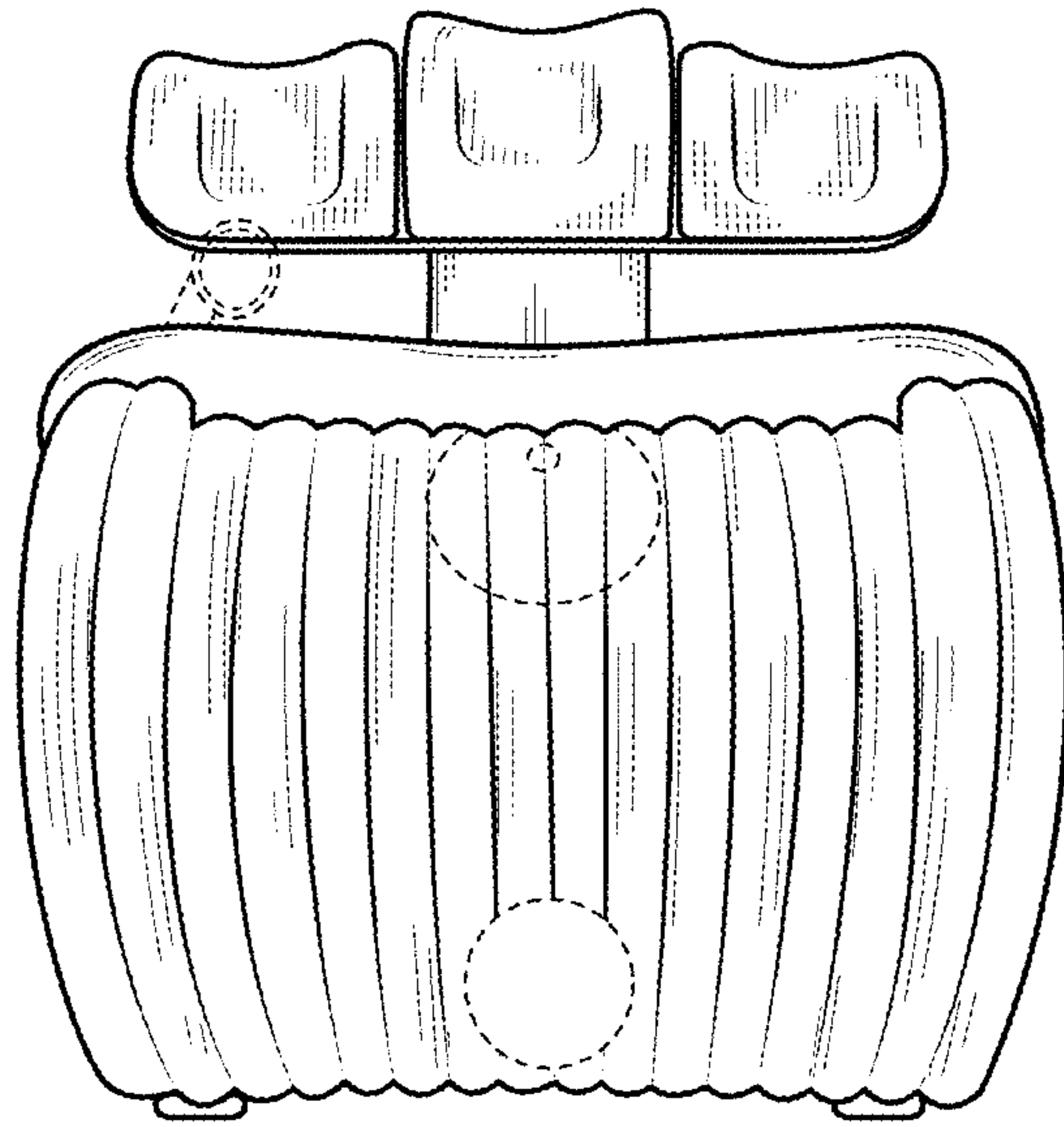

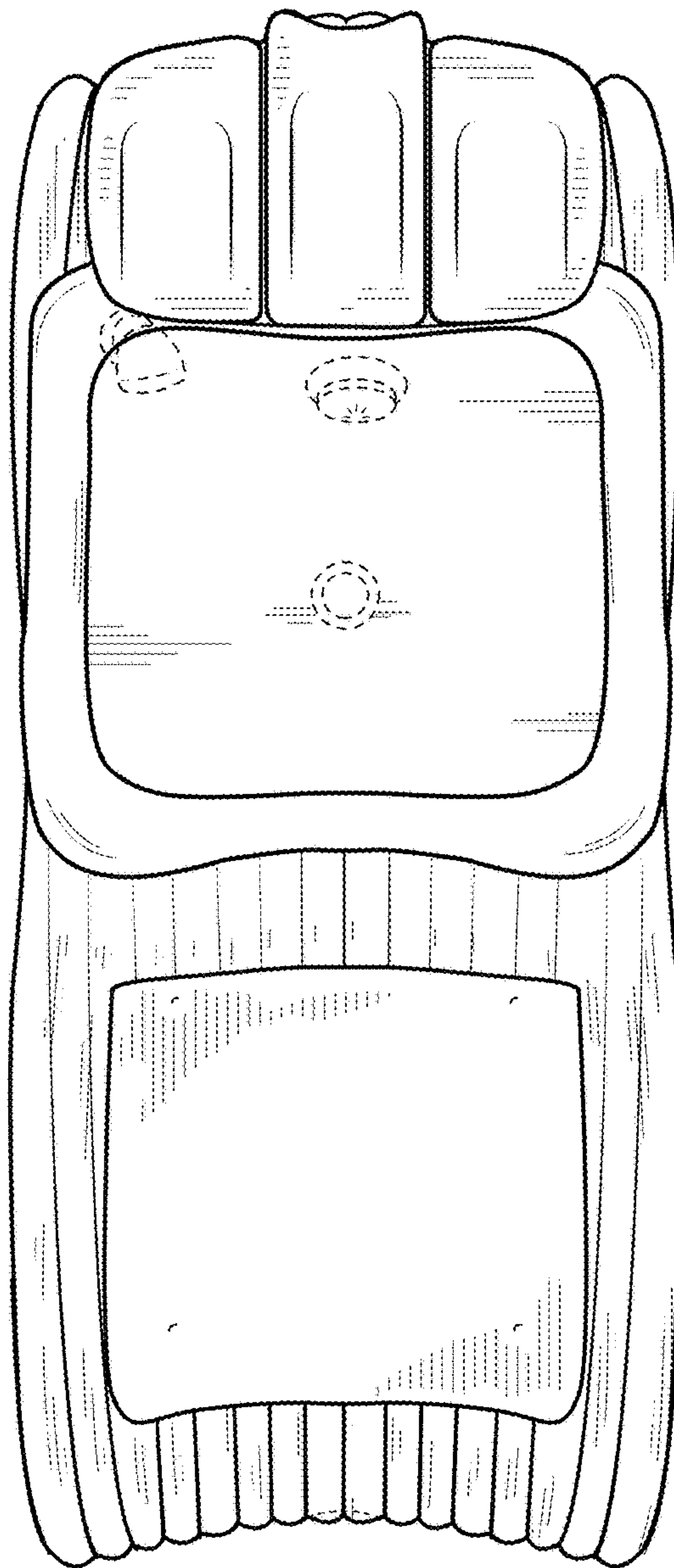

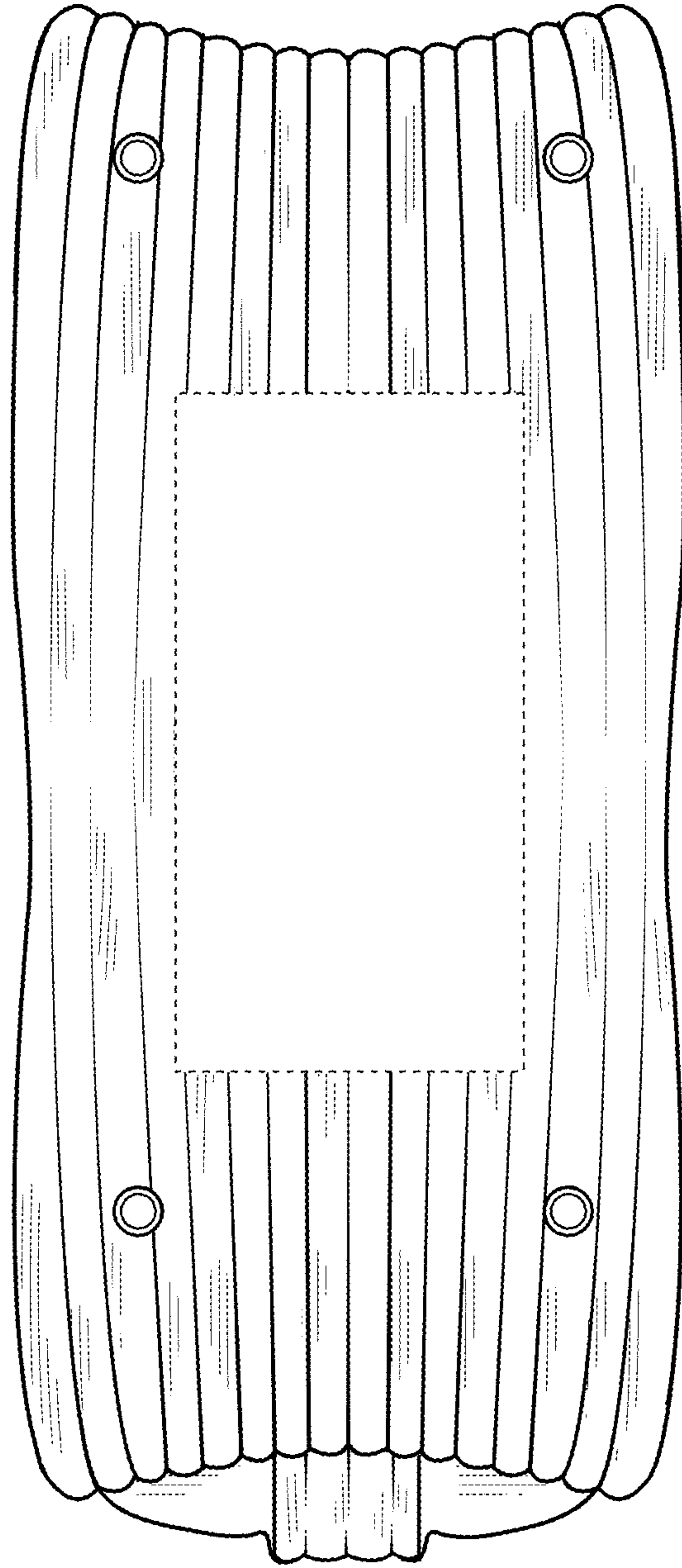

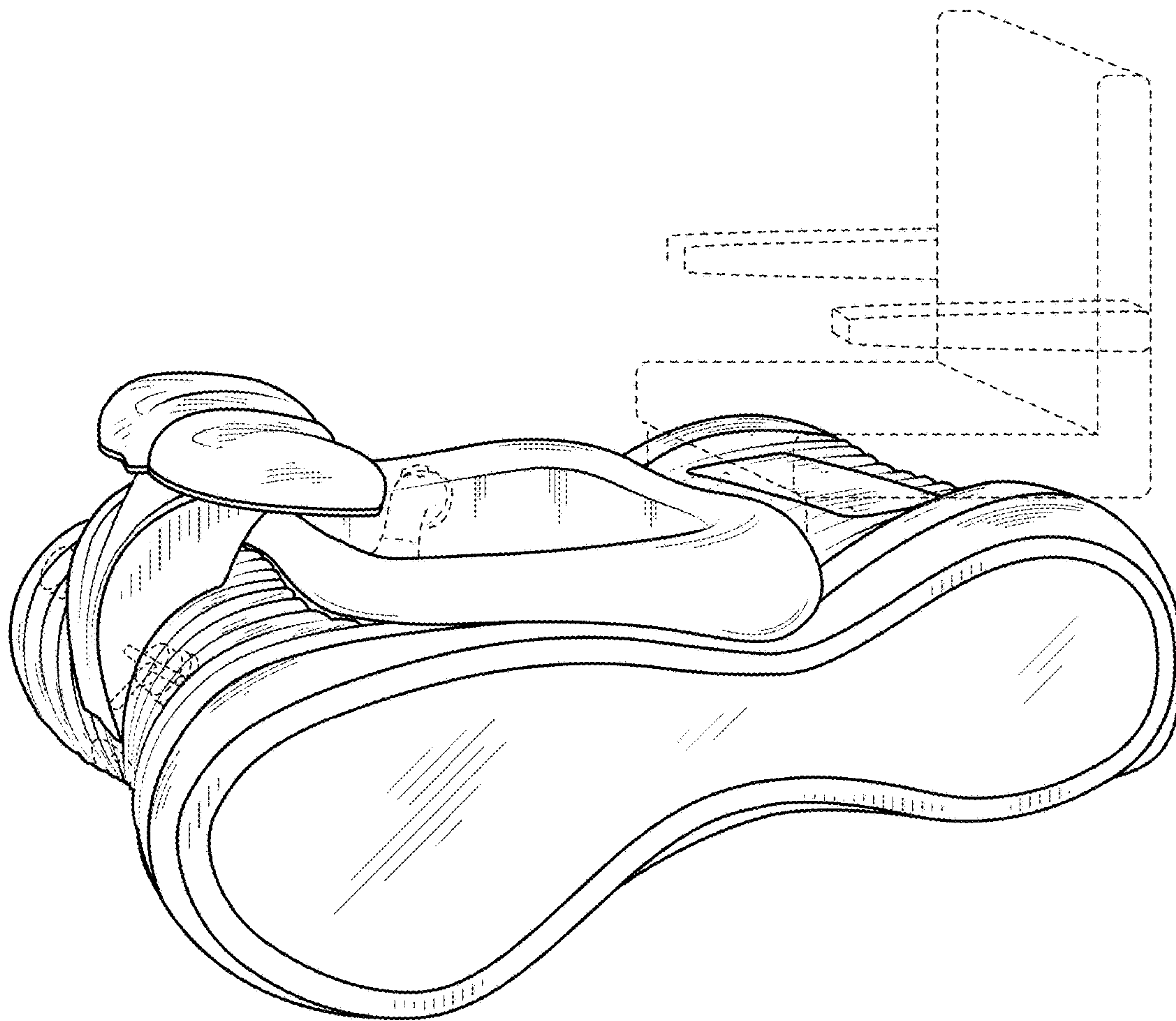
