**DESCRIPTION**

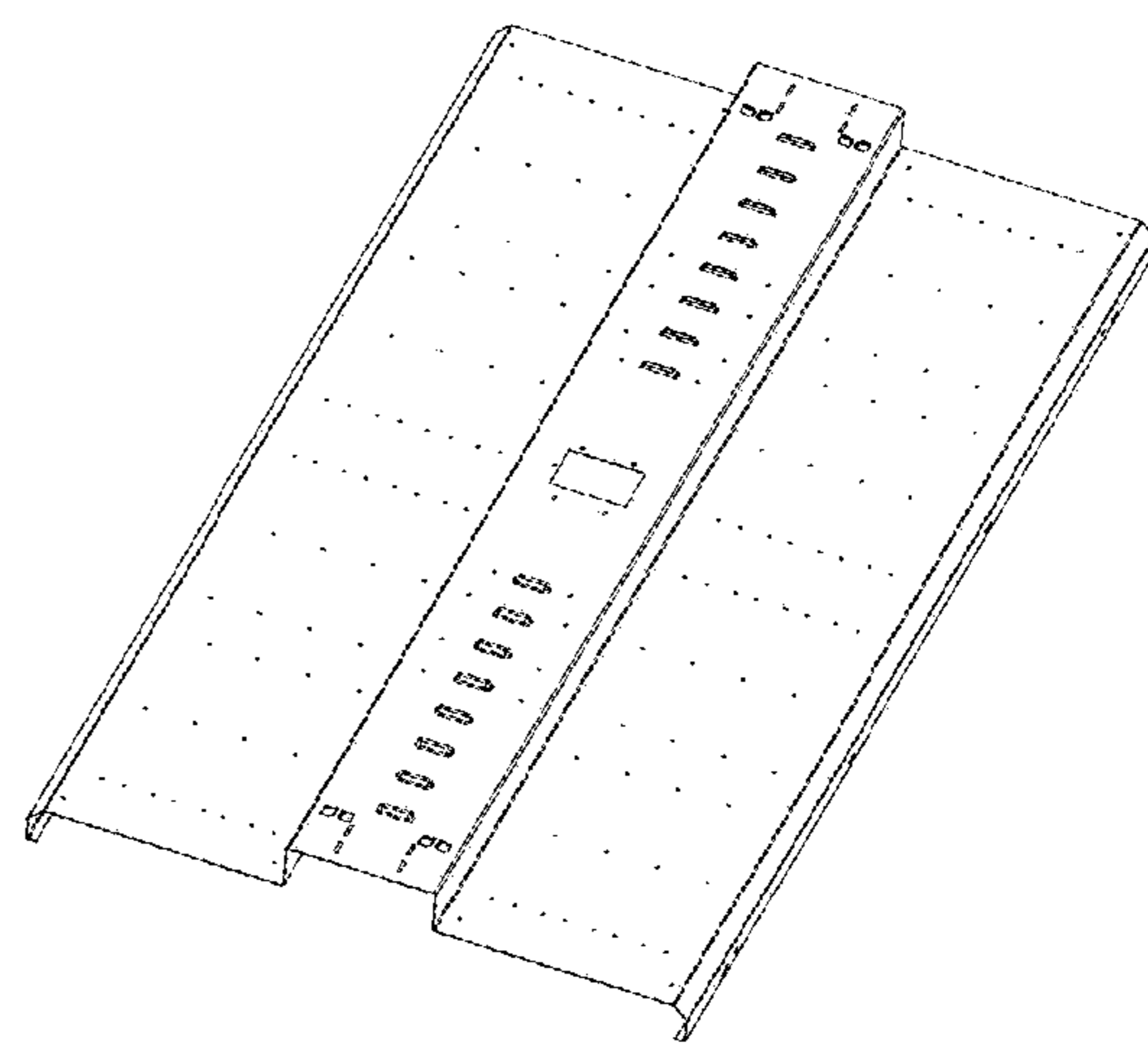
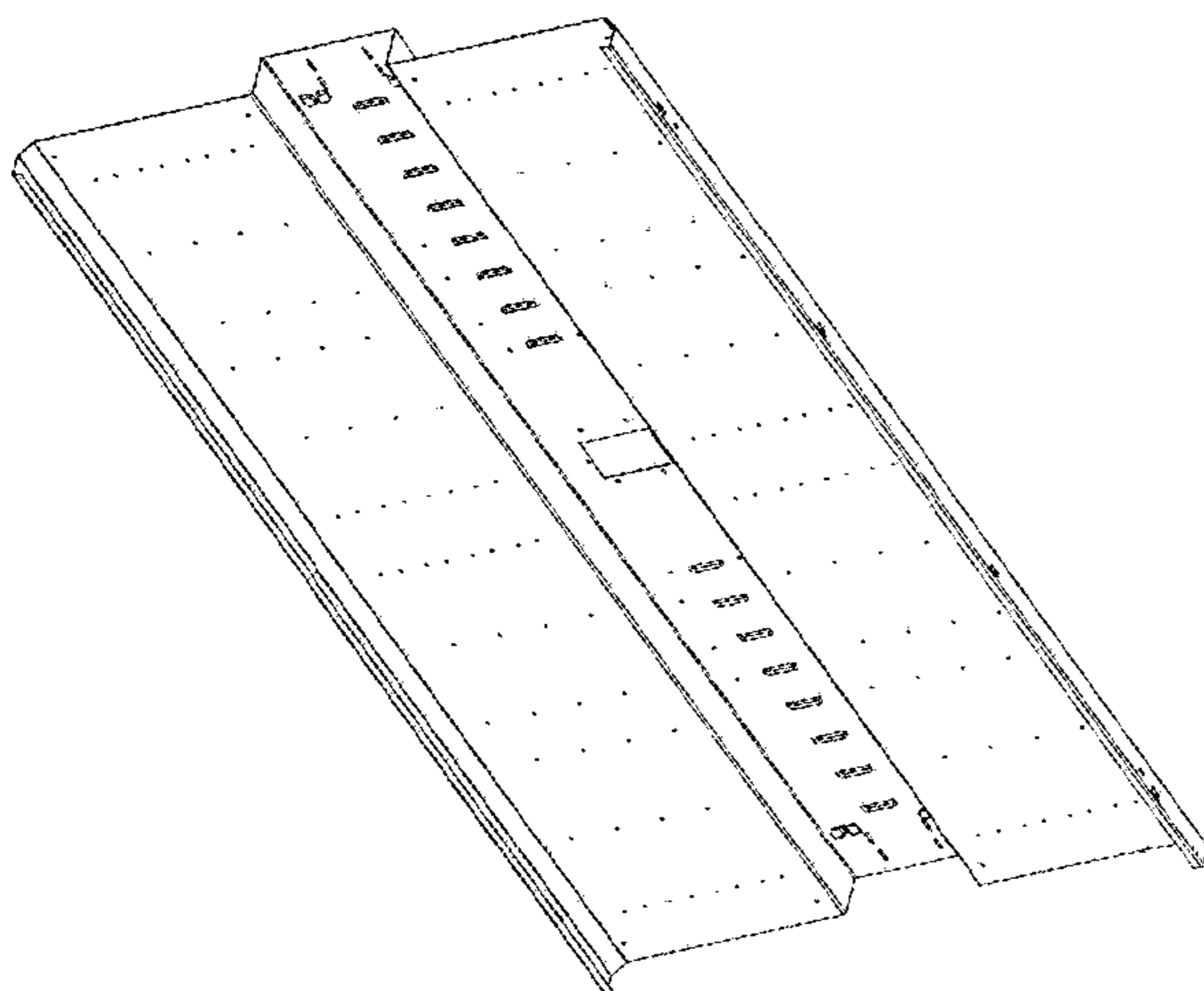
FIG. 1 is a bottom perspective view of a body for a light fixture;

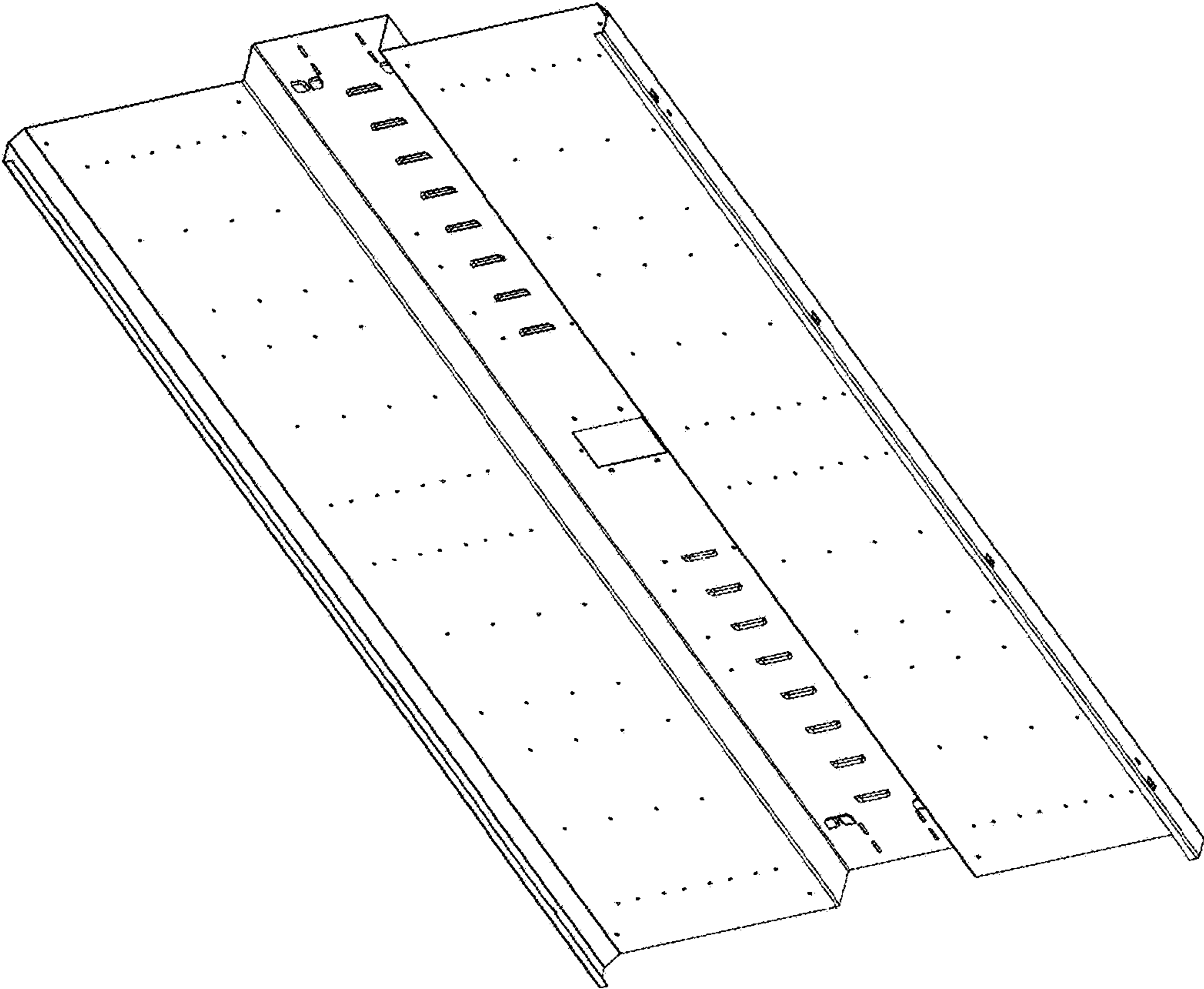

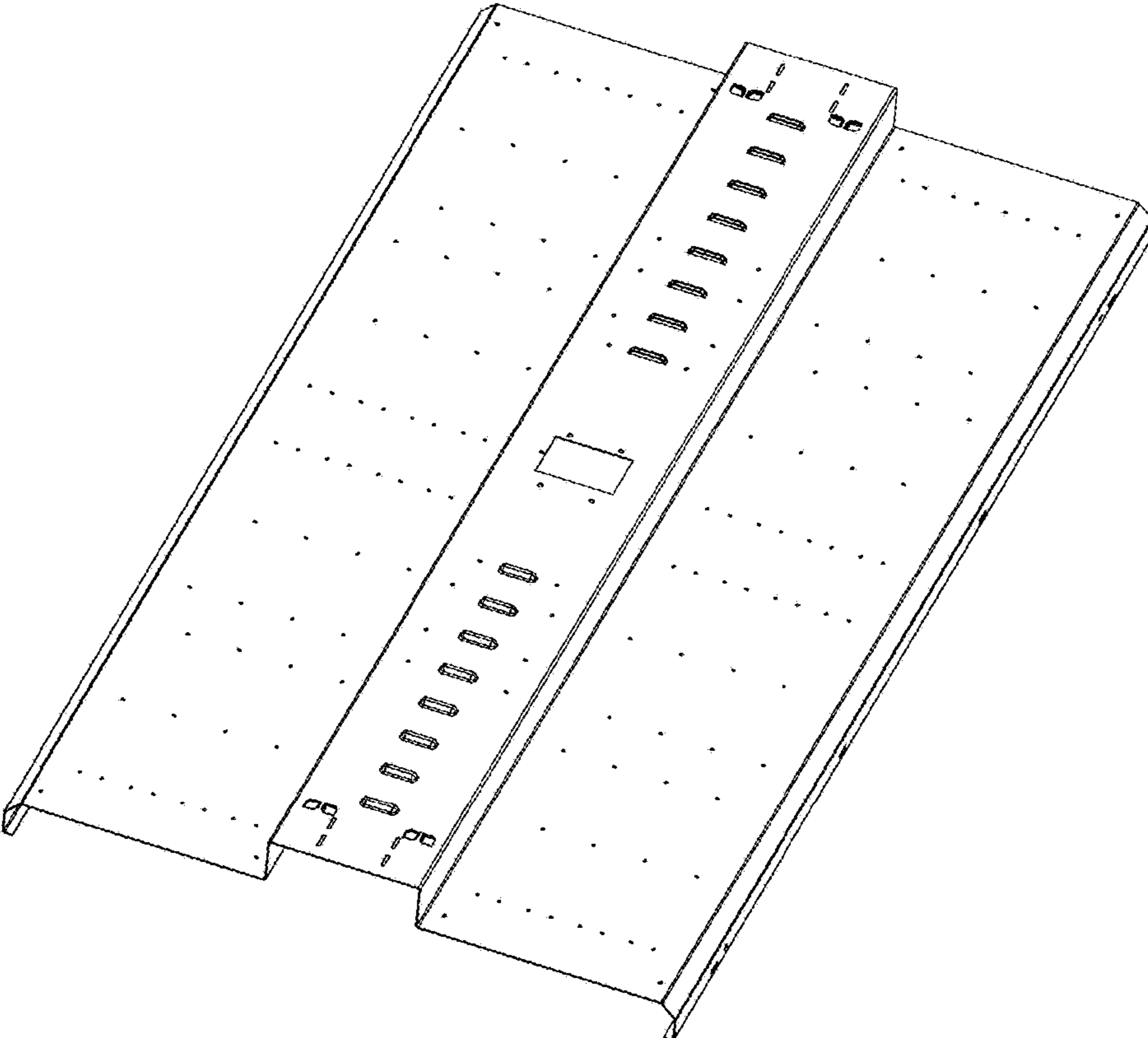

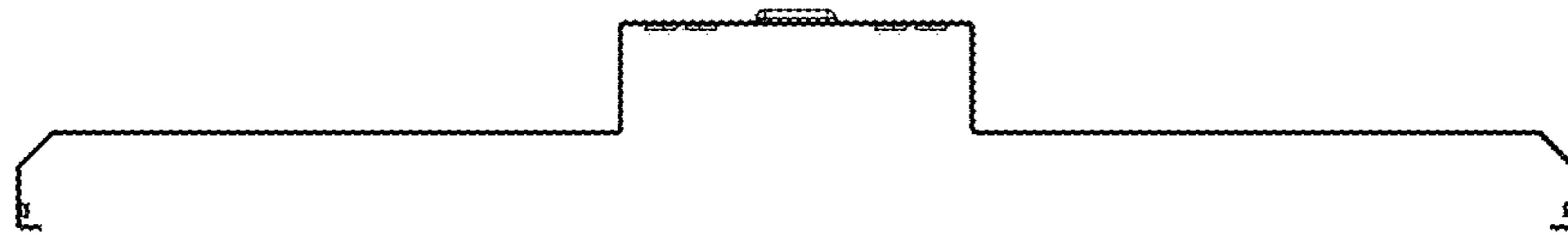

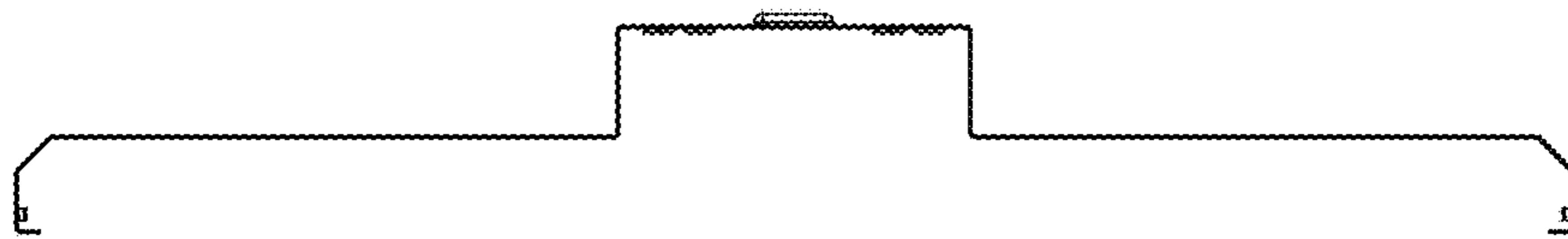

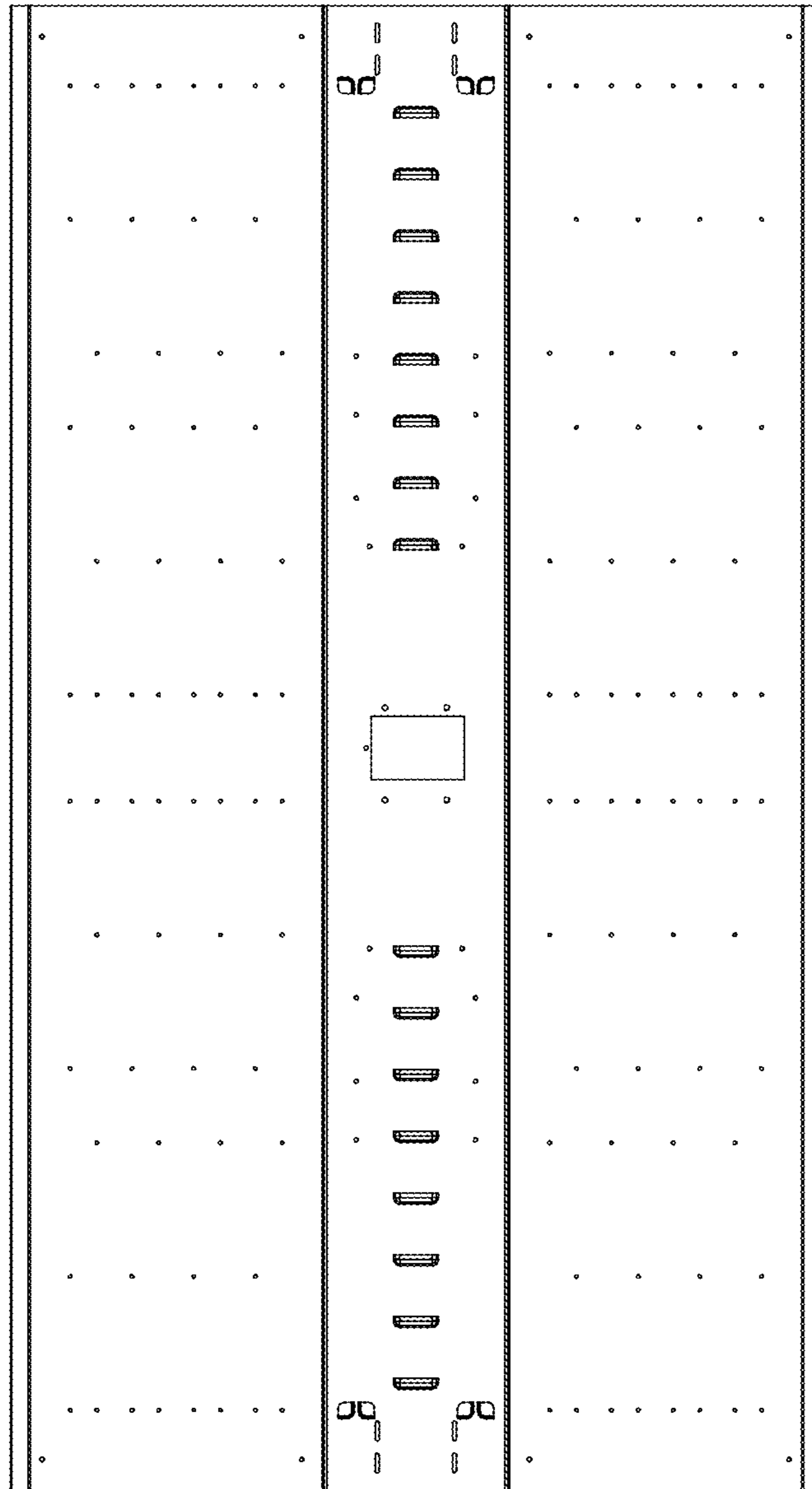

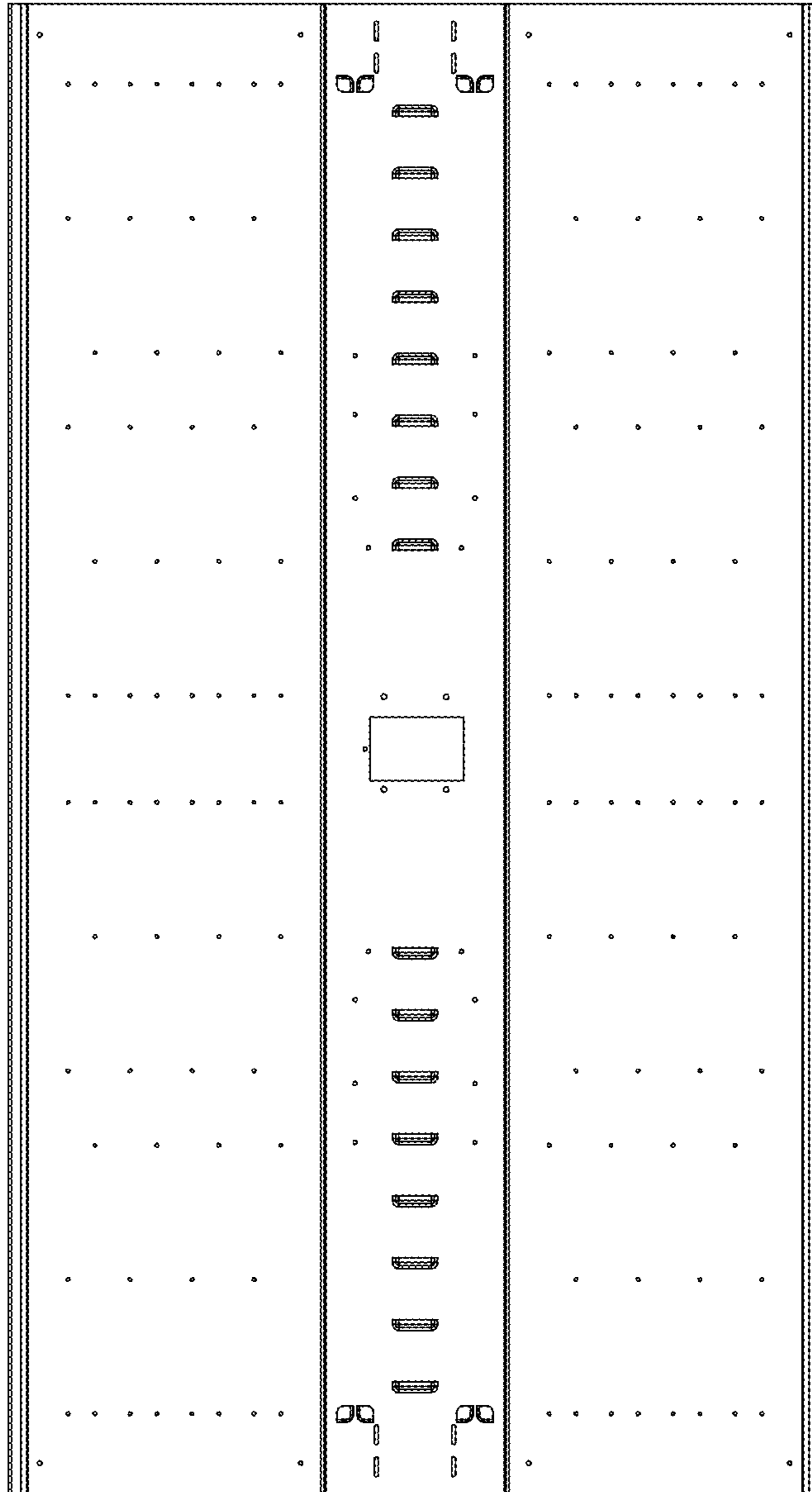

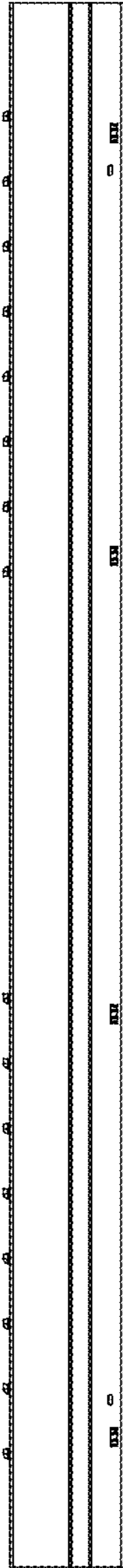
