(57) **CLAIM**  
The ornamental design for a power bar end, as shown and described.

**DESCRIPTION**  
FIG. 1 is a perspective view of the power bar end showing my new design;  
FIG. 2 is a top plan view thereof, the bottom plan view being a mirror image;  
FIG. 3 is a rear elevational view thereof;  
FIG. 4 is a left side elevational view thereof, the right side elevational view being a mirror image;  
FIG. 5 is a front elevational view thereof; and,  
FIG. 6 is a perspective view of the power bar end situated on the bar.  
The broken lines in the drawings are included for the purpose of illustrating portions of the article that form no part of the claimed design.
