(57) **CLAIM**

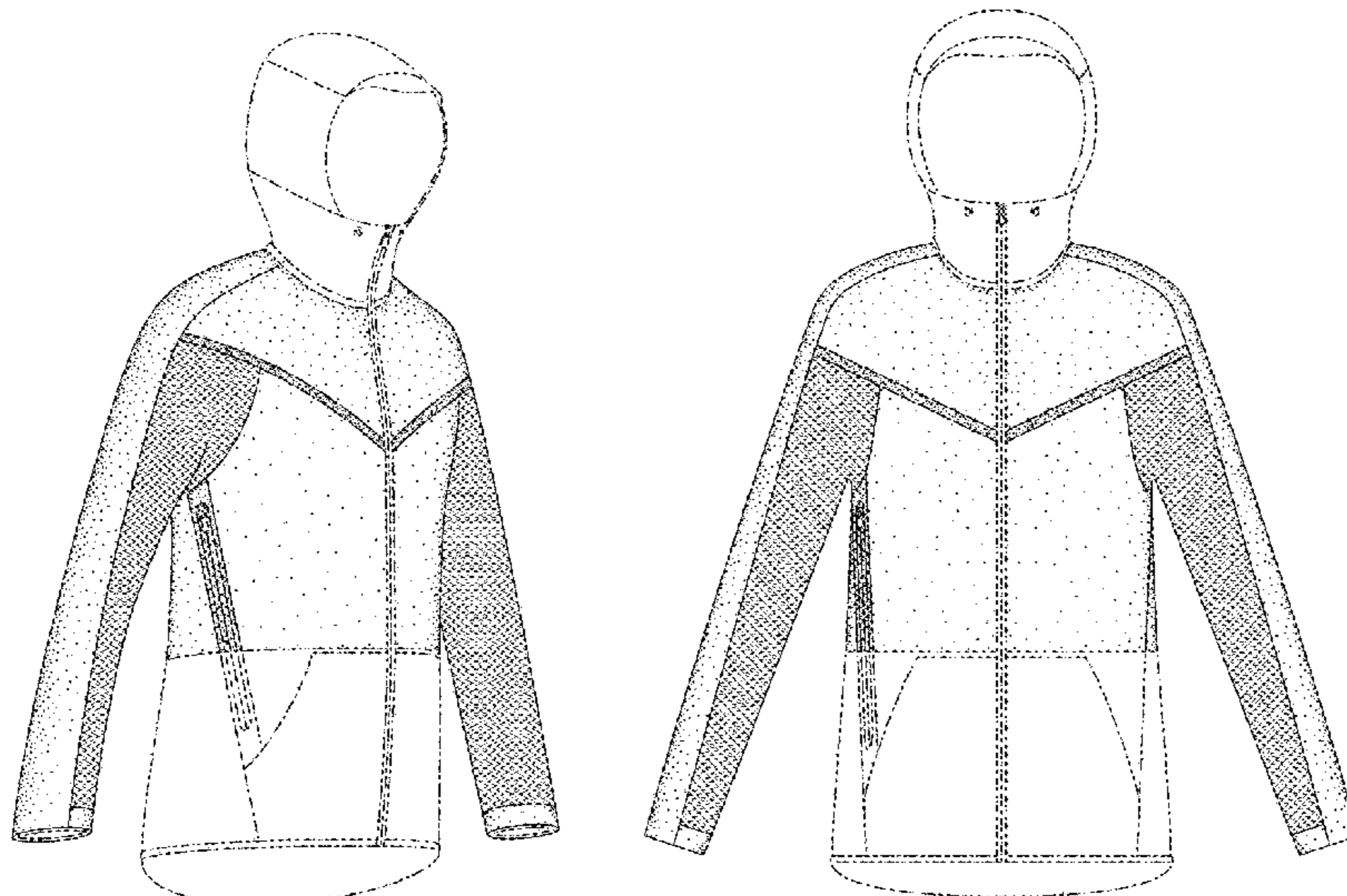
The ornamental design for a garment, as shown and described.

**DESCRIPTION**

FIG. 1 is a front left perspective view of a garment showing my new design in an in-use configuration; FIG. 2 is a front right perspective view thereof; FIG. 3 is a front view thereof; FIG. 4 is a rear view thereof; FIG. 5 is a left side view thereof; FIG. 6 is a right side view thereof; FIG. 7 is a top view thereof; and, FIG. 8 is a bottom view thereof.

The broken lines immediately adjacent to the shaded area represent unclaimed boundaries of the design. The unshaded regions, demarcated by broken lines, represent unclaimed portions of the garment that form no part of the claim. The broken lines depict portions of the article that form no part of the claim. The contrast in shading represents a contrast of appearance.

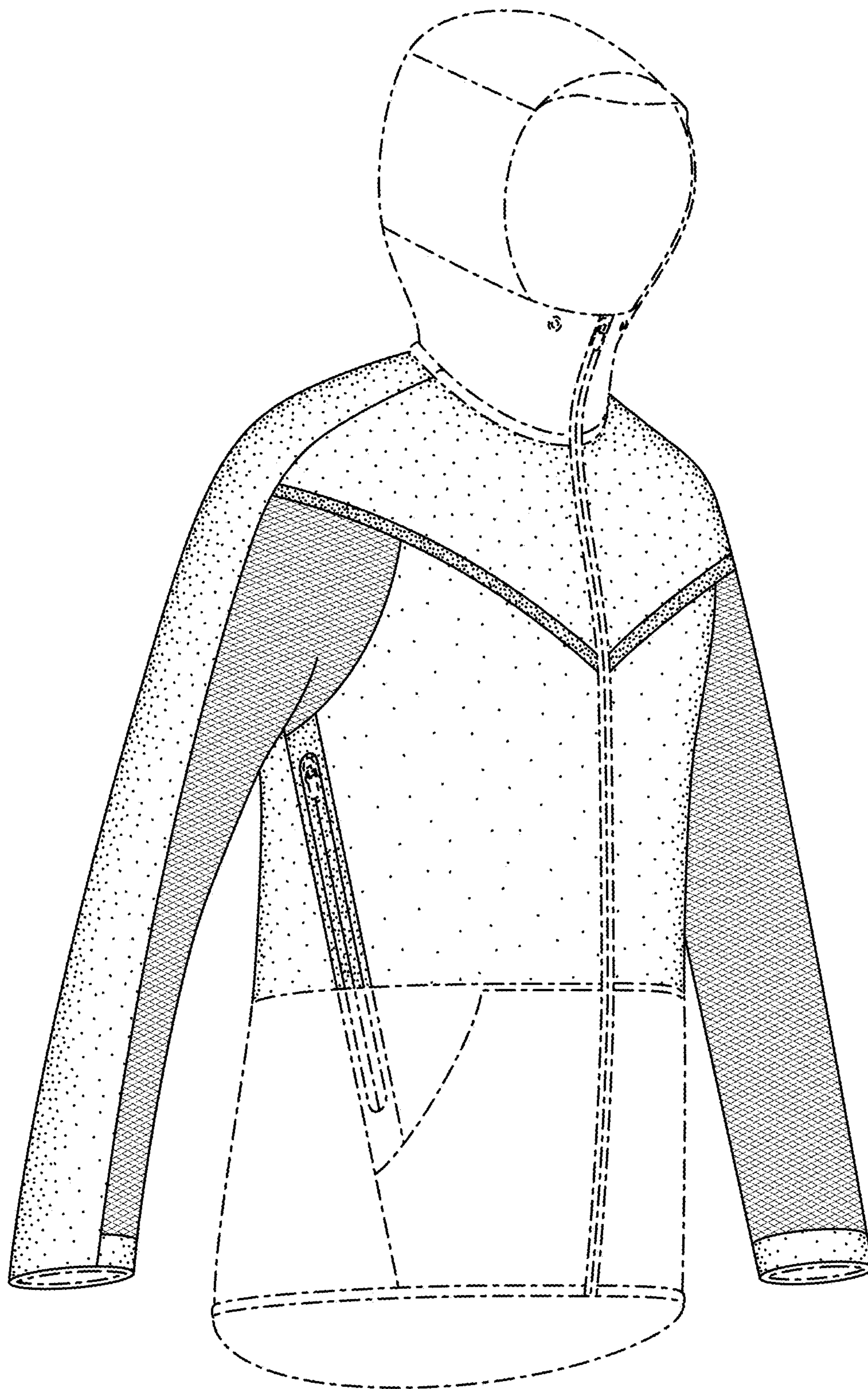

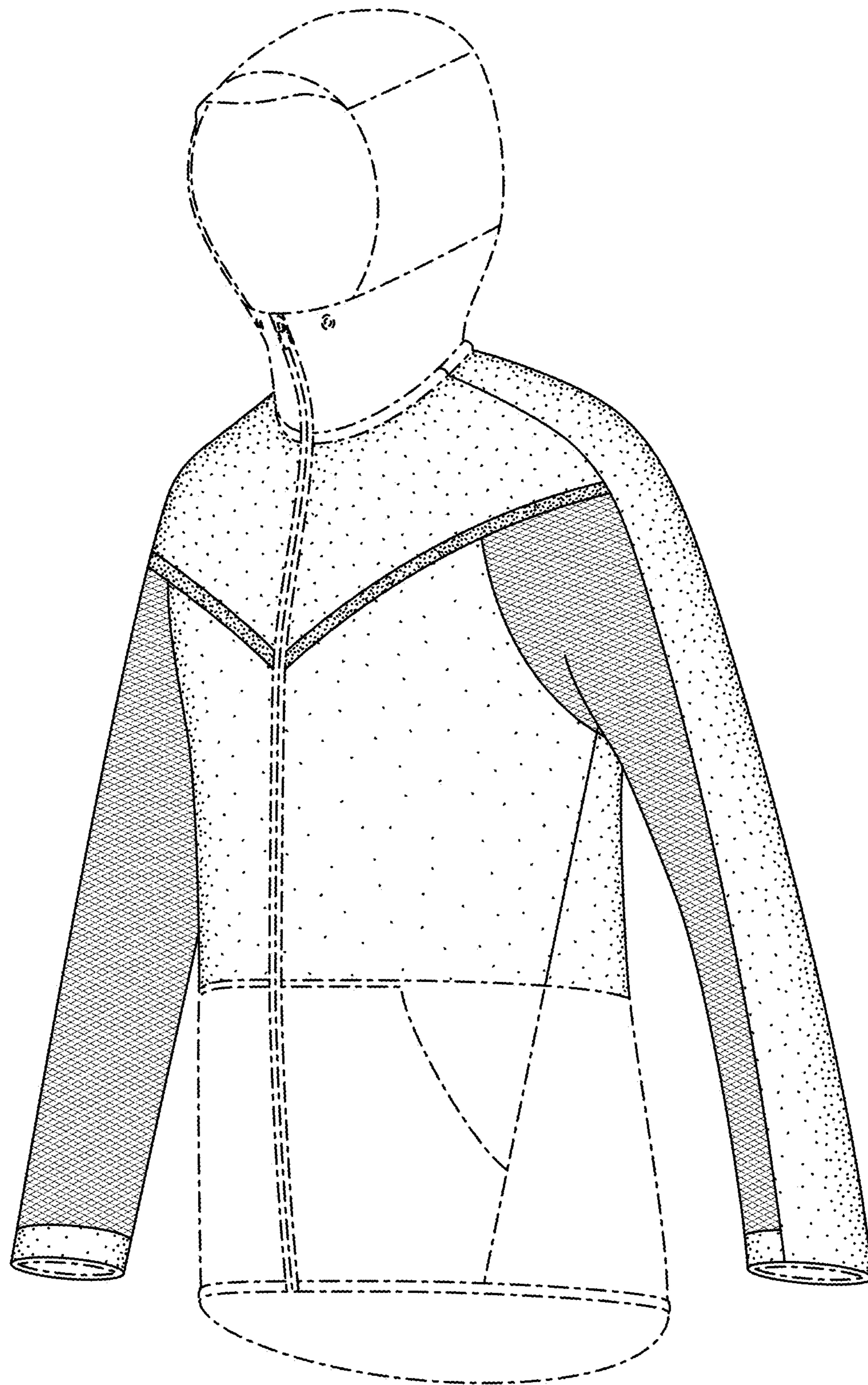

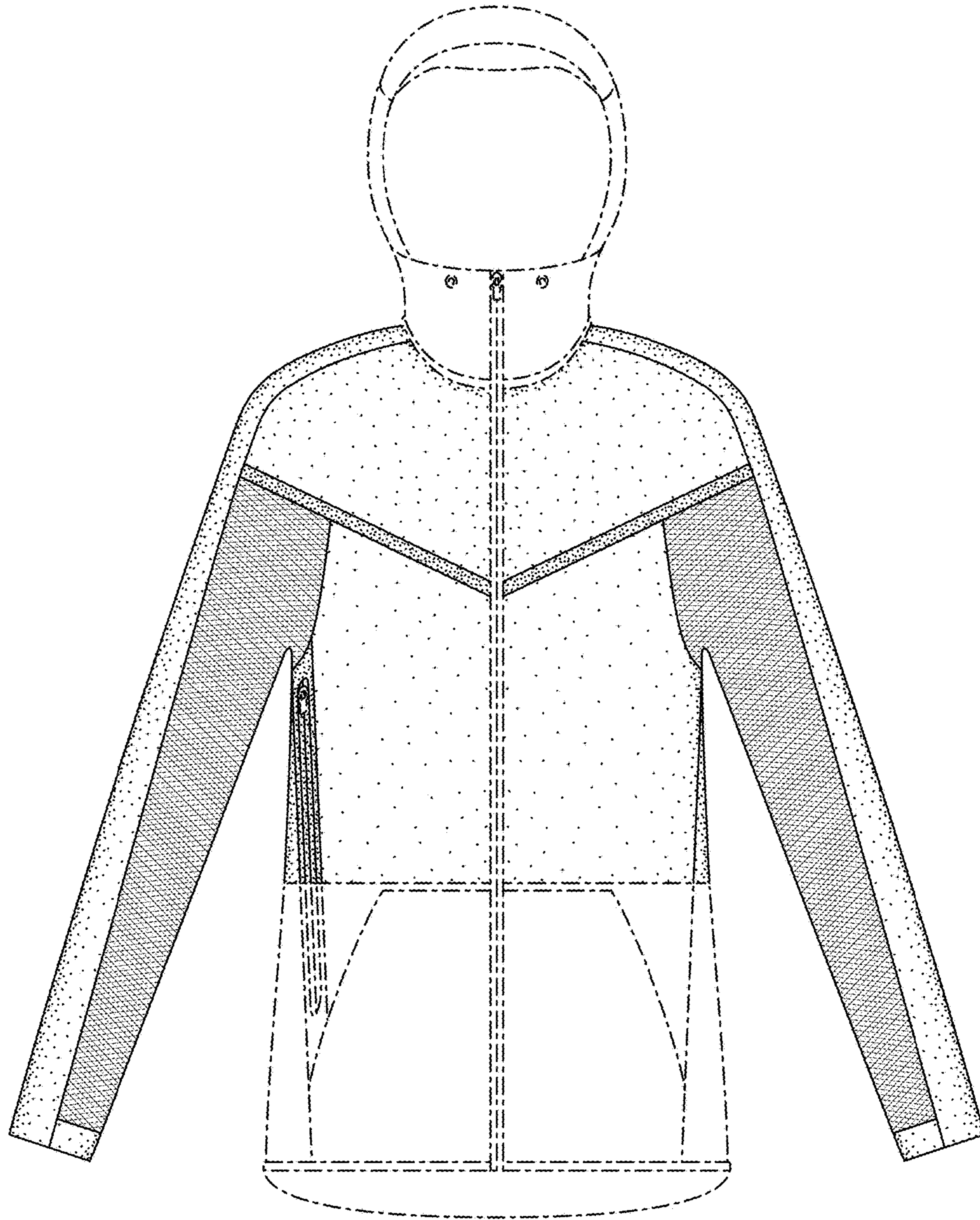

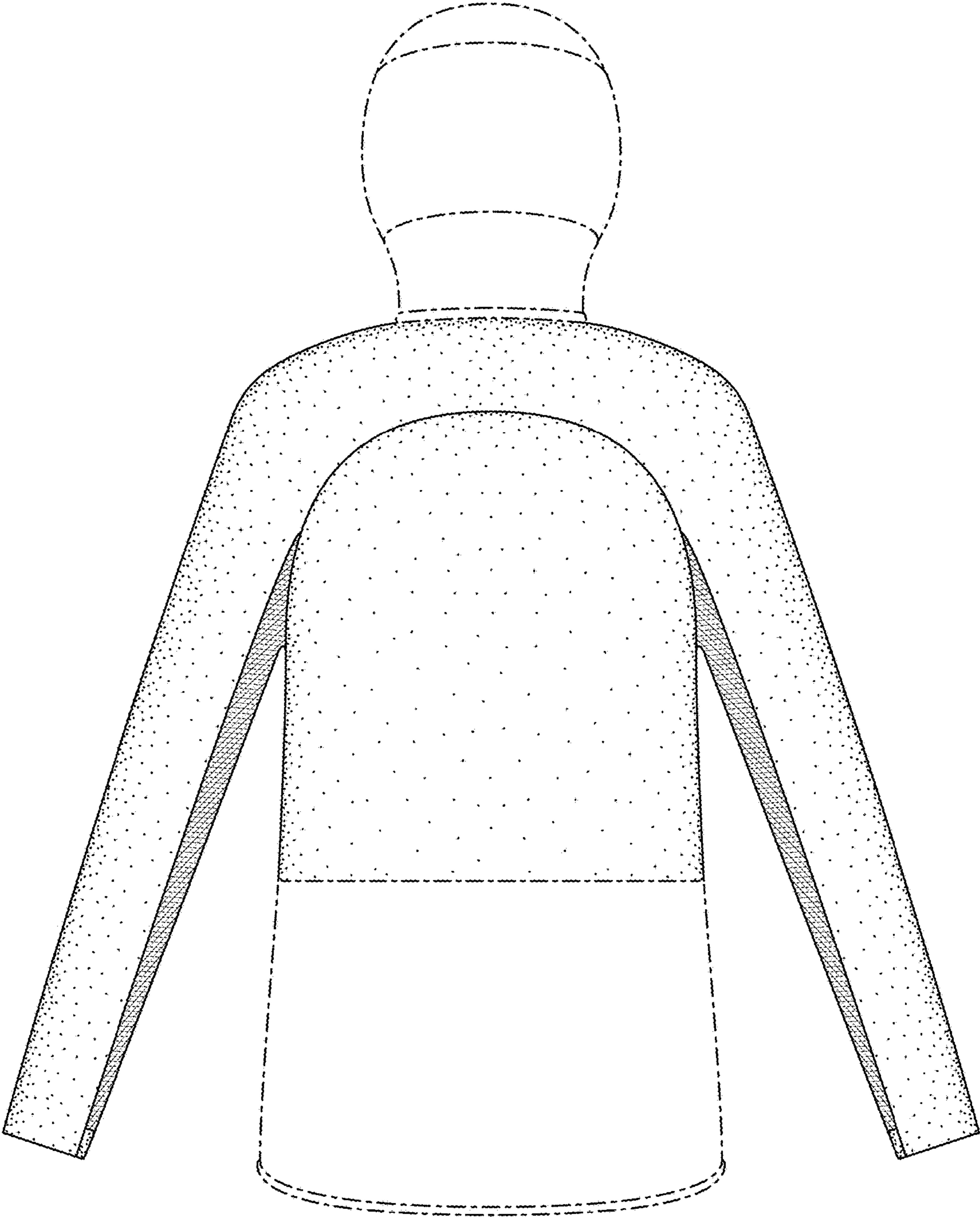

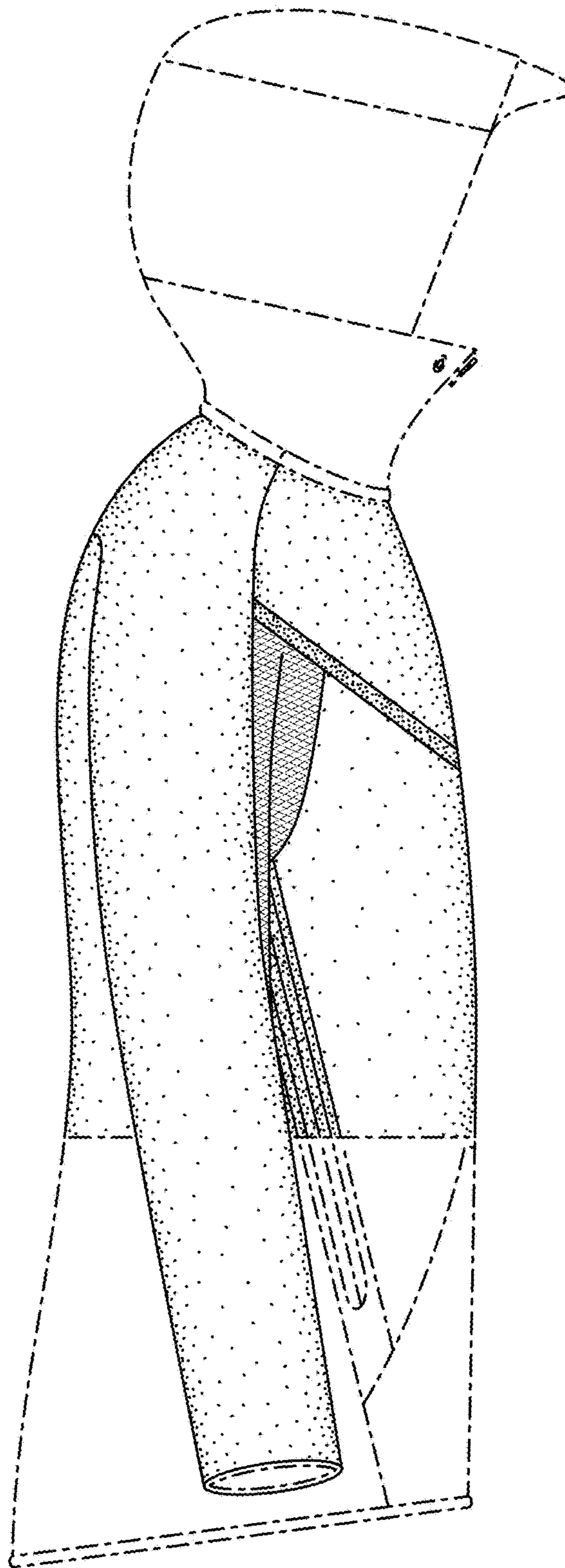
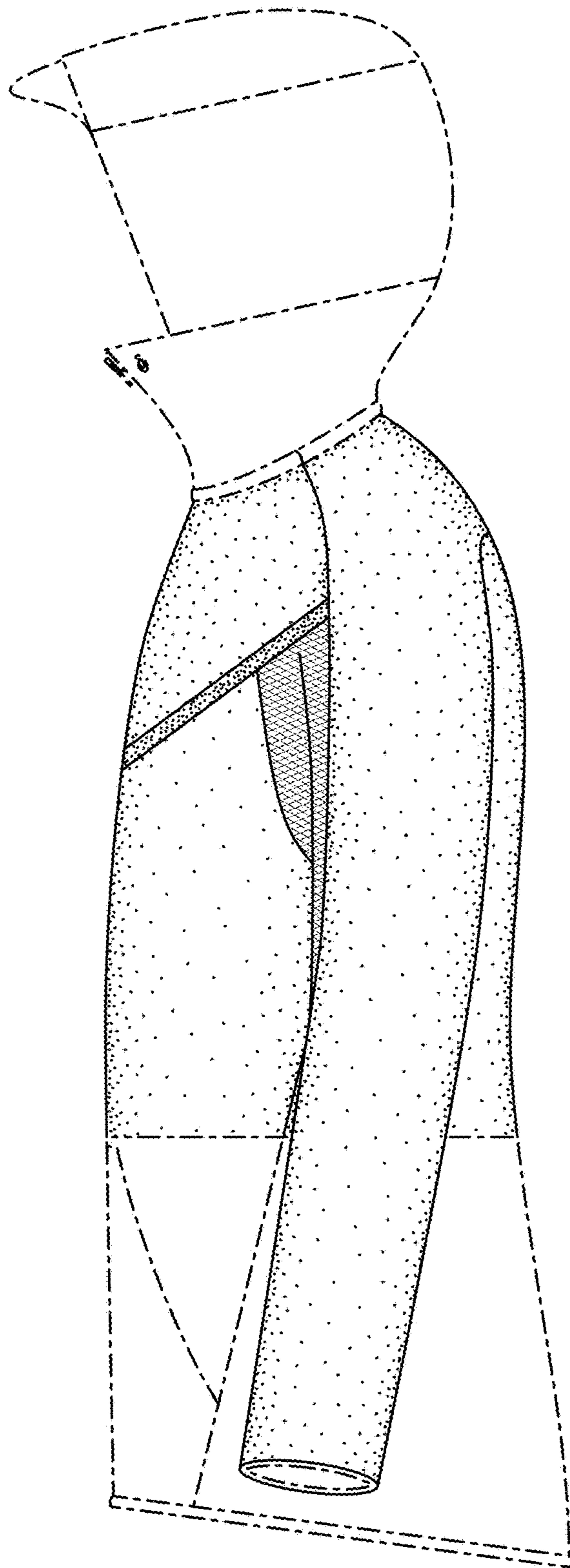

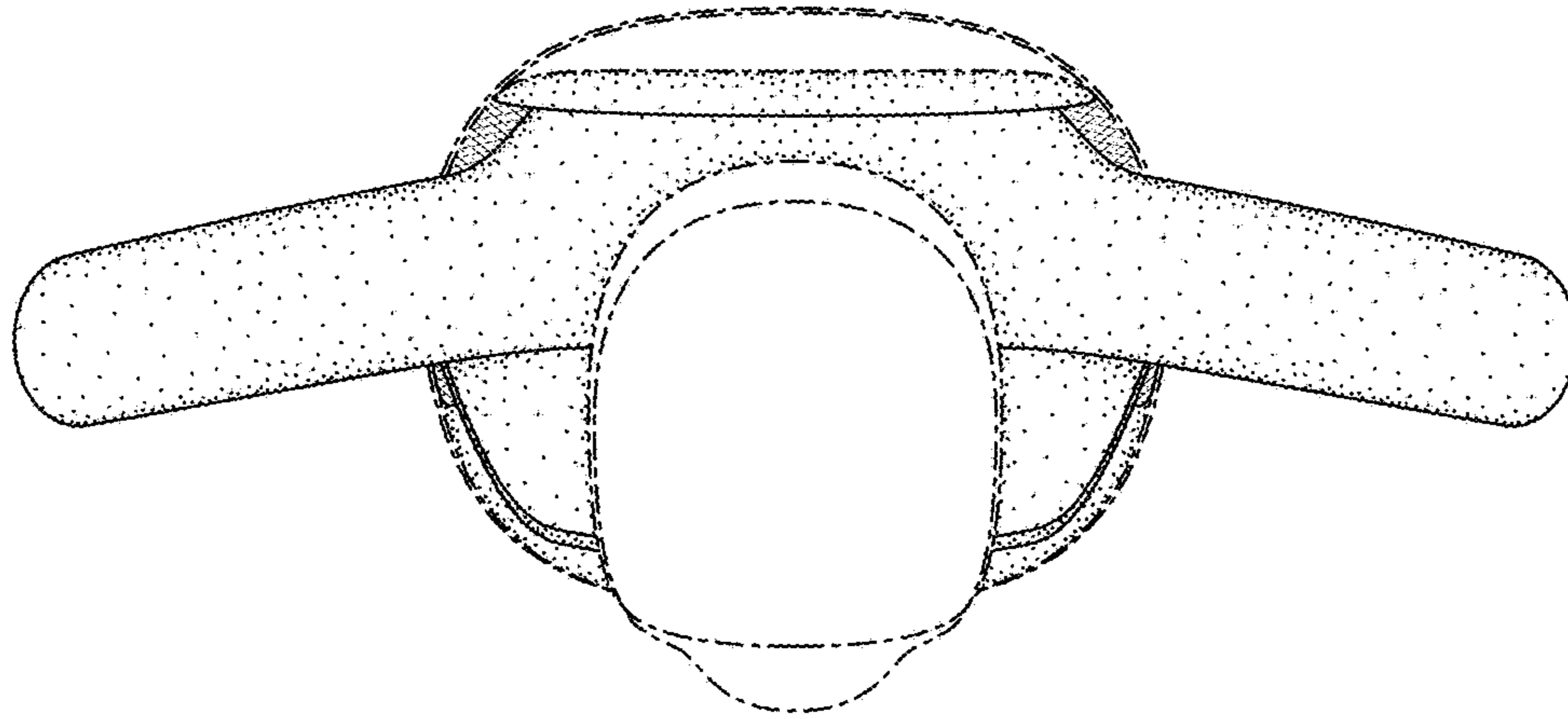

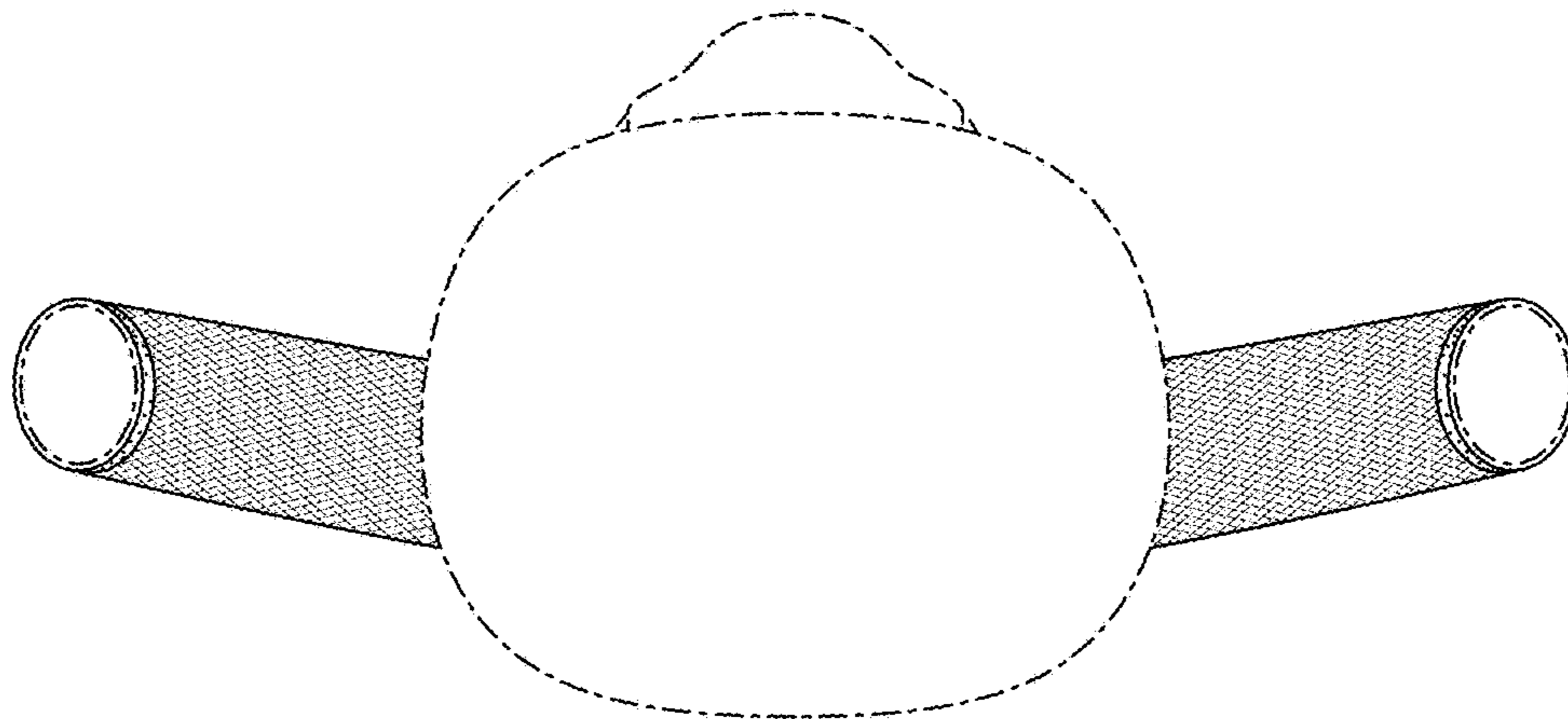
