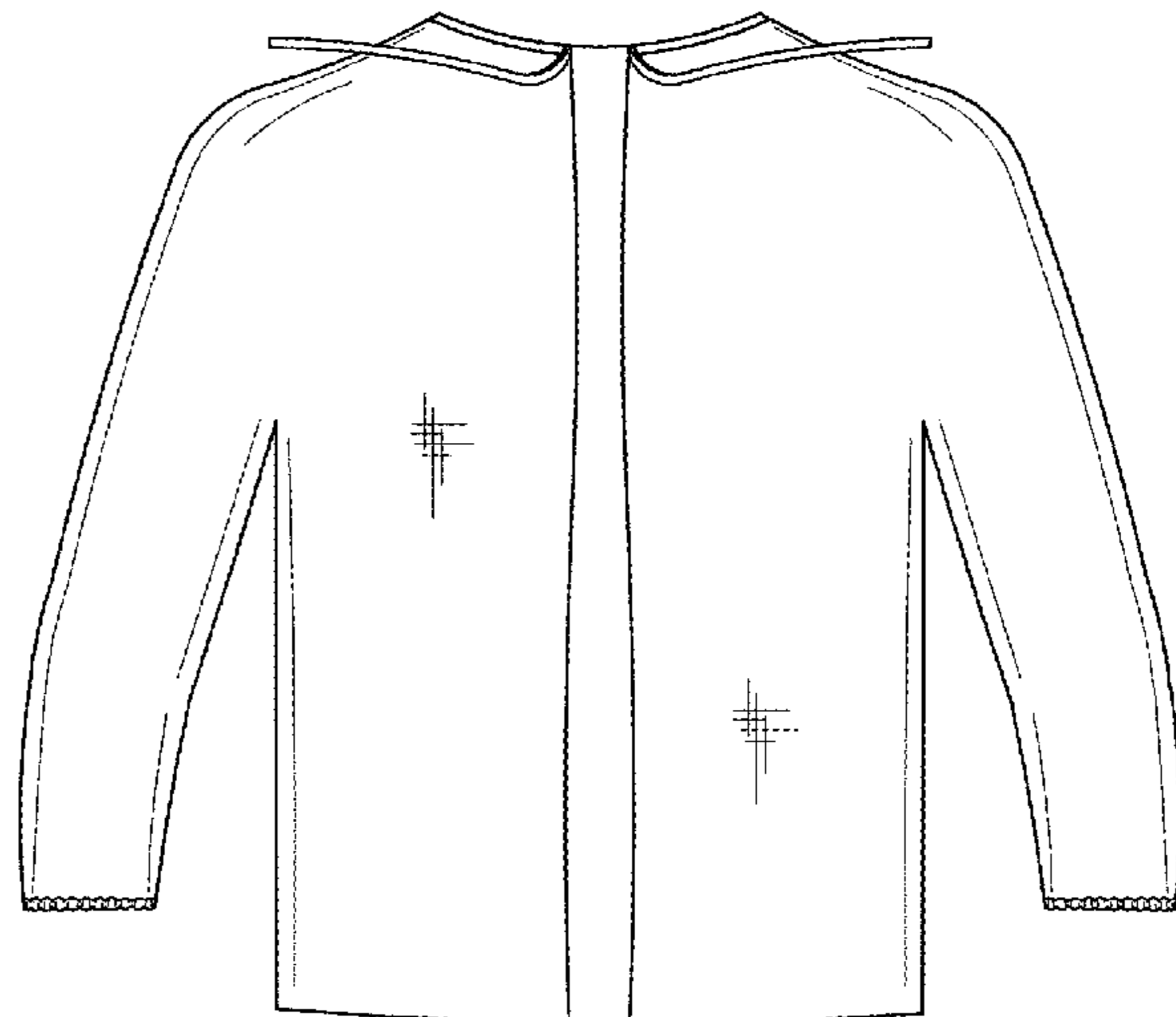
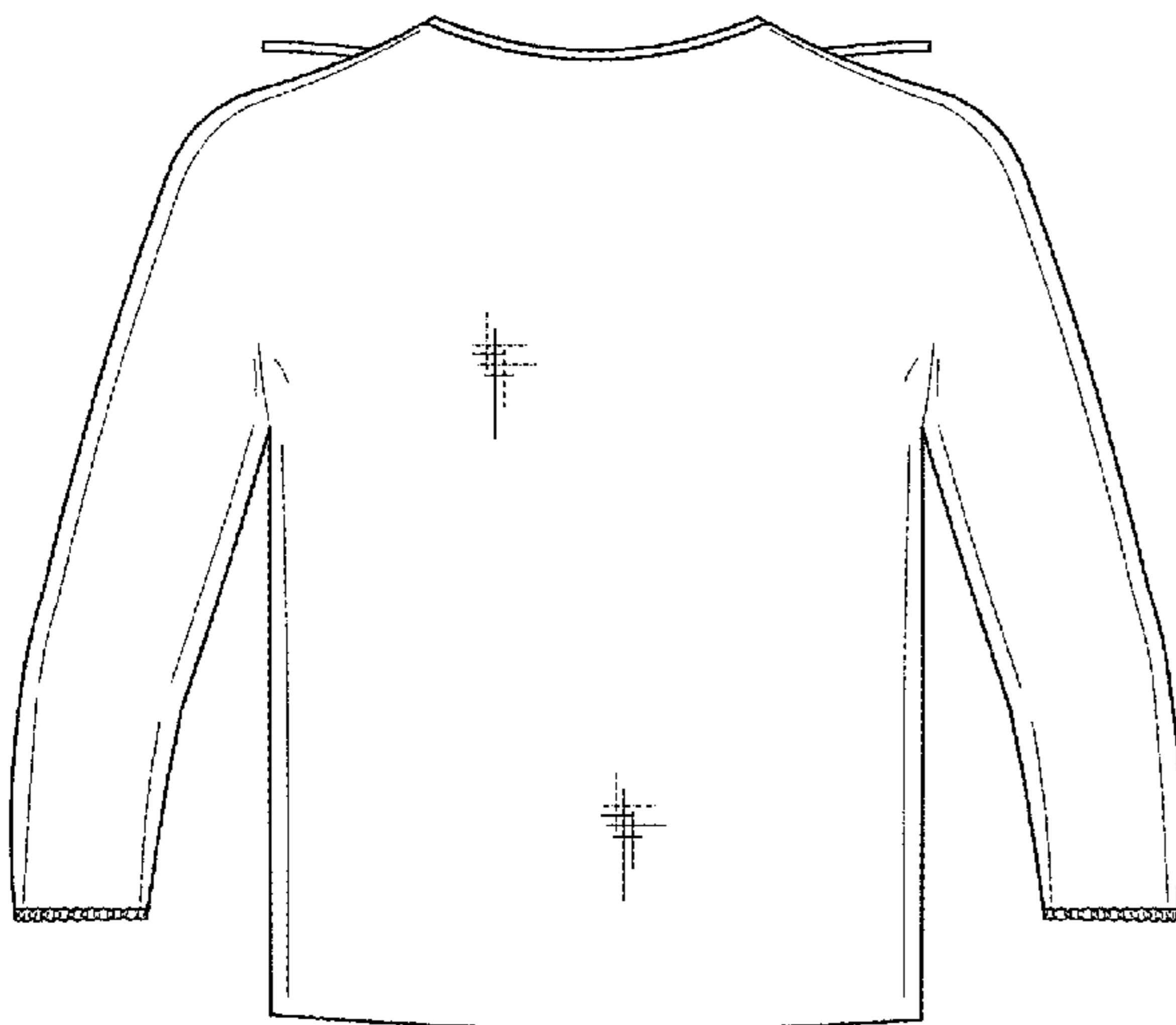
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a front view of a children’s garment cover showing my new design;
FIG. 2 is a rear view of the children’s garment cover;

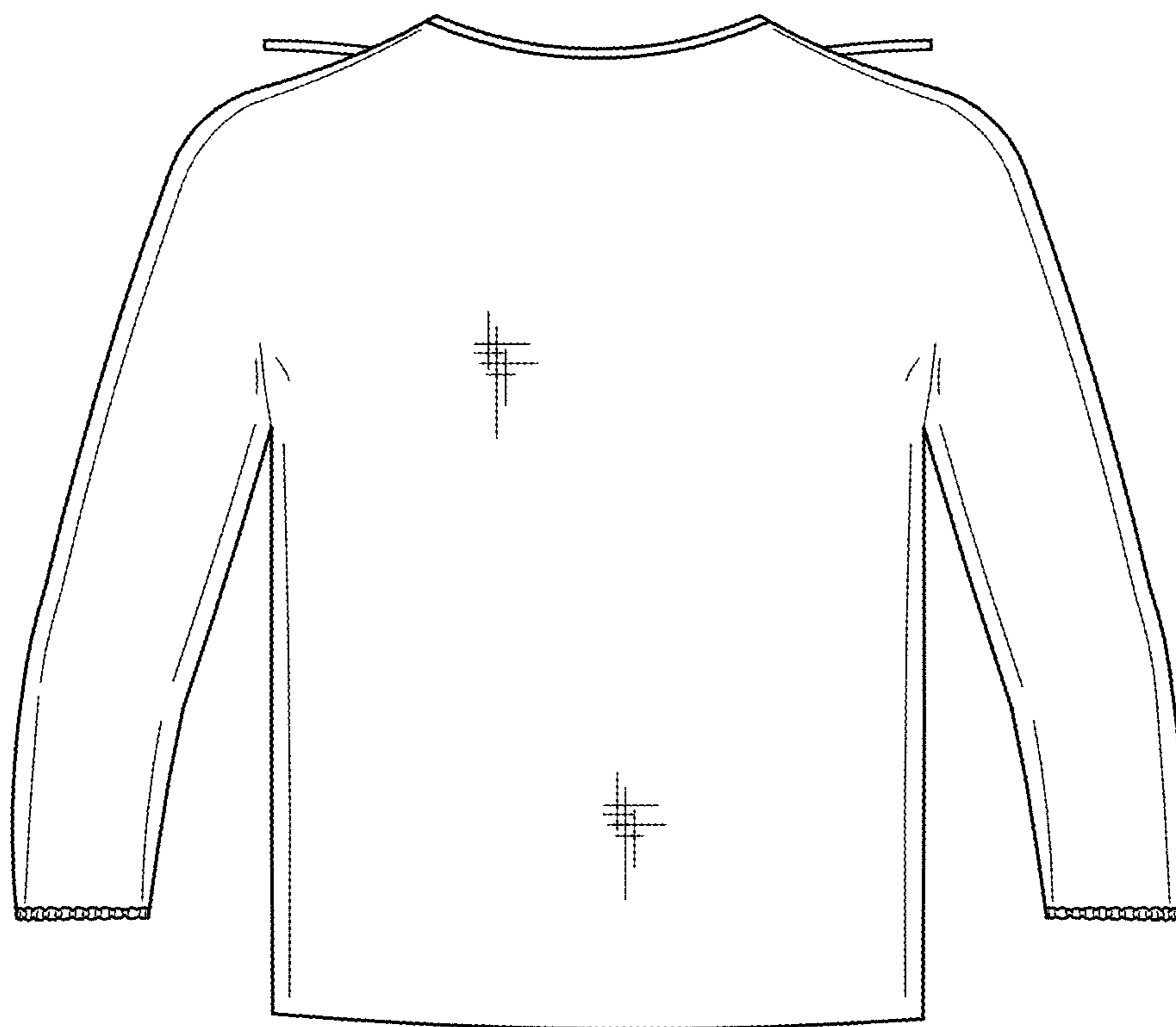

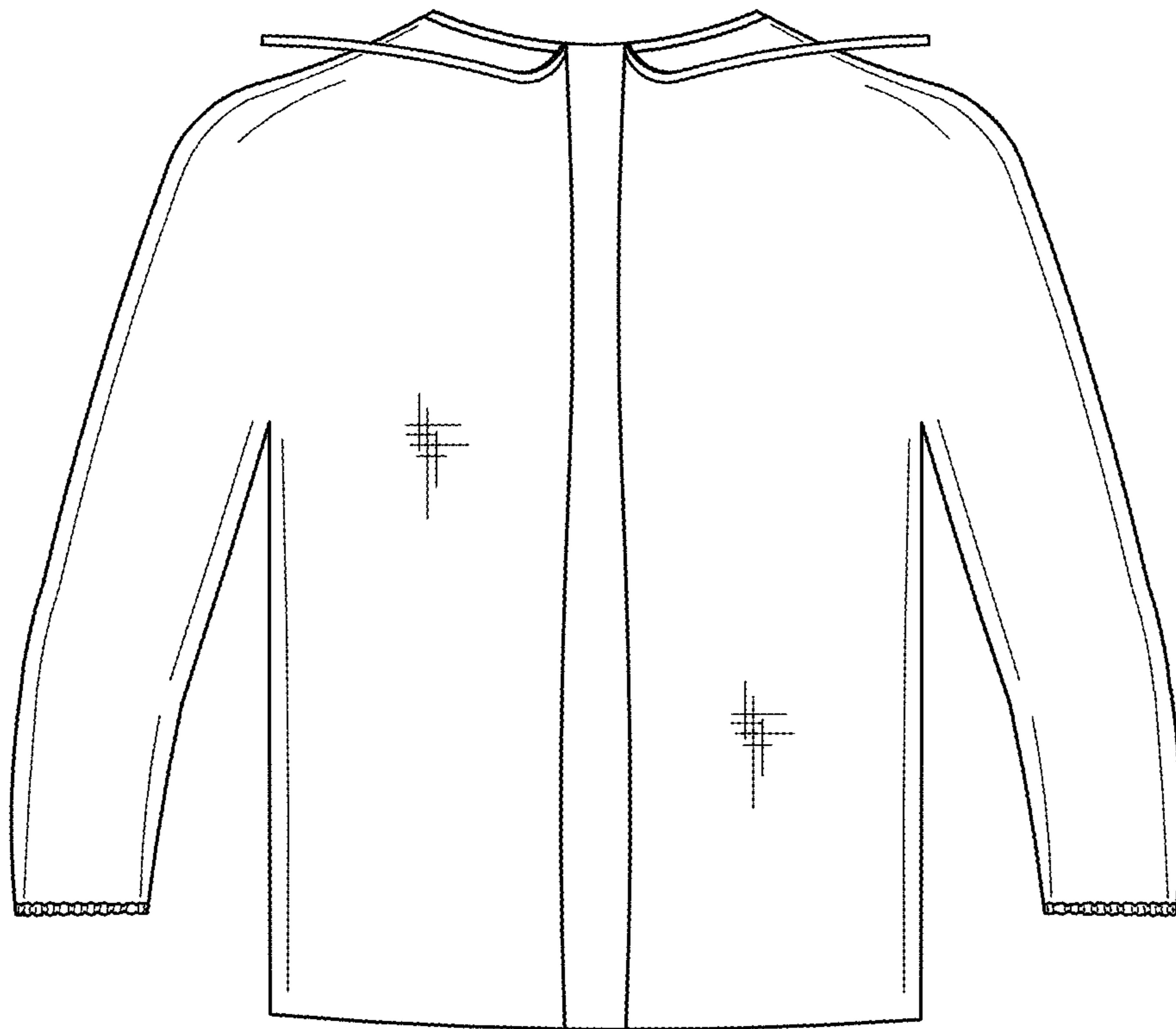

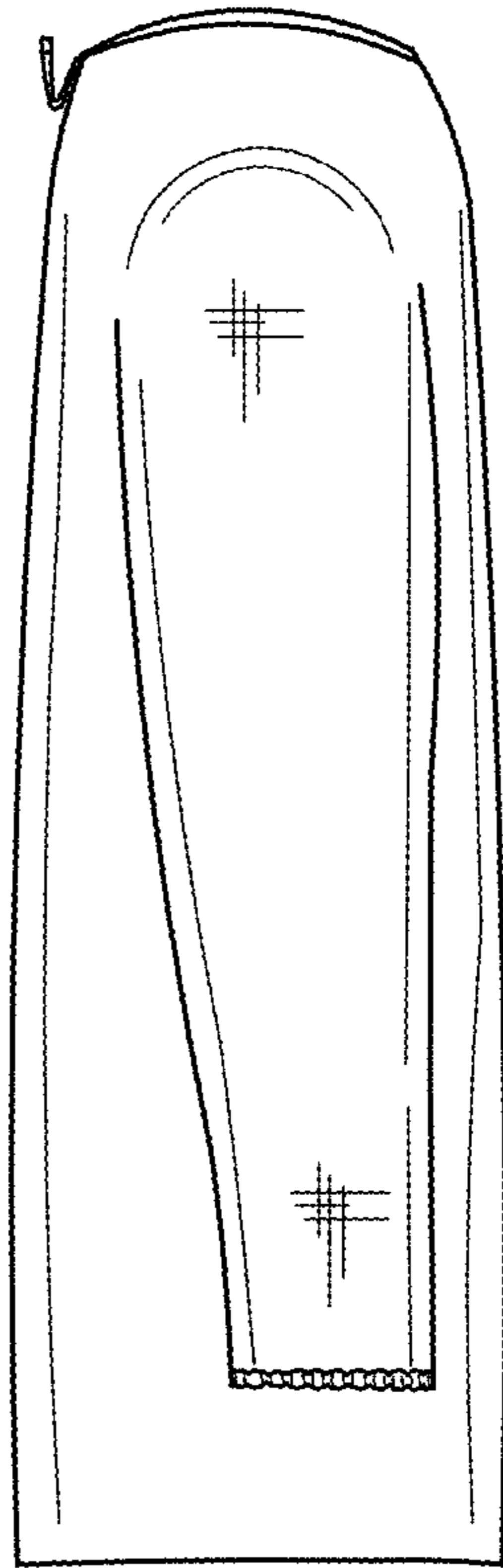

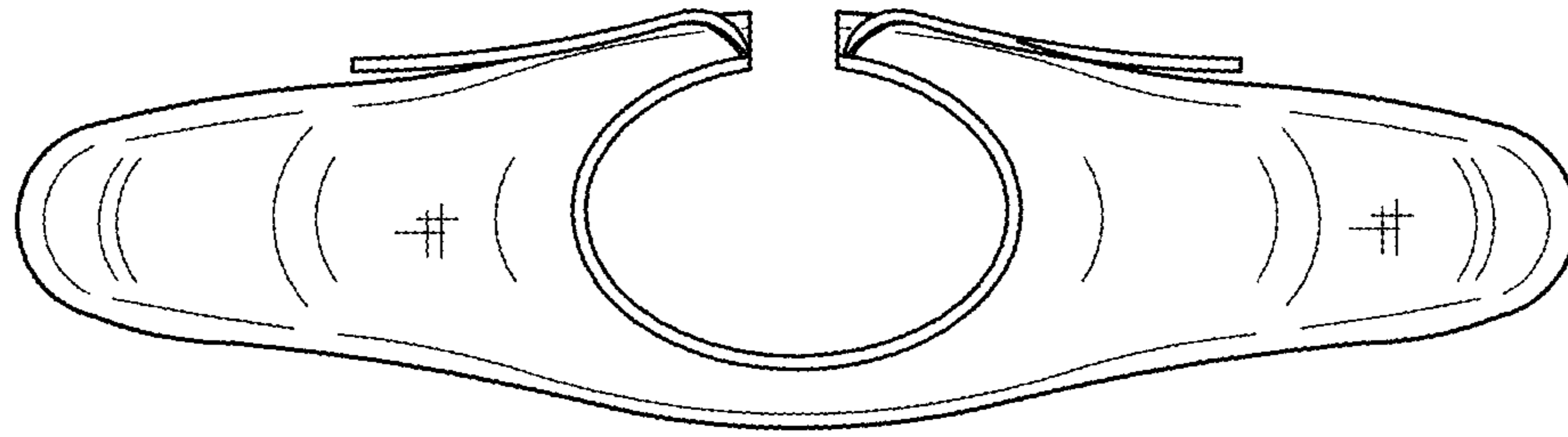

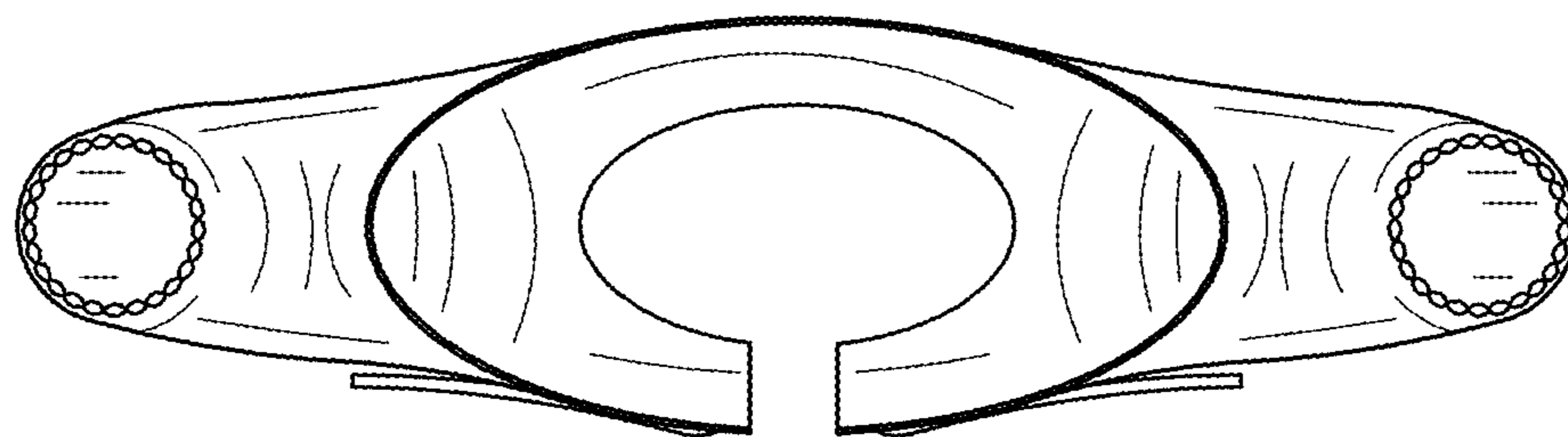
