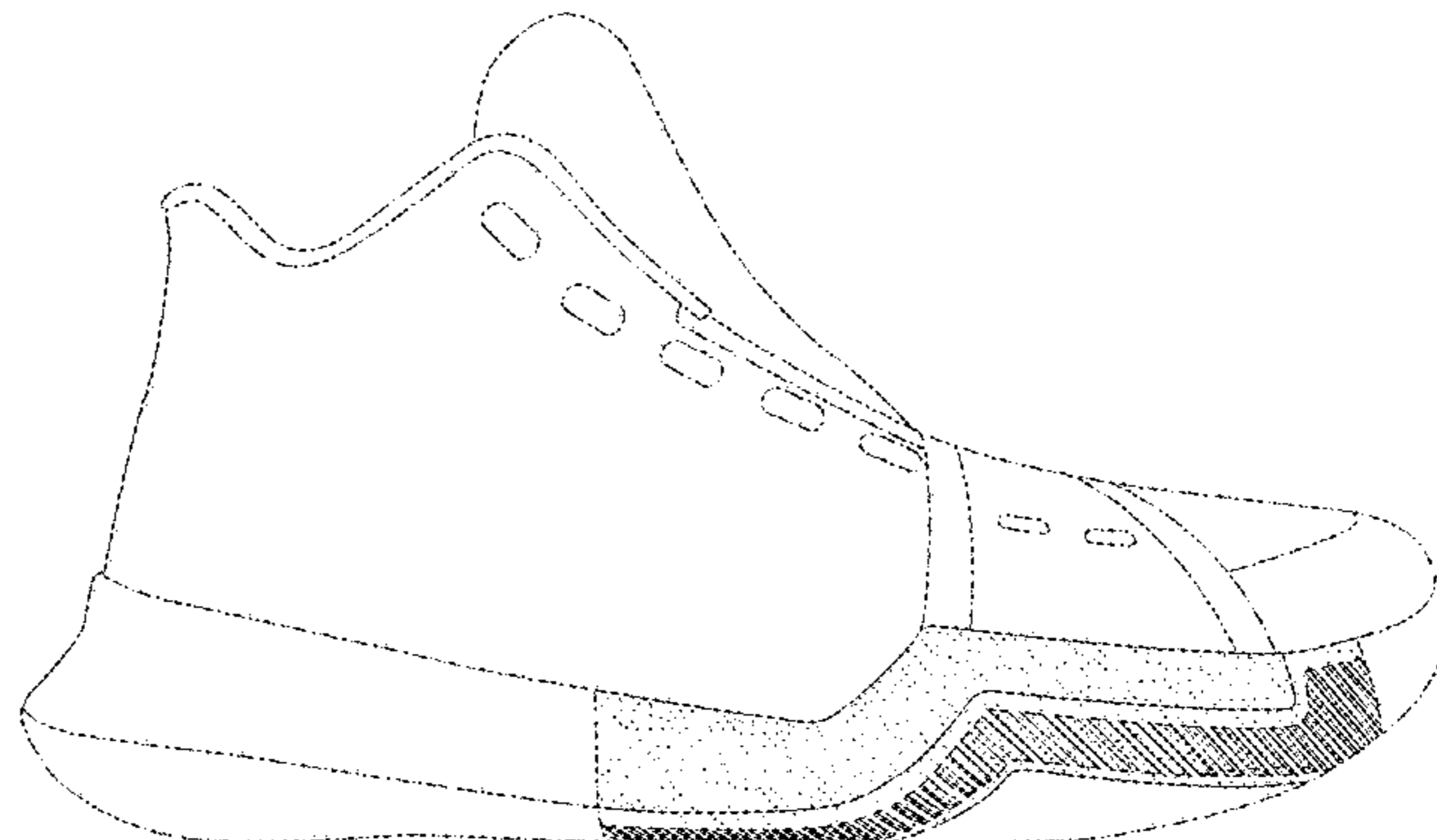
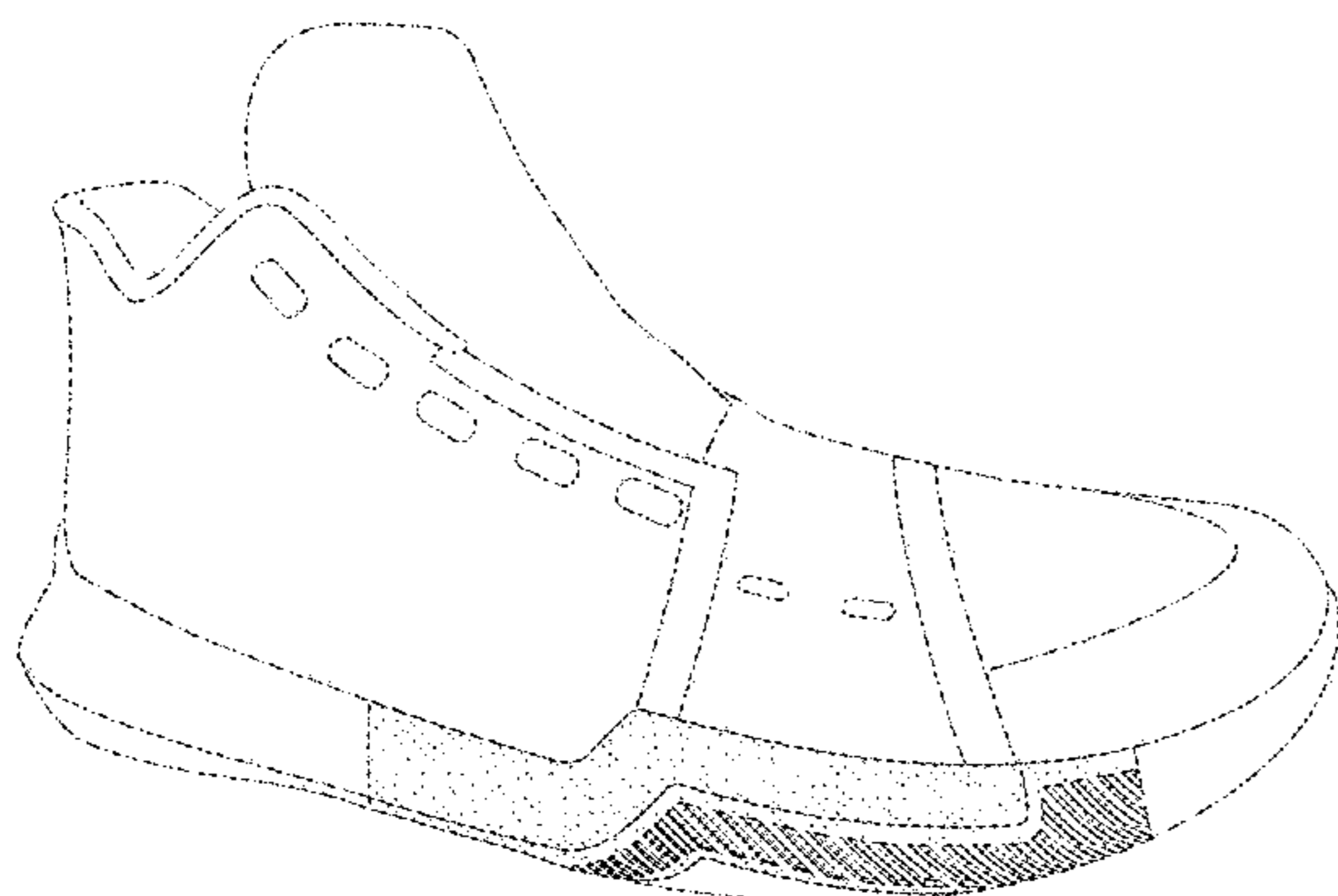
(57) **CLAIM**

The ornamental design for a shoe sole, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a shoe sole showing my new design;
FIG. 2 is a side view thereof; and,

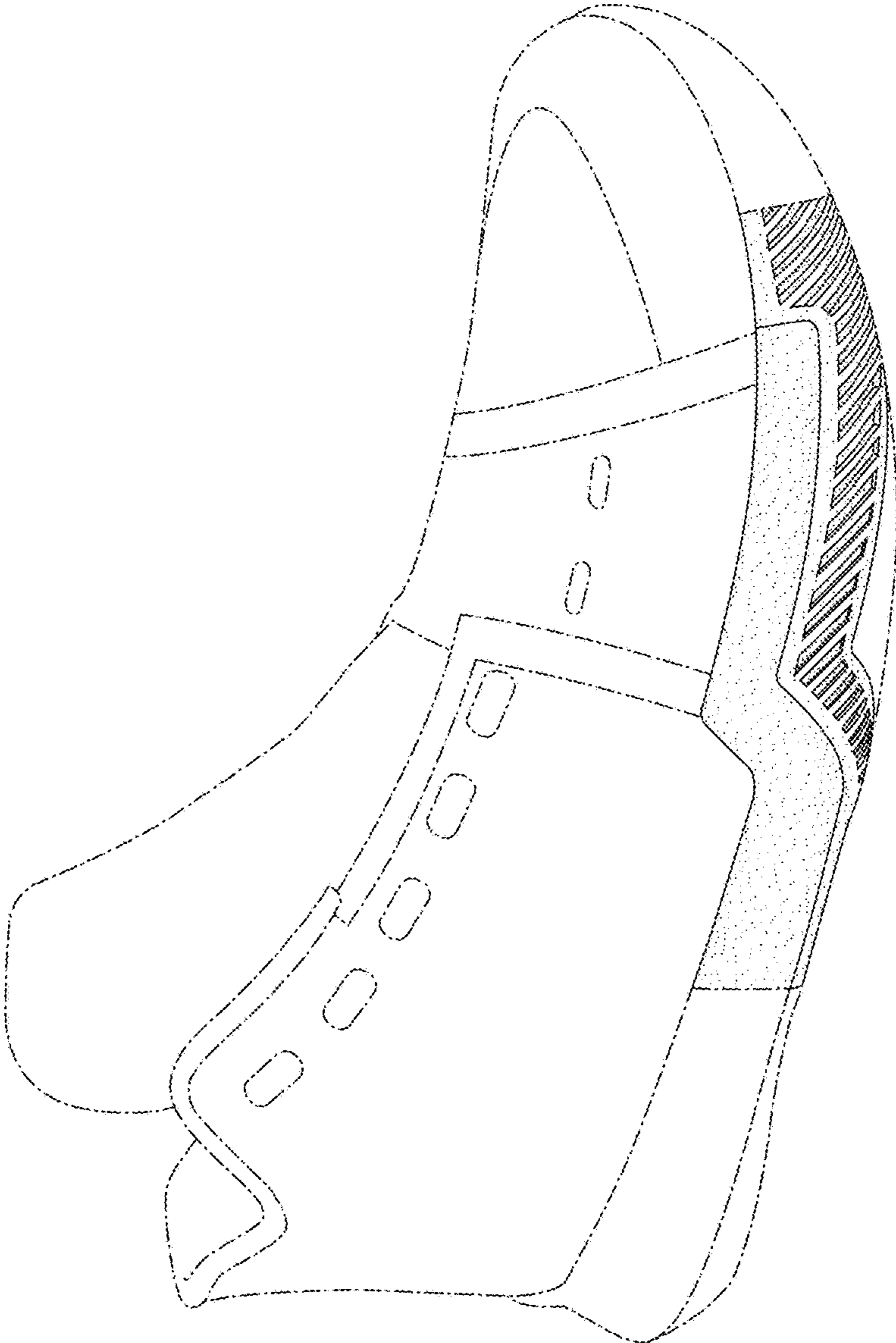

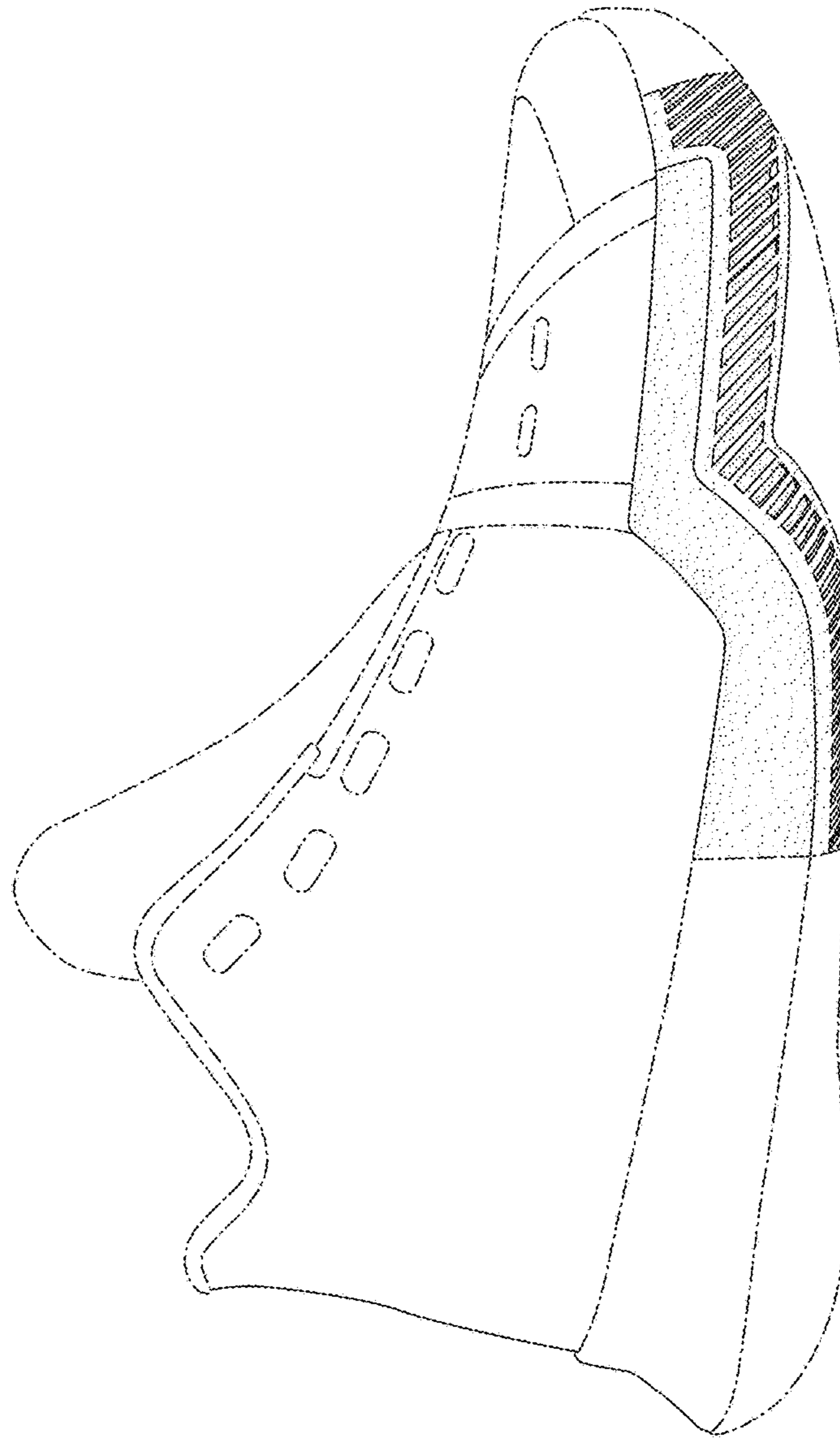

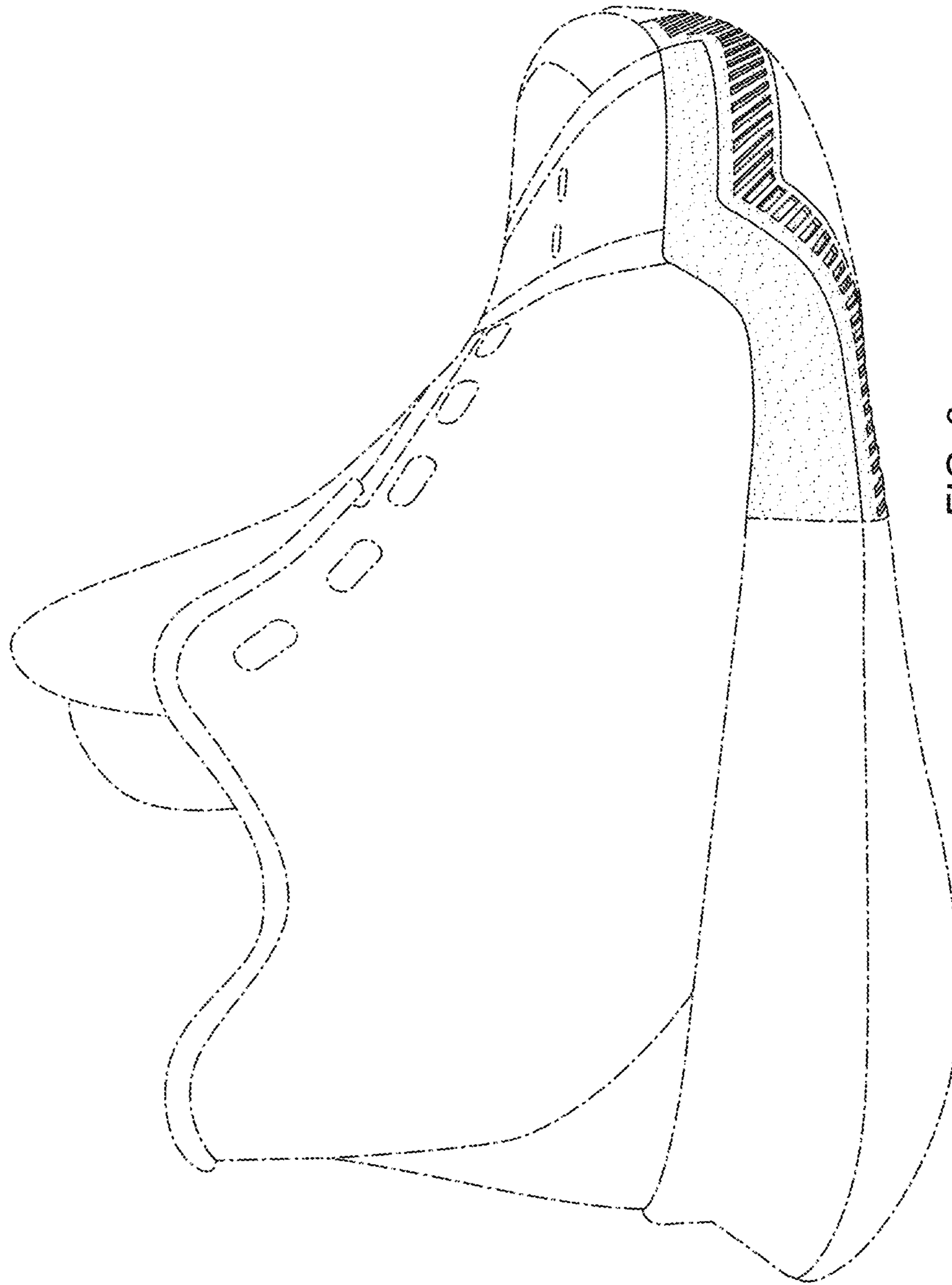
