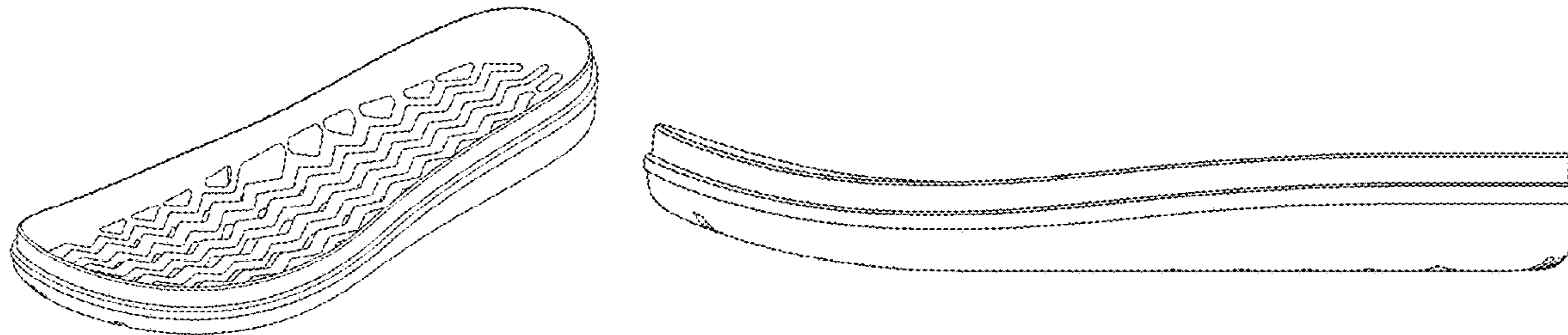
(57) **CLAIM**

The ornamental design for a shoe outsole, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the shoe outsole;
FIG. 2 is a front view of the shoe outsole;
FIG. 3 is a rear view of the shoe outsole;
FIG. 4 is a left side view of the shoe outsole;
FIG. 5 is a right side view of the shoe outsole;
FIG. 6 is a top plan view of the shoe outsole;
FIG. 7 is a bottom plan view of the shoe outsole; and,
FIG. 8 is an enlarged cross-section view of the shoe outsole
taken along line 8-8 in FIG. 7.
The broken lines seen in FIG. 7 are for the purpose of
explaining the location of the cross-sectional view of FIG. 8,
and form no part of the claimed design.

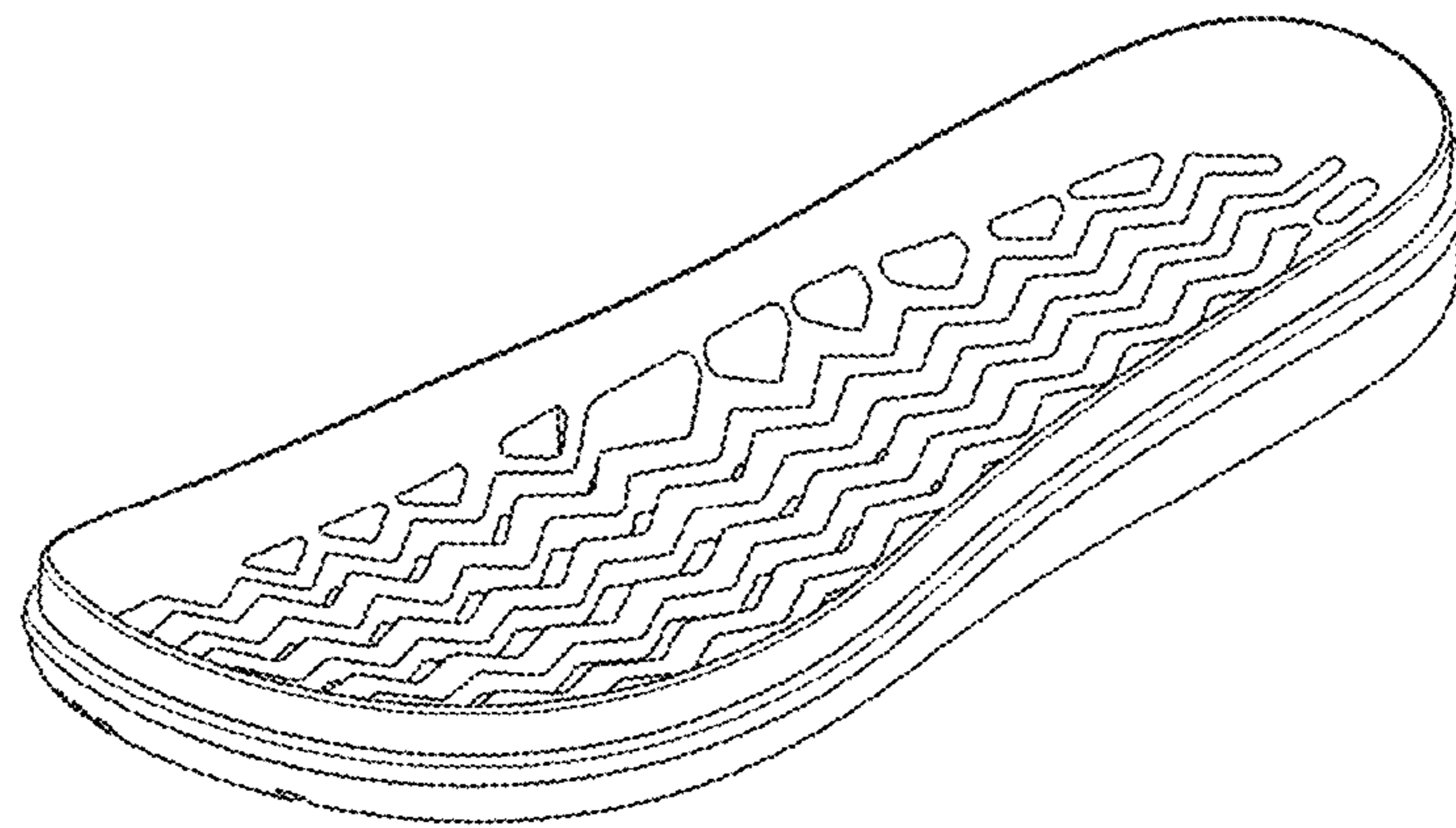

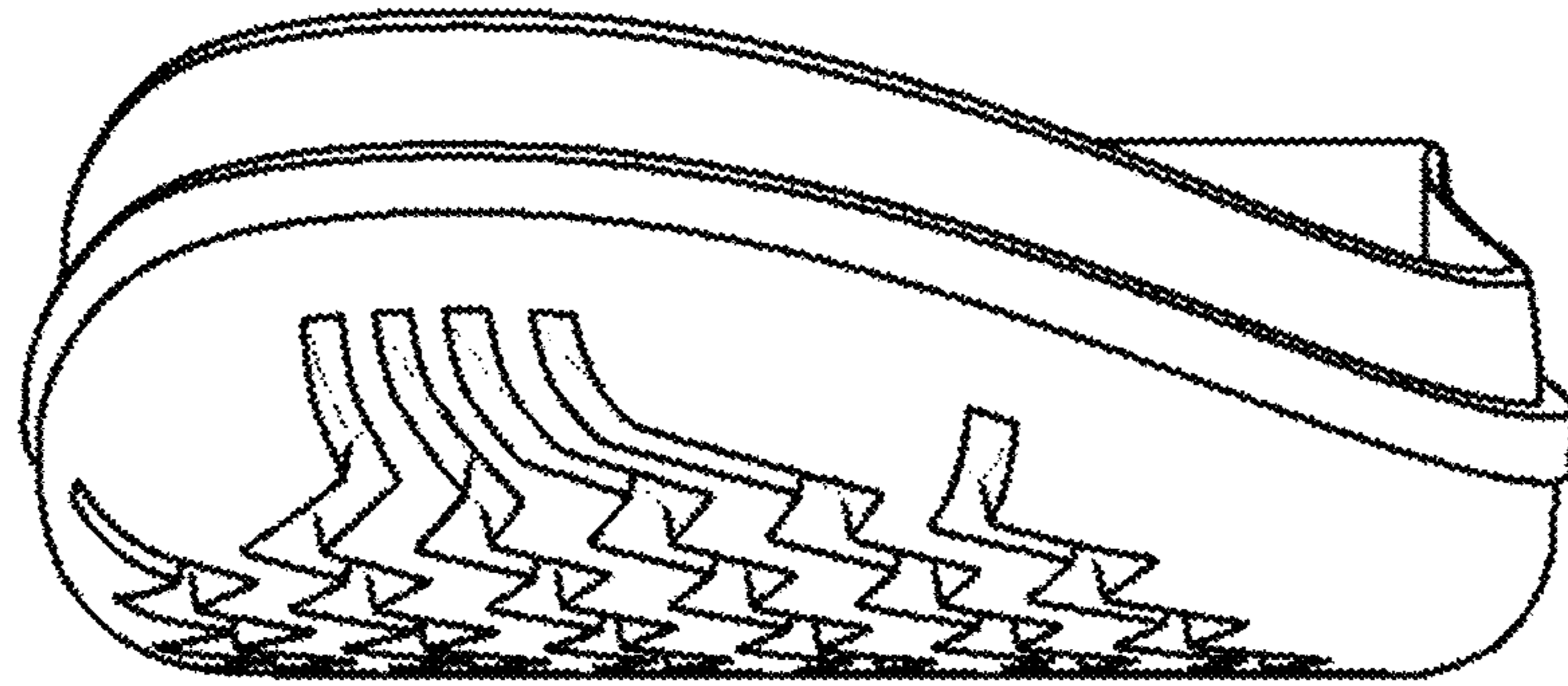

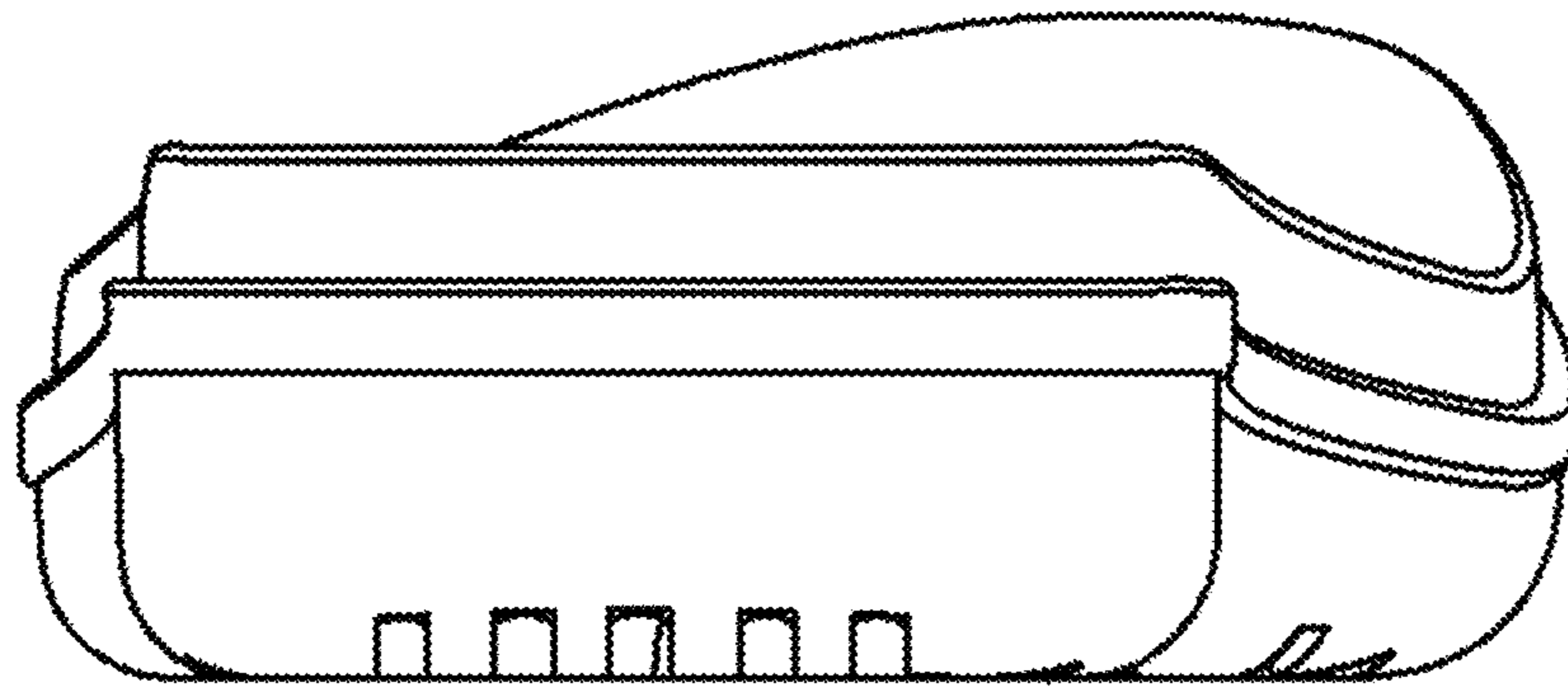

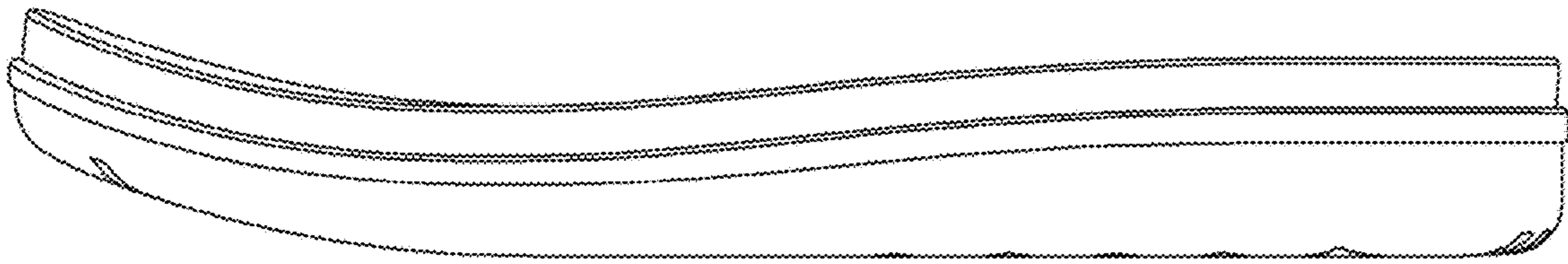

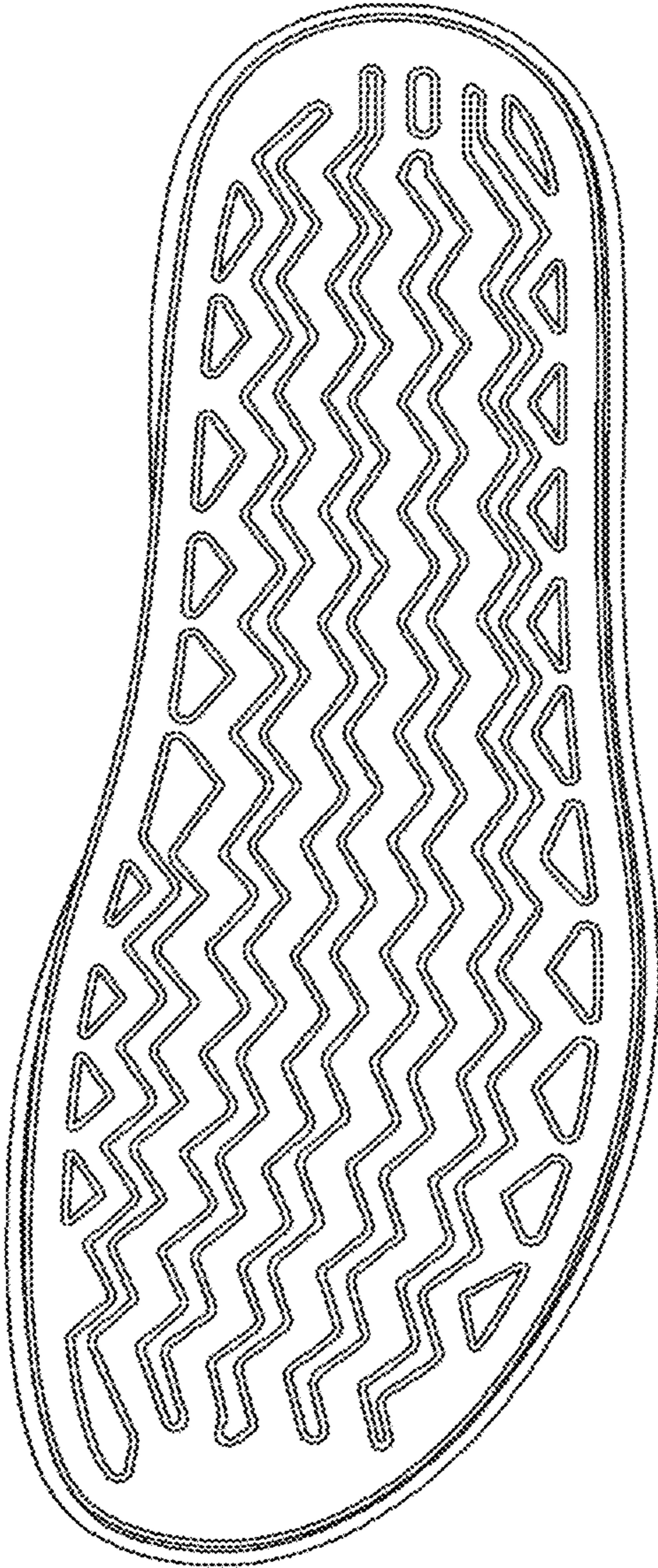

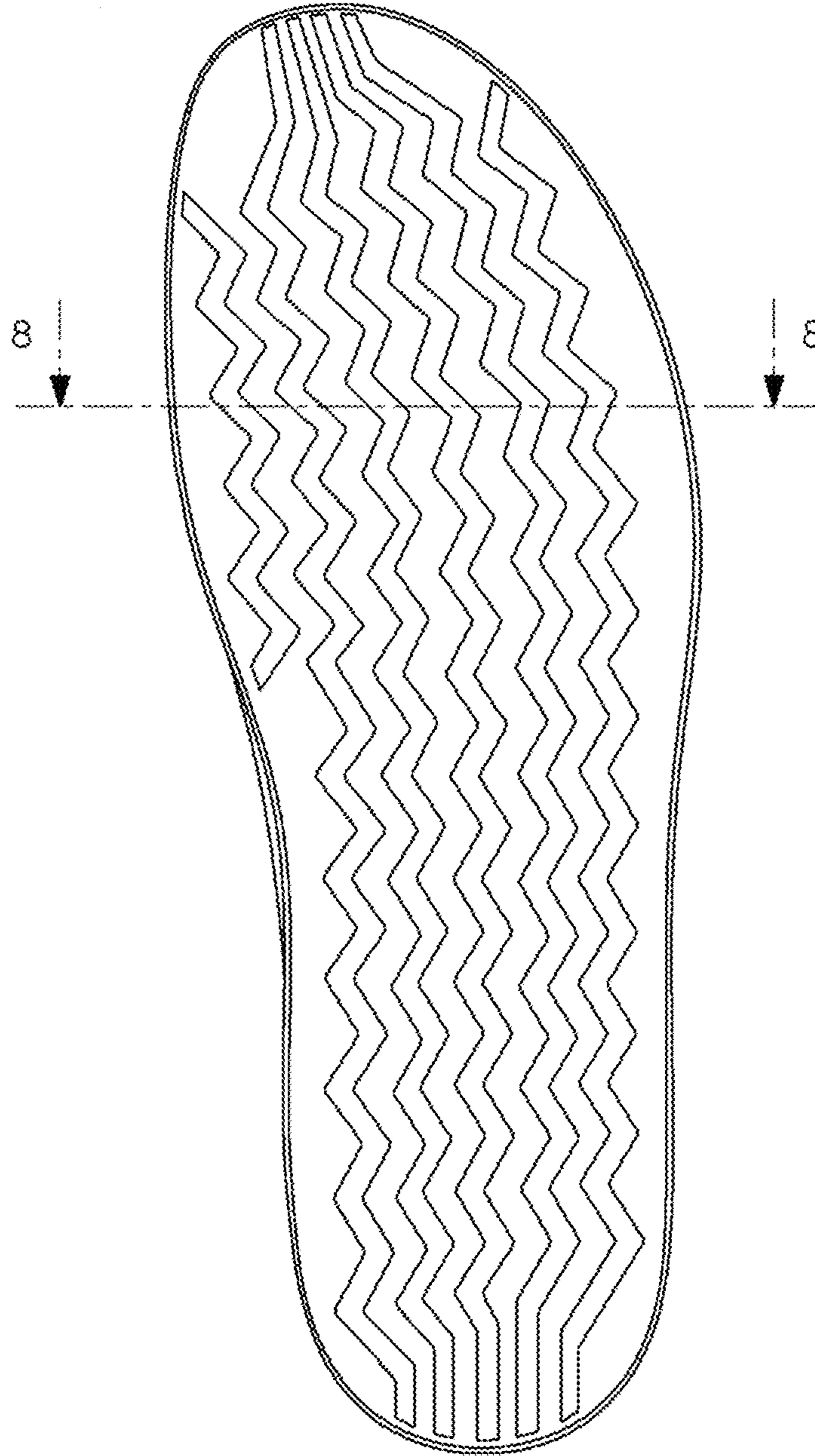

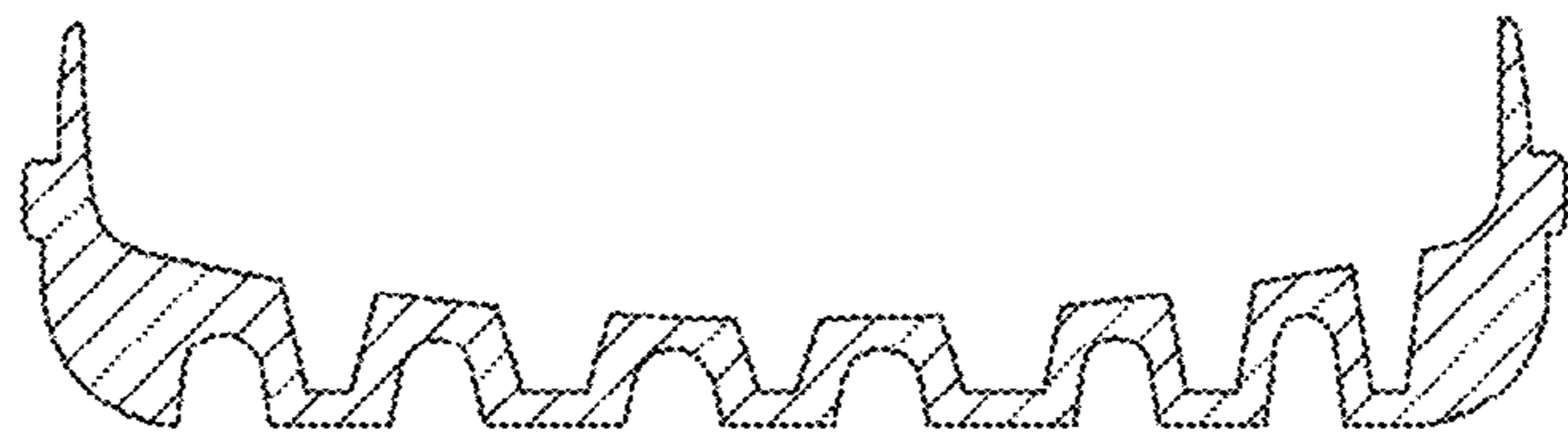
