The ornamental design for a shoe upper, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of a shoe upper showing my new design;

FIG. 2 is a side view thereof;

FIG. 3 is a second side view thereof;

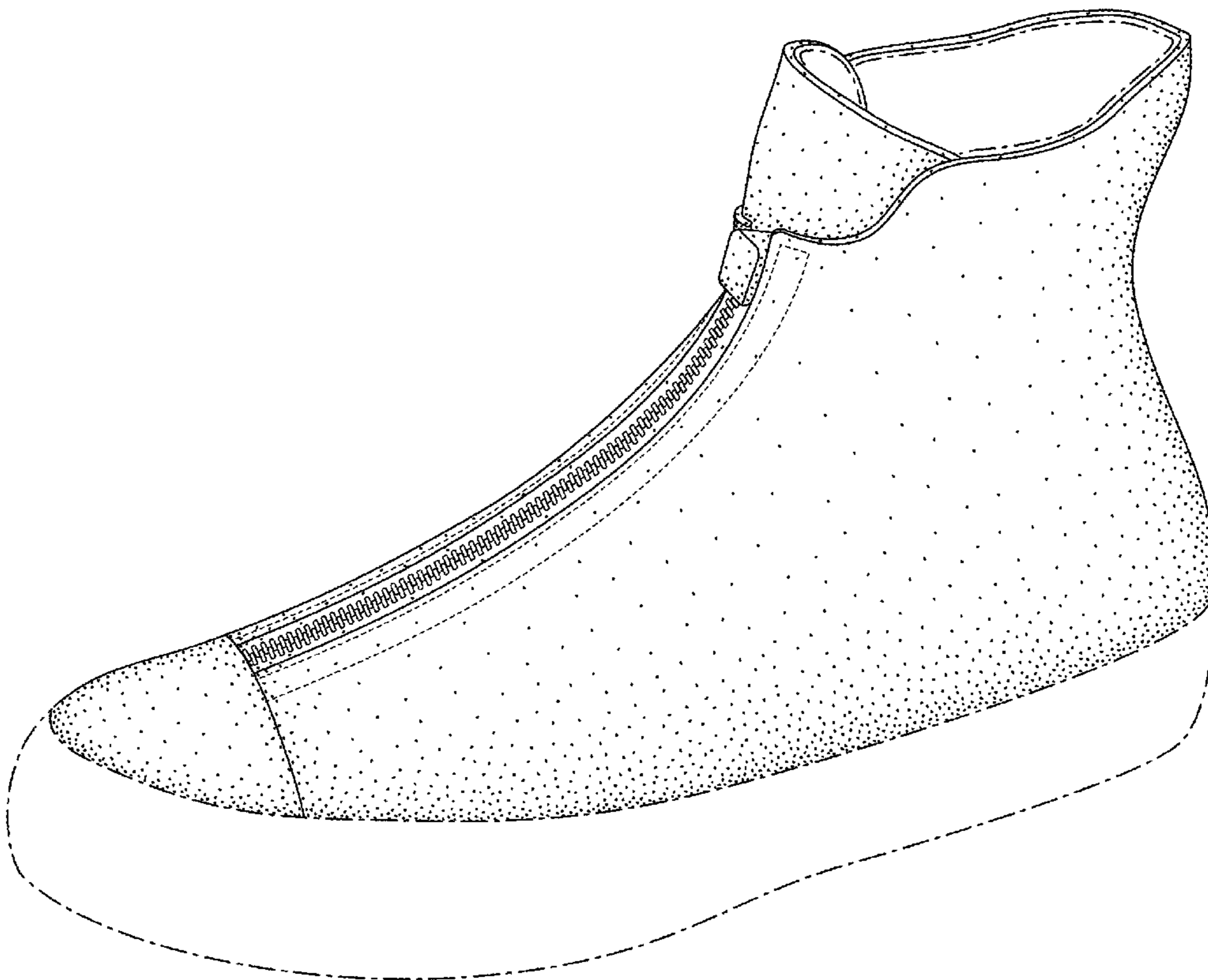
FIG. 4 is a front view thereof;

The even-length broken lines within the shaded area represent stitching. The uneven-length broken lines immediately adjacent to the shaded area represent unclaimed boundaries of the design. 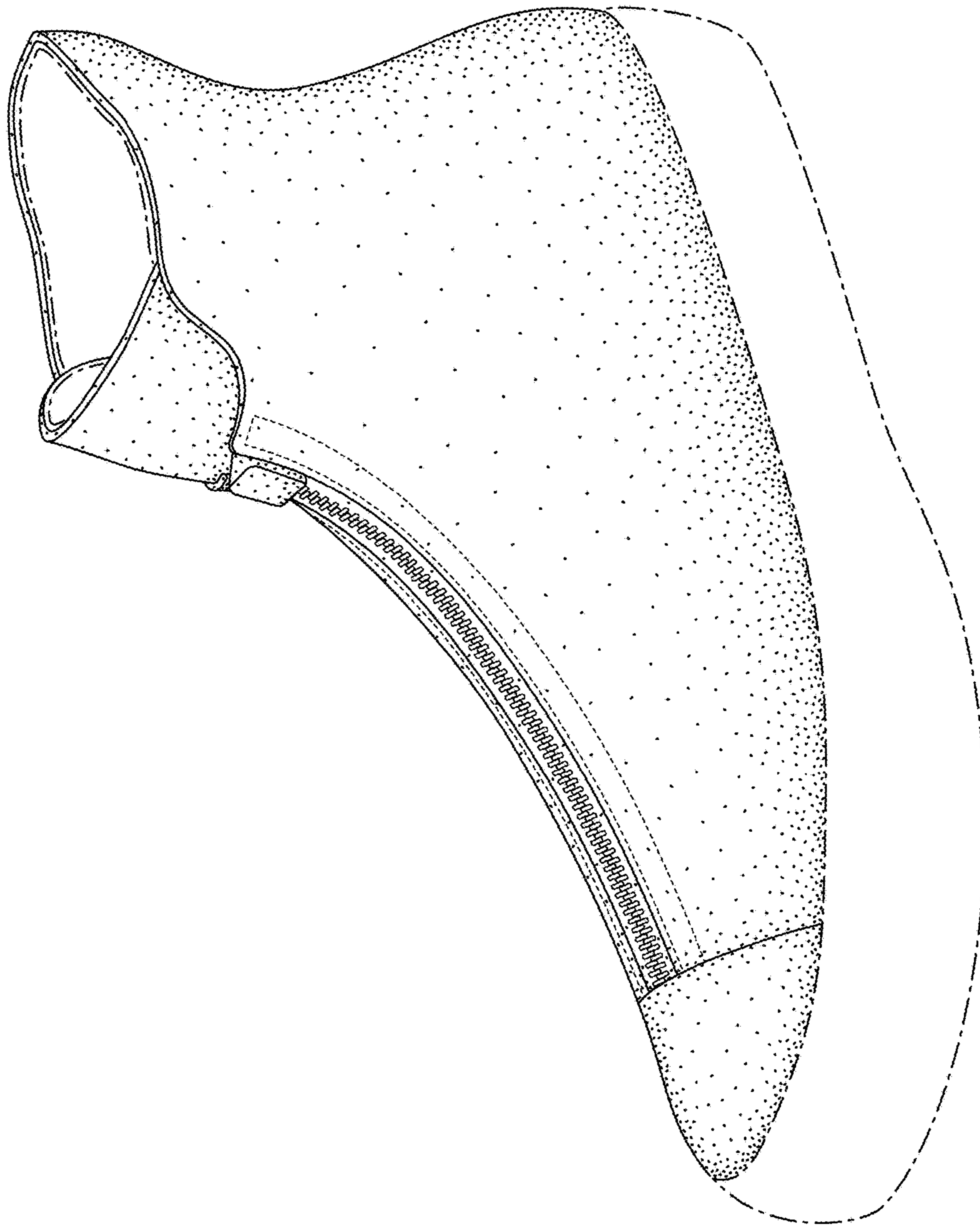

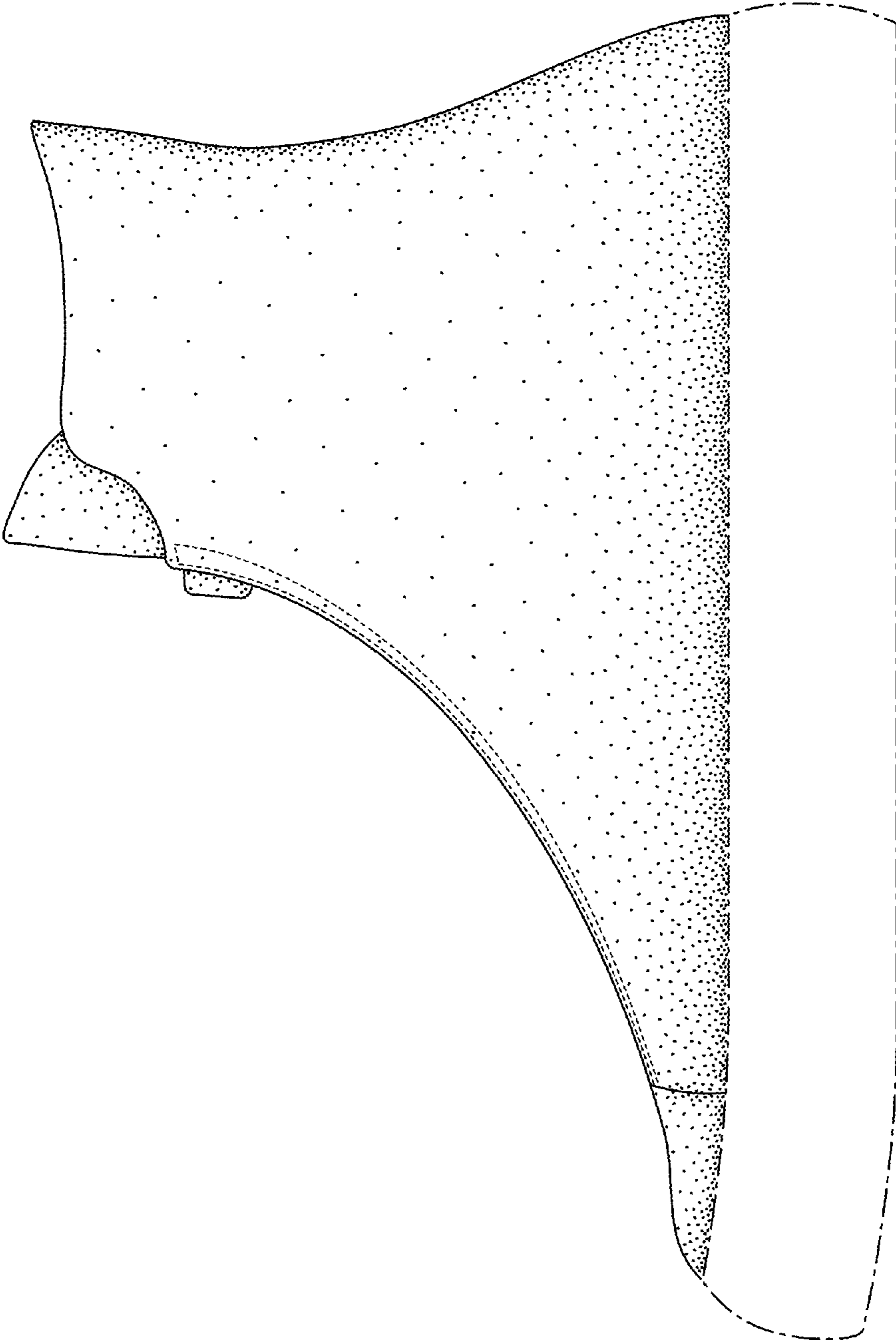

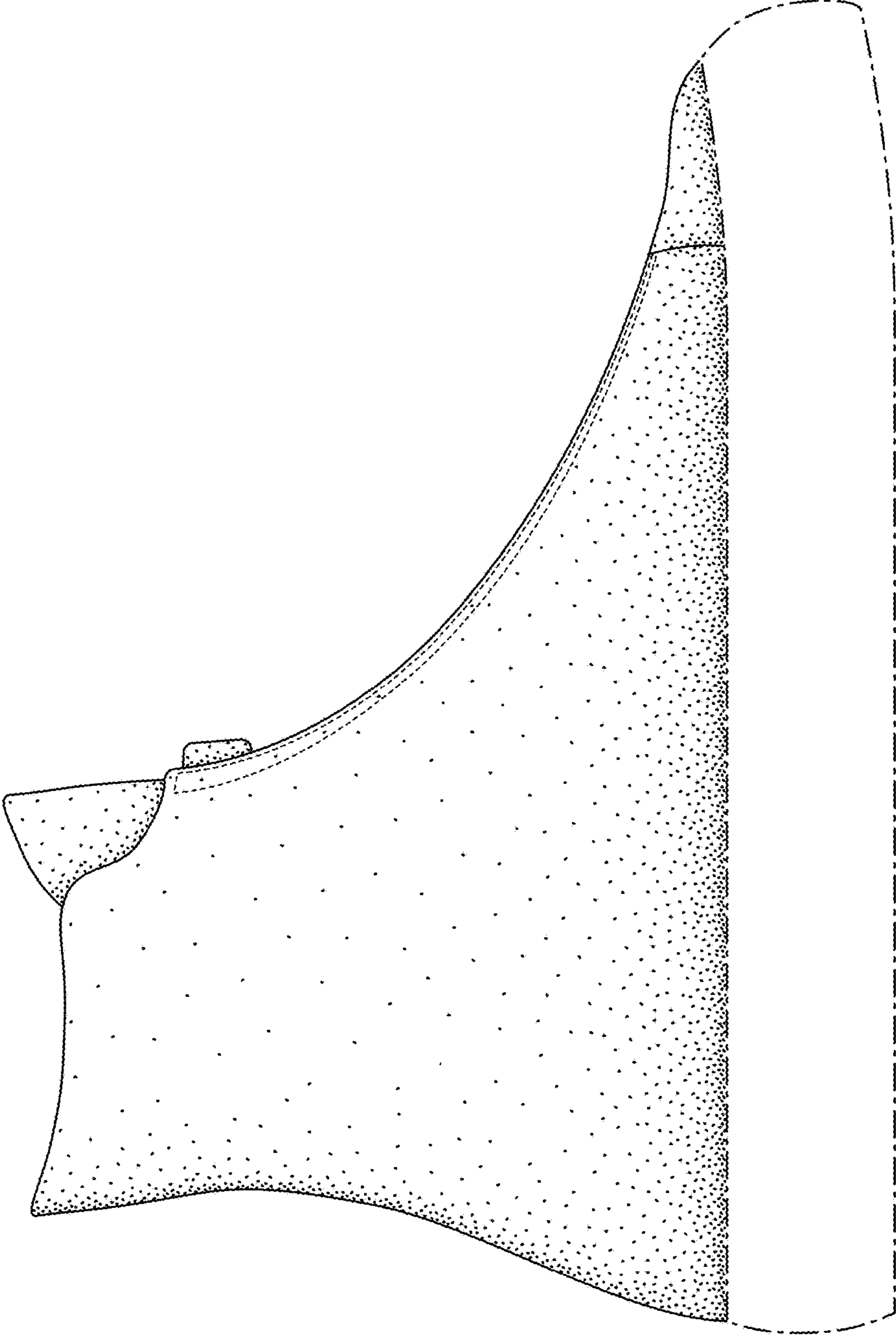

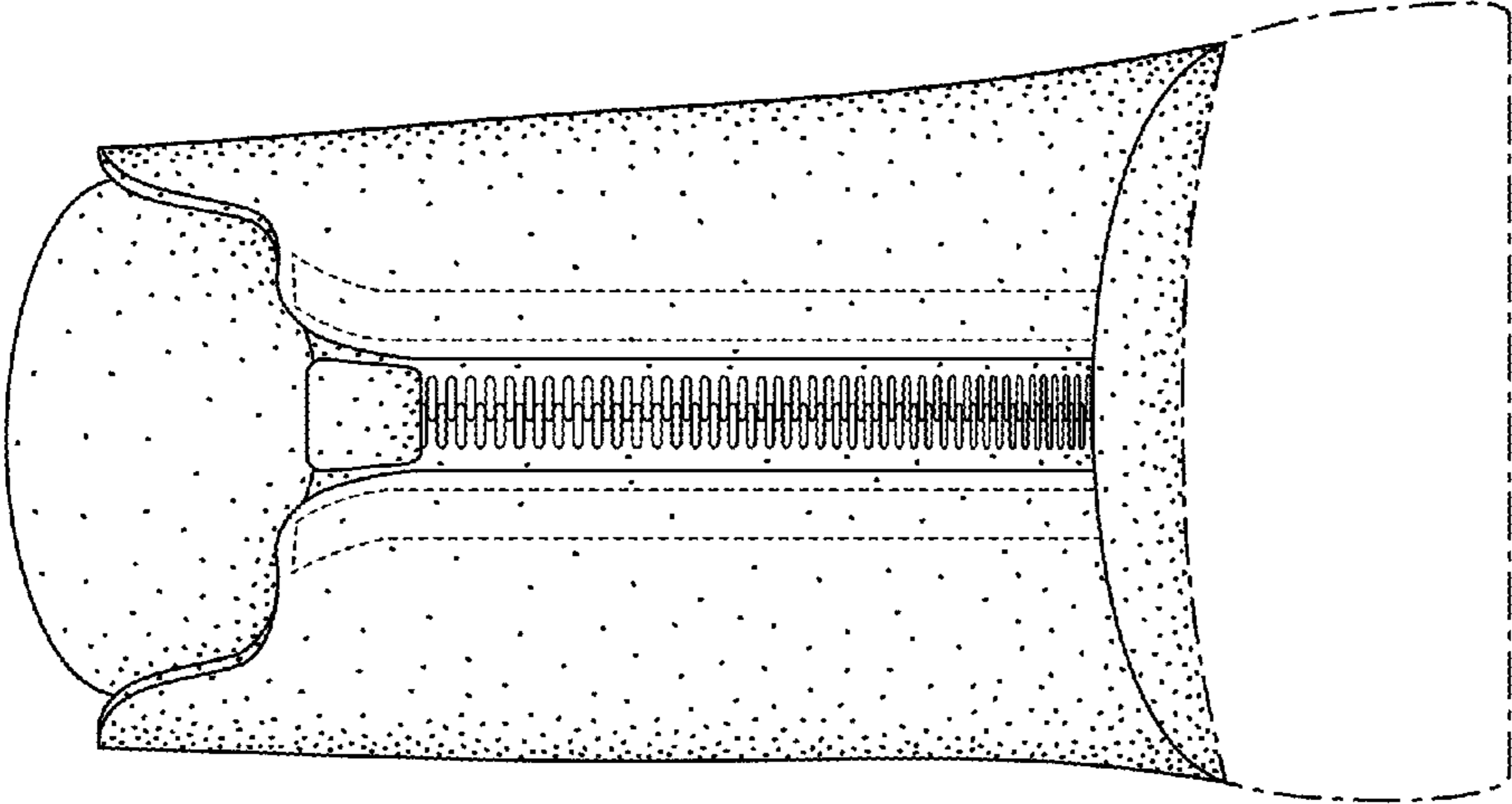

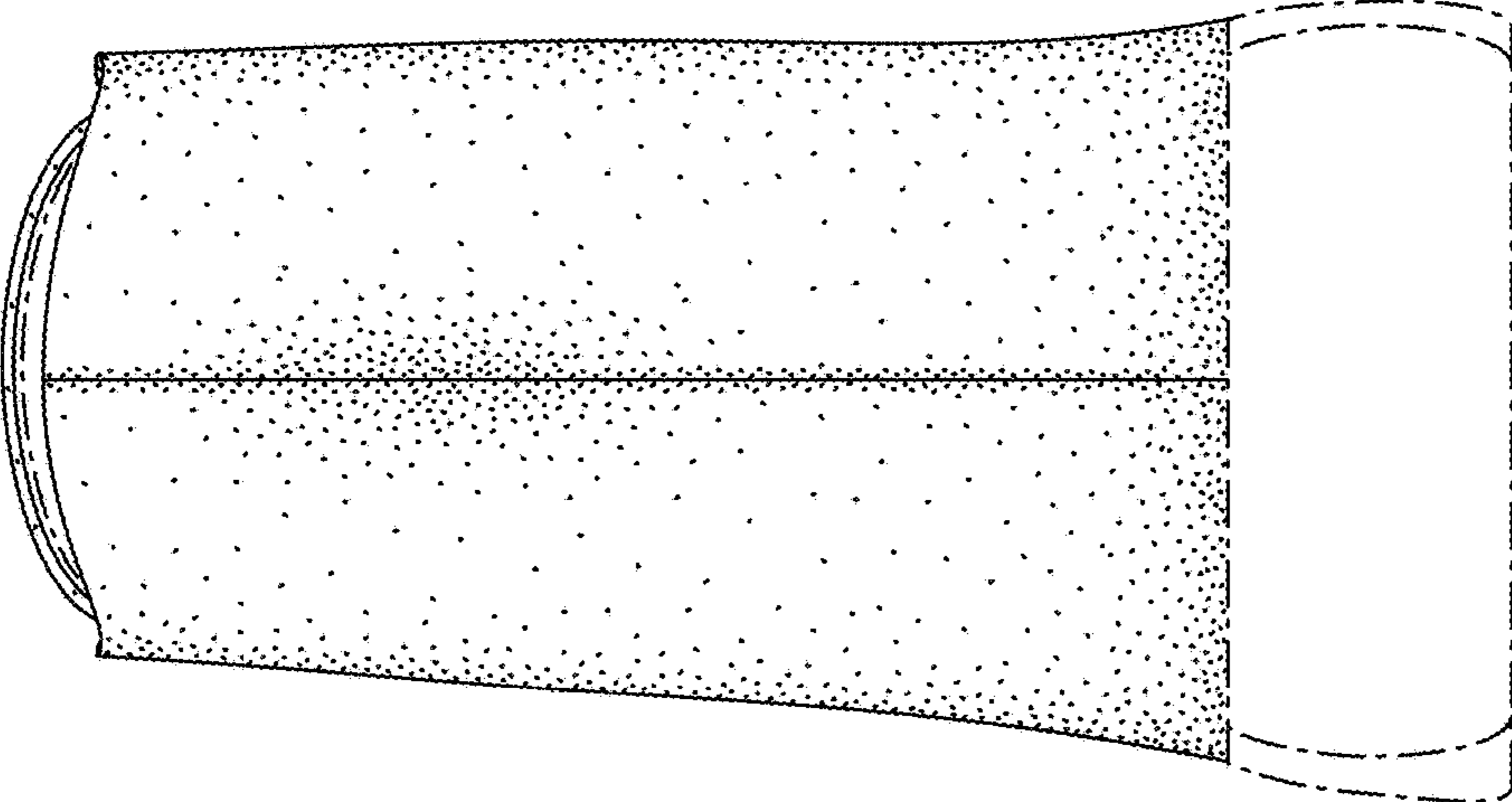

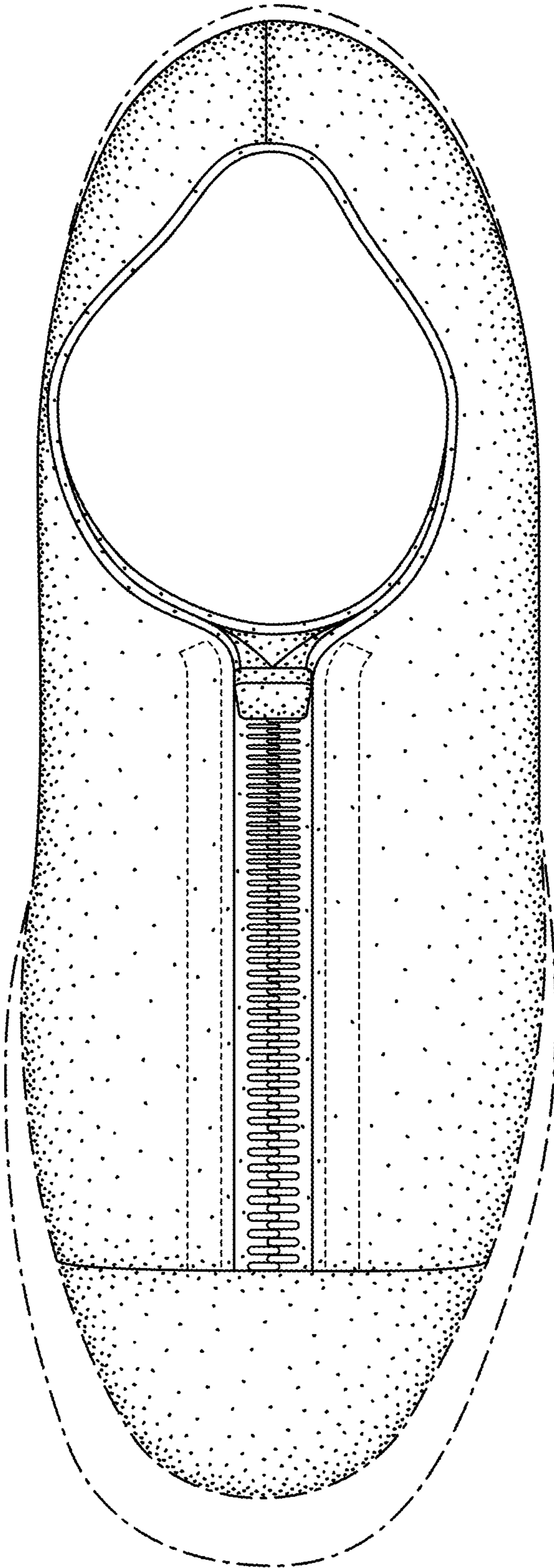
