The ornamental design for a shoe upper, as shown and described.

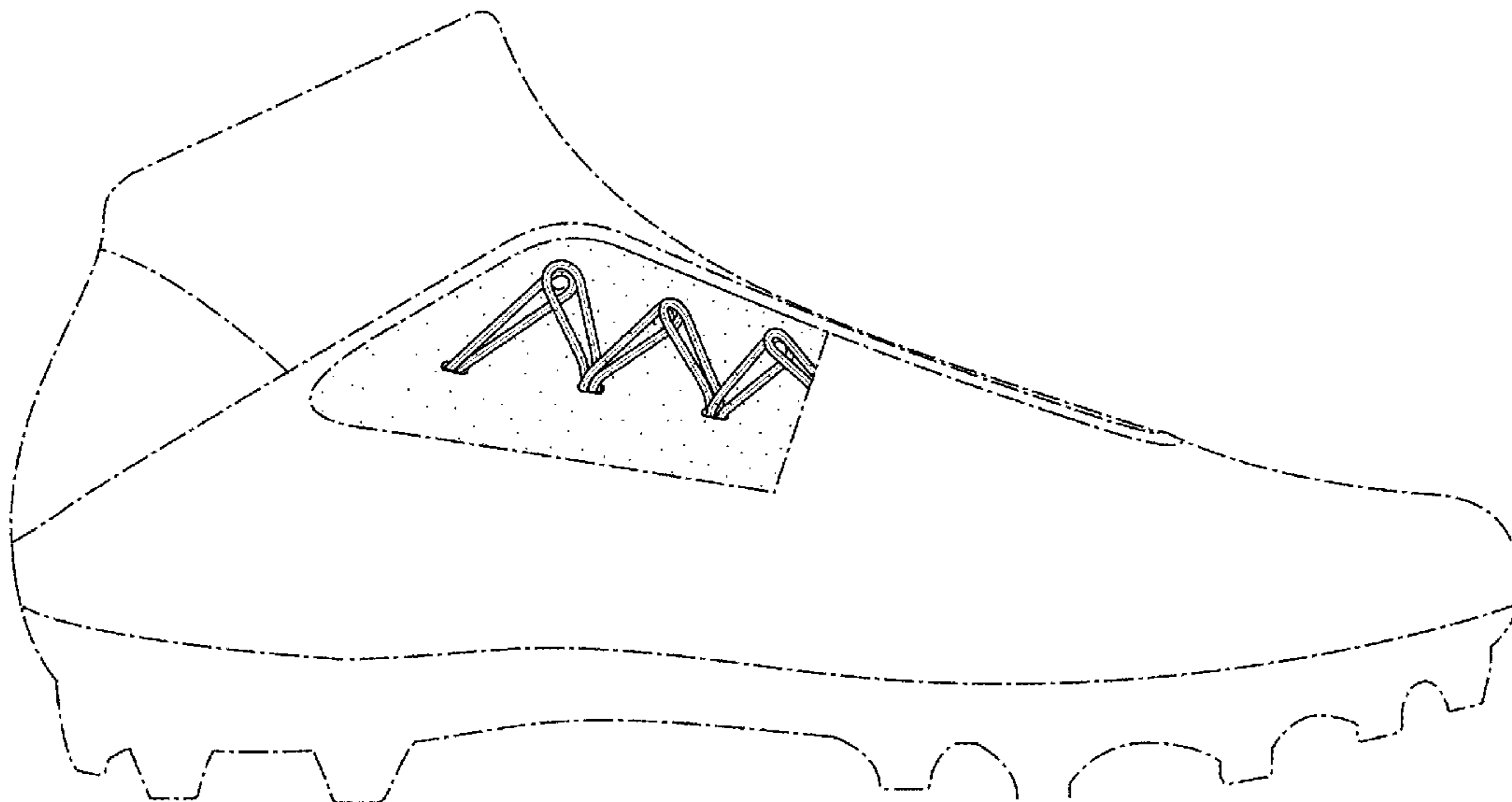
DESCRIPTION

FIG. 1 is a front perspective view of a shoe upper showing my new design;
FIG. 2 is a side view thereof; and,
FIG. 3 is a rear perspective view thereof.
The broken line adjacent to the front, rear, and bottom of the shaded area represents an unclaimed boundaries of the design. The broken lines showing the circular holes and unshaded regions within or adjacent to the shaded area form no part of the claimed design. The broken lines showing the remainder of the shoe are for environmental purposes only and form no part of the claimed design.

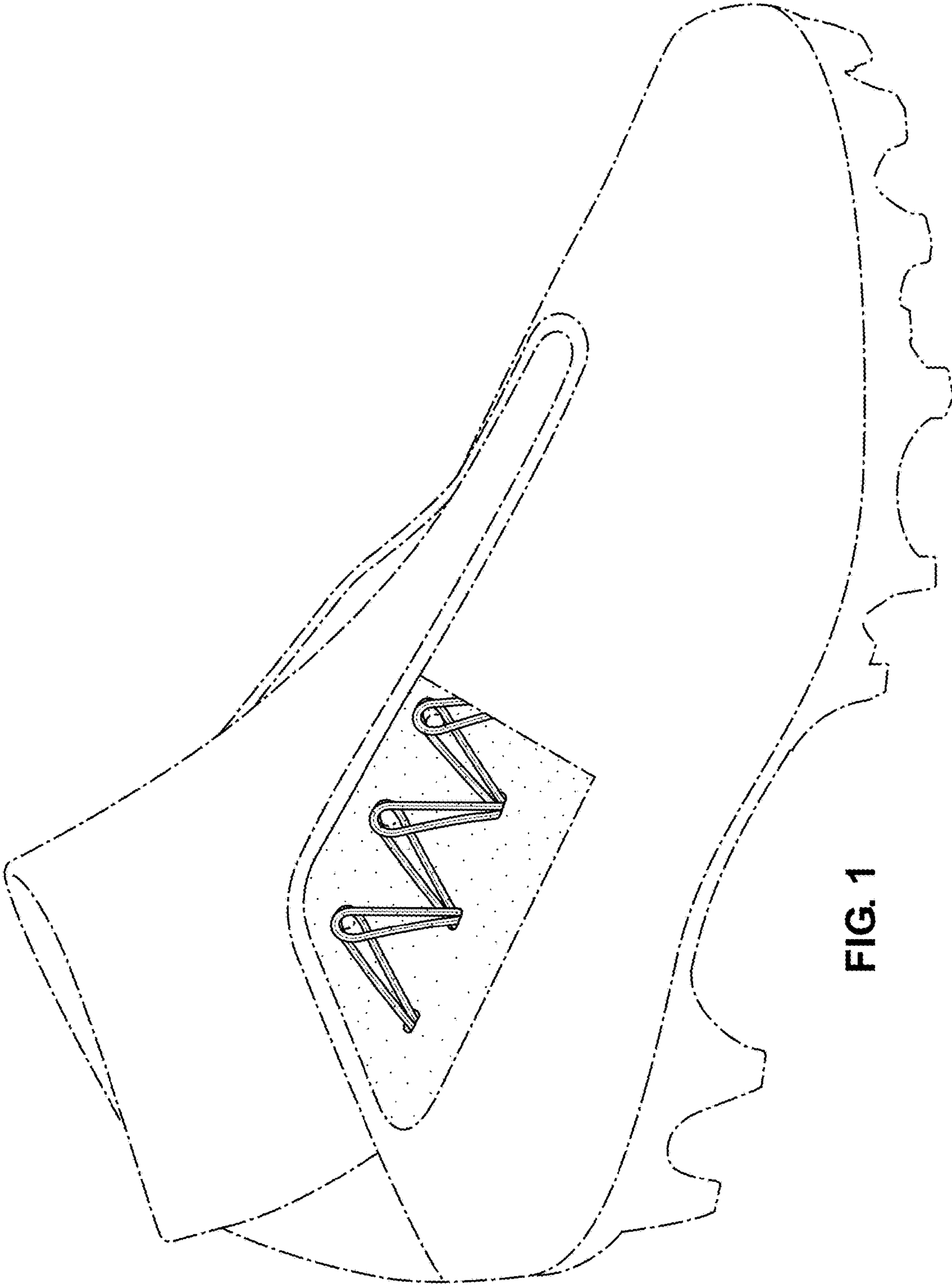

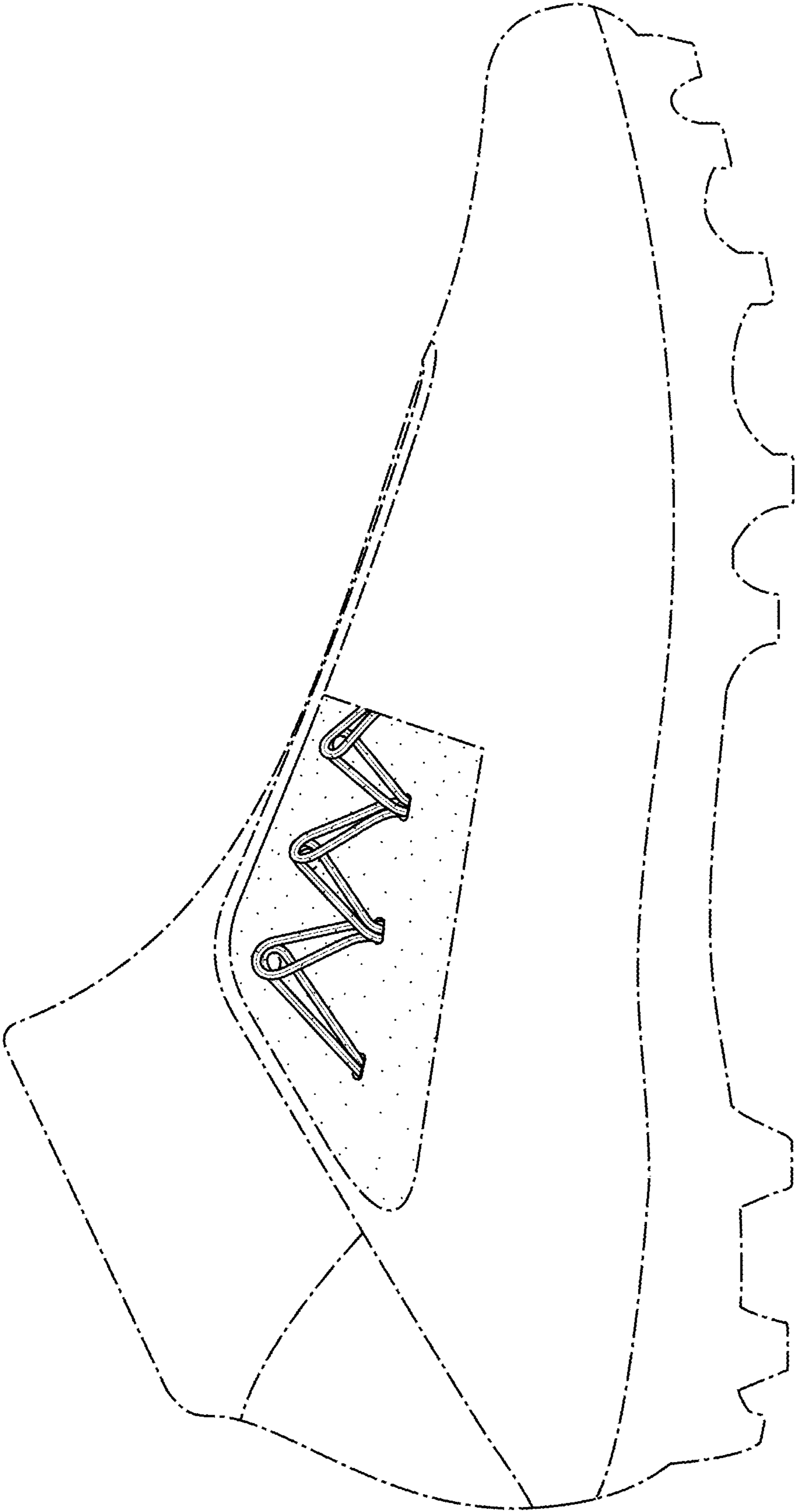

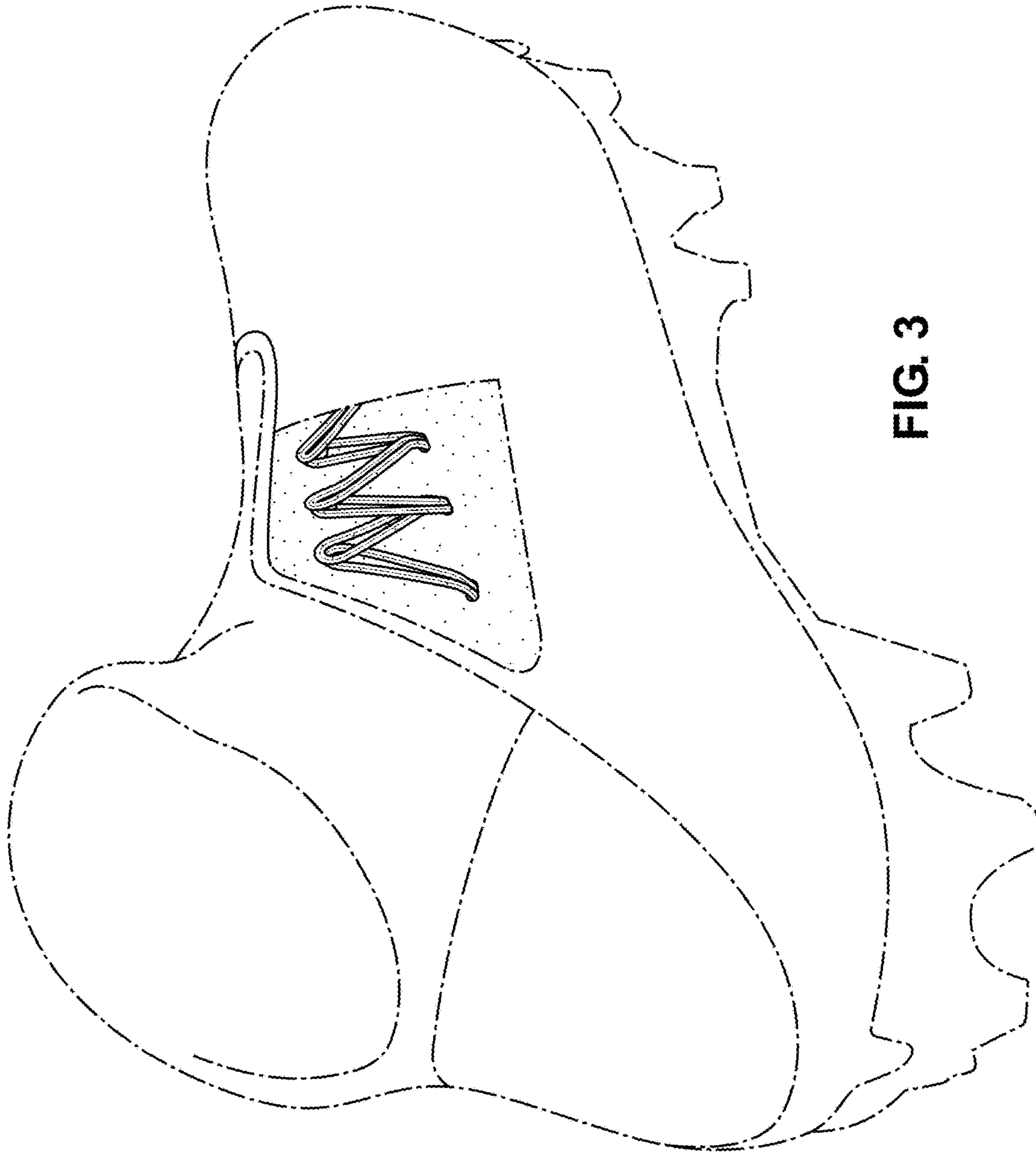
