(57) **CLAIM**

The ornamental design for a wrench, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a wrench according to an embodiment of the invention. The view from the opposite side being a mirror image thereof.

FIG. 2 is a right-side view of the wrench depicted in FIG. 1.

FIG. 3 is a left-side view of the wrench depicted in FIG. 1.

FIG. 4 is a top view of the wrench depicted in FIG. 1.

FIG. 5 is a bottom view of the wrench depicted in FIG. 1.

FIG. 6 is a front view of the wrench depicted in FIG. 1.

FIG. 7 is a rear view of the wrench depicted in FIG. 1.

FIG. 8 is a perspective view of a wrench according to another embodiment of the invention. The view from the opposite side being a mirror image thereof.

FIG. 9 is a right-side view of the wrench depicted in FIG. 8.

FIG. 10 is a left-side view of the wrench depicted in FIG. 8.

FIG. 11 is a top view of the wrench depicted in FIG. 8.

FIG. 12 is a bottom view of the wrench depicted in FIG. 8.

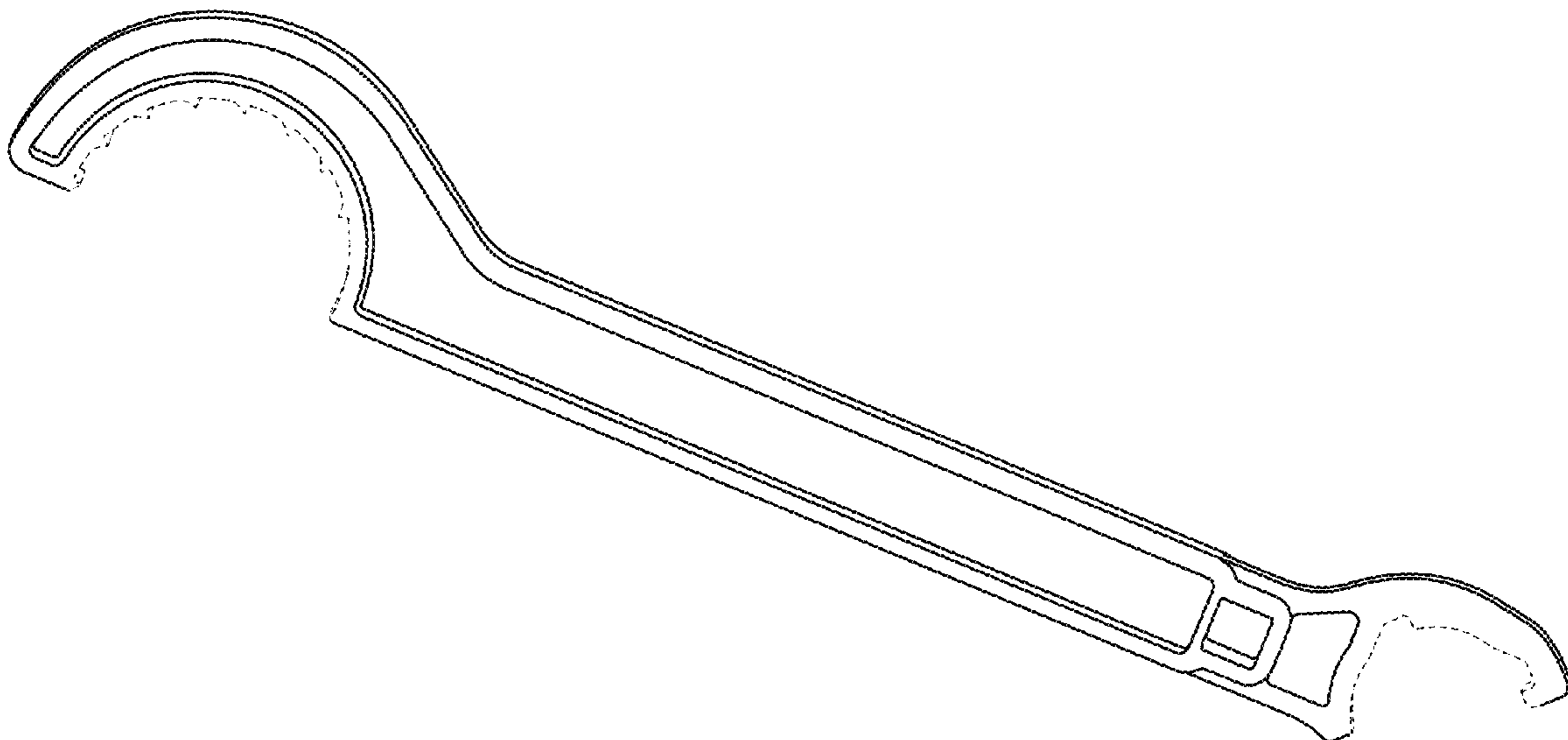
FIG. 13 is a front view of the wrench depicted in FIG. 8; and,

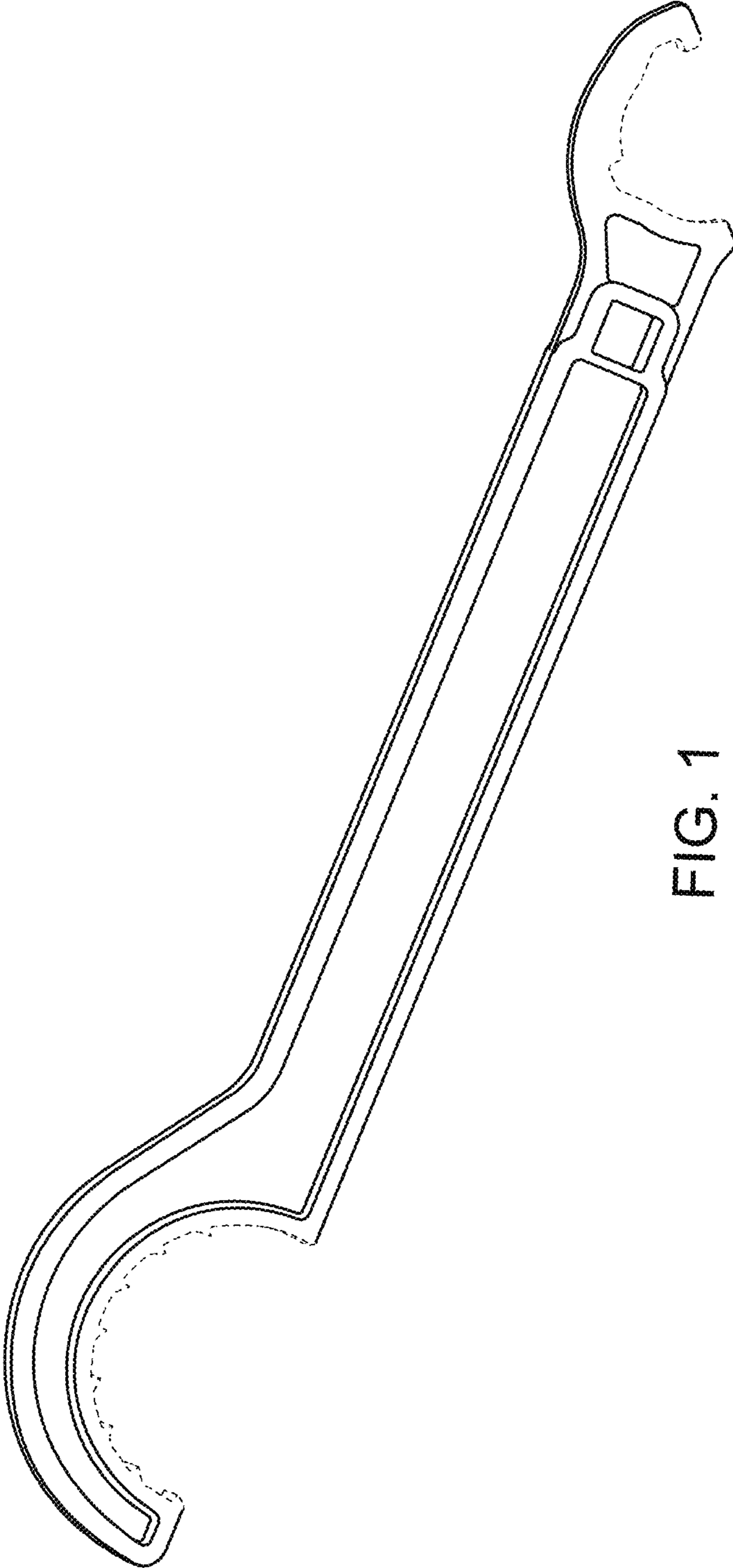

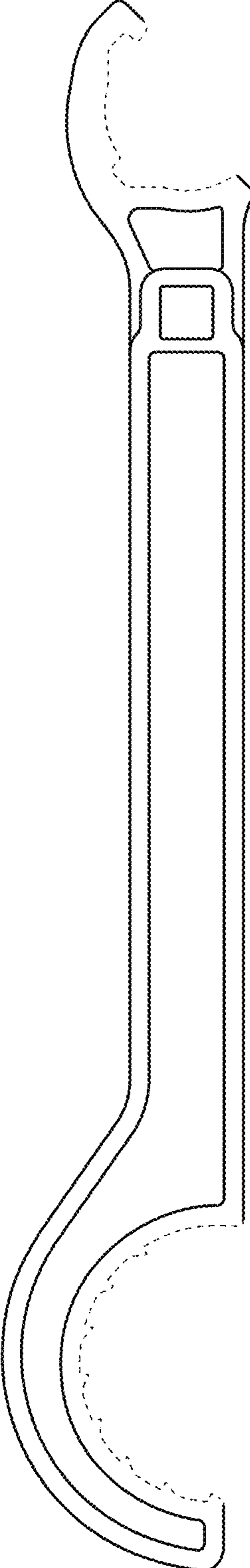

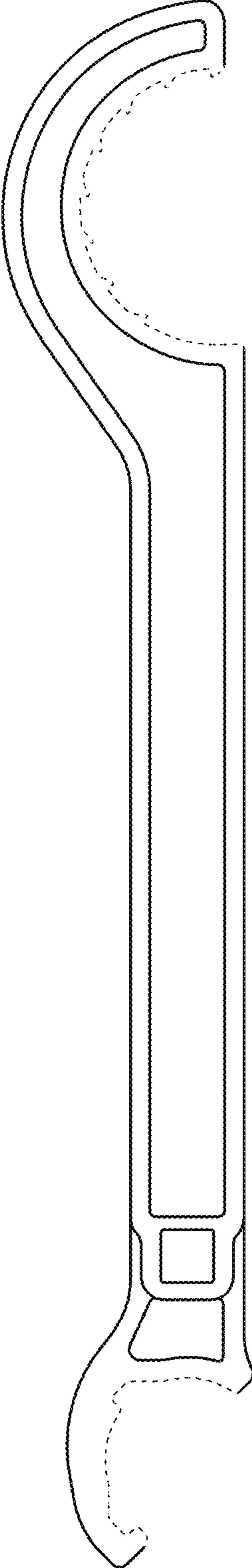

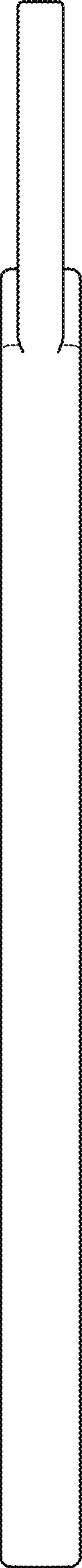

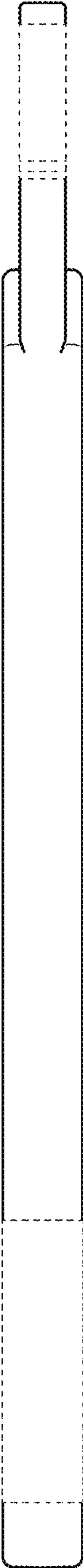

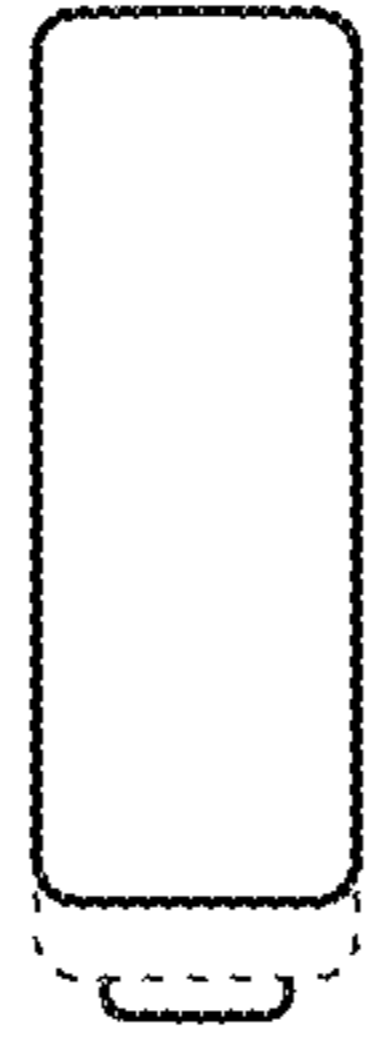

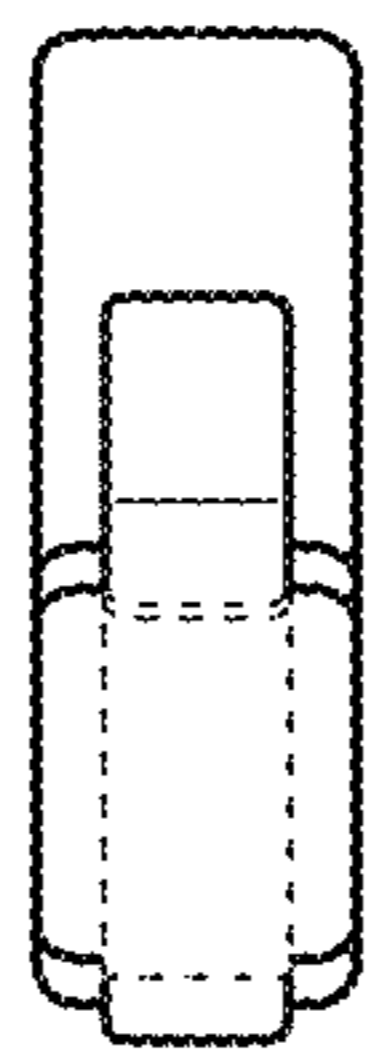

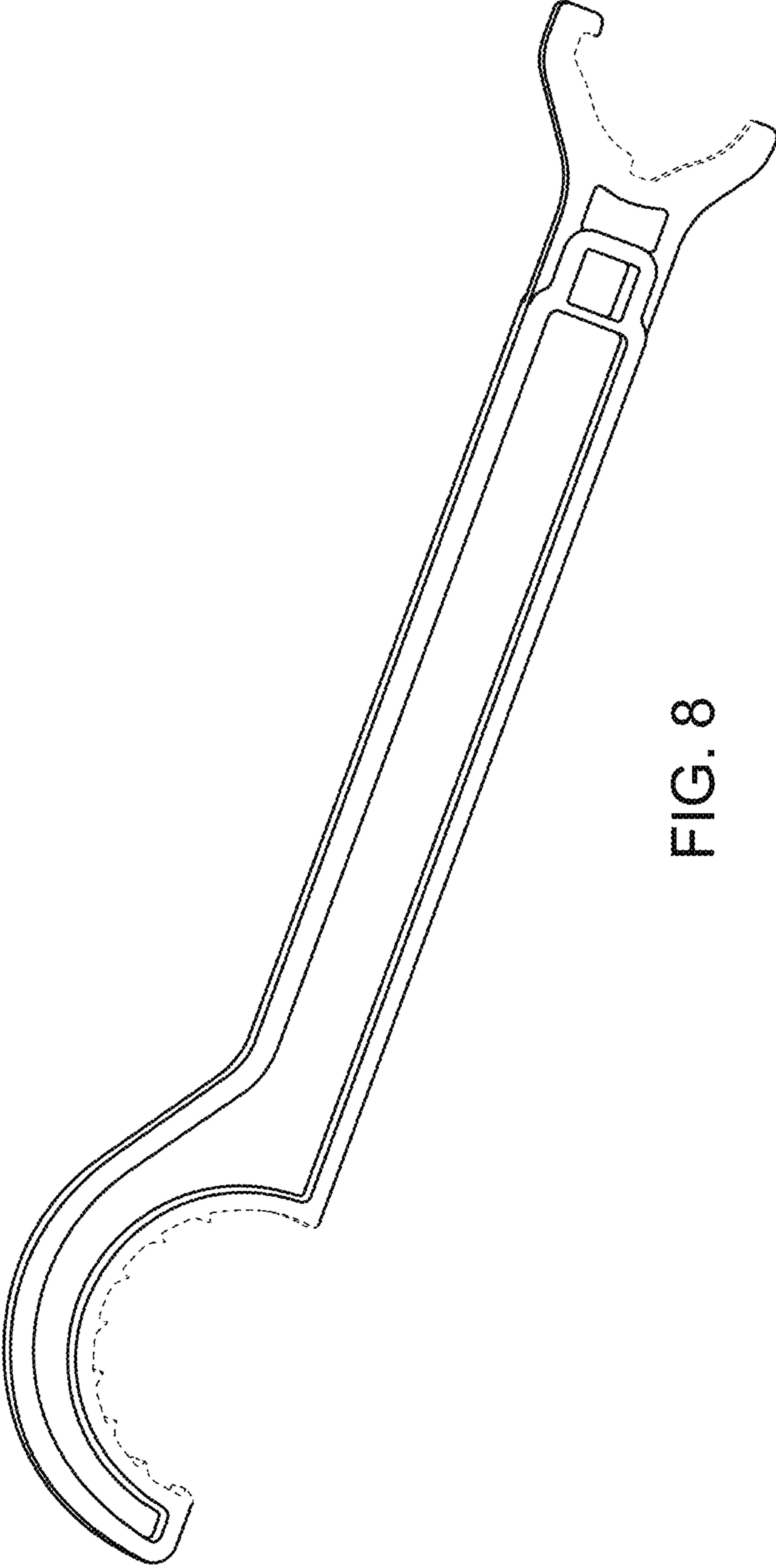

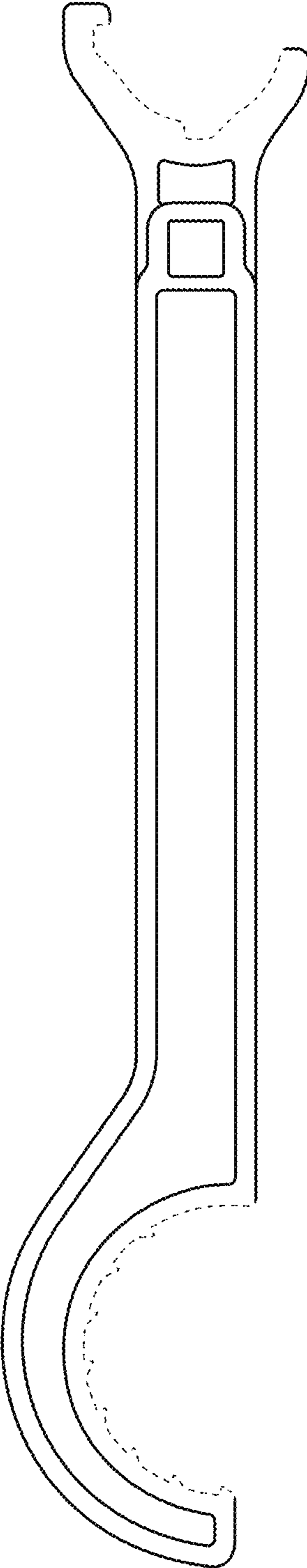

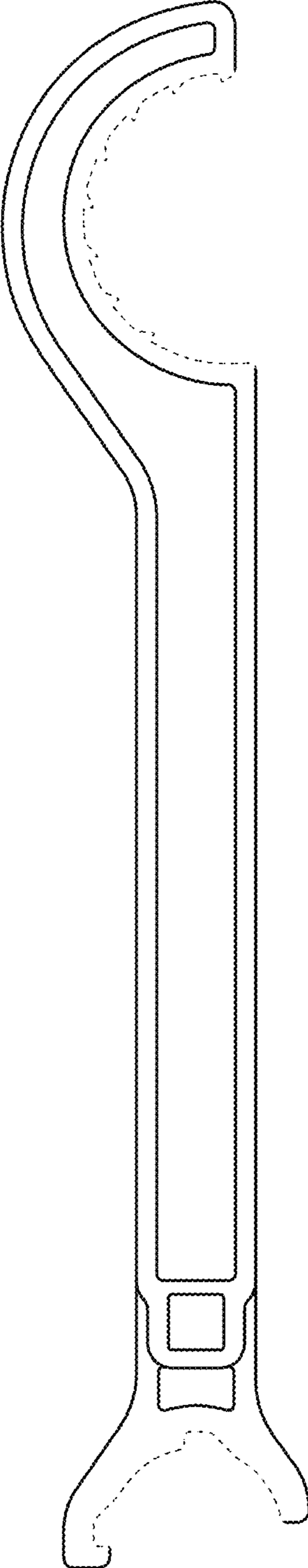

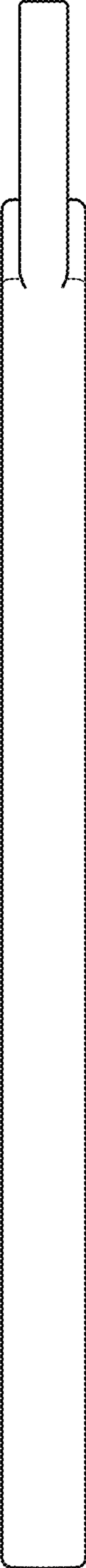

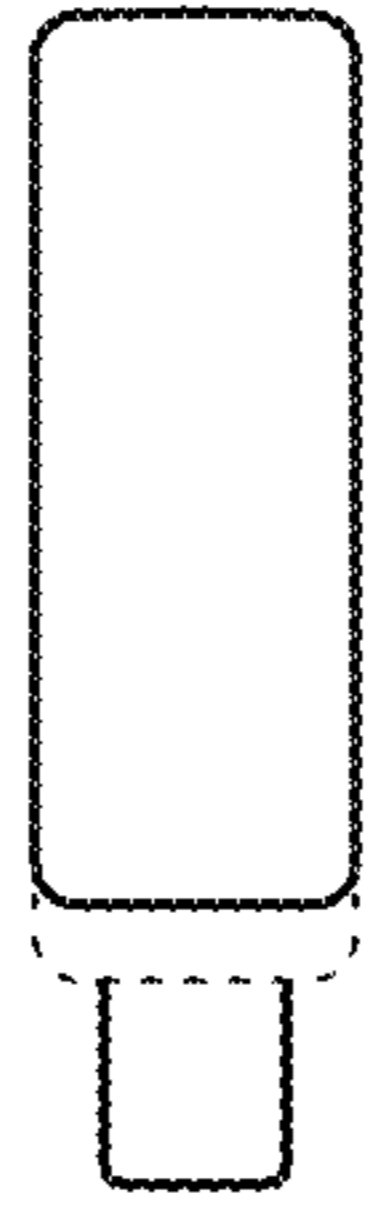

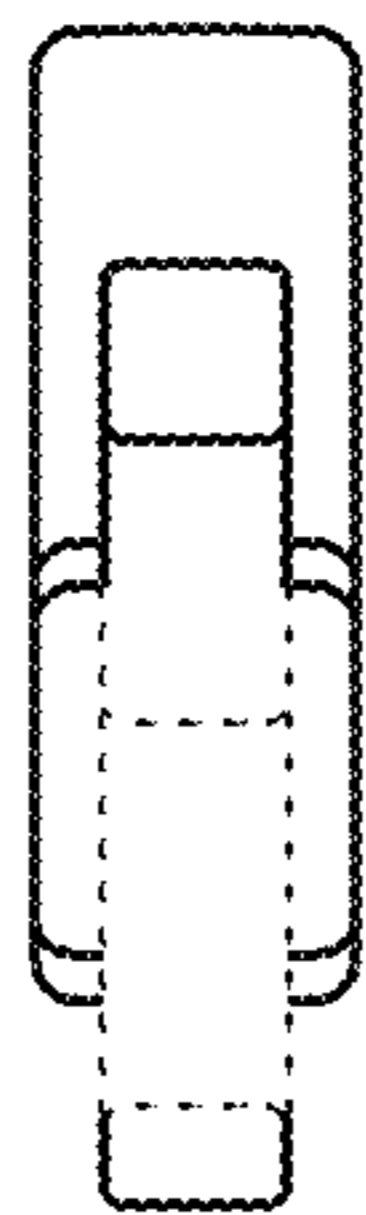
