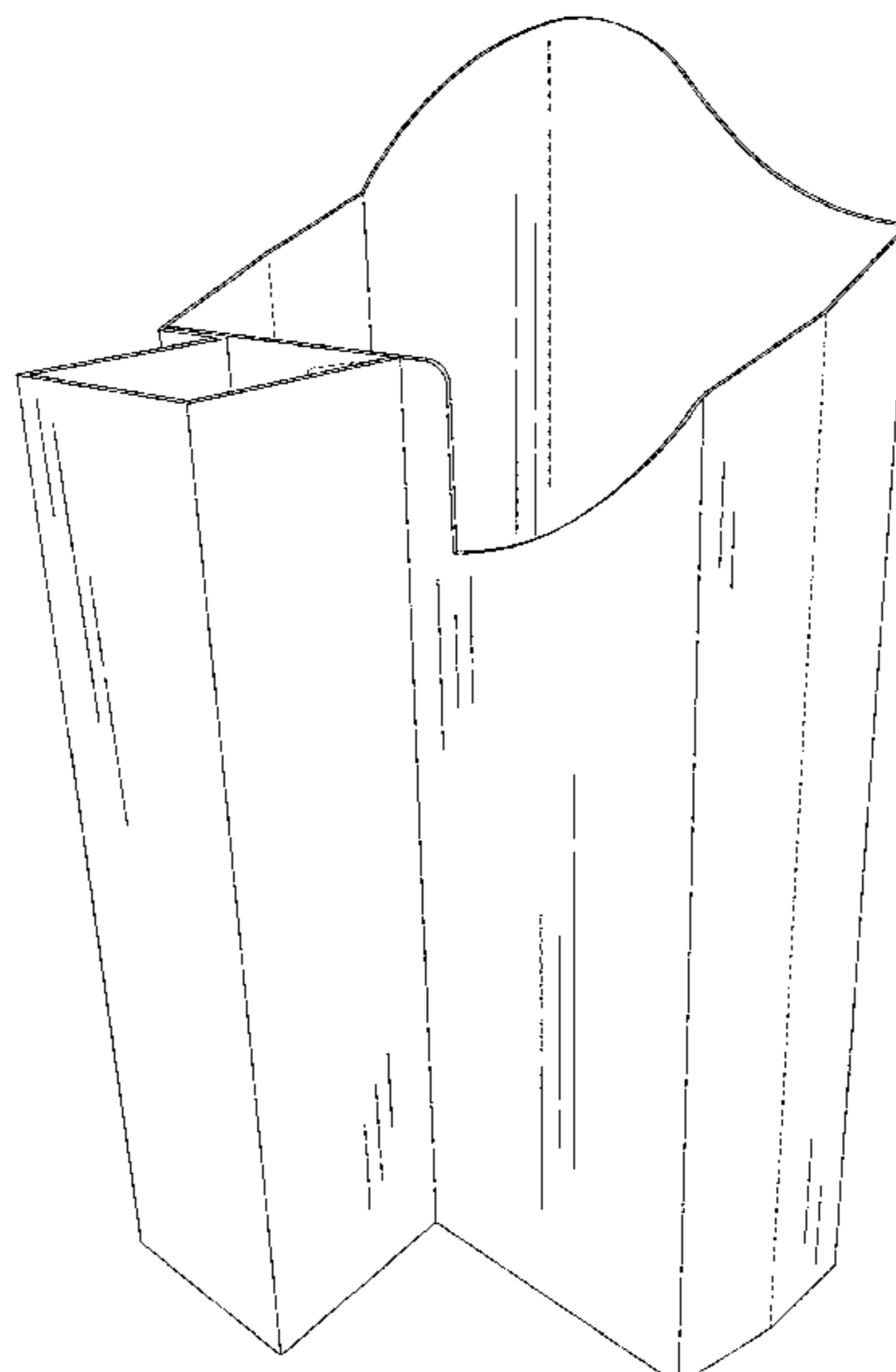
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is a top front perspective view of the carton for finger food and condiment;  
FIG. 2 is a bottom front perspective view thereof;  
FIG. 3 is a front view thereof;  
FIG. 4 is a rear view thereof;  
FIG. 5 is a top perspective view thereof;  
FIG. 6 is a bottom perspective view thereof;

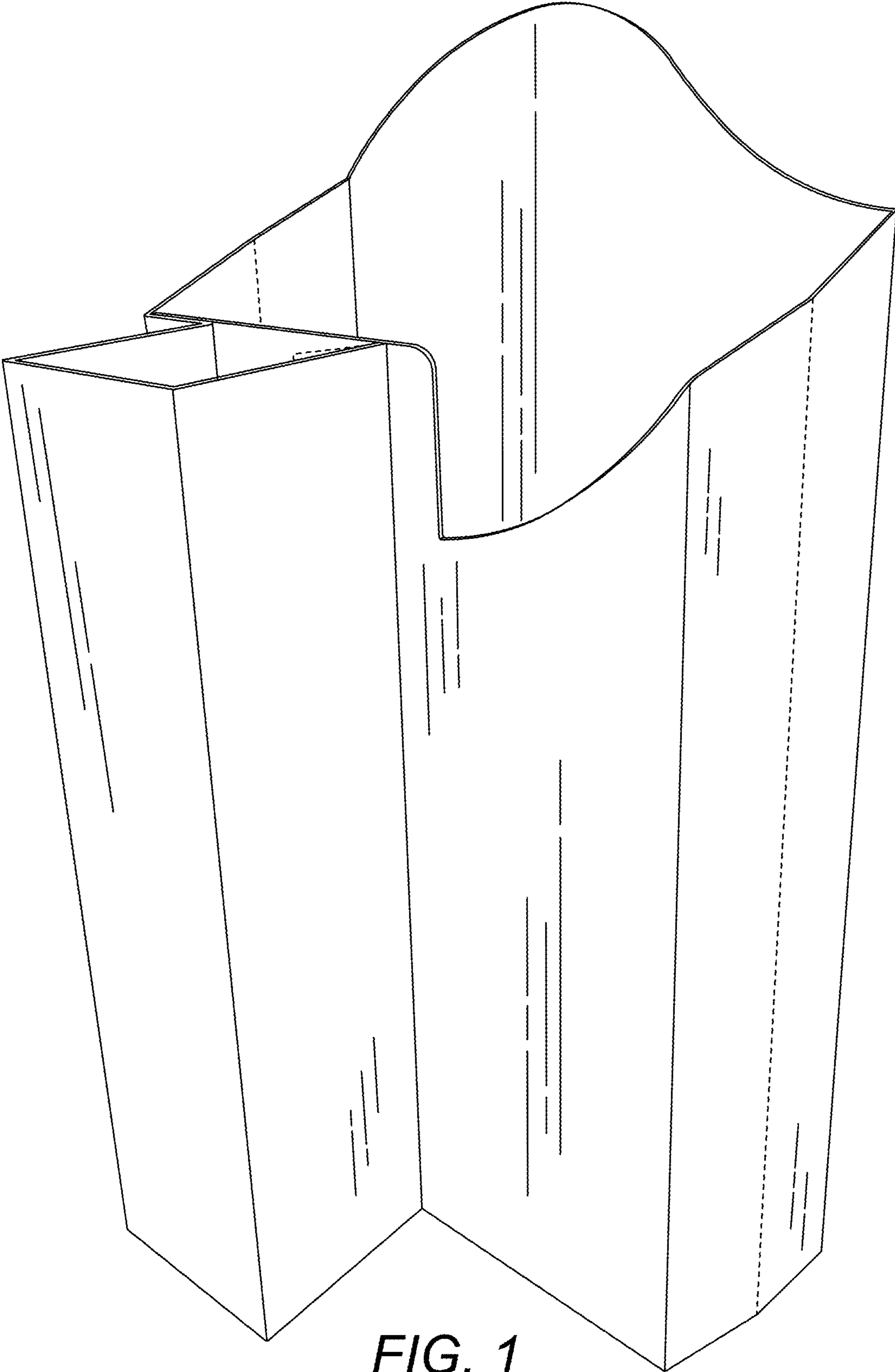

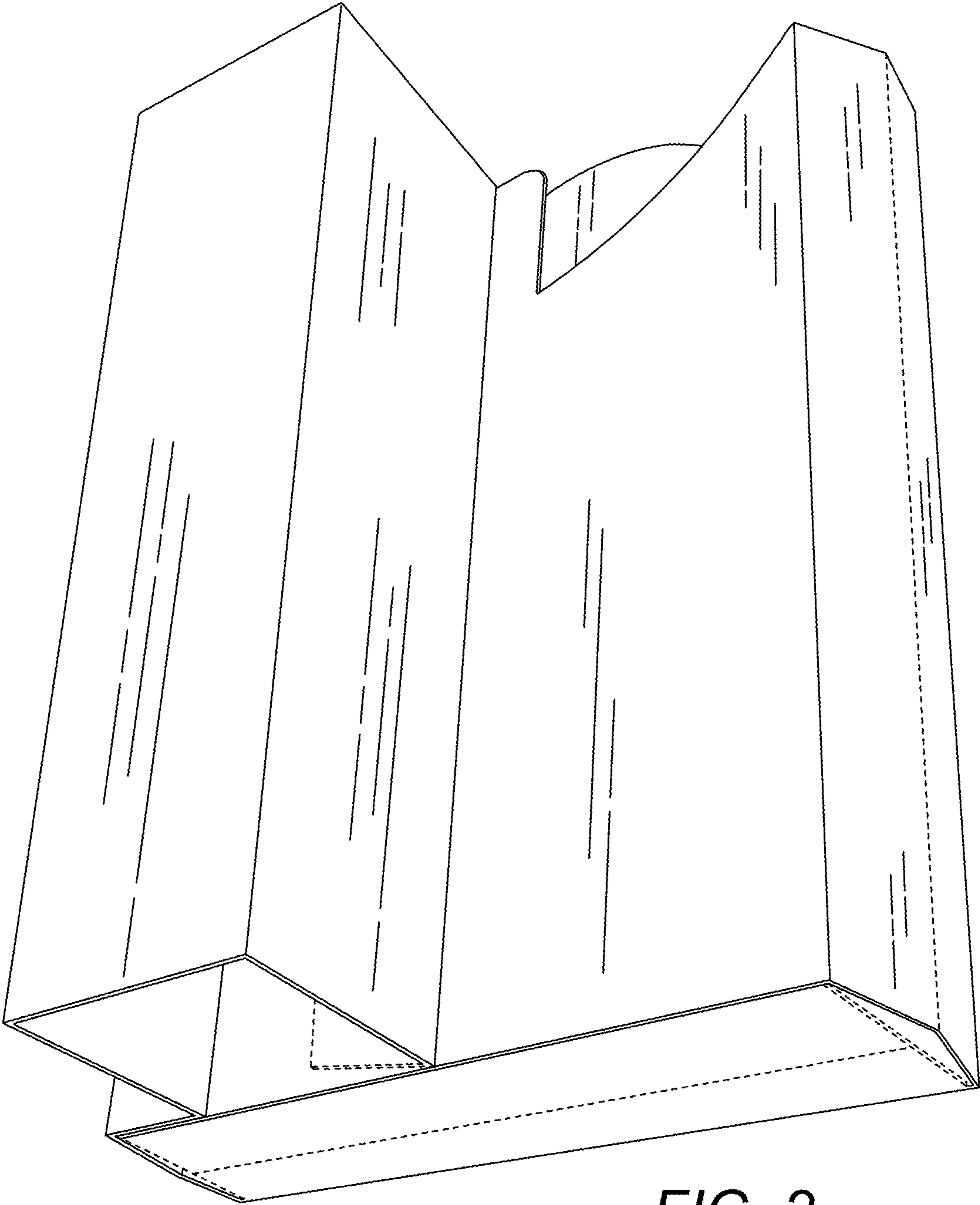

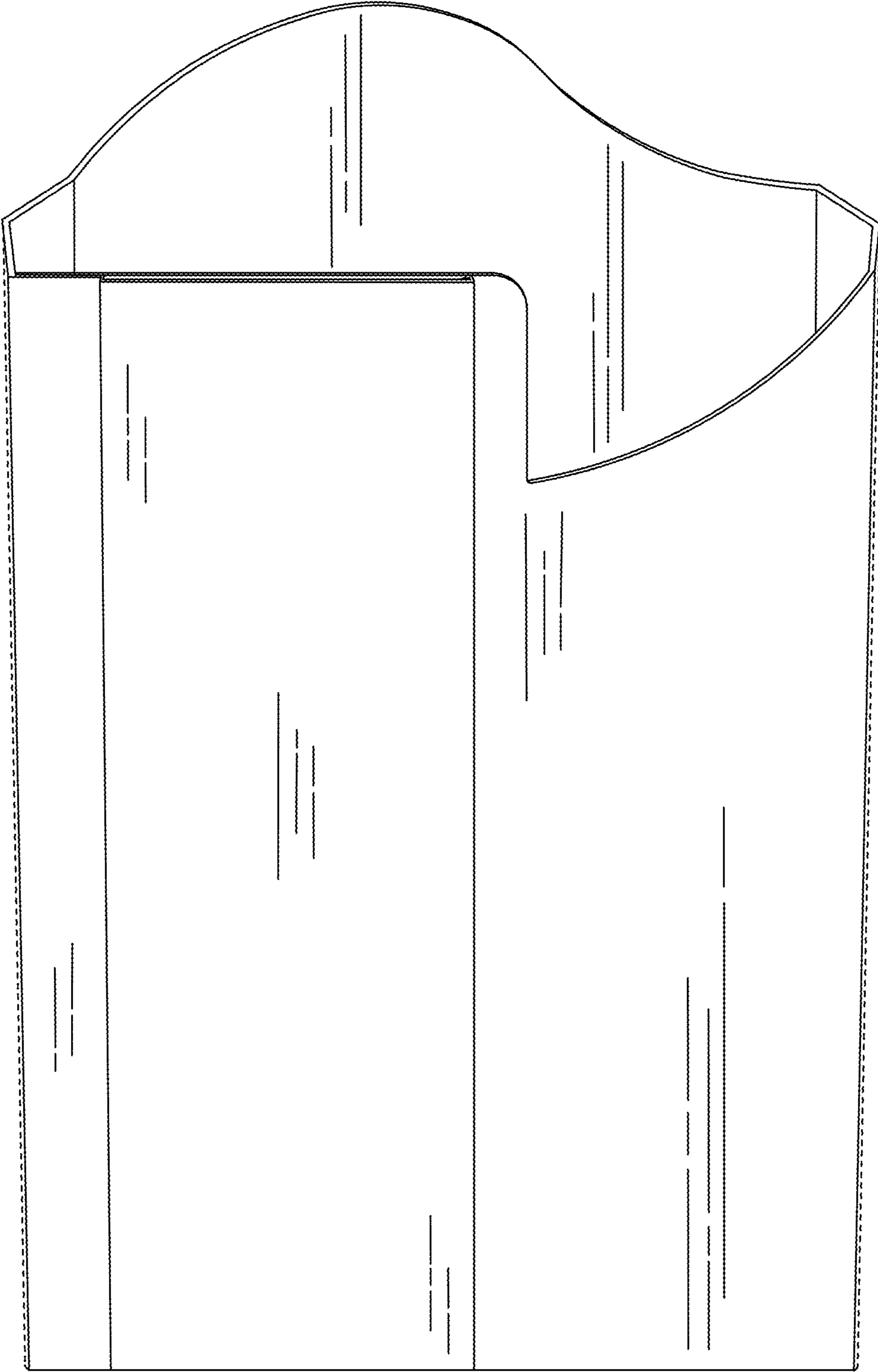

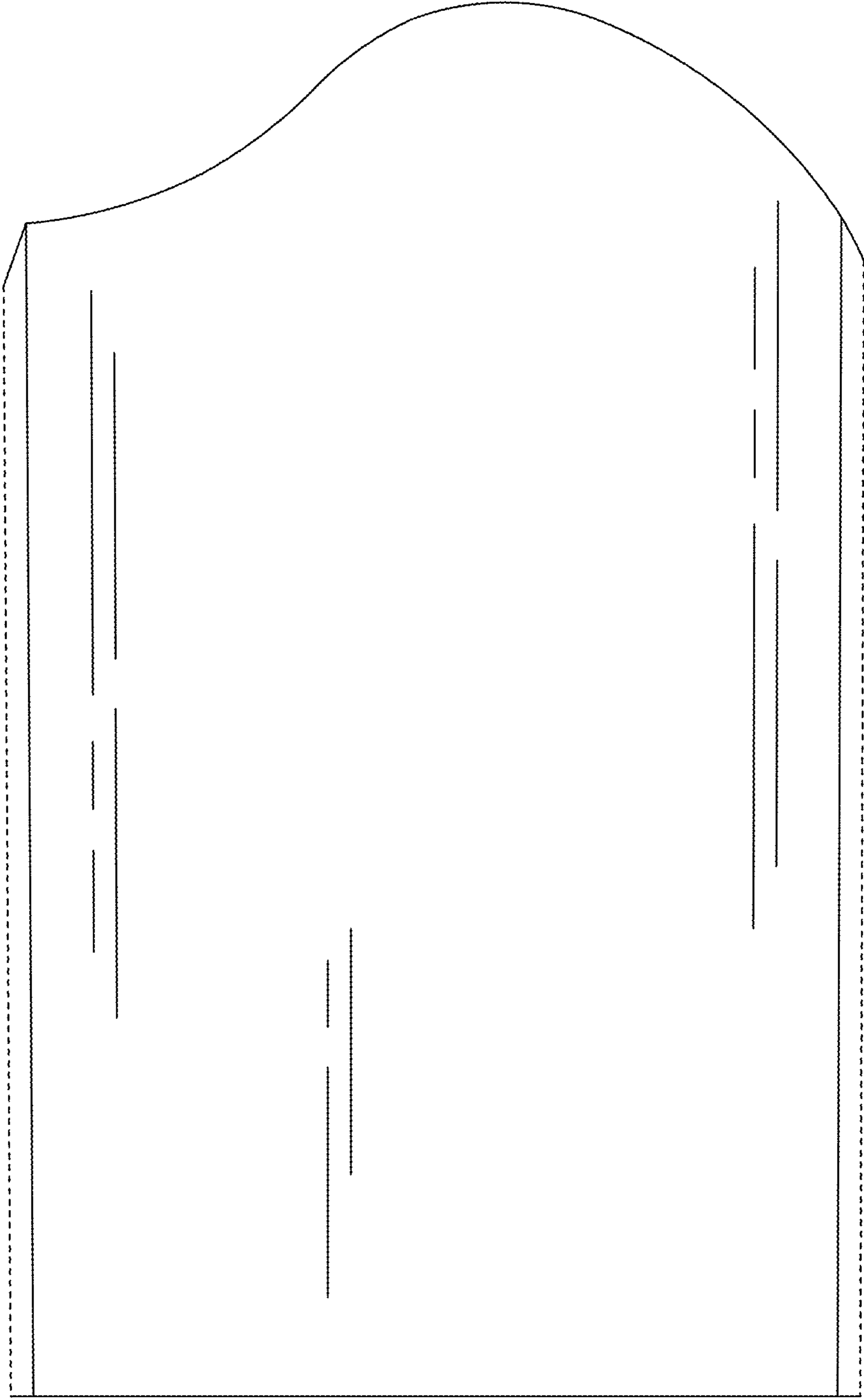

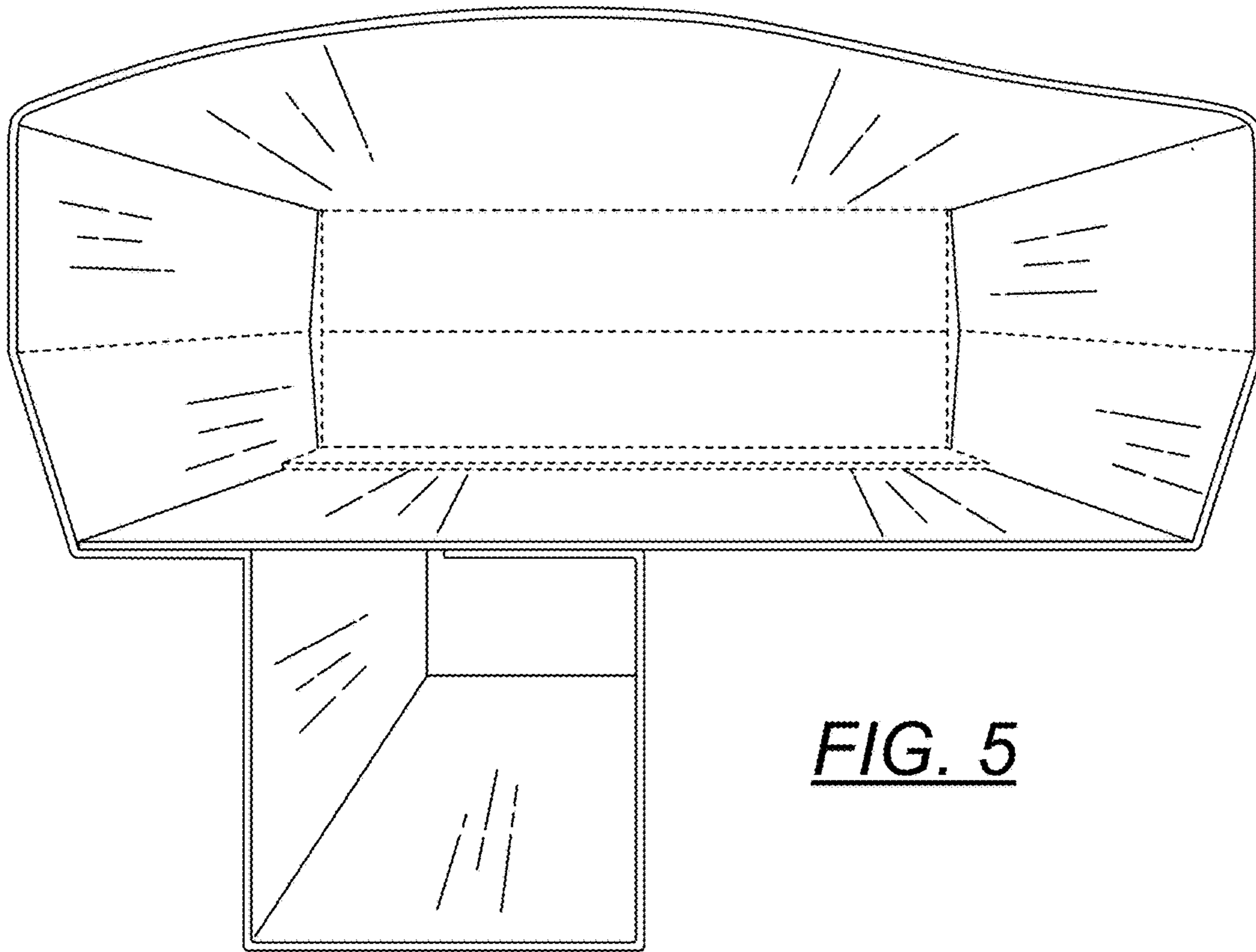

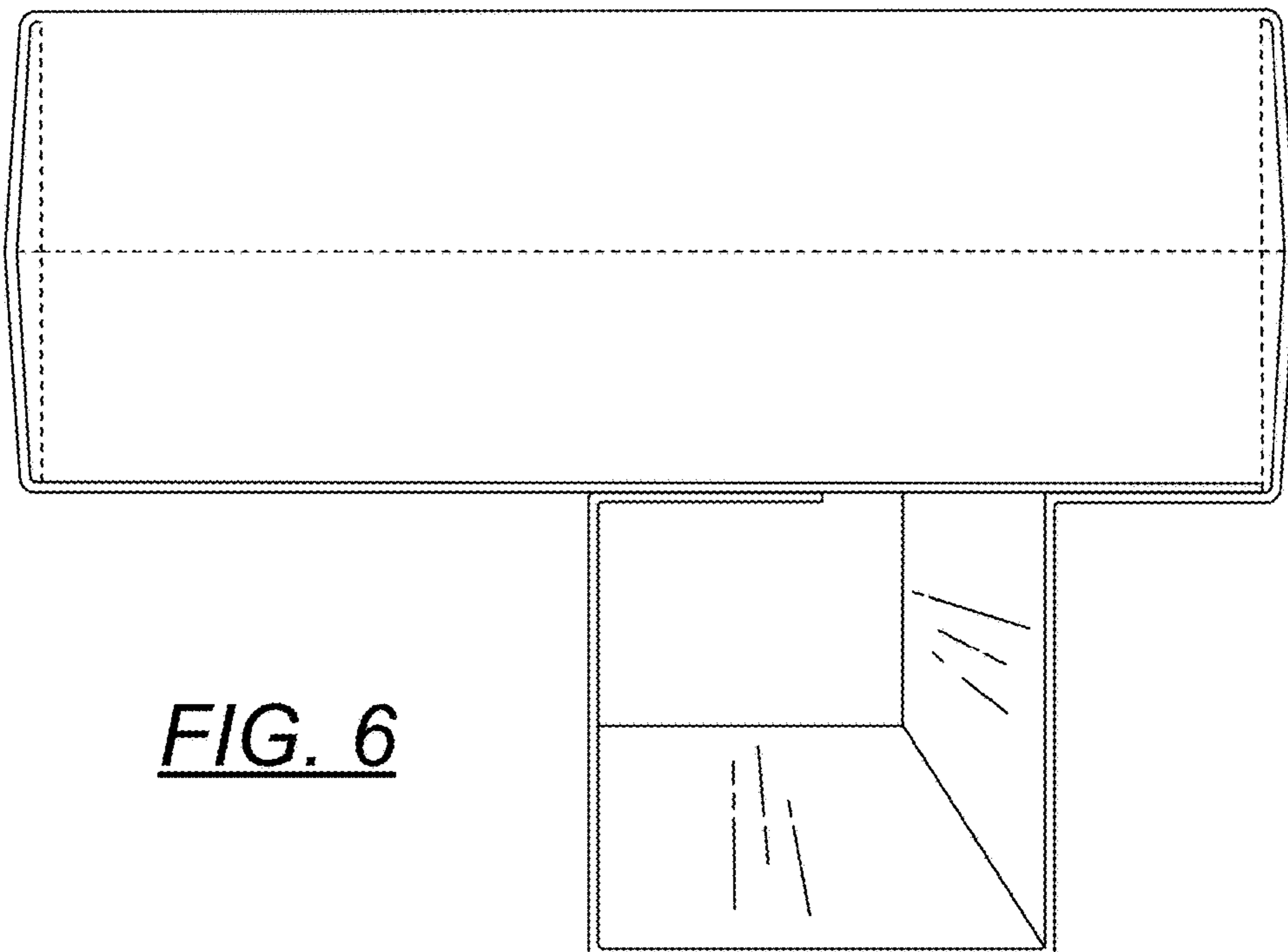

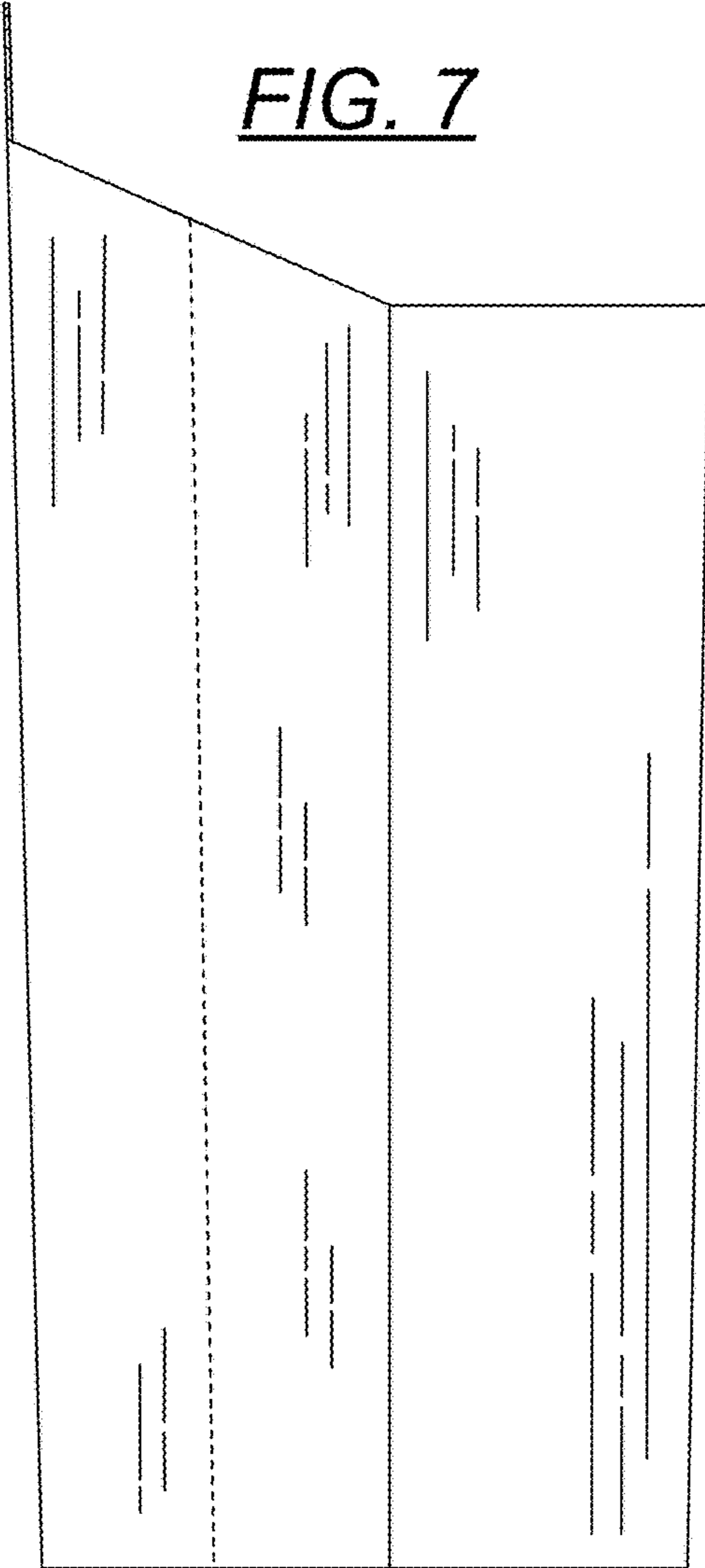
