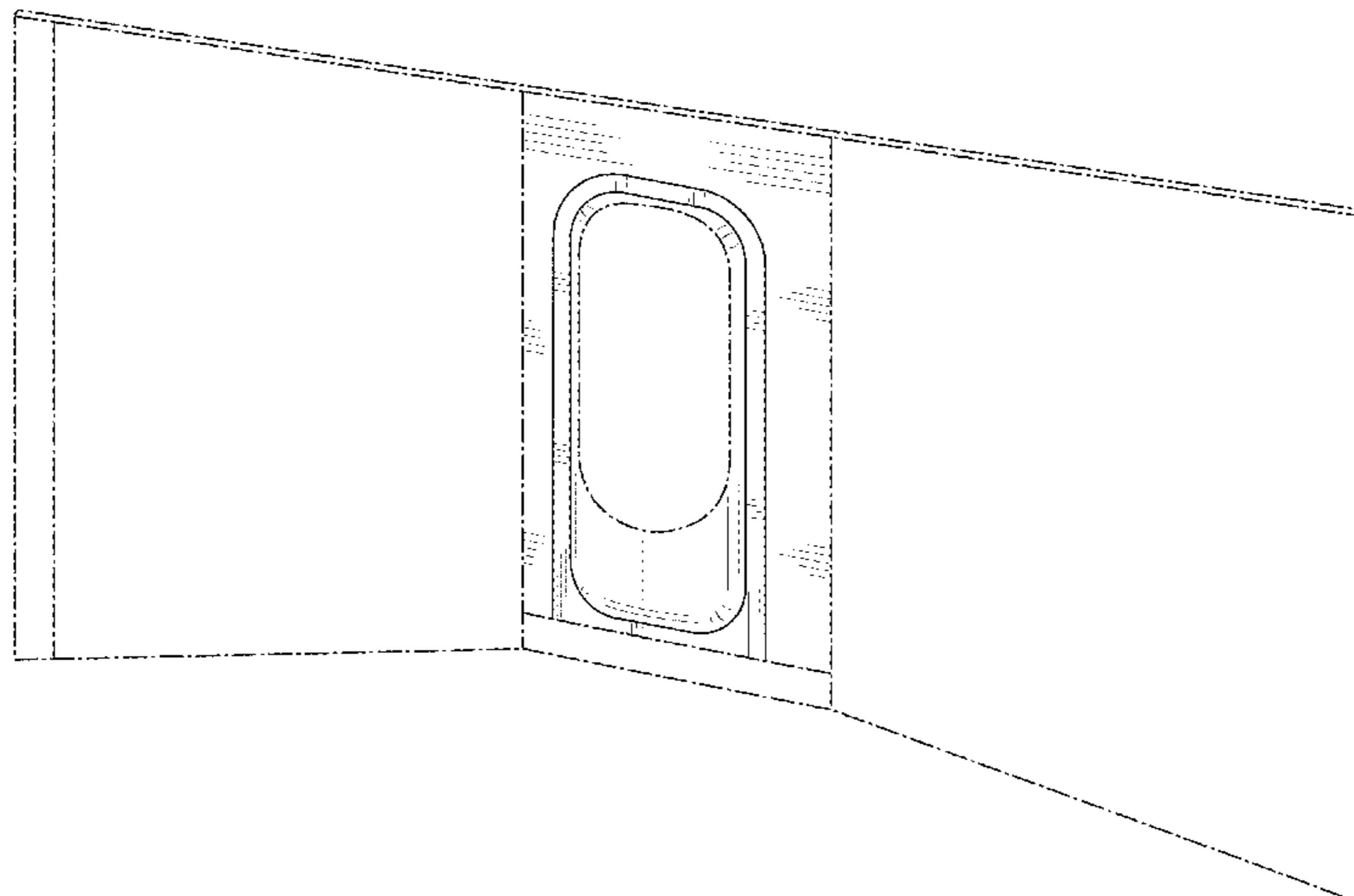
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a top perspective view of an arm band showing our new design in a flat configuration;
FIG. 2 is a top view thereof;
FIG. 3 is a bottom view thereof;
FIG. 4 is a side view thereof;
FIG. 5 is an opposite side view thereof;
FIG. 6 is a right side view thereof; and,
FIG. 7 is a left side view thereof.

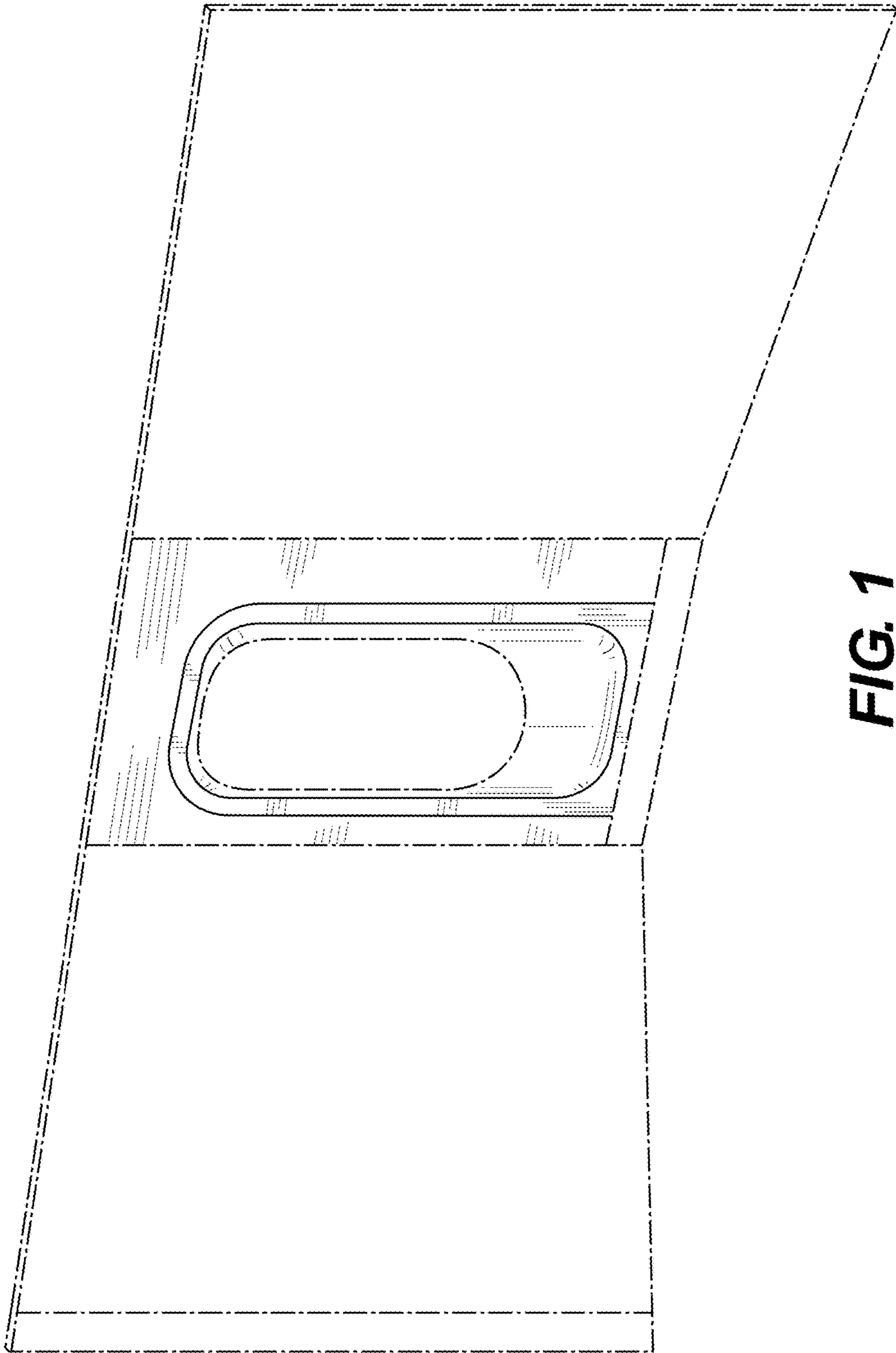

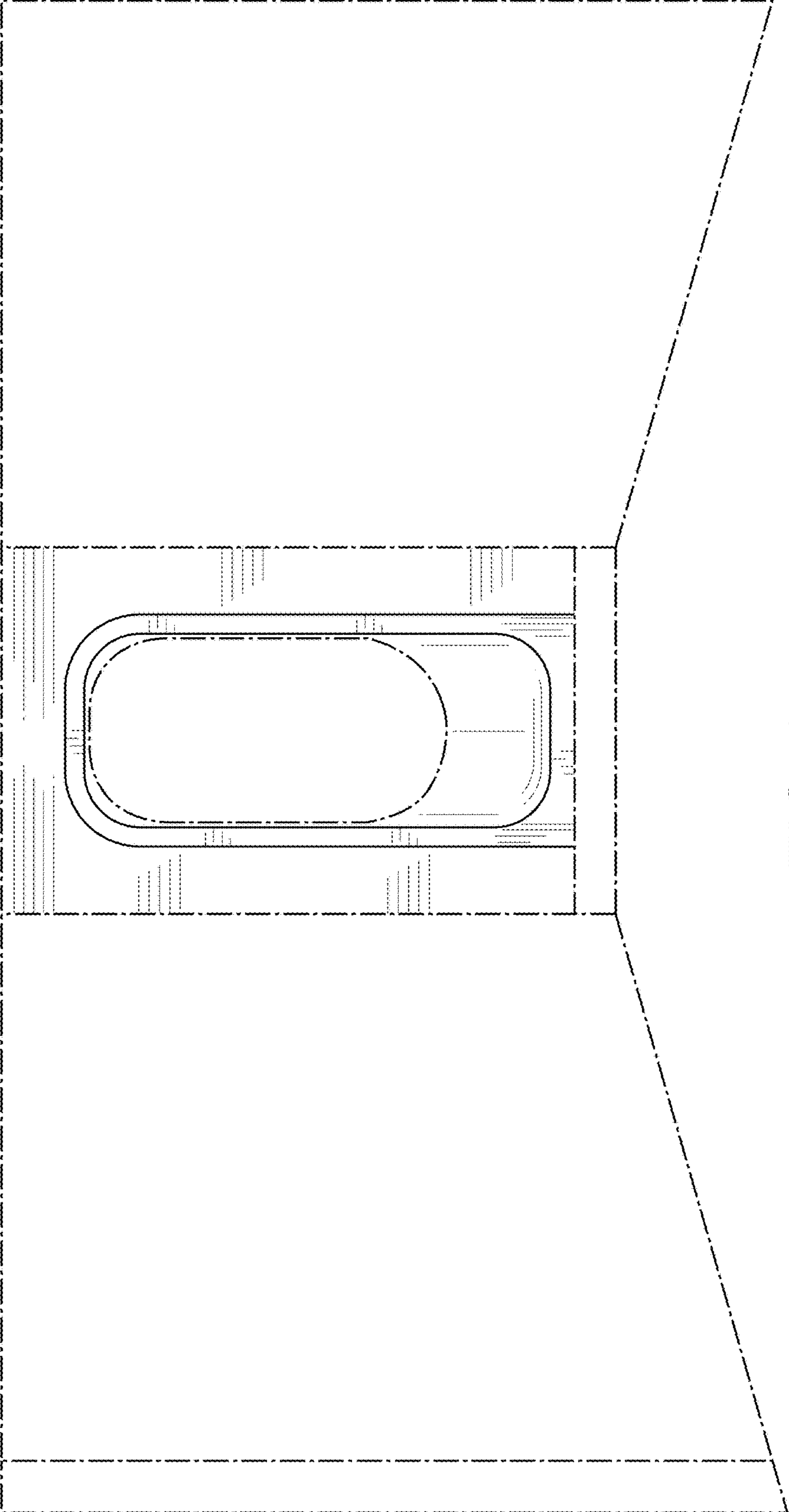

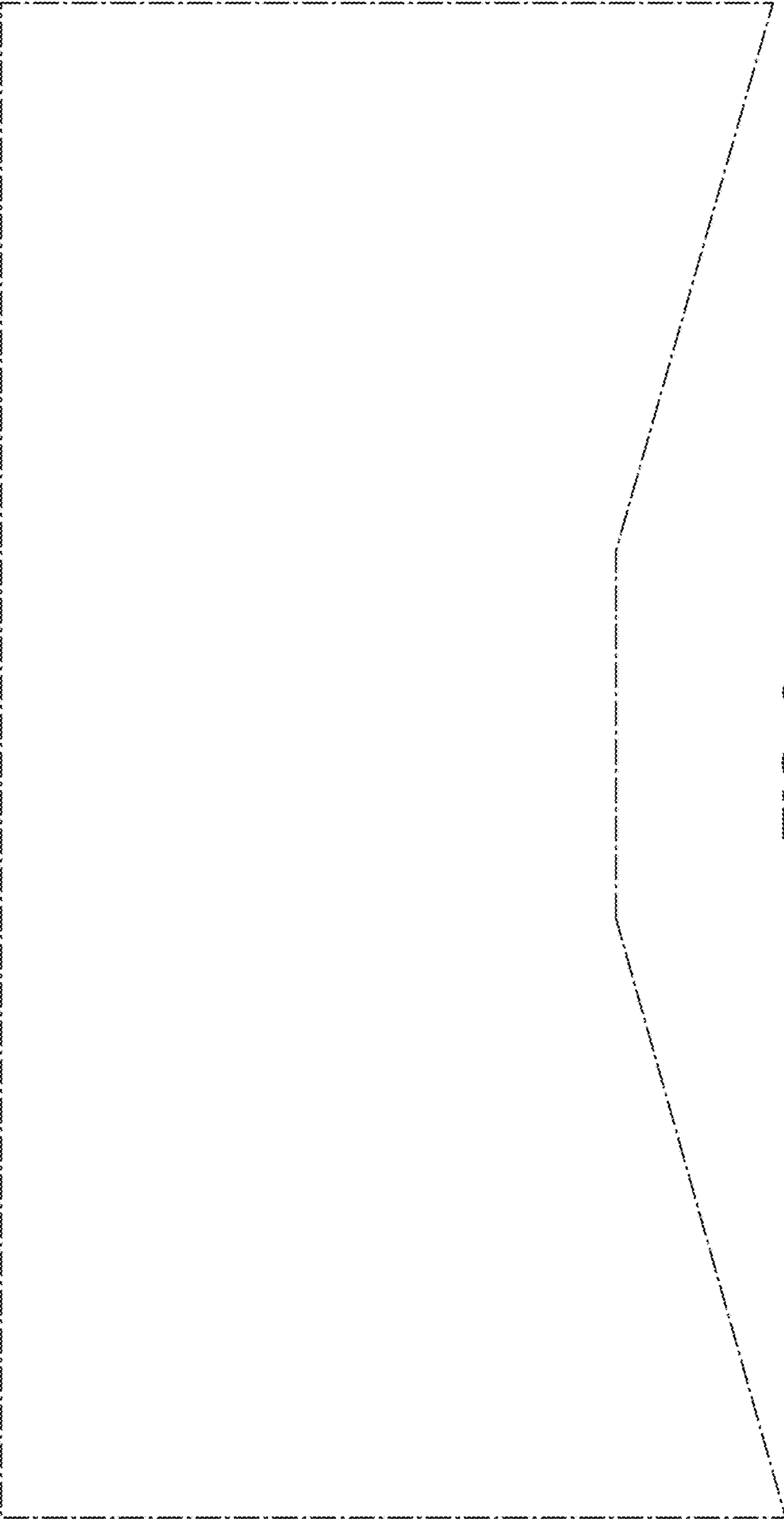

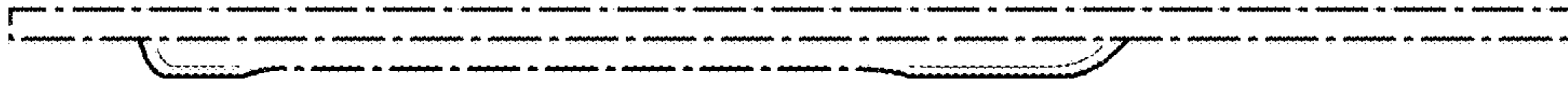

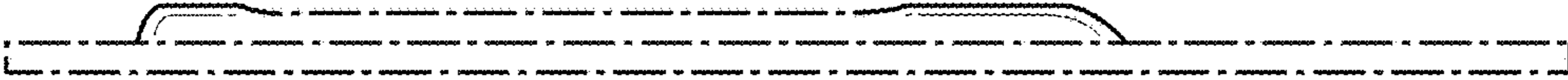

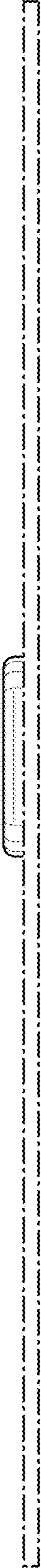
