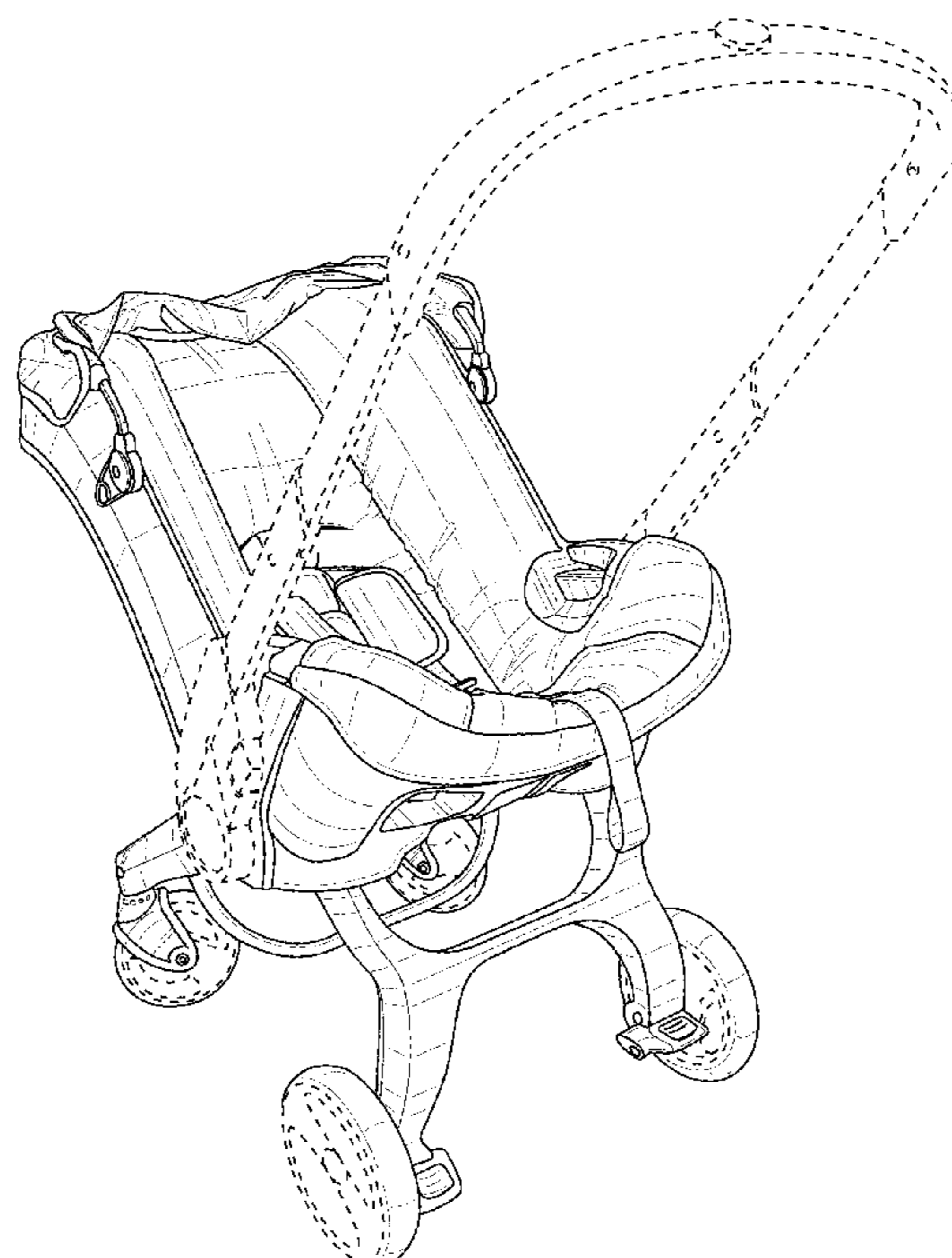
(57) **CLAIM**

The ornamental design for vehicle child seat convertible to stroller, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a vehicle child seat convertible to stroller with the handle and wheels in a retracted position;
FIG. 2 is a front view thereof;
FIG. 3 is a right side view thereof;
FIG. 4 is a left side view thereof;
FIG. 5 is a perspective view thereof, with the handle and wheels in an extended position;
FIG. 6 is a front view thereof;
FIG. 7 is a left side view thereof, with the handle retracted;
FIG. 8 is a left side view thereof, with the handle extended; and,
FIG. 9 is a top view thereof, with the handle retracted.

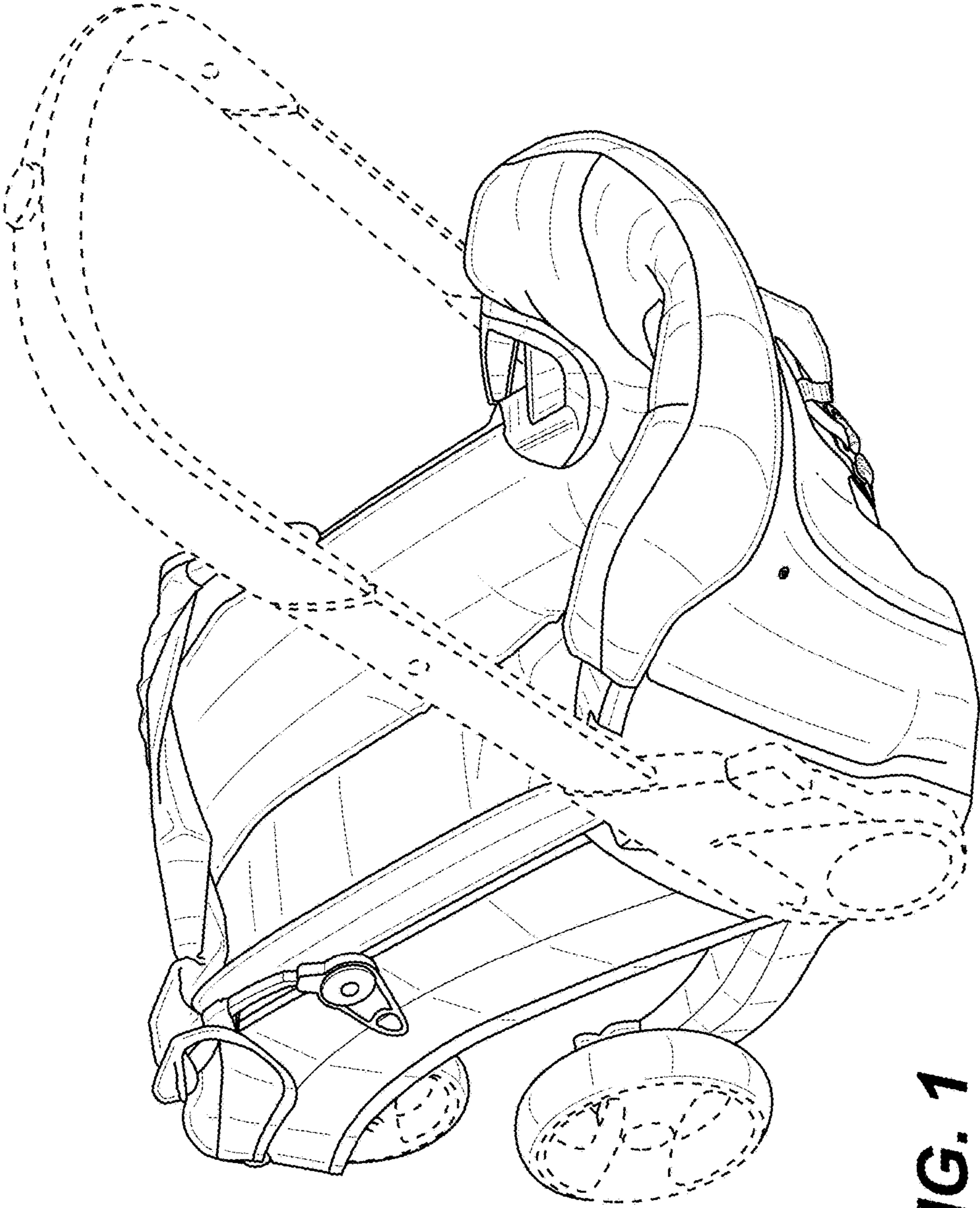

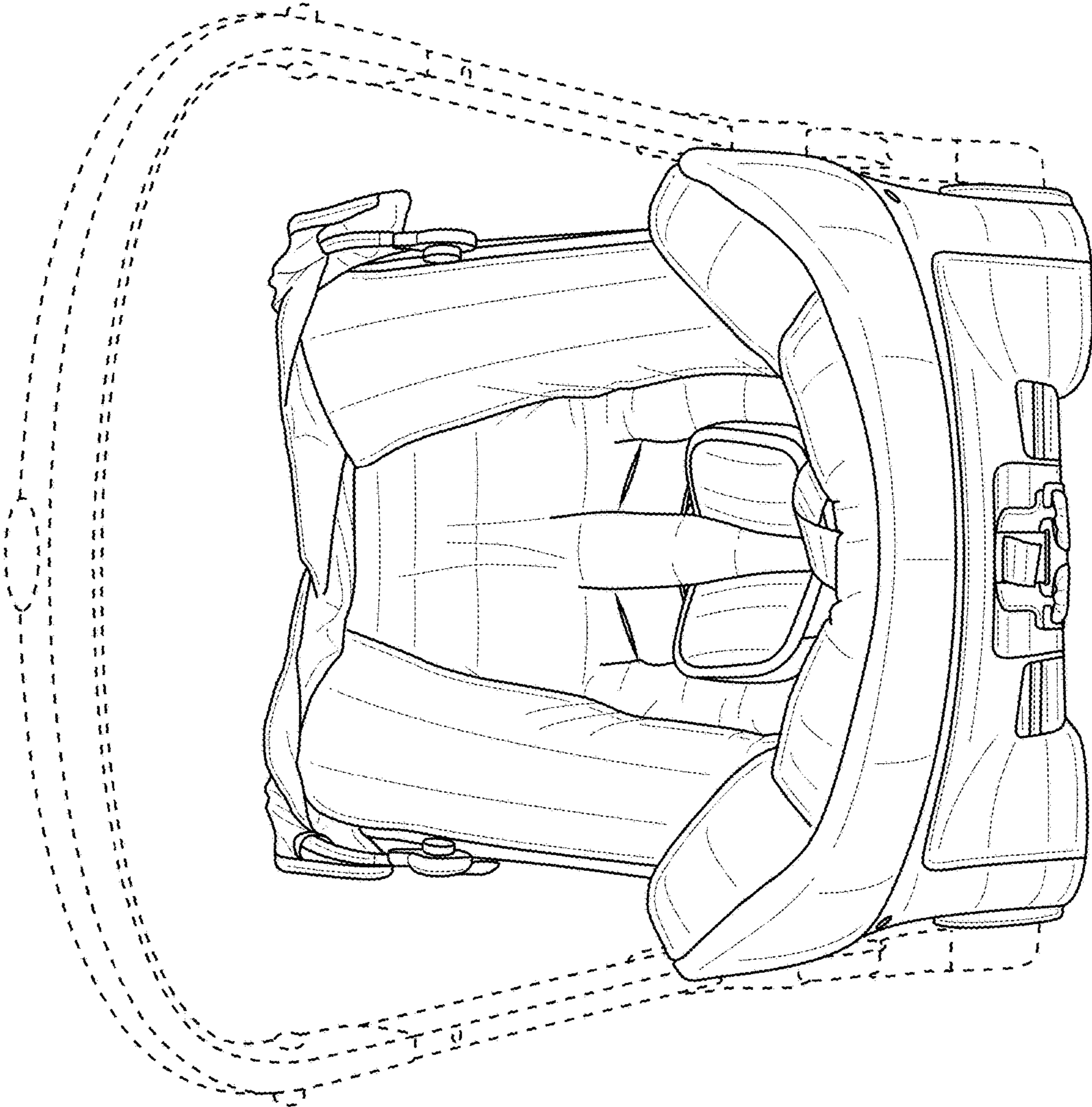

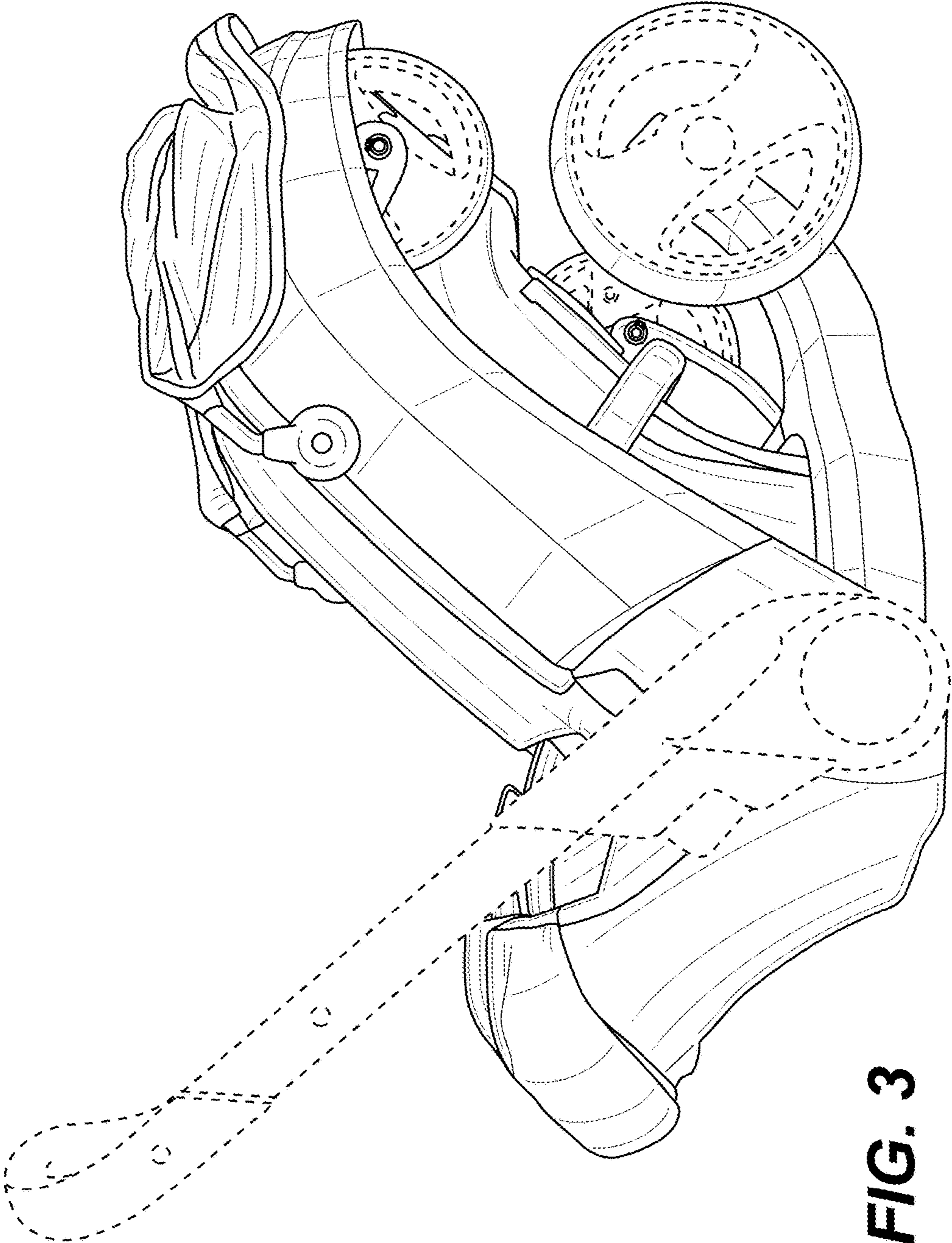

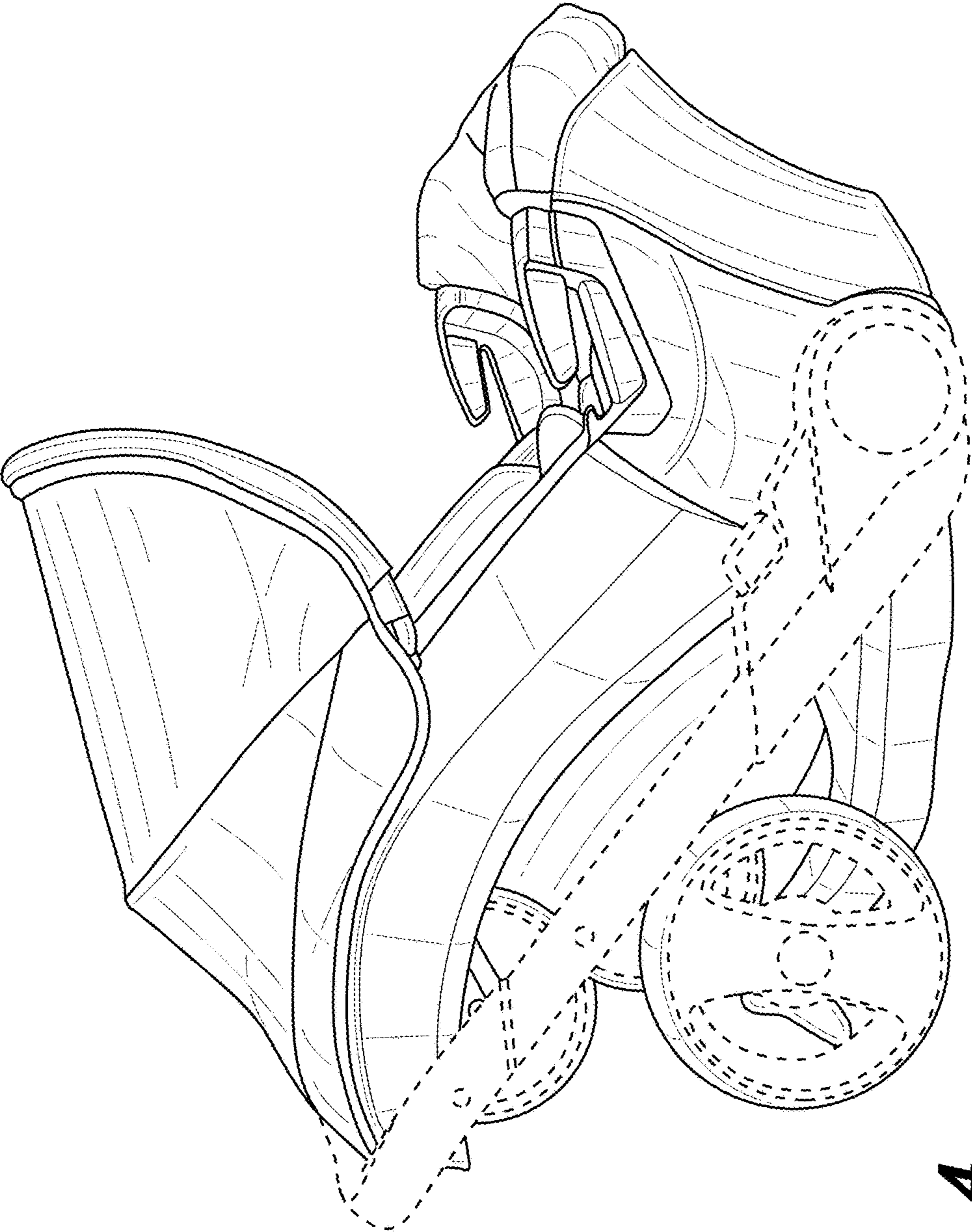

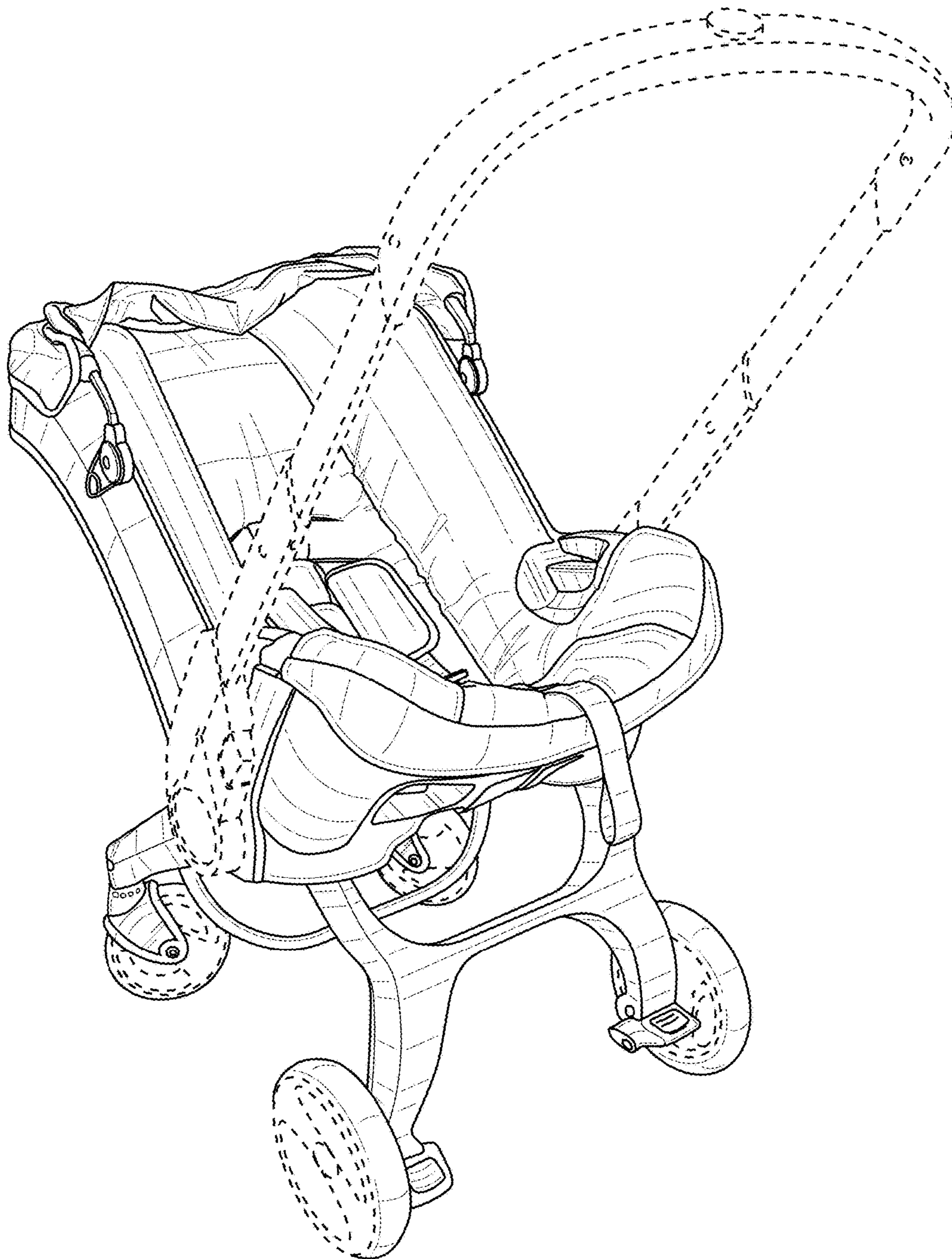

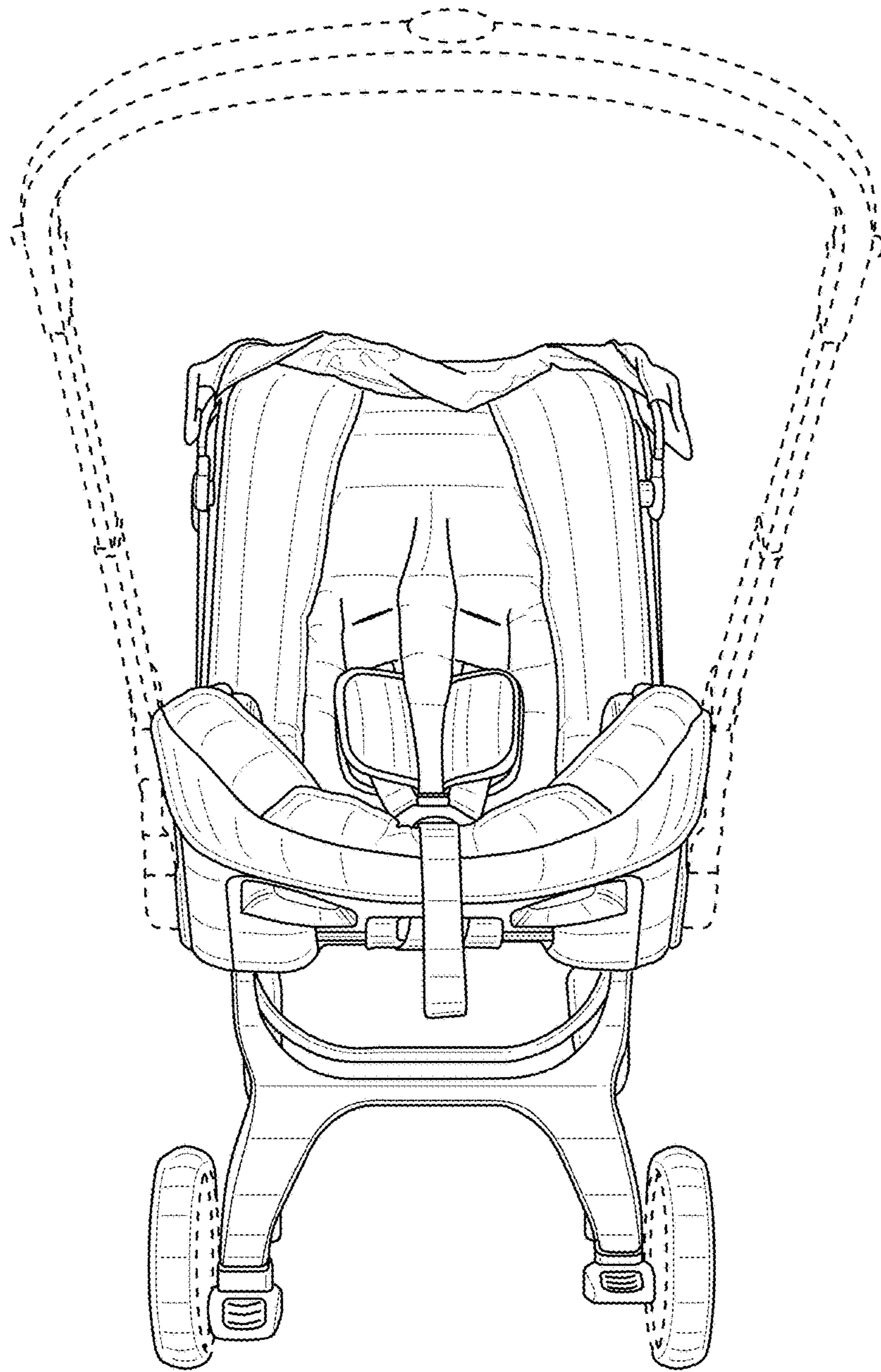

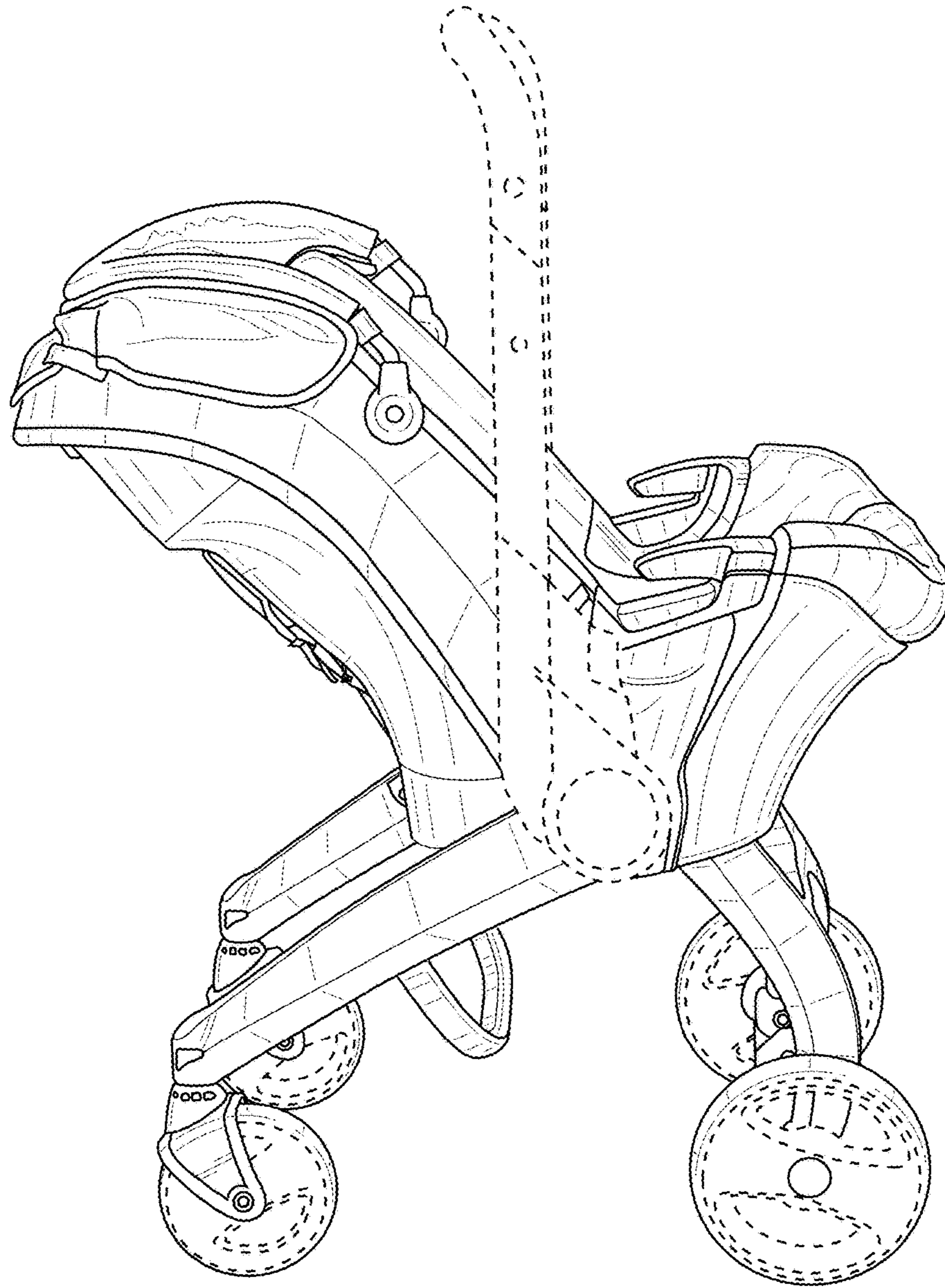

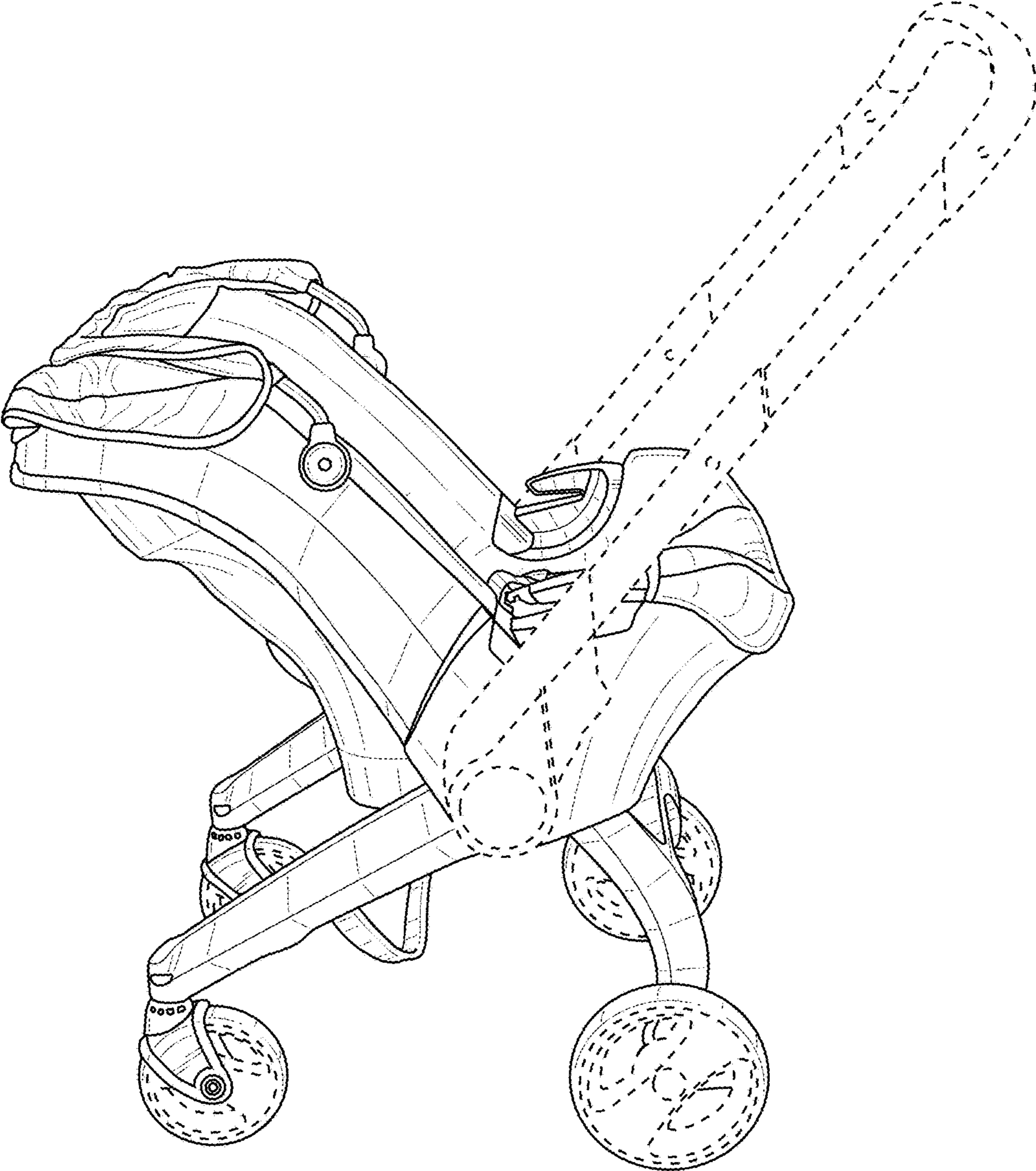

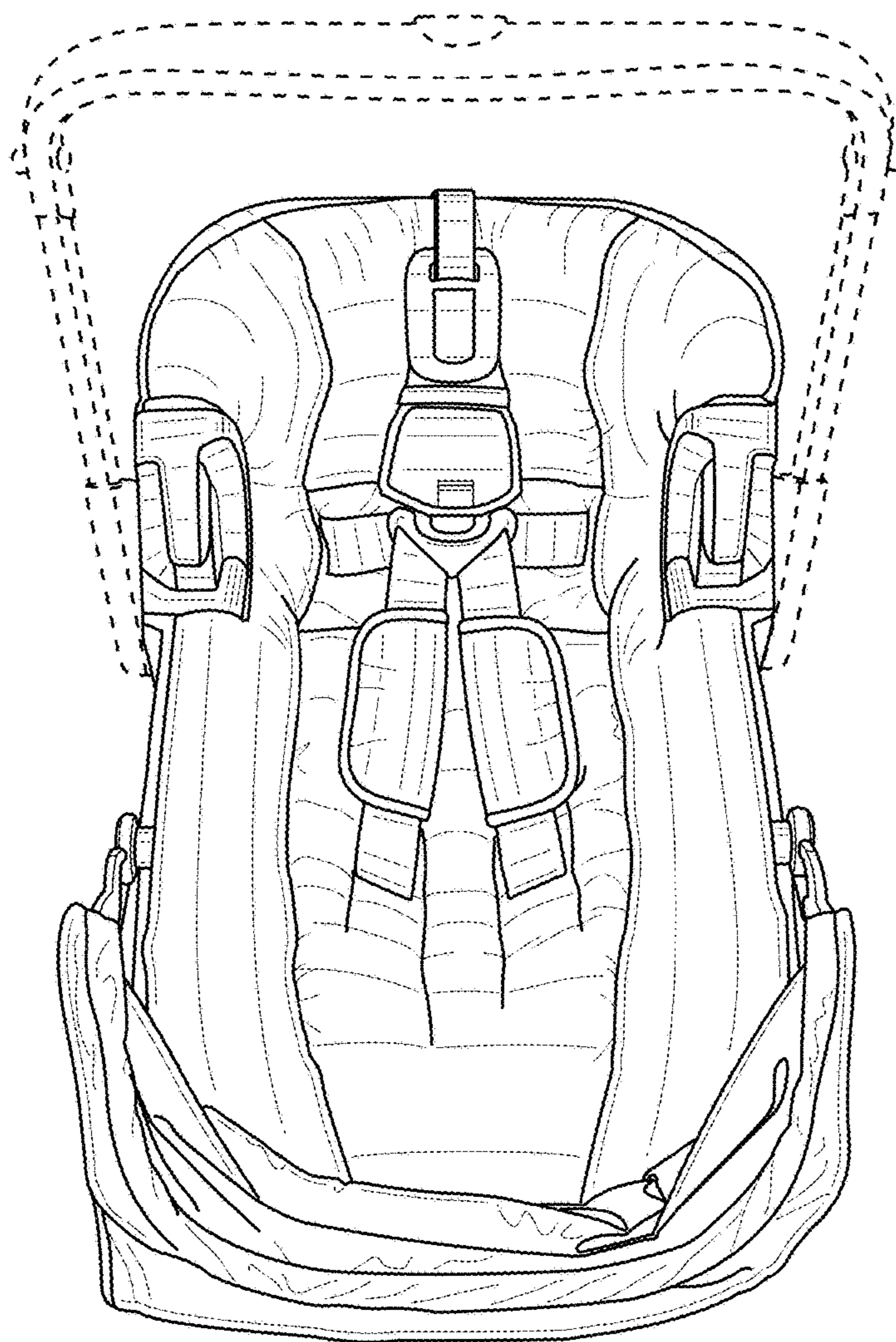
