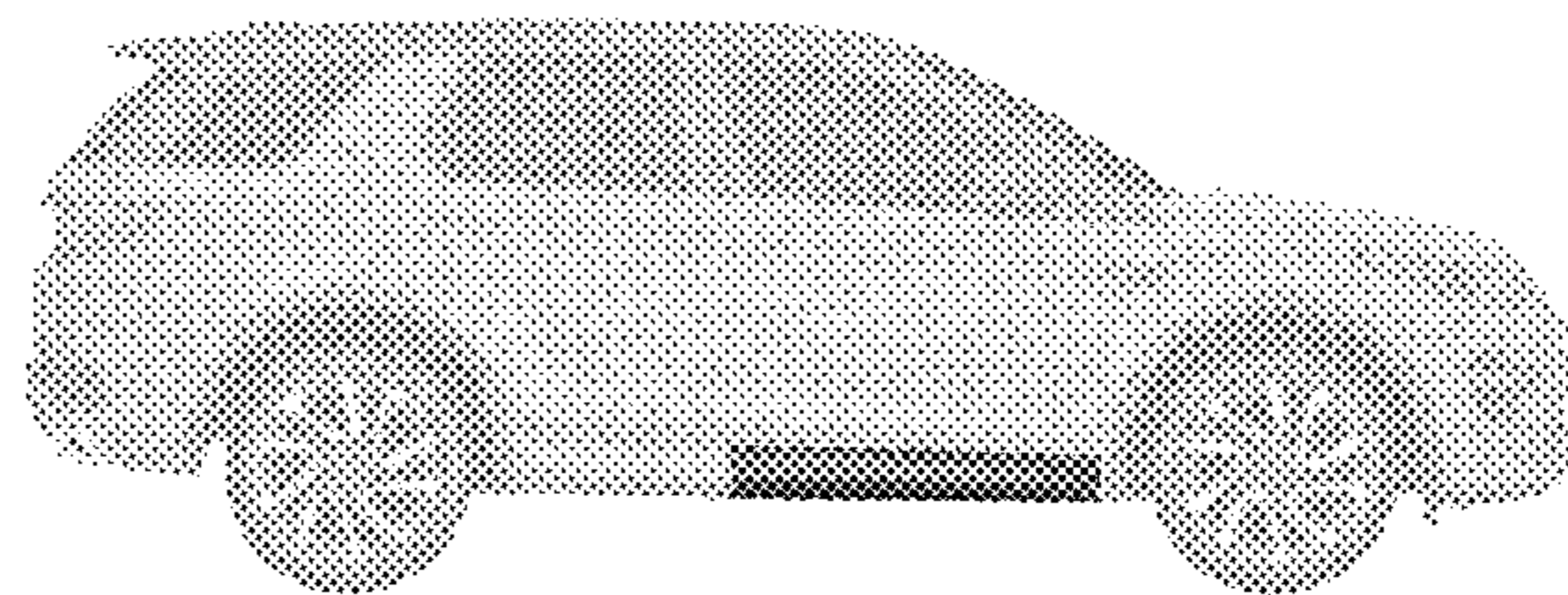
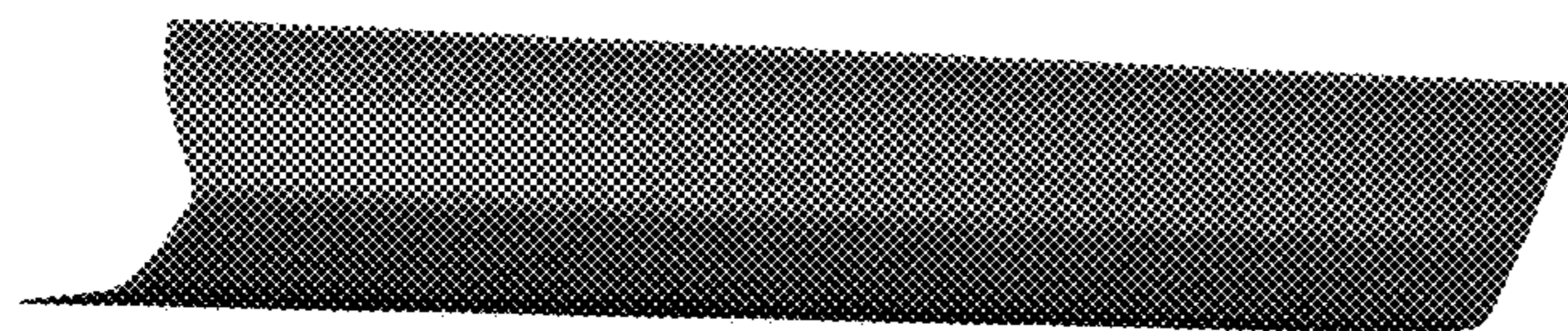
The ornamental design for a front door cladding for a

DESCRIPTION

FIG. 1 is a right, front perspective view of a front door
cladding for a vehicle, showing my new invention;
FIG. 2 is a rear, left perspective view thereof;
FIG. 3 is a front view thereof;
FIG. 4 is a rear view thereof;
FIG. 5 is a left side view thereof;
FIG. 6 is a right side view thereof;
FIG. 7 is a top plan view thereof; and,

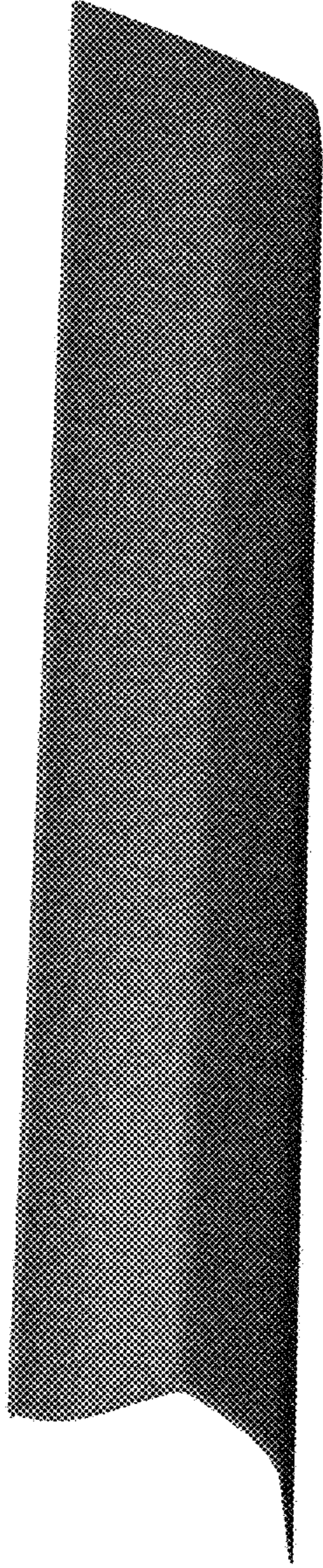

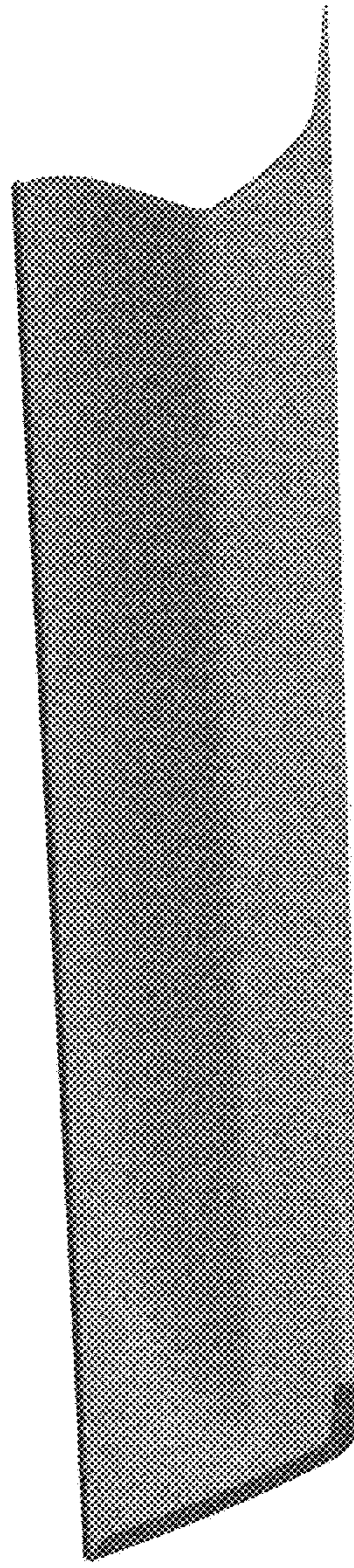

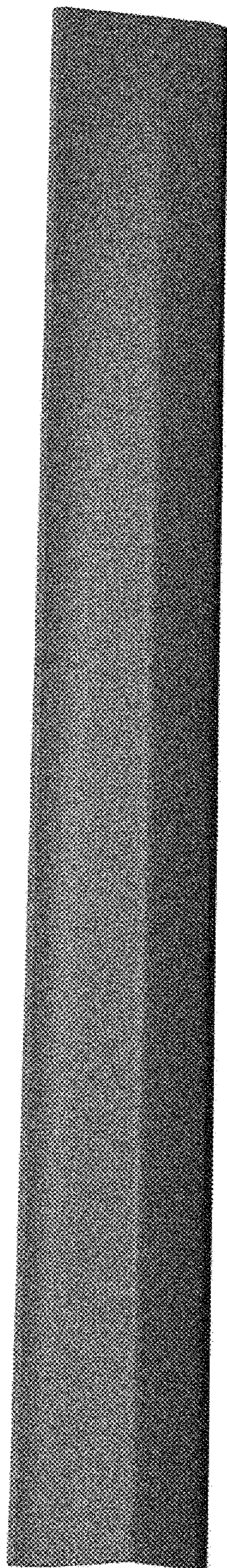

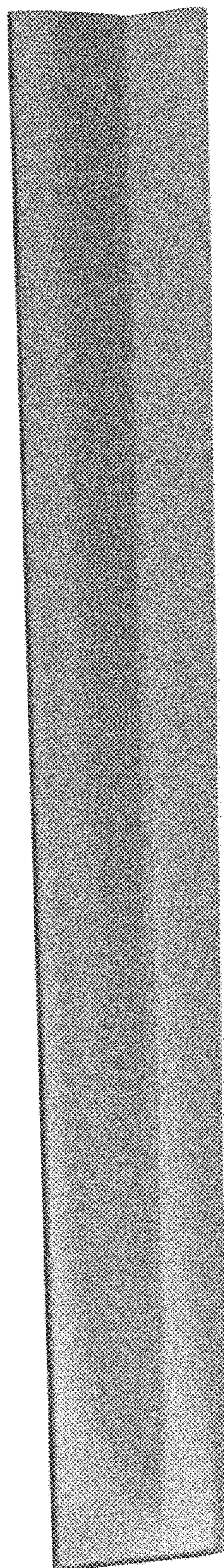

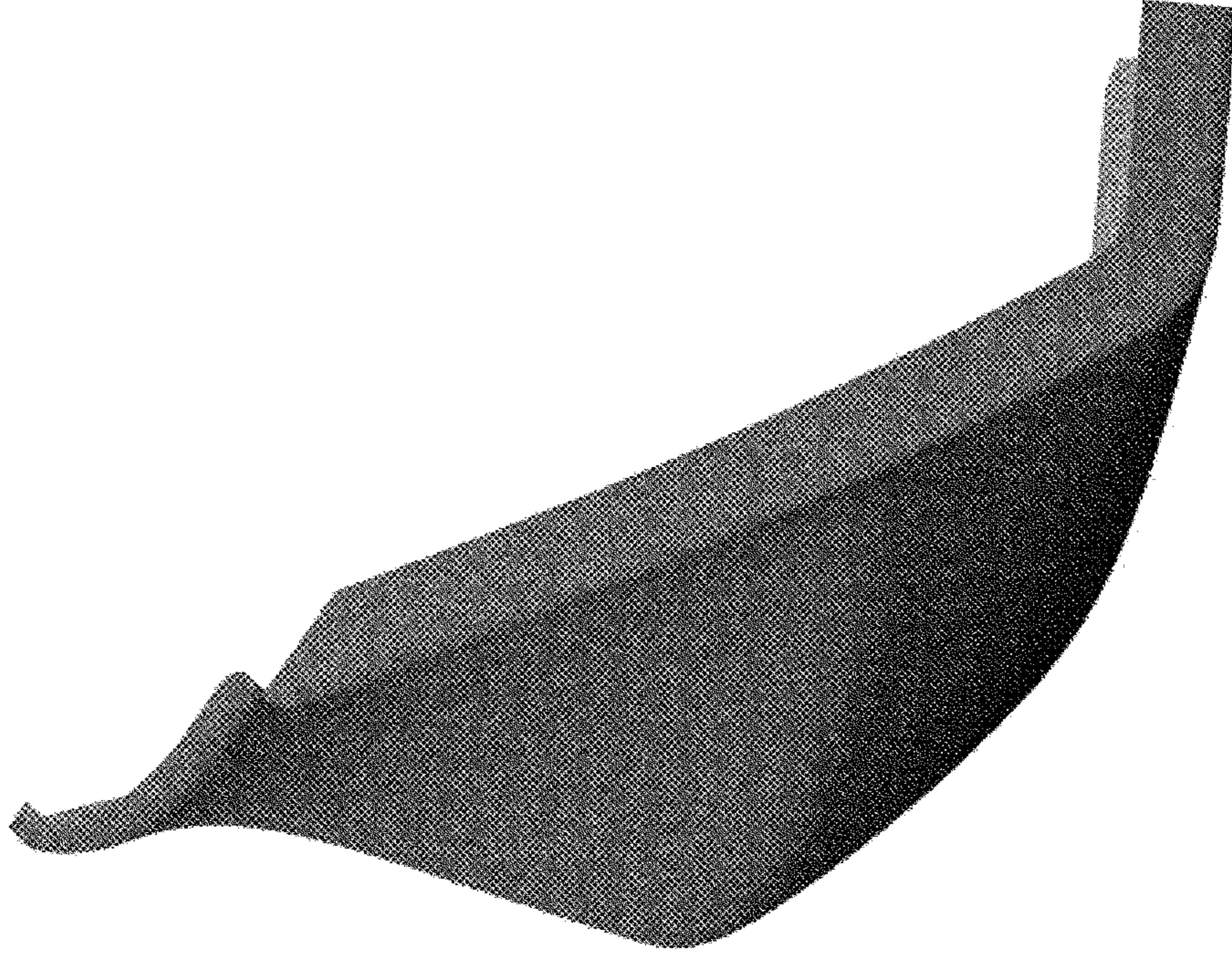

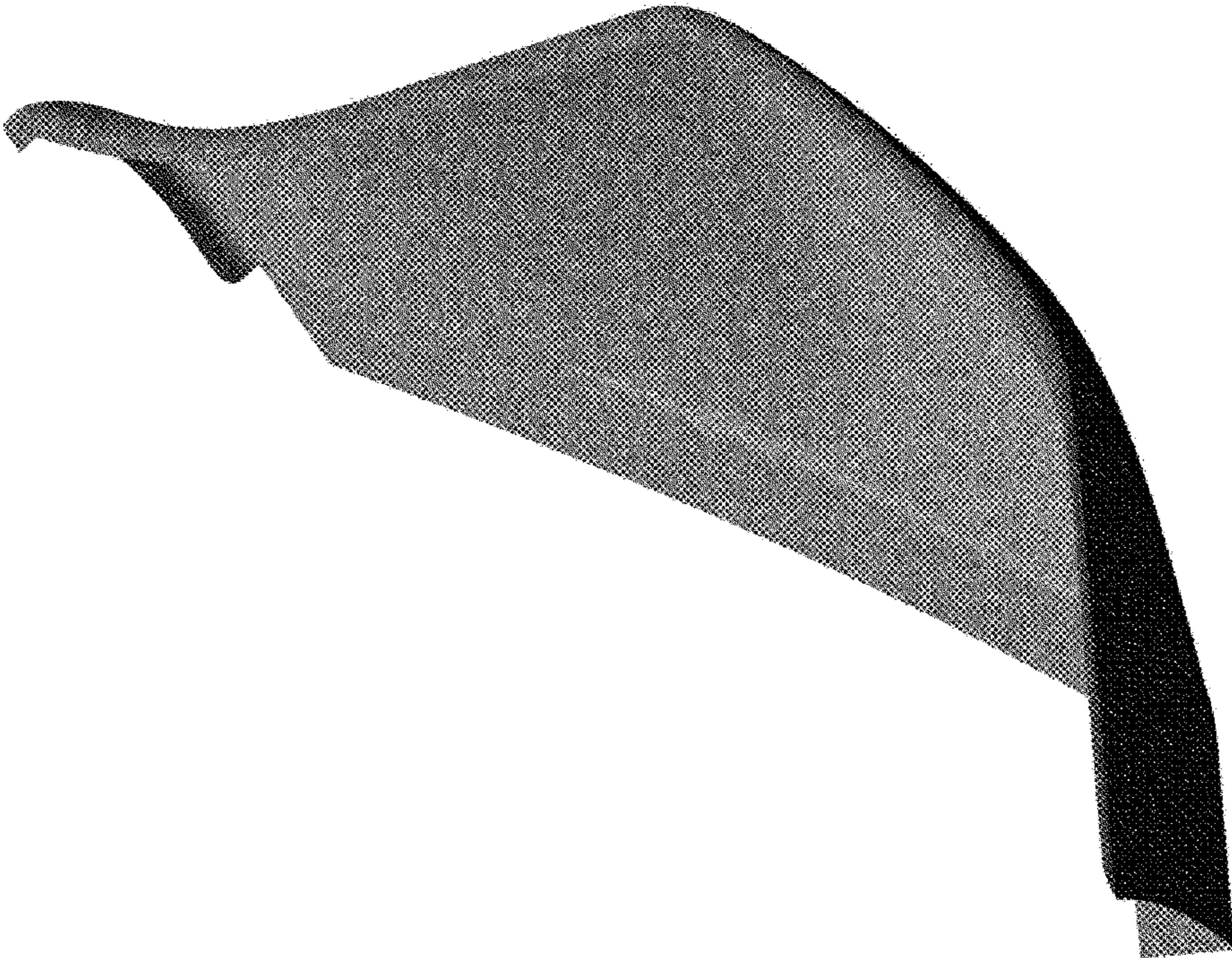

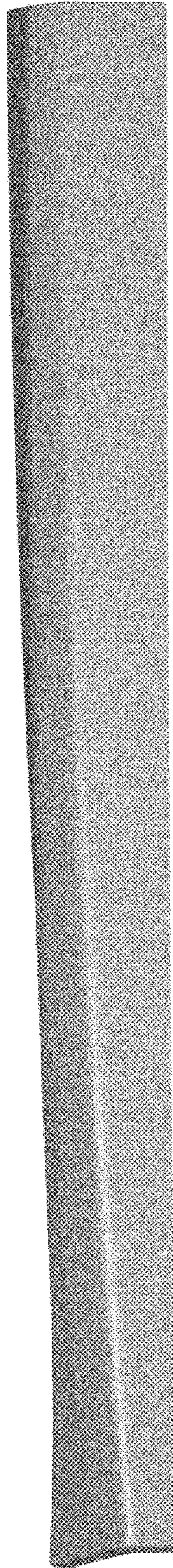

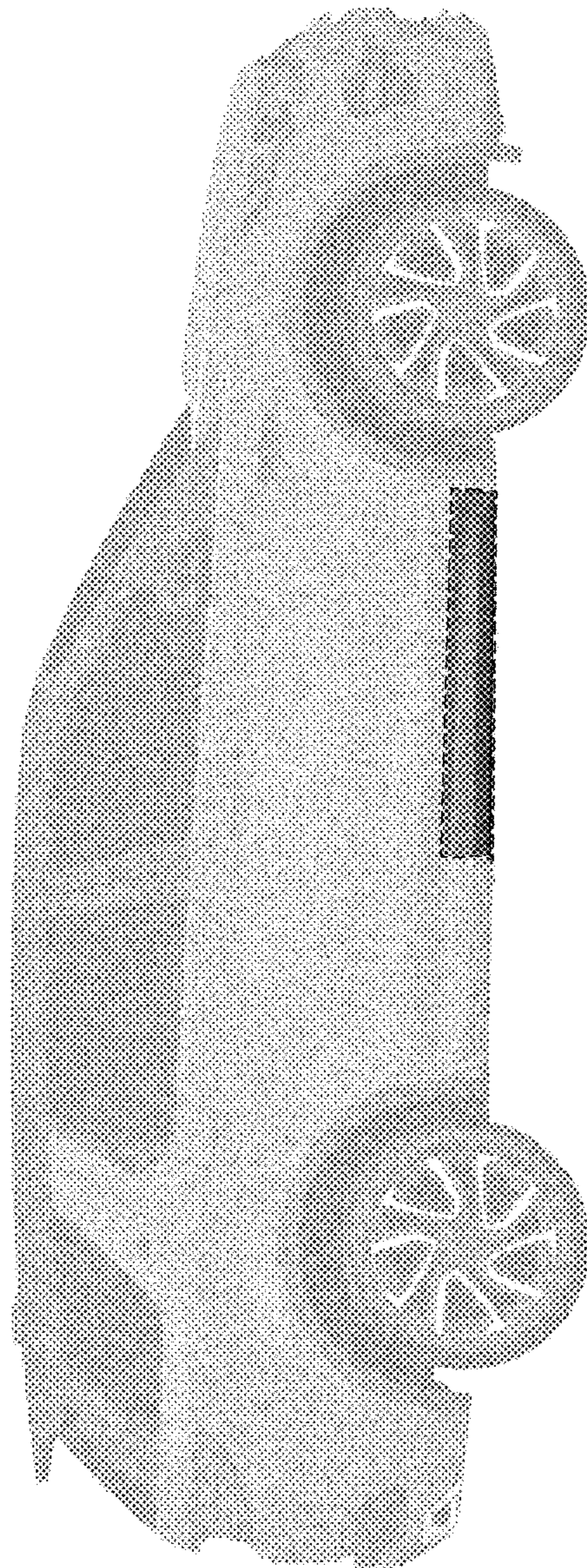
