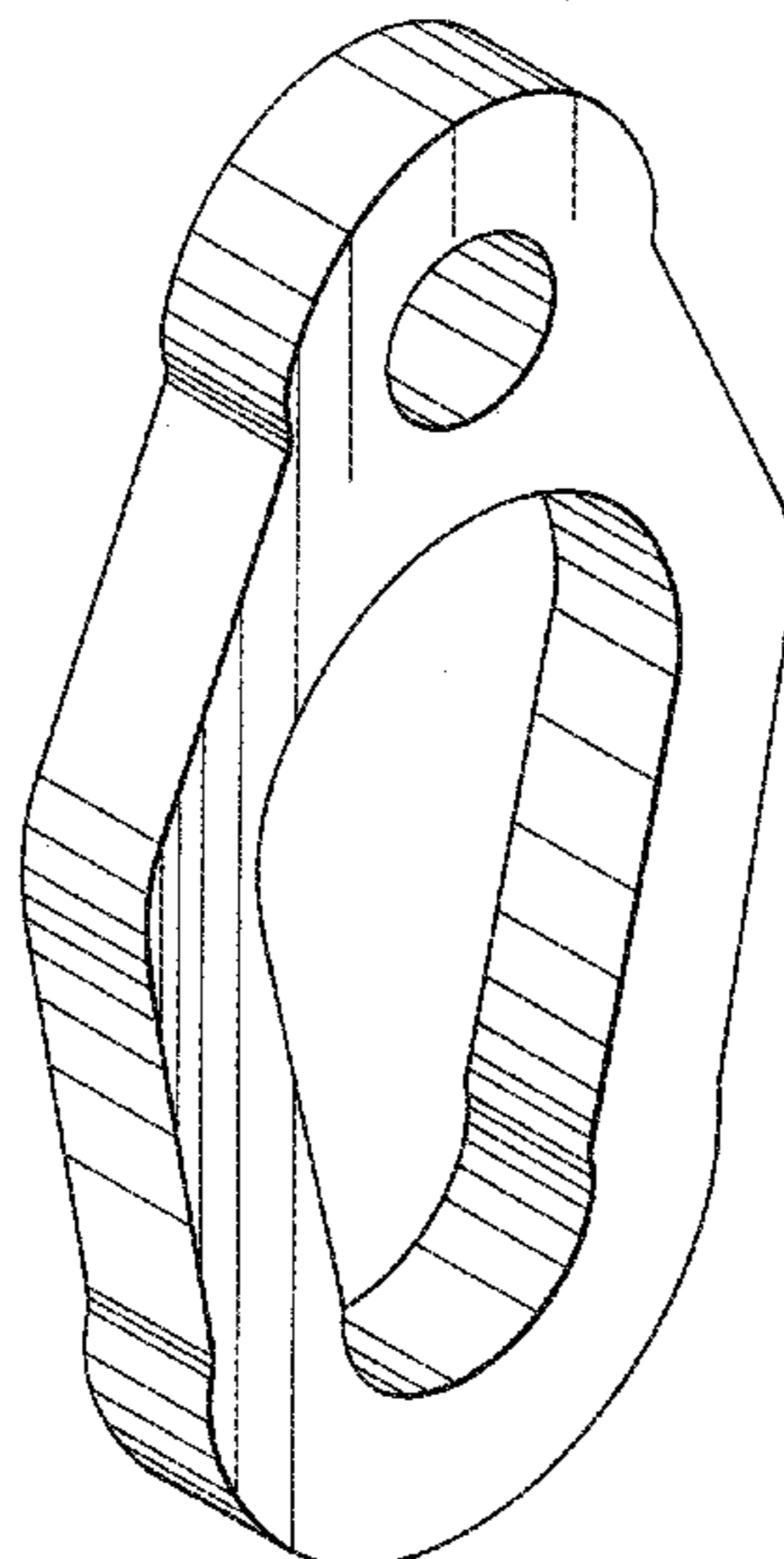
(57) **CLAIM**

we claim the ornamental design for a plate to assist in establishing a towing connection to a ball hitch, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view showing the front, left side and top features of our new design;  
FIG. 2 is a front elevation view thereof;  
FIG. 3 is a right side elevation view thereof, it being understood that a left side elevation view is identical hereto;  
FIG. 4 is a top plan view thereof; and,  
FIG. 5 is a bottom view thereof.

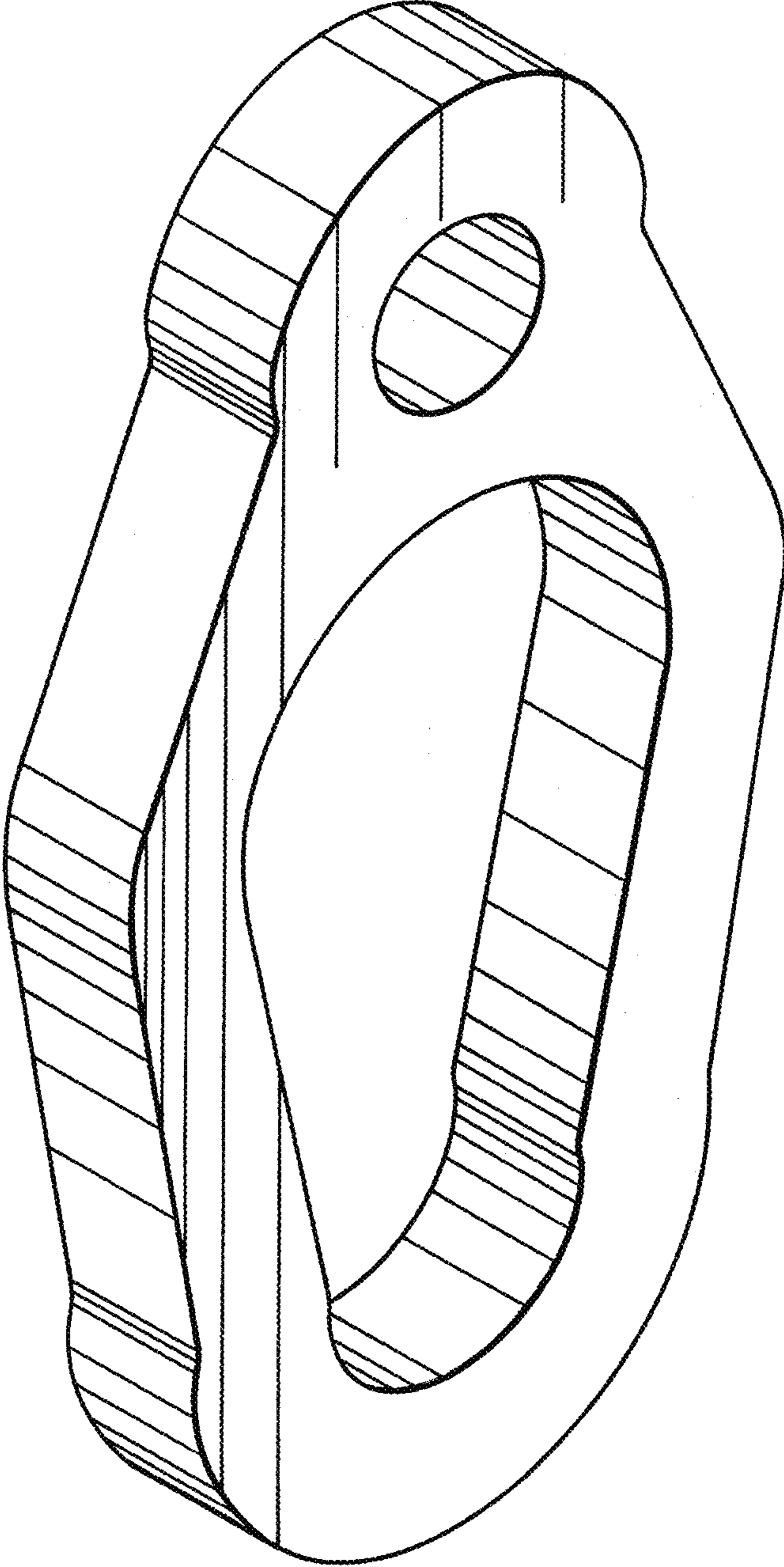

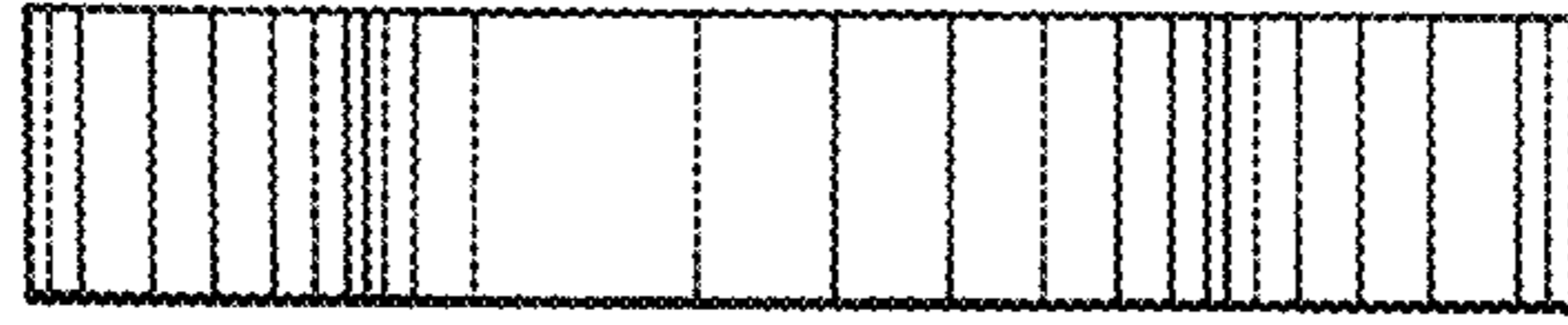

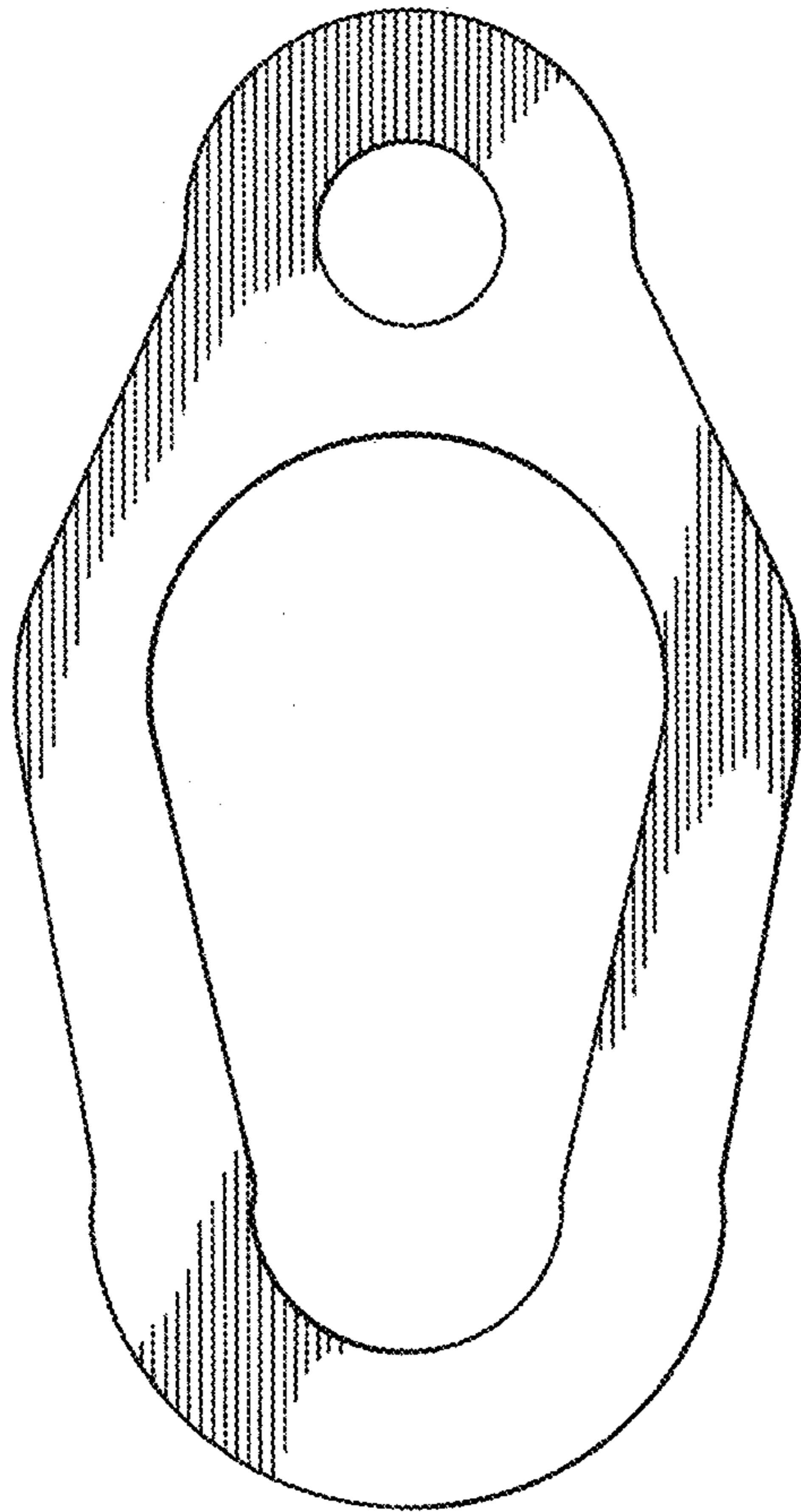

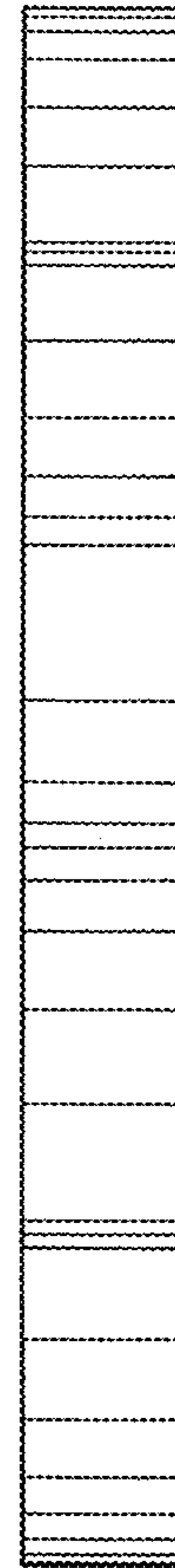

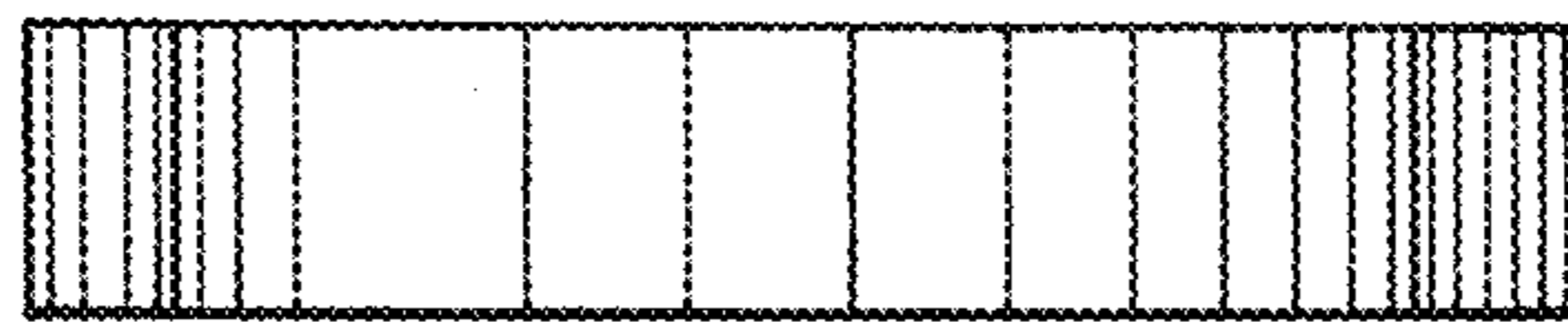
