The figures show differing tones, which indicate a contrast in appearance.

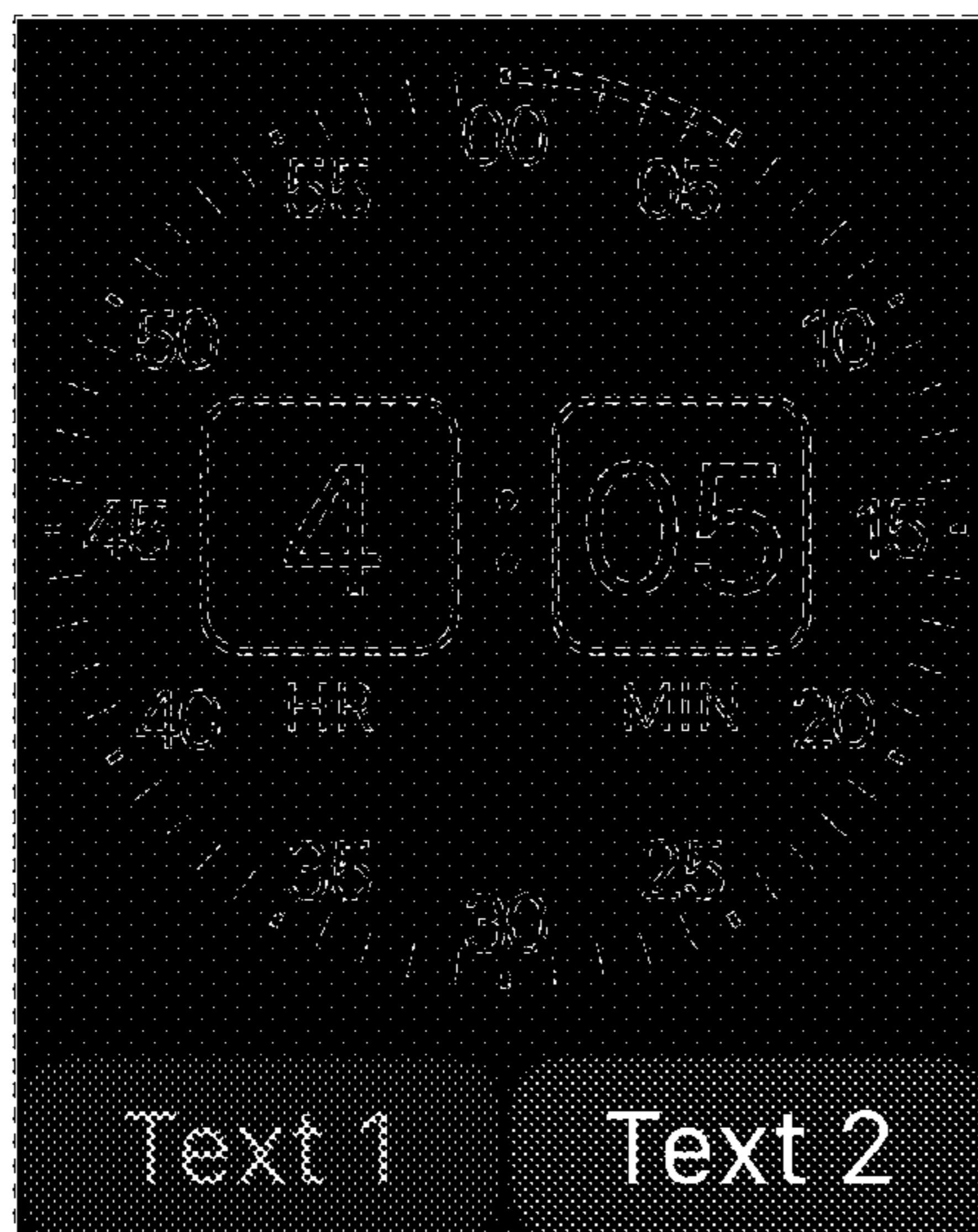

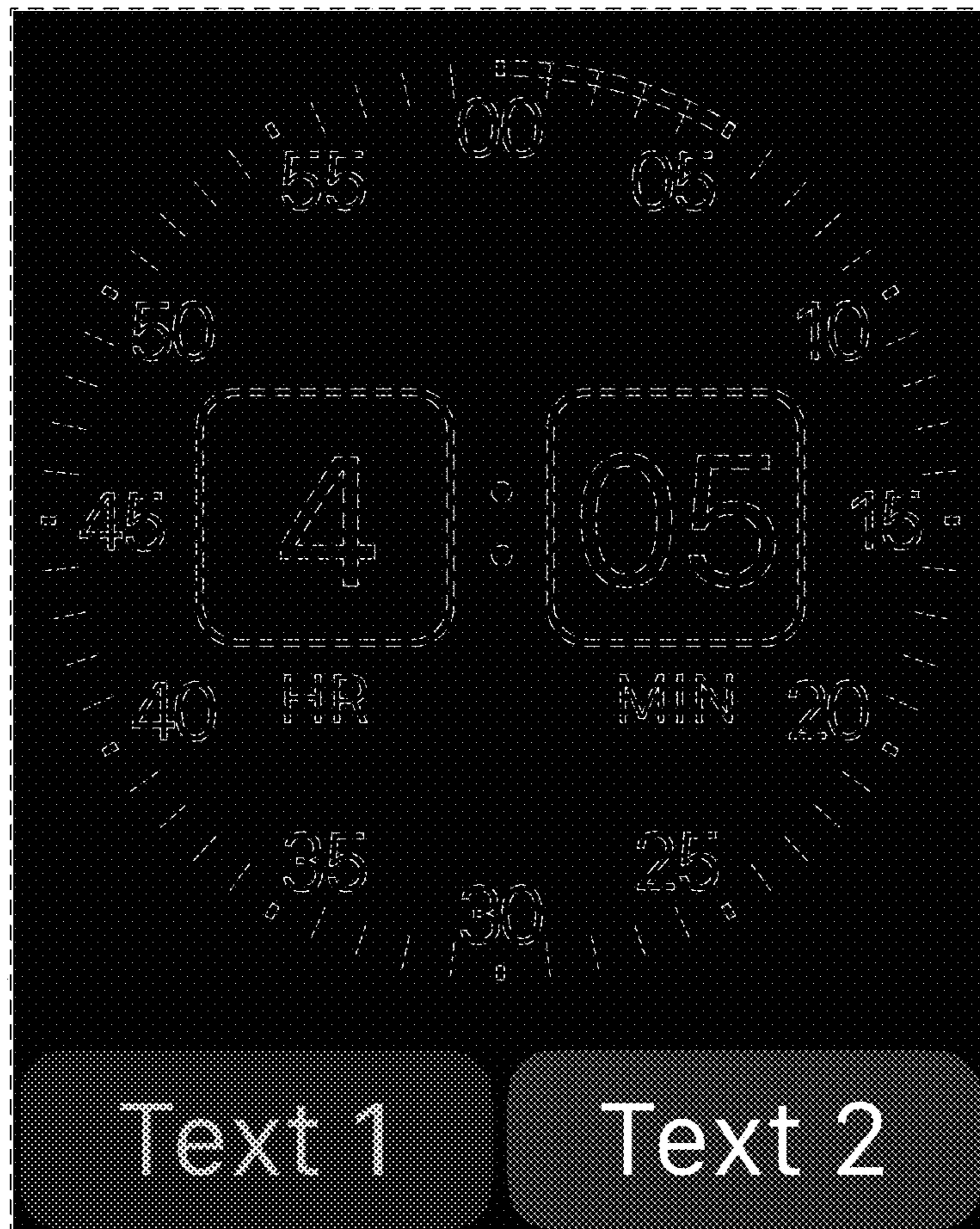

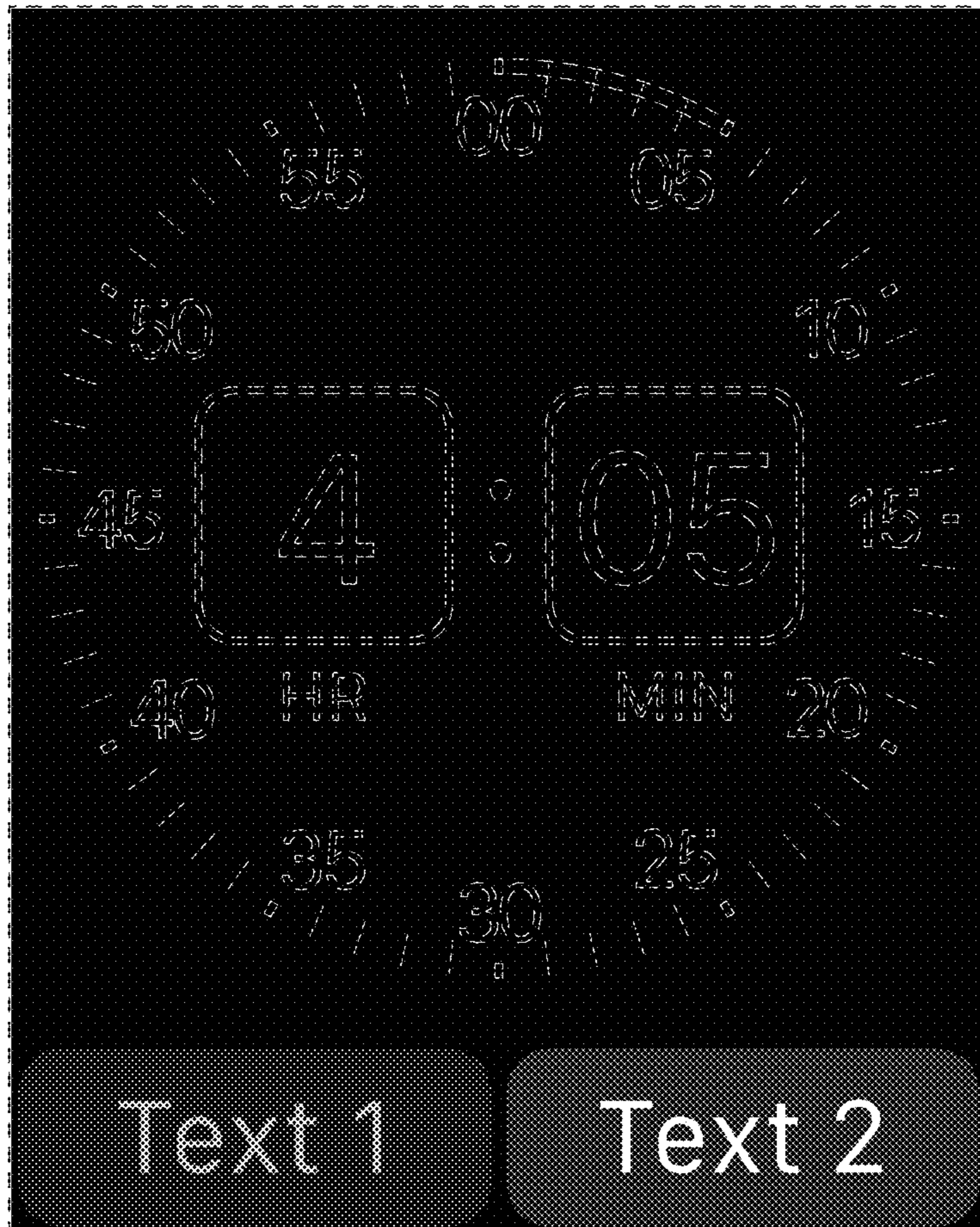

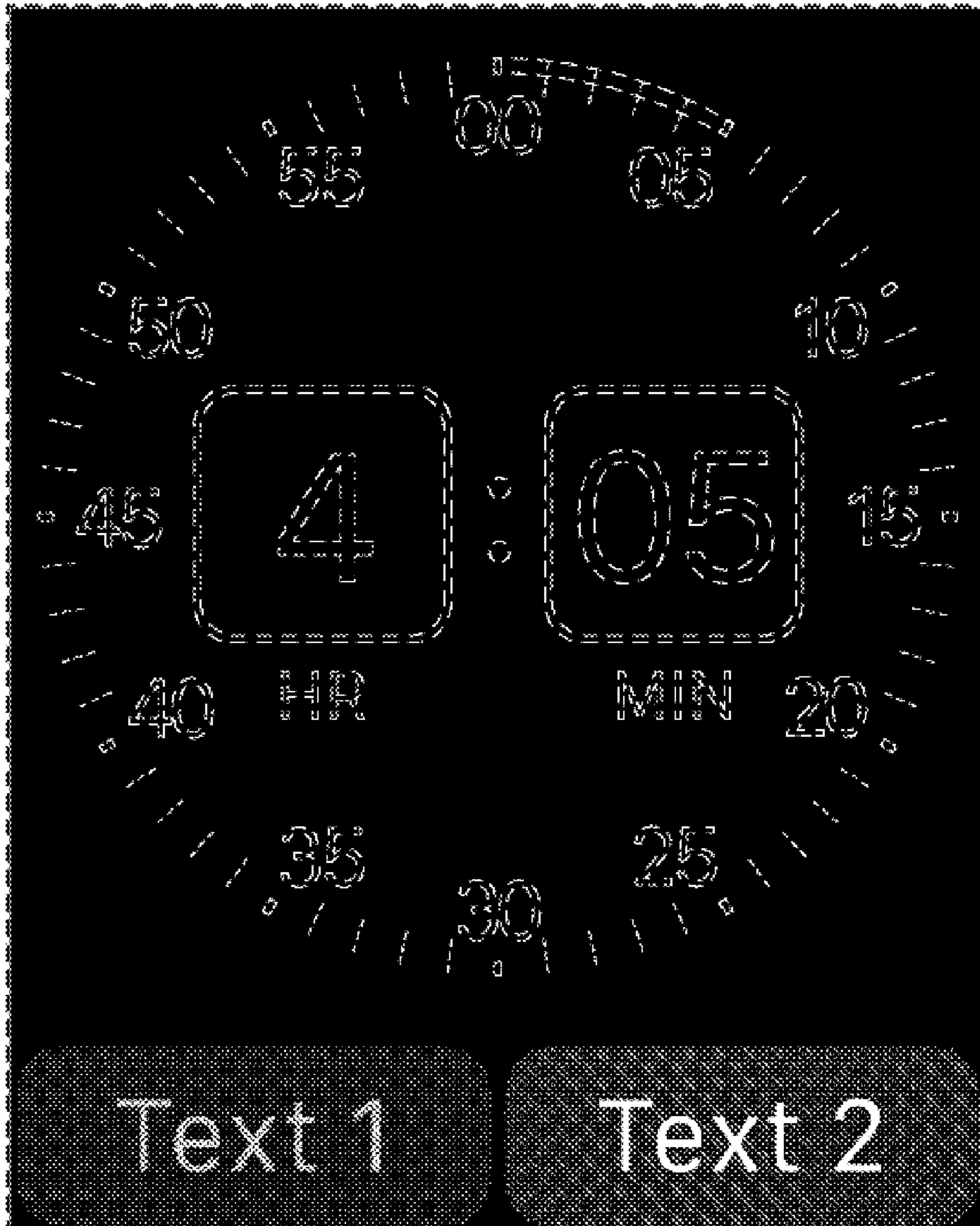
