(57) **CLAIM**

The ornamental design for a multipurpose portable mini loom, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of the new design for a multipurpose portable mini loom.
FIG. 2 is a bottom perspective view of FIG. 1.
FIG. 3 is a top plan view of FIG. 1.
FIG. 4 is a bottom plan view of FIG. 1.
FIG. 5 is a right side view of FIG. 1.
FIG. 6 is an end view of FIG. 1, the opposite end being the same.
FIG. 7 is an inverted left side view of a second embodiment of the multipurpose portable mini loom.
FIG. 8 is an inverted left side view of FIG. 1.
FIG. 9 is a top plan view of FIG. 1, showing the unclaimed yarn thread warped between the outer opposed rows of end slots.
FIG. 10 is a top plan view of FIG. 1, showing the unclaimed yarn thread warped between the outer opposed array of holes.
FIG. 11 is a top plan view of FIG. 1, showing the unclaimed yarn thread warped between the inner opposed array of holes.
FIG. 12 is a top perspective view of FIG. 1, showing the unclaimed weaving and threading needles.
FIG. 13 is a top plan view of a third embodiment of the multipurpose portable mini loom of FIG. 1.
FIG. 14 is a top plan view of a fourth embodiment of the multipurpose portable mini loom of FIG. 1 showing the unclaimed ruled markings.
FIG. 15 is a top plan view of a fifth embodiment of the multipurpose portable mini loom of FIG. 1.
FIG. 16 is a top plan view of FIG. 1, showing the unclaimed yarn thread warped between the outer opposed array of holes.
FIG. 17 is a bottom plan view of FIG. 16.

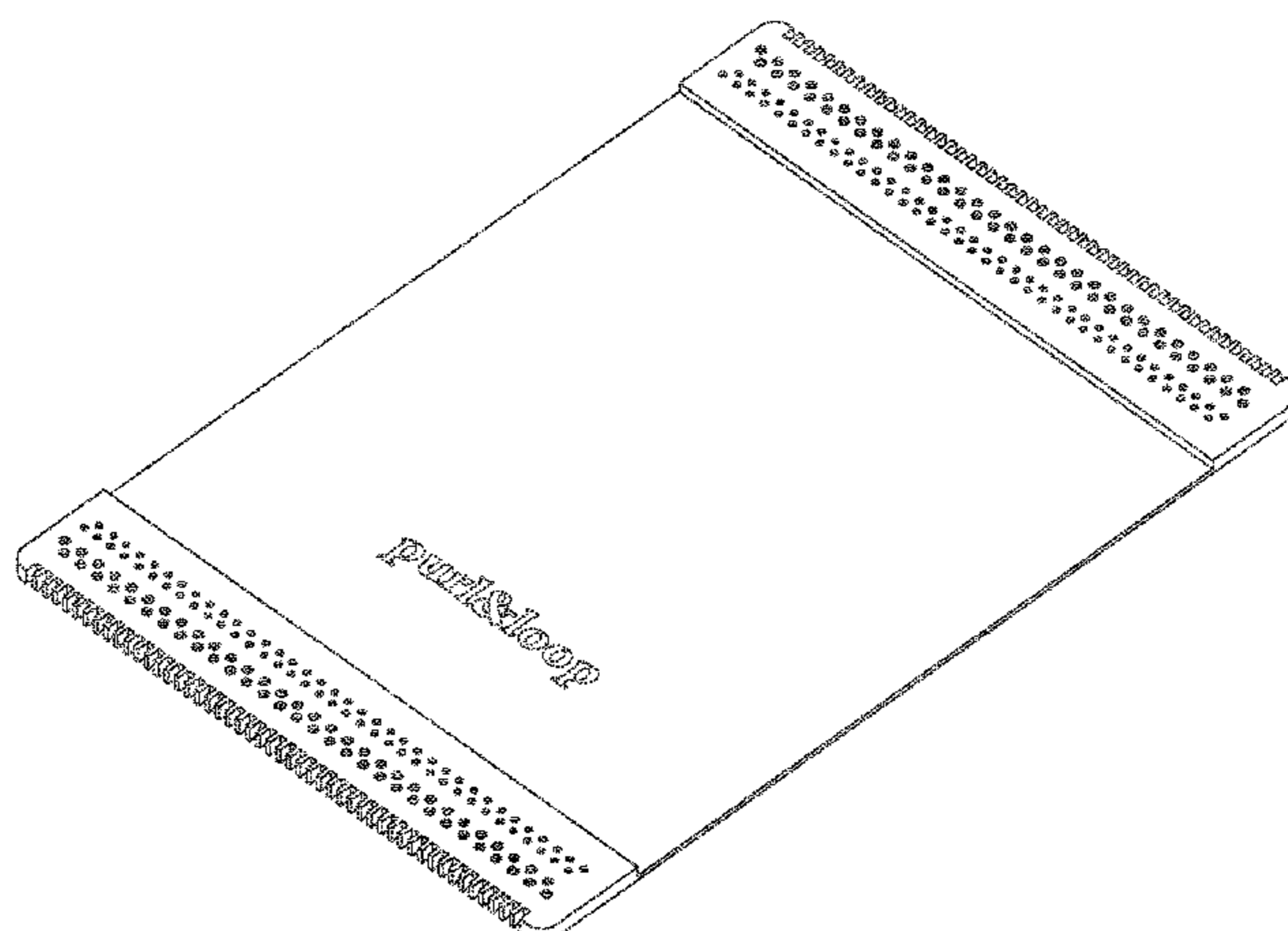

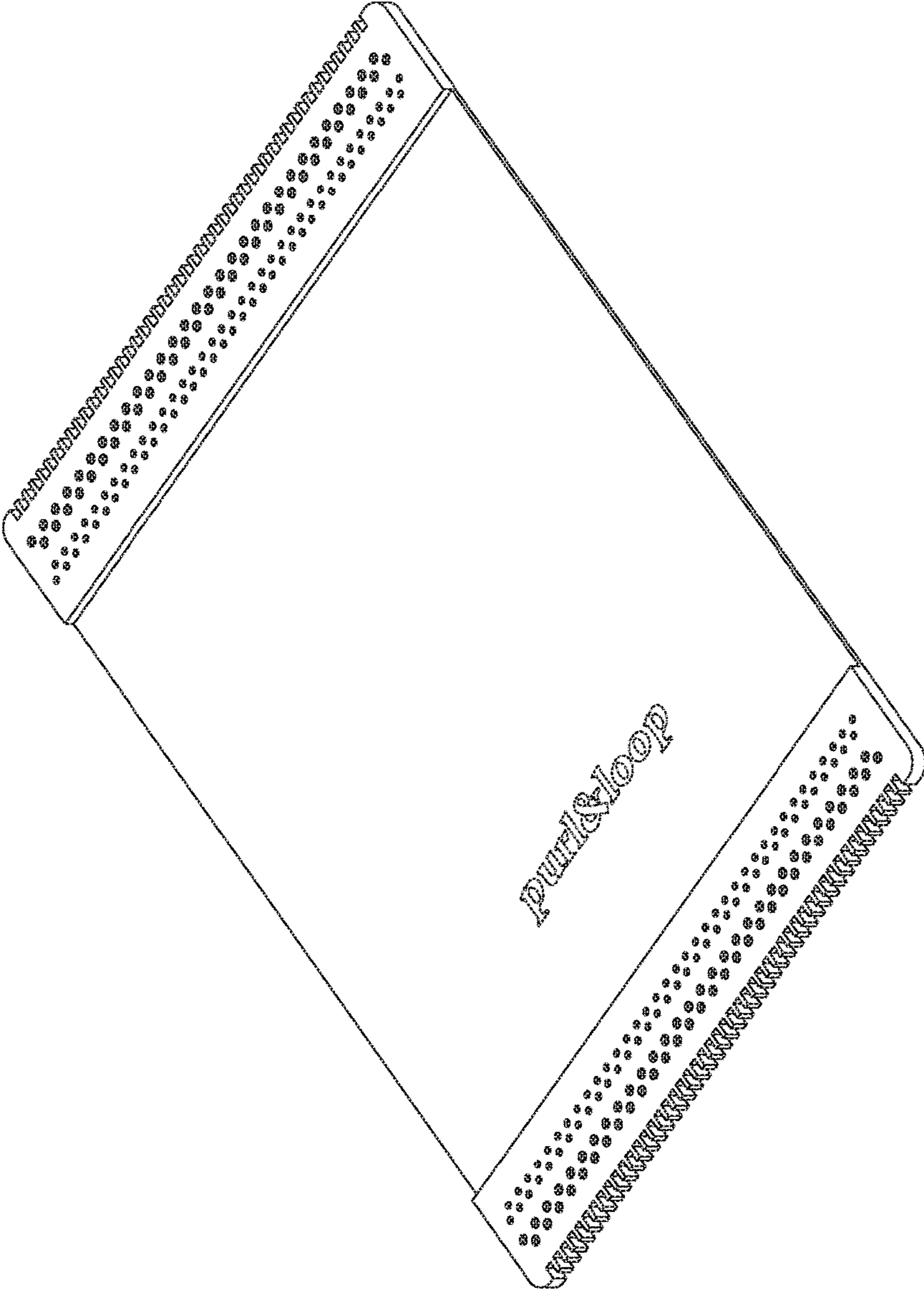

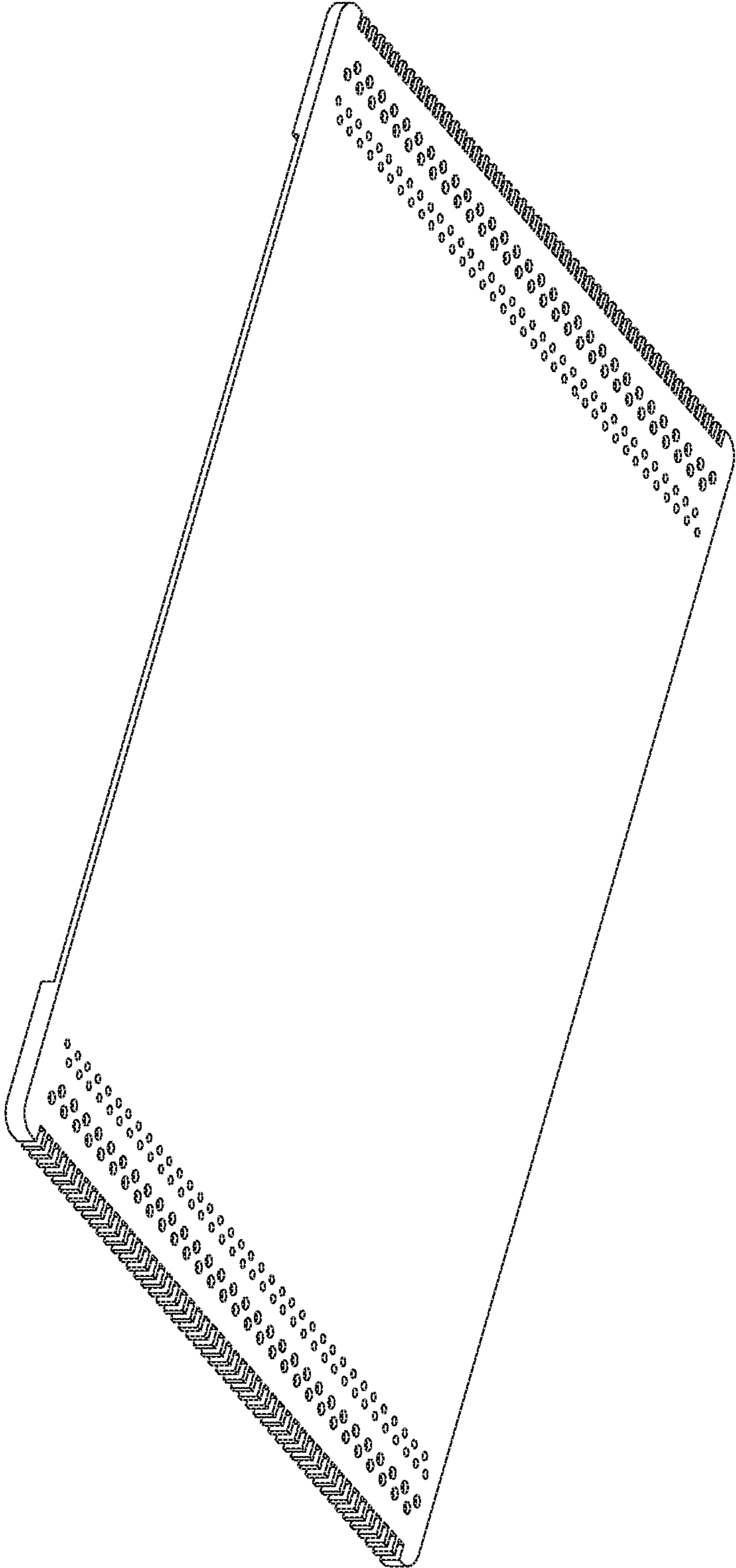

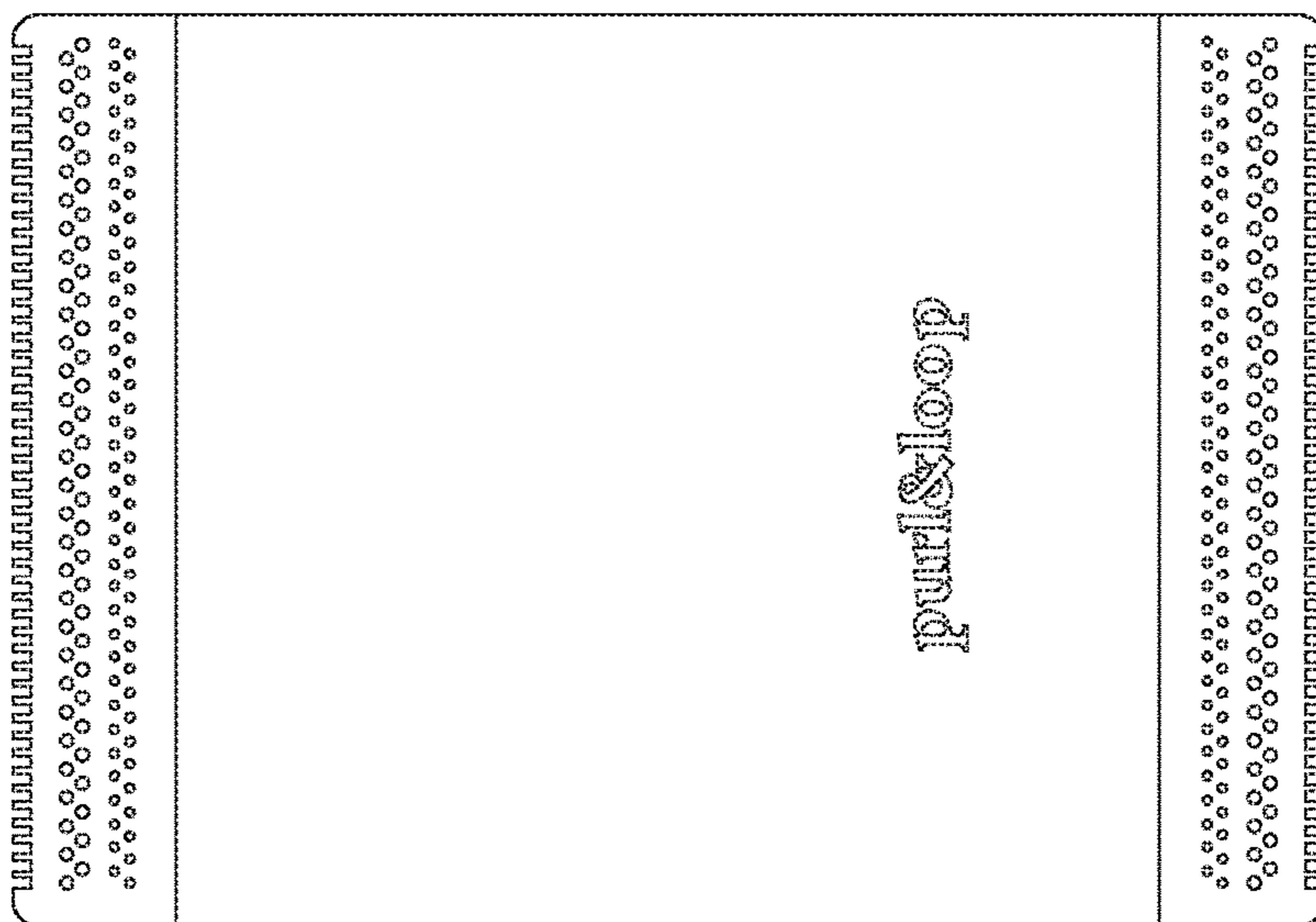

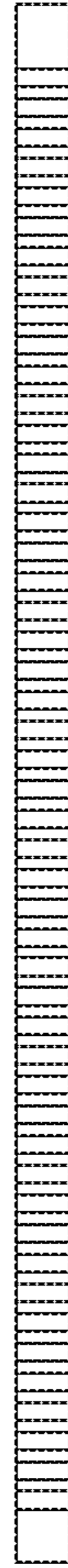

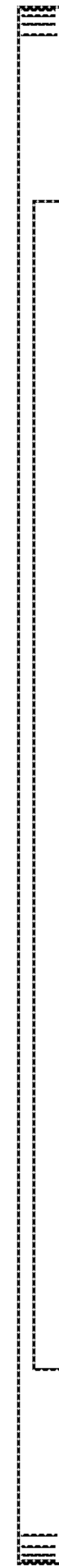

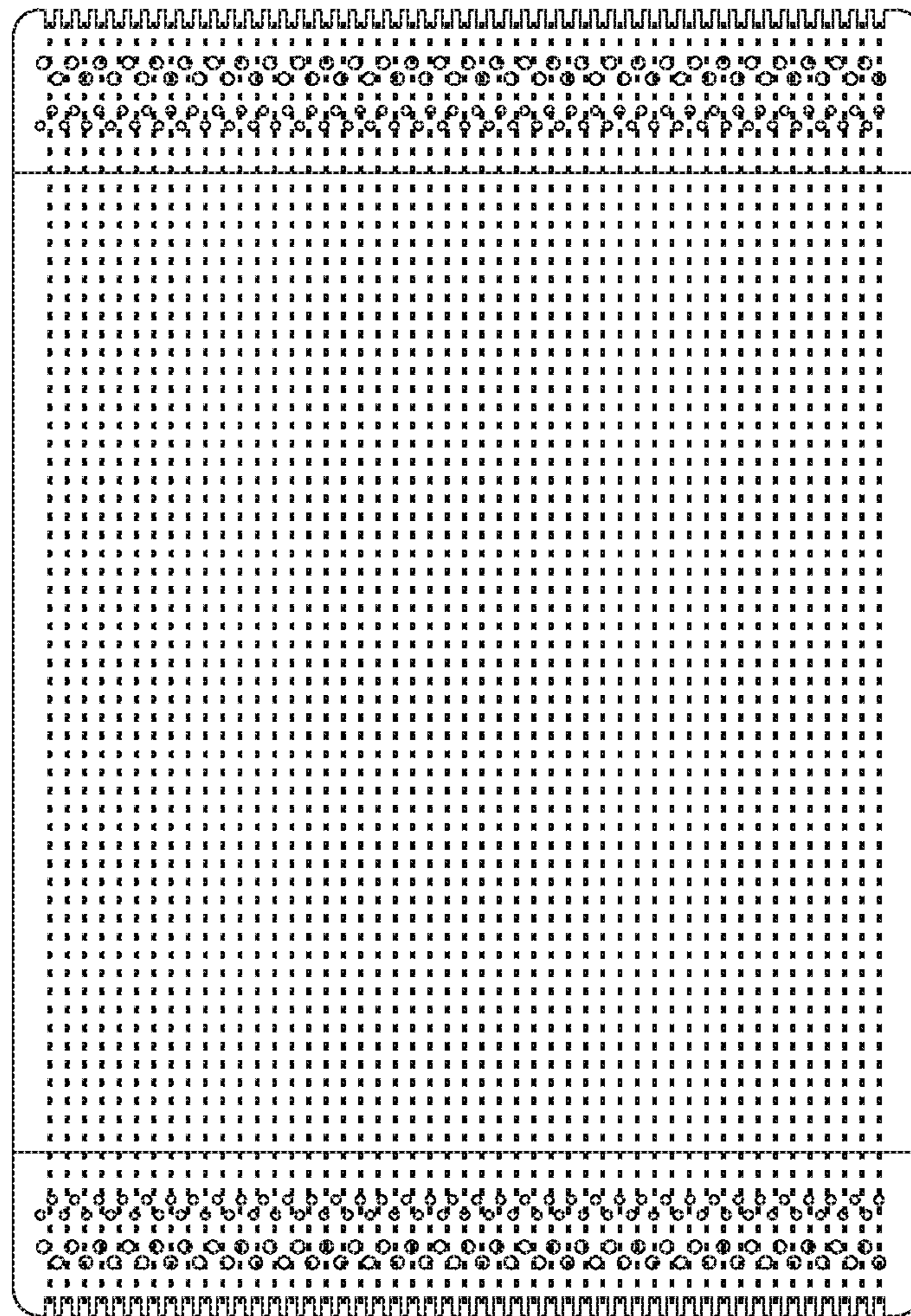

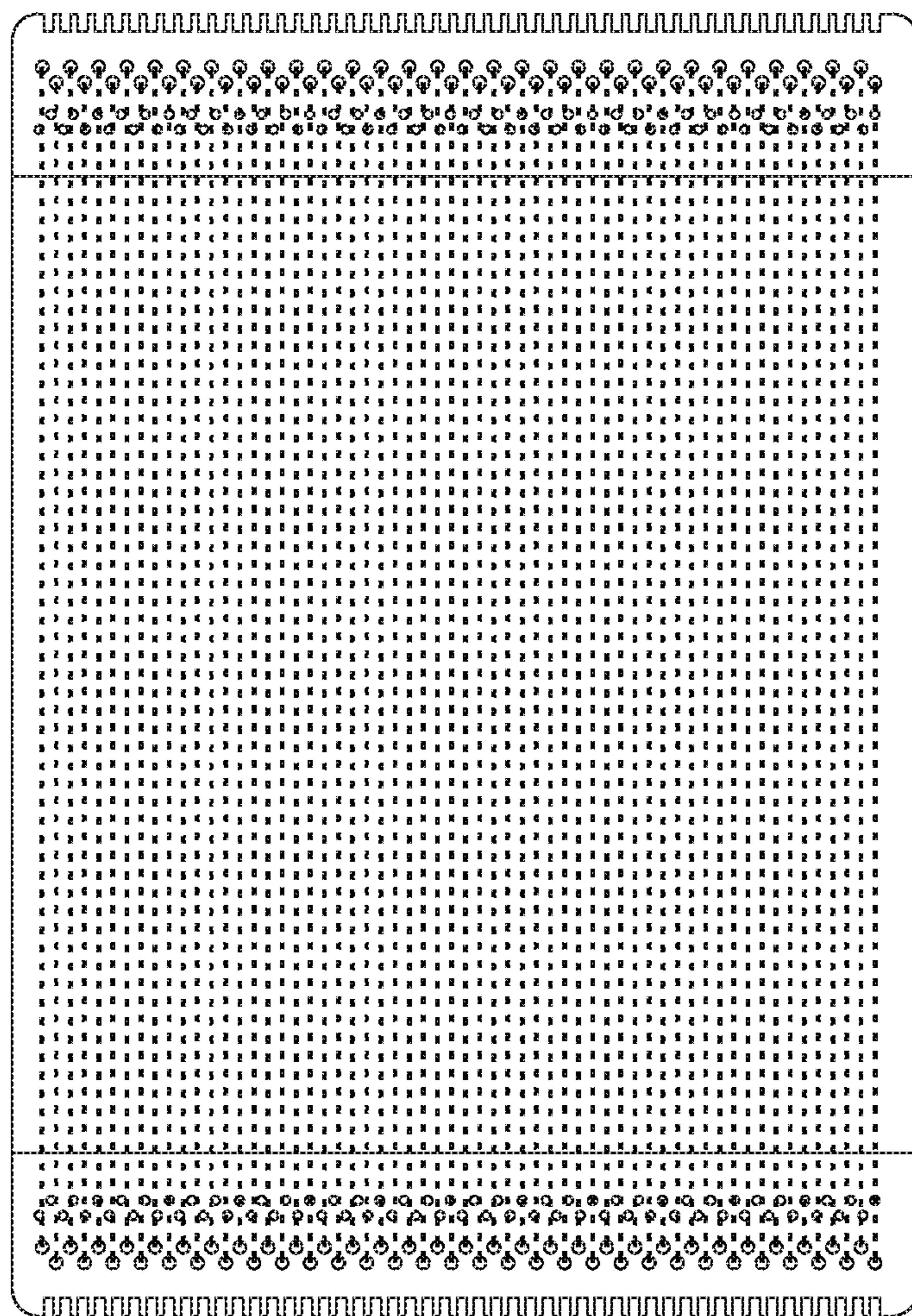

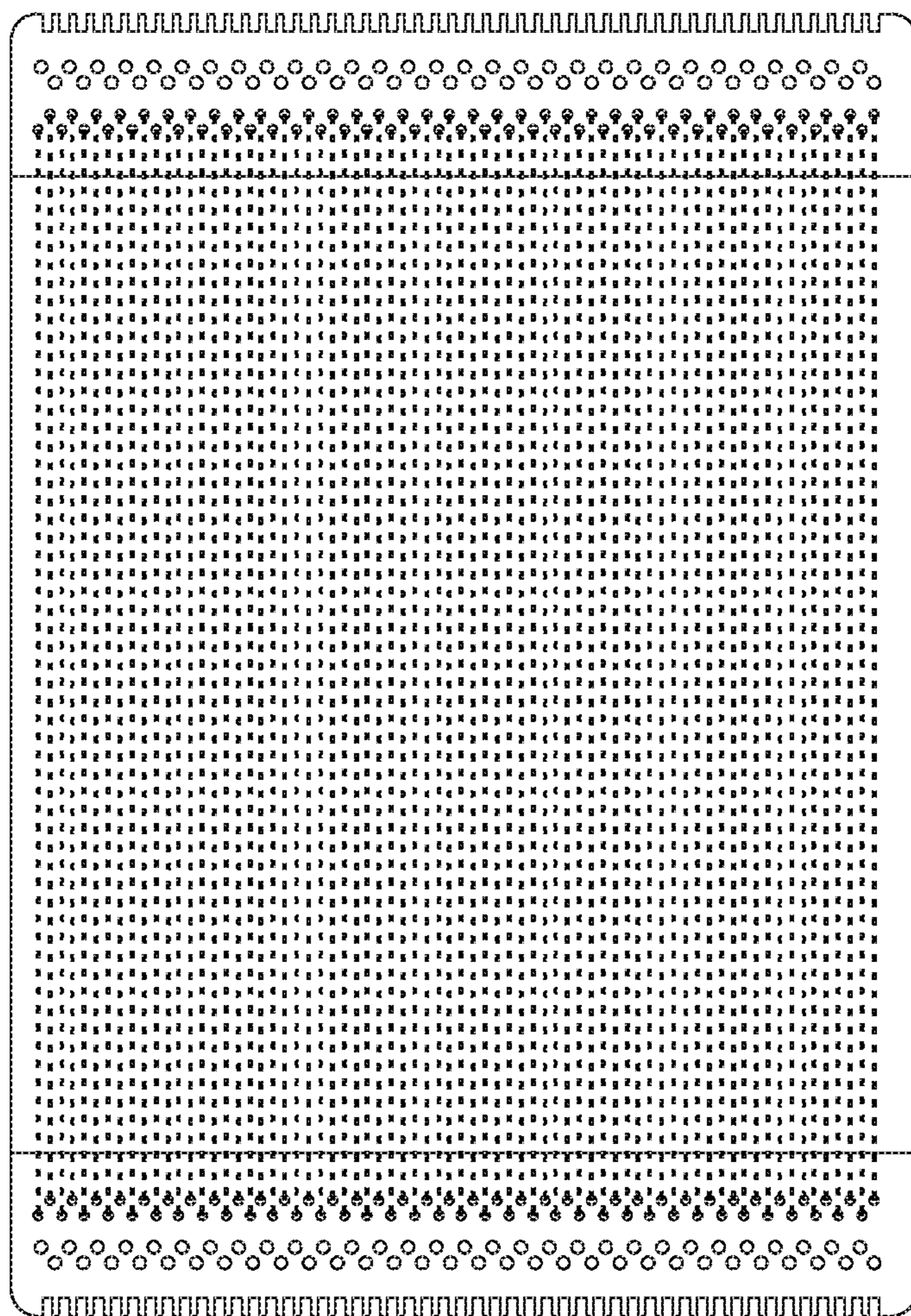

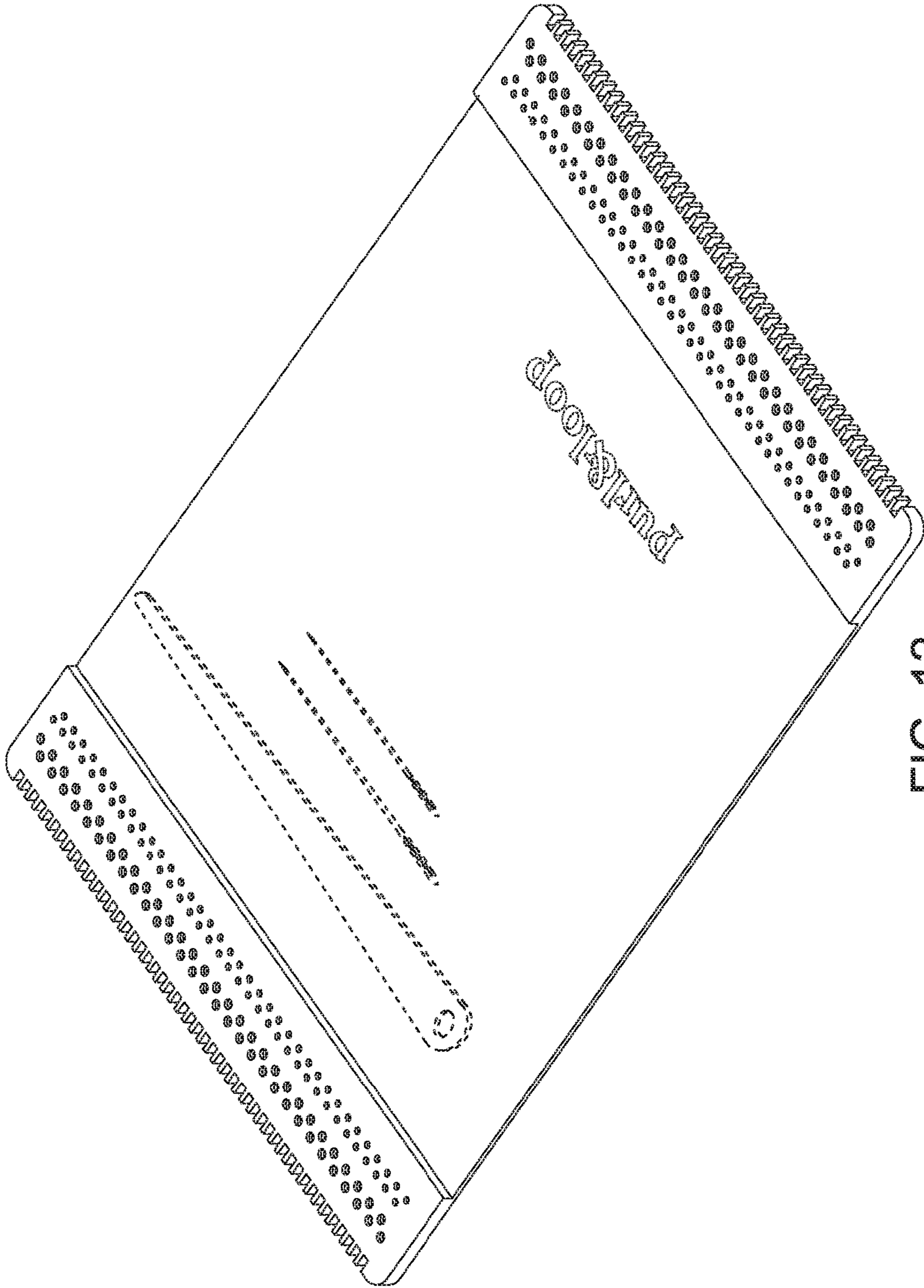

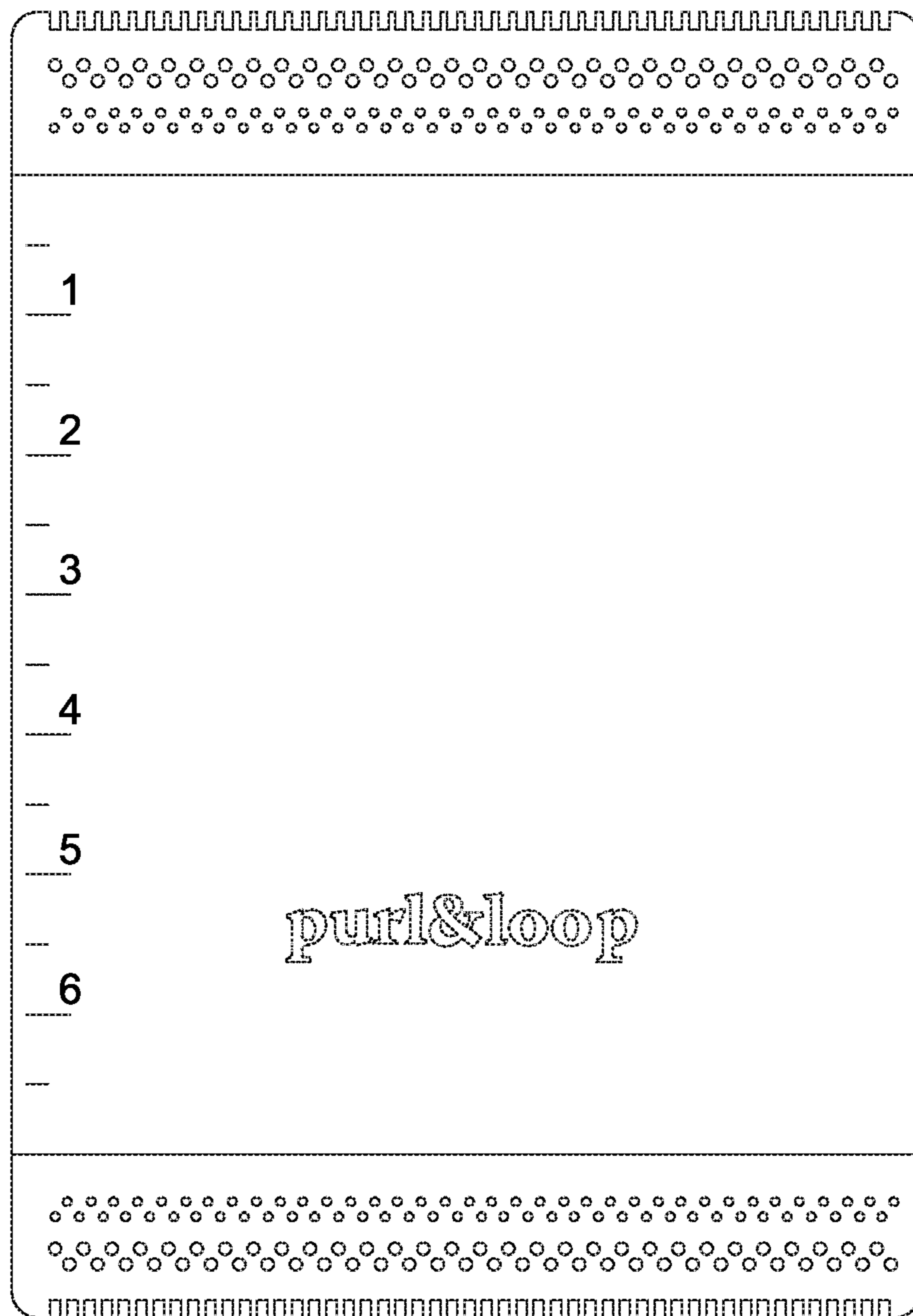

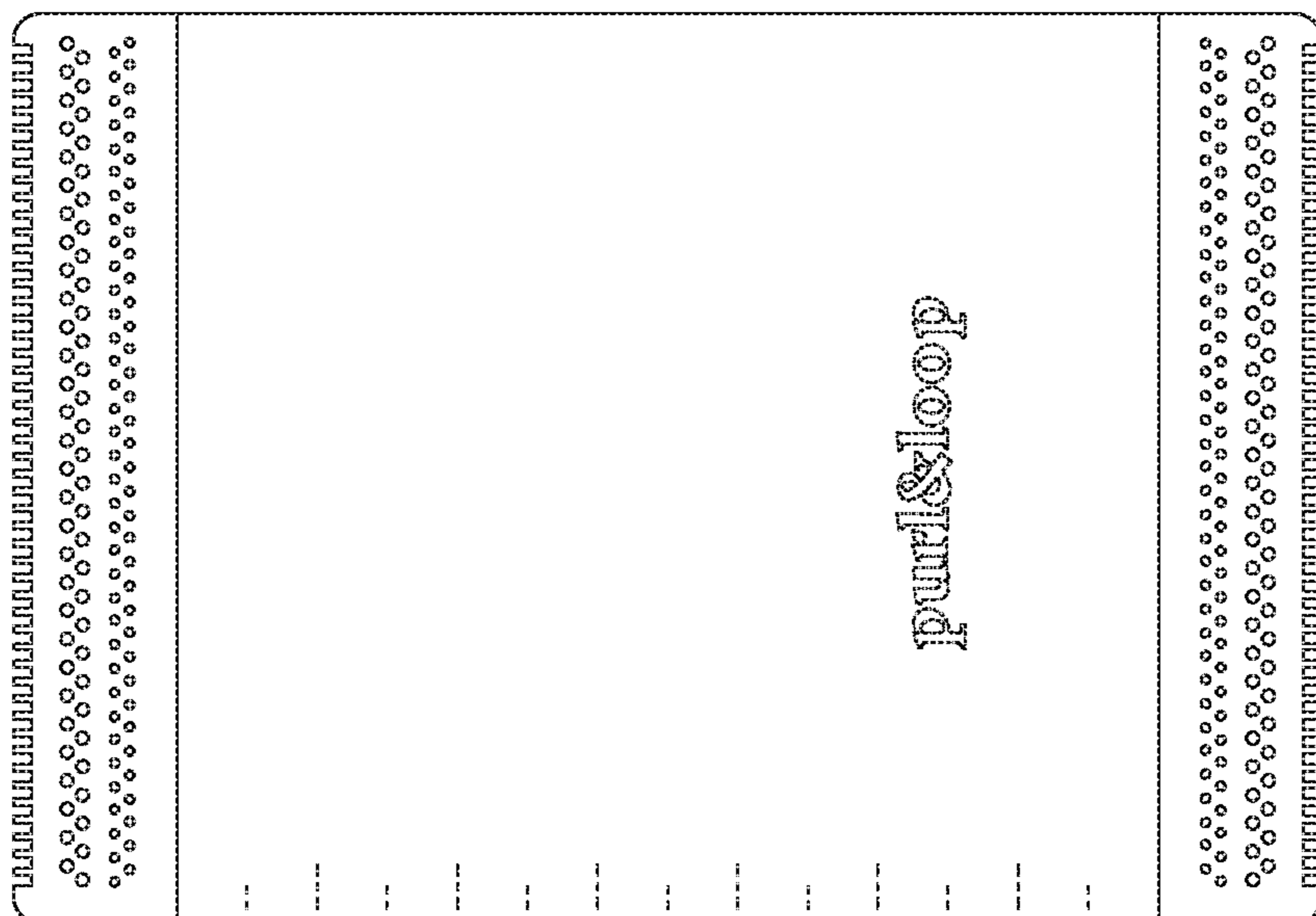

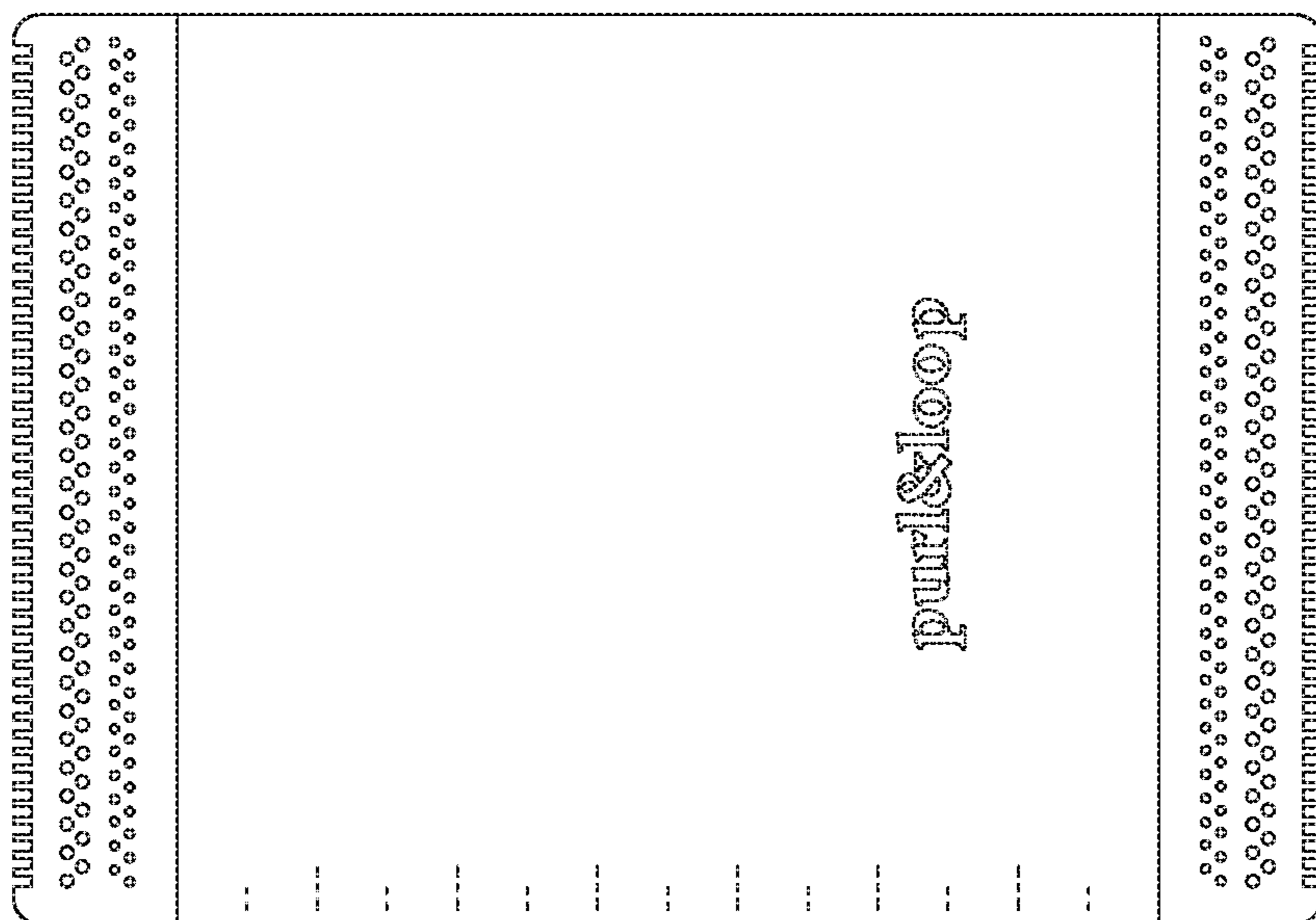

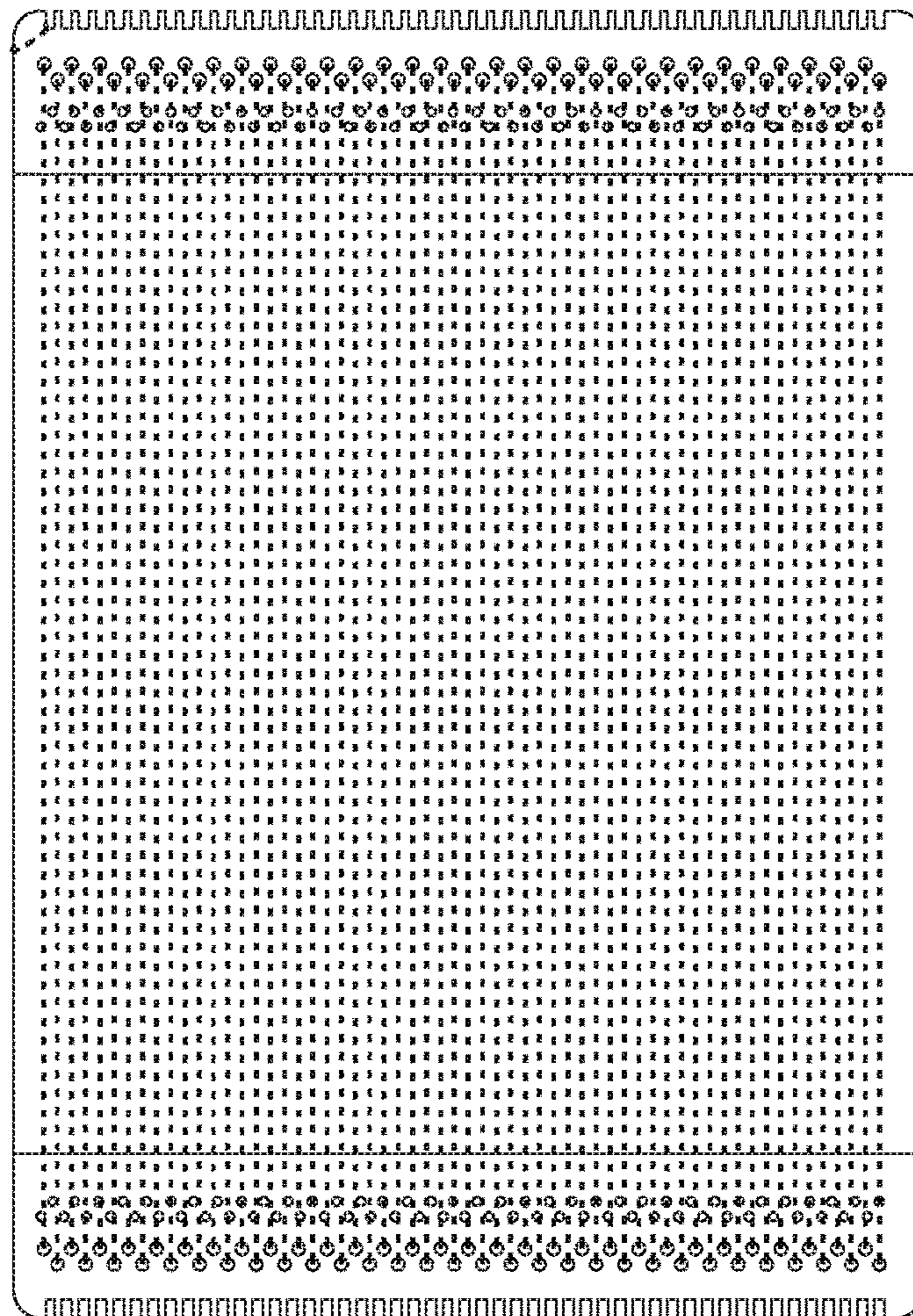

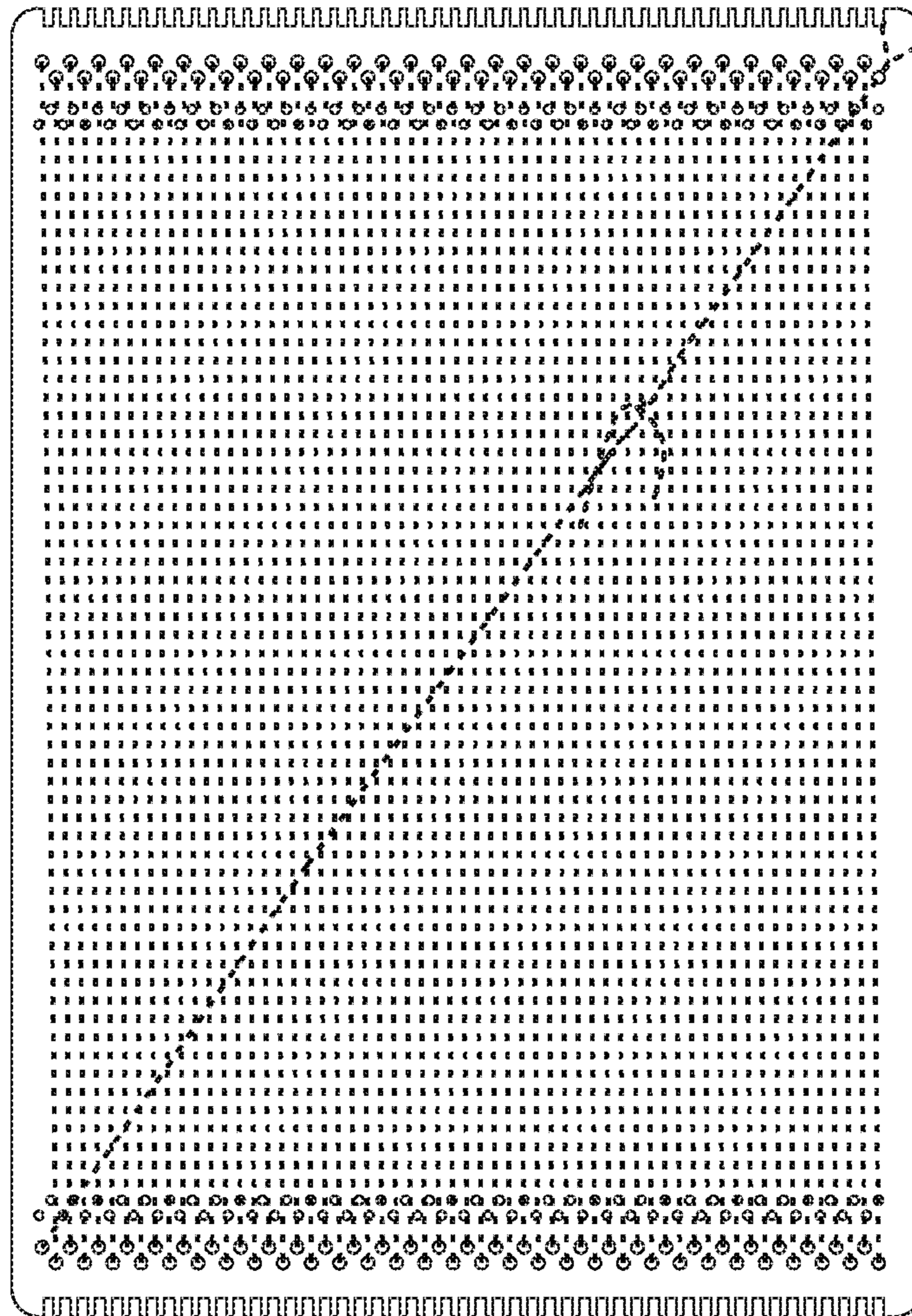

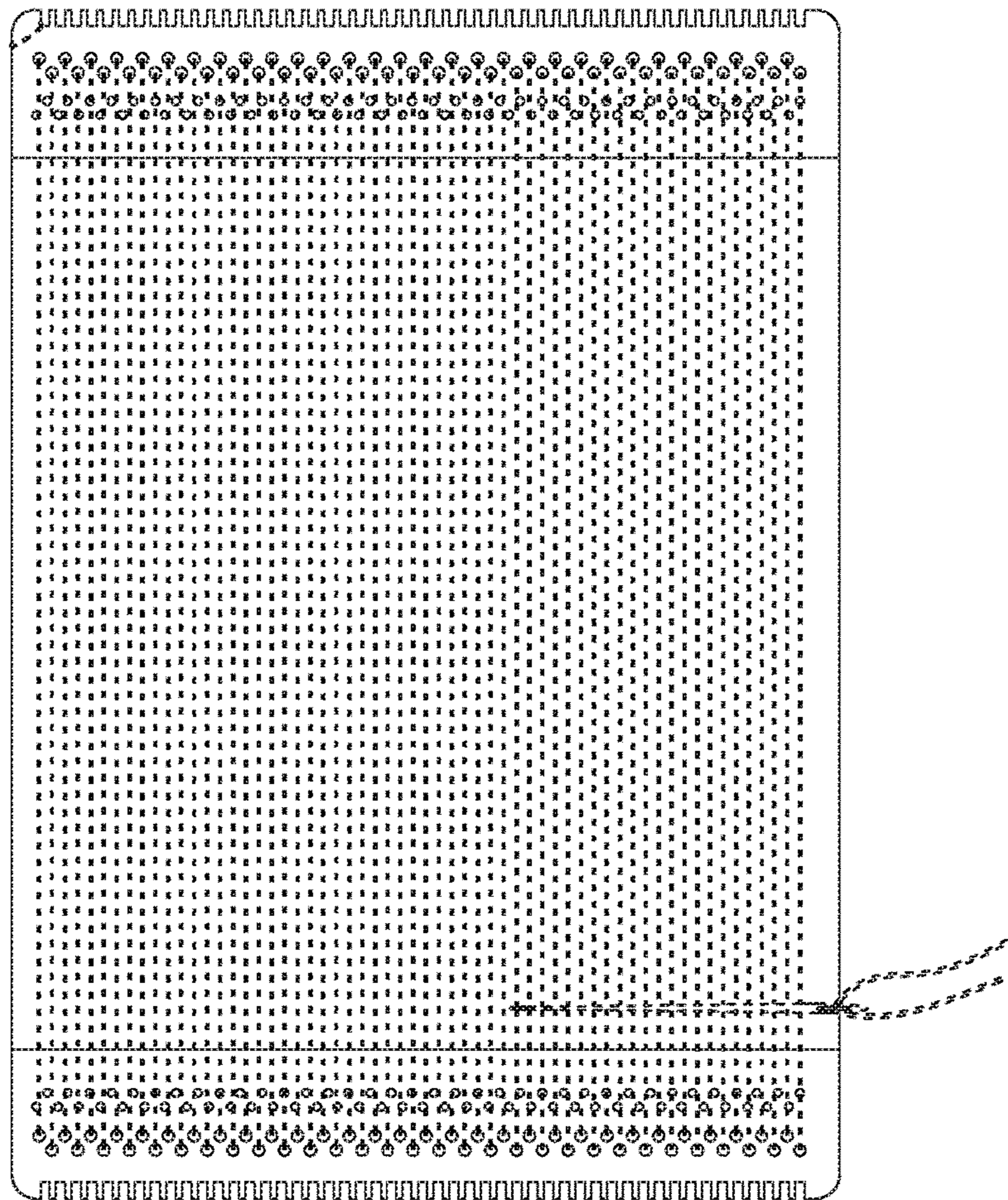

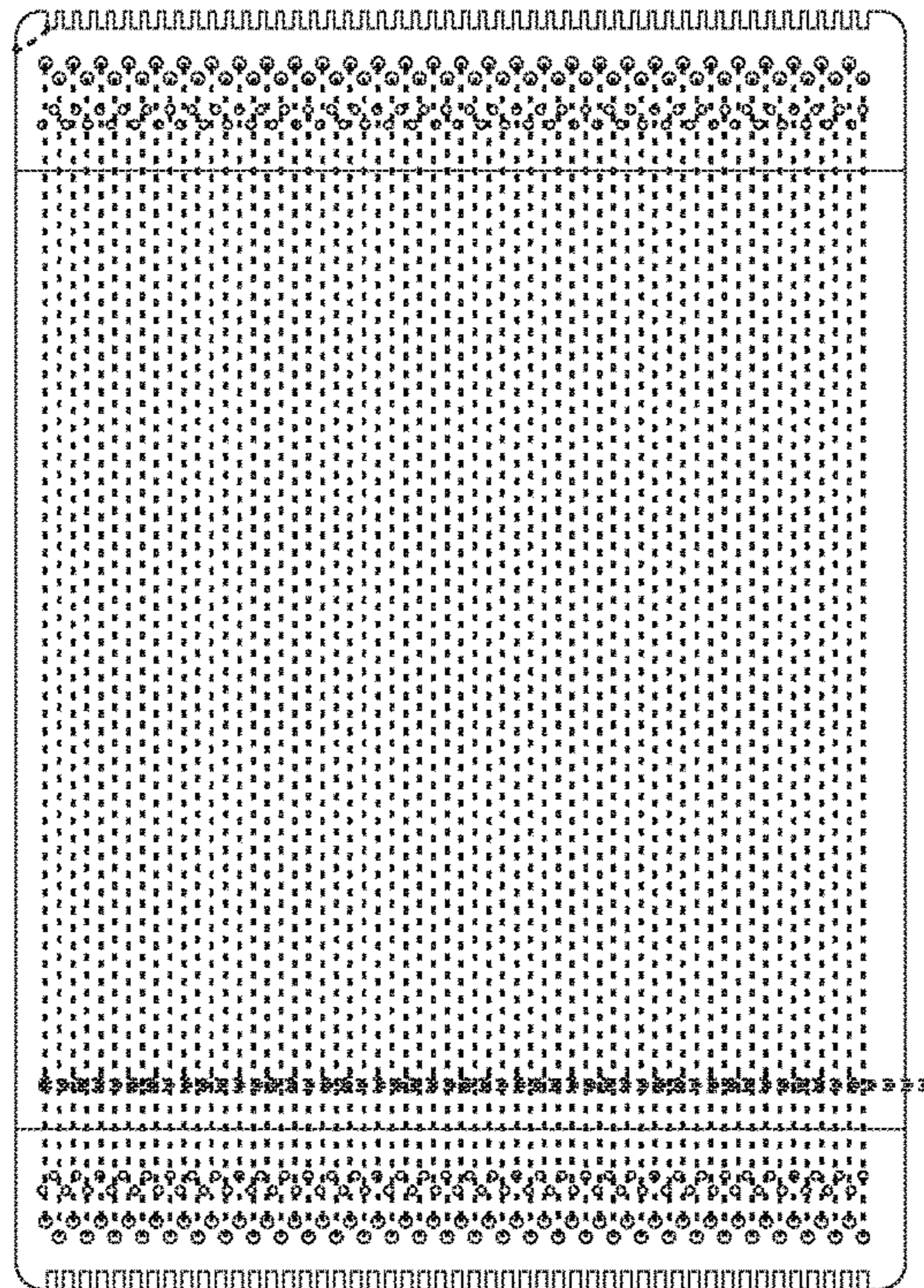
