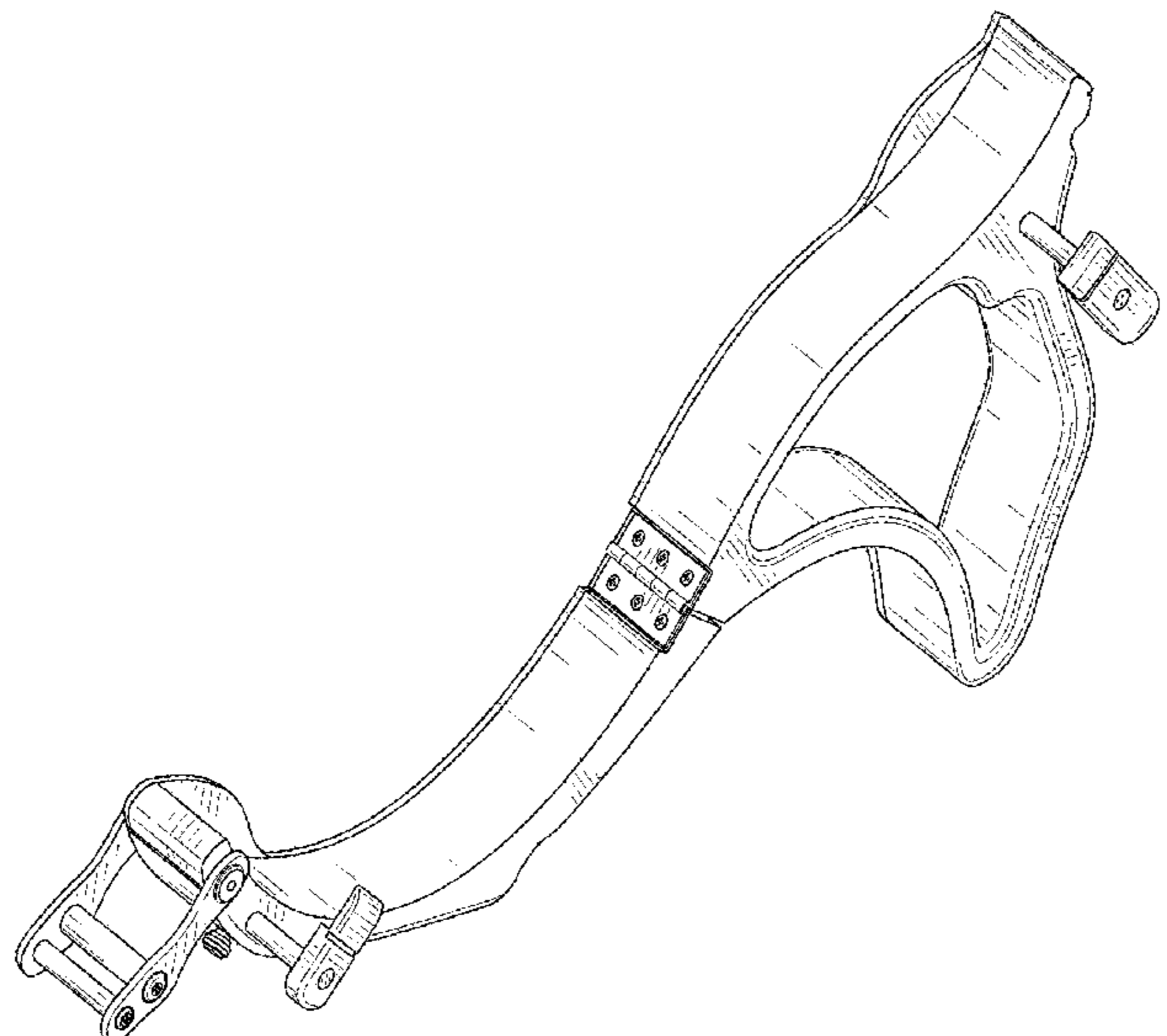
(57) **CLAIM**

The ornamental design for an ergonomic guitar support for acoustic guitar, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of the new design for an ergonomic guitar support for acoustic guitar in an unfolded position;  
FIG. 2 is a front view of thereof;  
FIG. 3 is a back view of thereof;

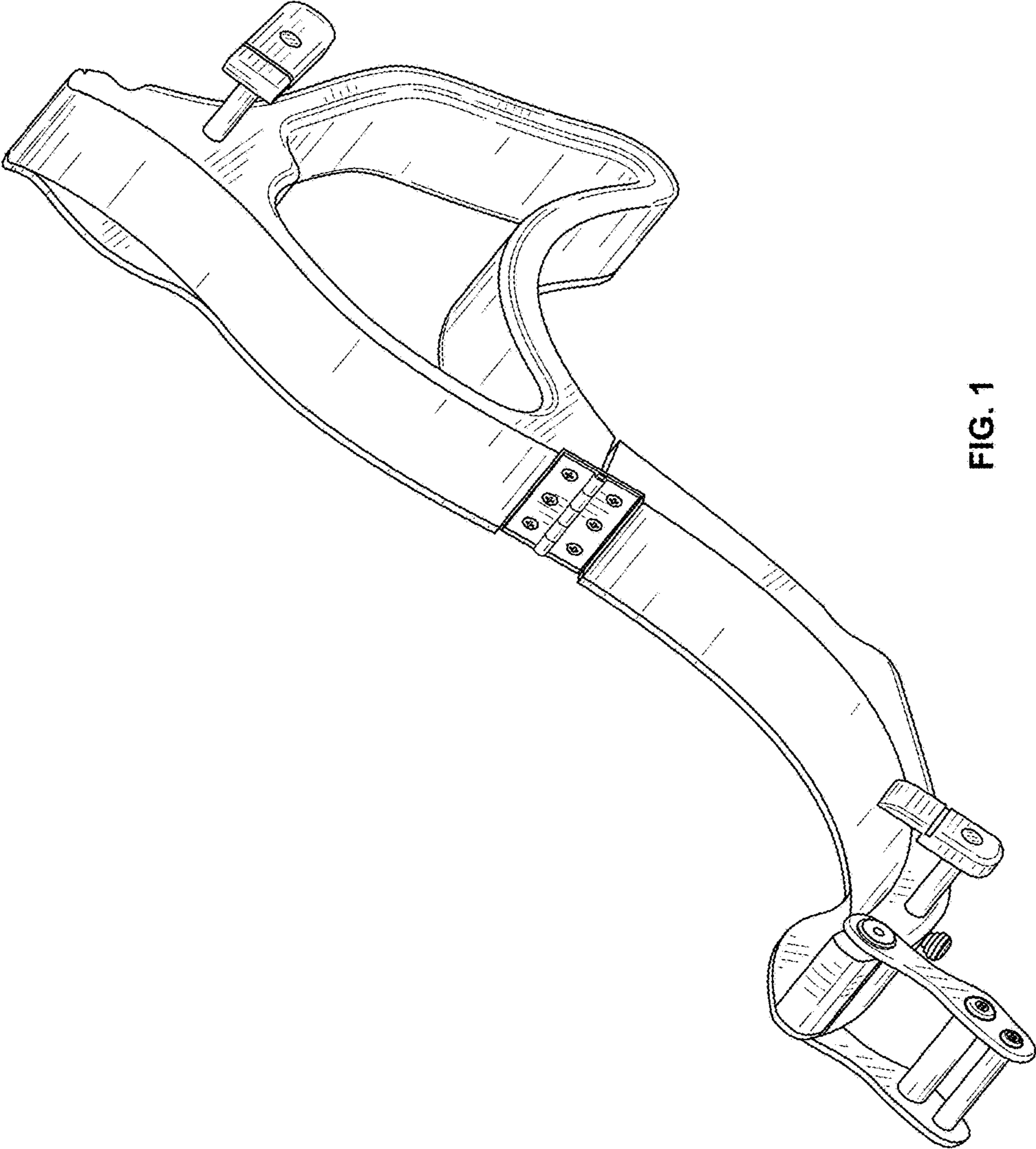

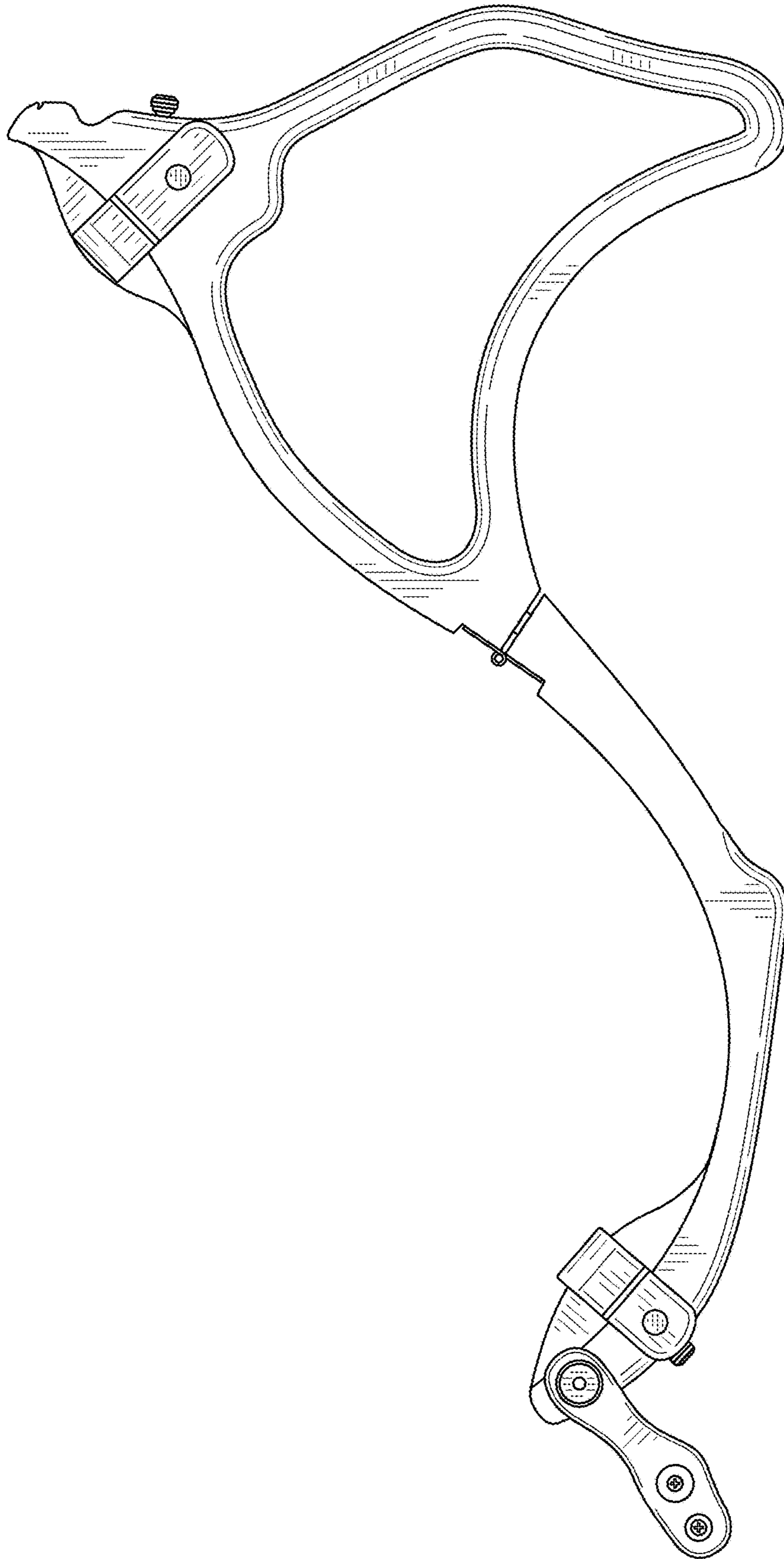

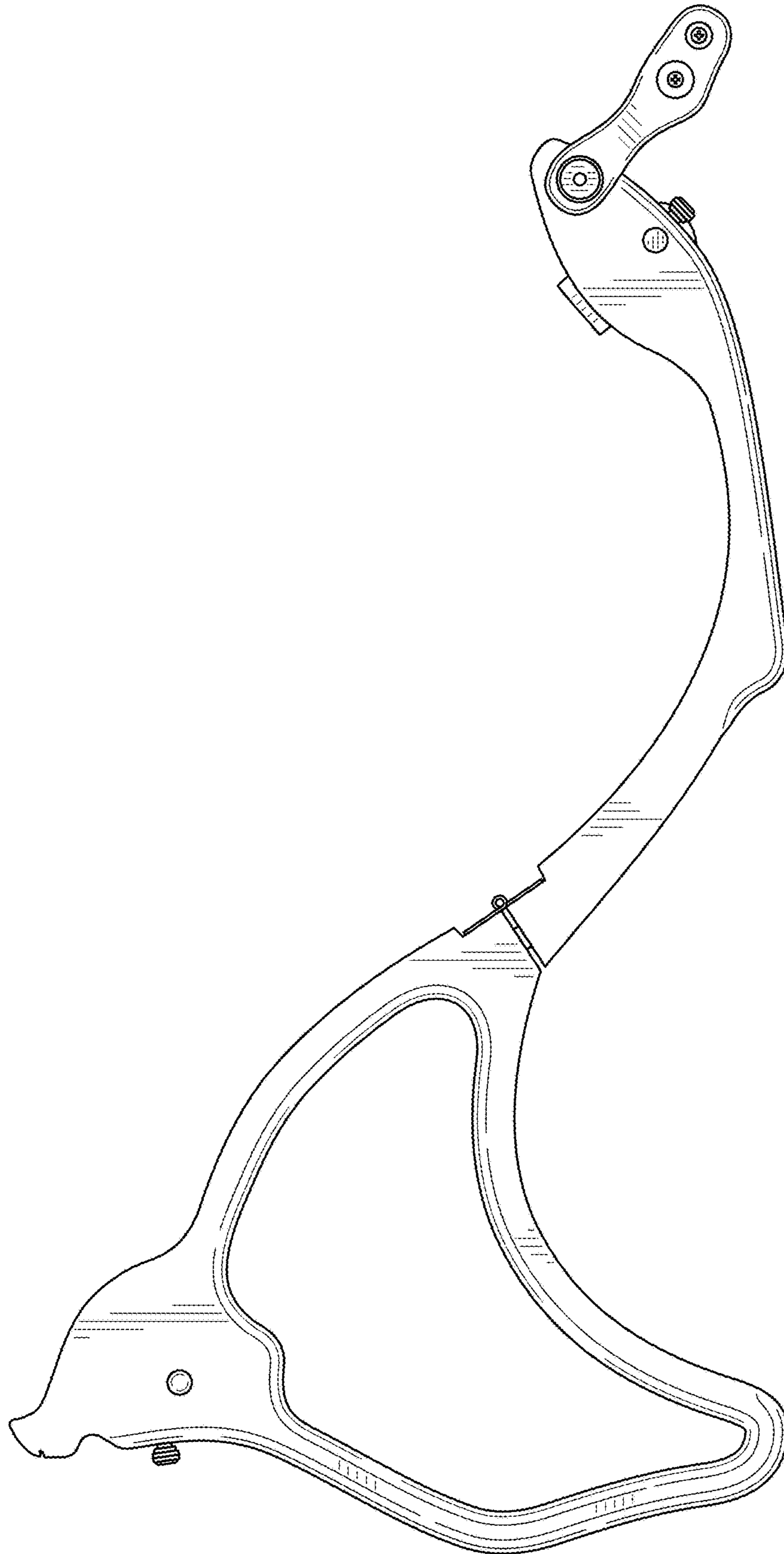

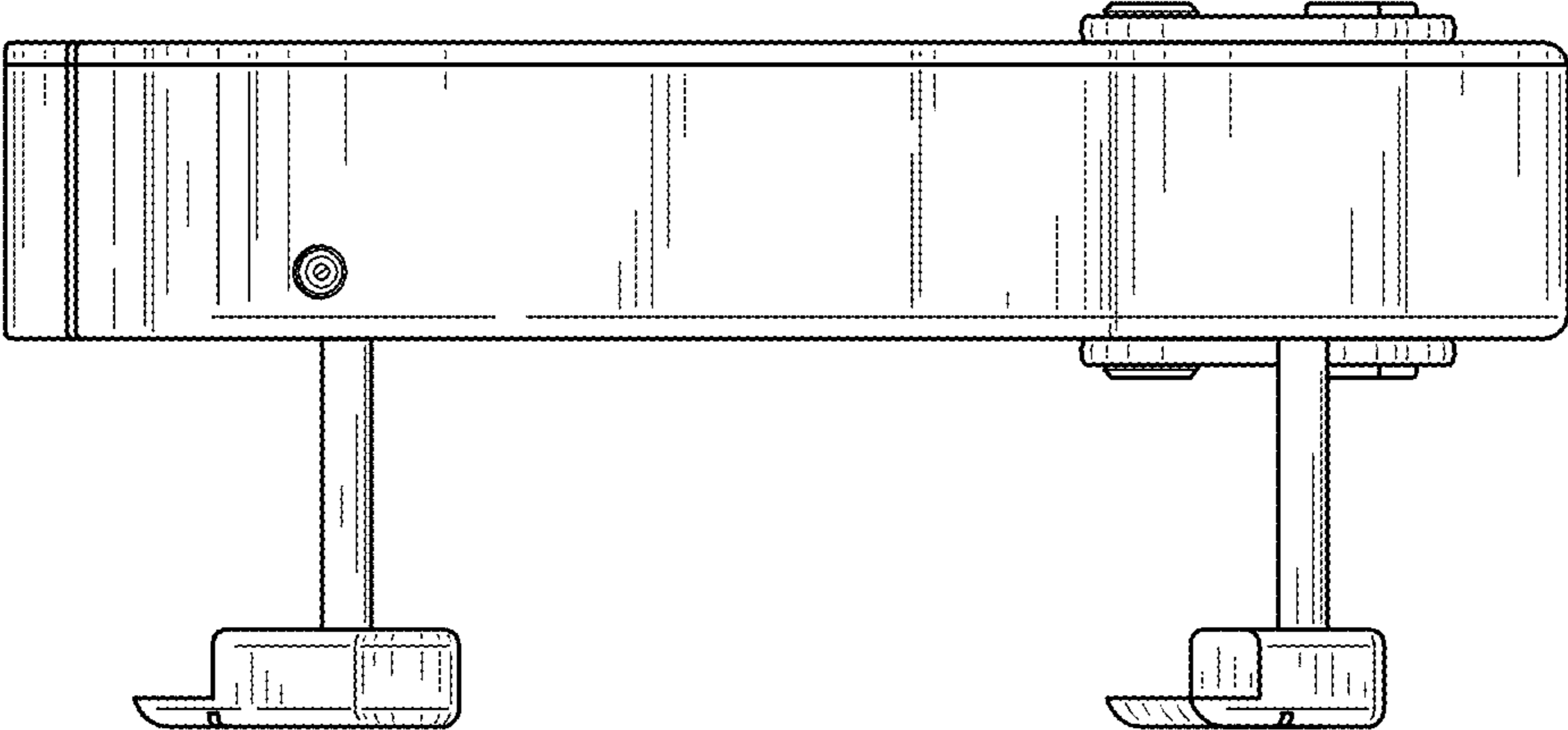

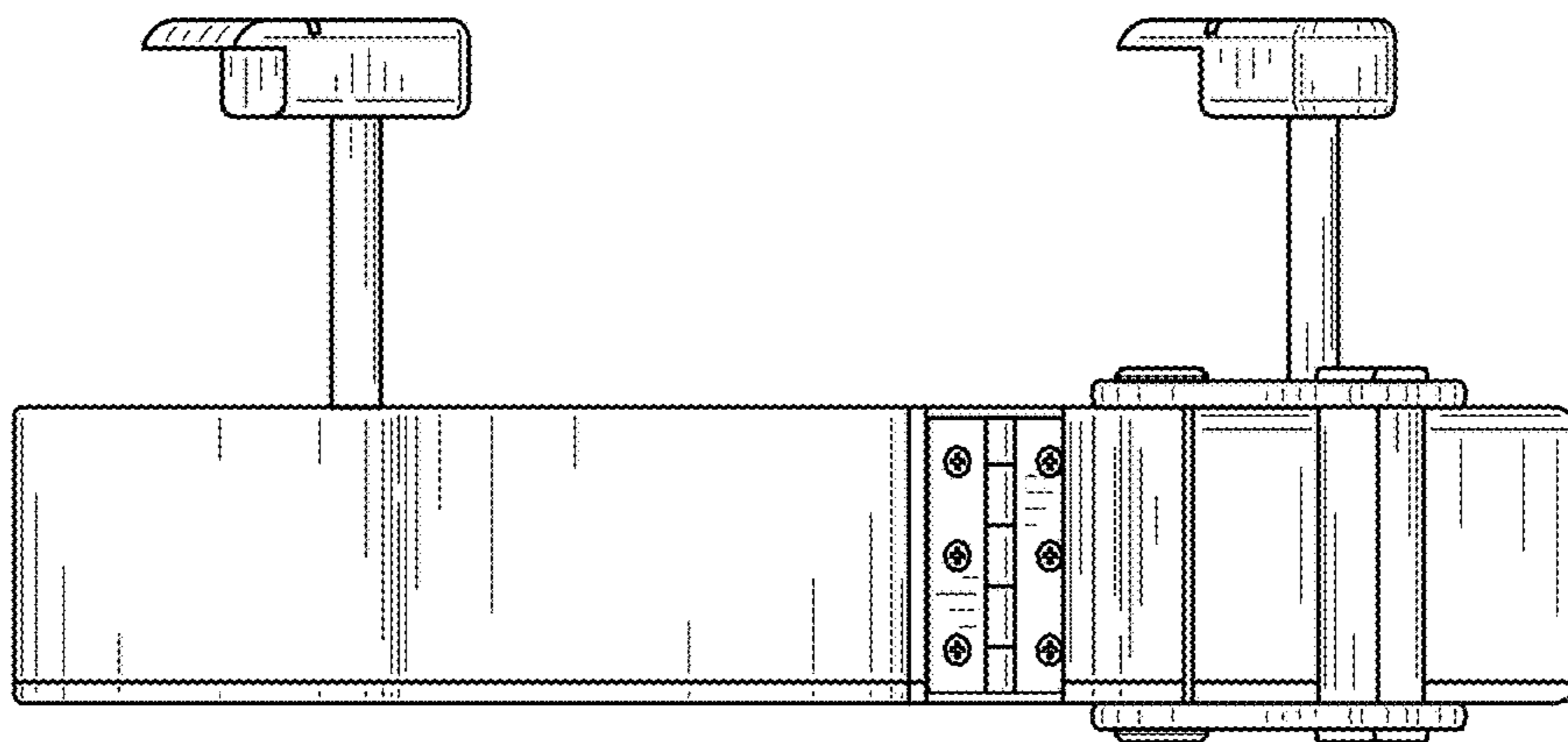

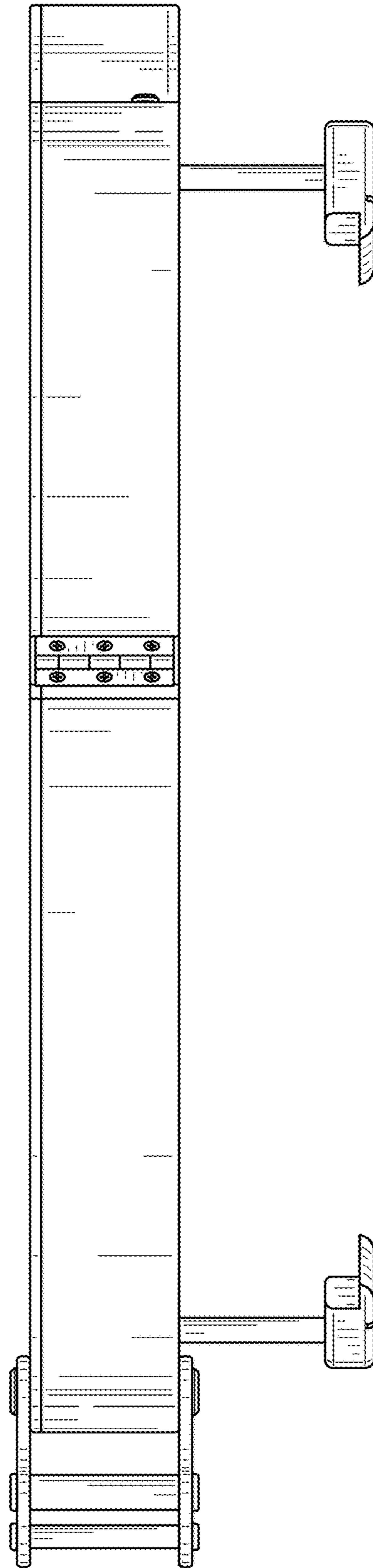

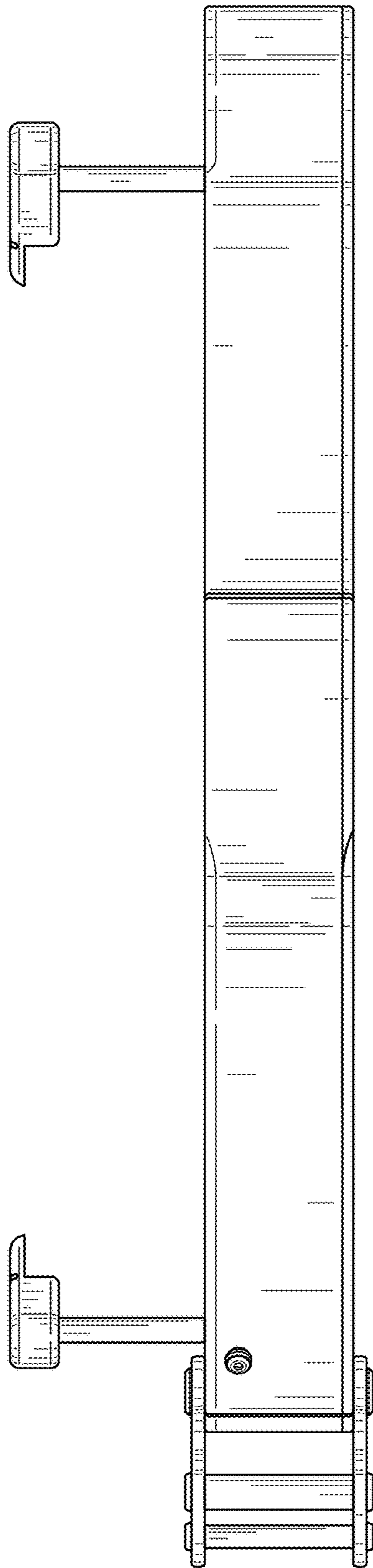
