(57) **CLAIM**

The ornamental design for a teddy bear, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of a teddy bear in accordance with my new design, shown in a first configuration;
FIG. 2 is a side elevational view thereof;
FIG. 3 is a rear elevational view thereof;
FIG. 4 is a perspective view of the teddy bear, shown in a second configuration;
FIG. 5 is a front elevational view of the teddy bear, shown in a third configuration; and,
FIG. 6 is a perspective view thereof.

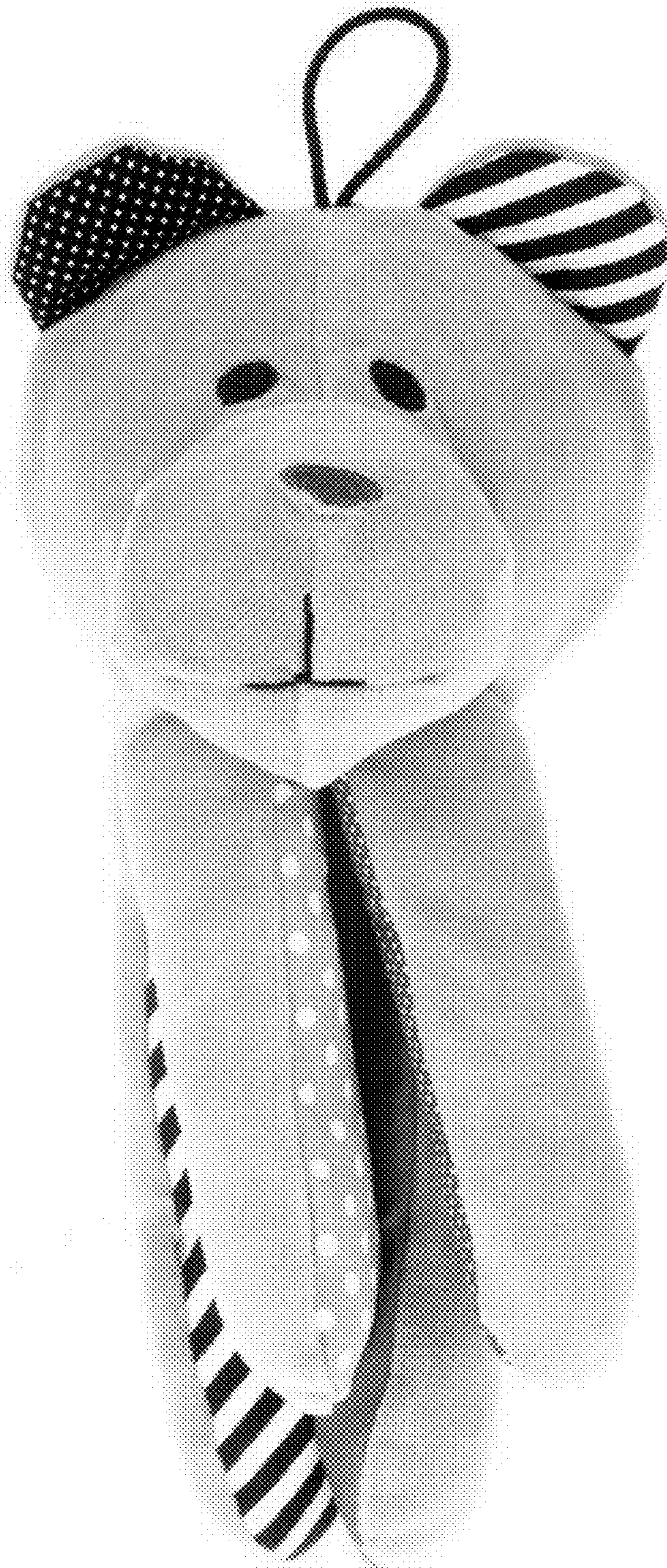
