**CLAIM**

(57) The ornamental design for a firearm bullet, as shown and described.

**DESCRIPTION**

FIG. 1 is a top perspective view of a firearm bullet of the present invention, wherein a pair of substantially horizontal, closely adjacent broken lines is included for indicating that no particular length is being claimed;  
FIG. 2 is a bottom perspective view of the bullet of FIG. 1;  
FIG. 3 is a front elevation view of the bullet of FIG. 1;  
FIG. 4 is a top plan view of the bullet of FIG. 1;  
FIG. 5 is a bottom plan view of the bullet of FIG. 1;  
FIG. 6 is a top perspective view of a firearm bullet, FIGS. 6-10 are respectively like FIGS. 1-5 except that shading is not shown, and the diagonal hatching designates a color and the horizontal hatching designates a color that is different from the color designated by the diagonal hatching;  
FIG. 7 is a bottom perspective view of the bullet of FIG. 6;  
FIG. 8 is a front elevation view of the bullet of FIG. 6;  
FIG. 9 is a top plan view of the bullet of FIG. 6; and  
FIG. 10 is a bottom plan view of the bullet of FIG. 6.

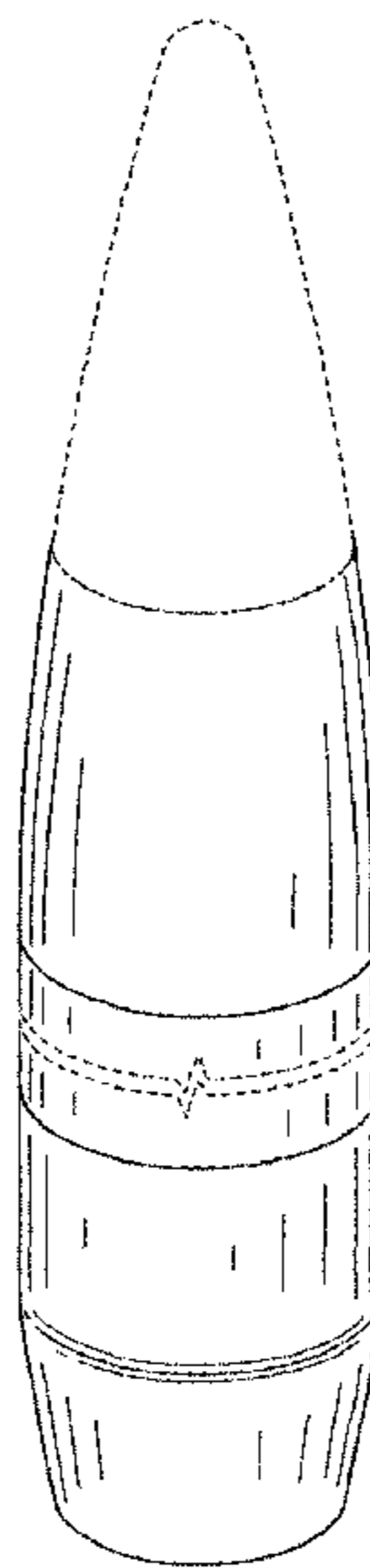

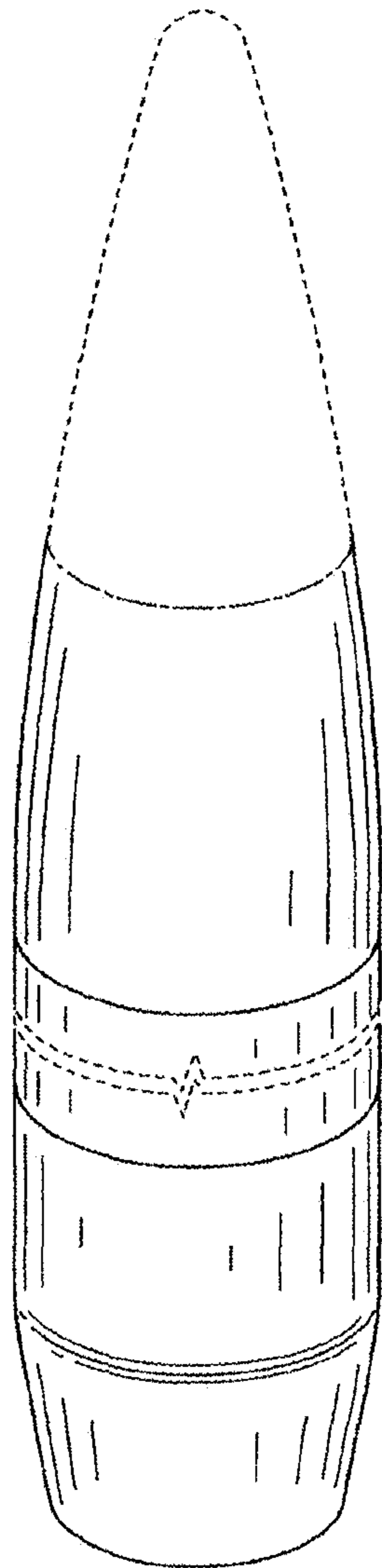

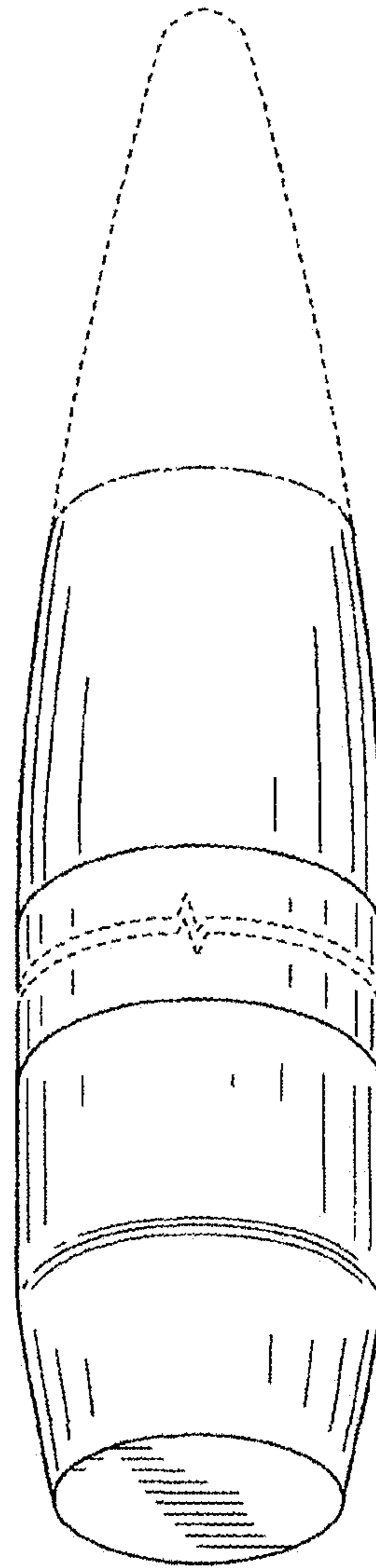

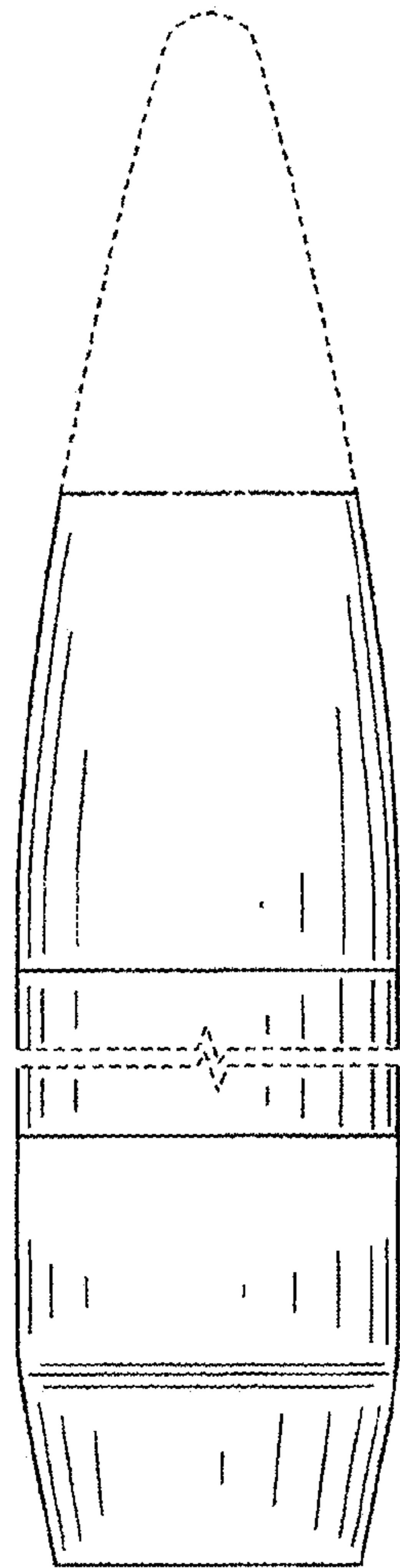

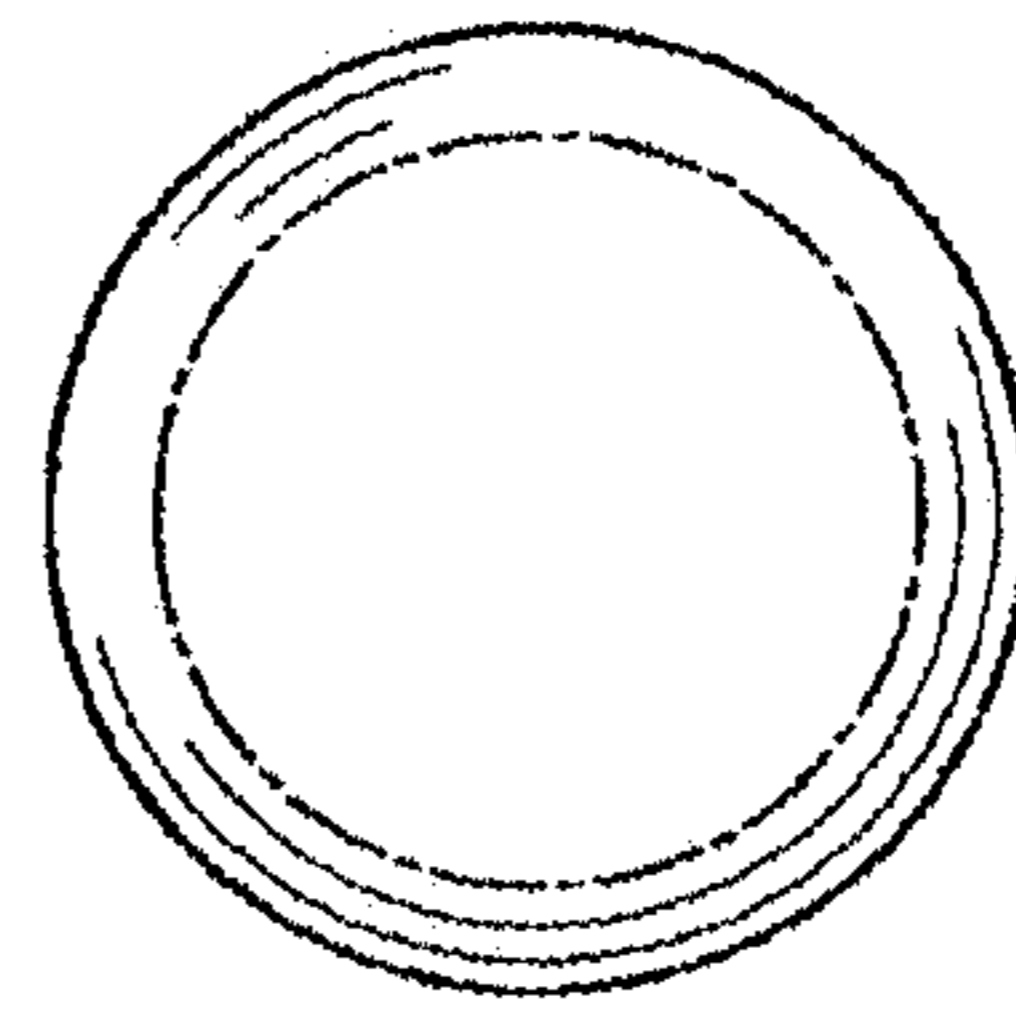

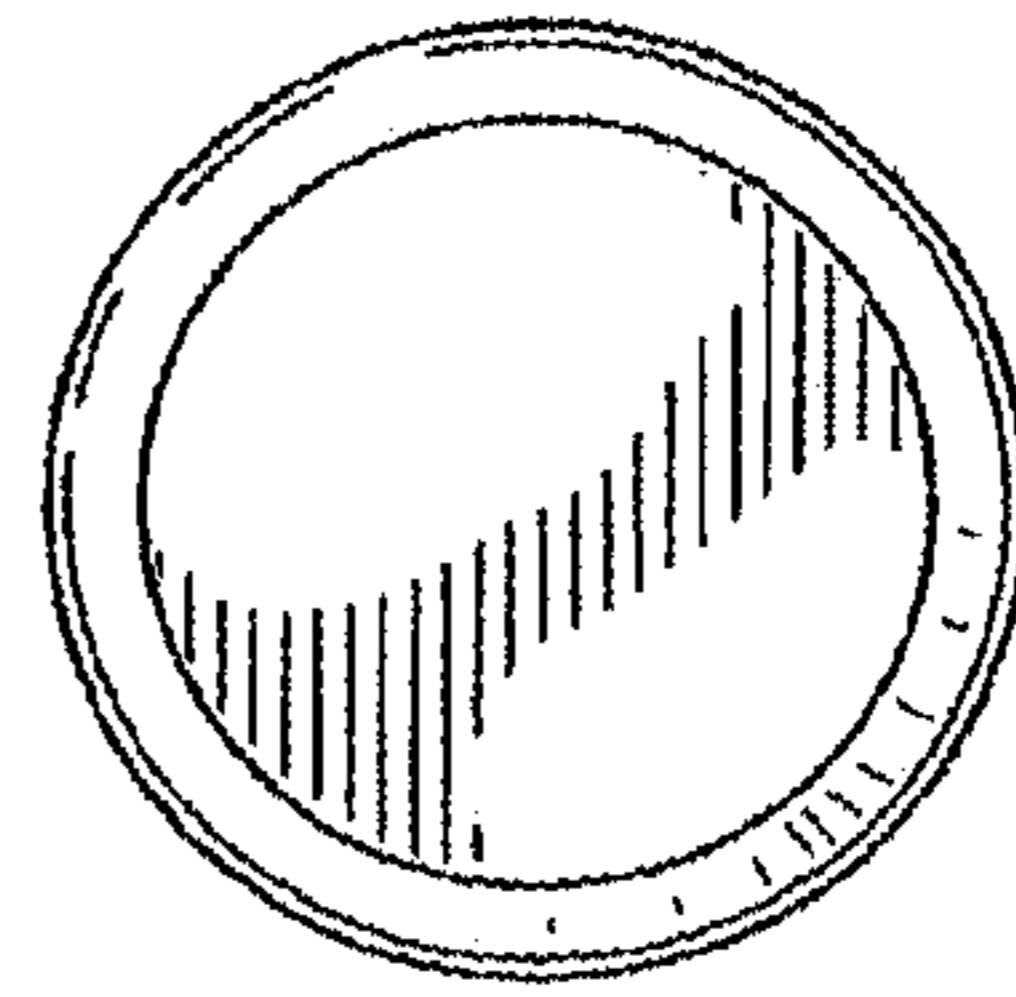

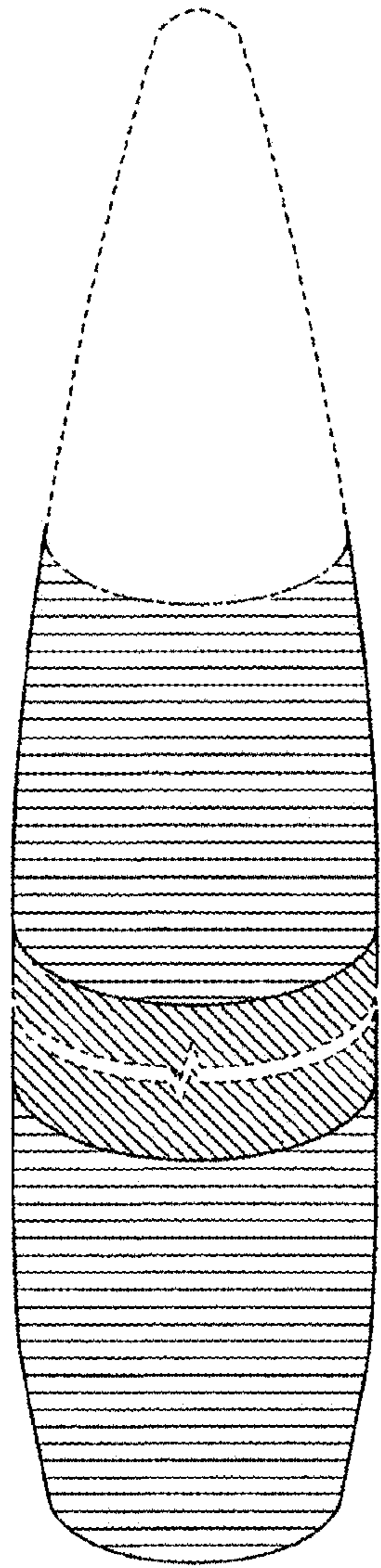

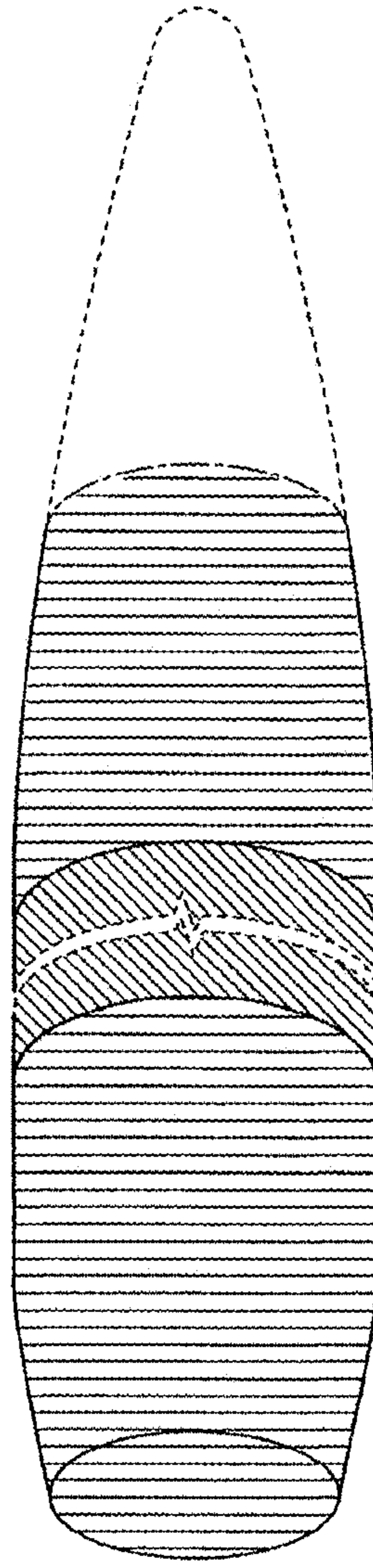

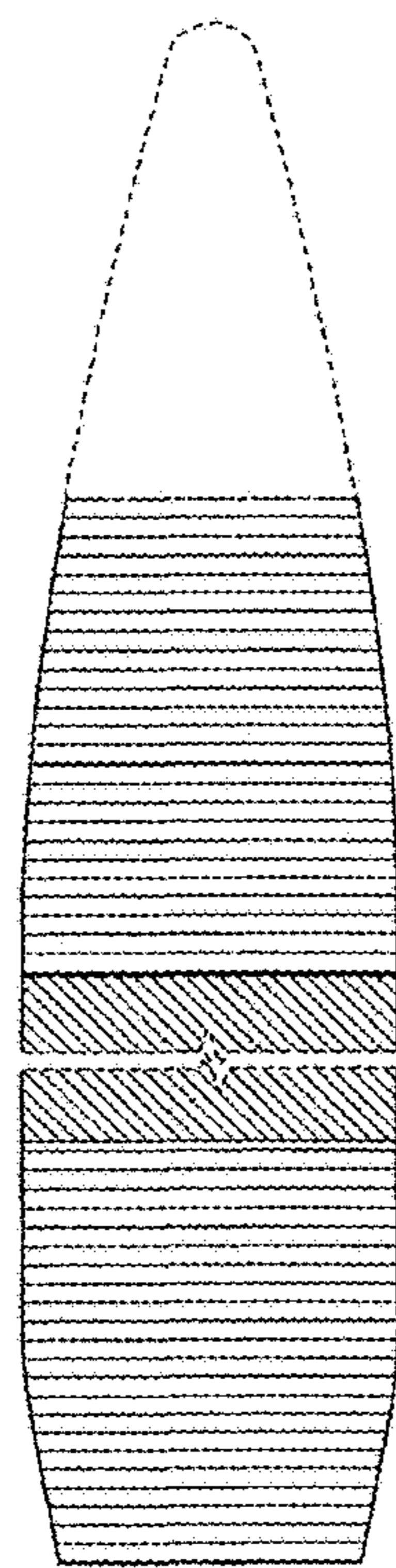

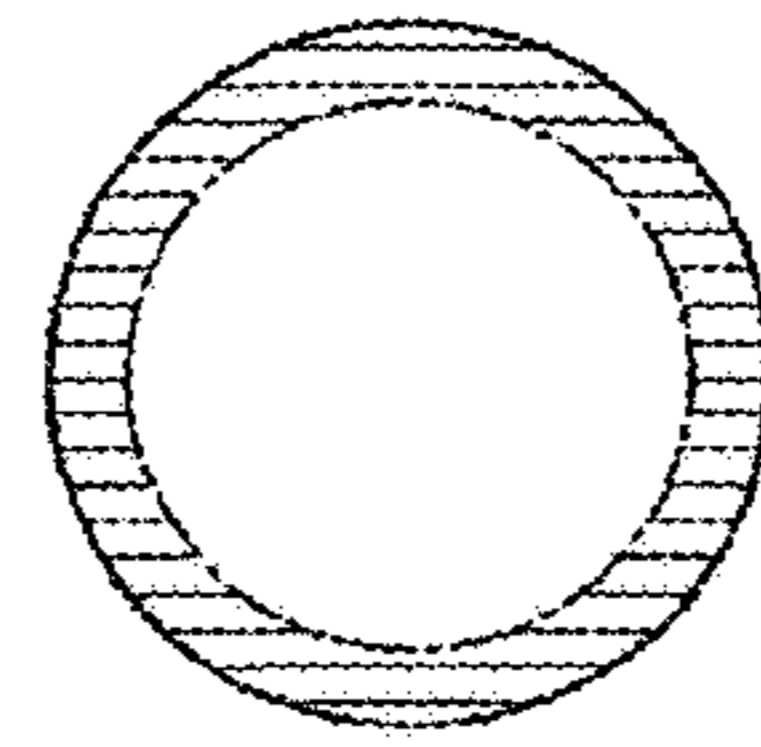

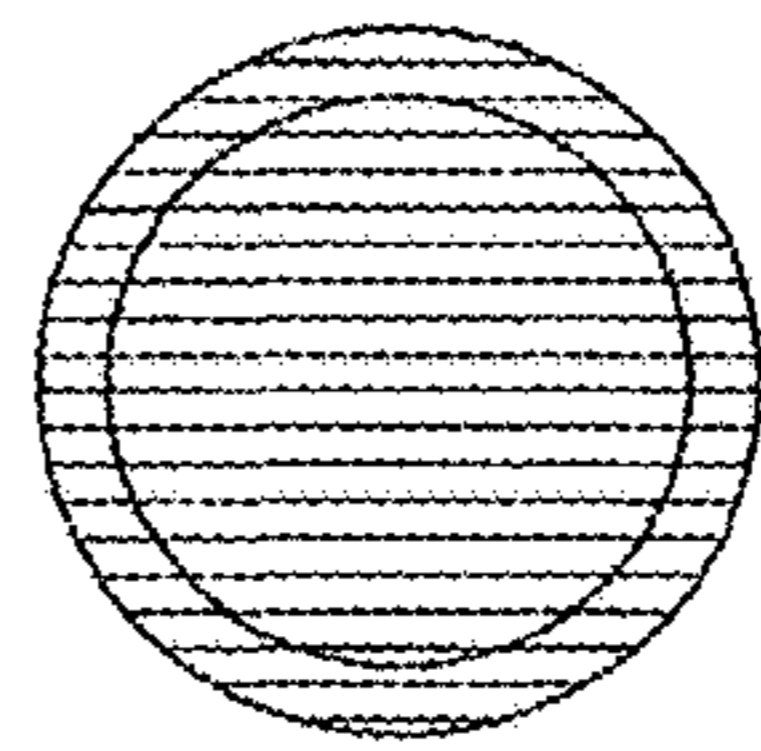
