DESCRIPTION

FIG. 1 is a perspective view of the air purifier in a first embodiment;

FIG. 18 is a left side elevation view of the invention illustrated in FIG. 15;

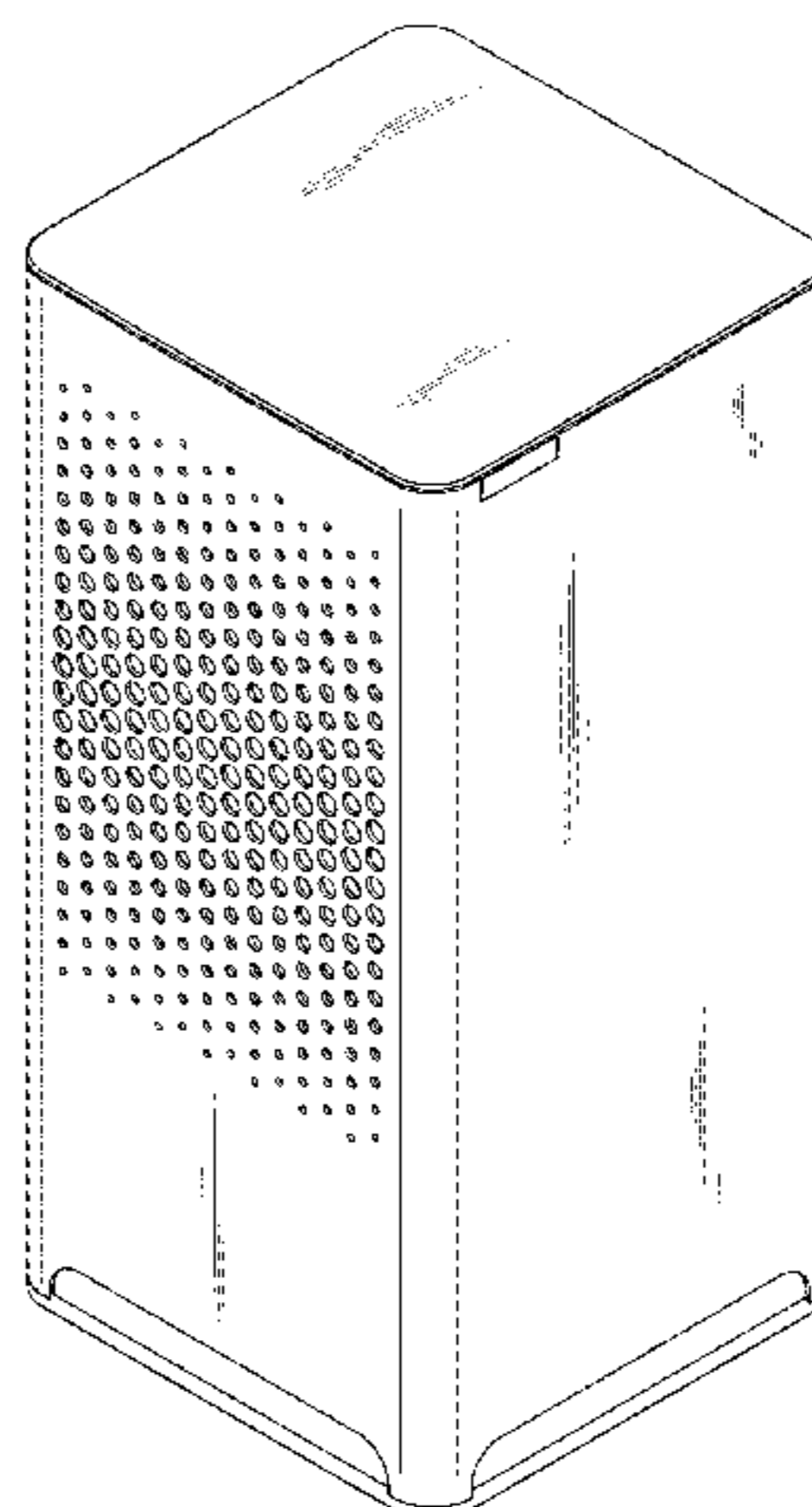
FIG. 19 is a bottom plan view of the invention illustrated in FIG. 15;

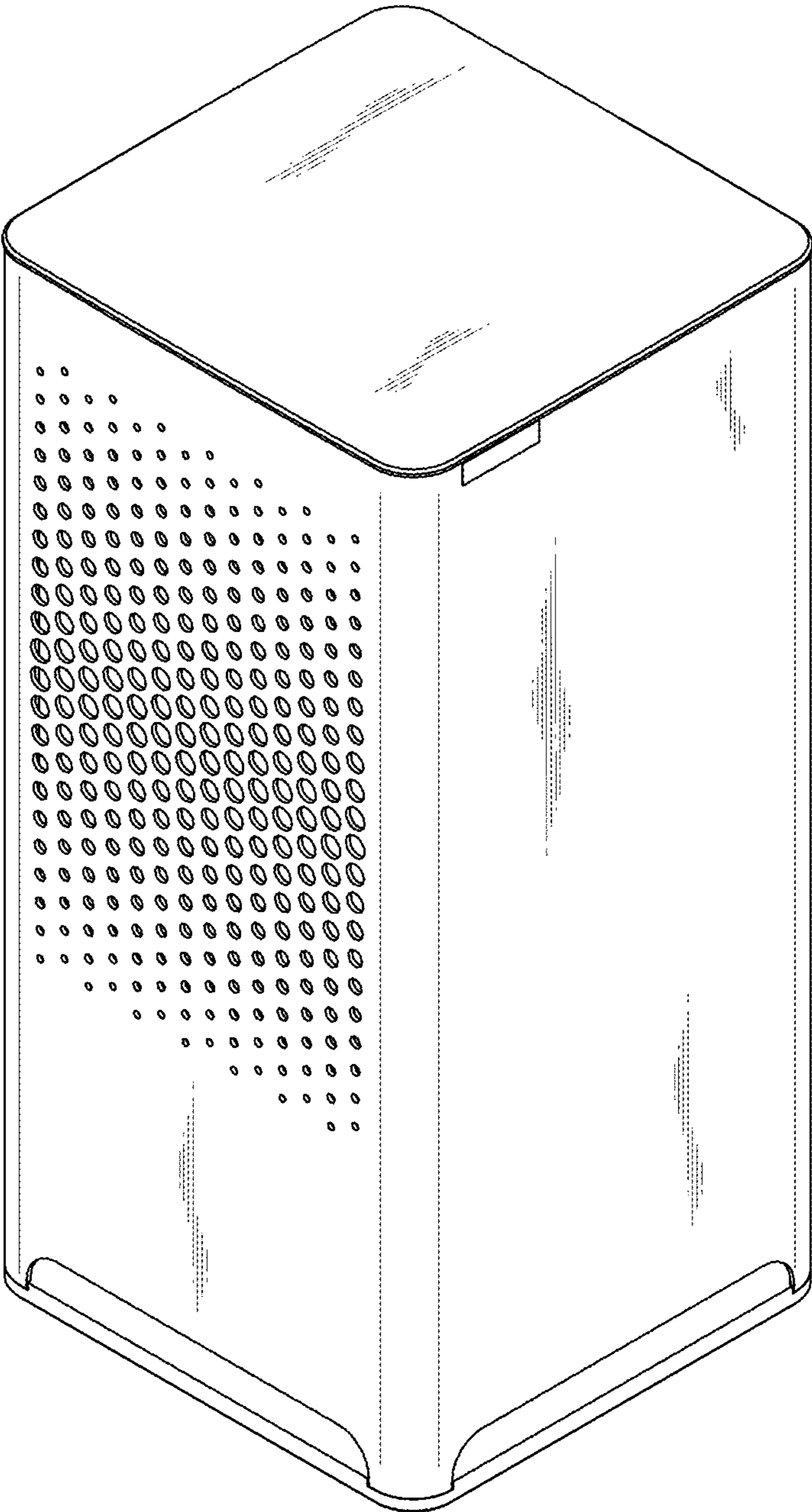

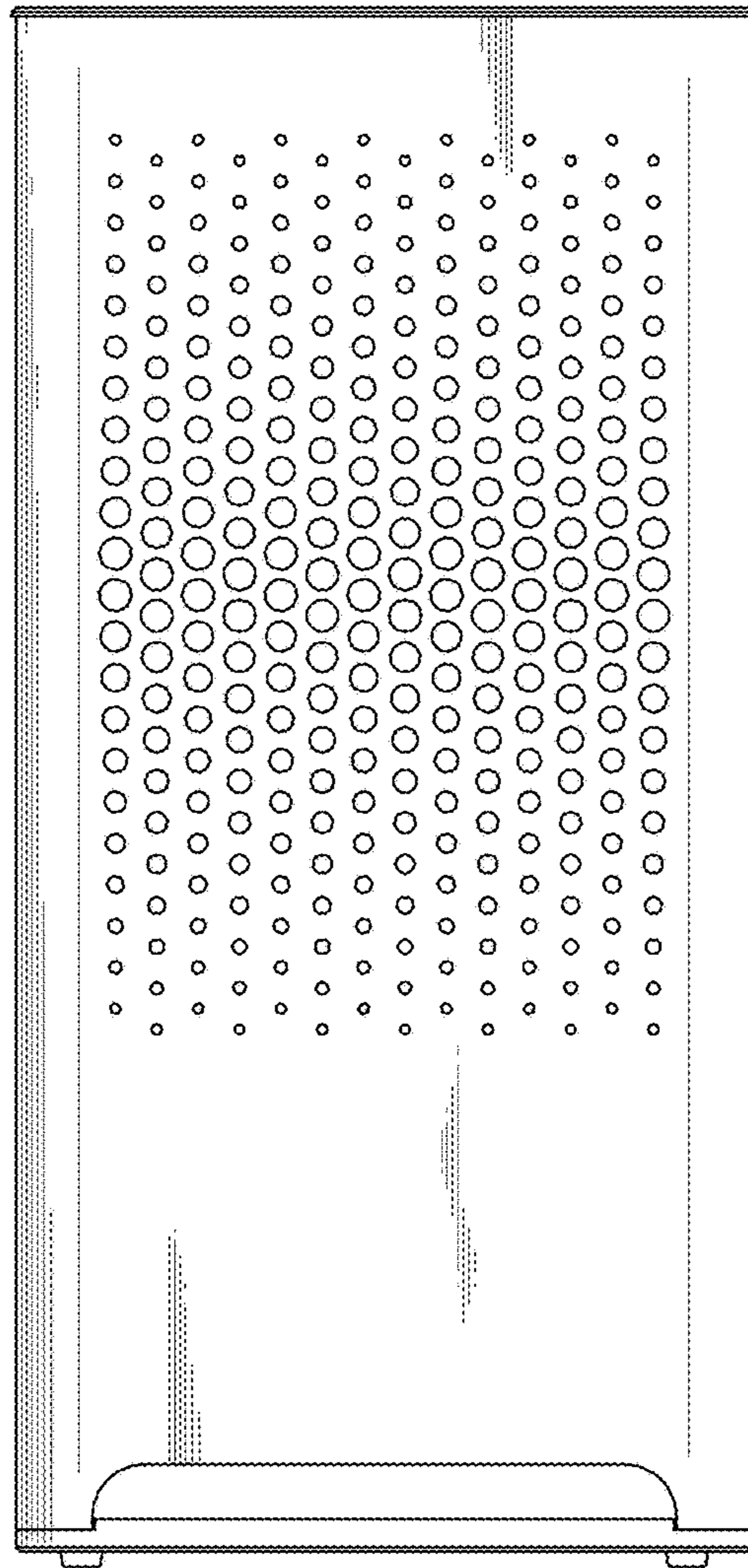

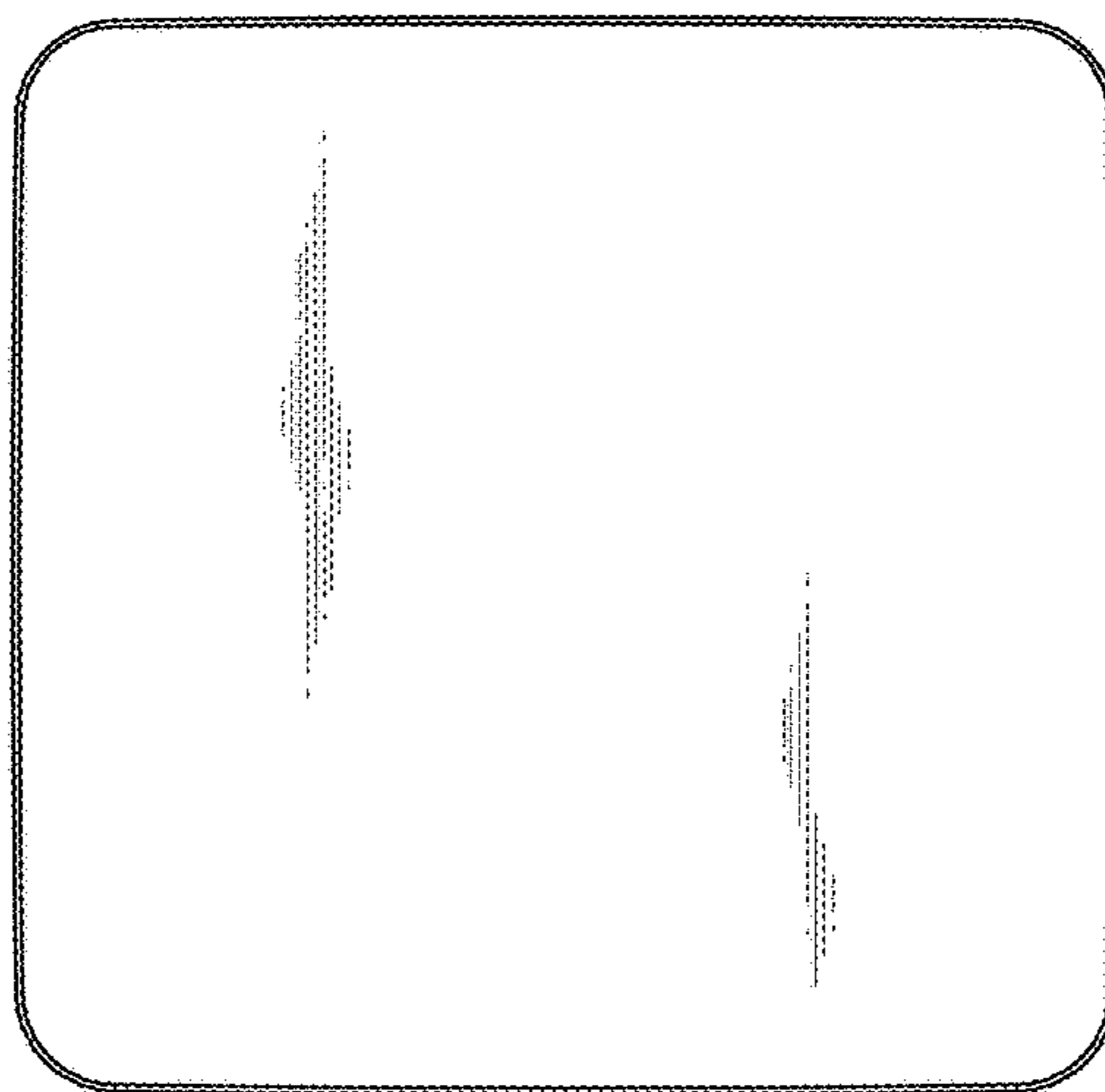

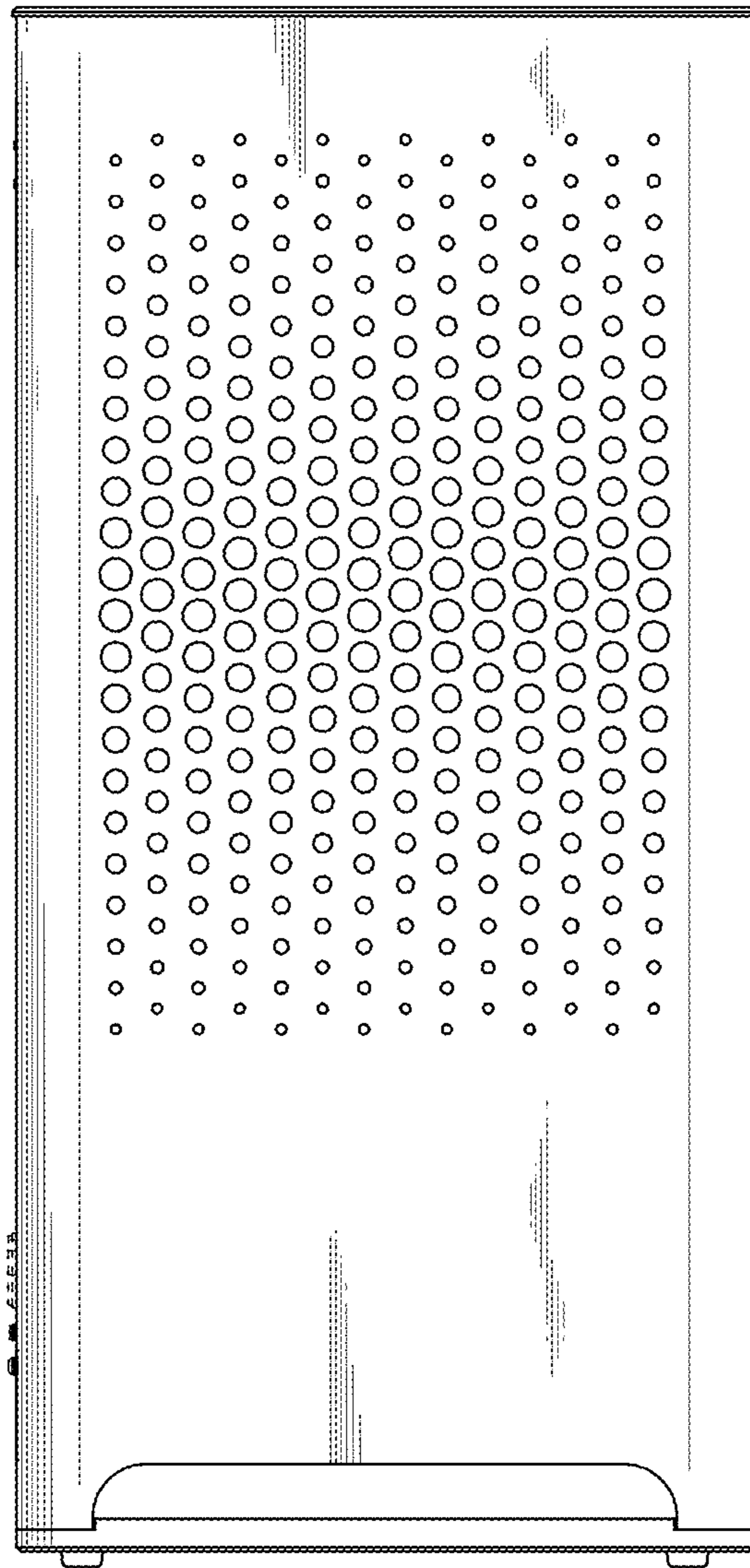

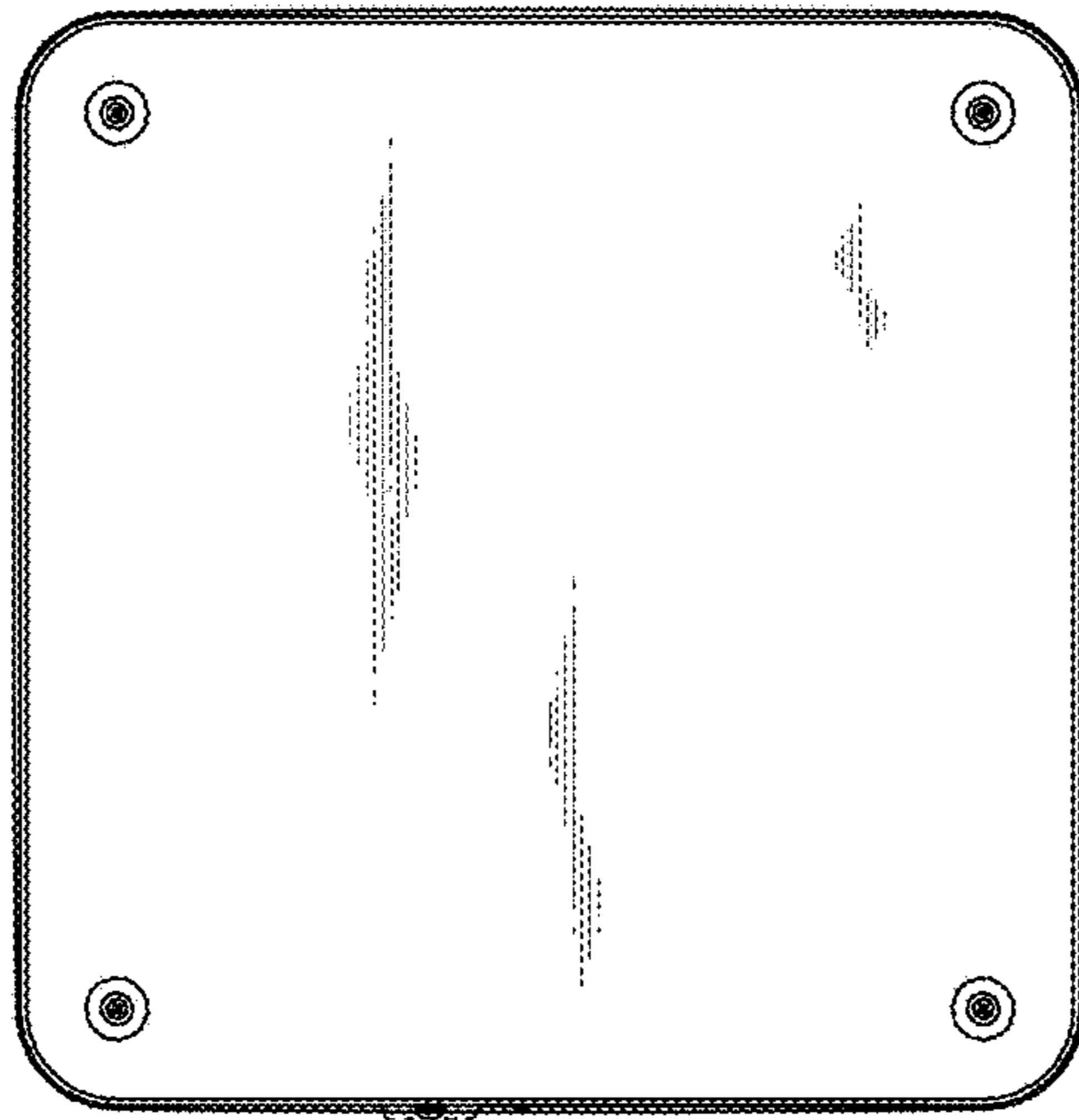

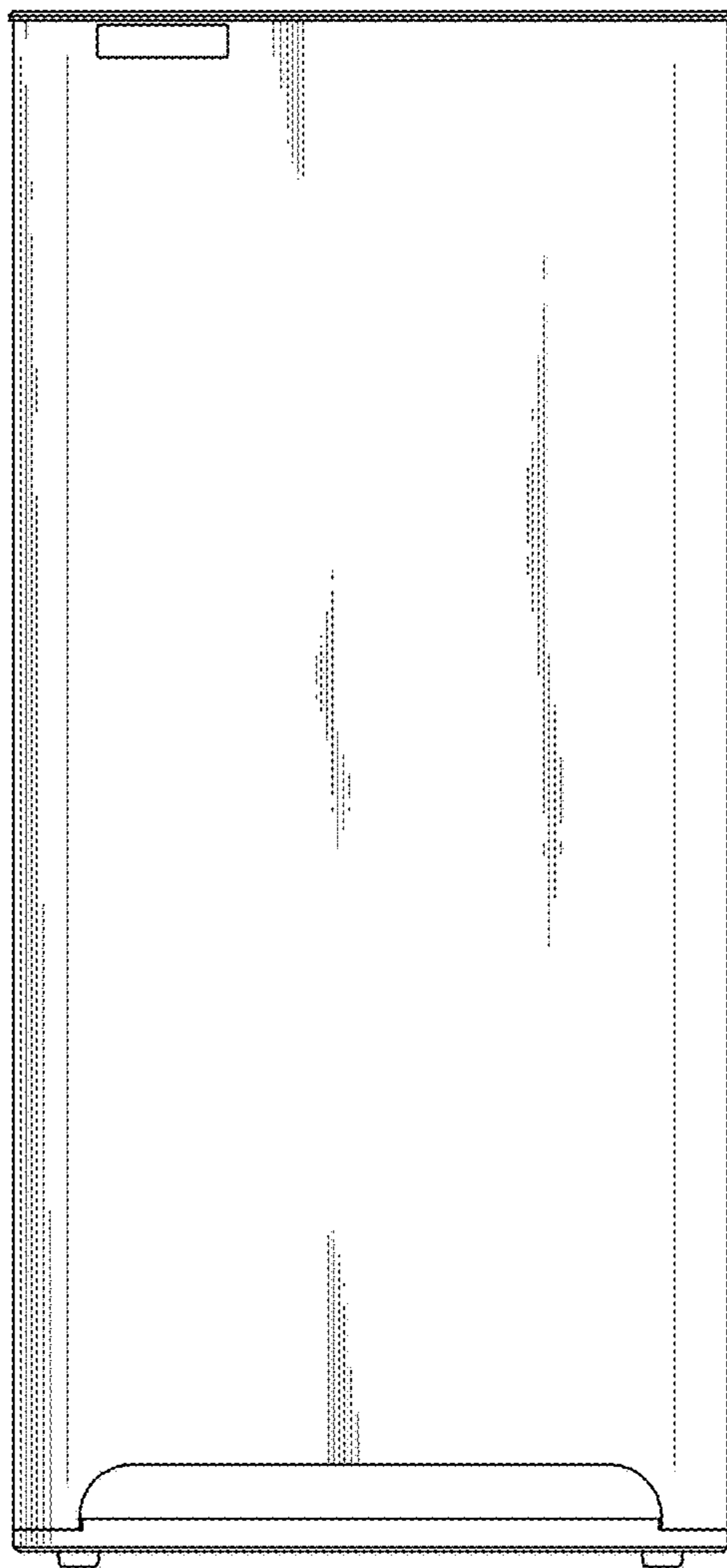

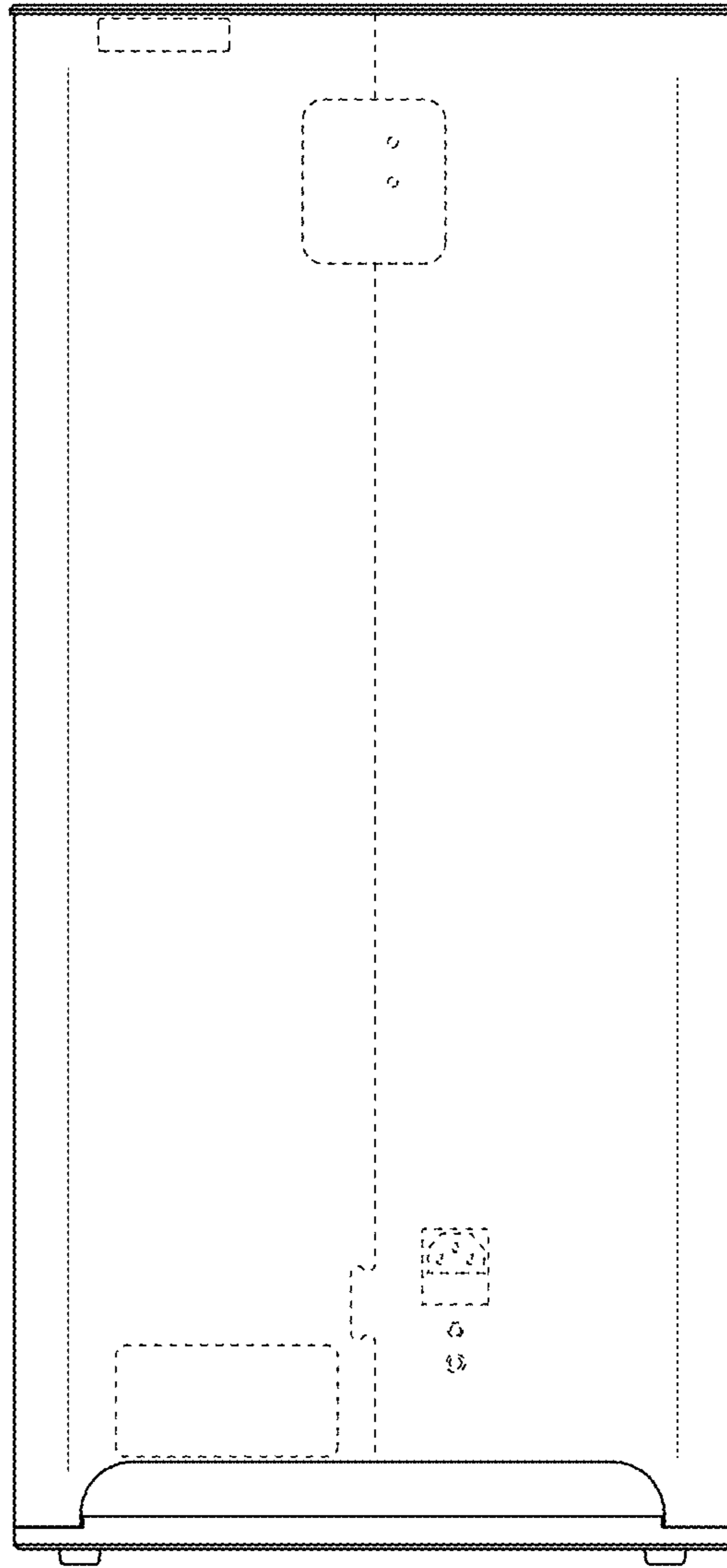

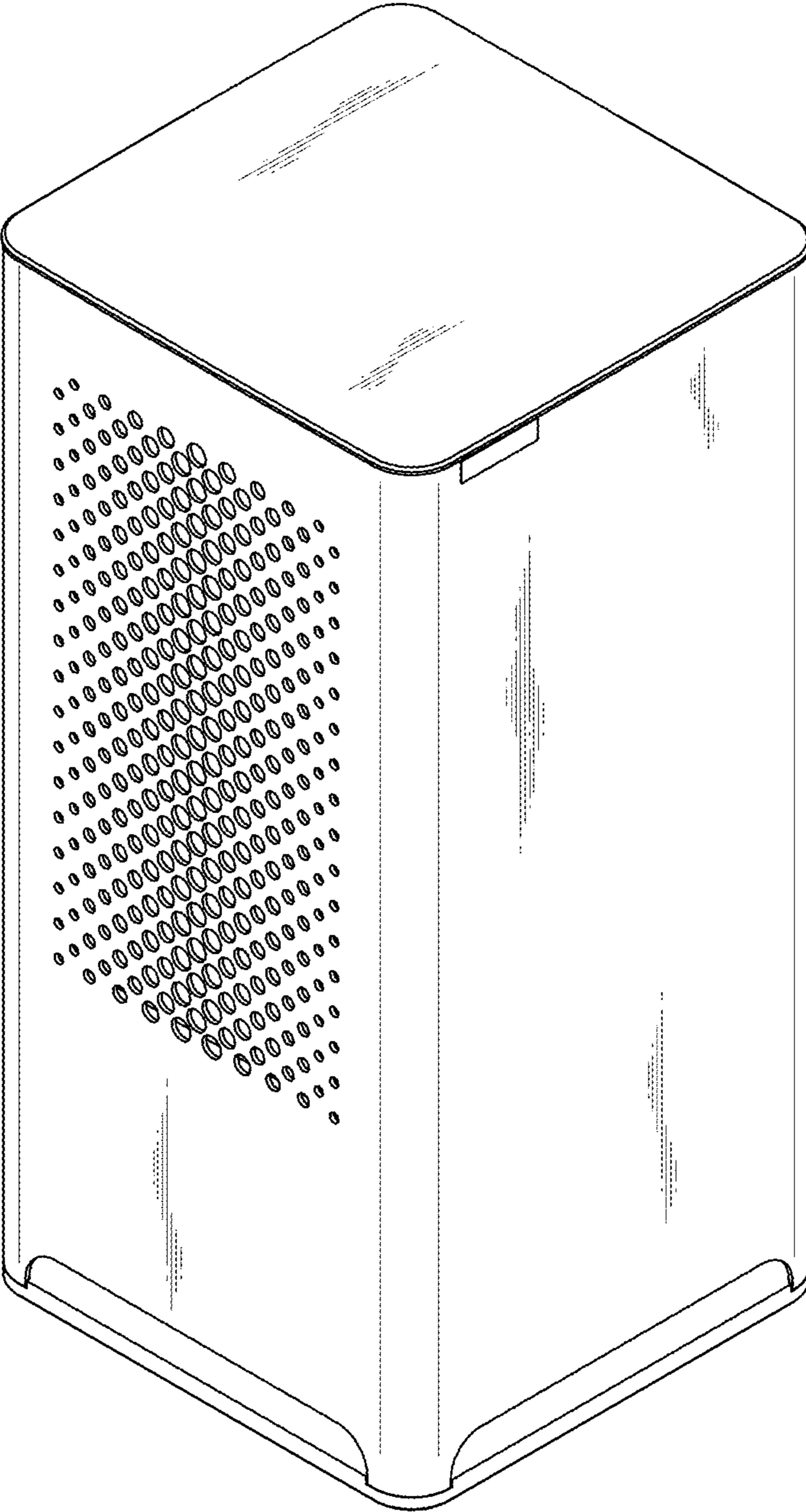

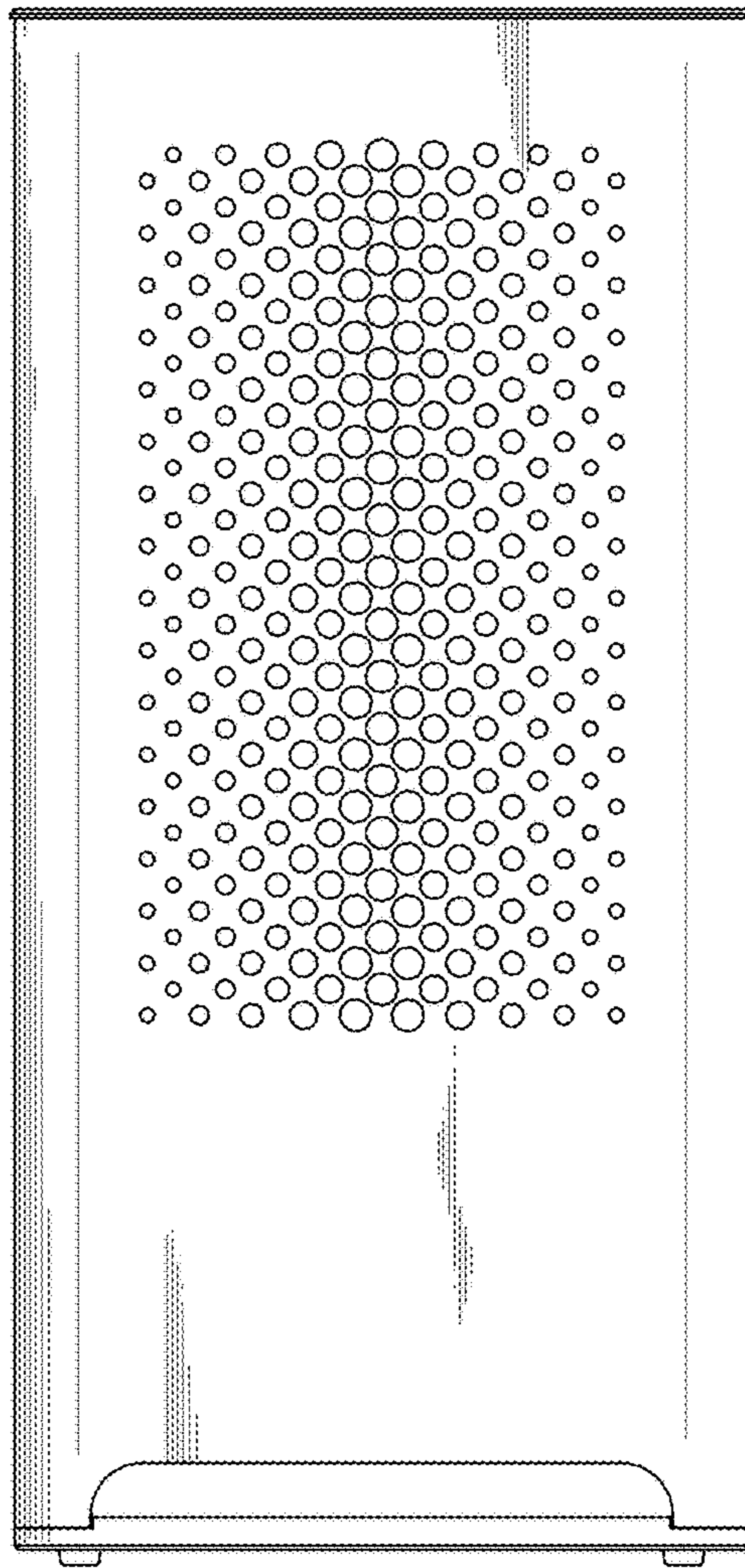

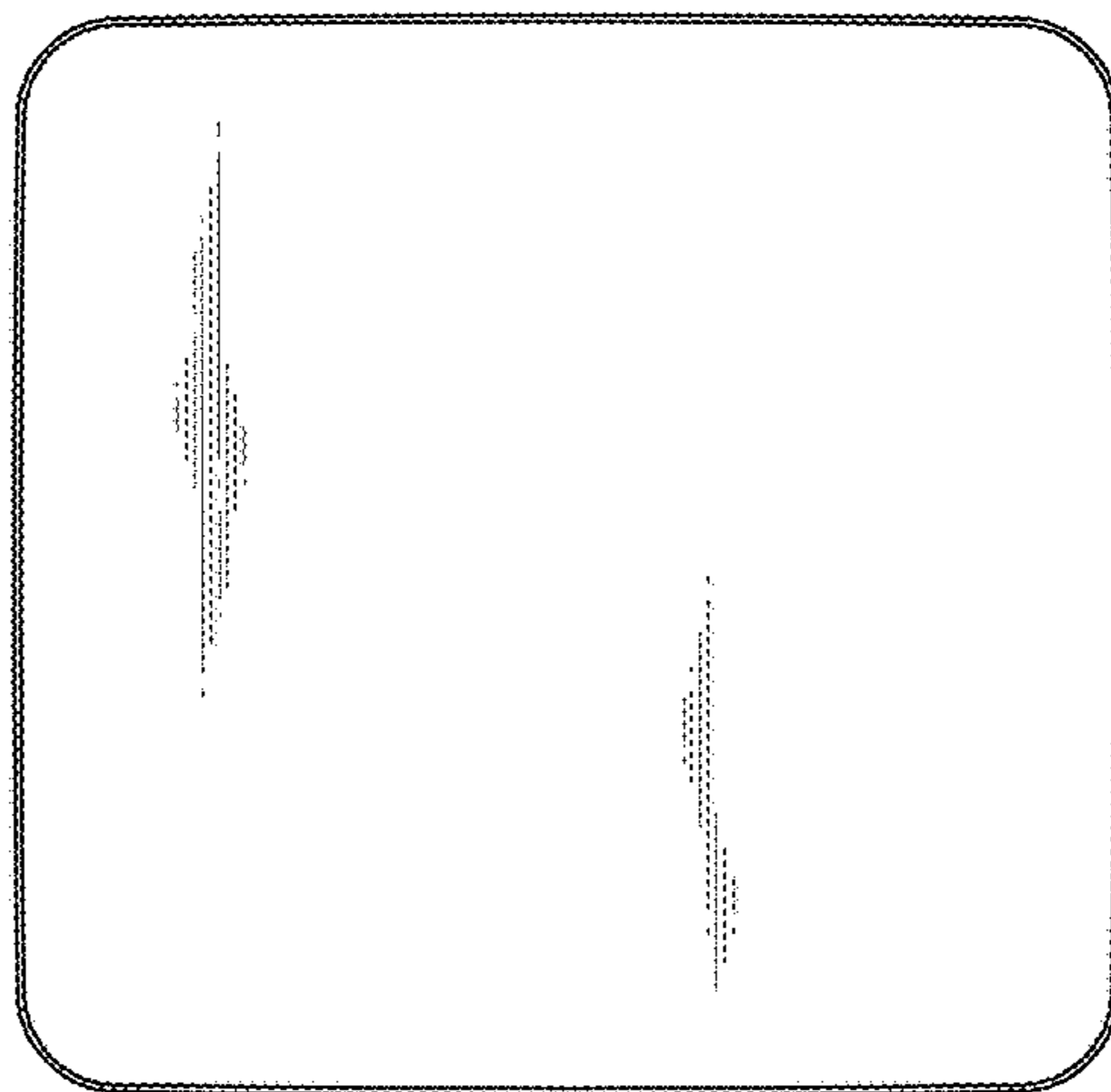

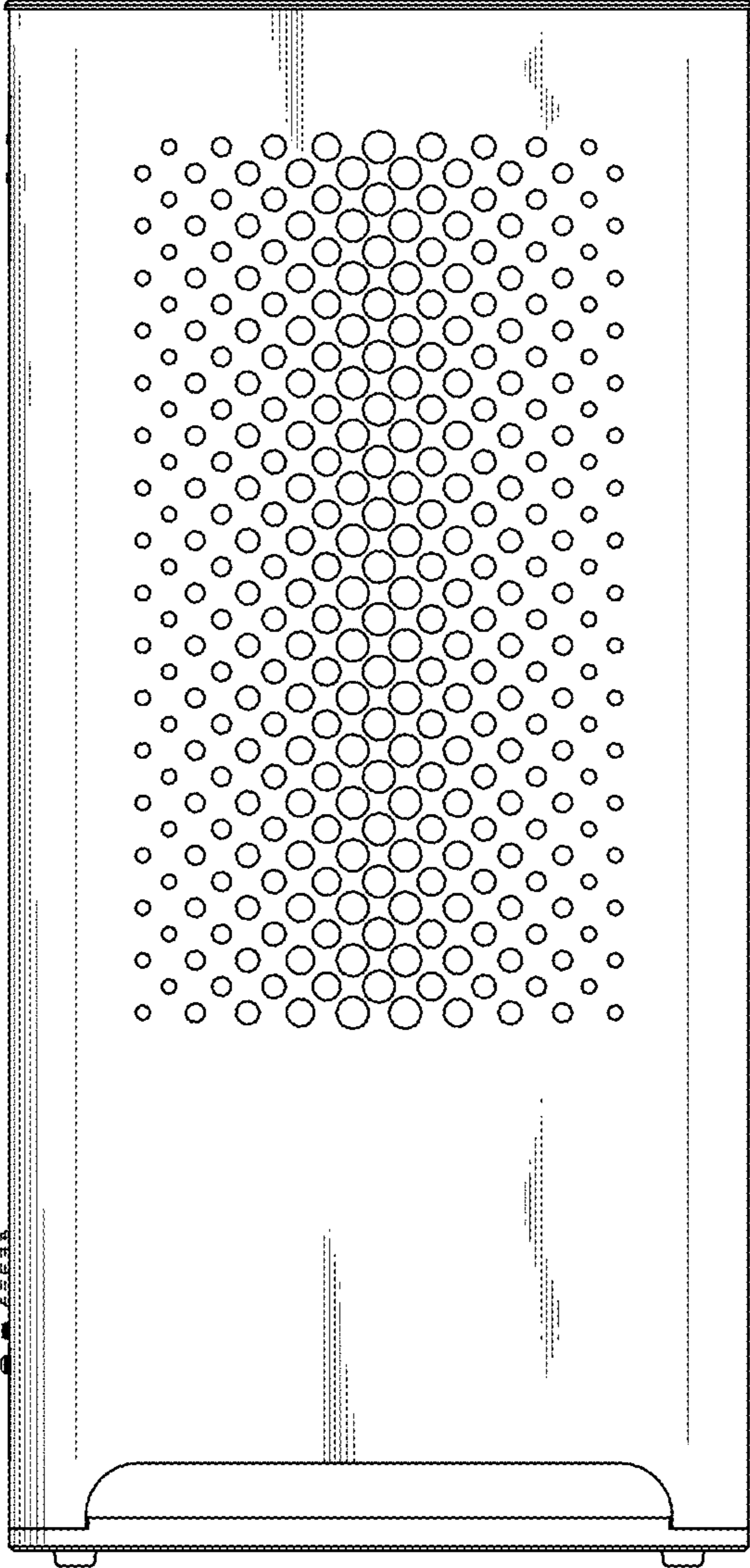

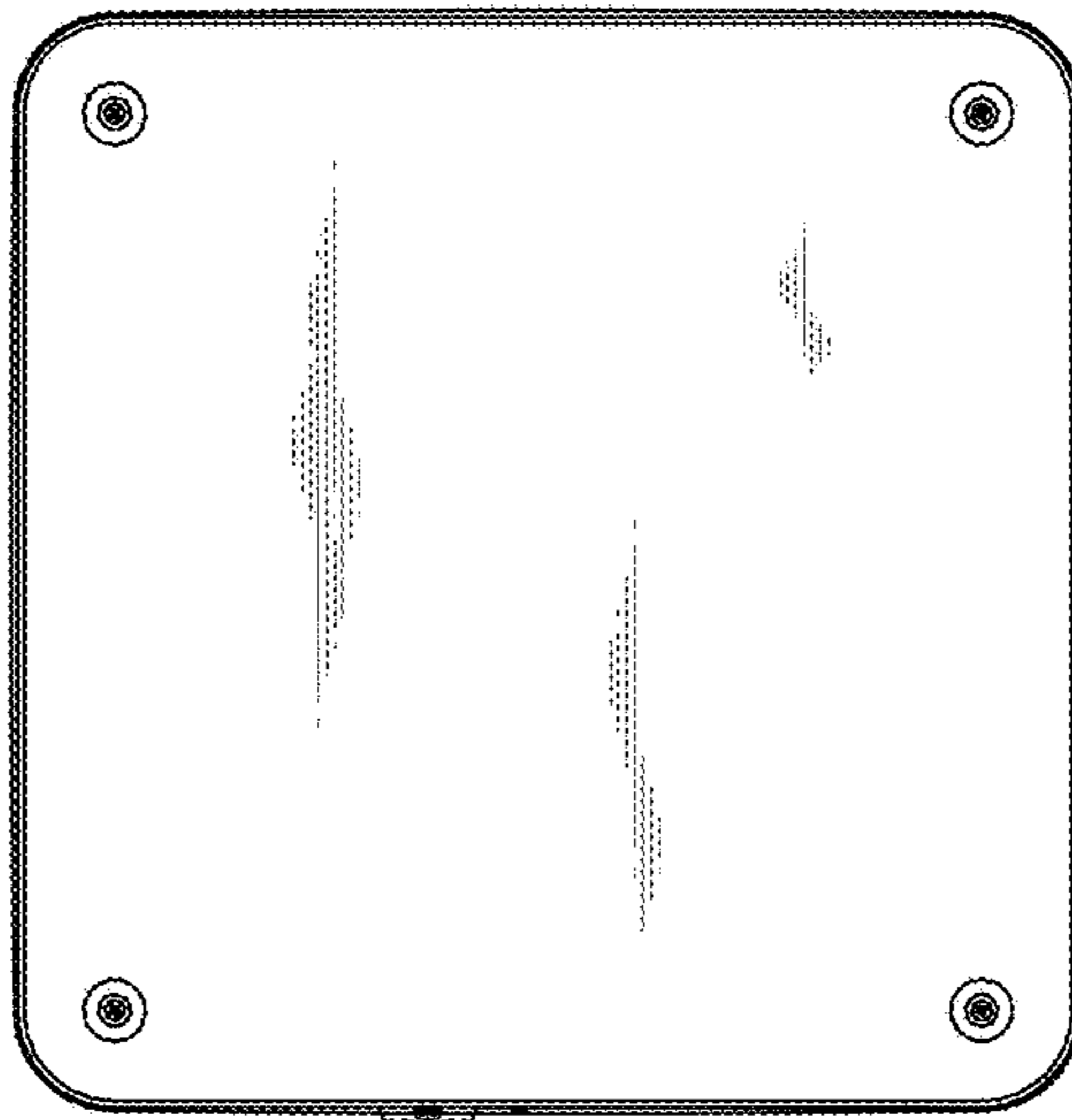

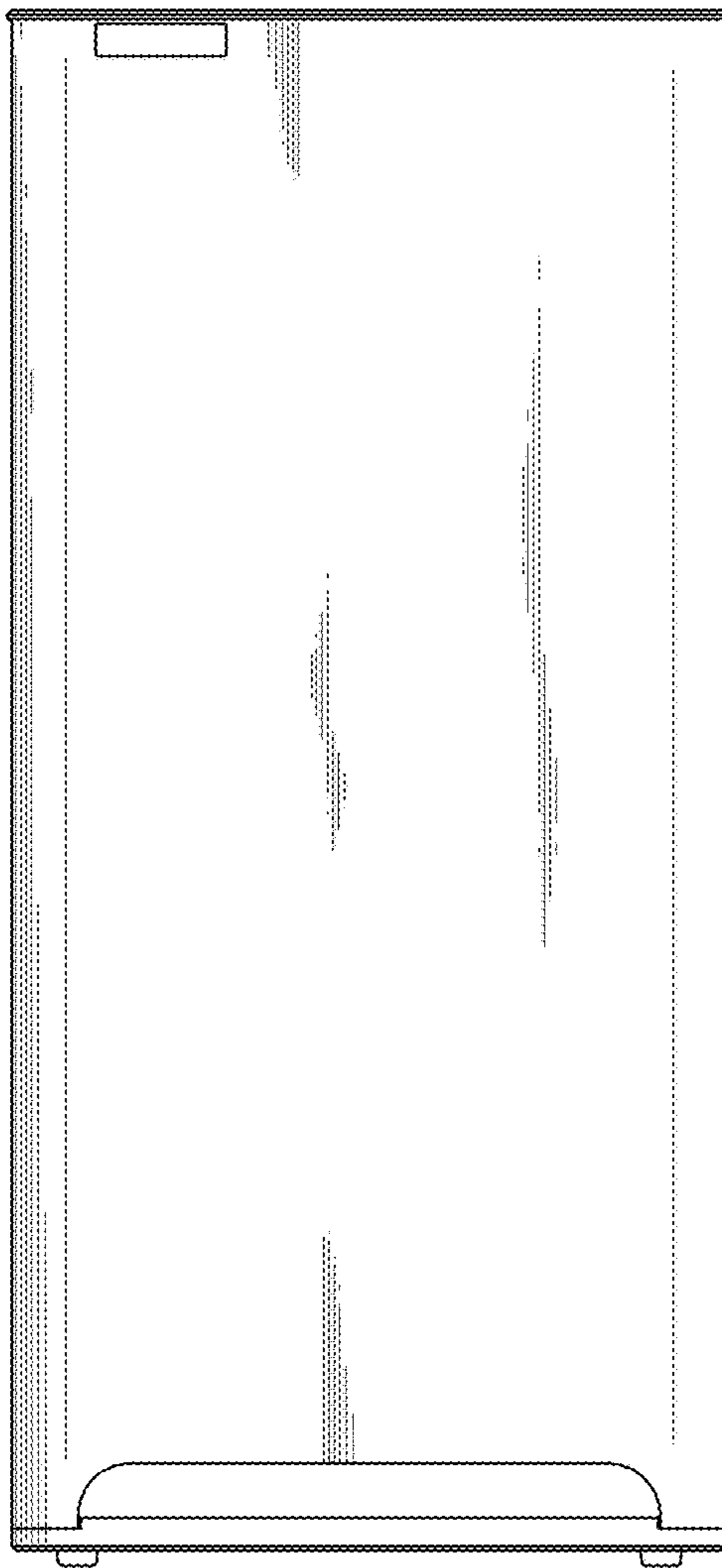

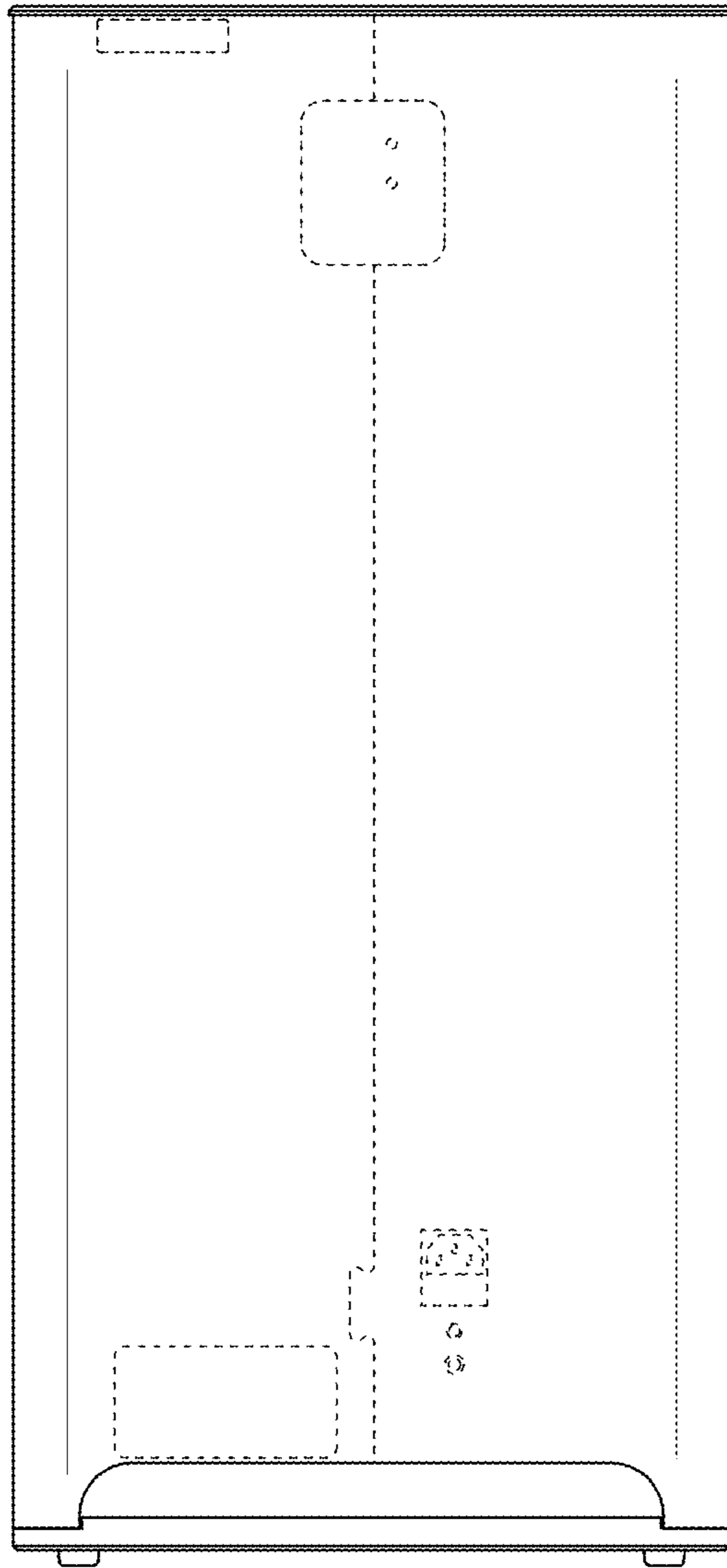

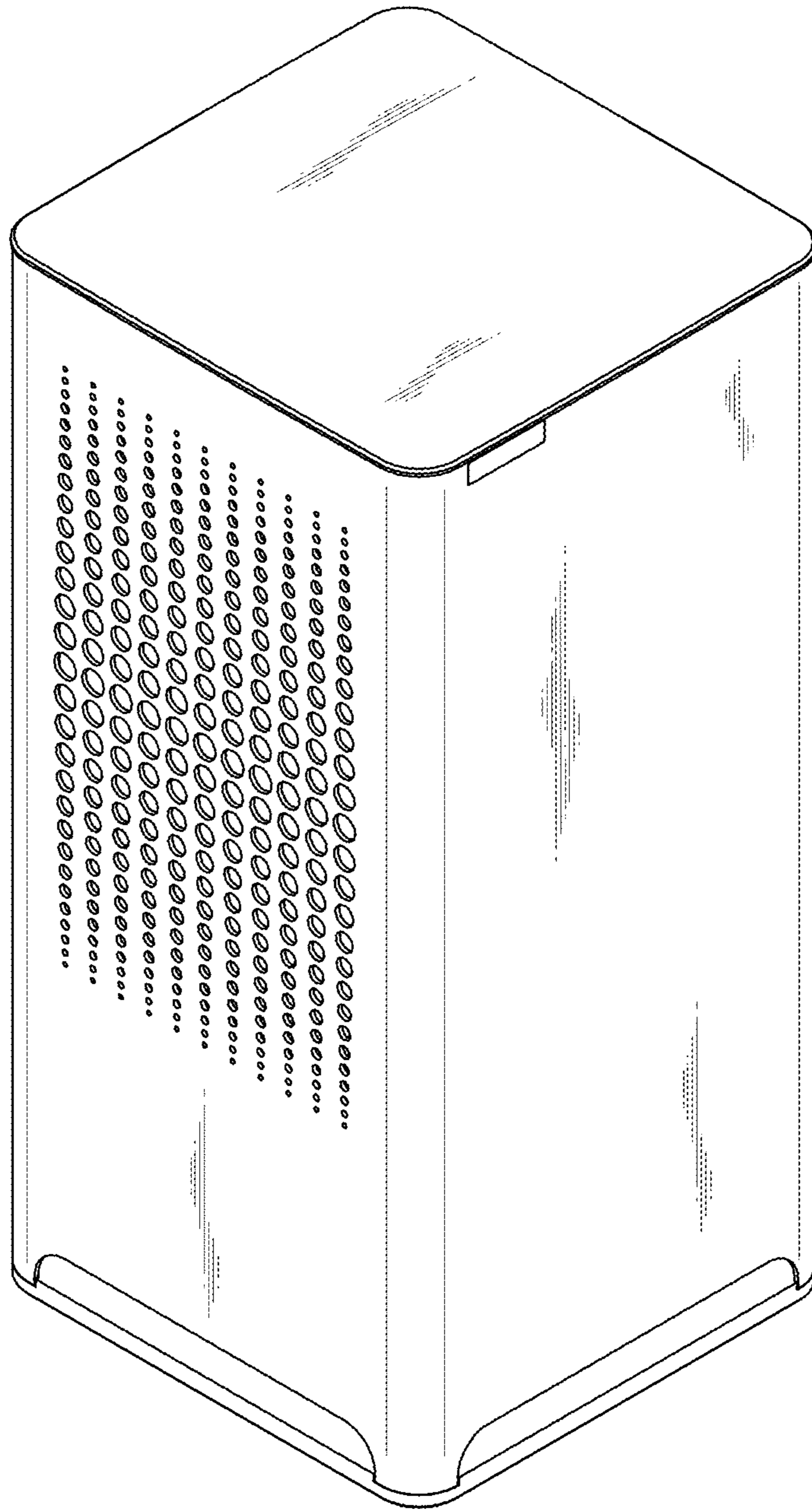

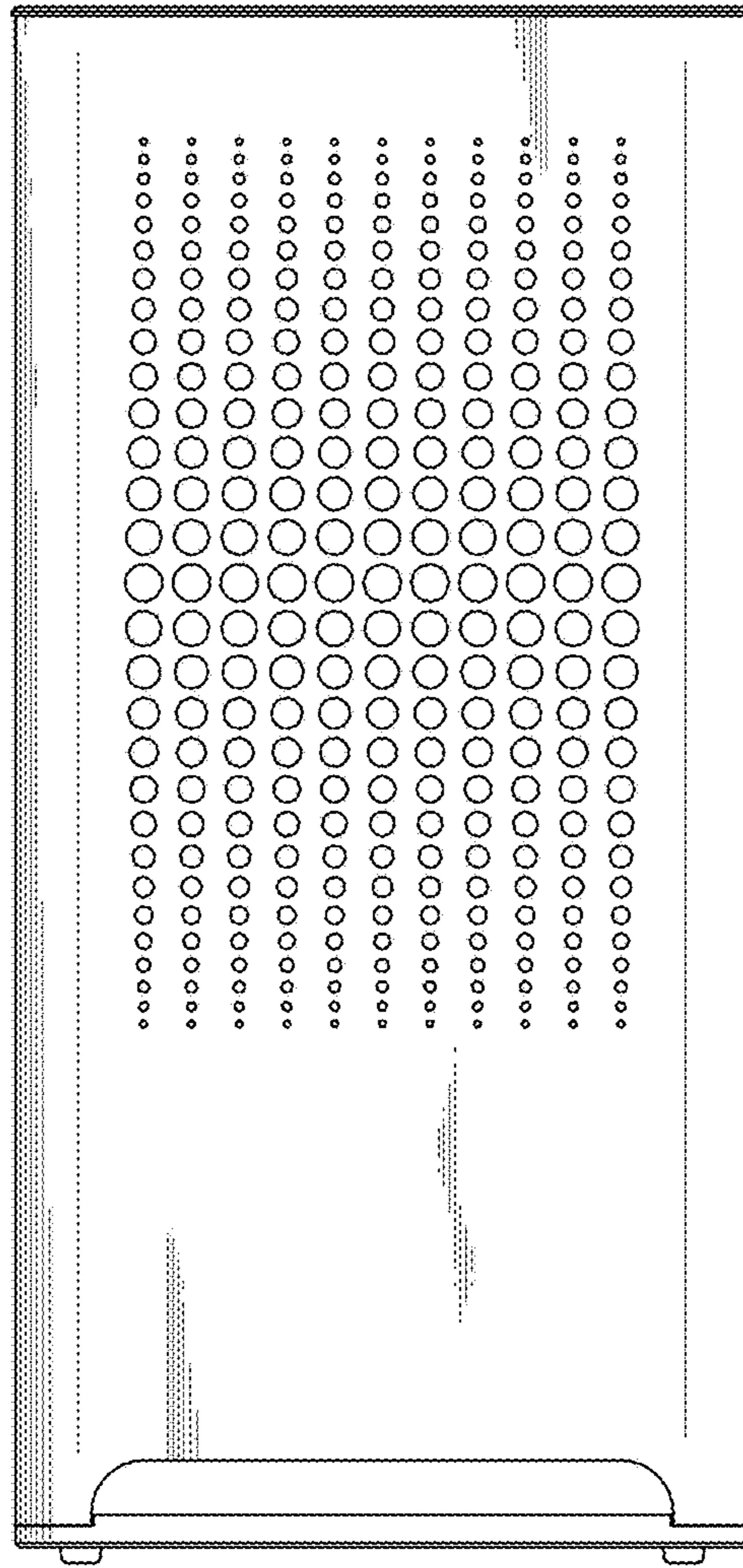

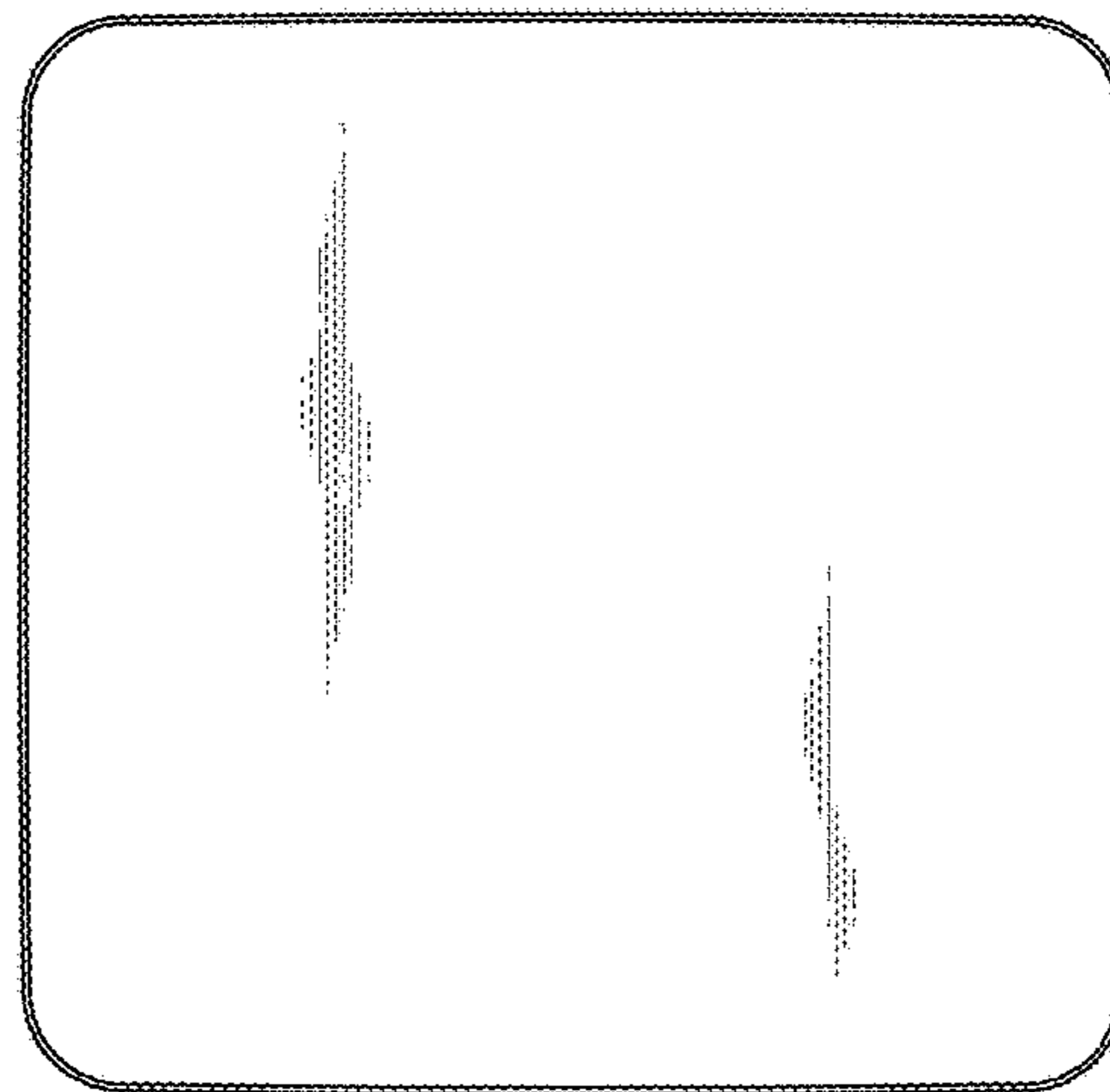

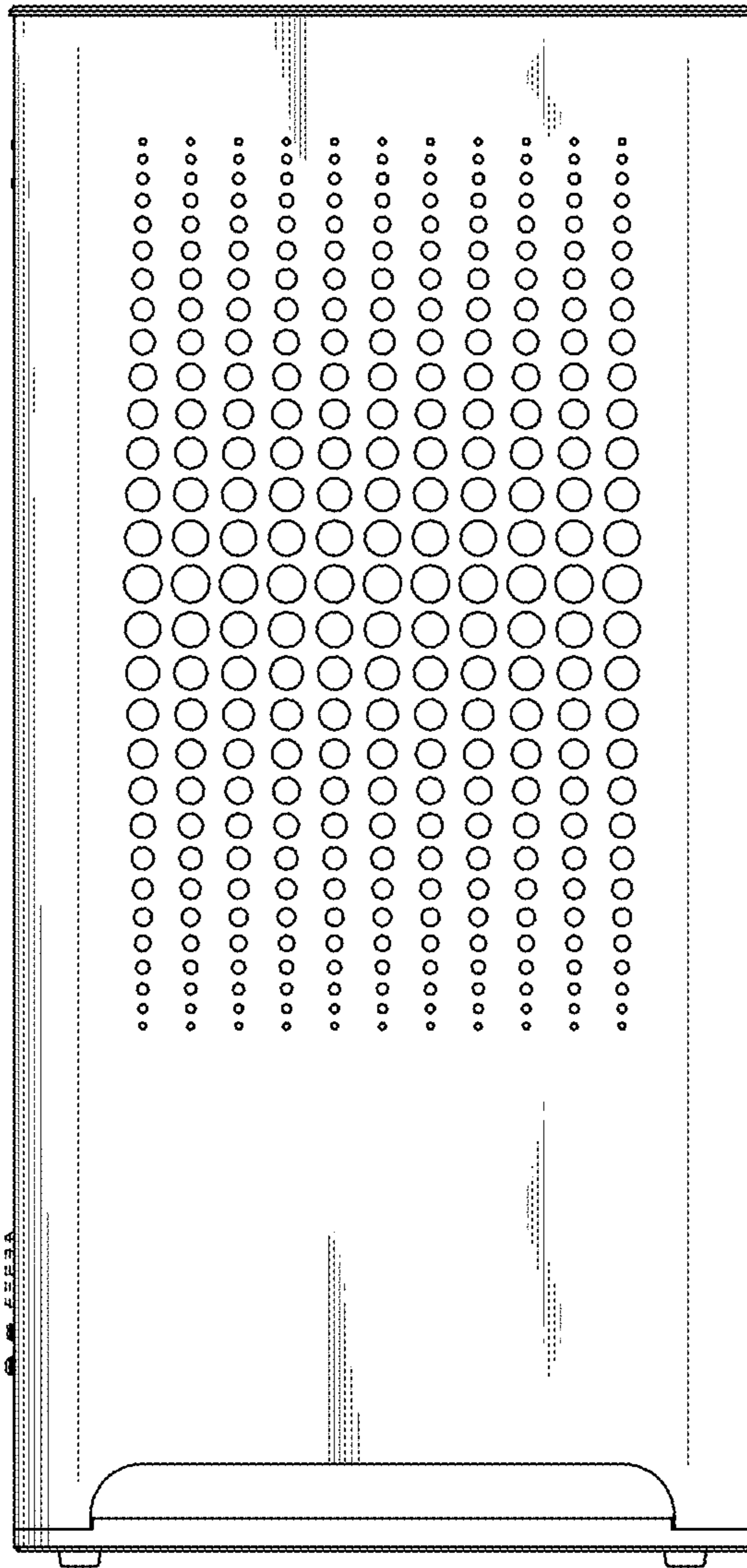

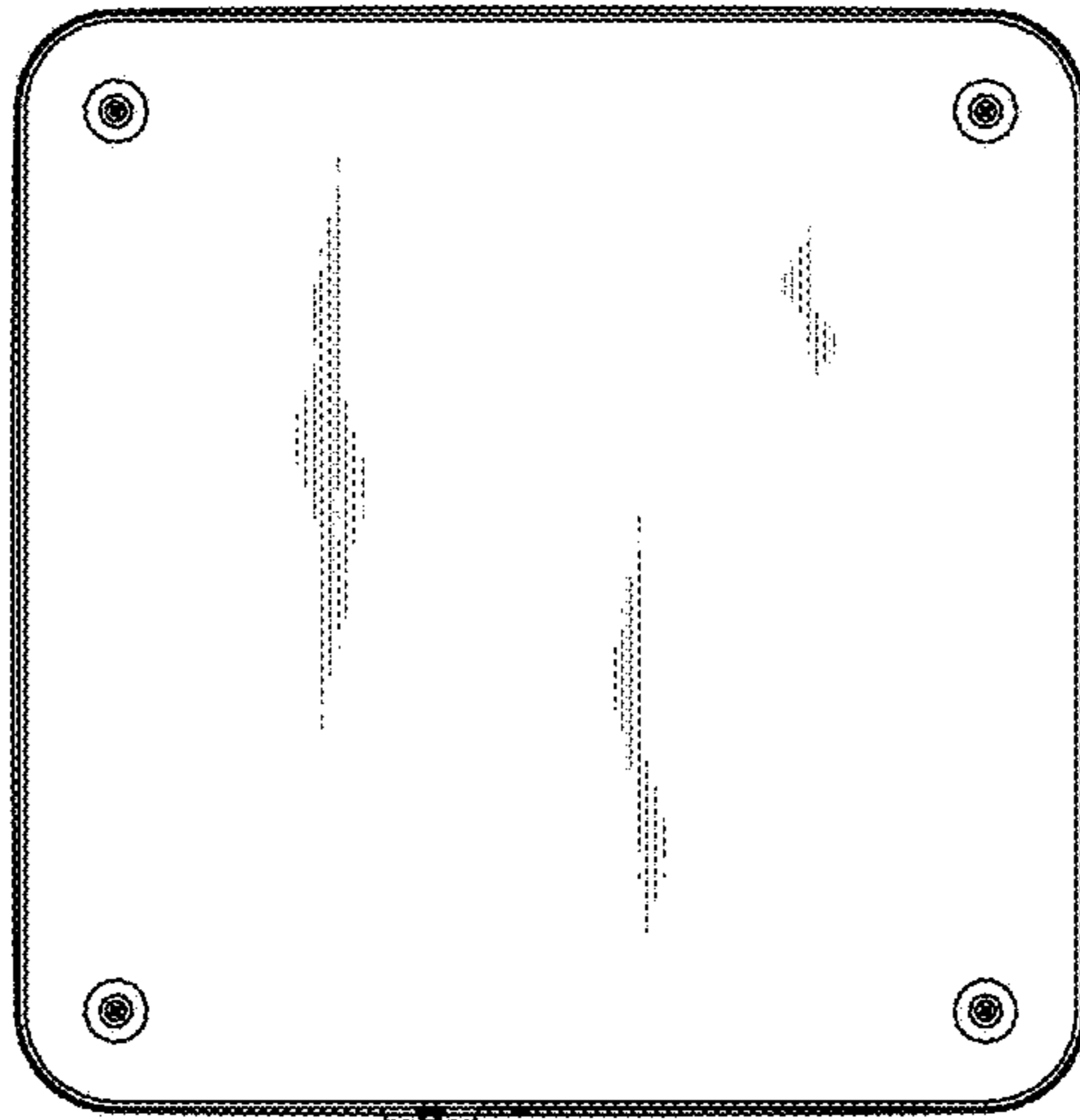

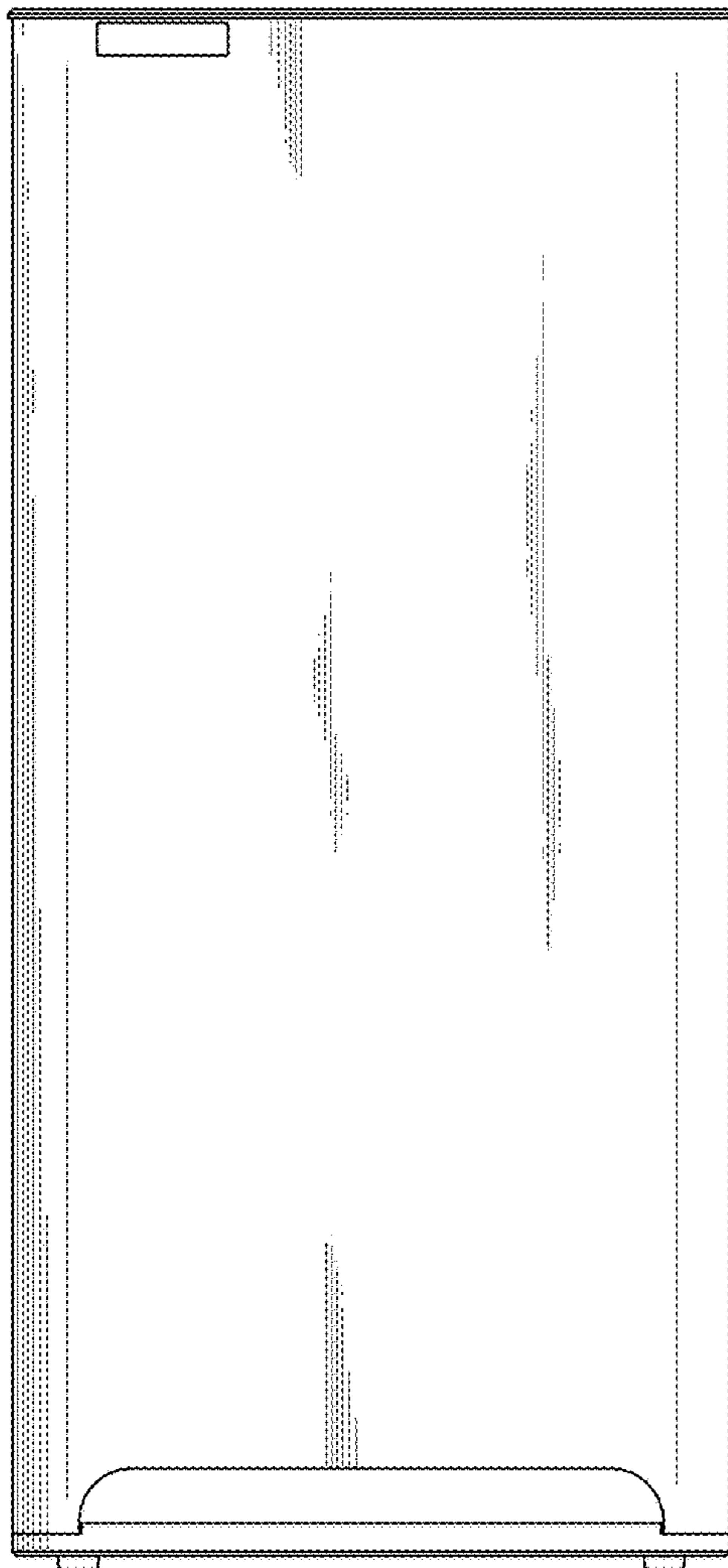

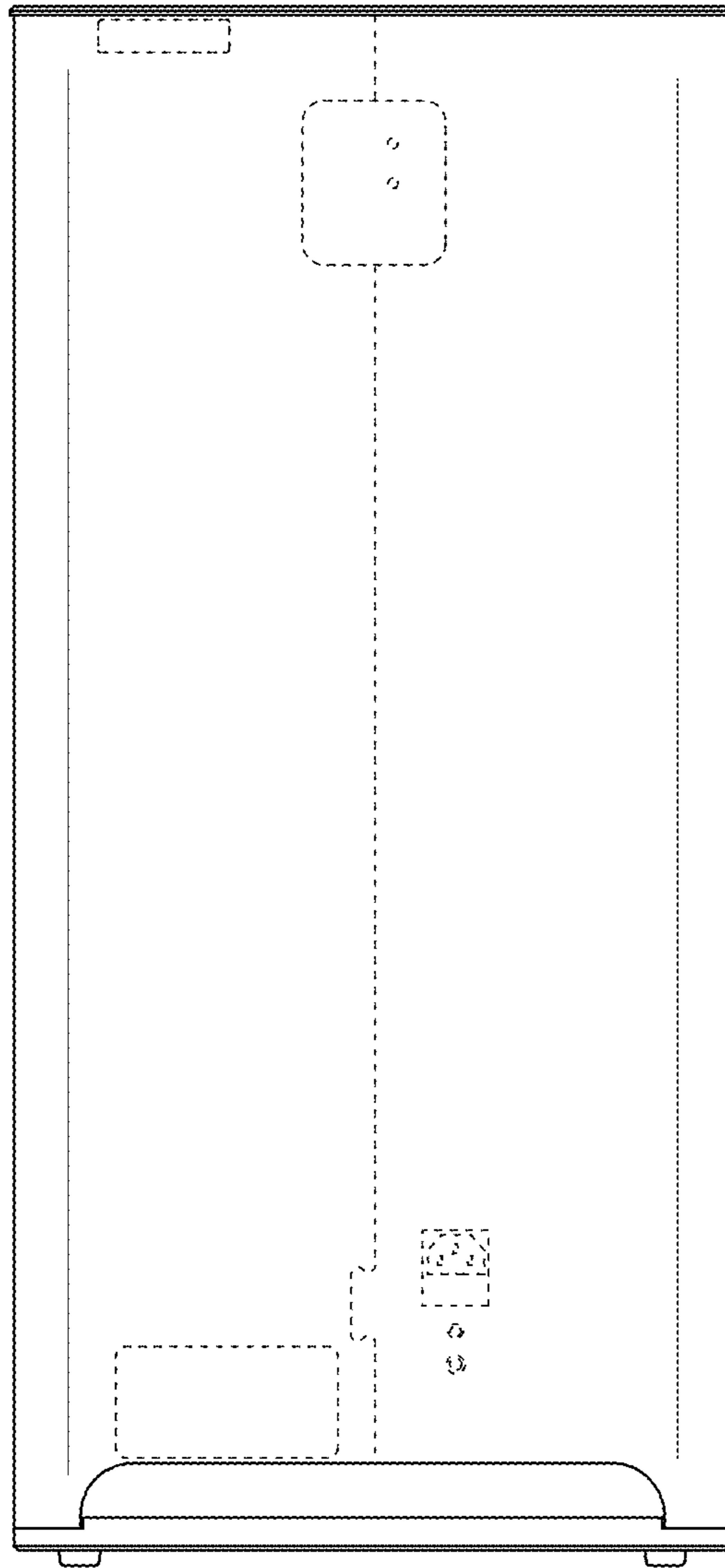
