**DESCRIPTION**

FIG. 1 is a front perspective view of a nasal dilator device showing my design;

FIG. 8 is a top plan view of the nasal dilator device.

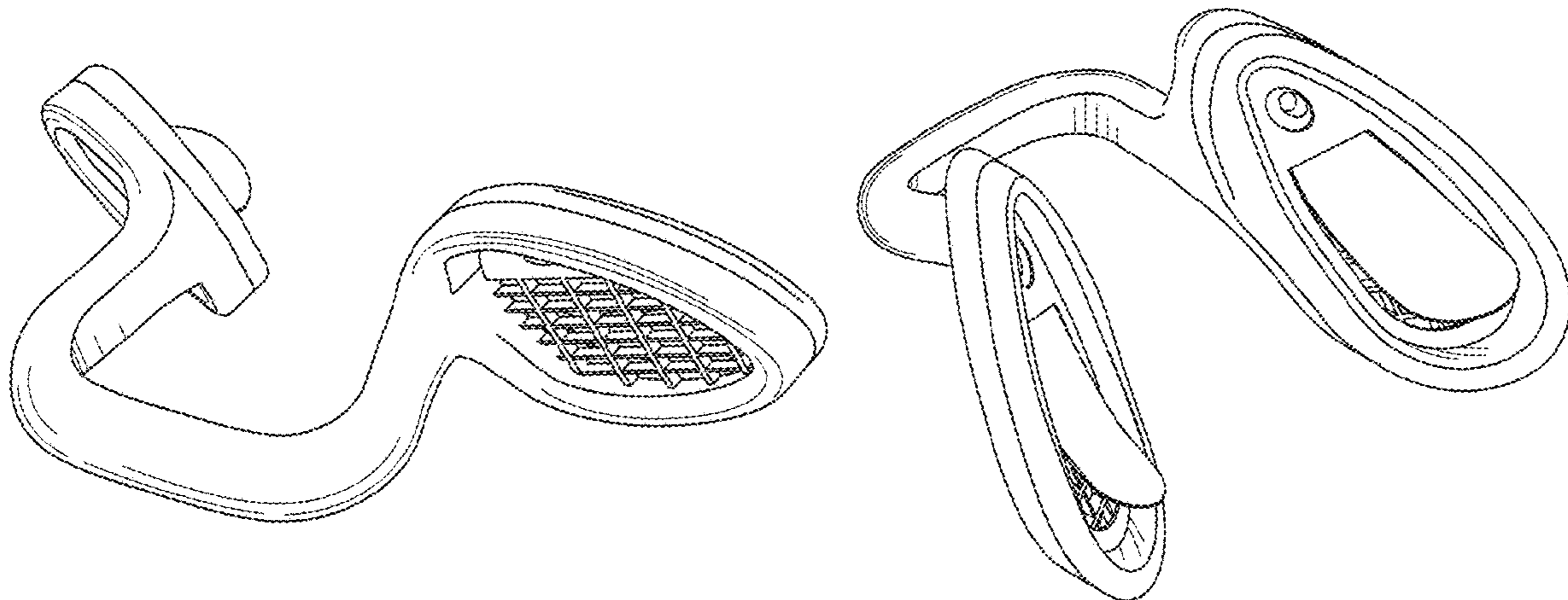

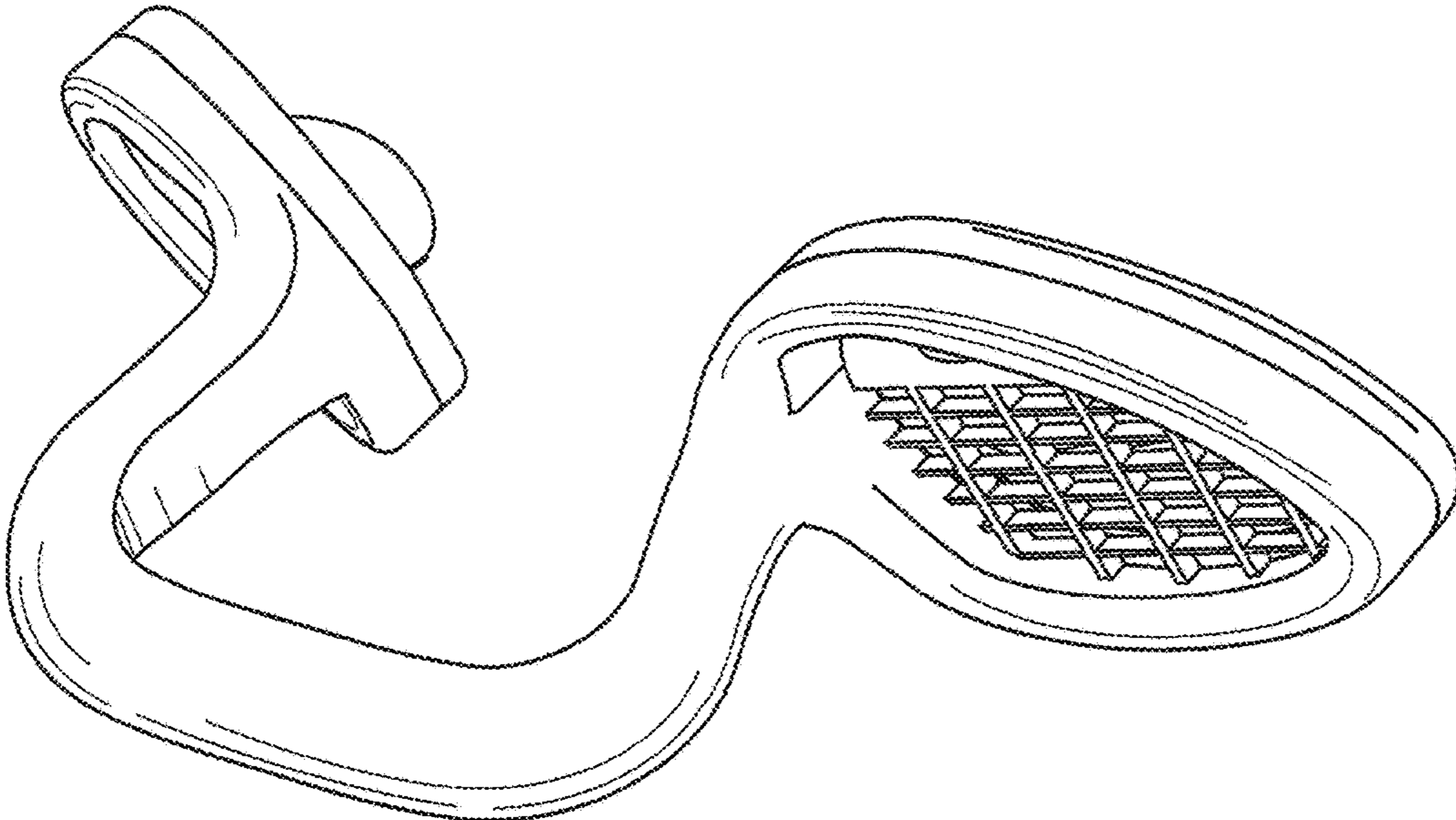

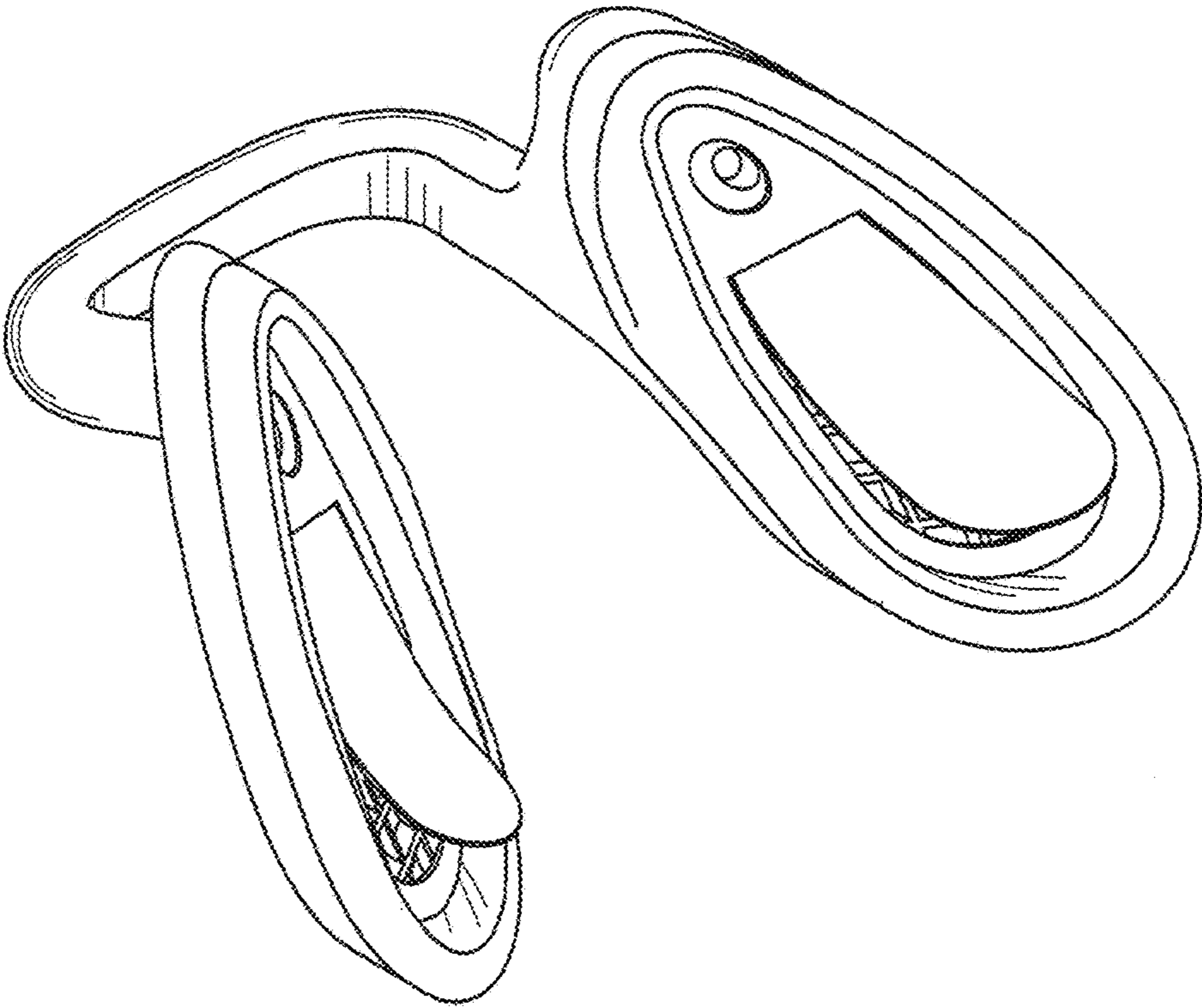
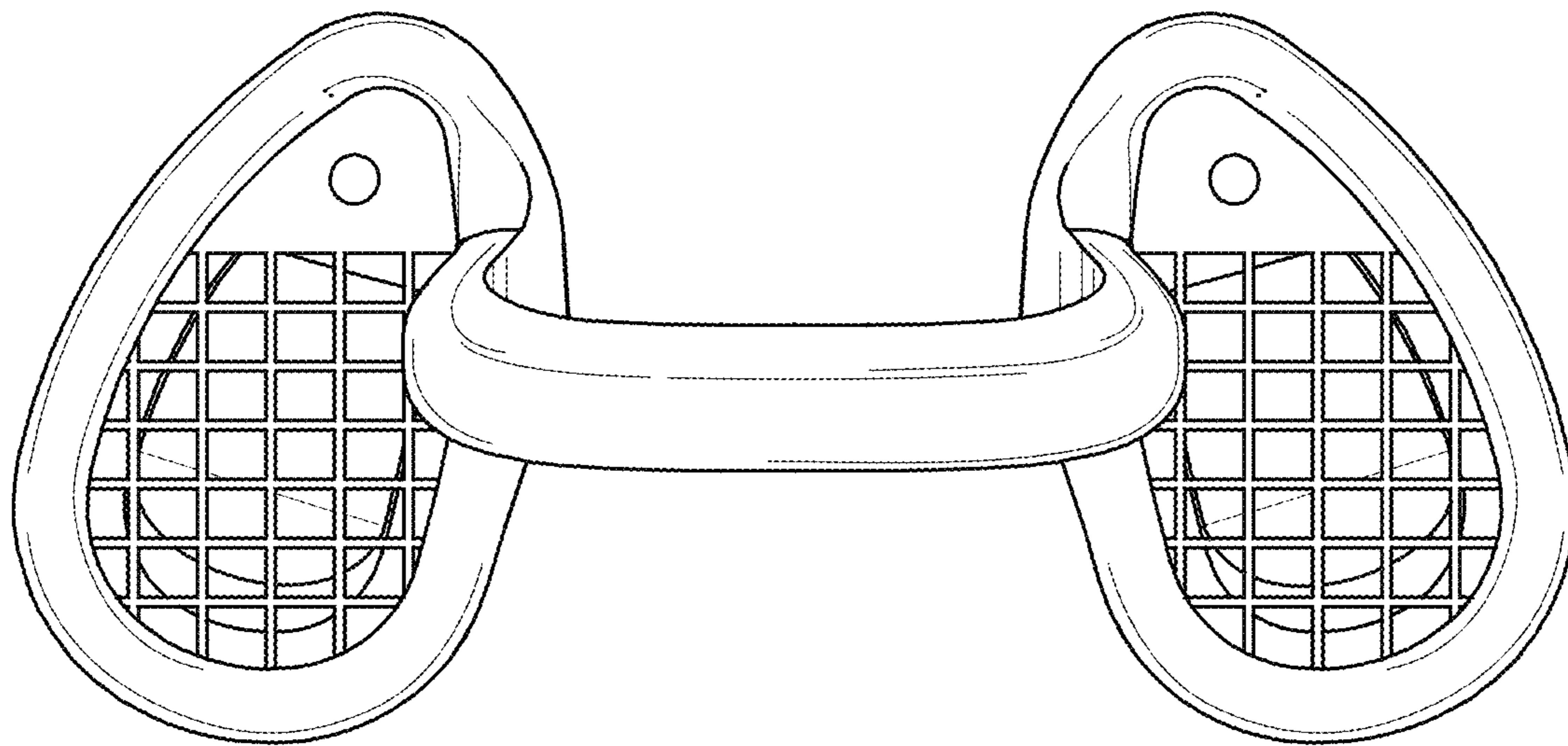
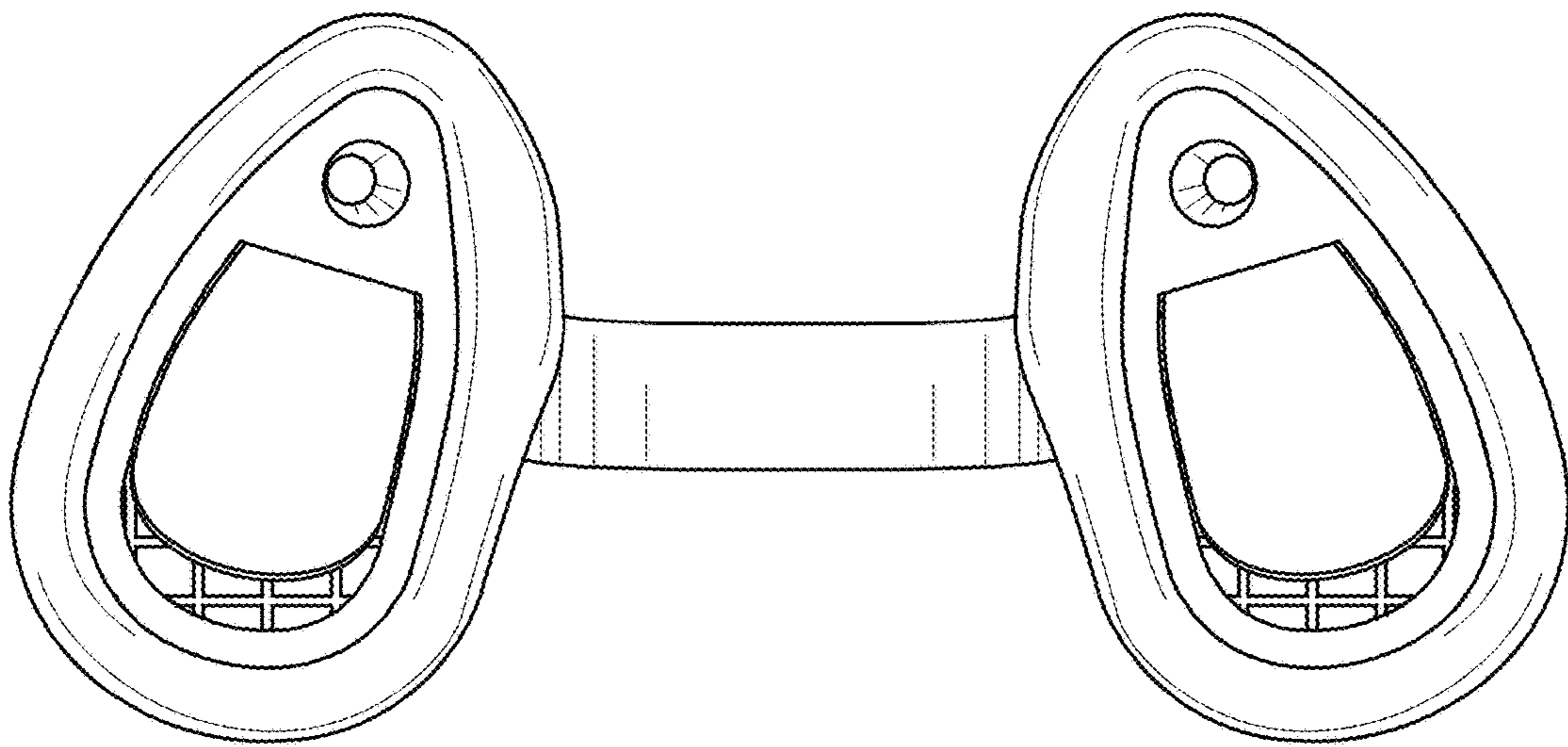

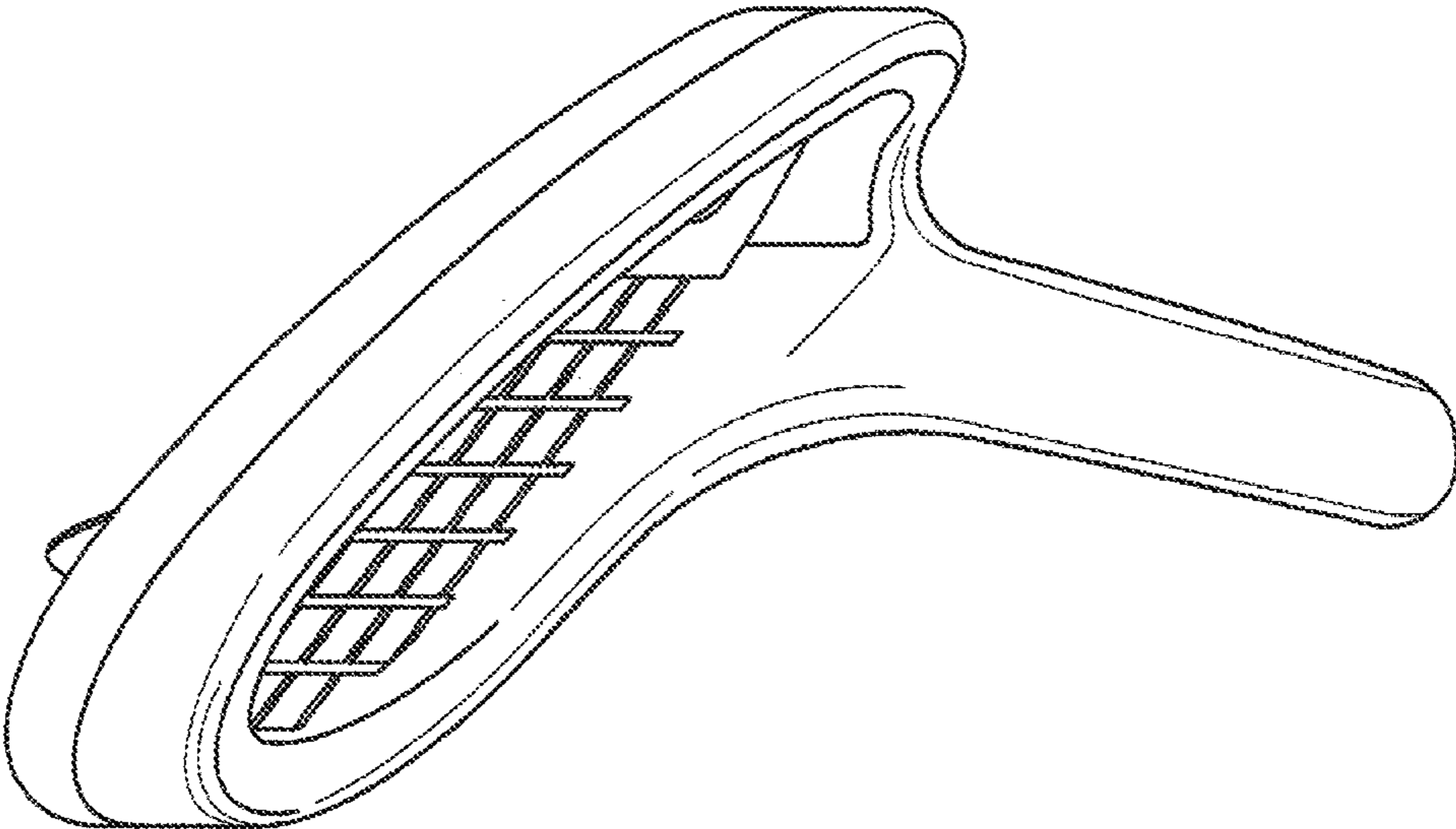

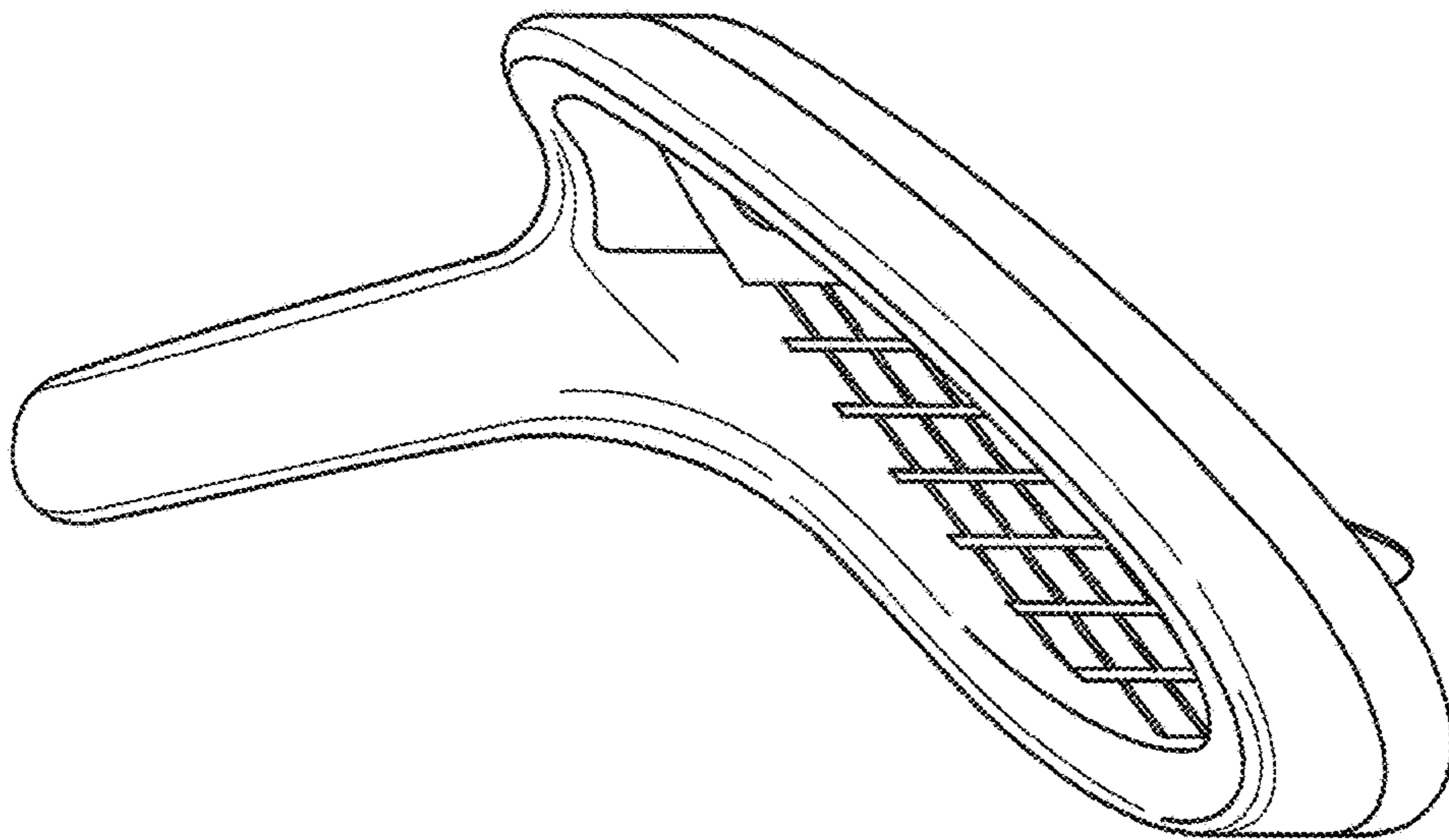

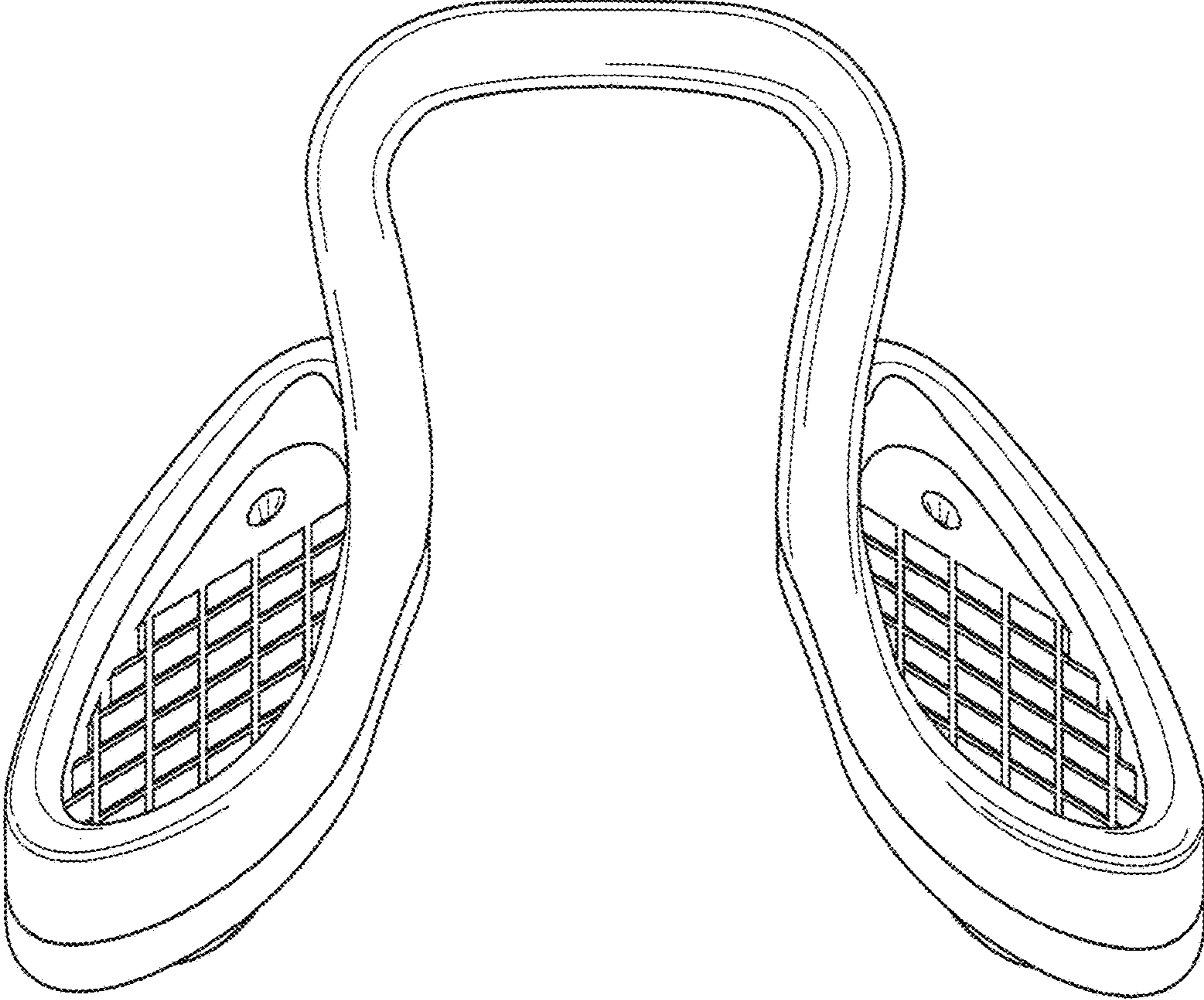

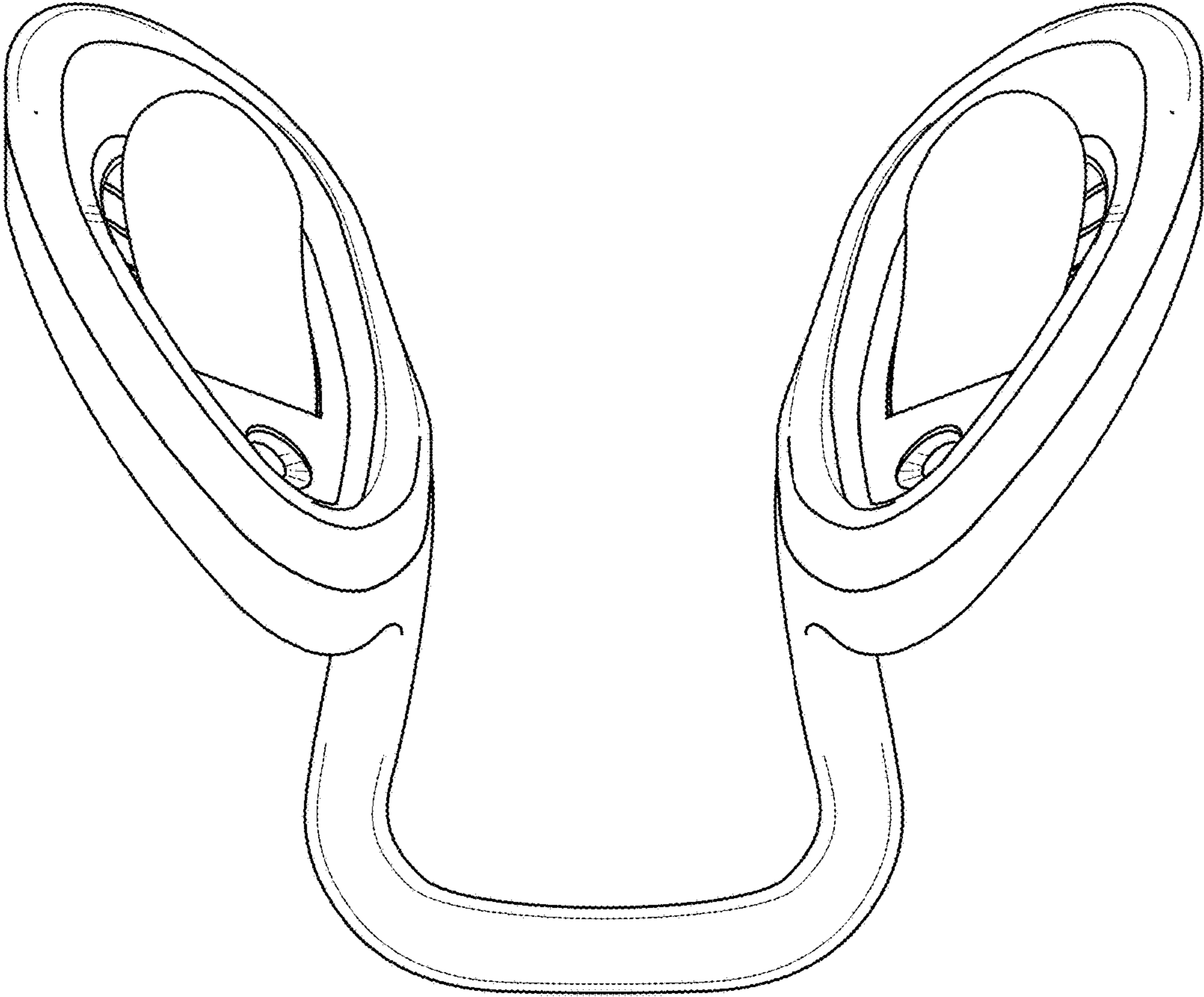
