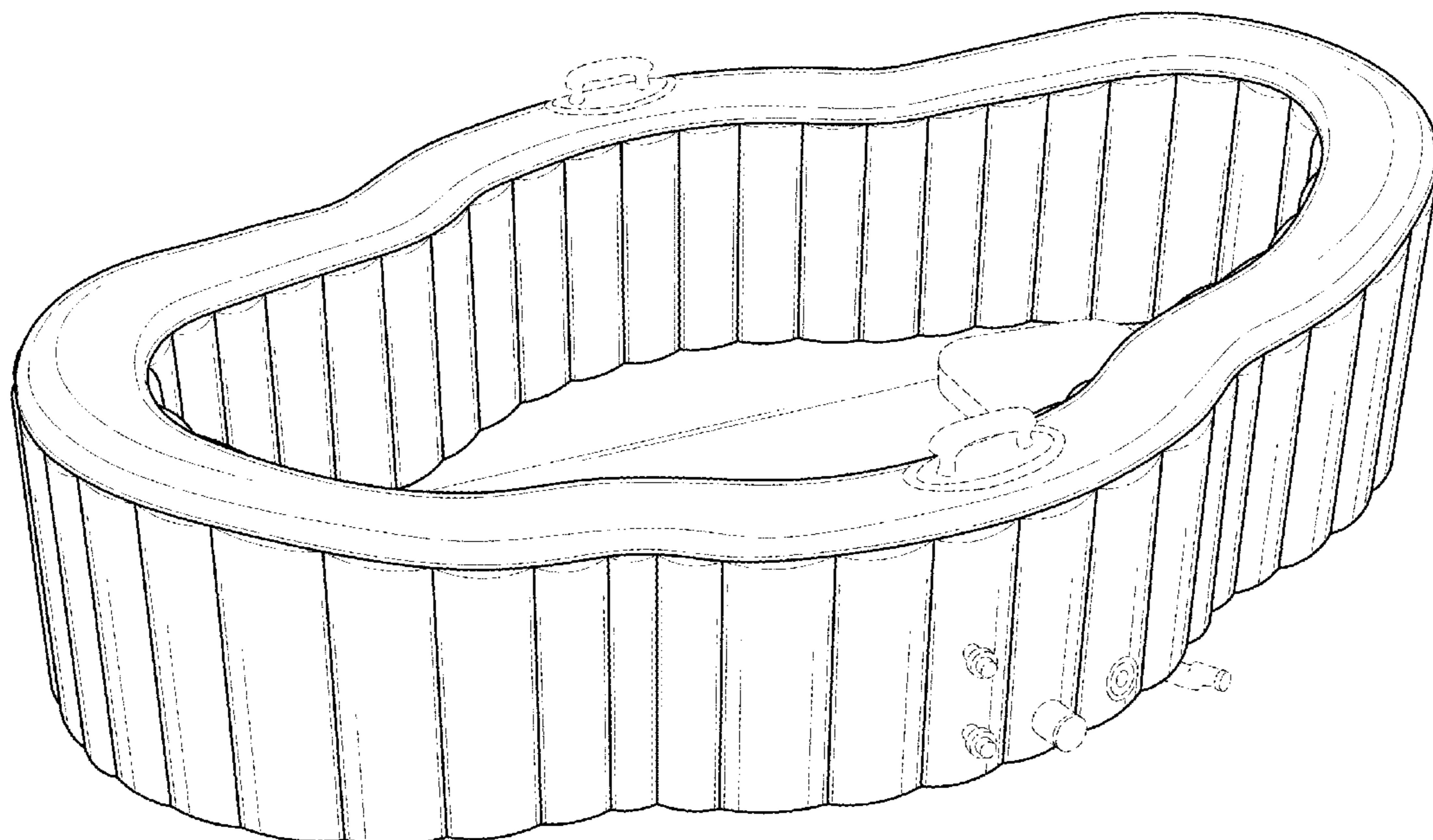
(57) **CLAIM**

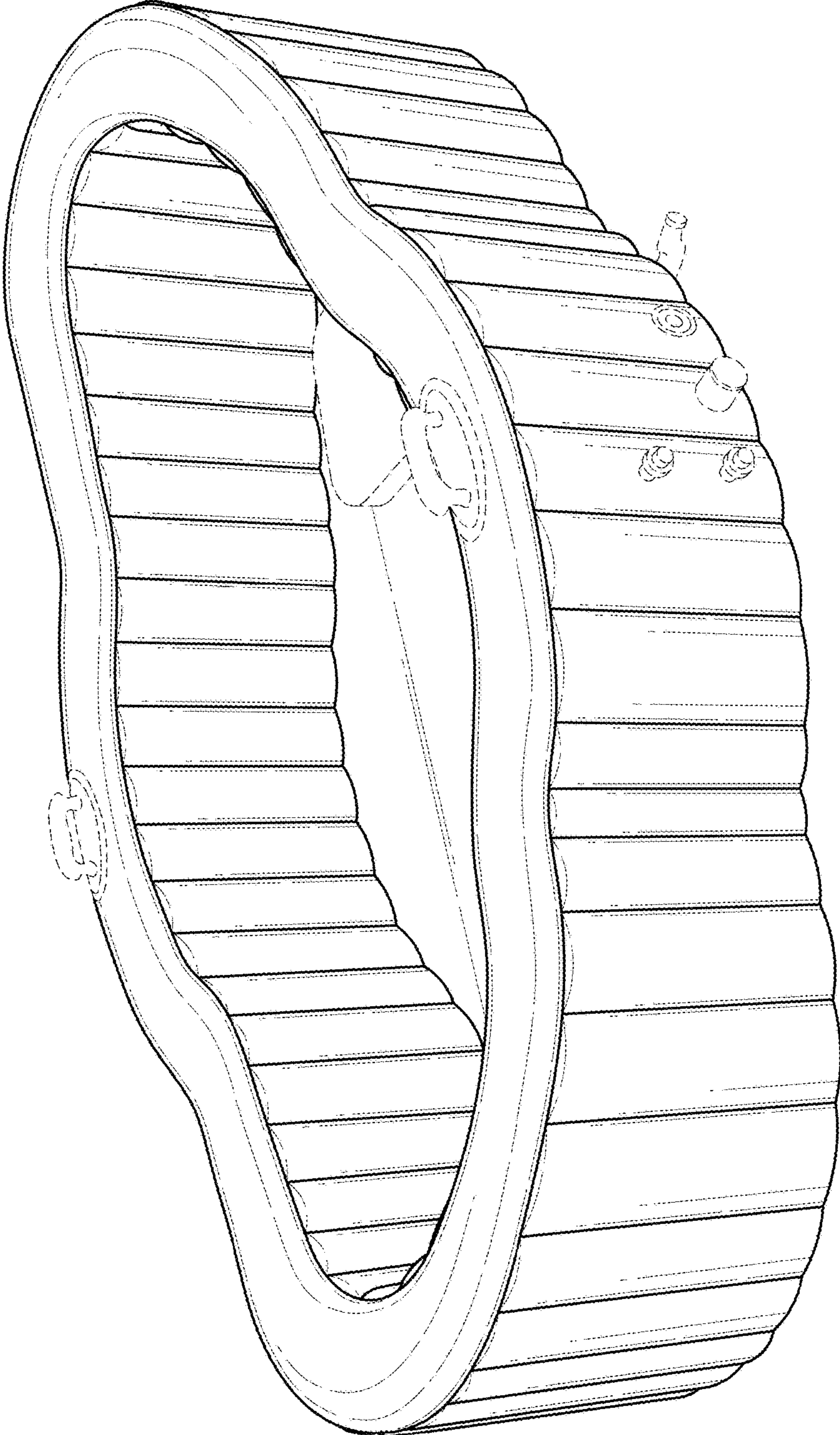
The ornamental design for a boat shaped pool for spa, as shown and described.

**DESCRIPTION**

The broken lines shown in the figures represent portions of the boat shaped pool for spa that form no part of the claimed design.

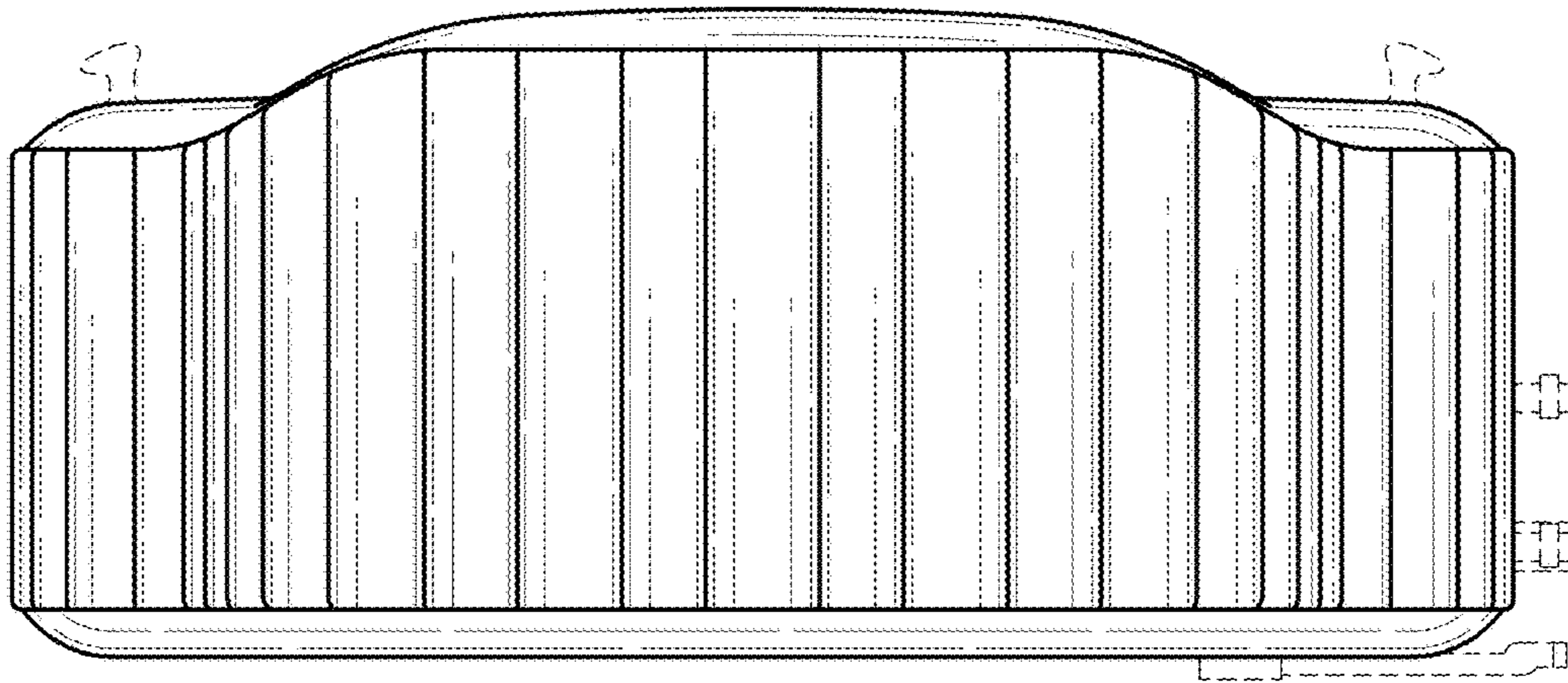

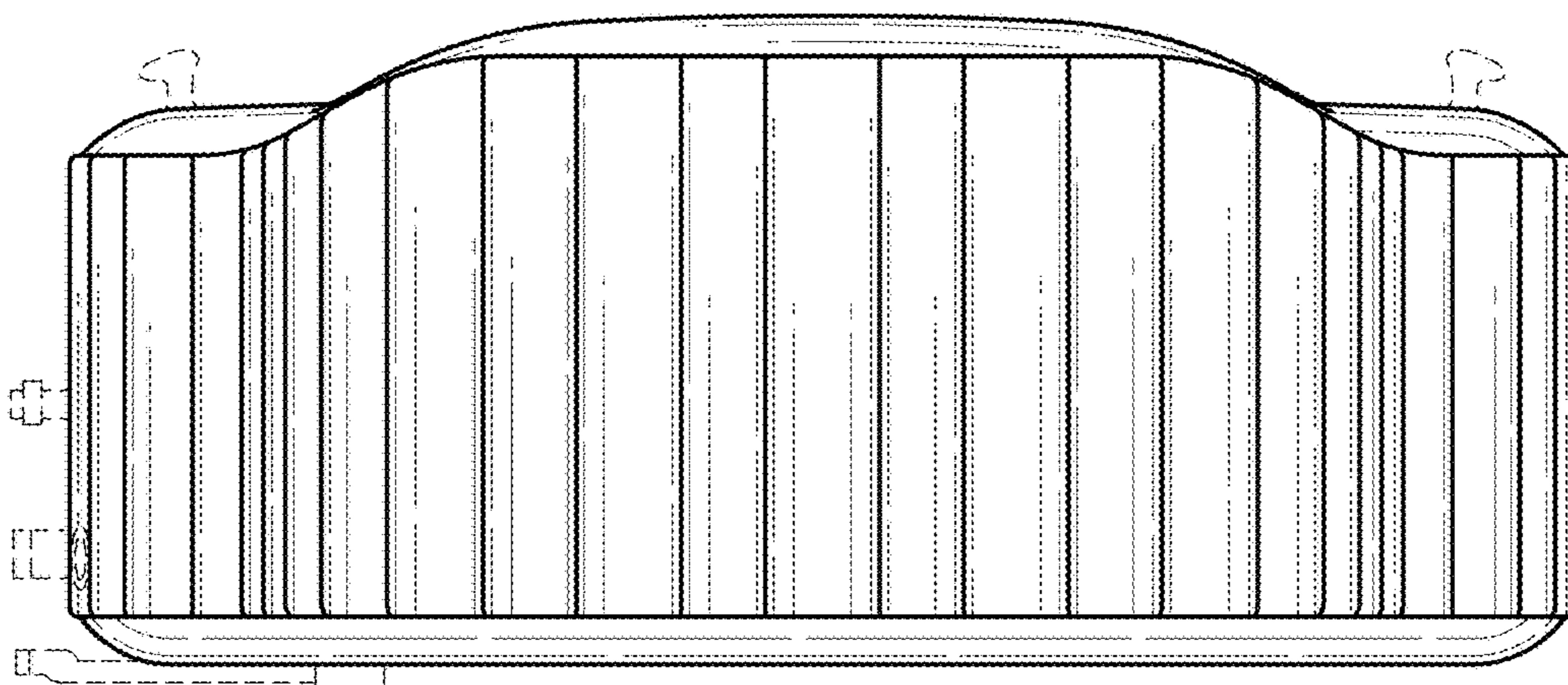

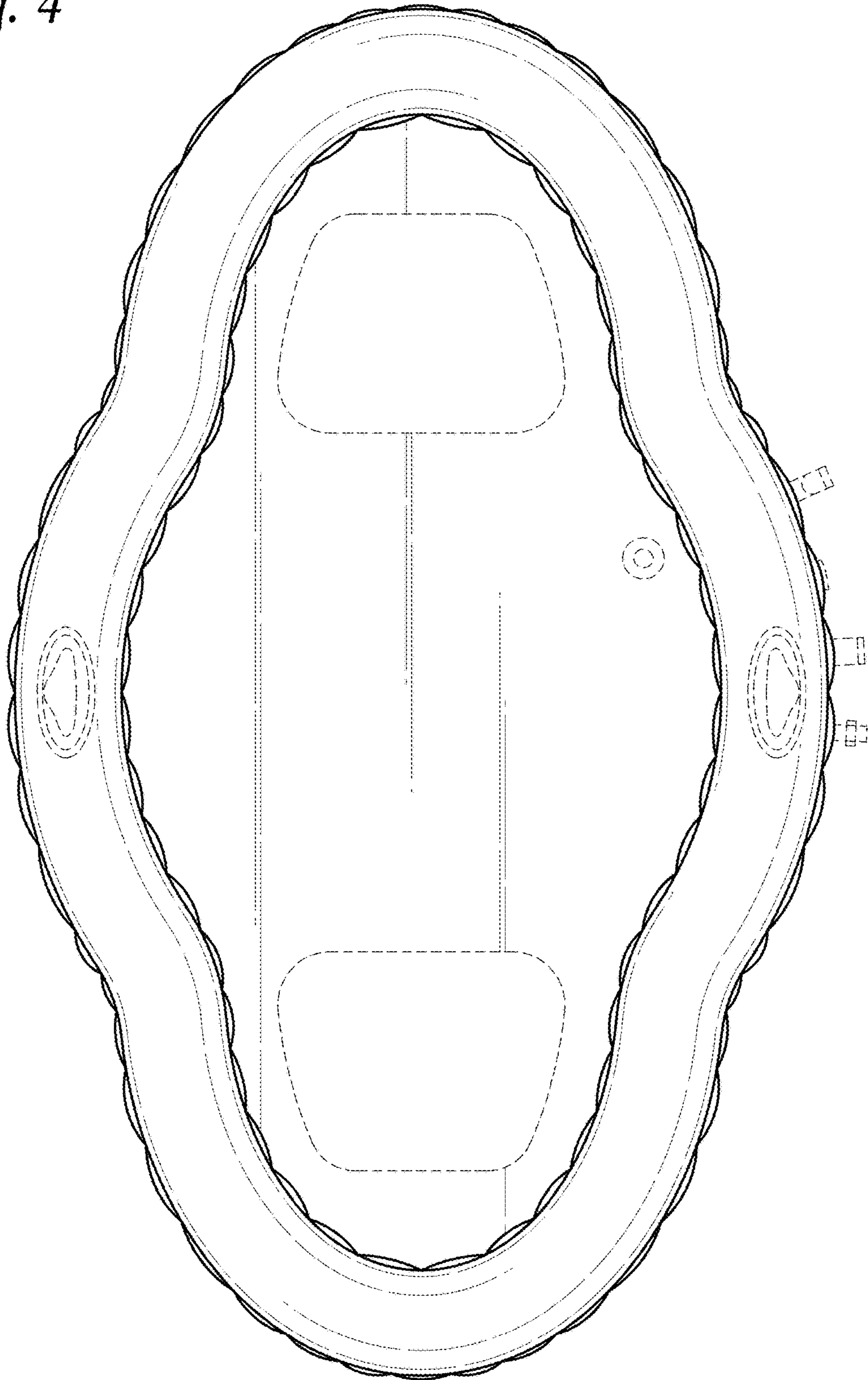

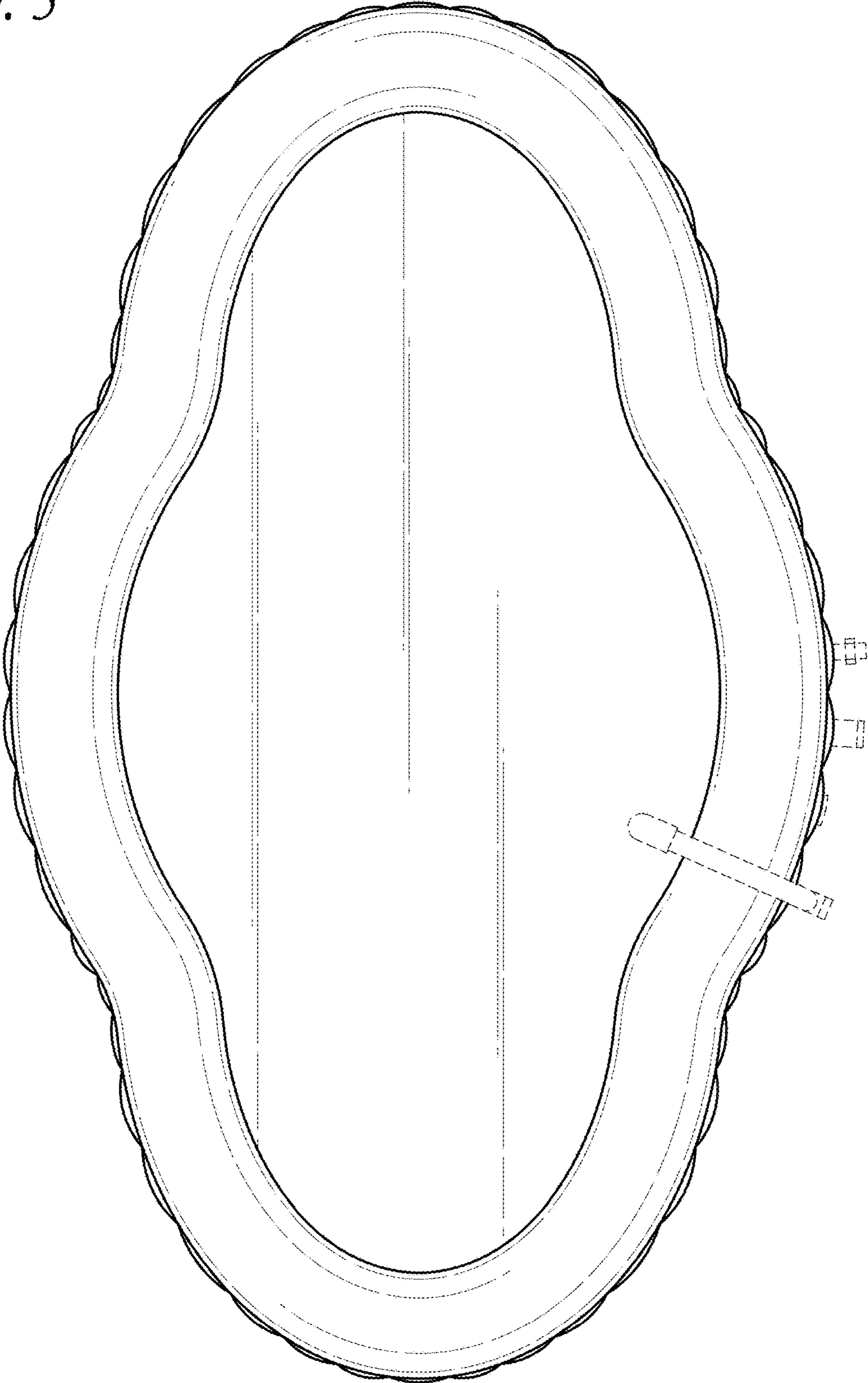

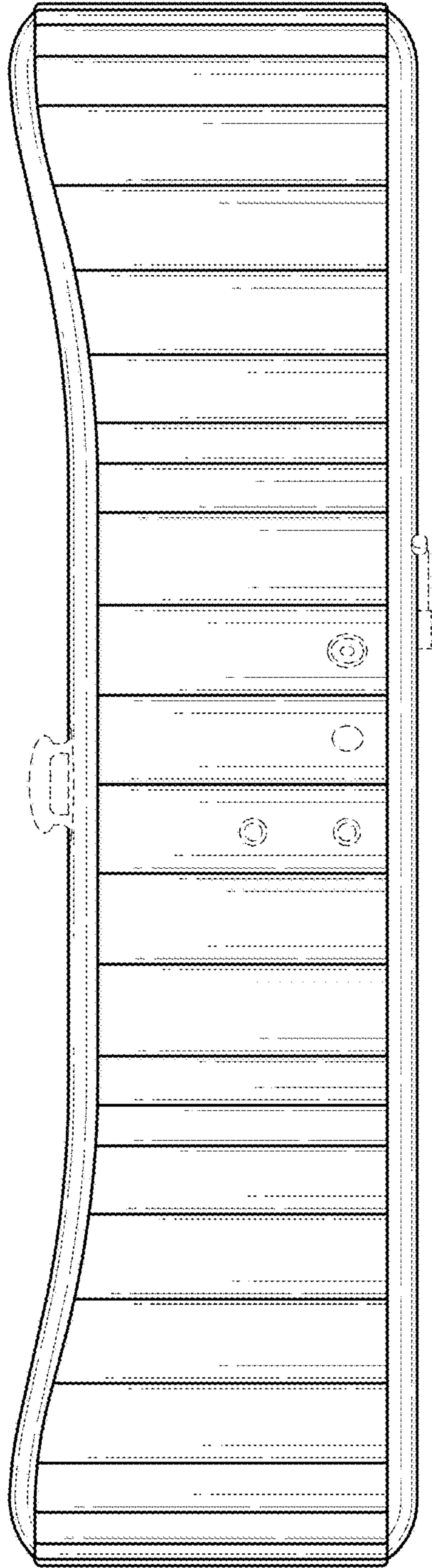
