The ornamental design for a fluid flow sinker and a fluid flow sinker assembly, as shown and described.

**DESCRIPTION**

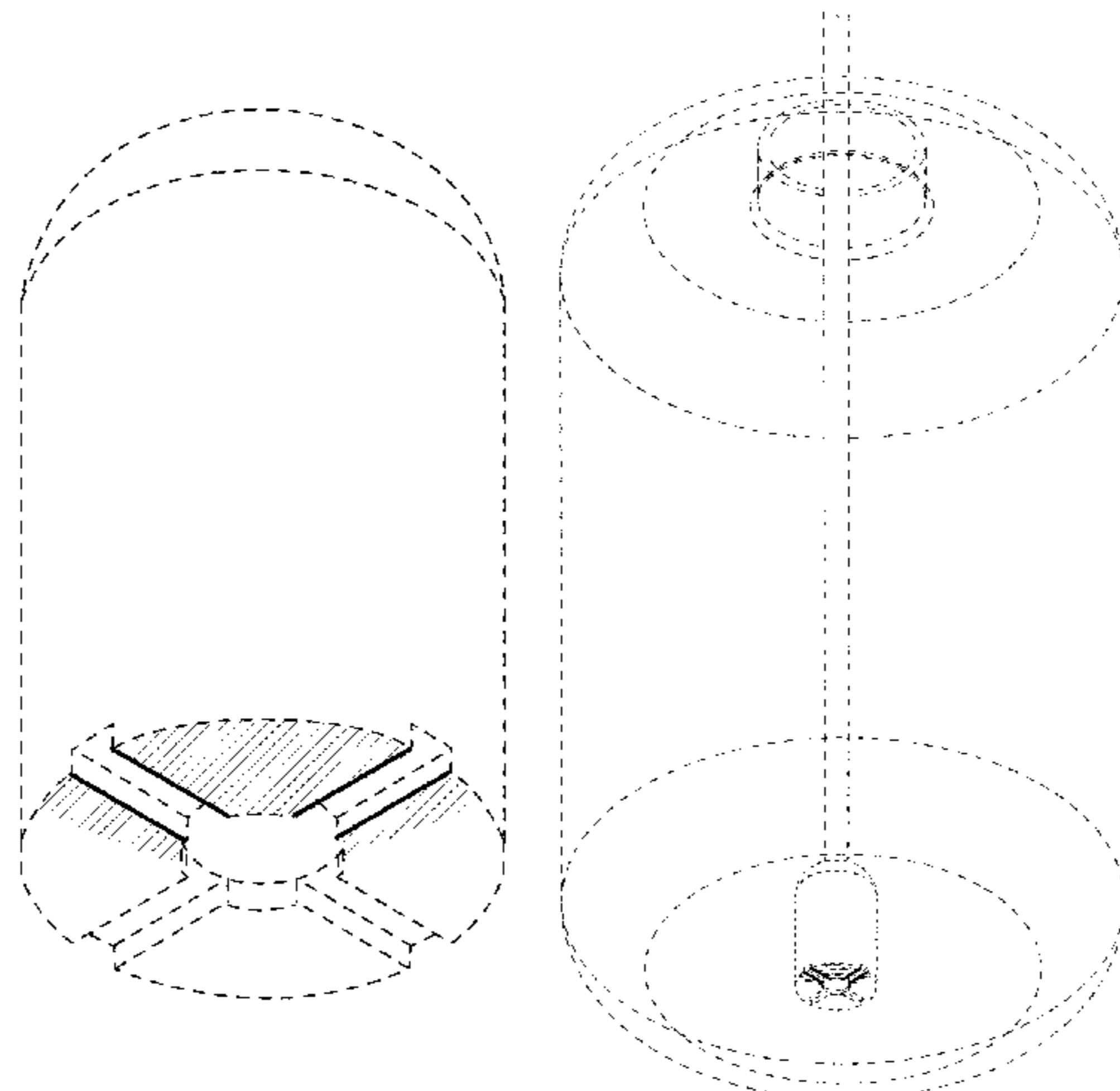


FIG. 14 is a side elevation view thereof; the opposite side being a mirror image thereof;

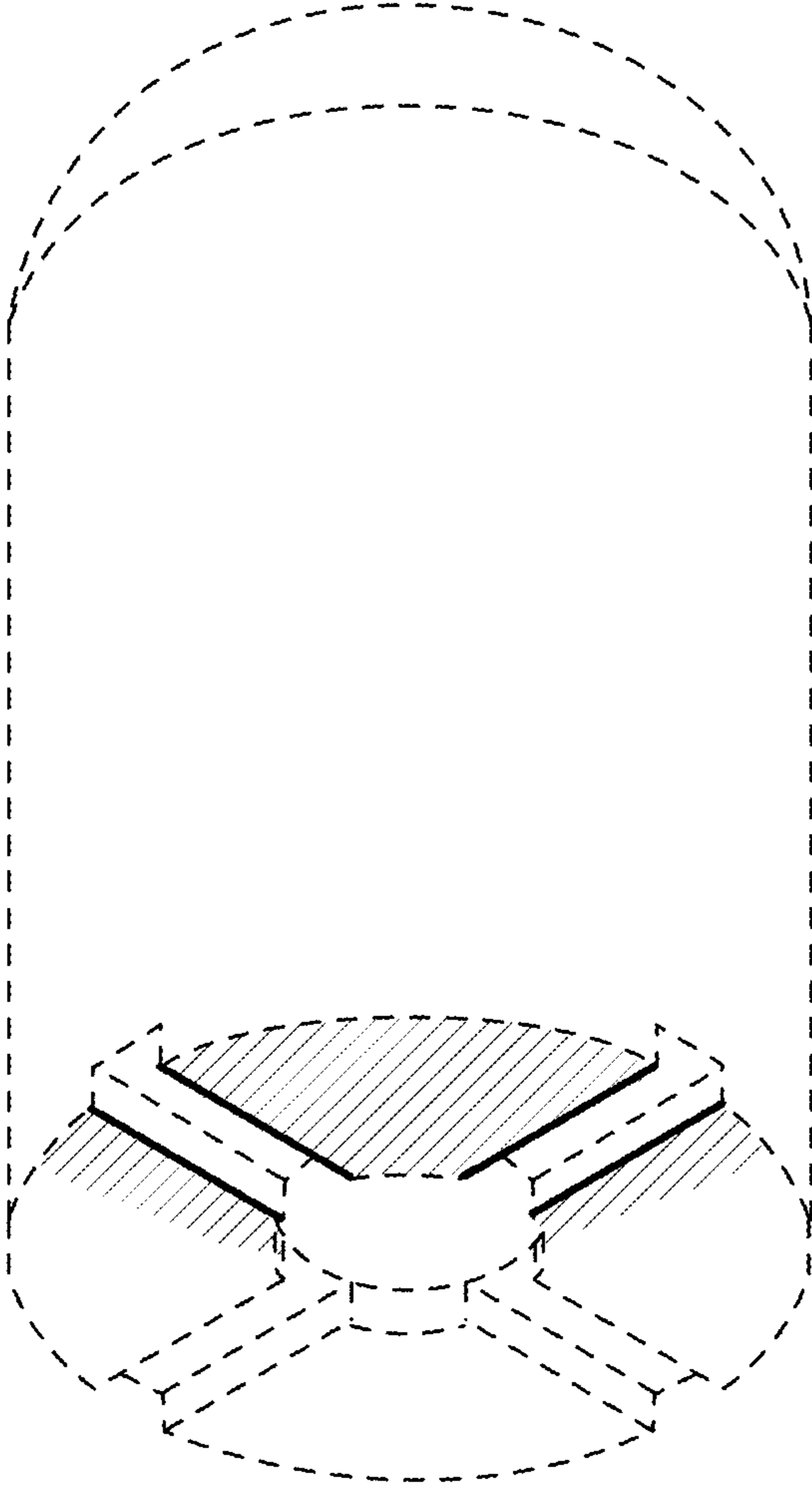

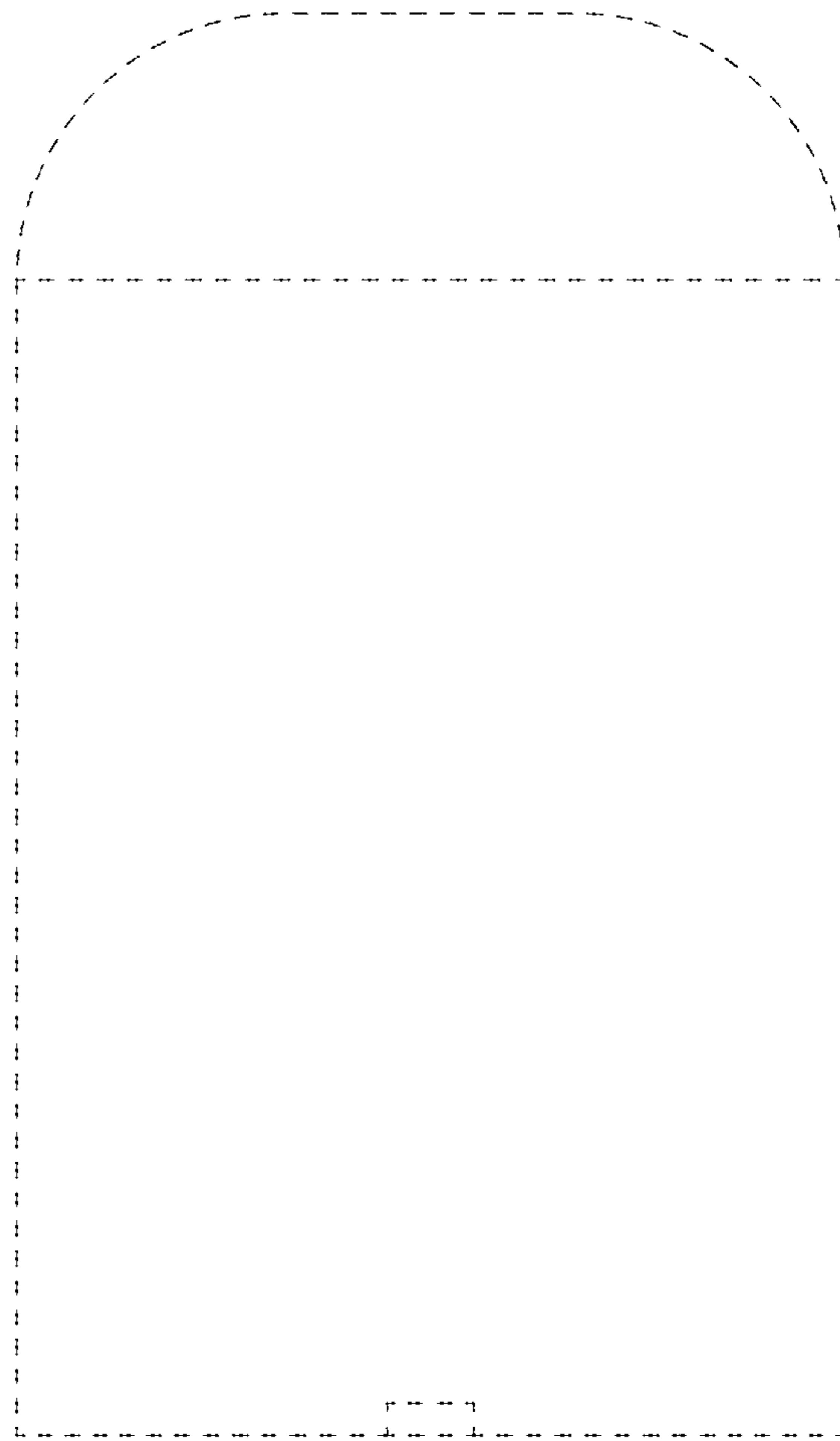

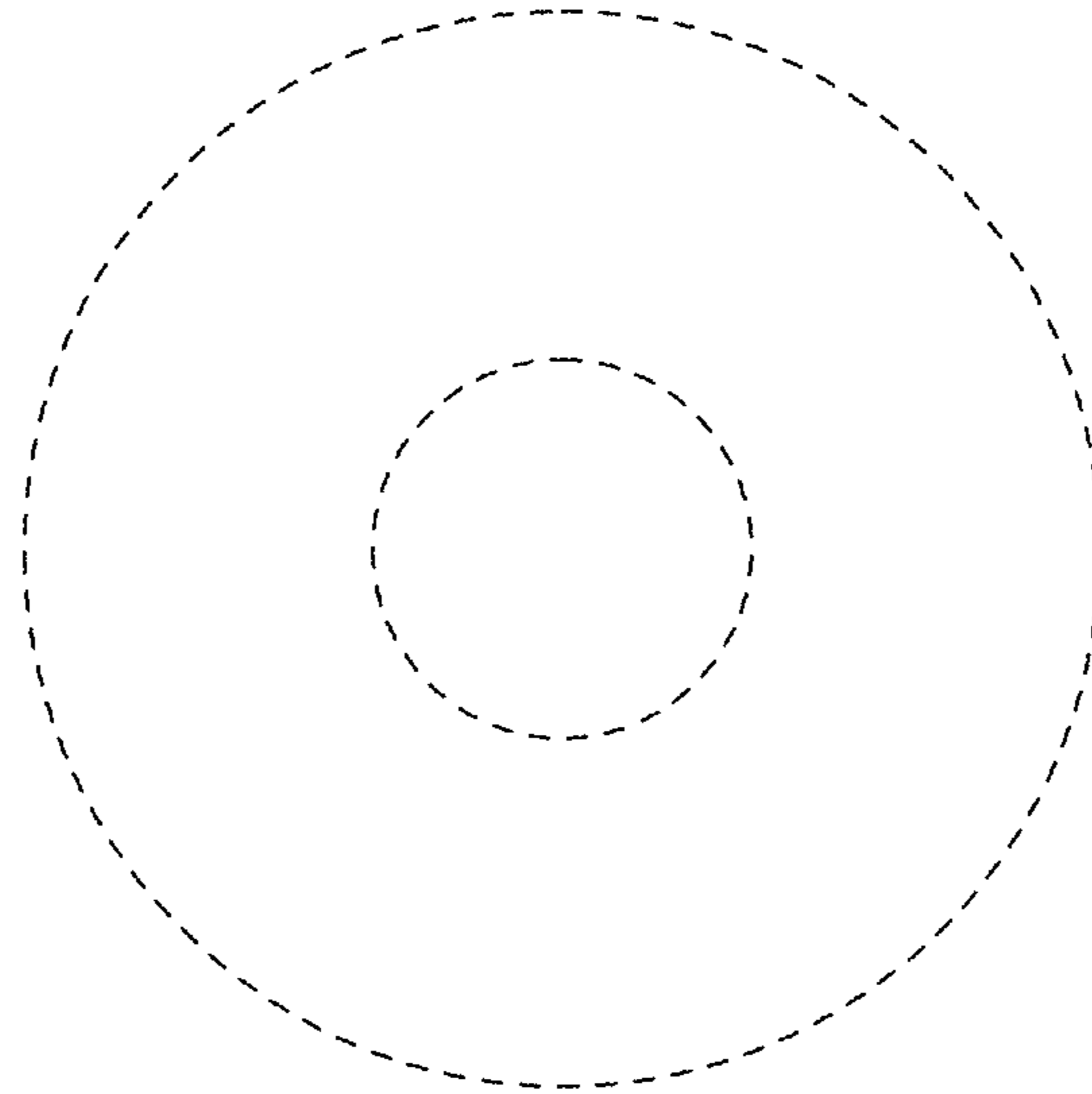

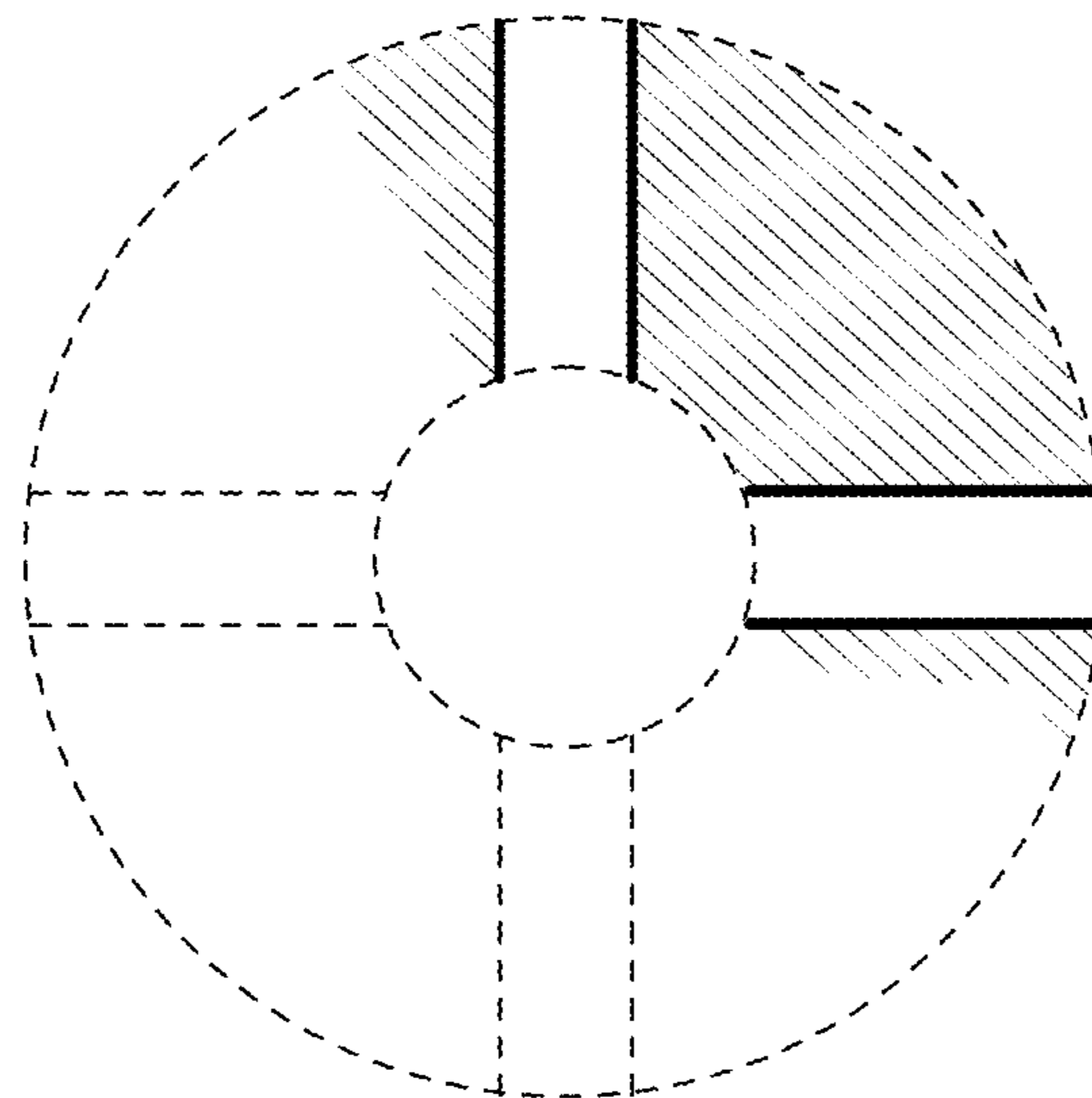
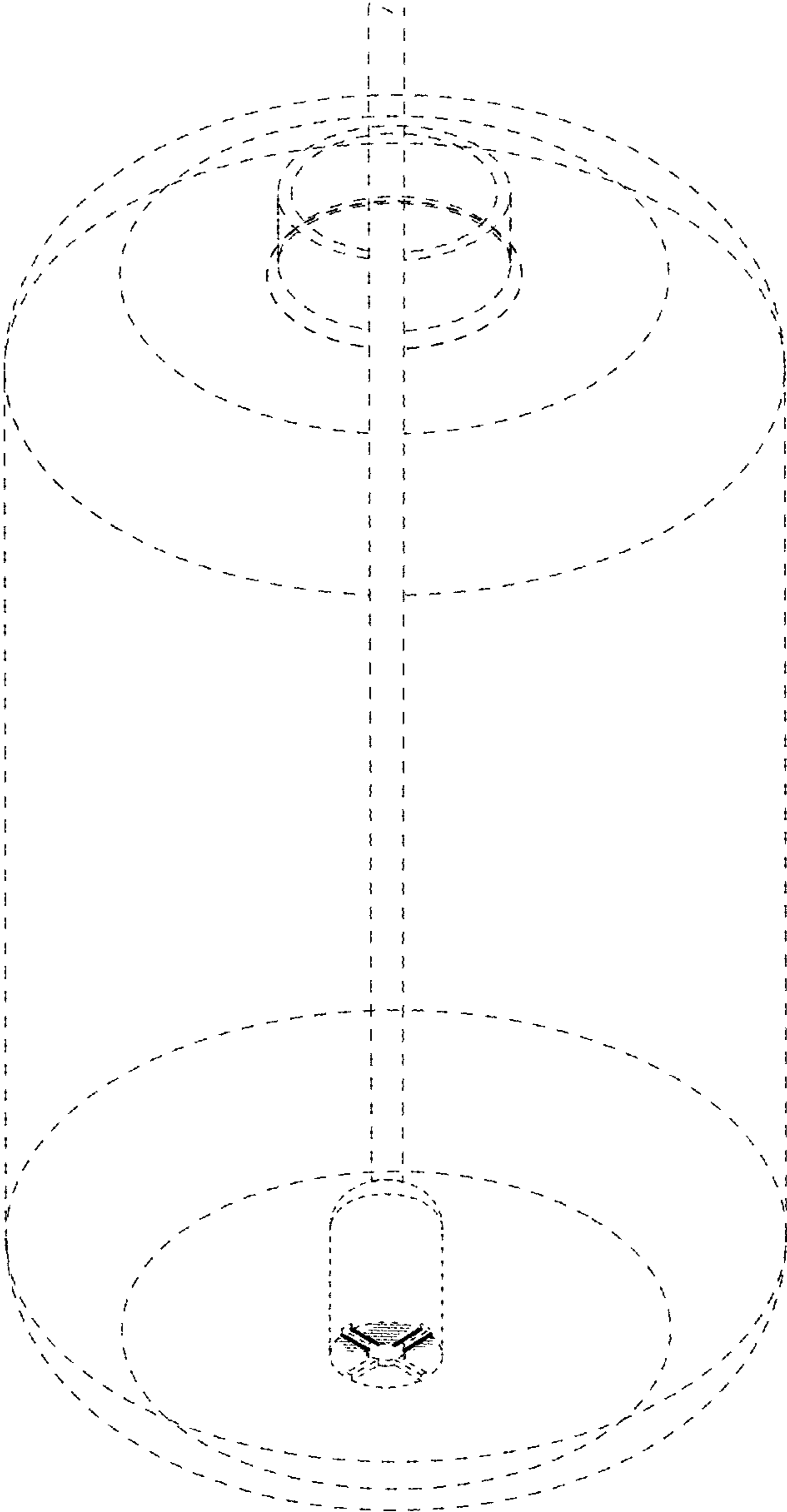

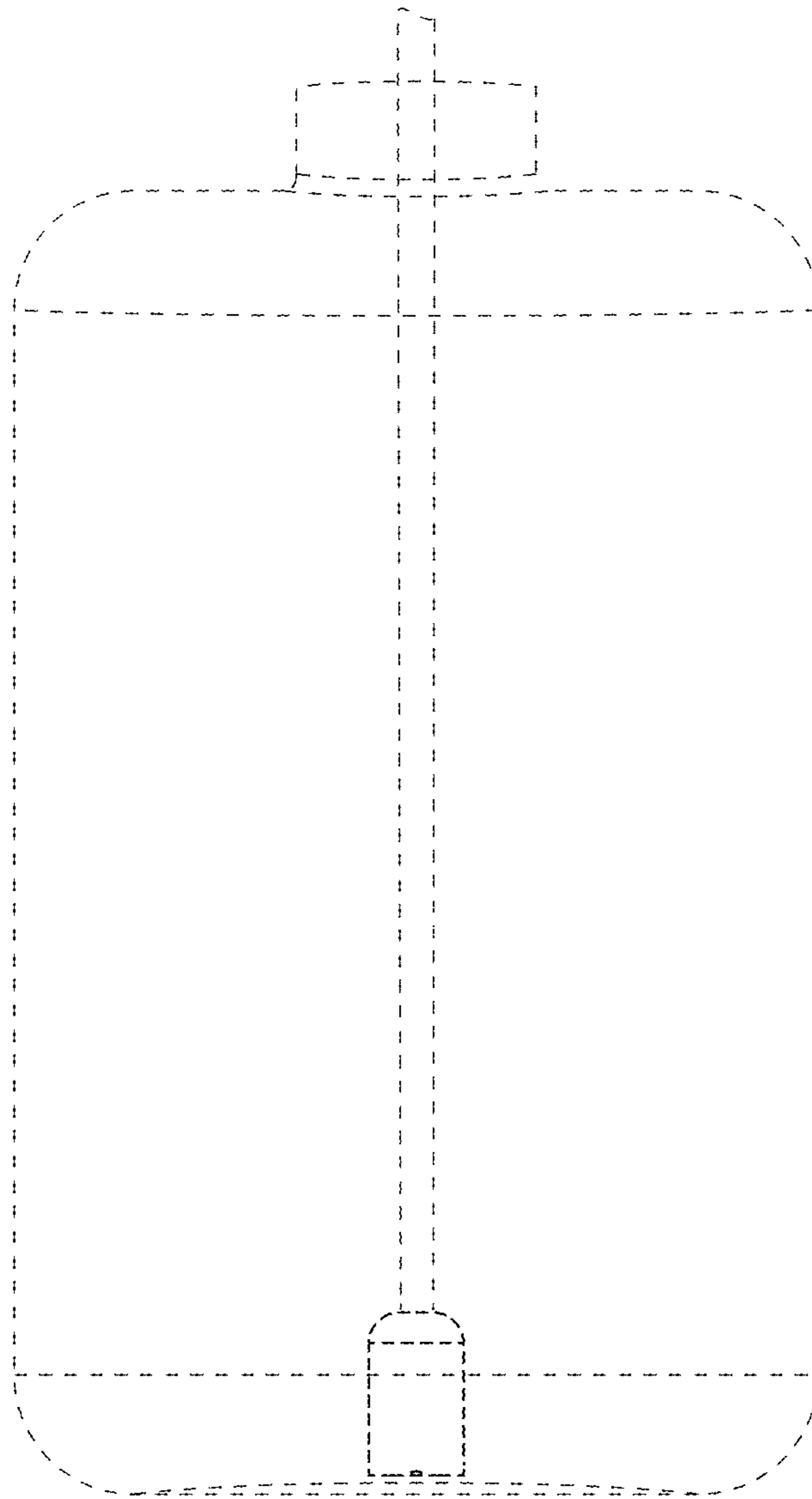
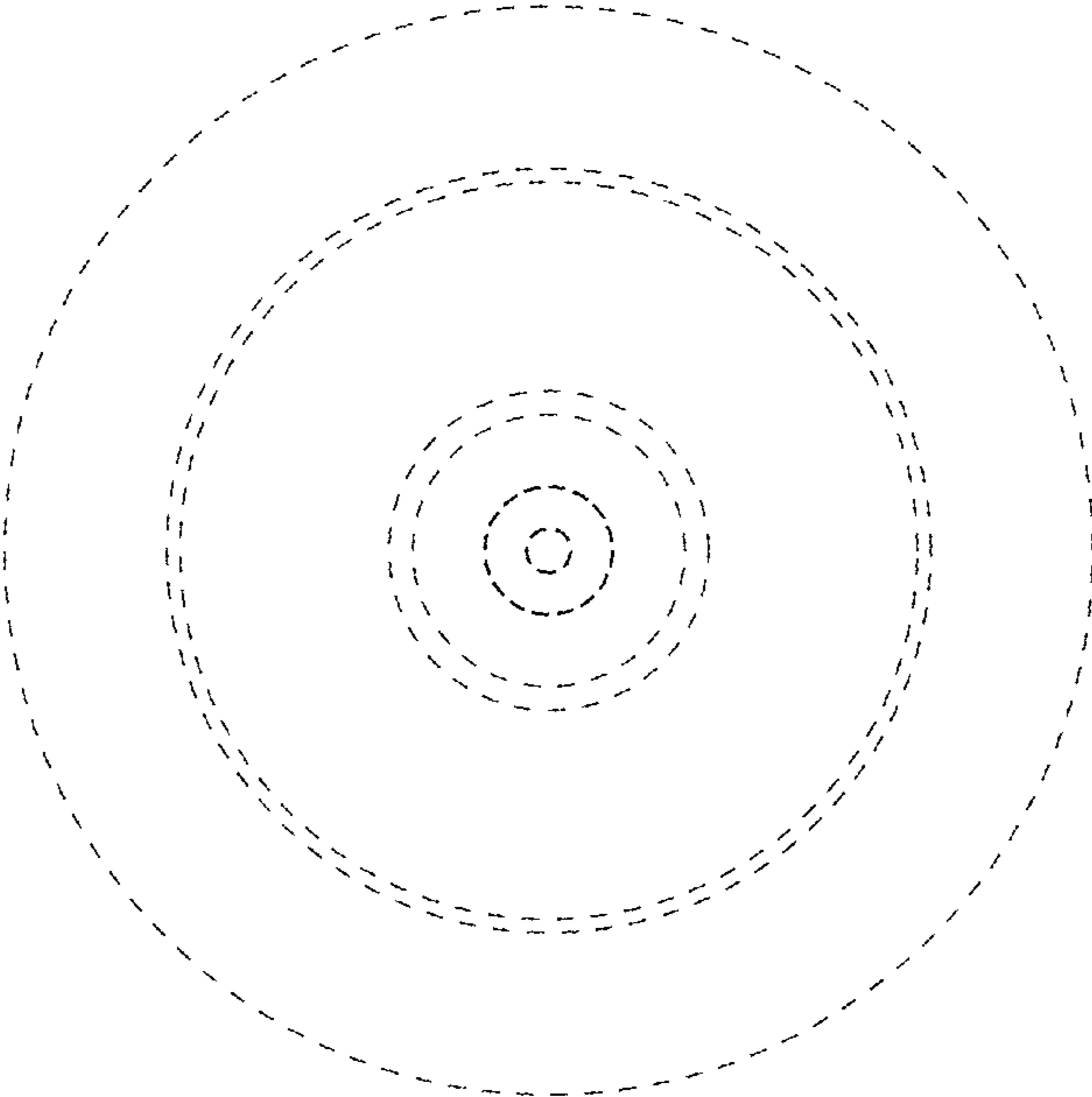
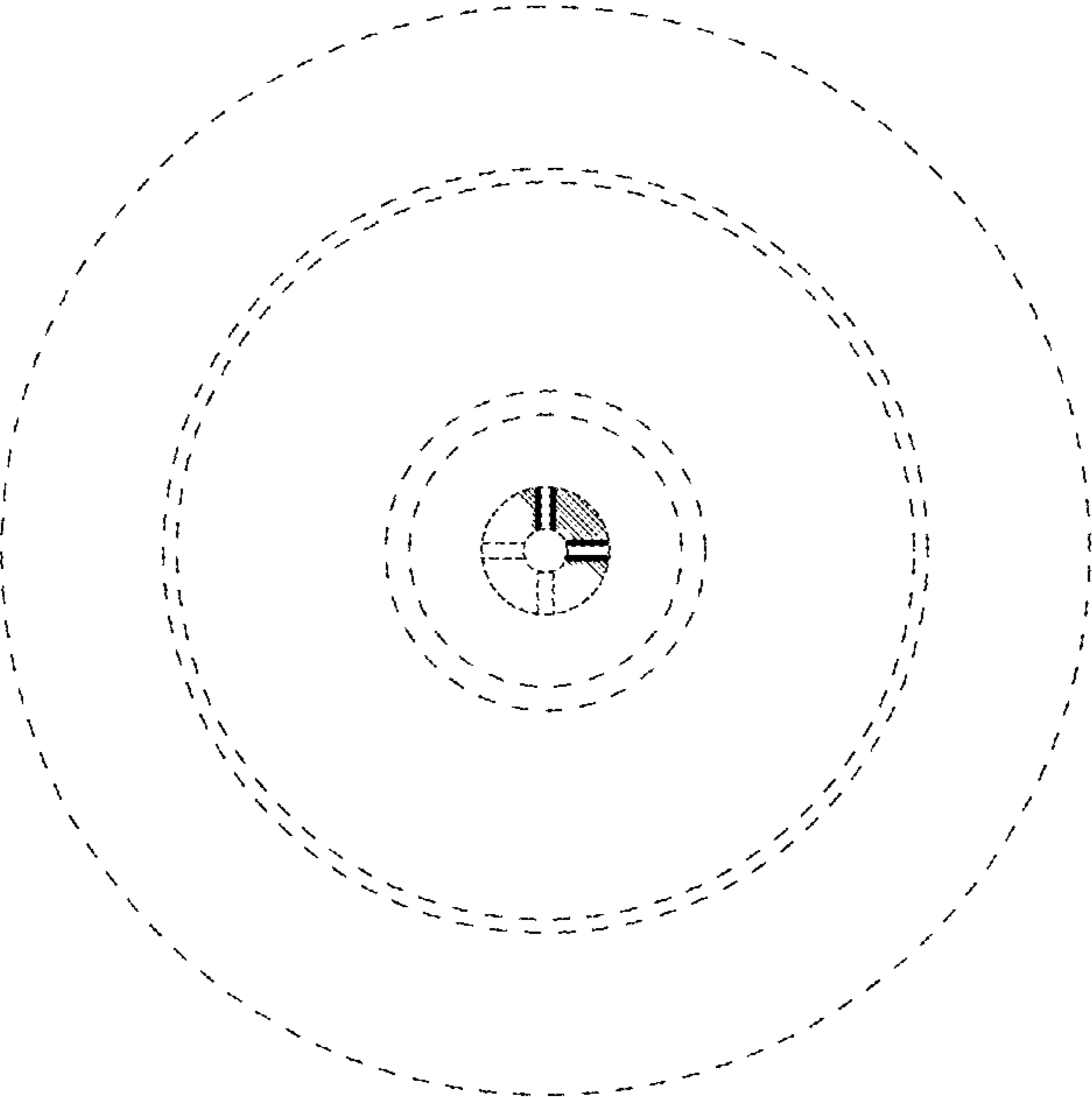

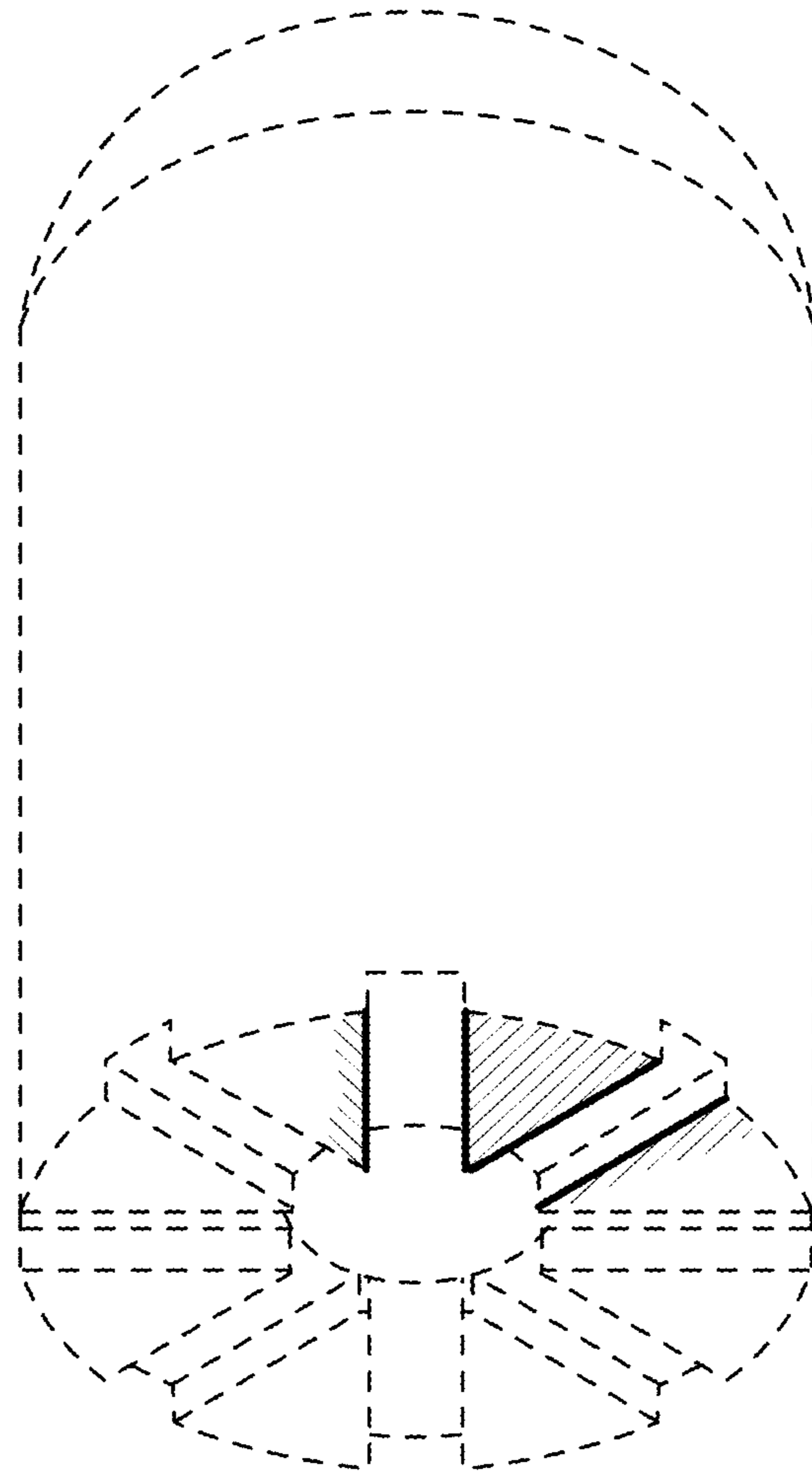

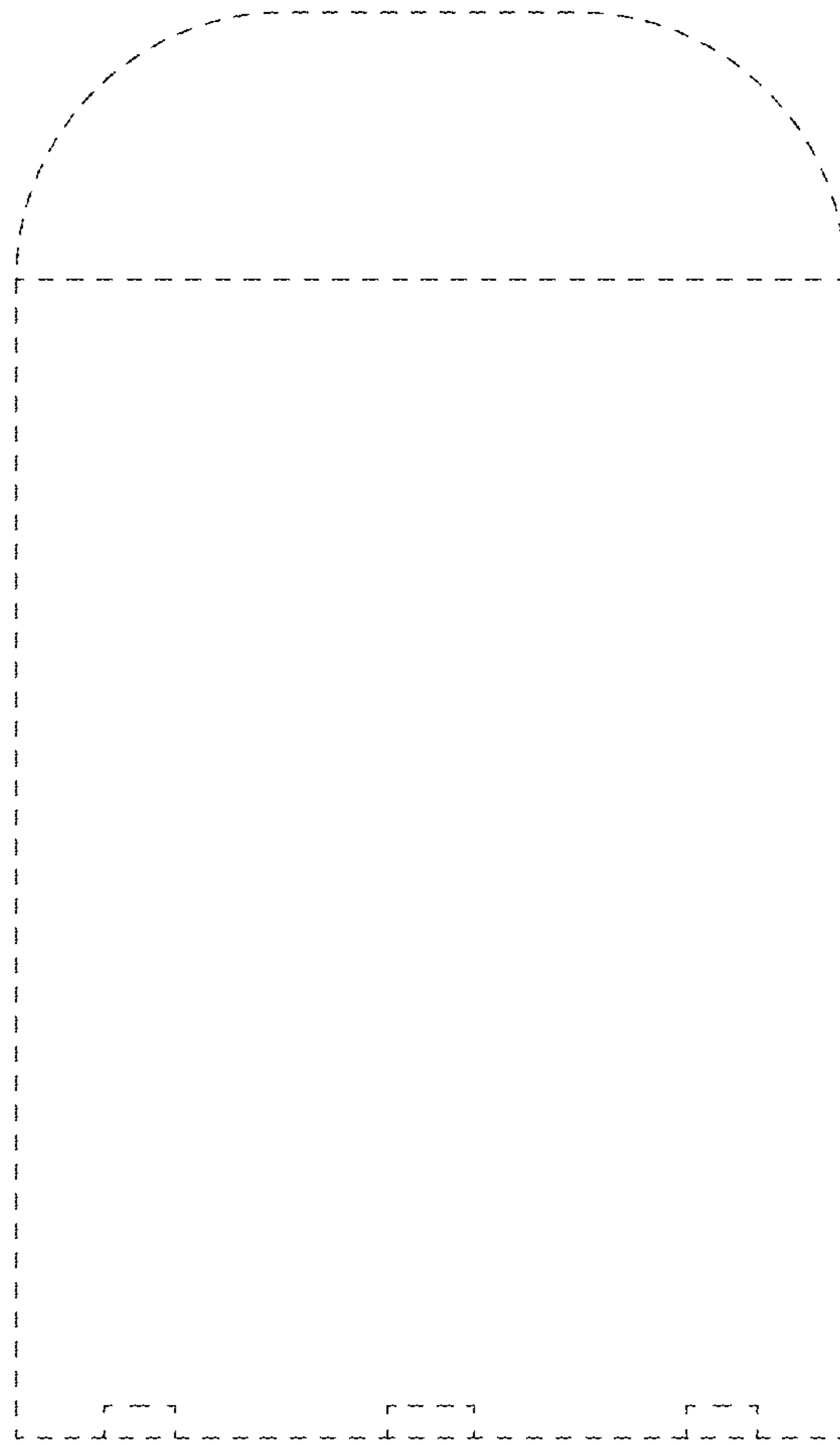

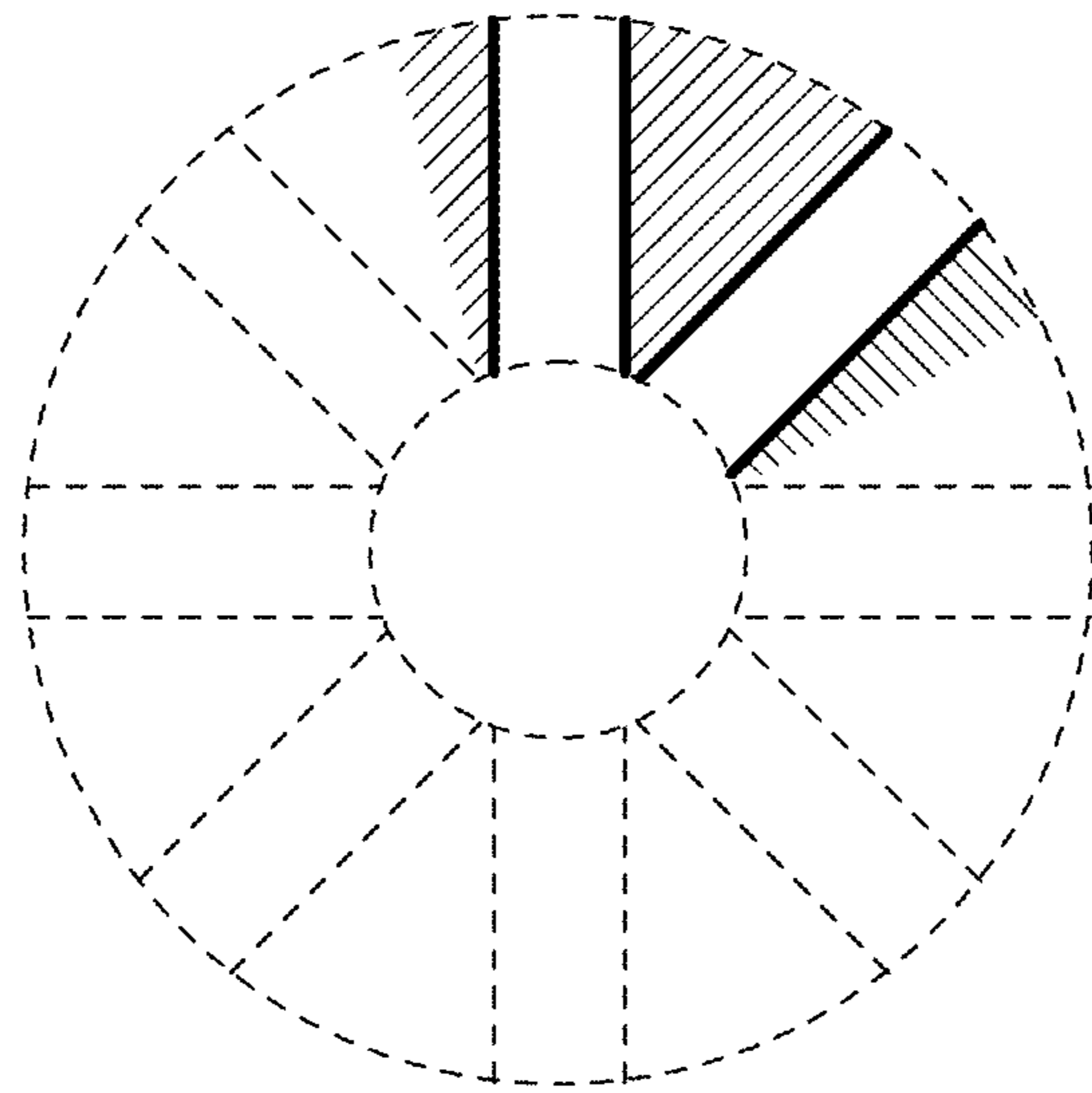

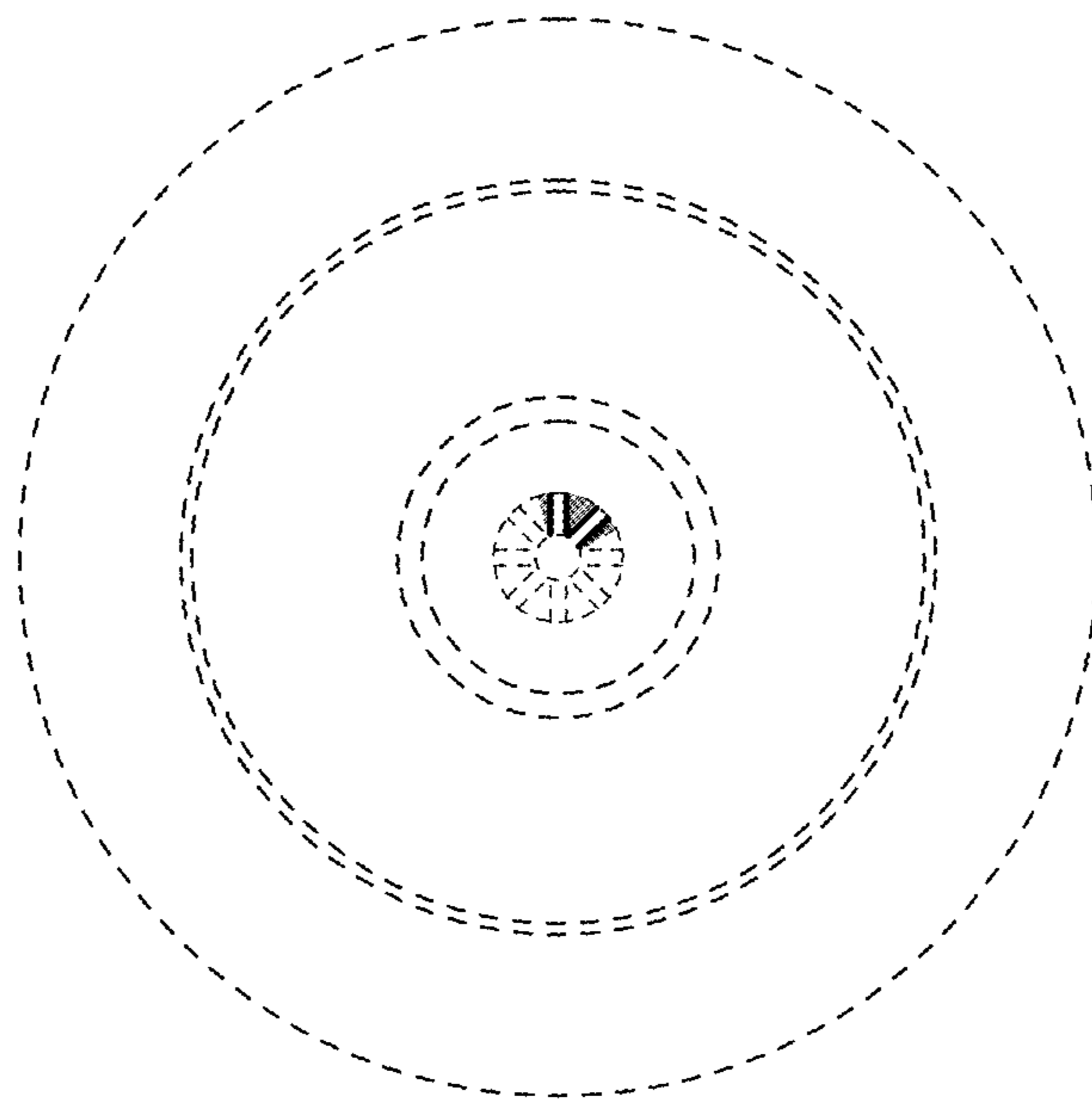

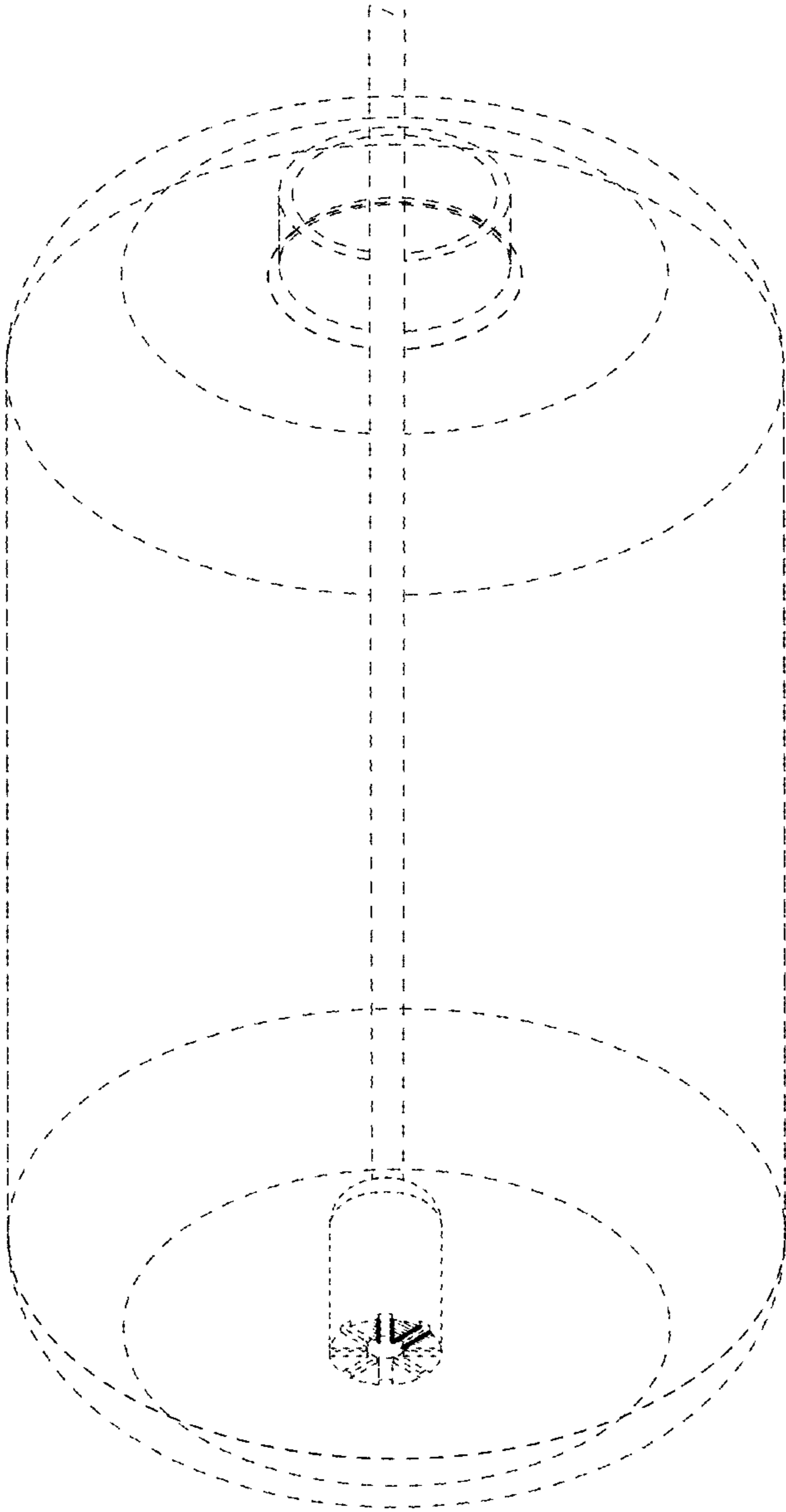

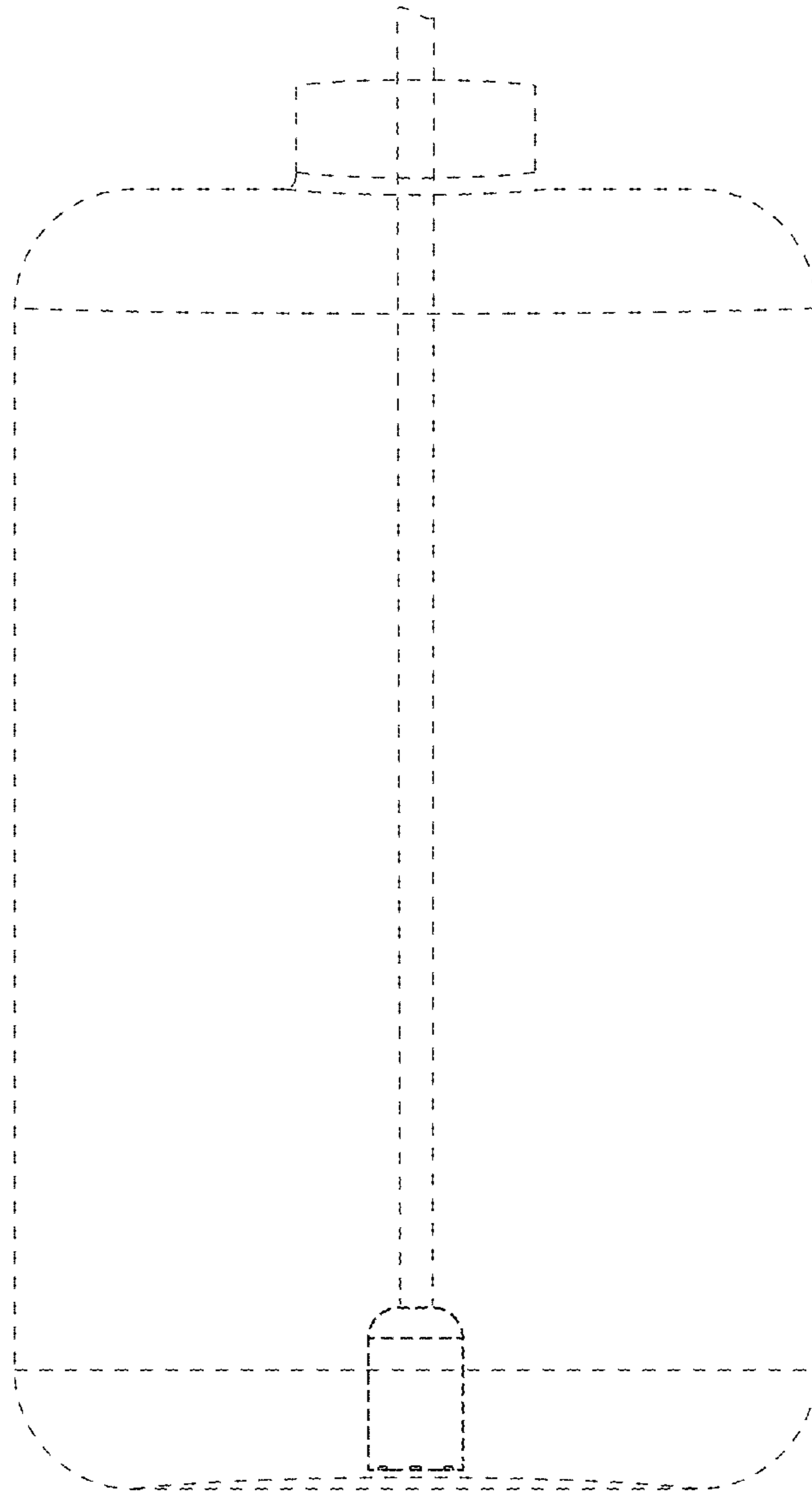

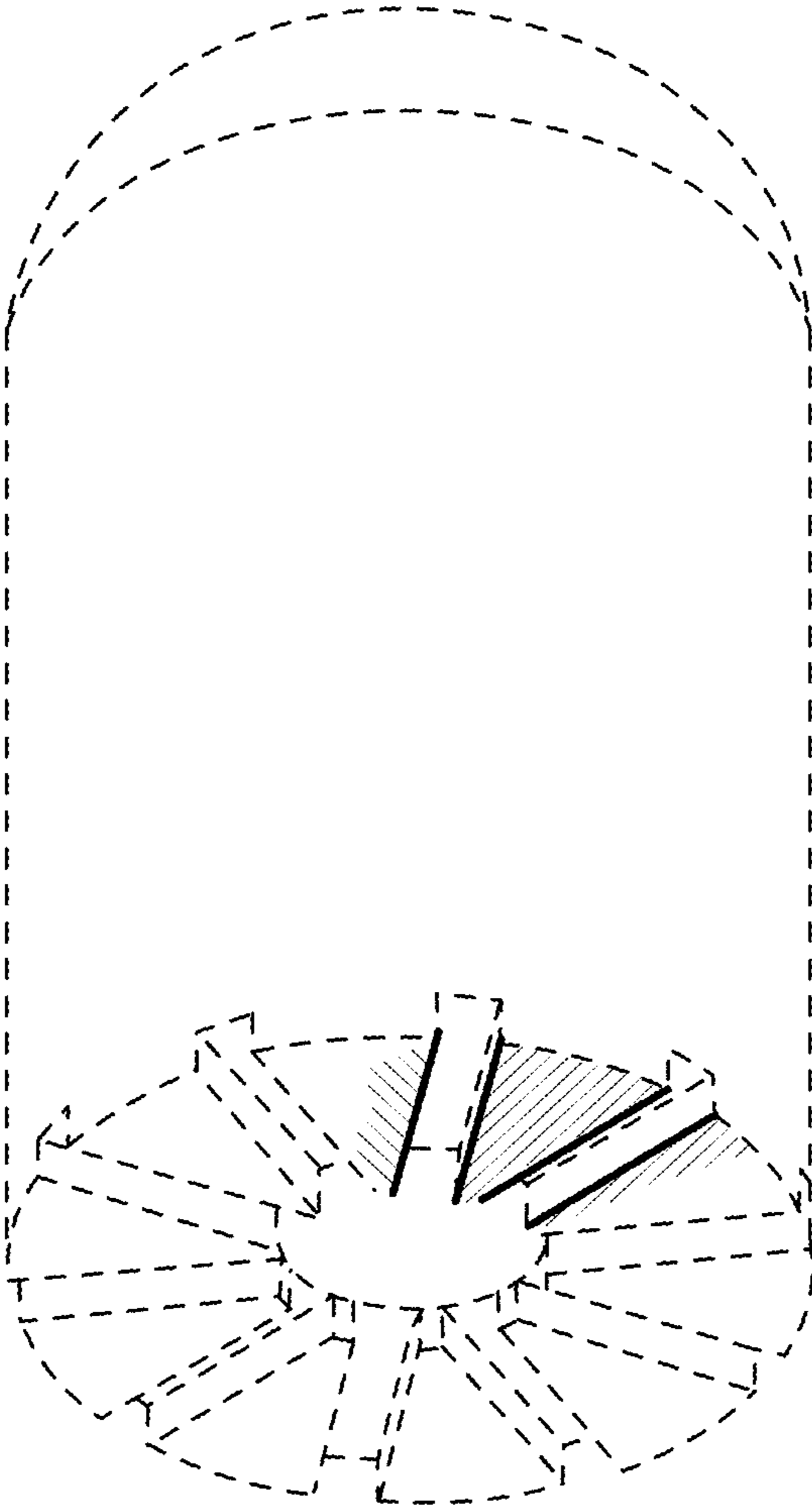

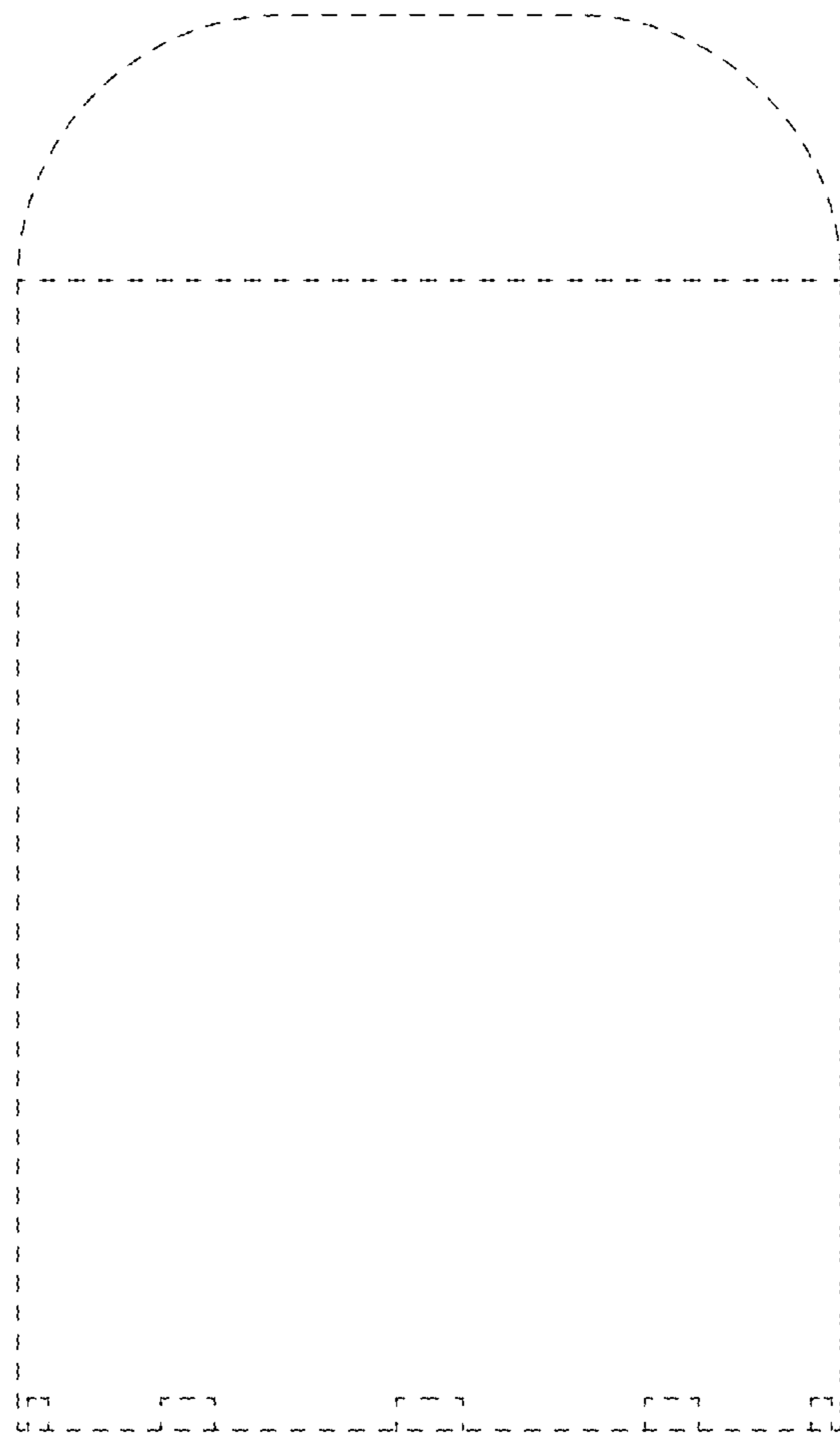

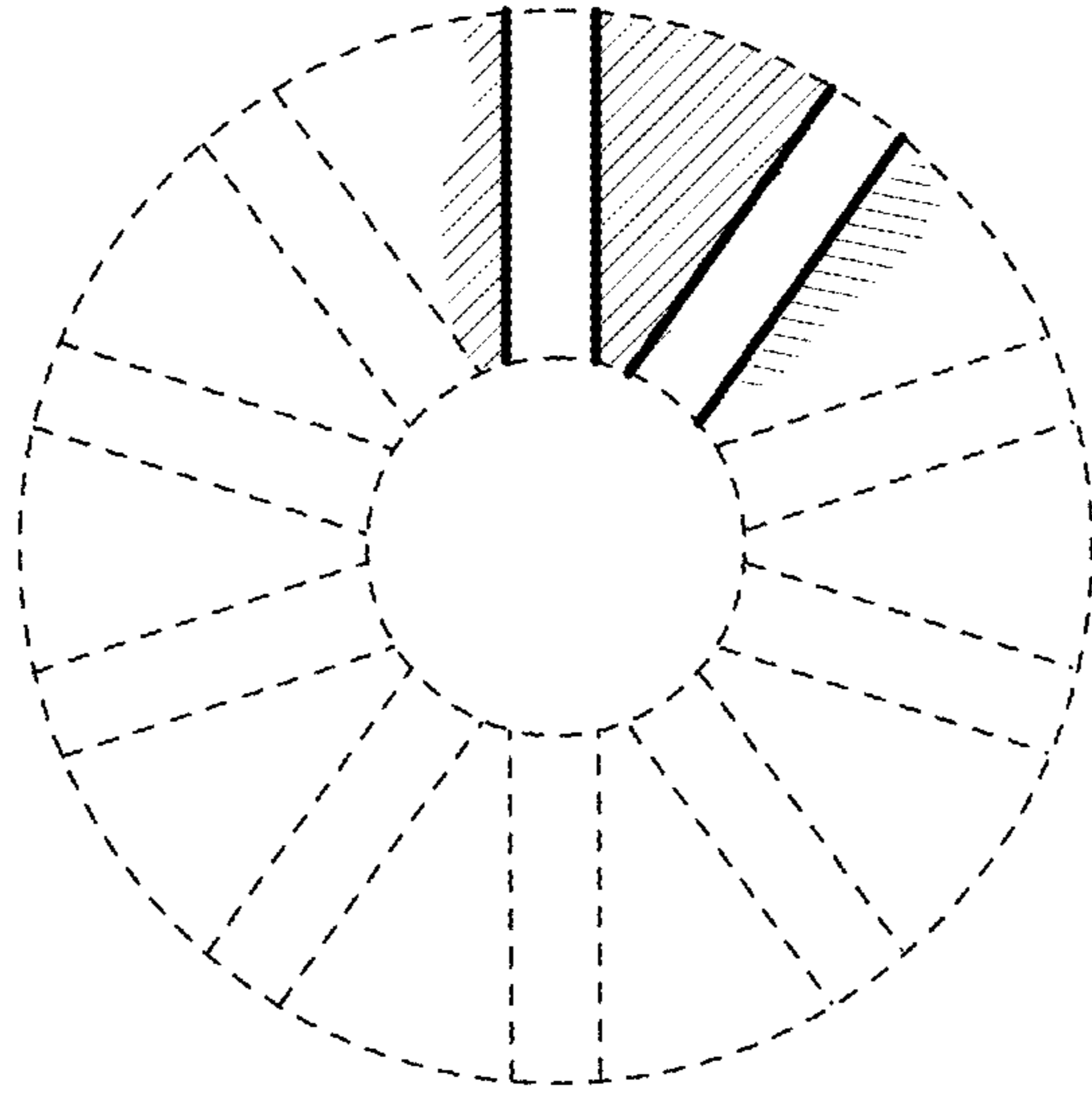

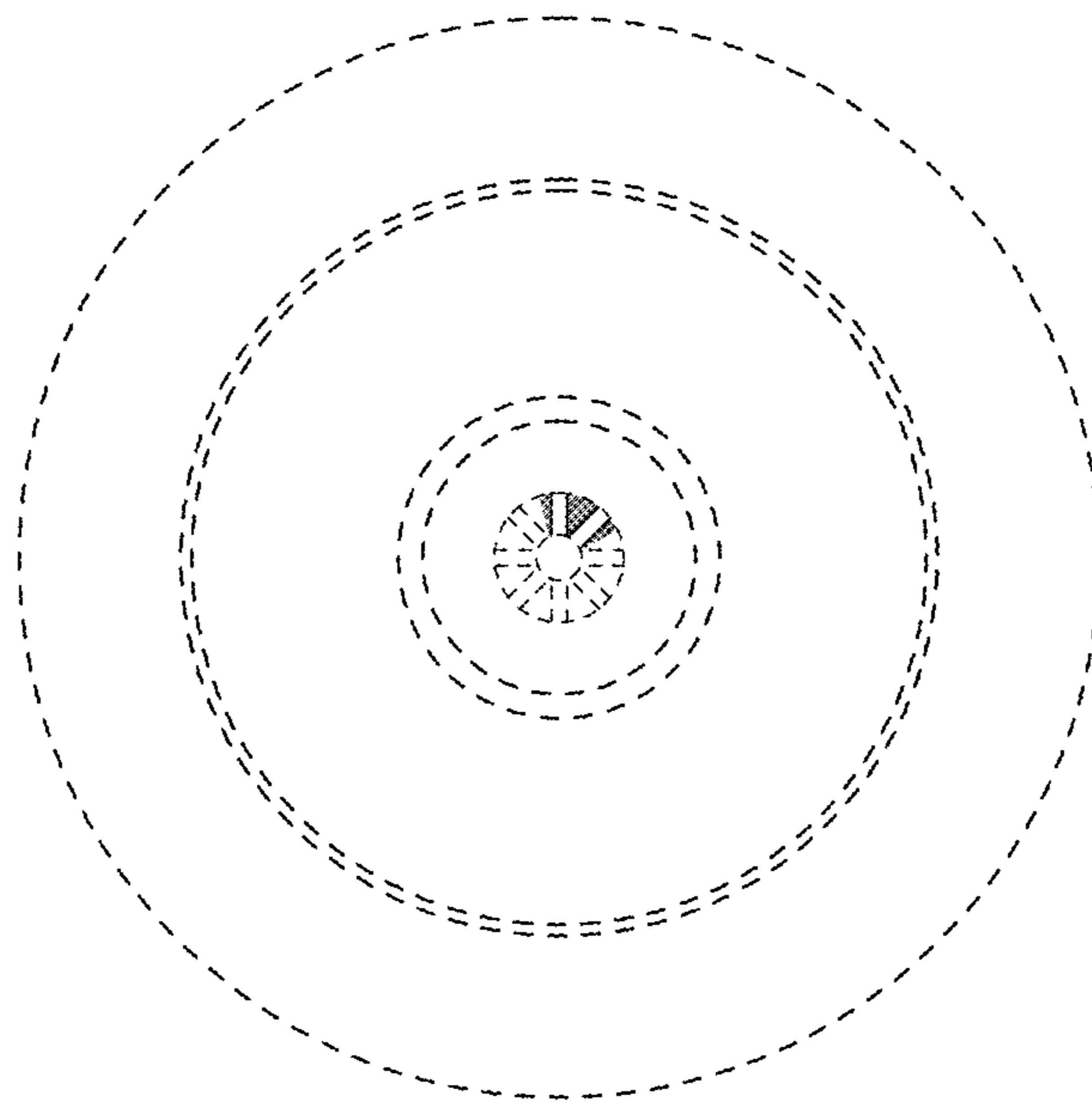

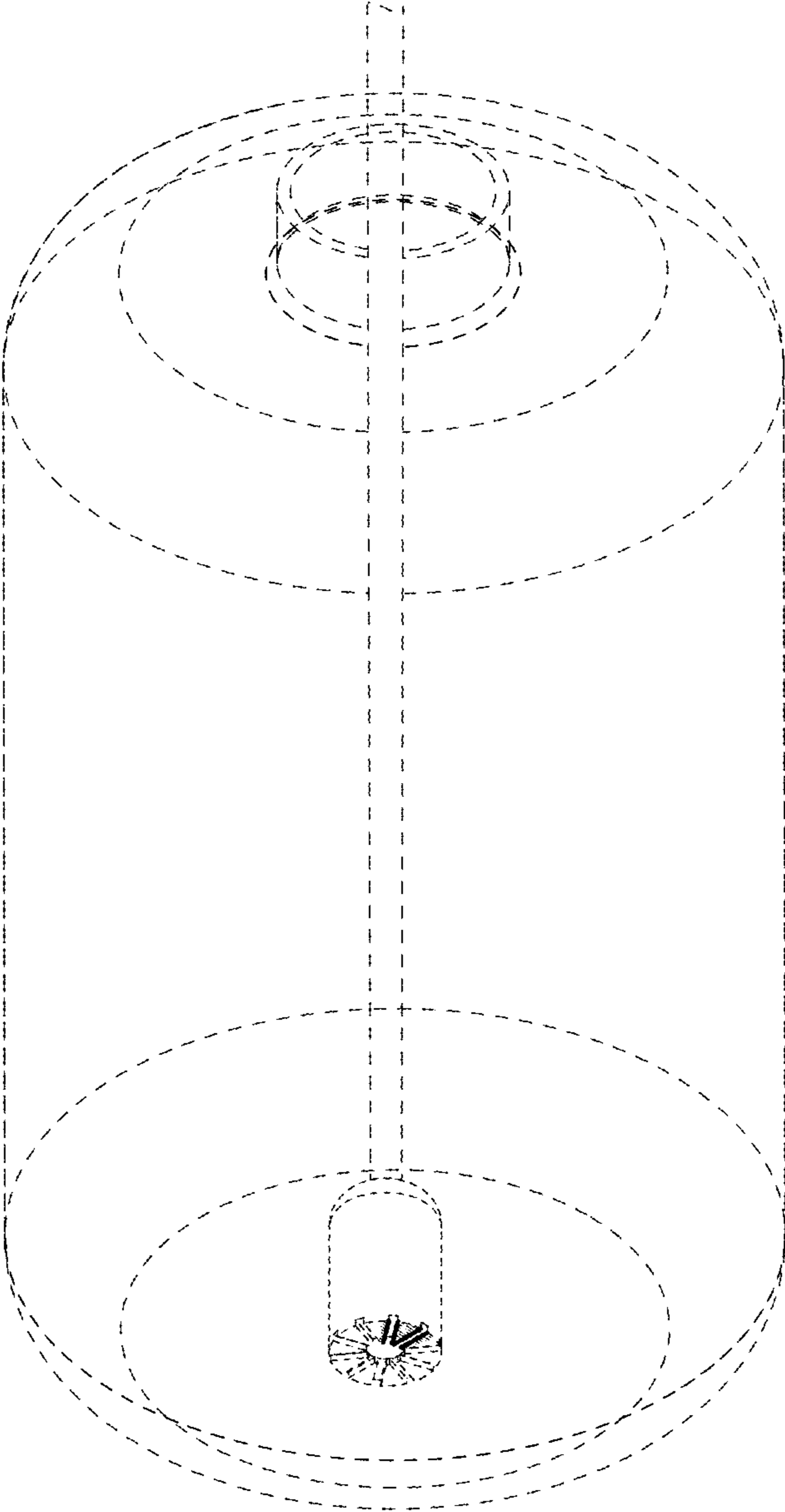
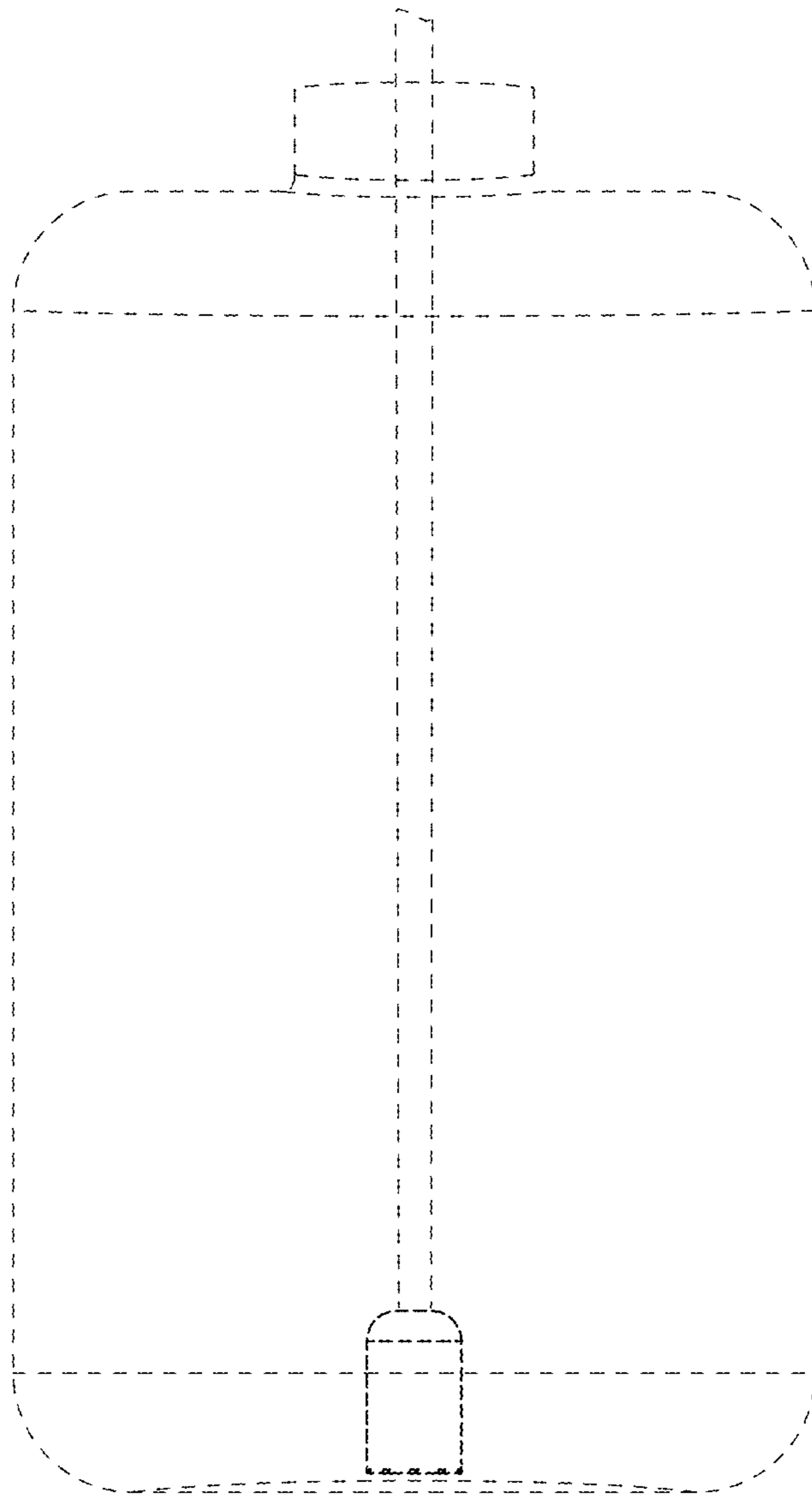
