(57) **CLAIM**

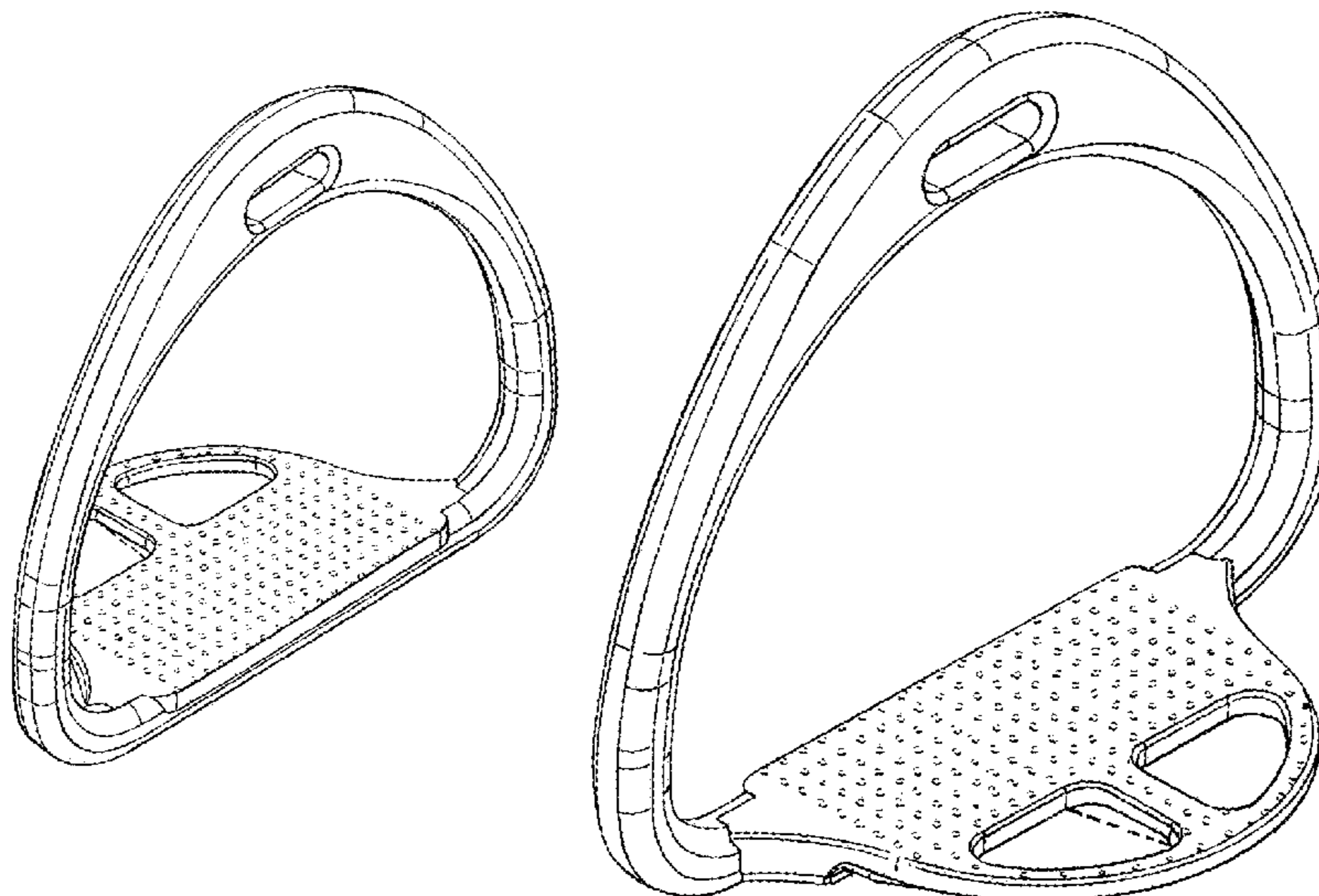
The ornamental design for a stirrup, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view, taken from the front, top, and right side, of a stirrup, in accordance with my new design; FIG. 2 is a front elevation view of the stirrup shown in FIG. 1; FIG. 3 is a rear elevation view of the stirrup shown in FIG. 1; FIG. 4 is a side elevation view of the stirrup shown in FIG. 1, taken from the right side of FIG. 1; FIG. 5 is a side elevation view of the stirrup shown in FIG. 1, taken from the left side of FIG. 1; FIG. 6 is a top plan view of the stirrup shown in FIG. 1; FIG. 7 is a bottom plan view of the stirrup shown in FIG. 1; and, FIG. 8 is a perspective view, taken from the rear, top, and left side, of the stirrup shown in FIG. 1.

The broken lines in the figures illustrate portions of the article that form no part of the claimed design. The broken line showing of textured surface features on the top of the stirrup are for the purpose of illustrating portions of the article and form no part of the claim.

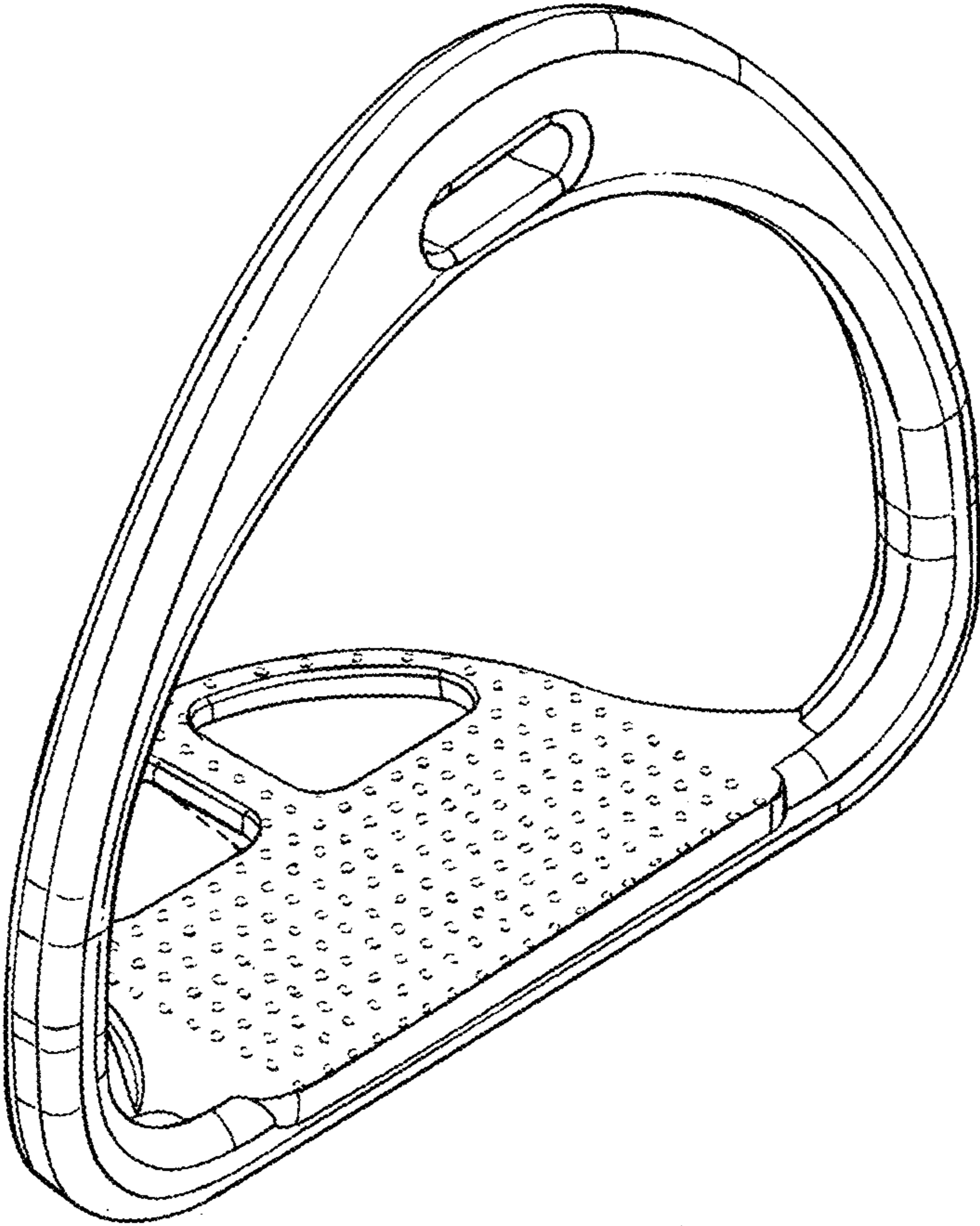

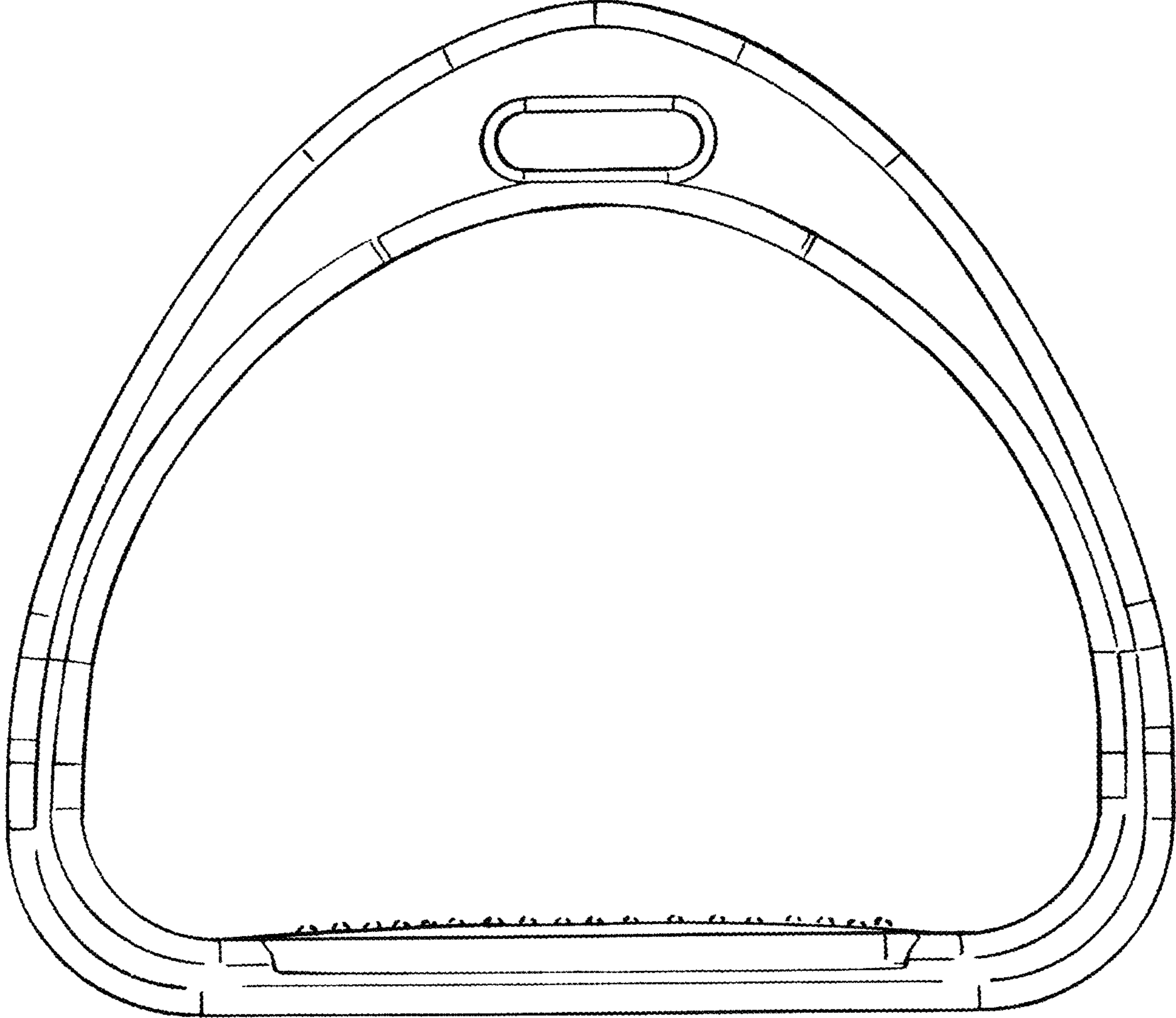

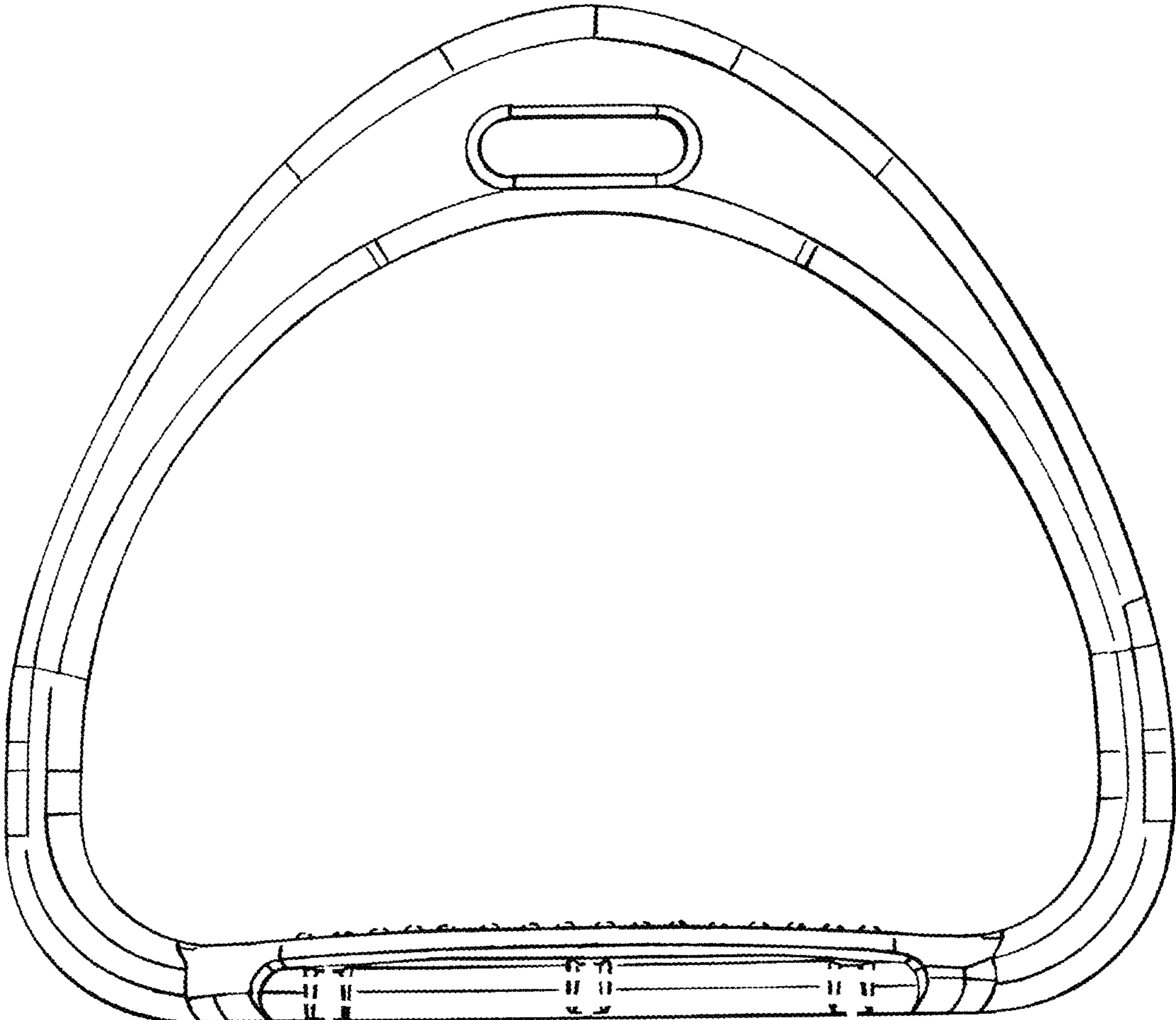

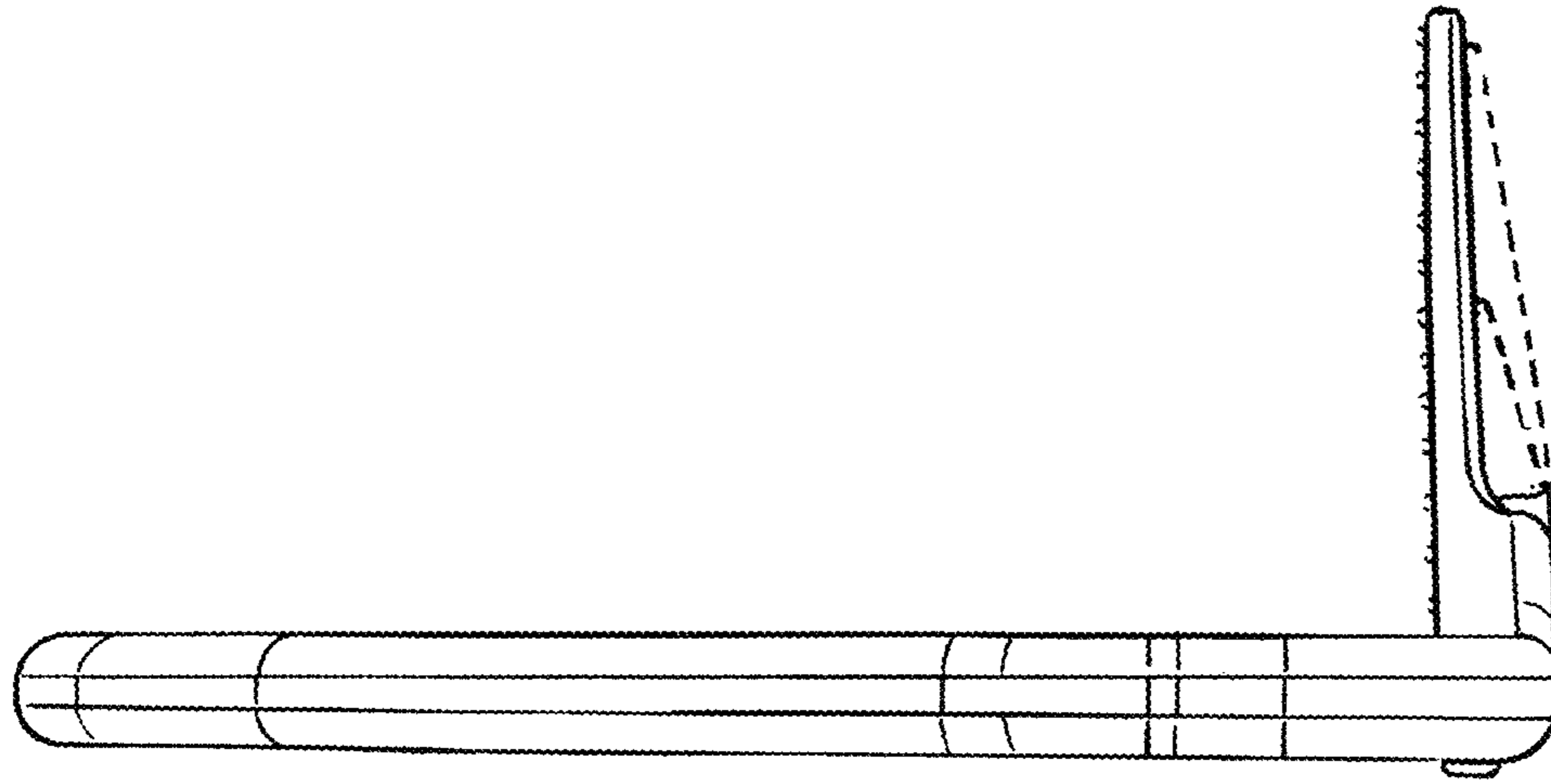

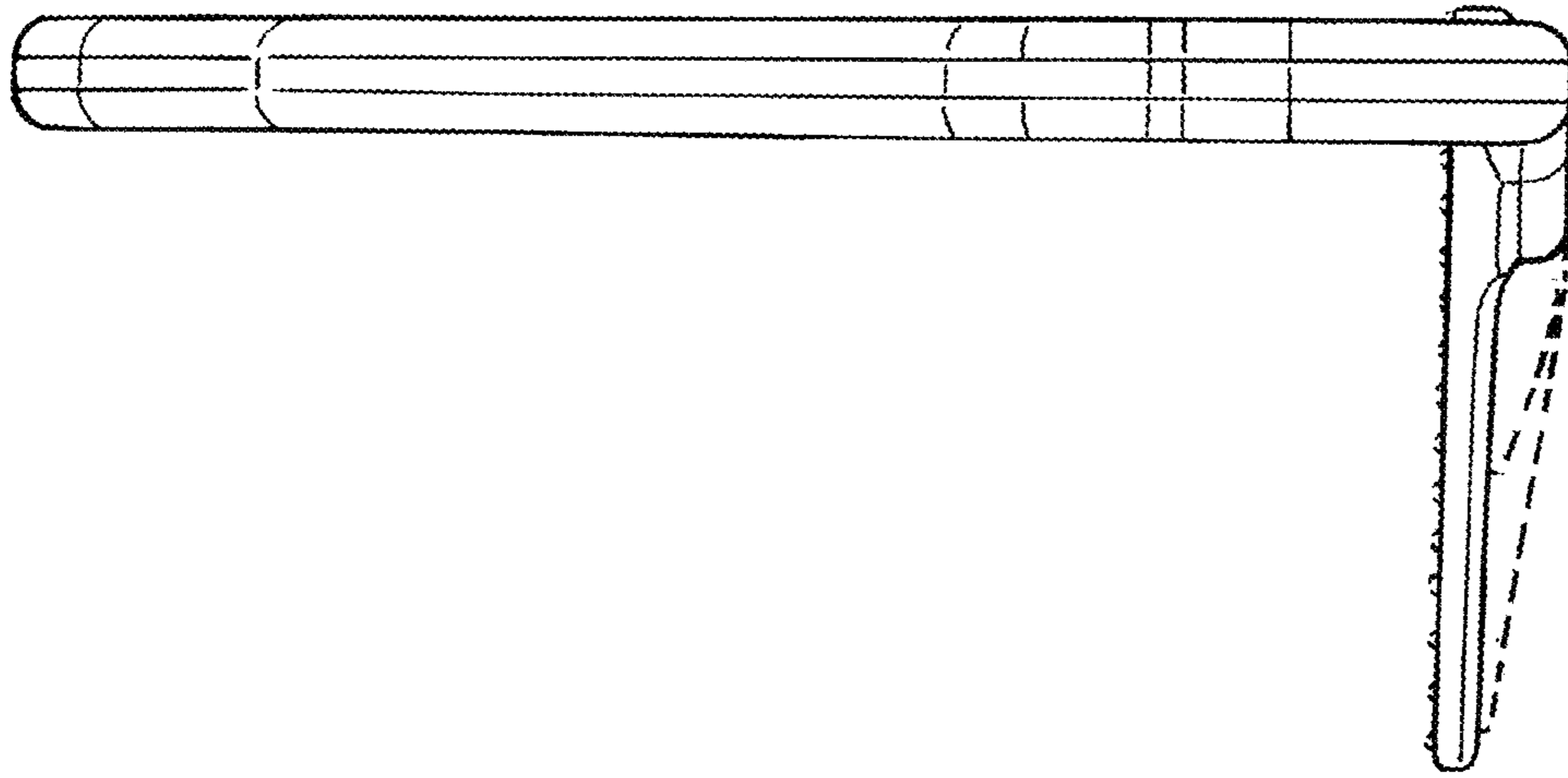

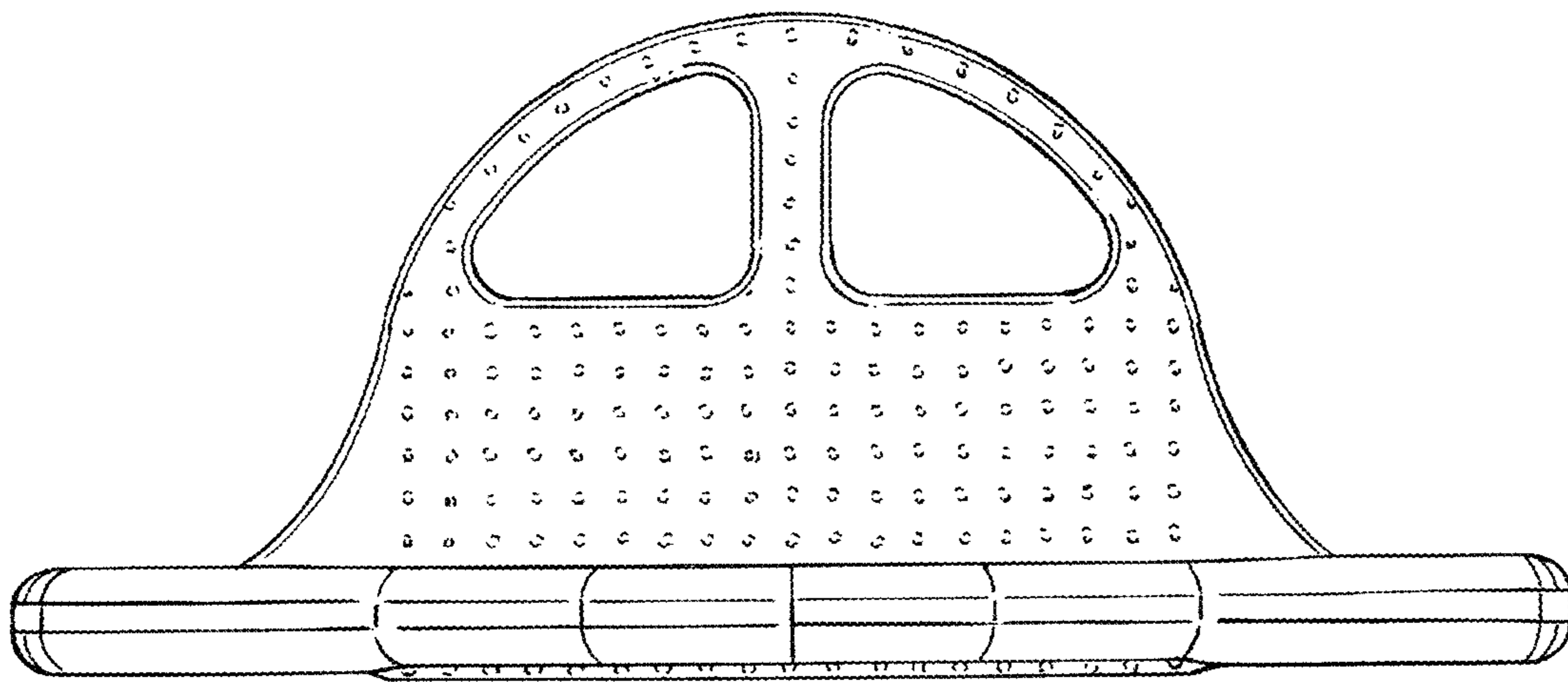

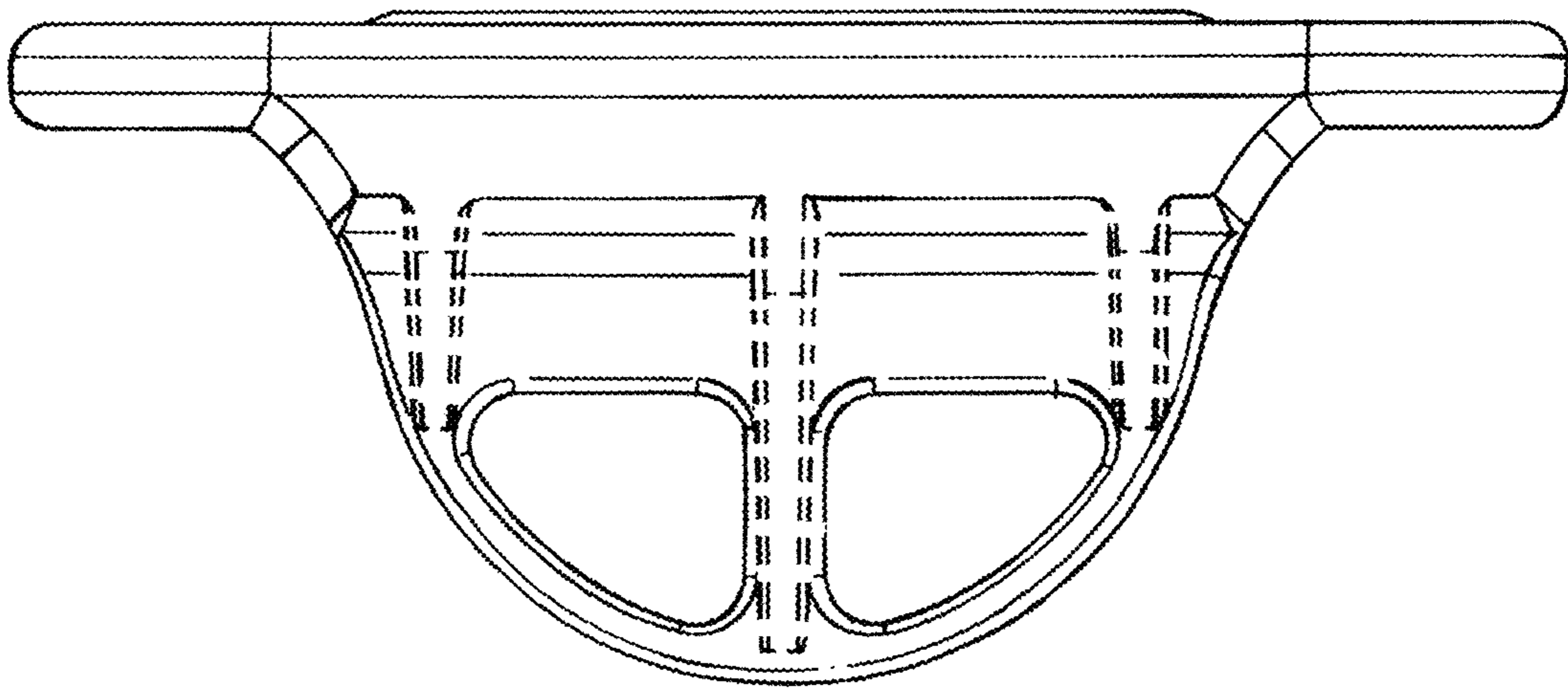

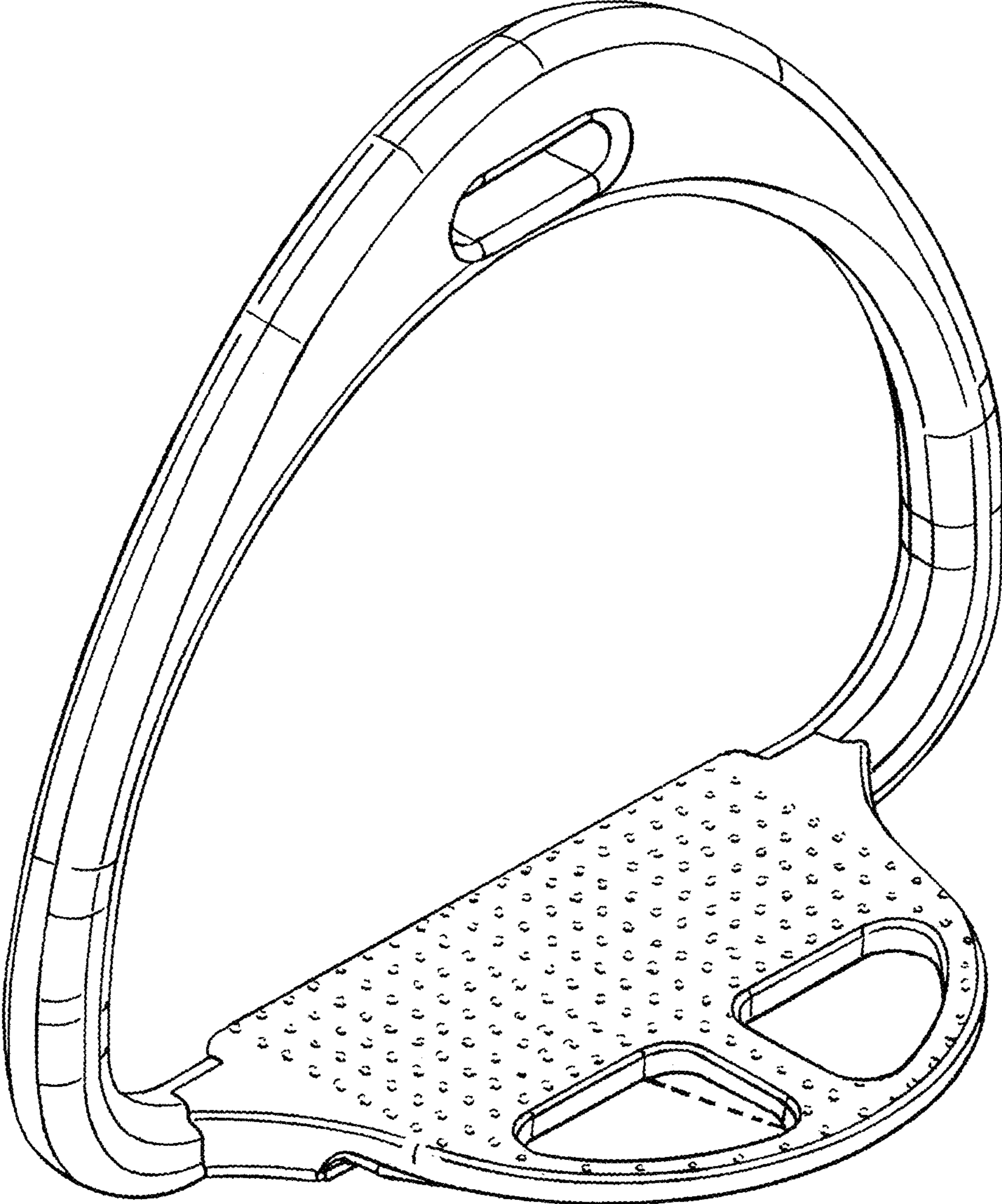
