DESCRIPTION

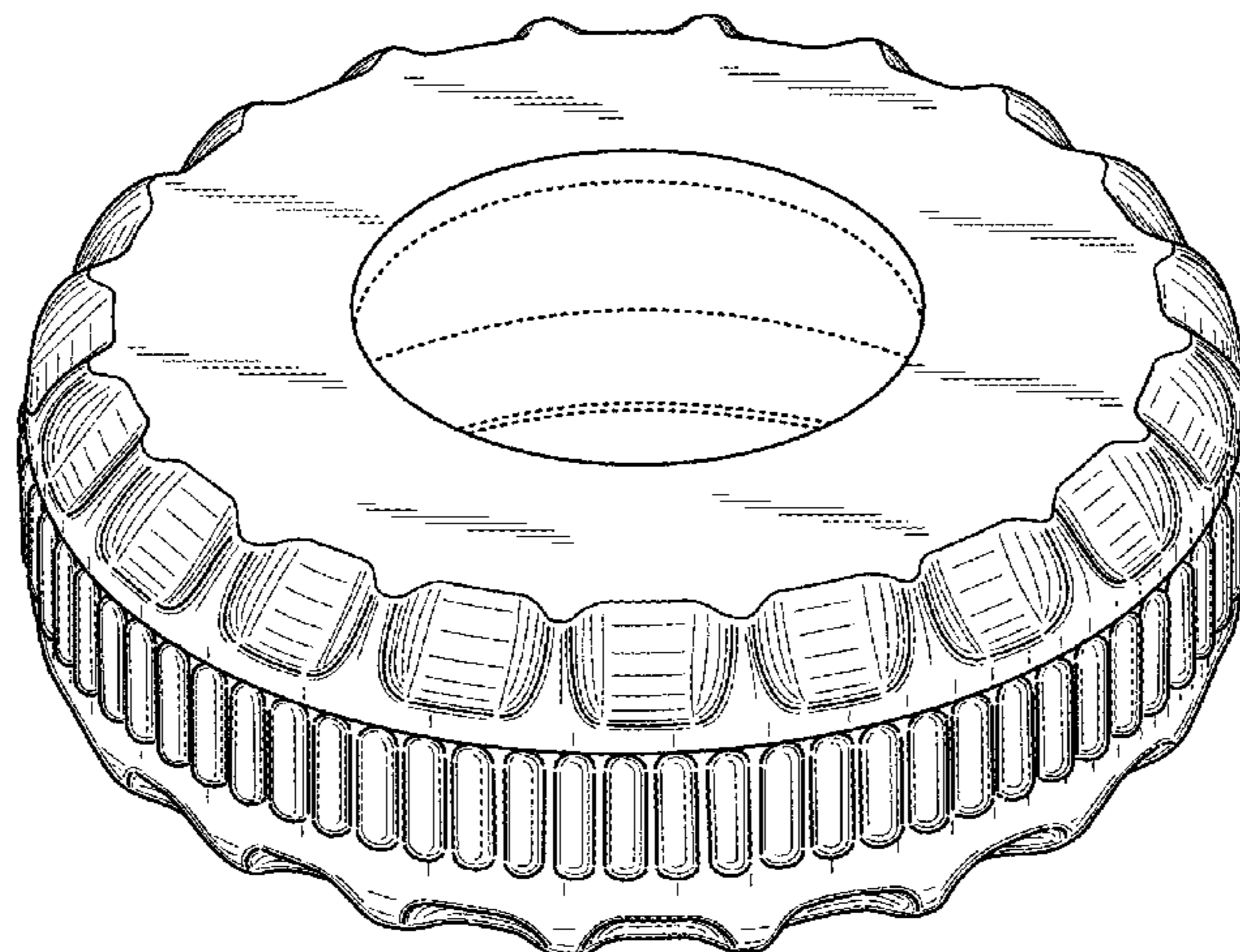
FIG. 1 is a perspective view of a pet treat; FIG. 2 is a top view thereof, where the top view is symmetric with the bottom view; and, FIG. 3 is a side view thereof, where the right side is symmetric with the left side. 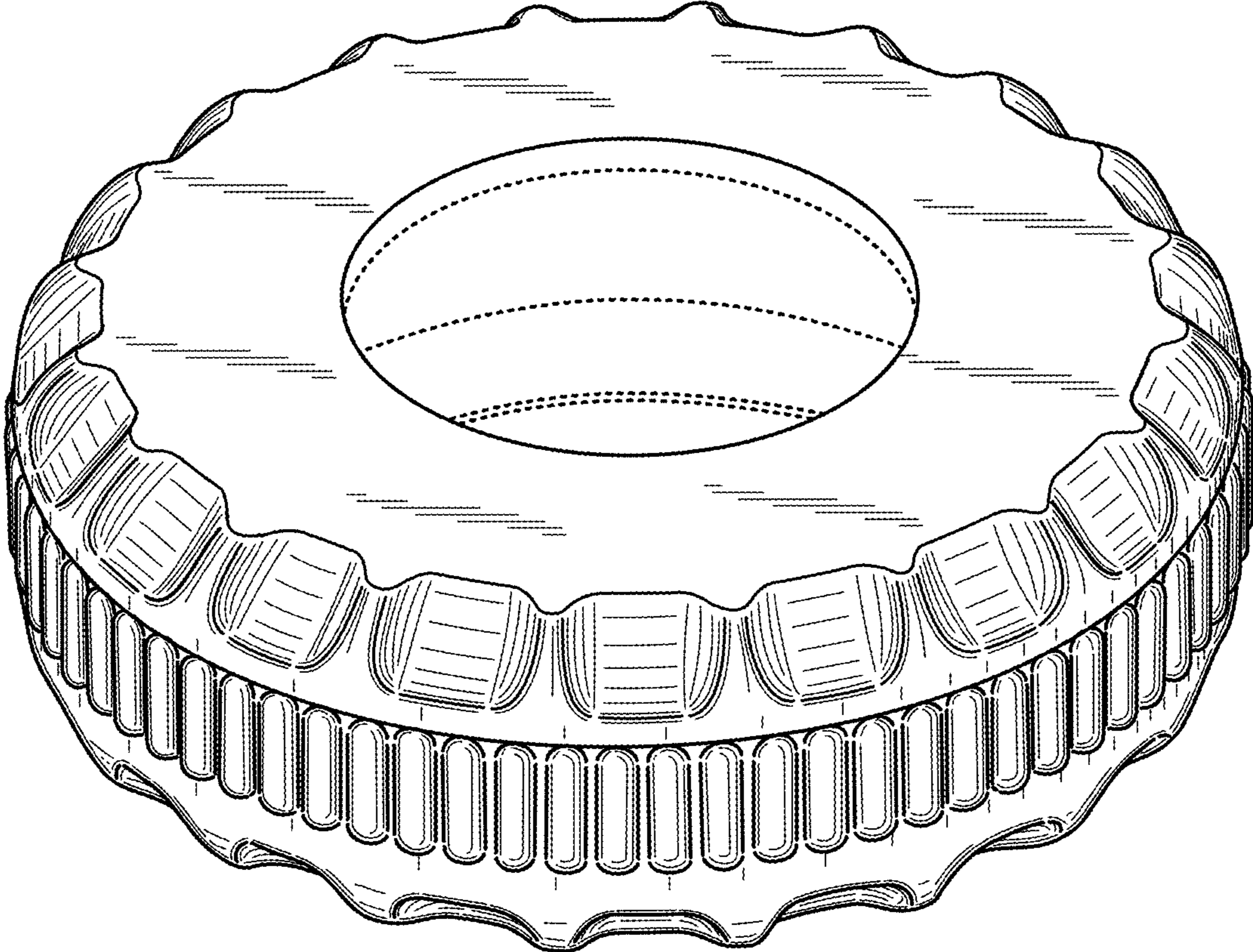

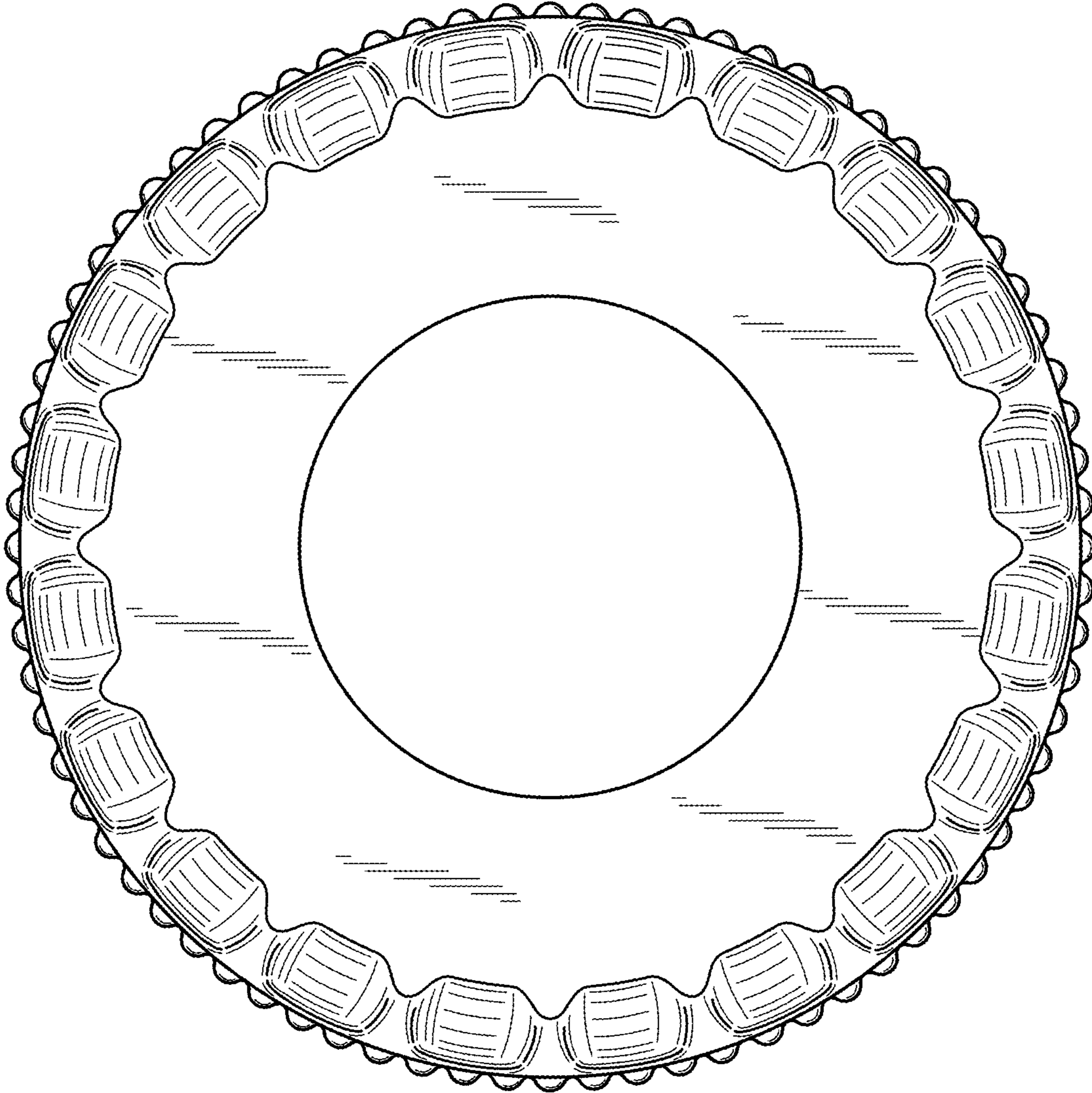

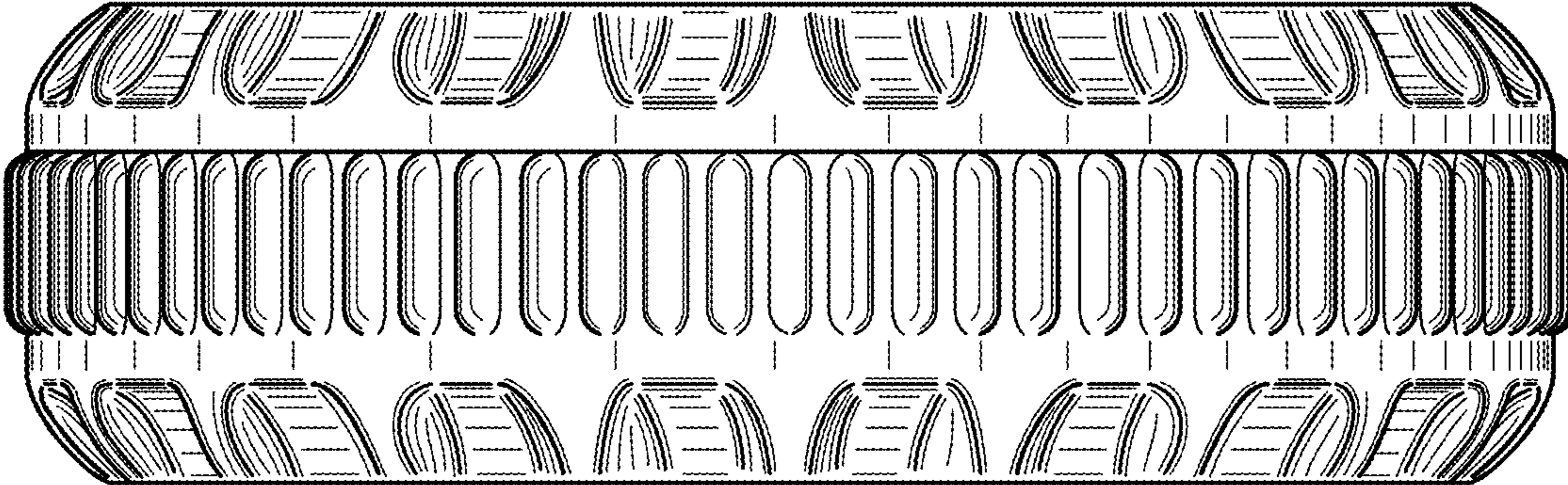
