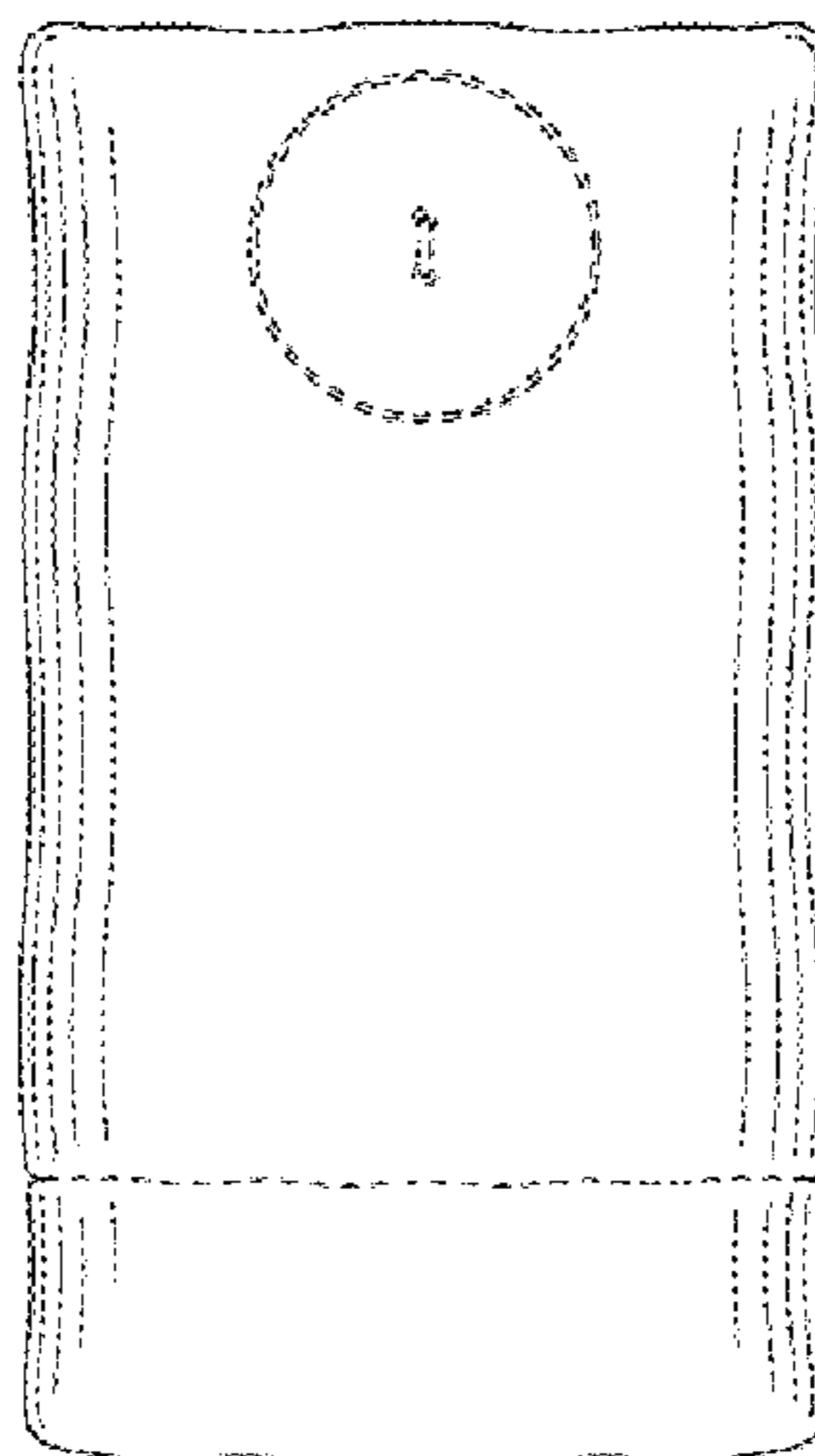

FIG. 1 is a front side view of an absorbent wristband of the  
present invention, showing the new, original, and ornamen-  
tal design;  
FIG. 2 is a rear side view thereof;  
FIG. 3 is a right side view thereof, the left side being a mirror  
image;  
FIG. 4 is a top plan view thereof; and,  
FIG. 5 is a bottom plan view thereof.  
The broken lines shown in the drawings are included for the  
purpose of illustrating unclaimed portions of the absorbent  
wristband and environmental structure, and form no part of  
the claimed design.

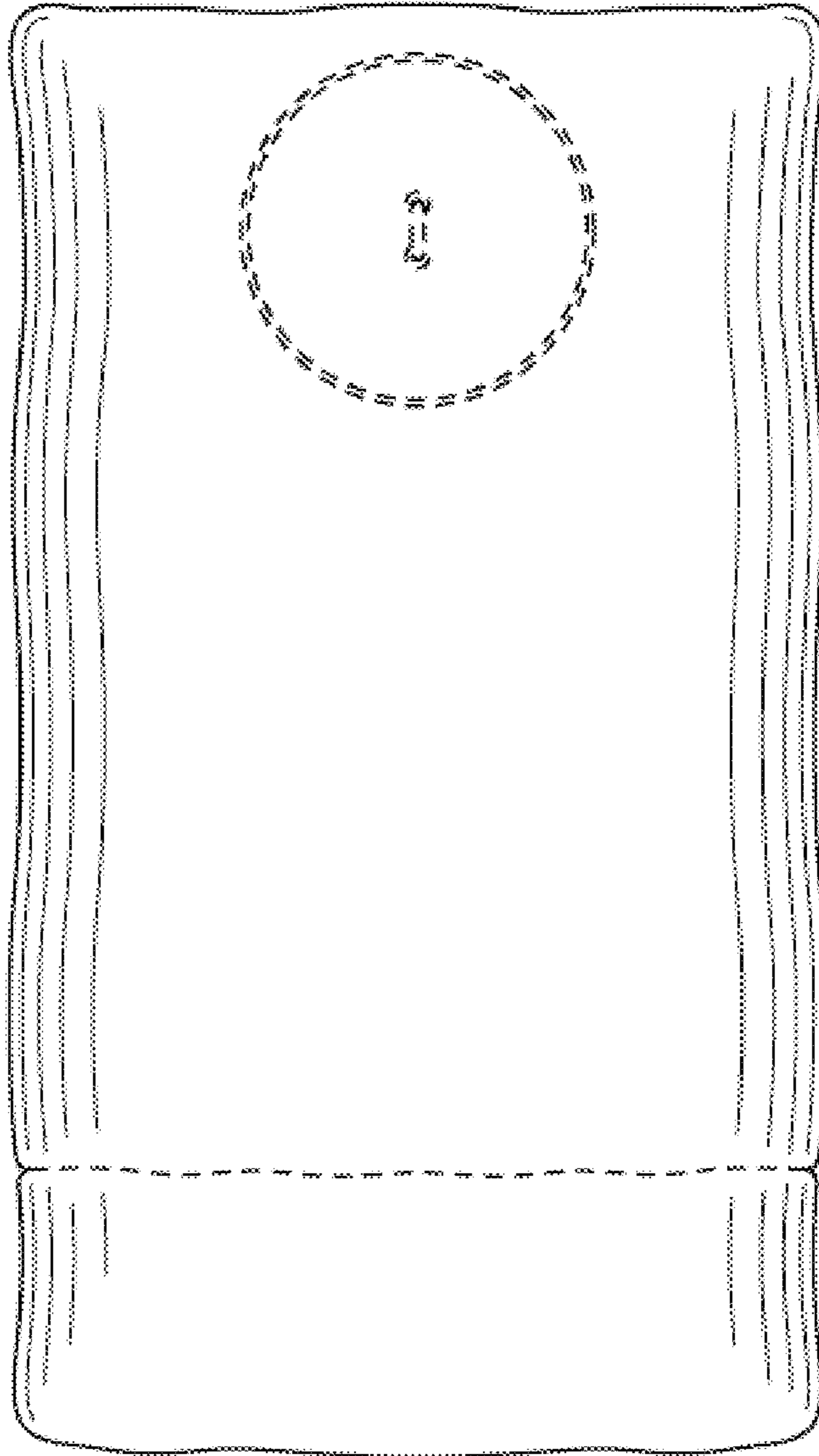
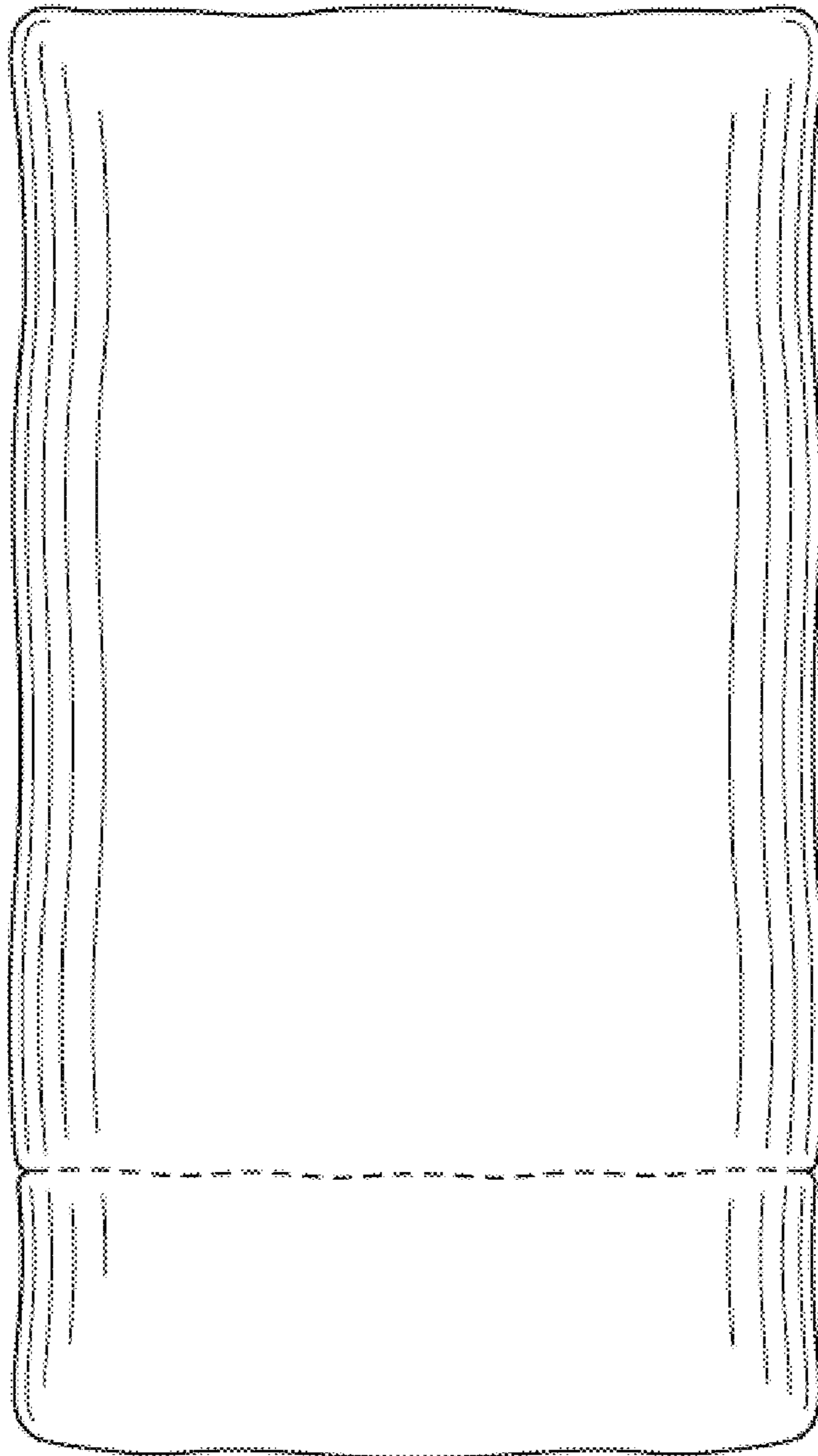
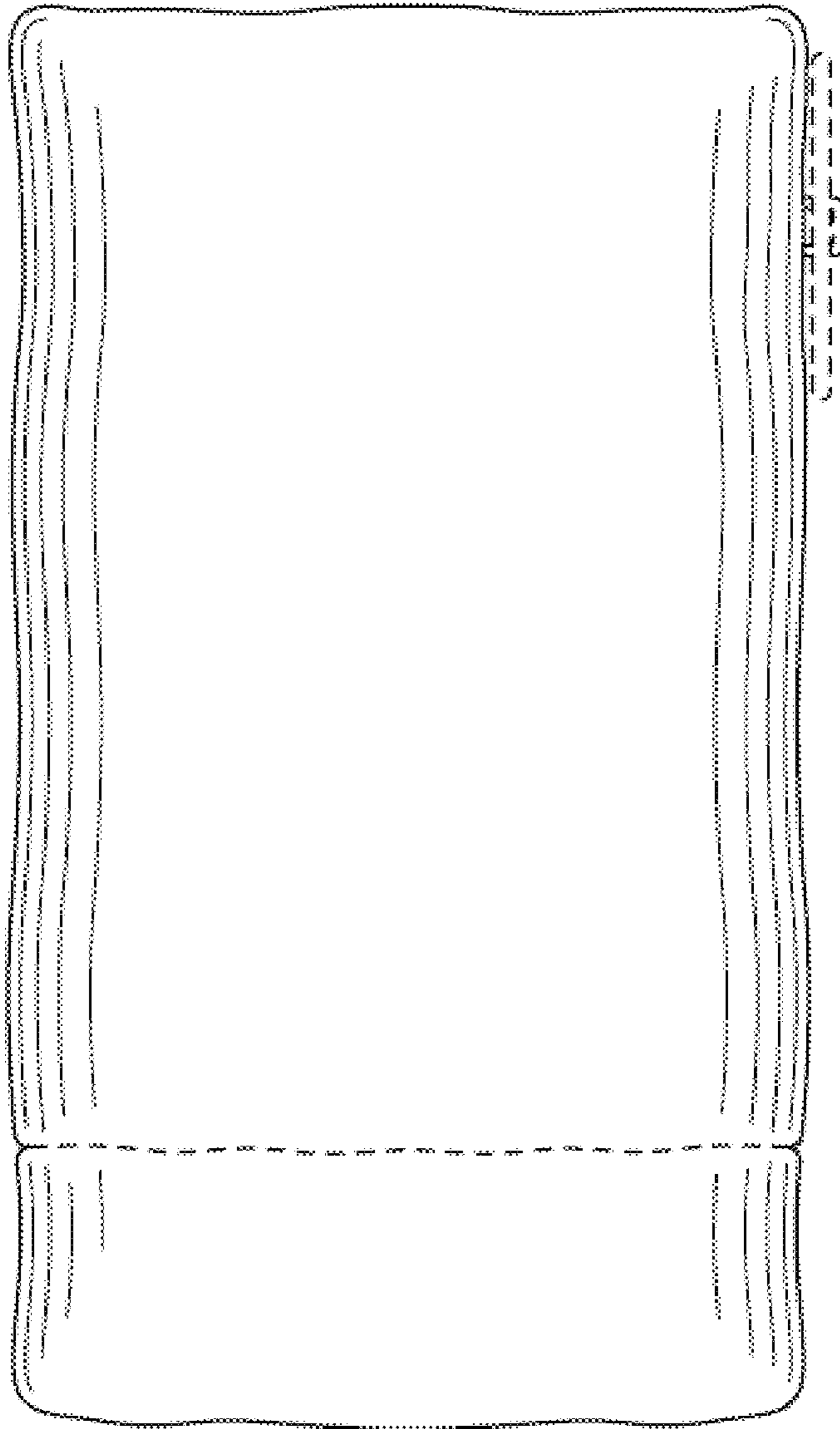

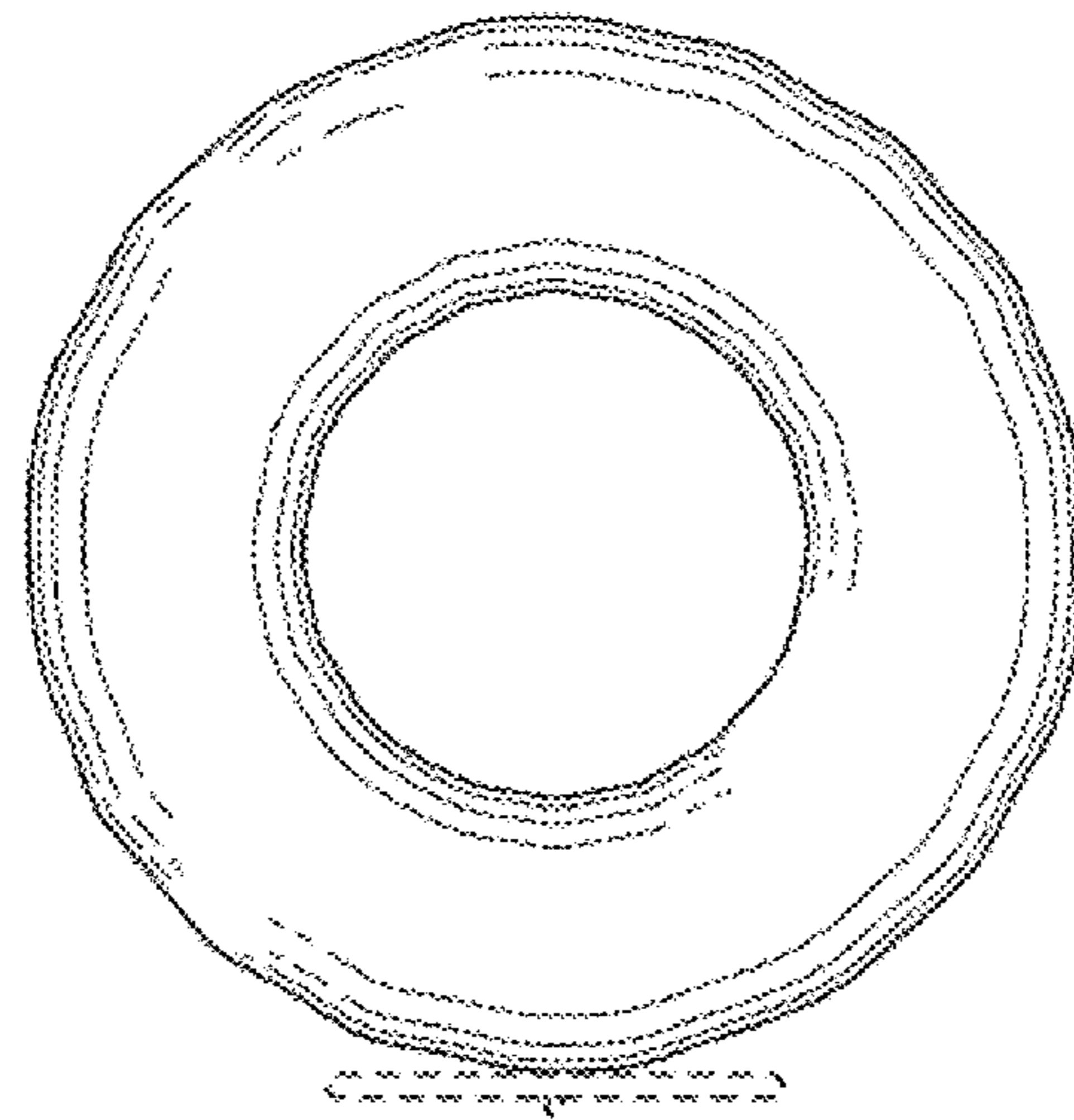

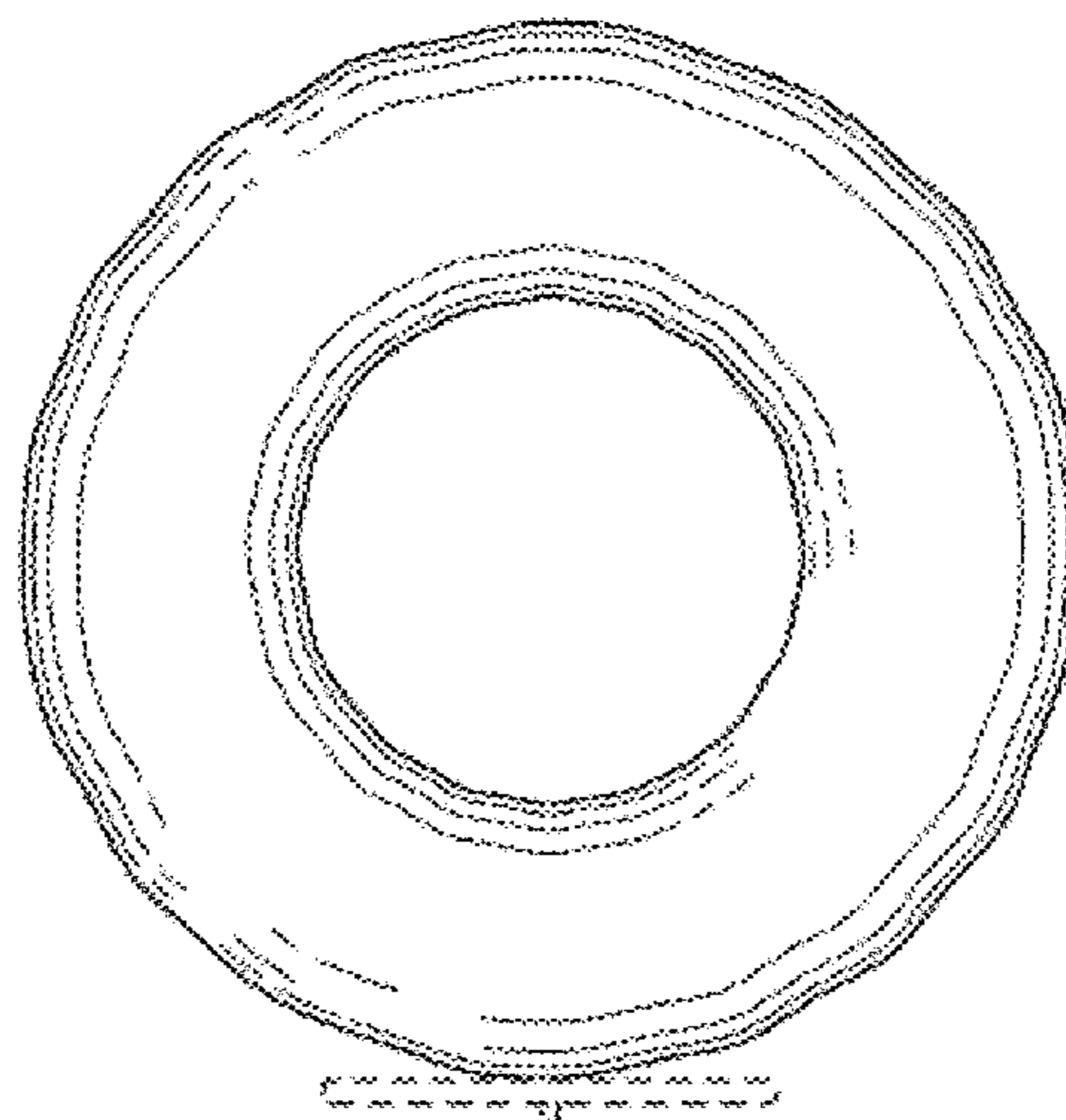
