FIG. 4 is a top plan view thereof.

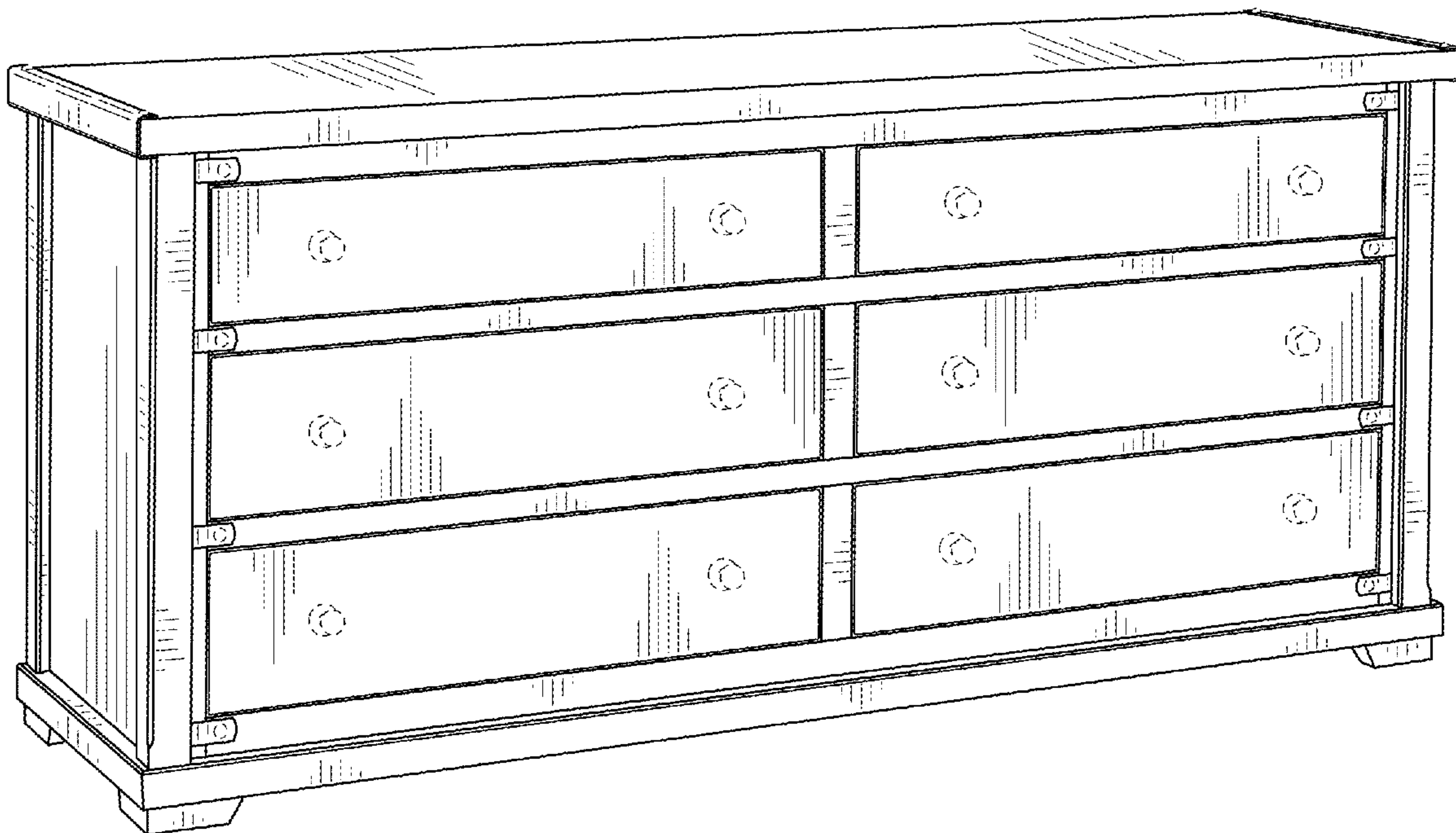
The broken lines in the figures illustrate portions of the dresser that form no part of the claimed design. Views of the dresser not shown in the figures form no part of the claimed design.

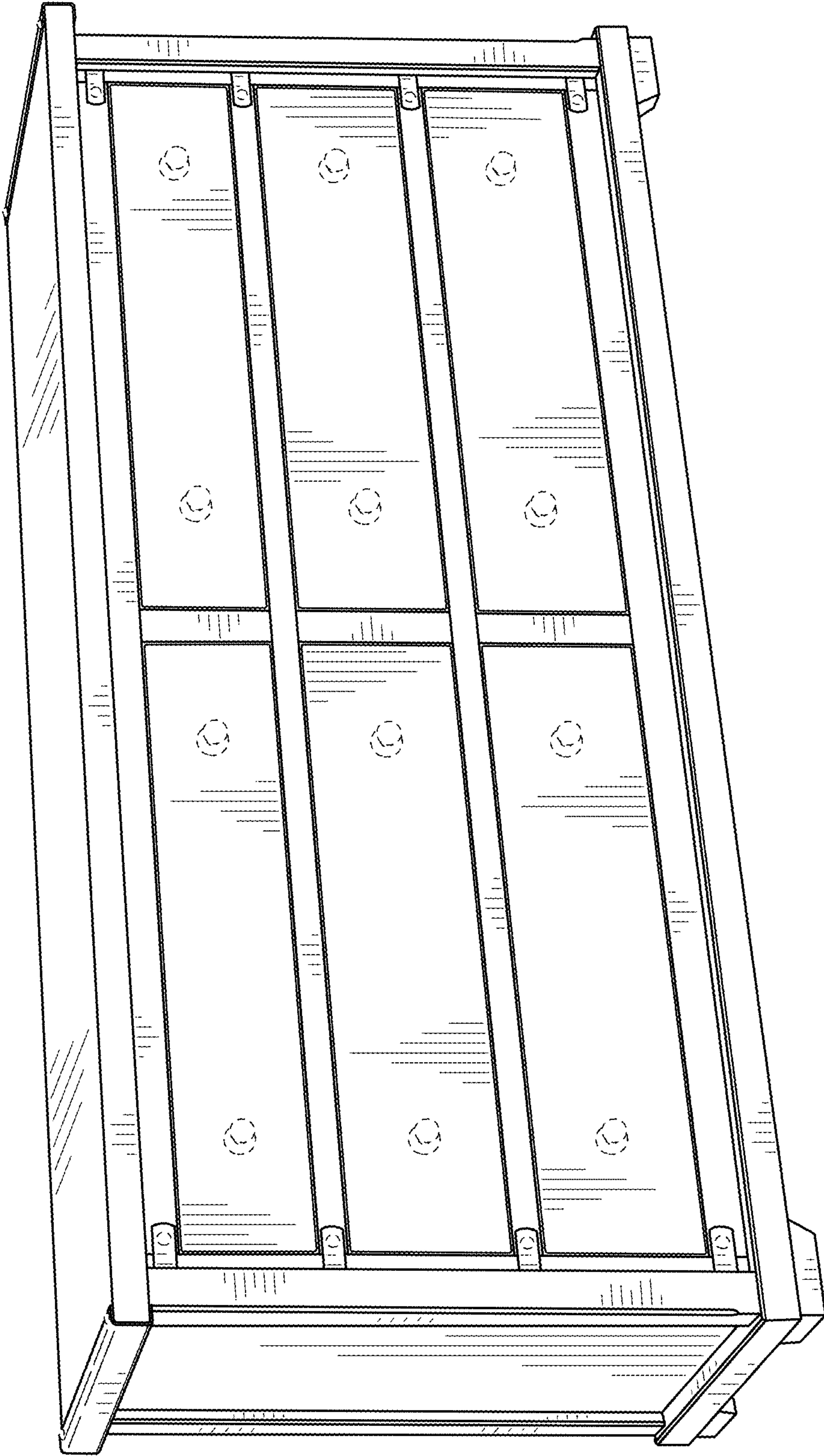

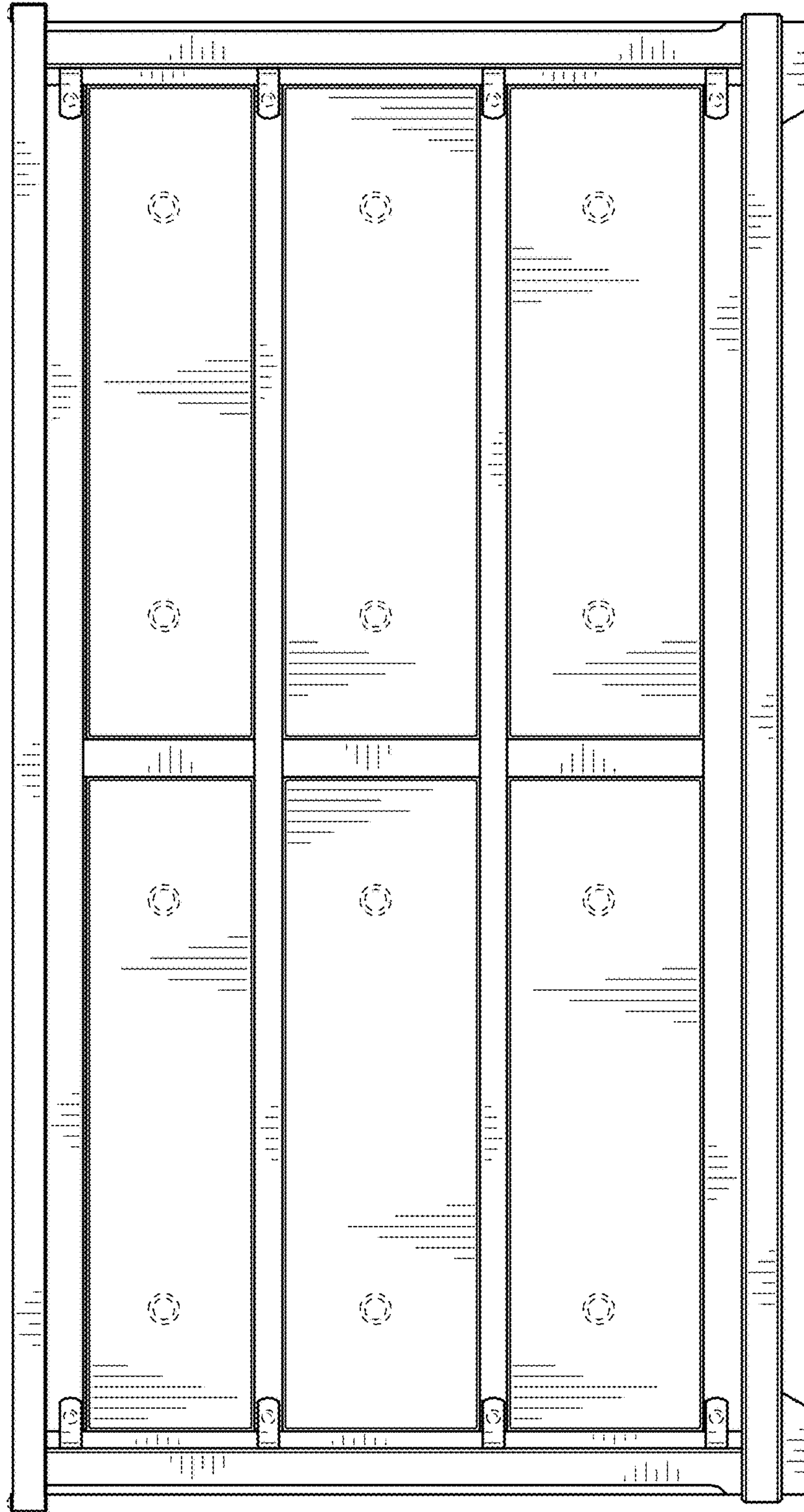

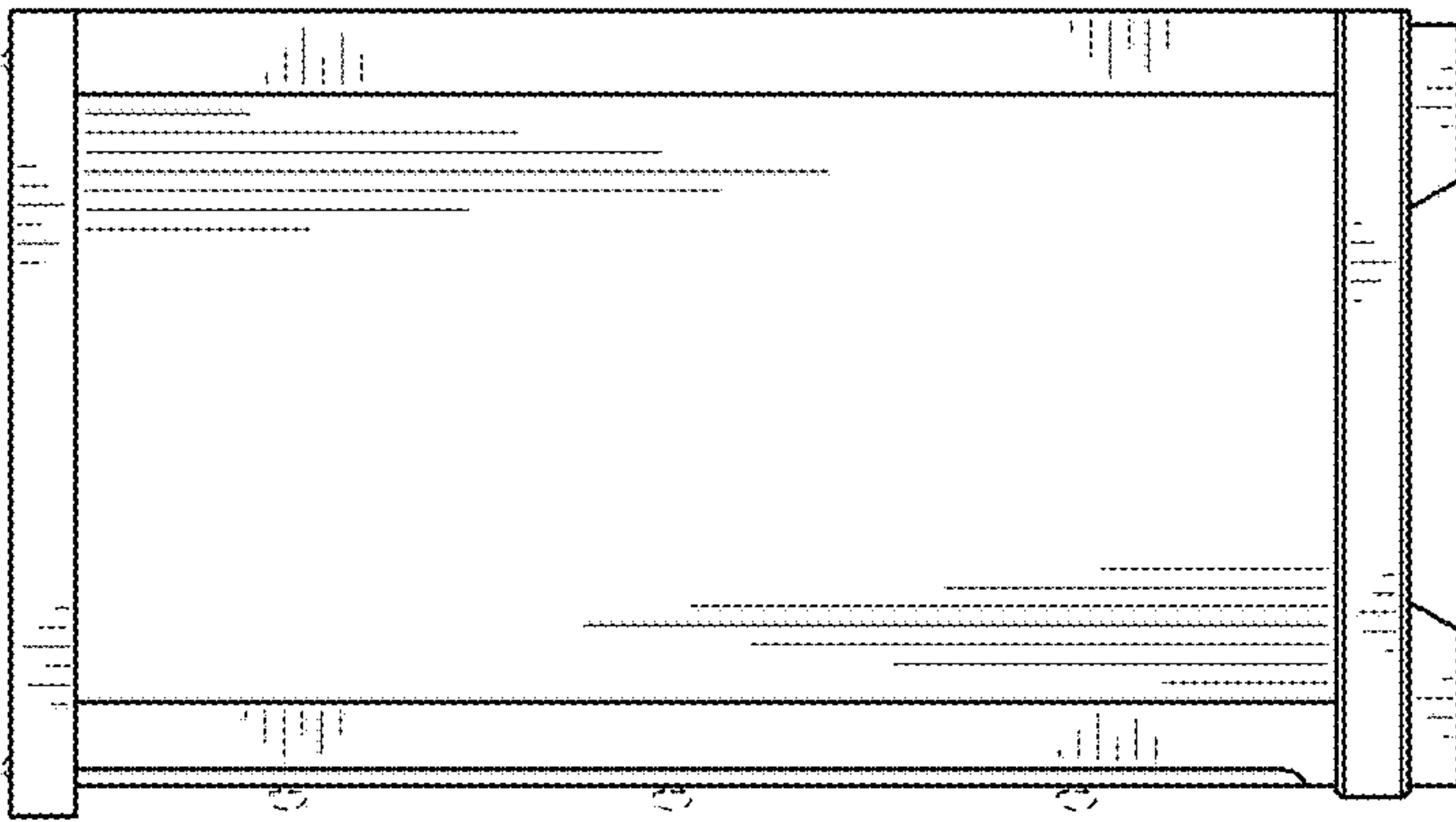

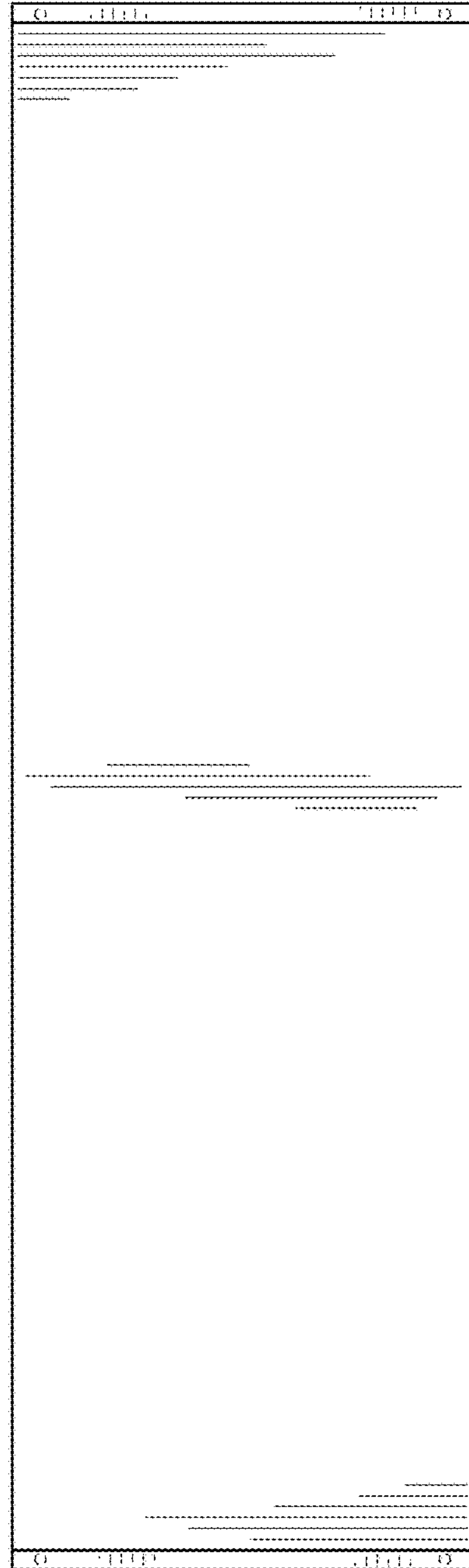
