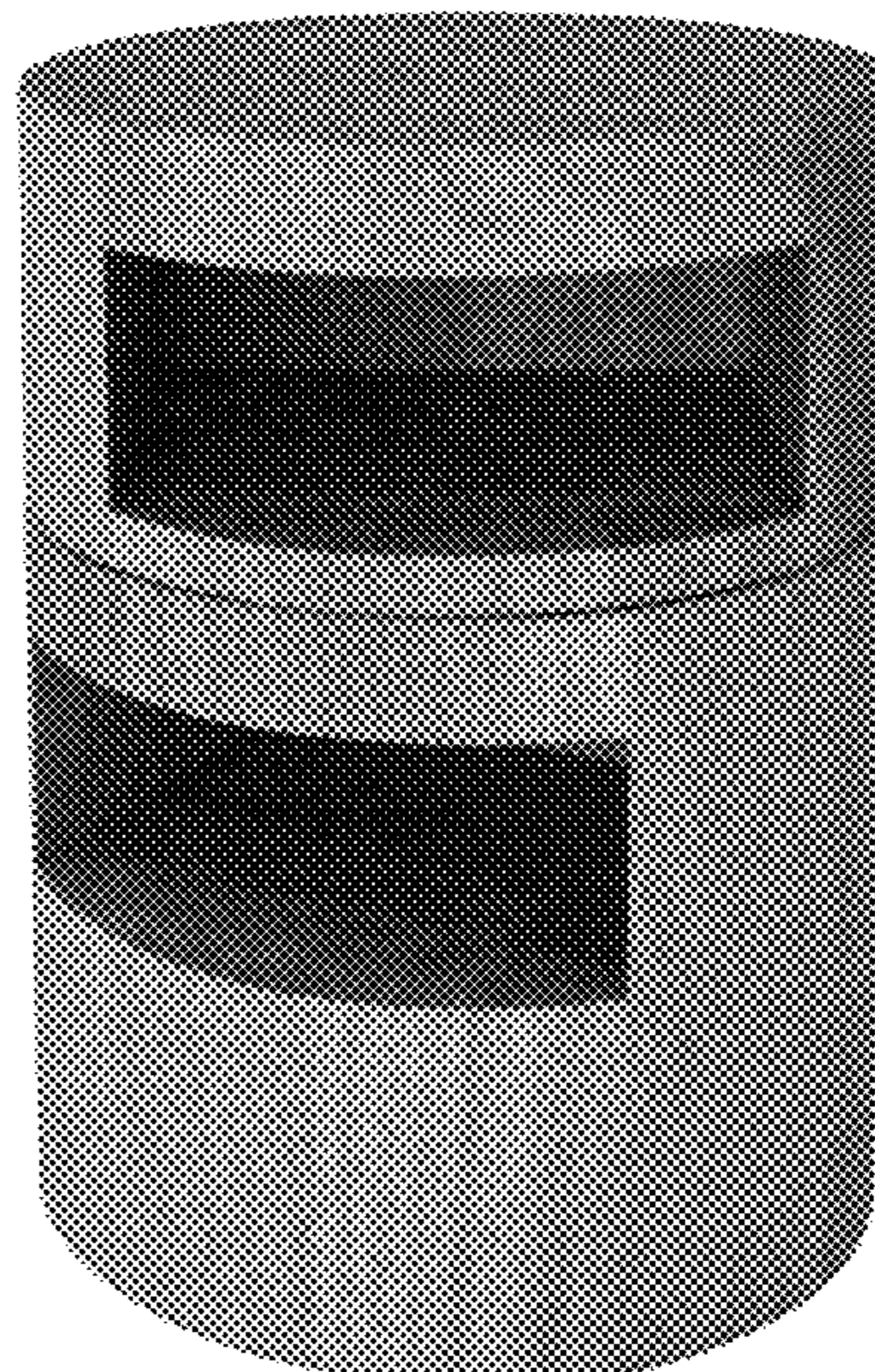
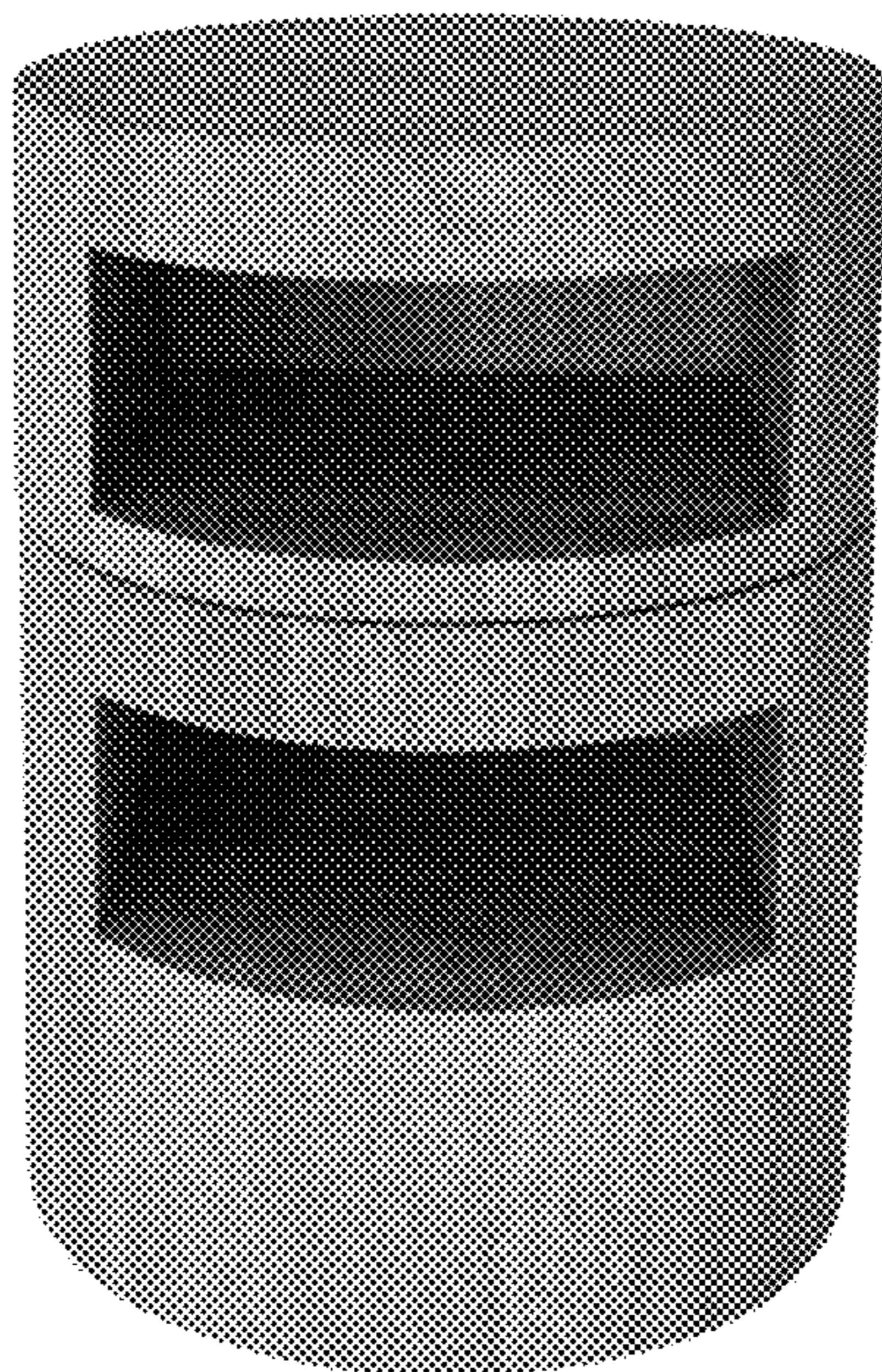

The ornamental design for an occasional table, as shown and described.

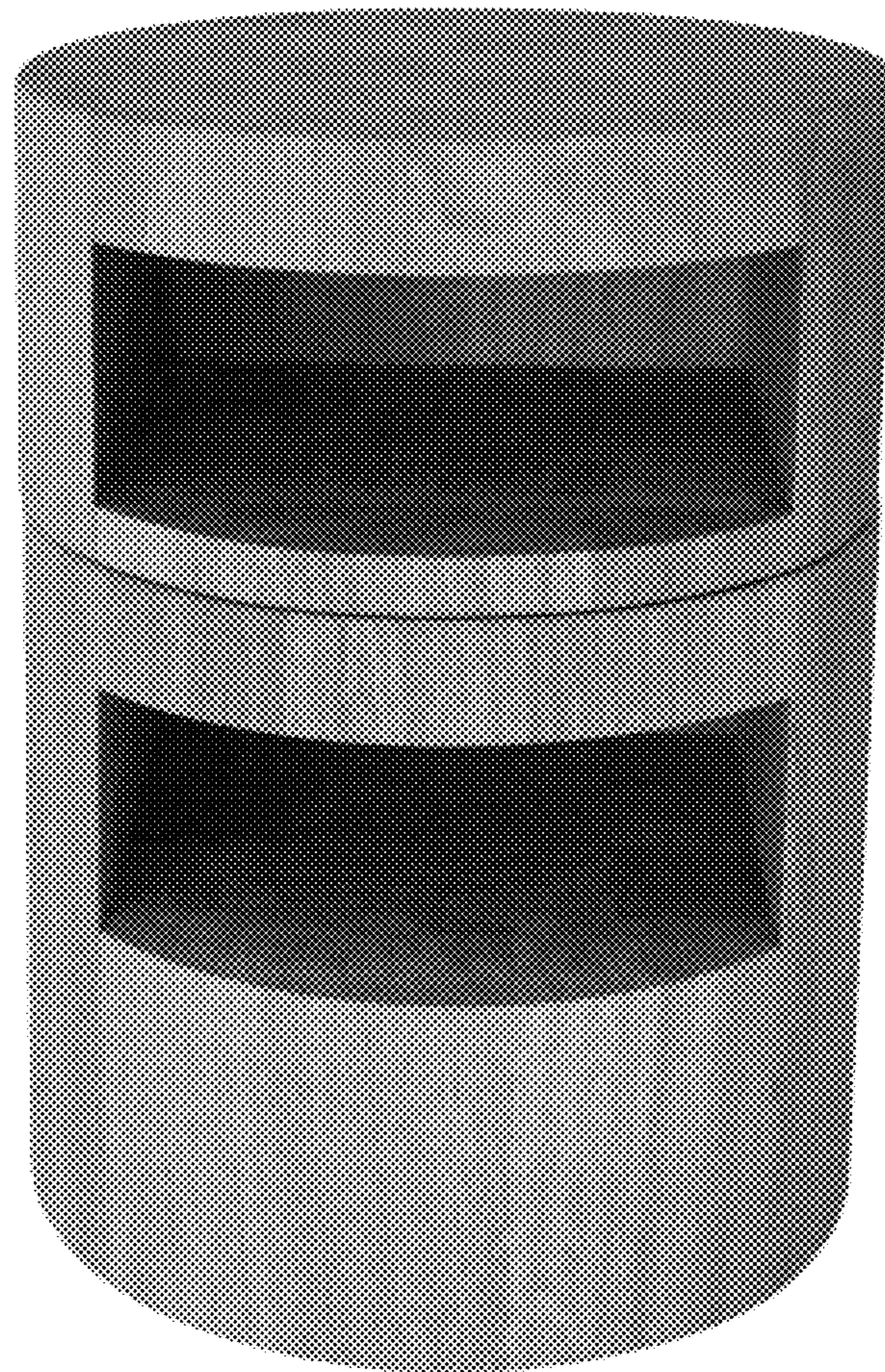
DESCRIPTION

- 6.3 is a back perspective view.

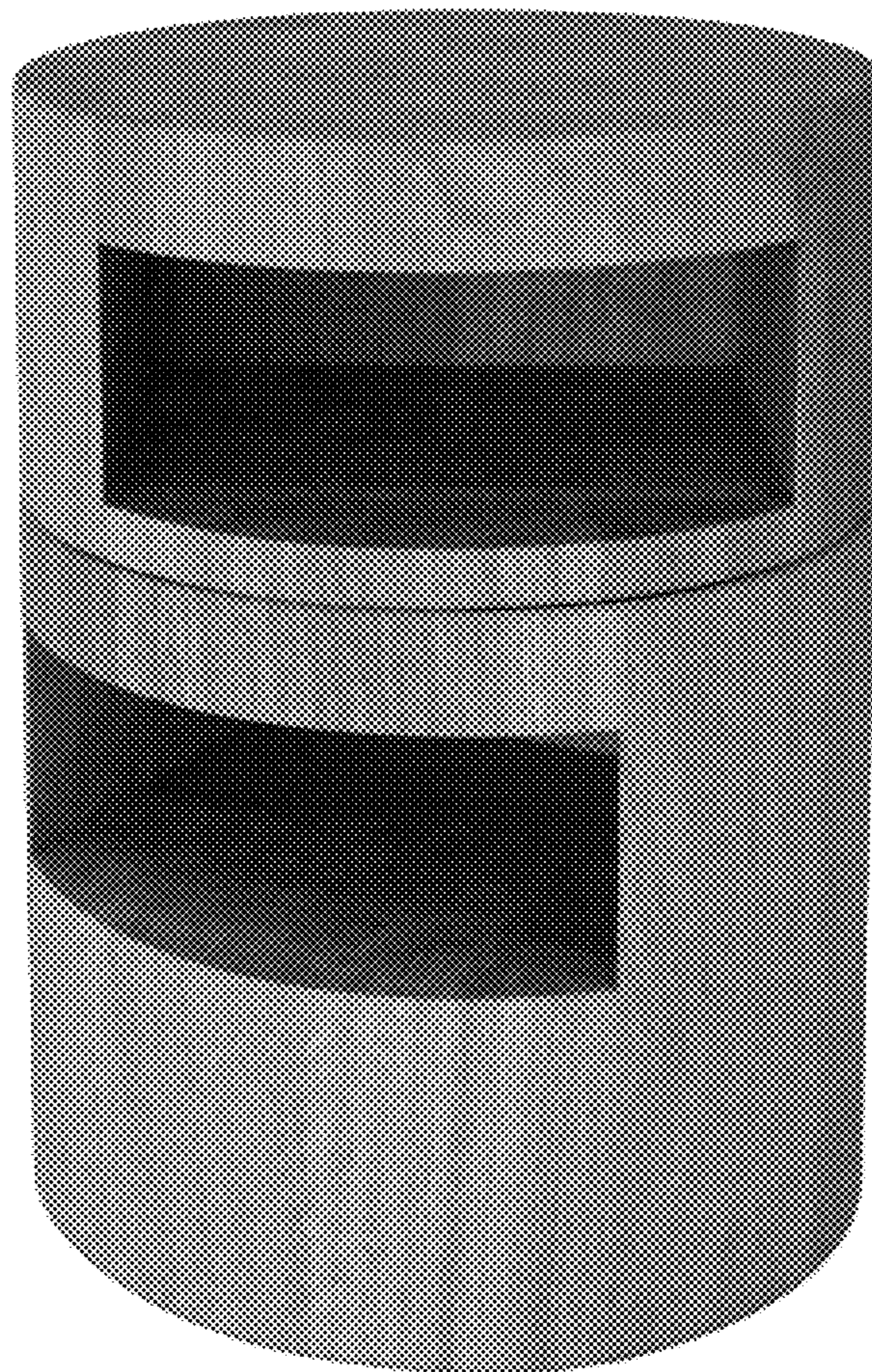

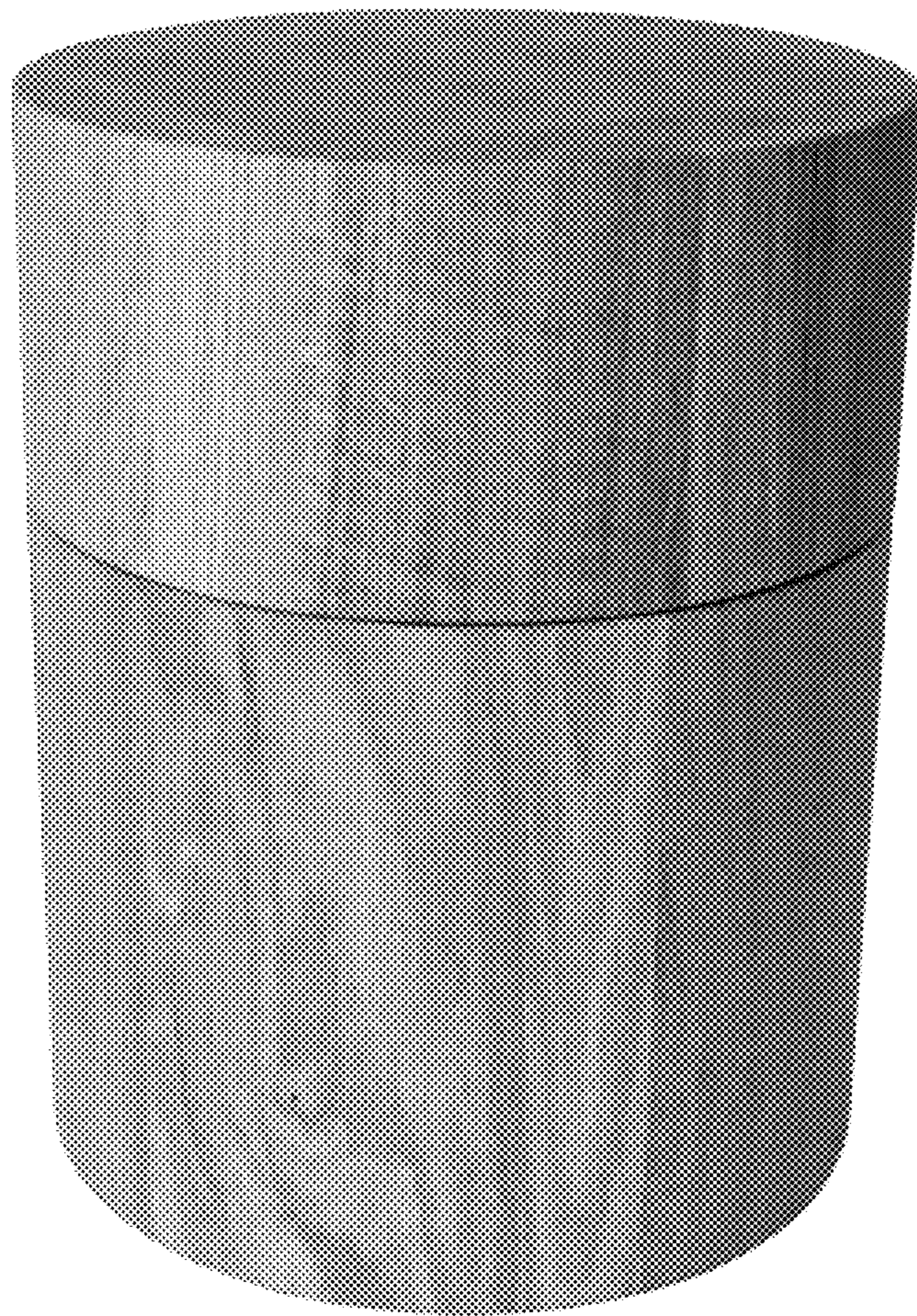

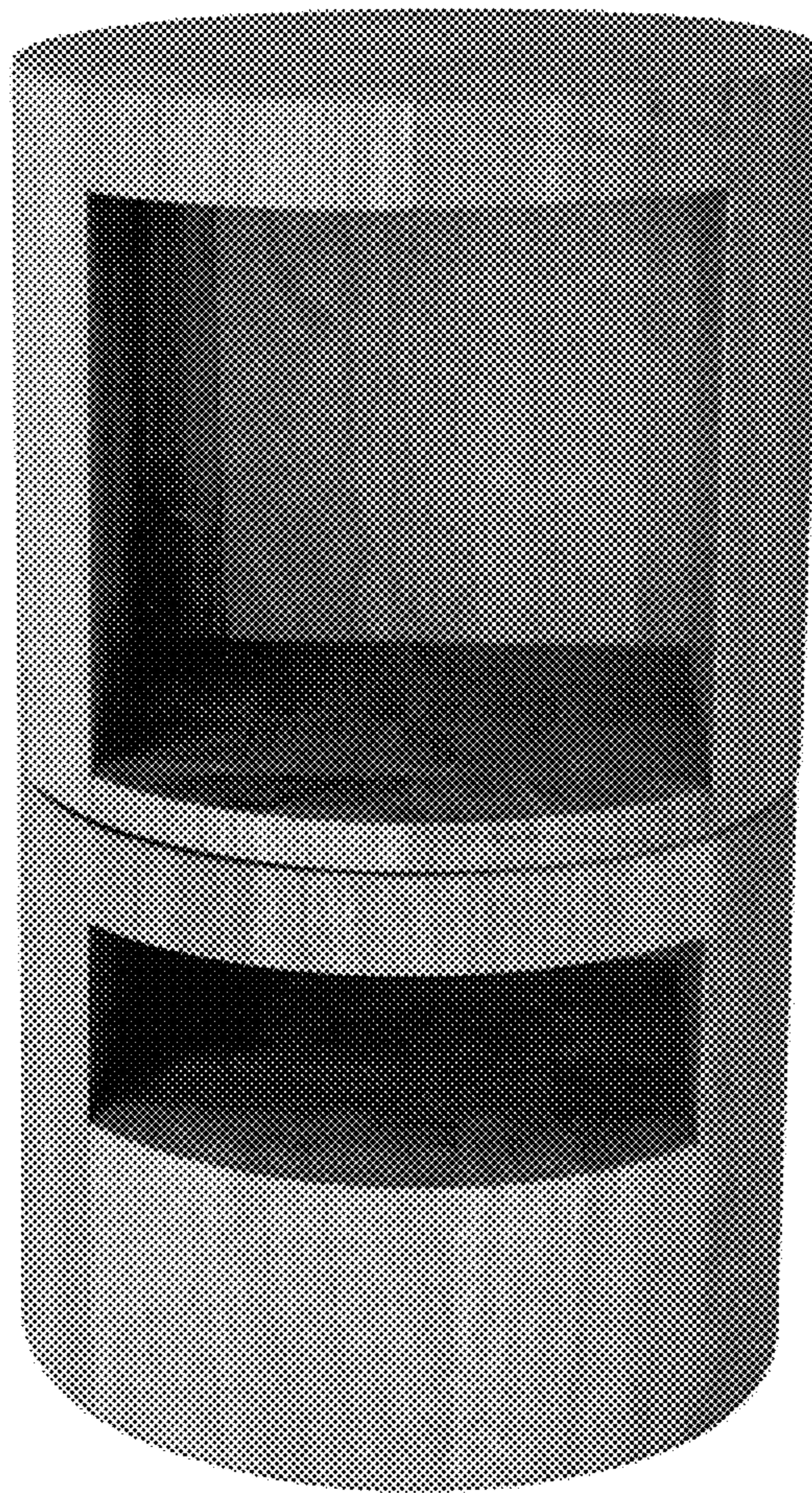

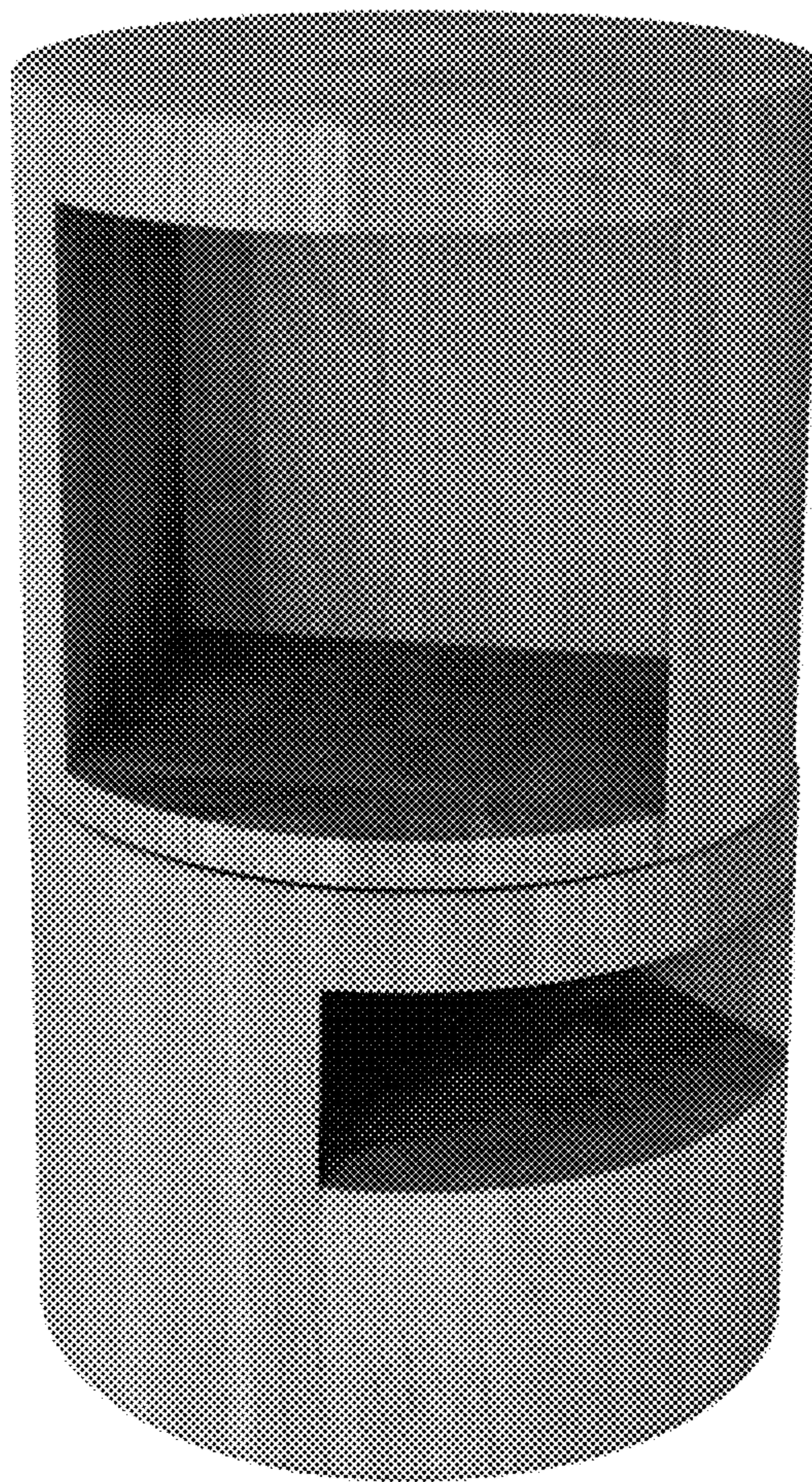

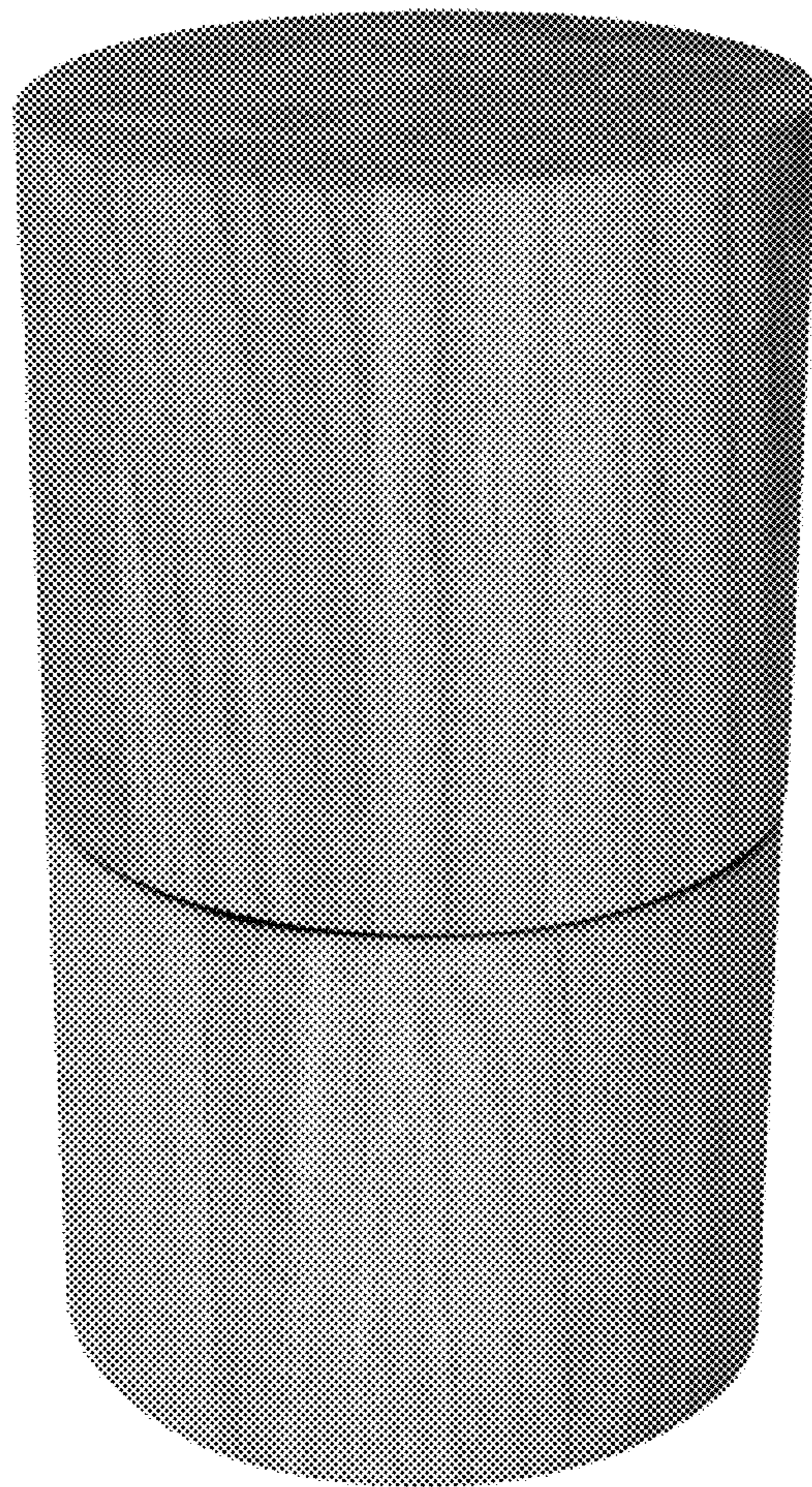

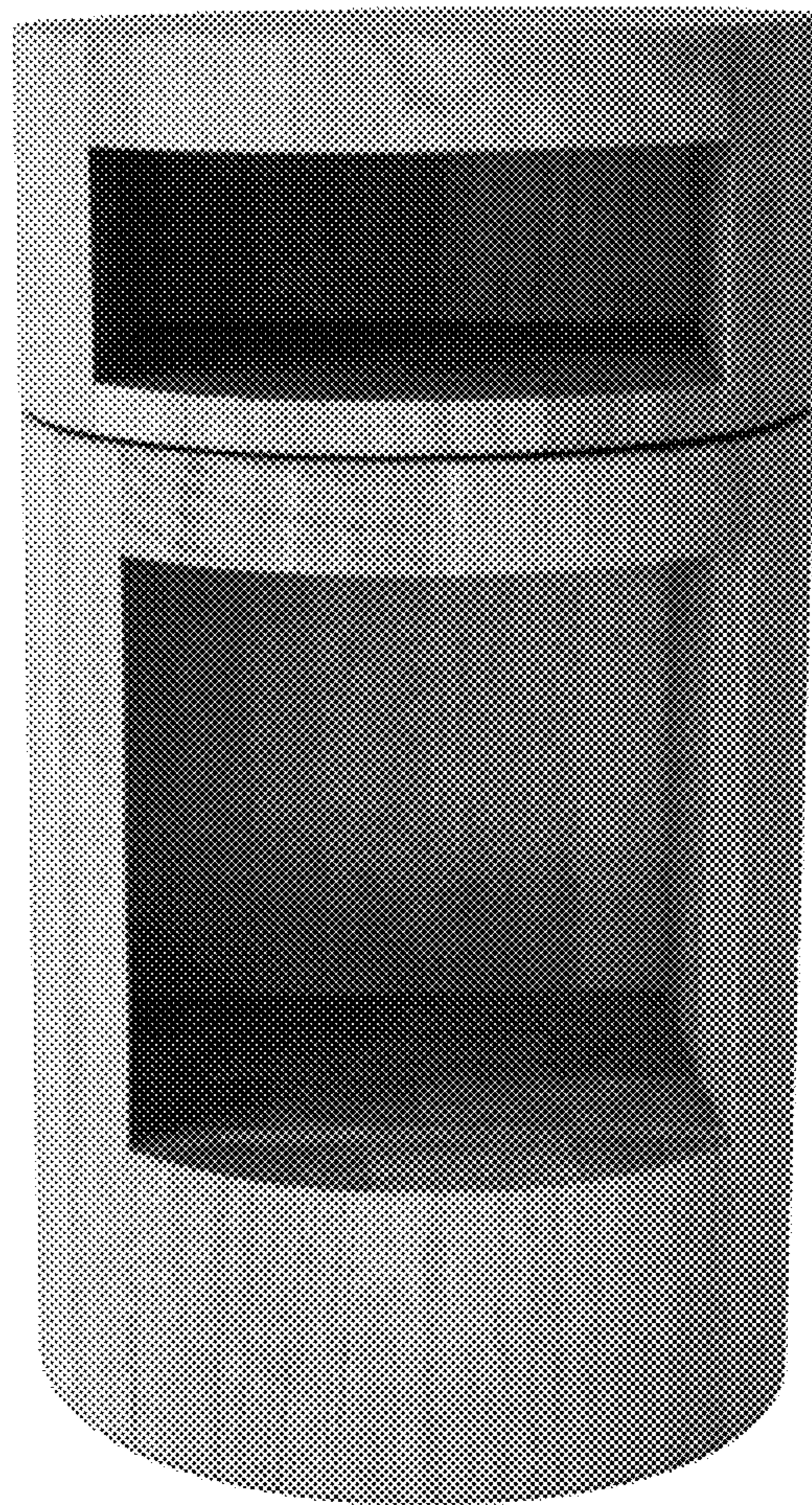

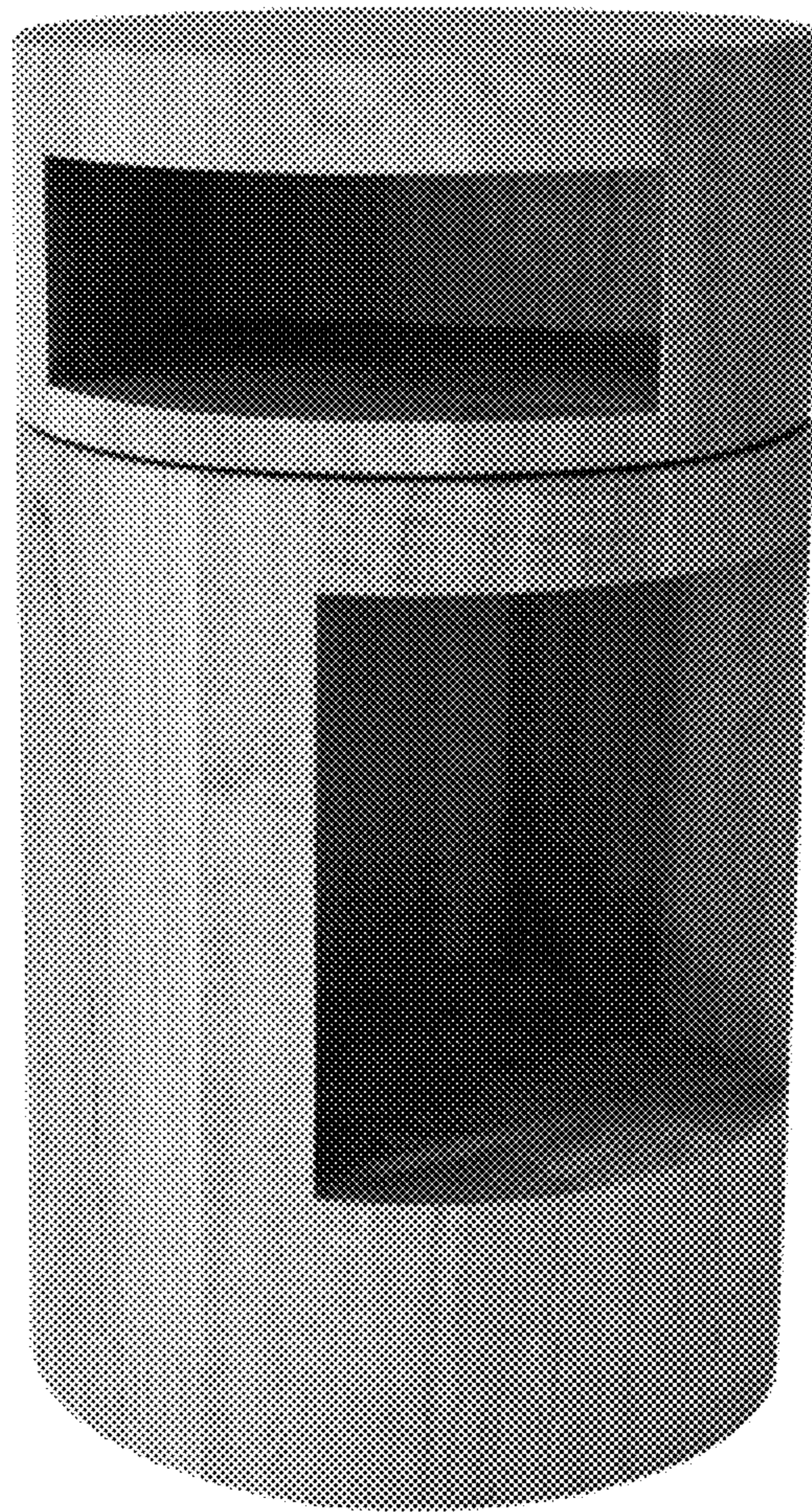

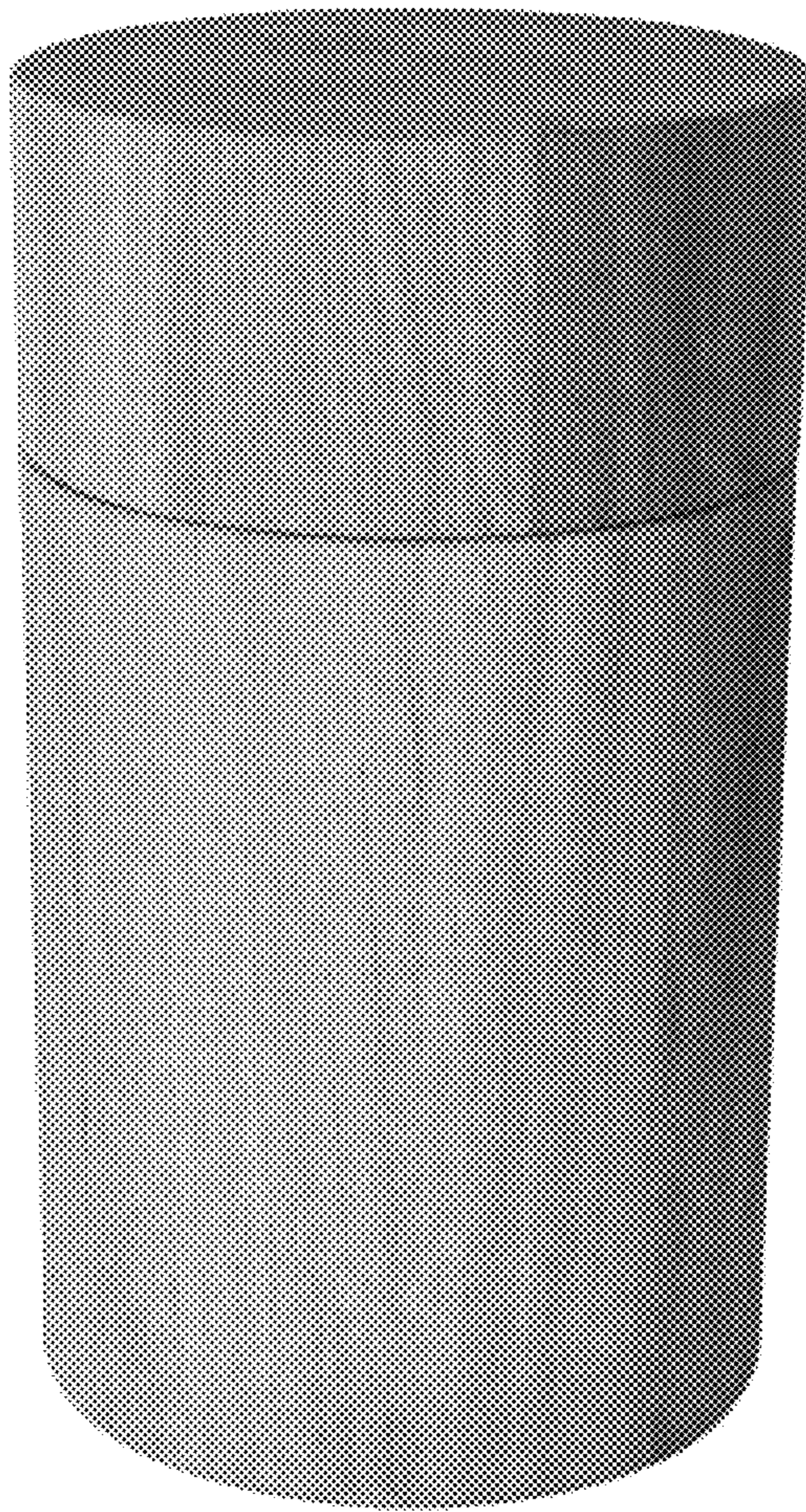

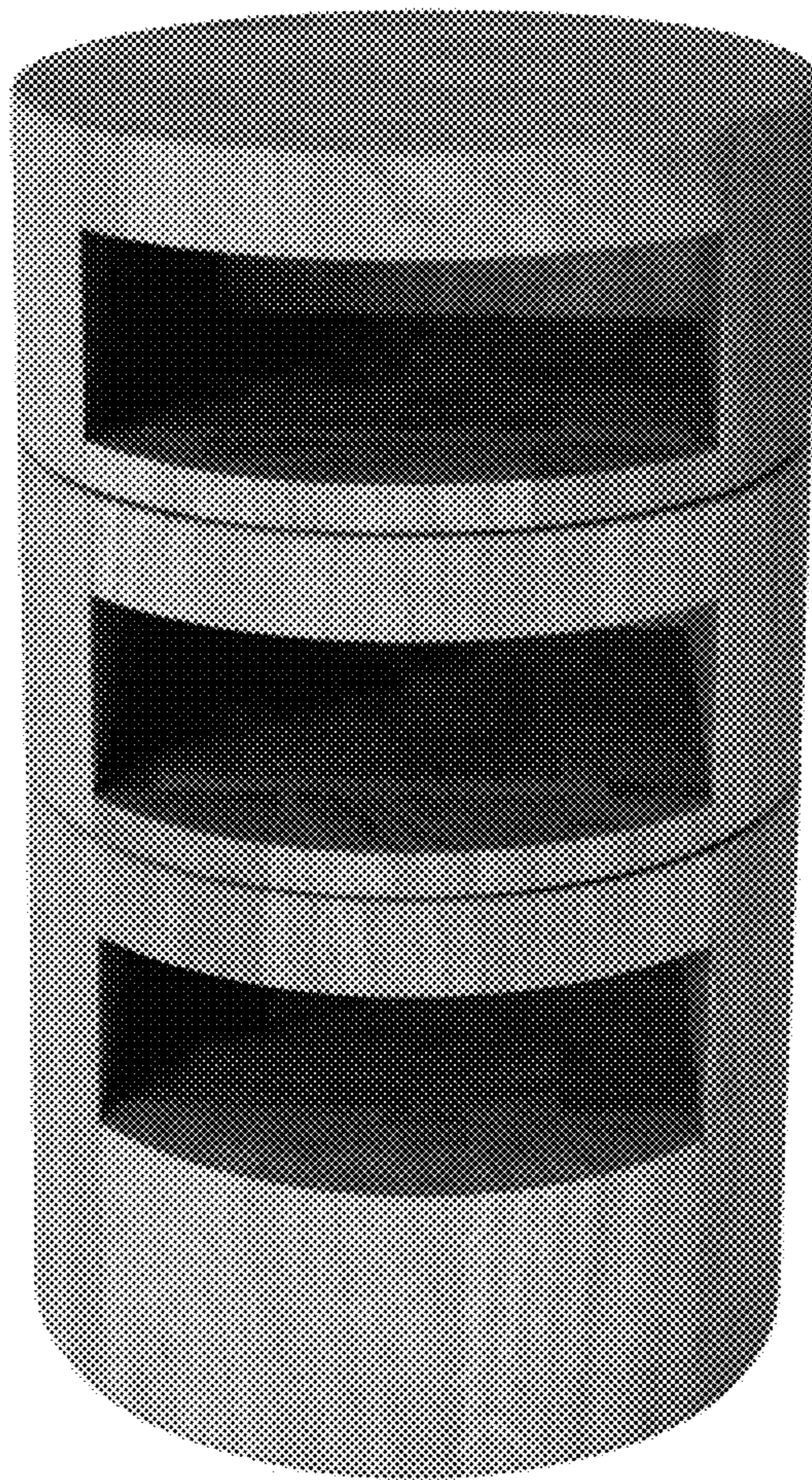

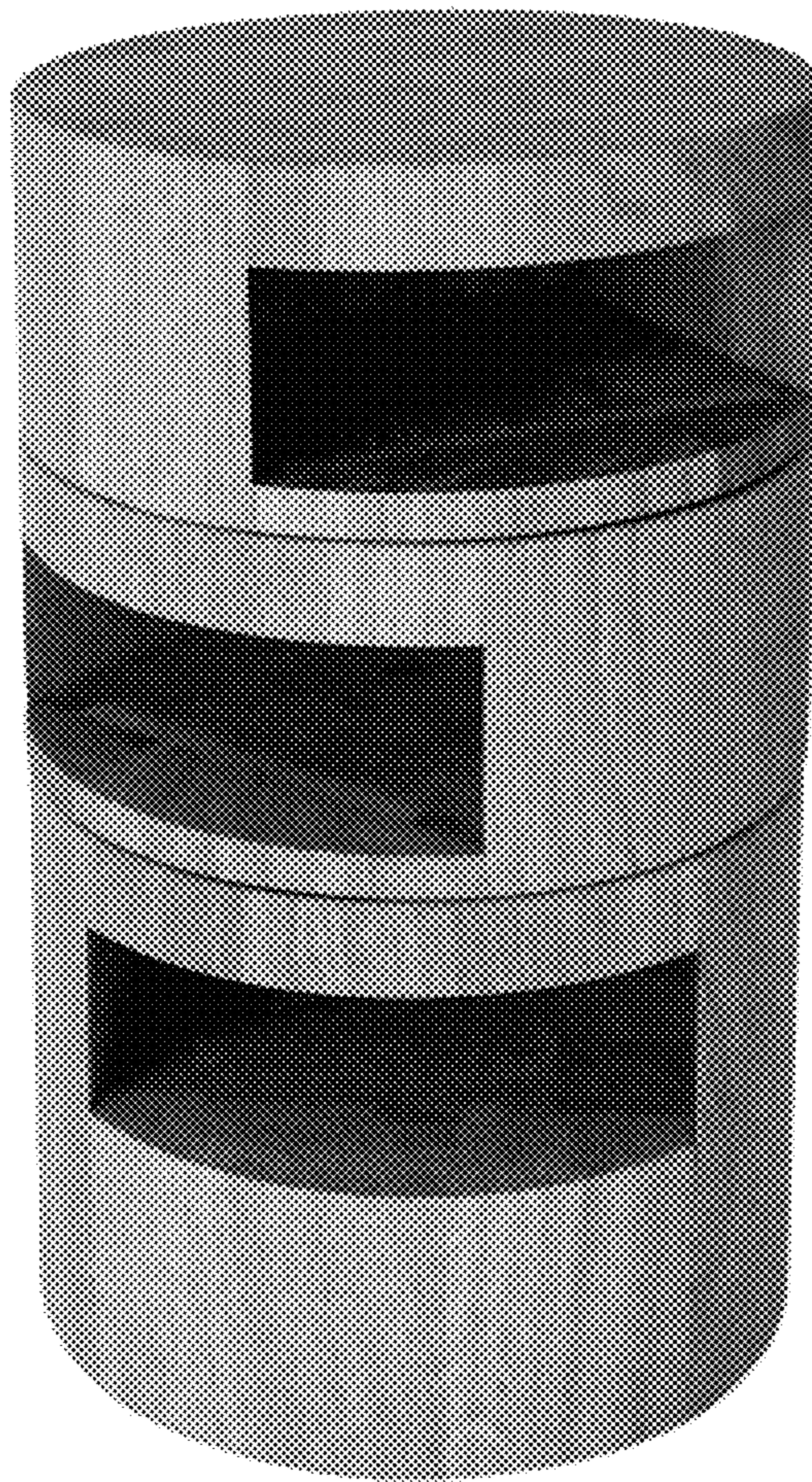

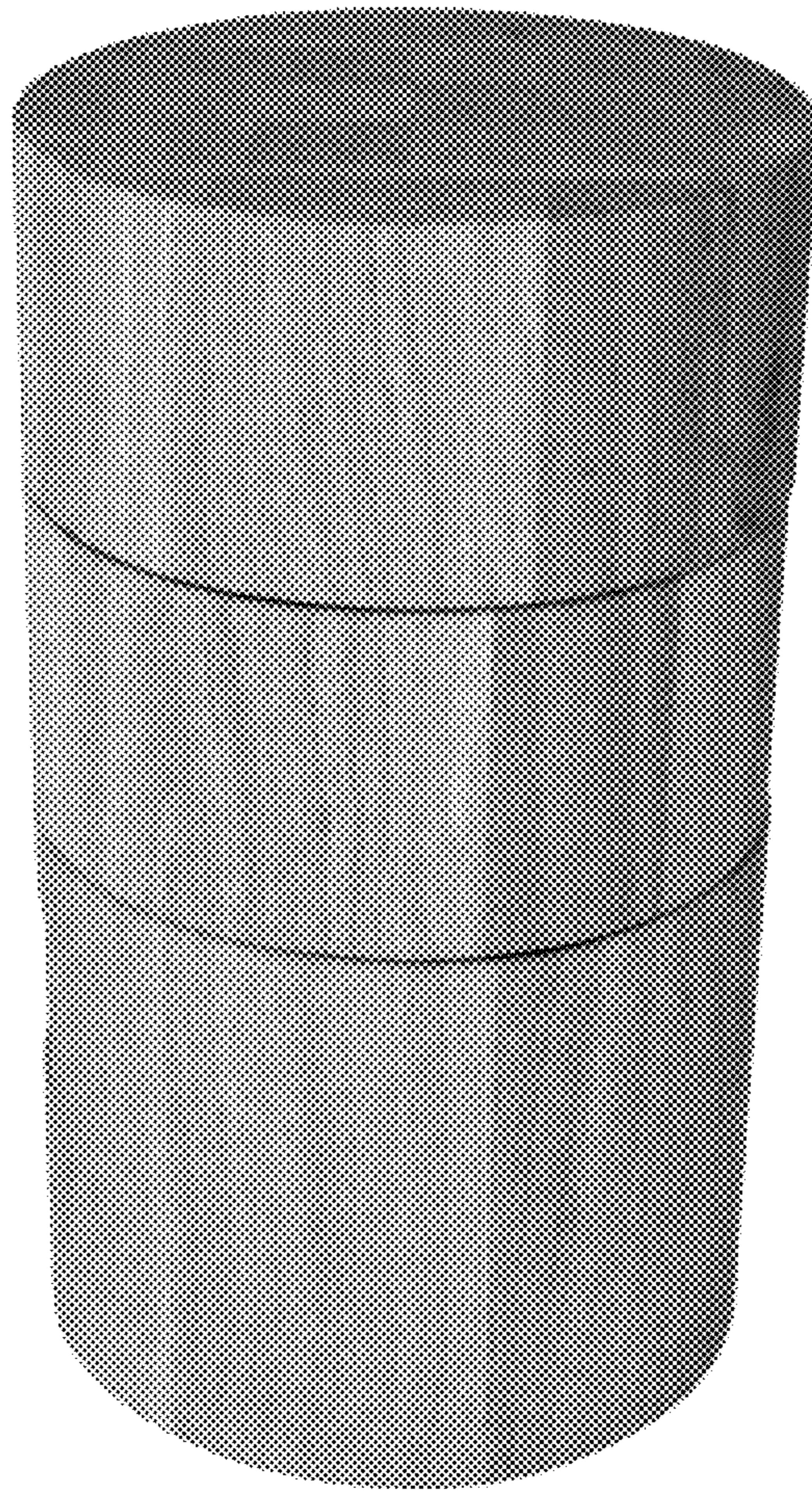

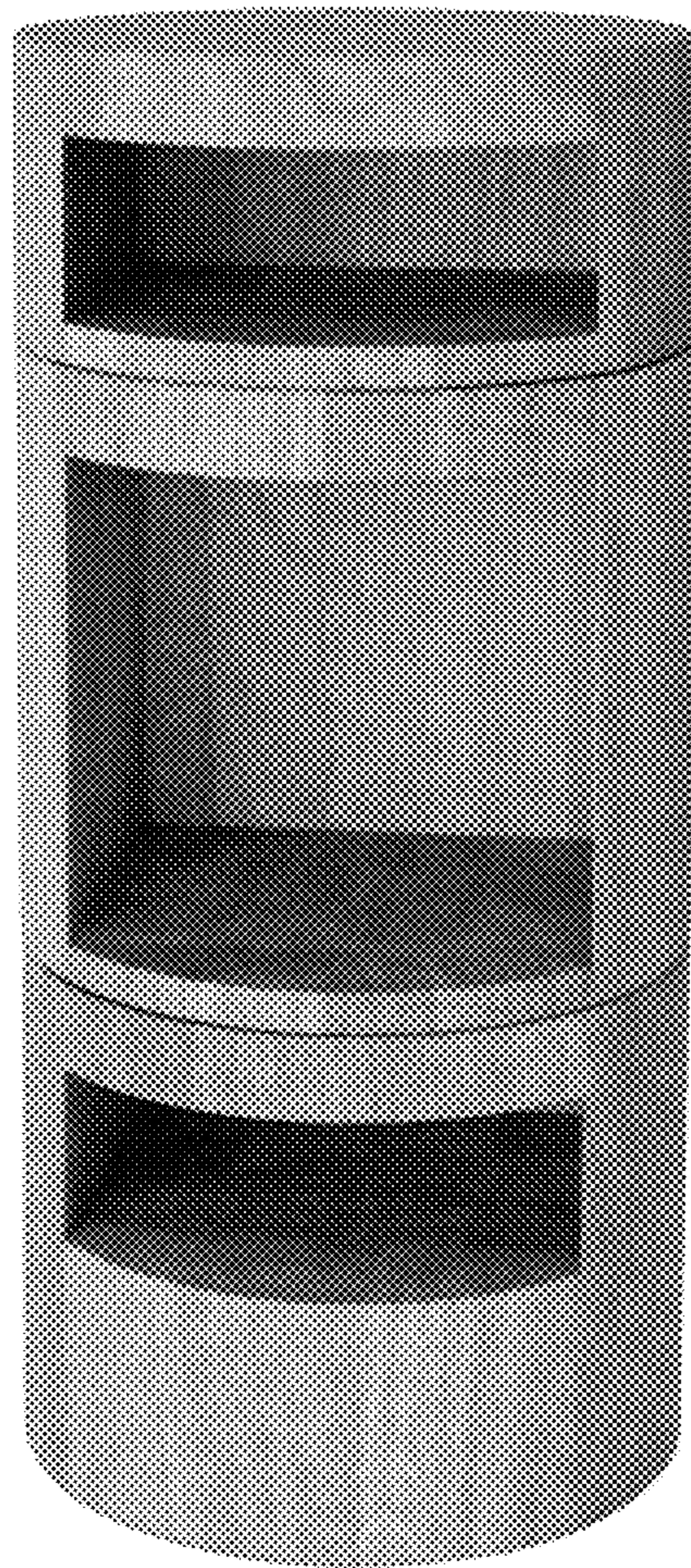

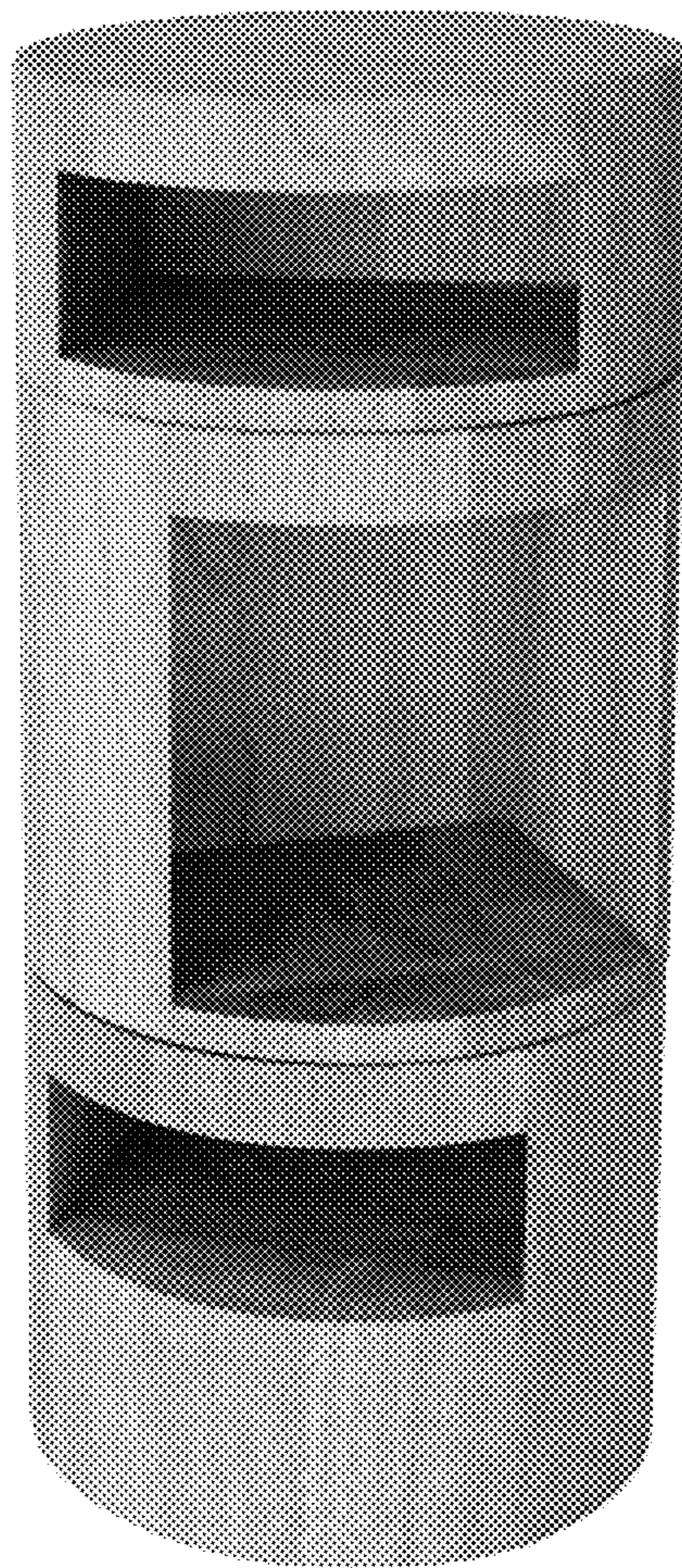

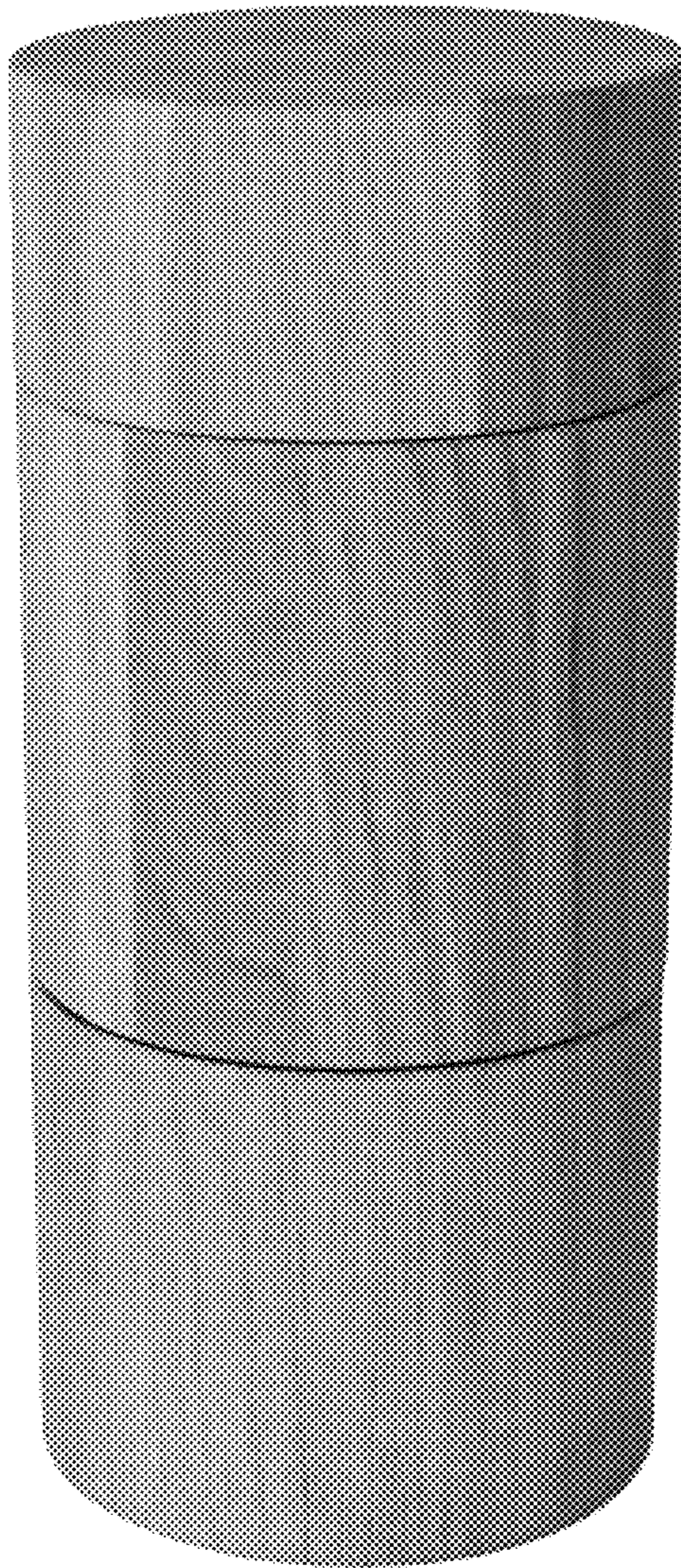

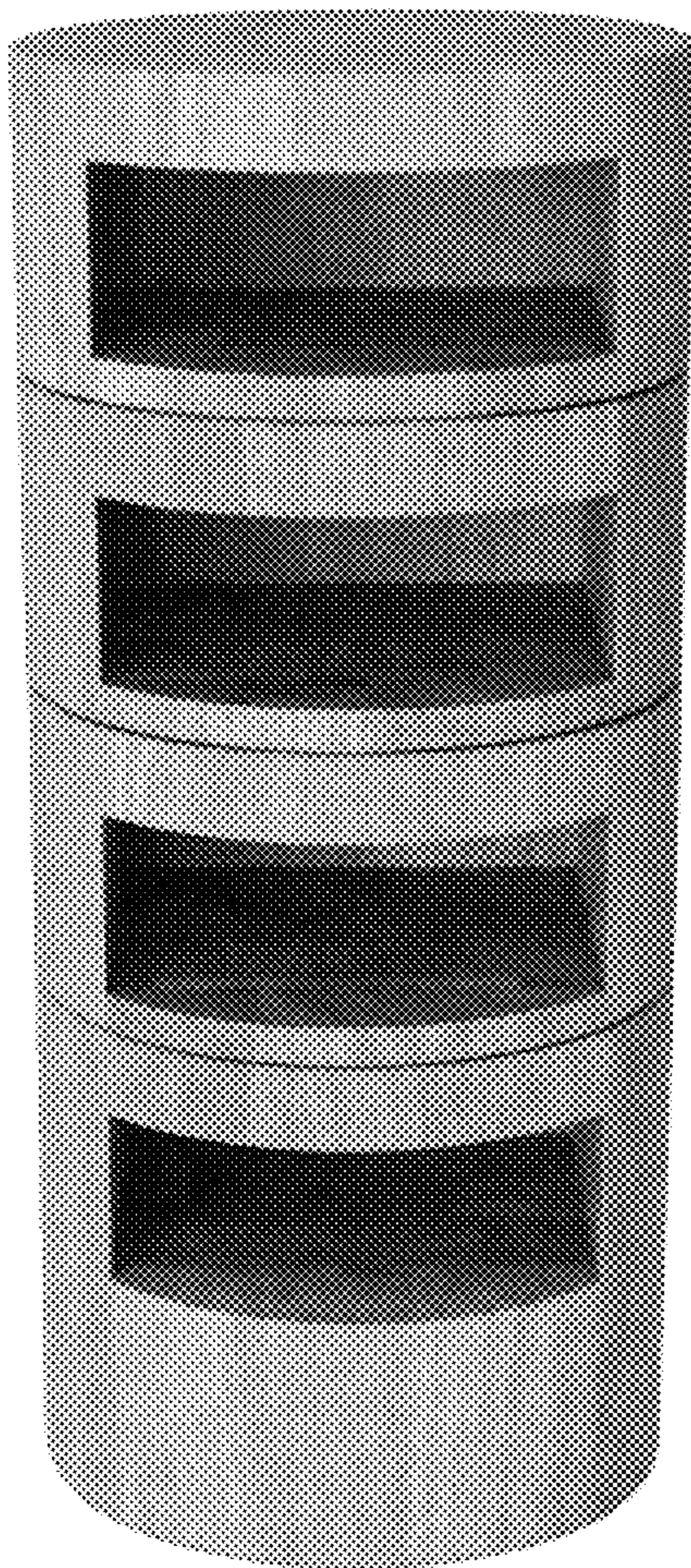

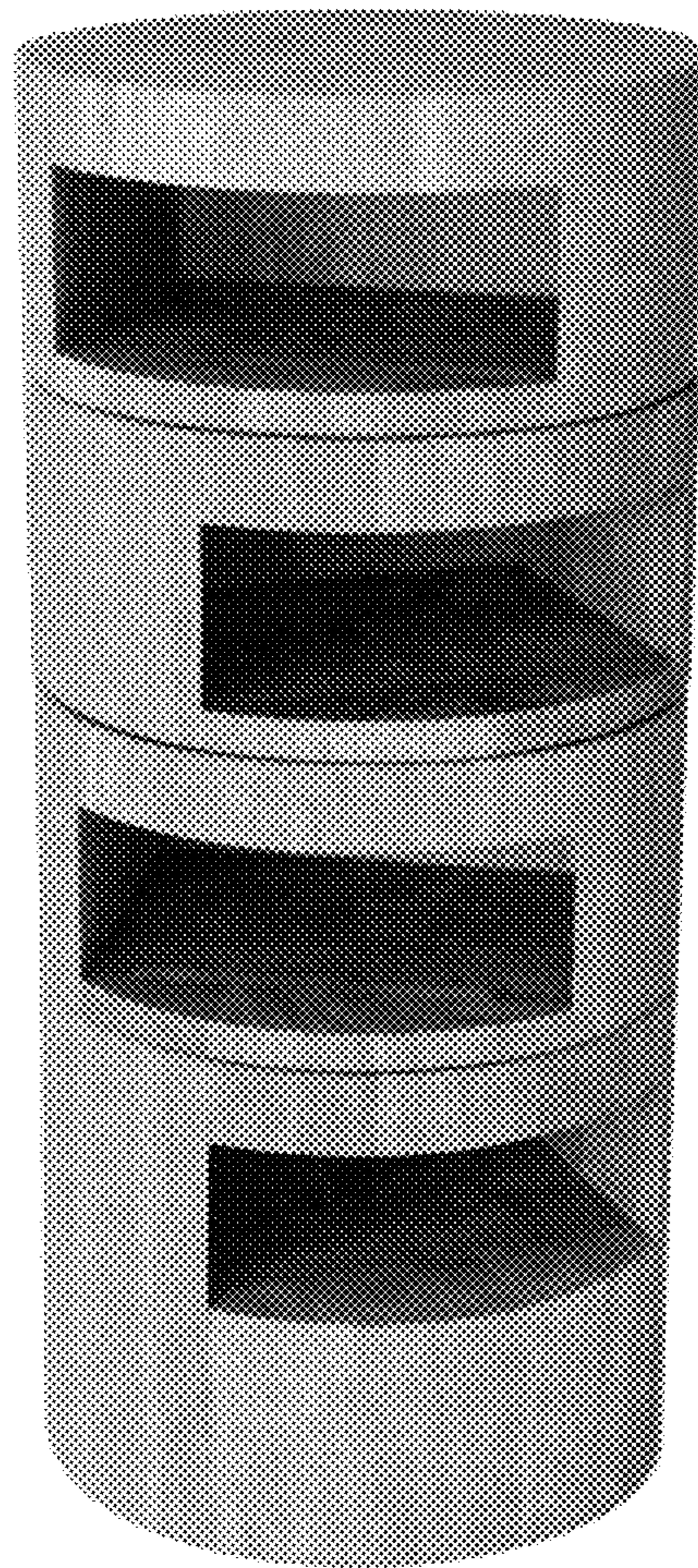
