FIG. 7 is a bottom plan view of the beverage holder illustrated in FIG. 1.

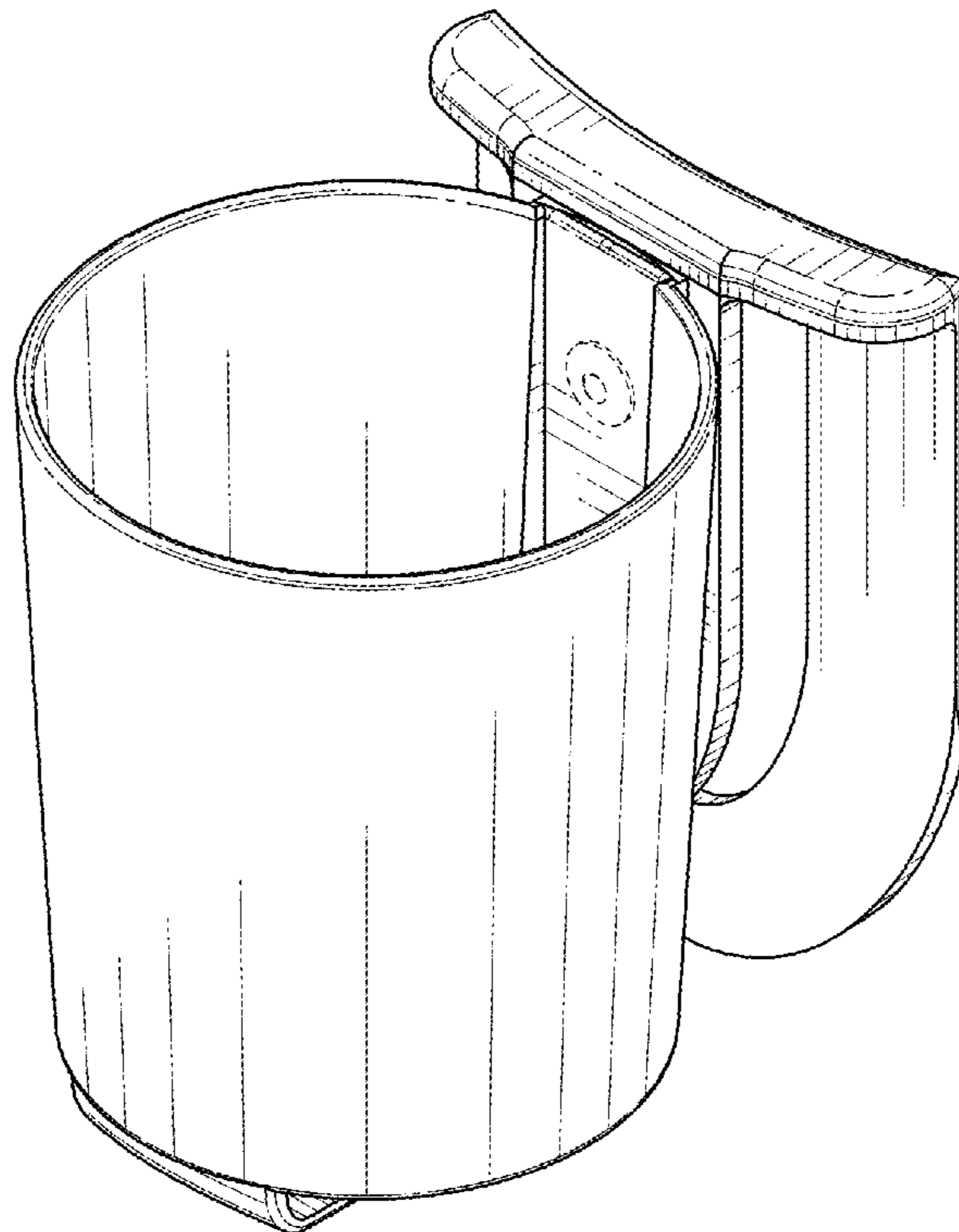
The broken lines in FIGS. 1 and 3-6 depict fasteners that are elements of the beverage holder that do not form a claimed feature of the present invention.

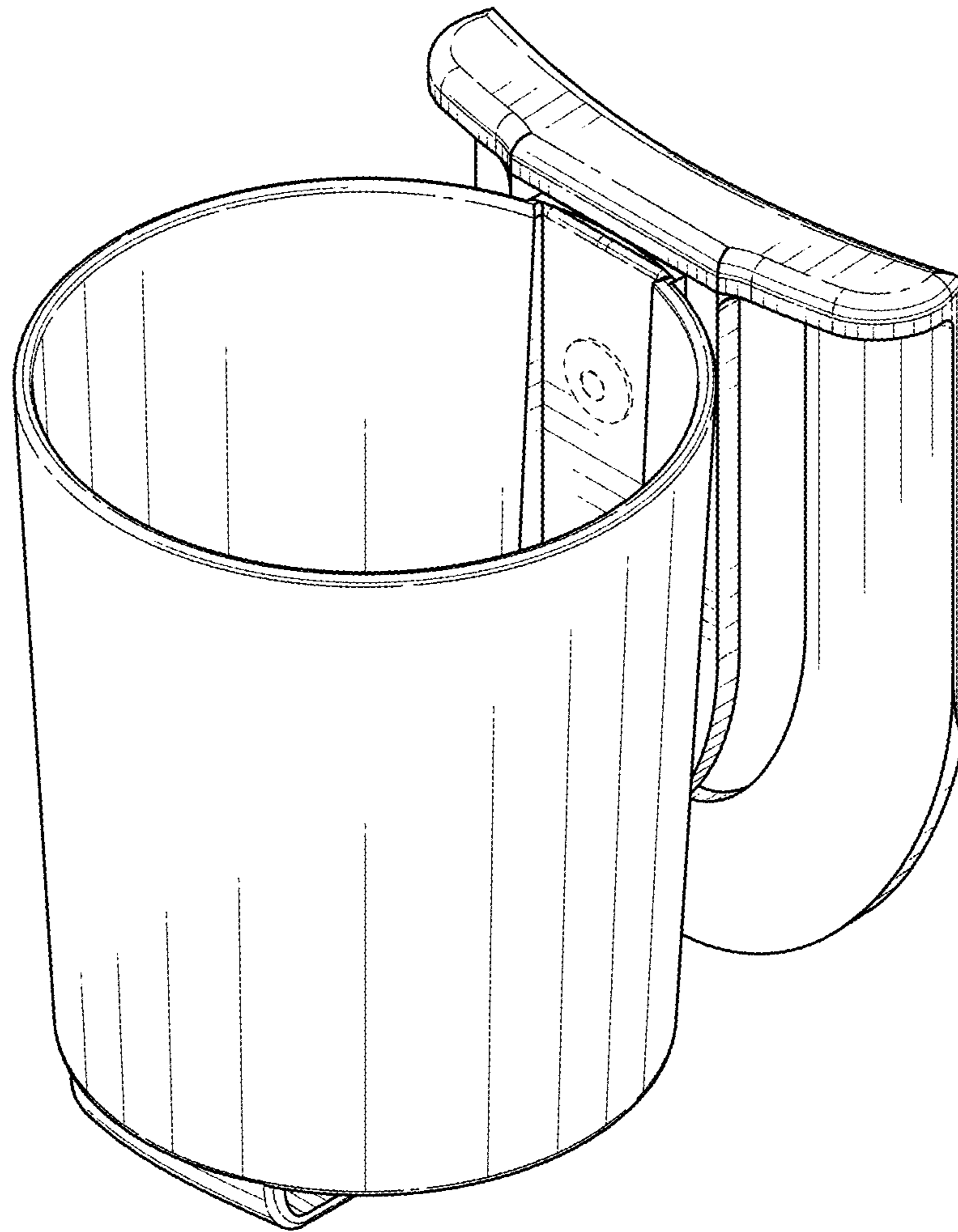

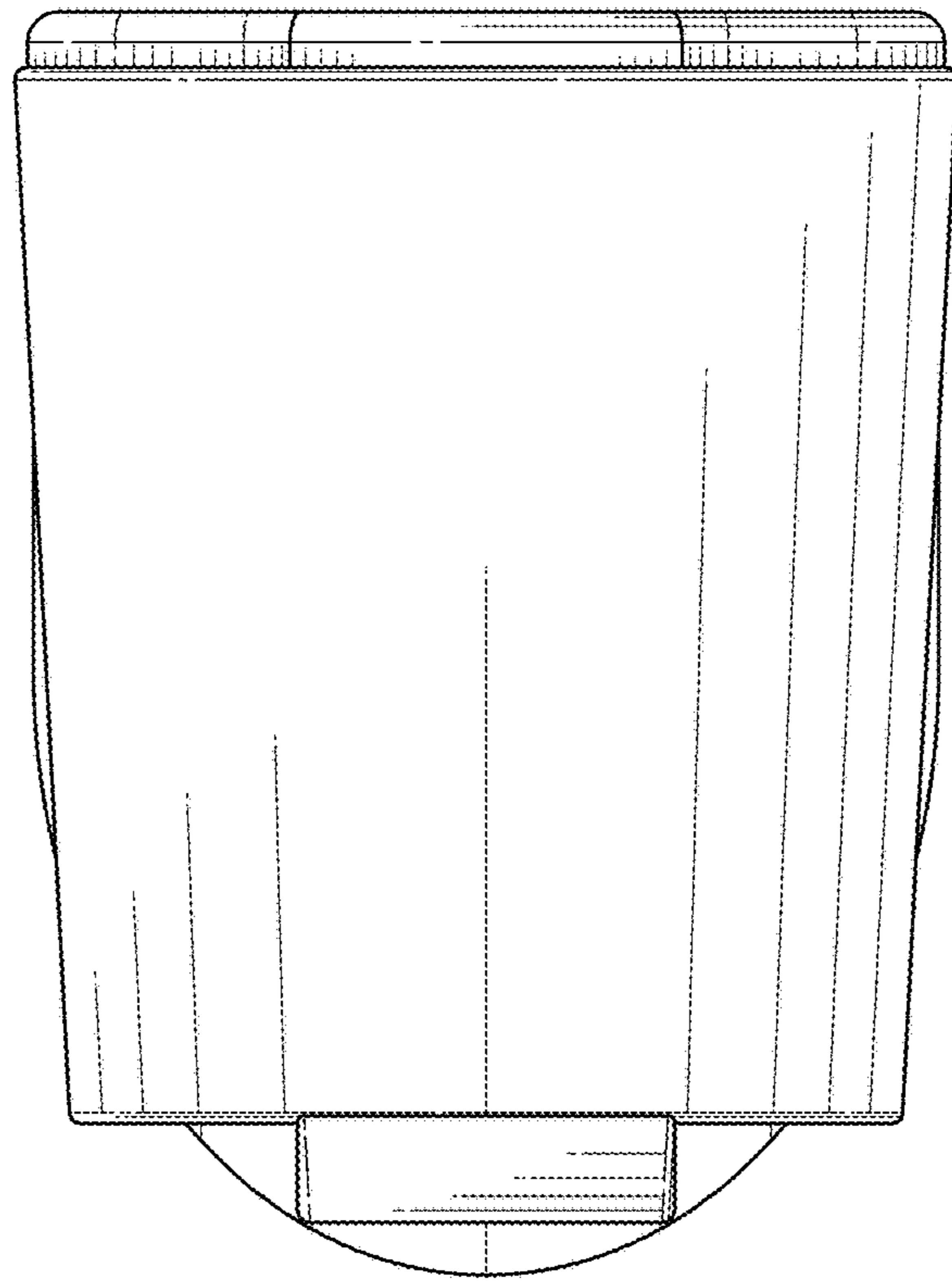

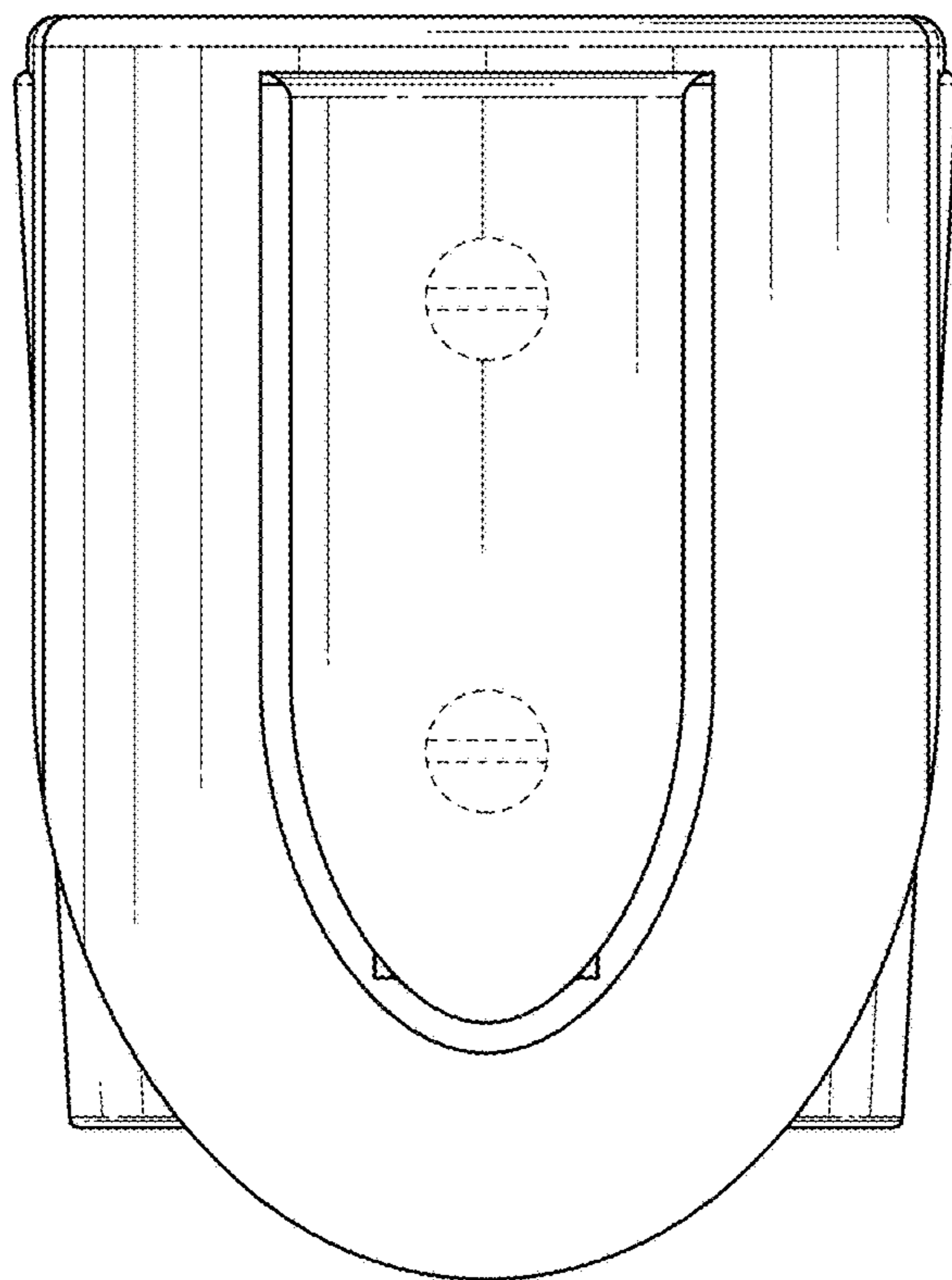

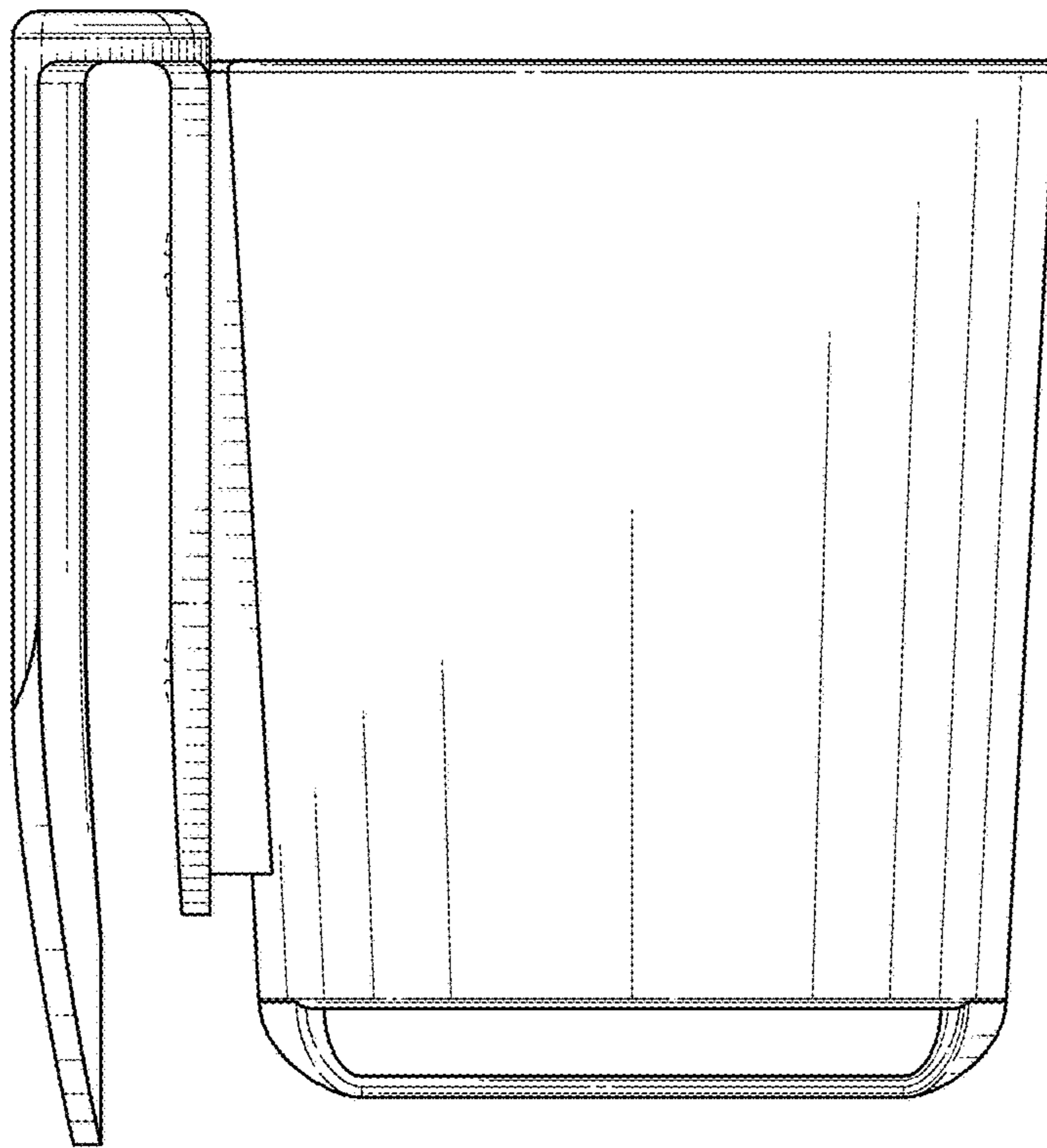

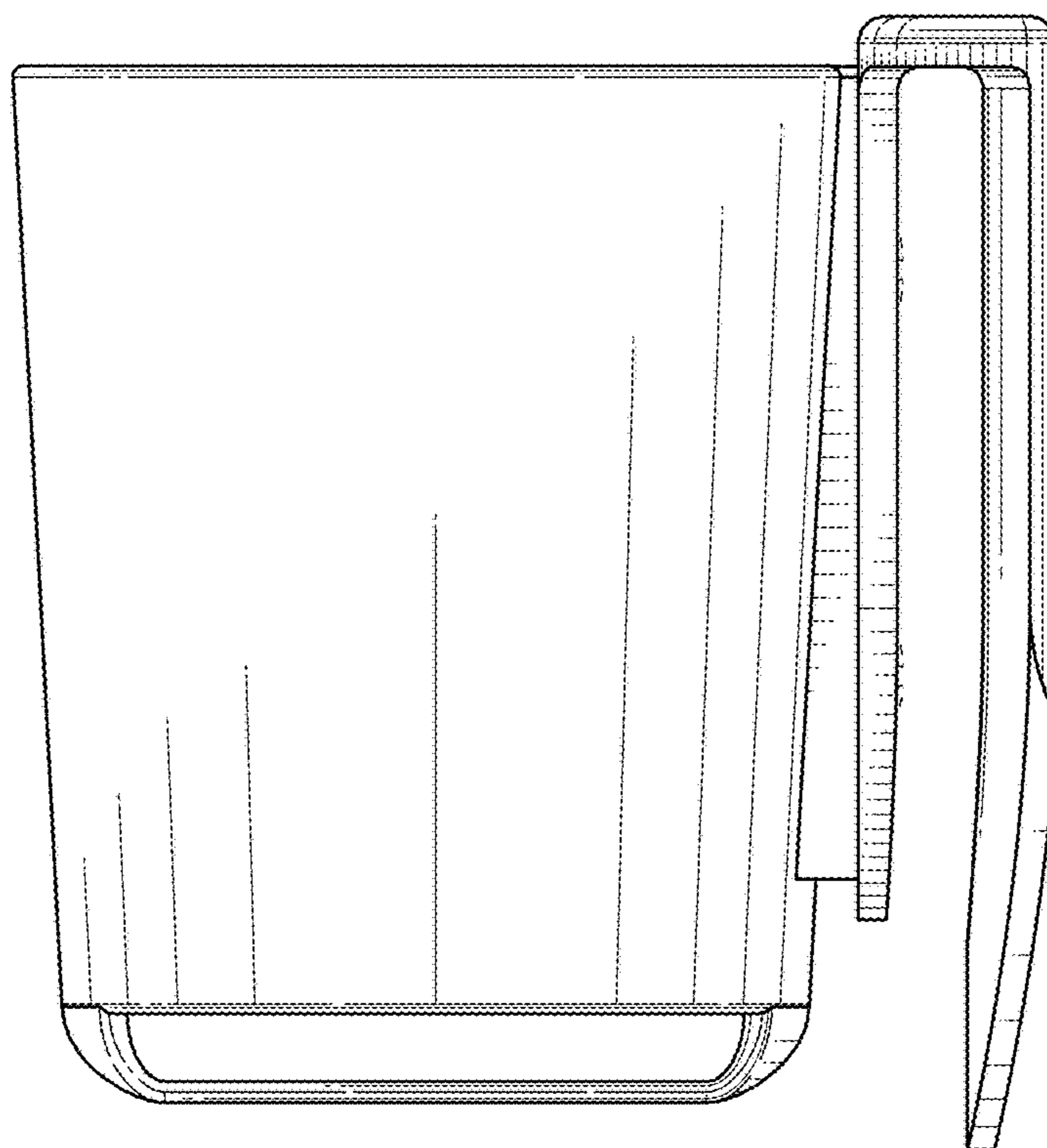

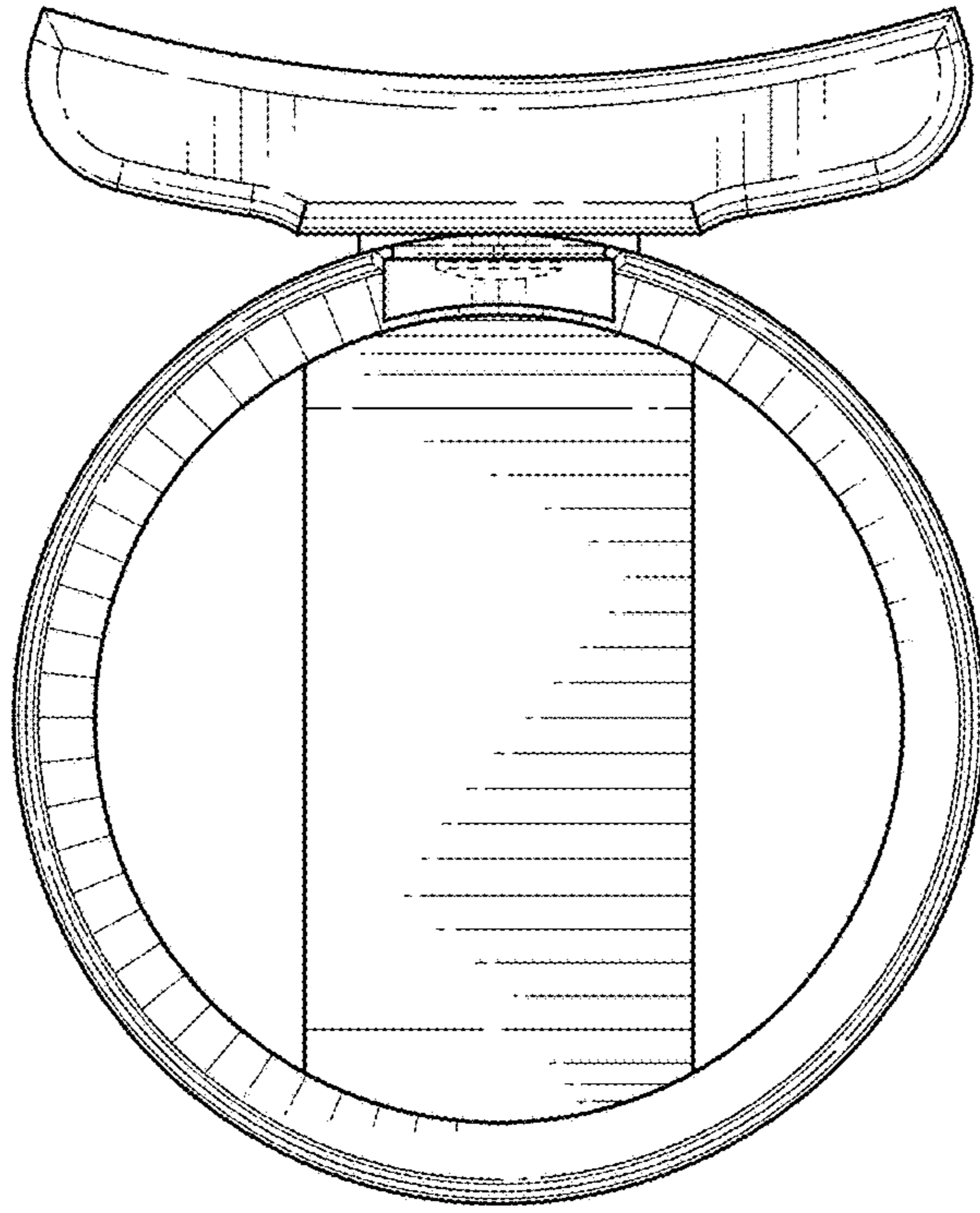

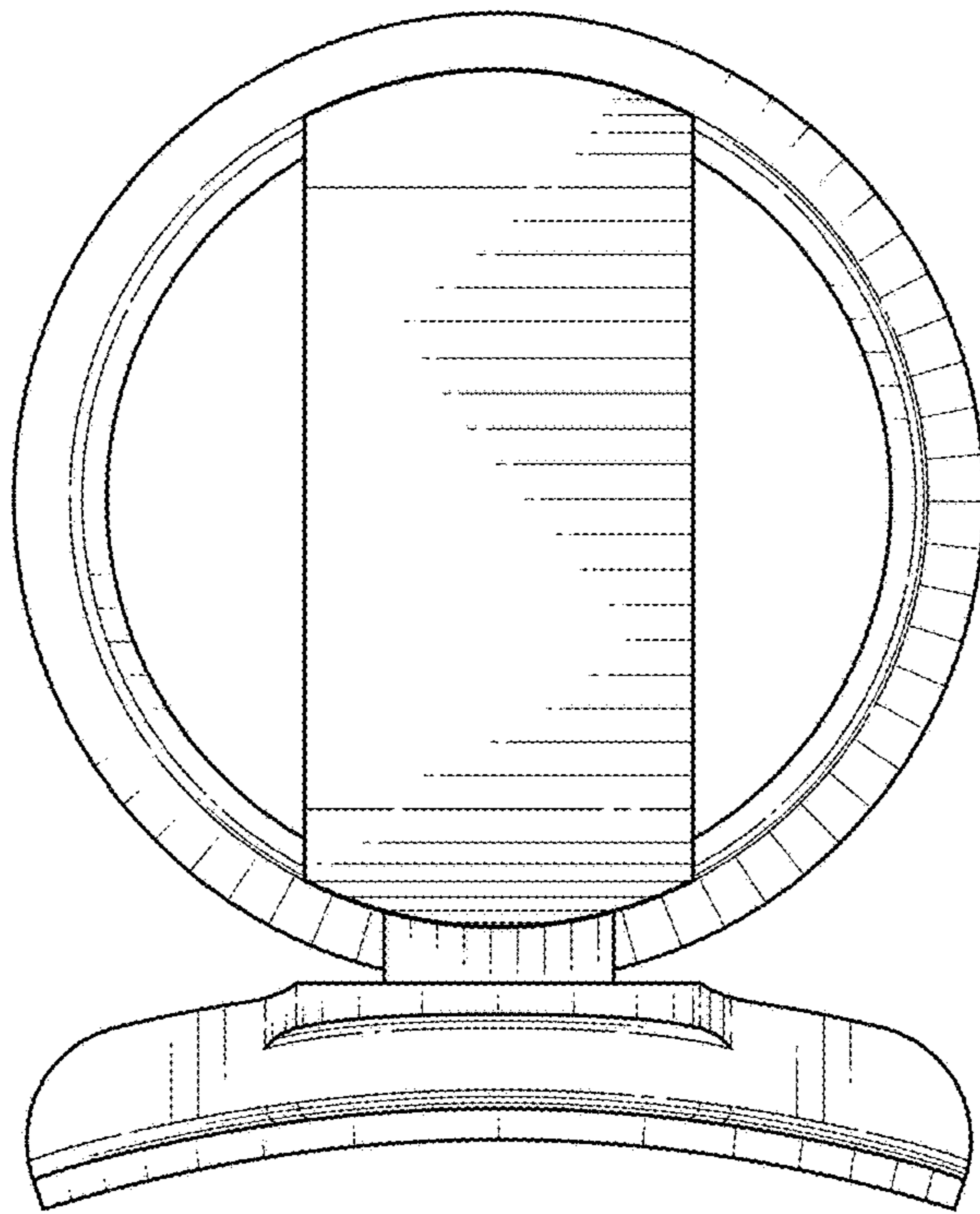
