FIG. 15 is a bottom view thereof.

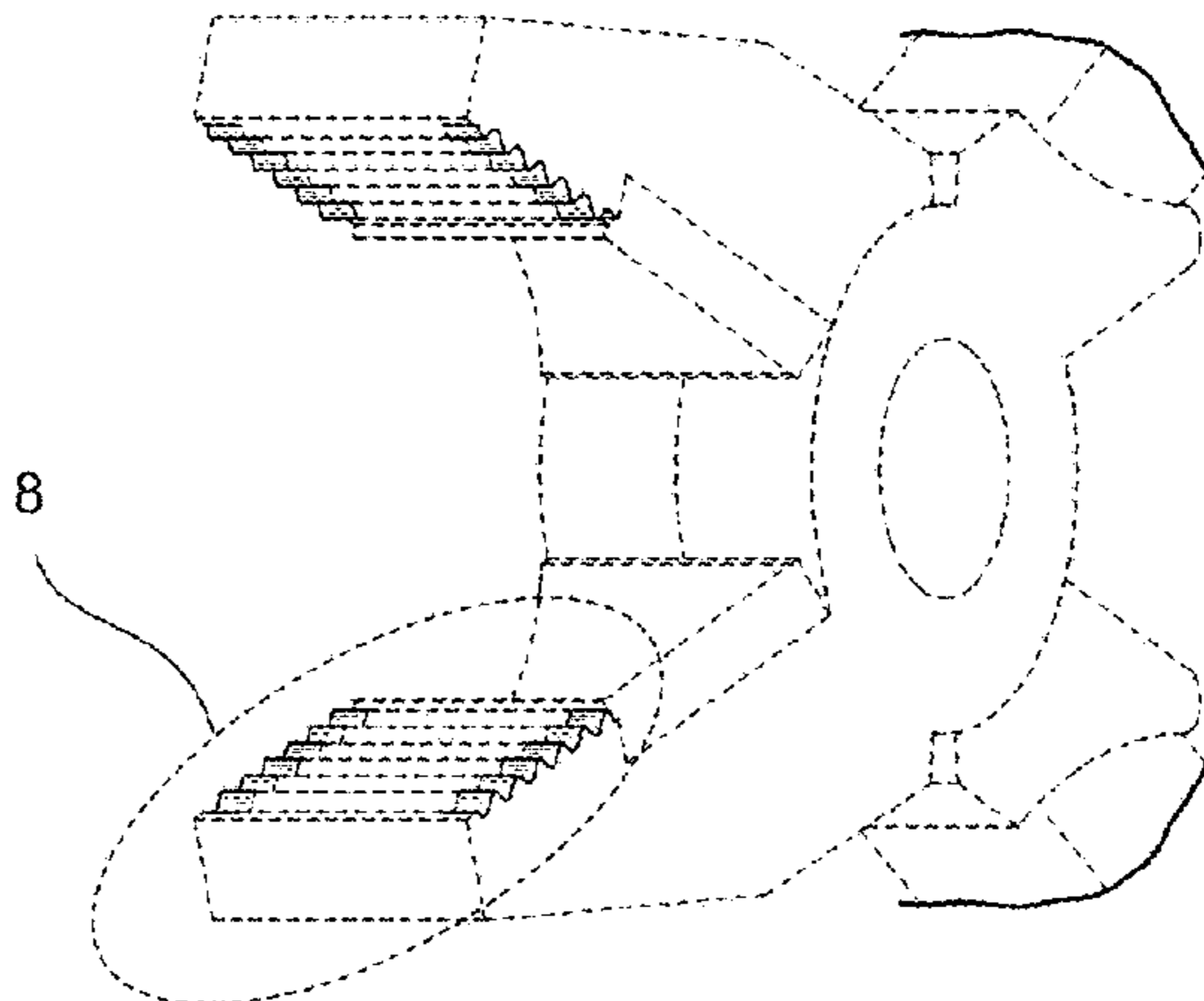
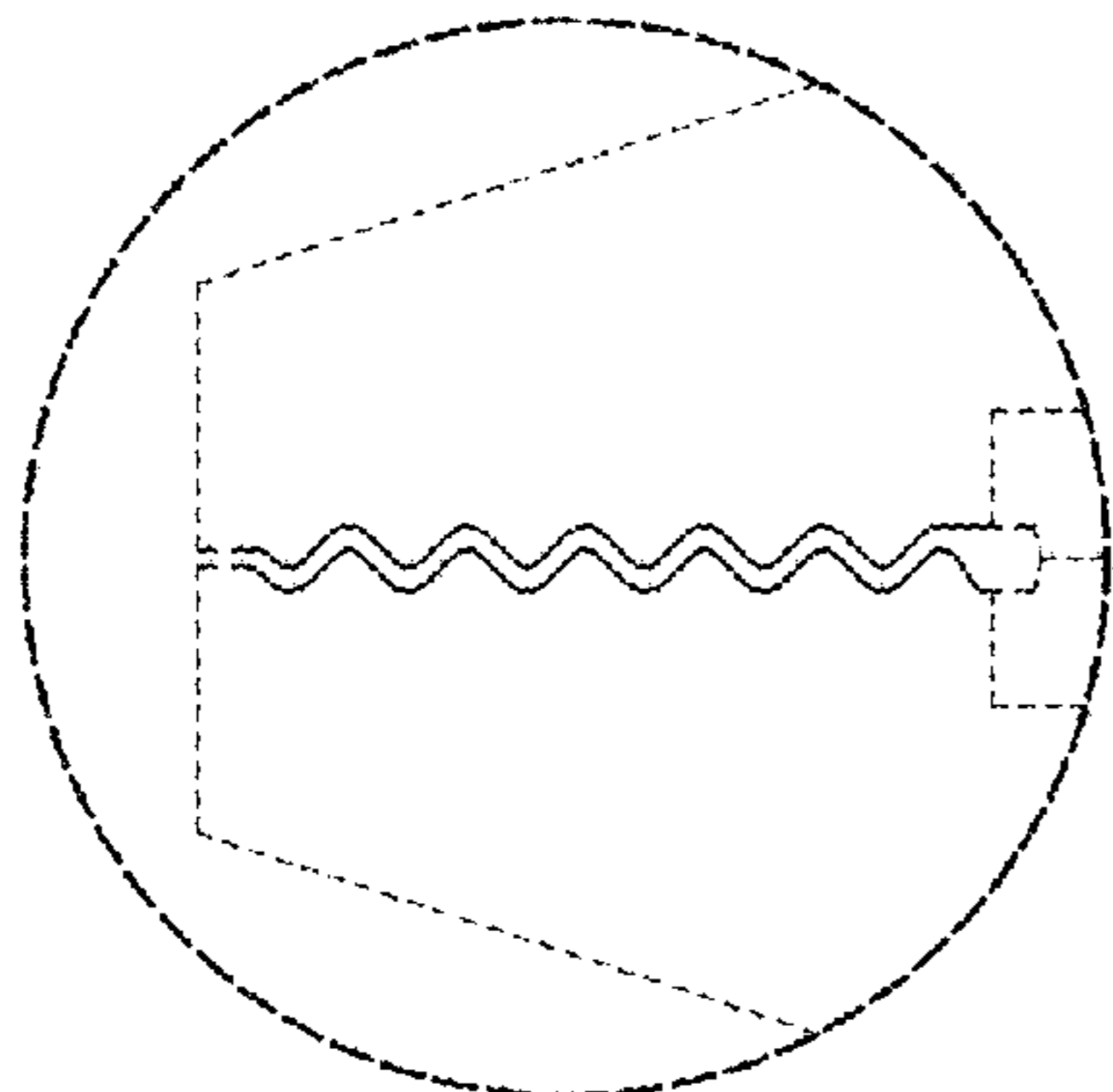
FIG. 16 is an enlarged view of the area indicated in FIG. 10.

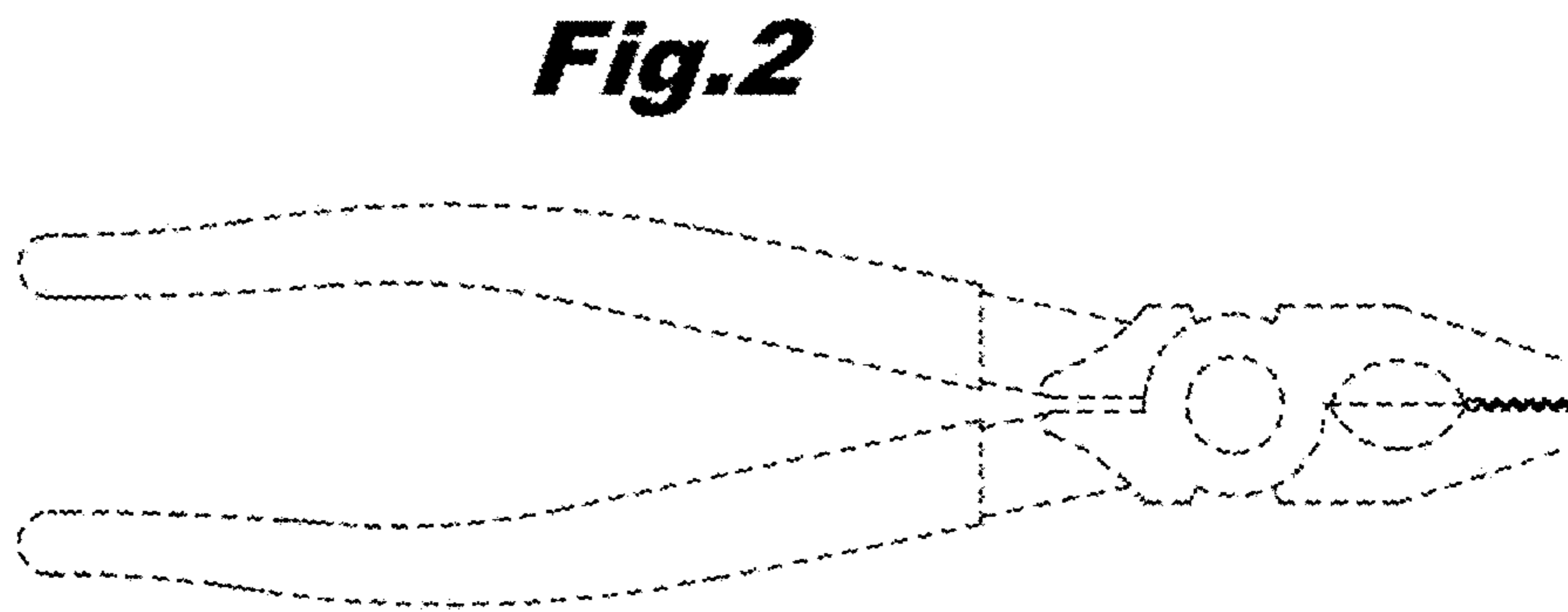
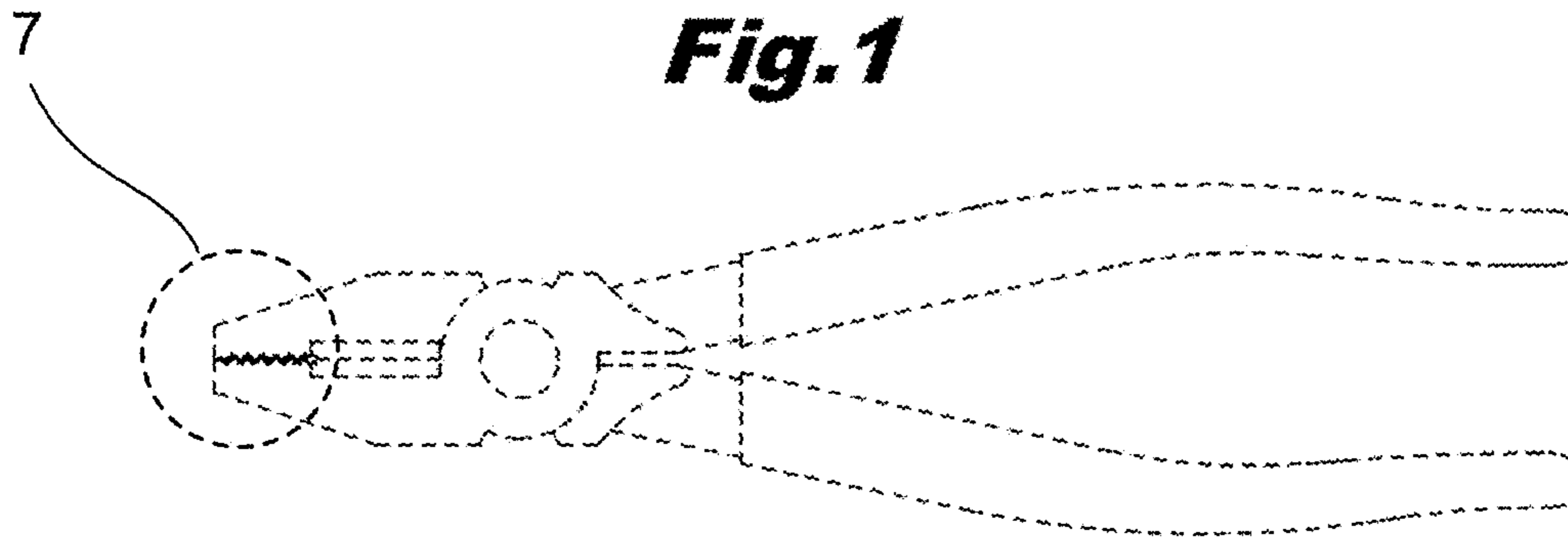

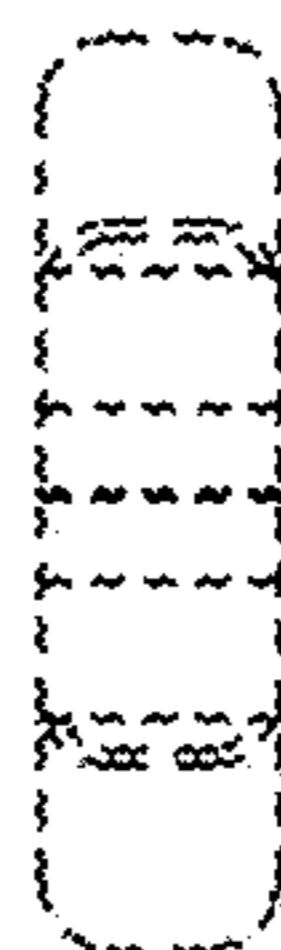

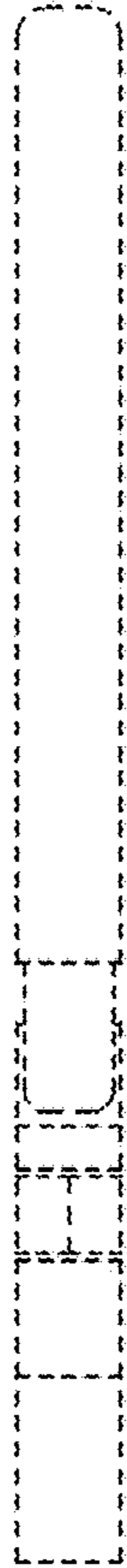

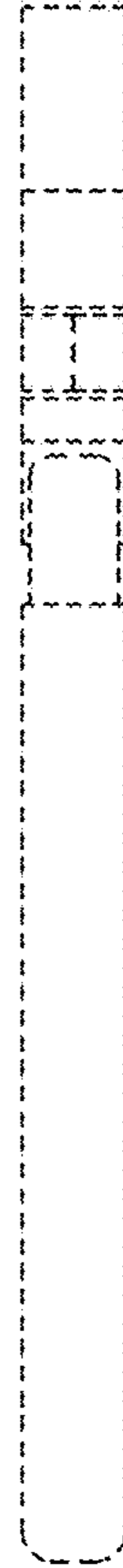

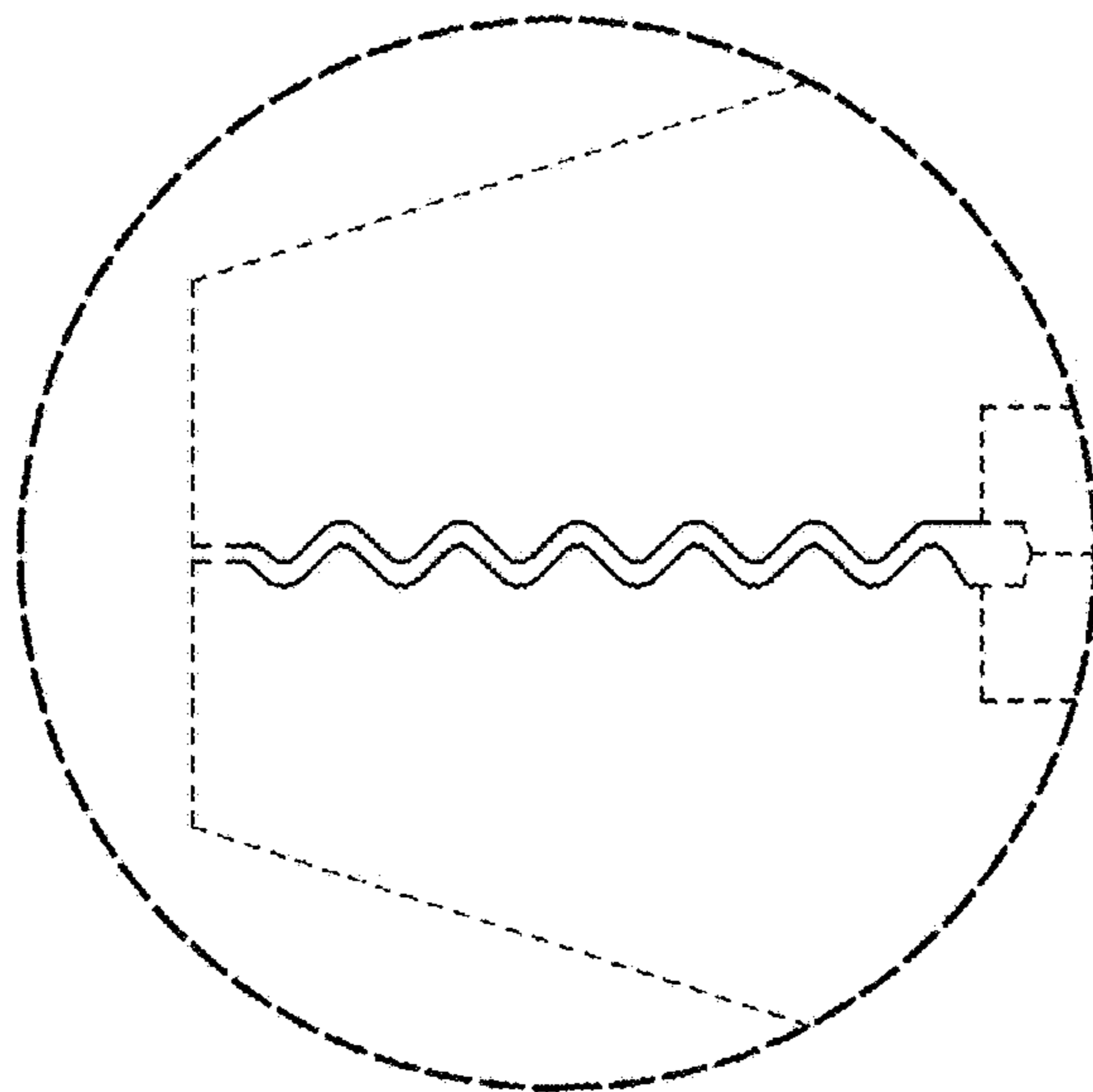

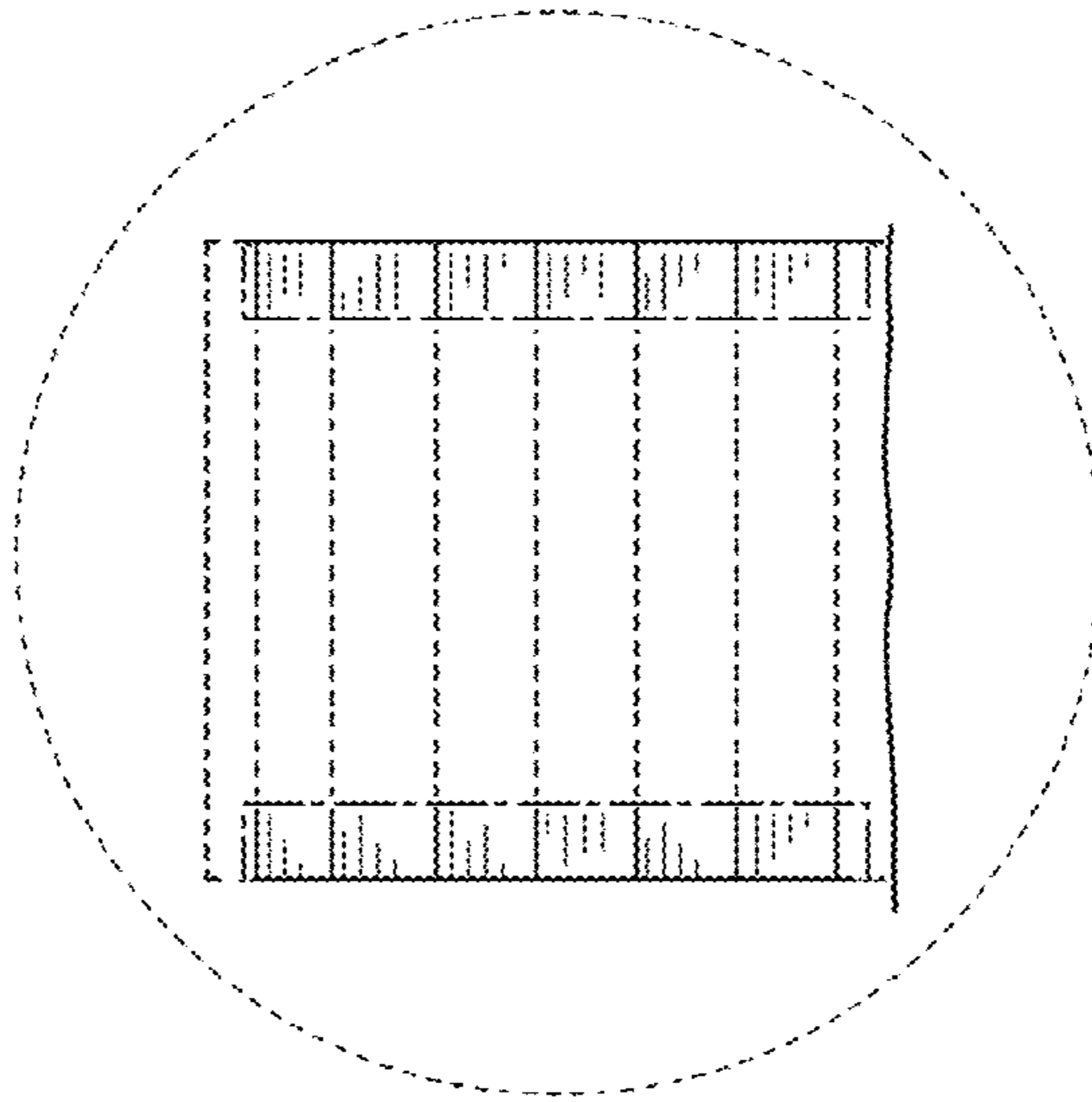

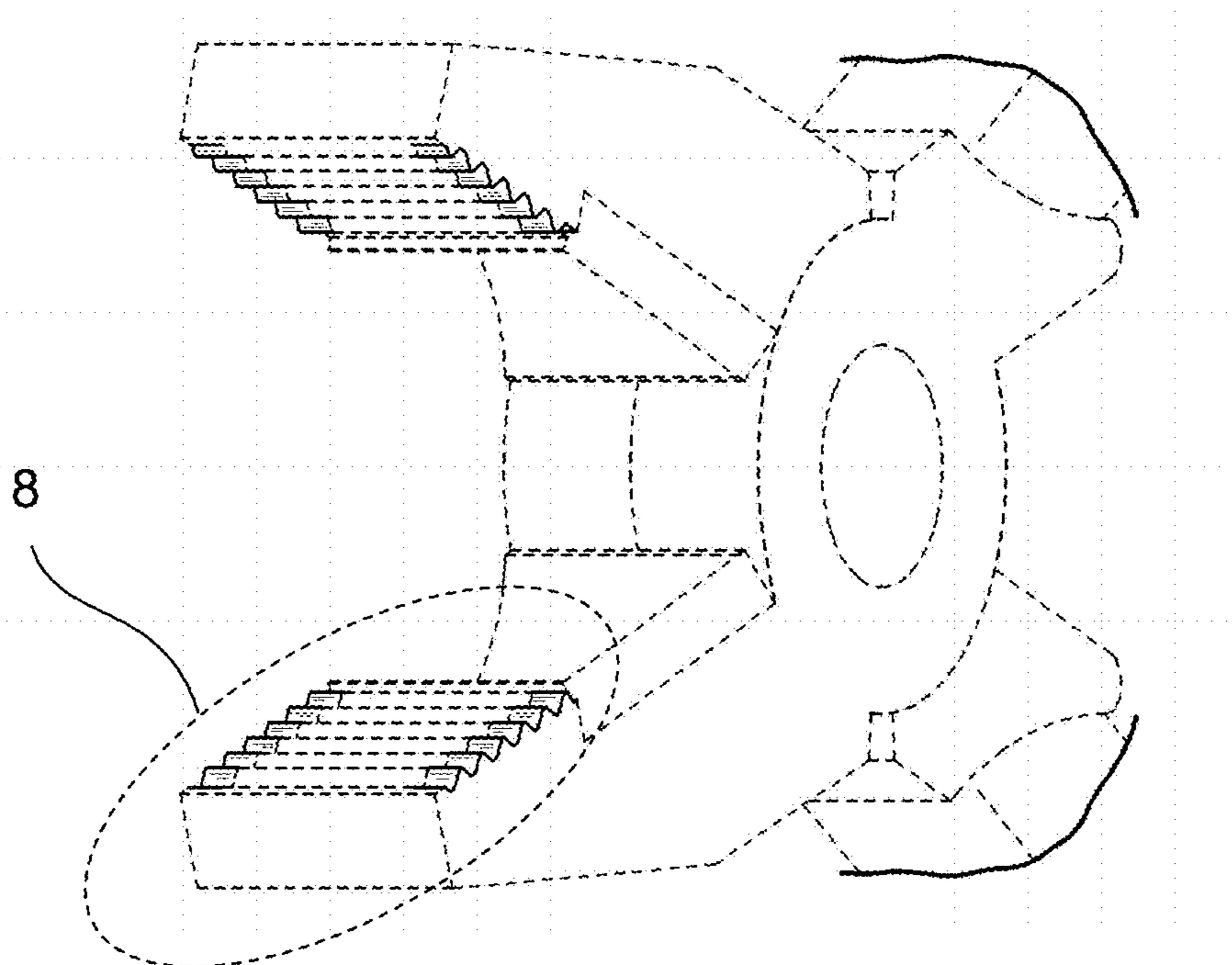

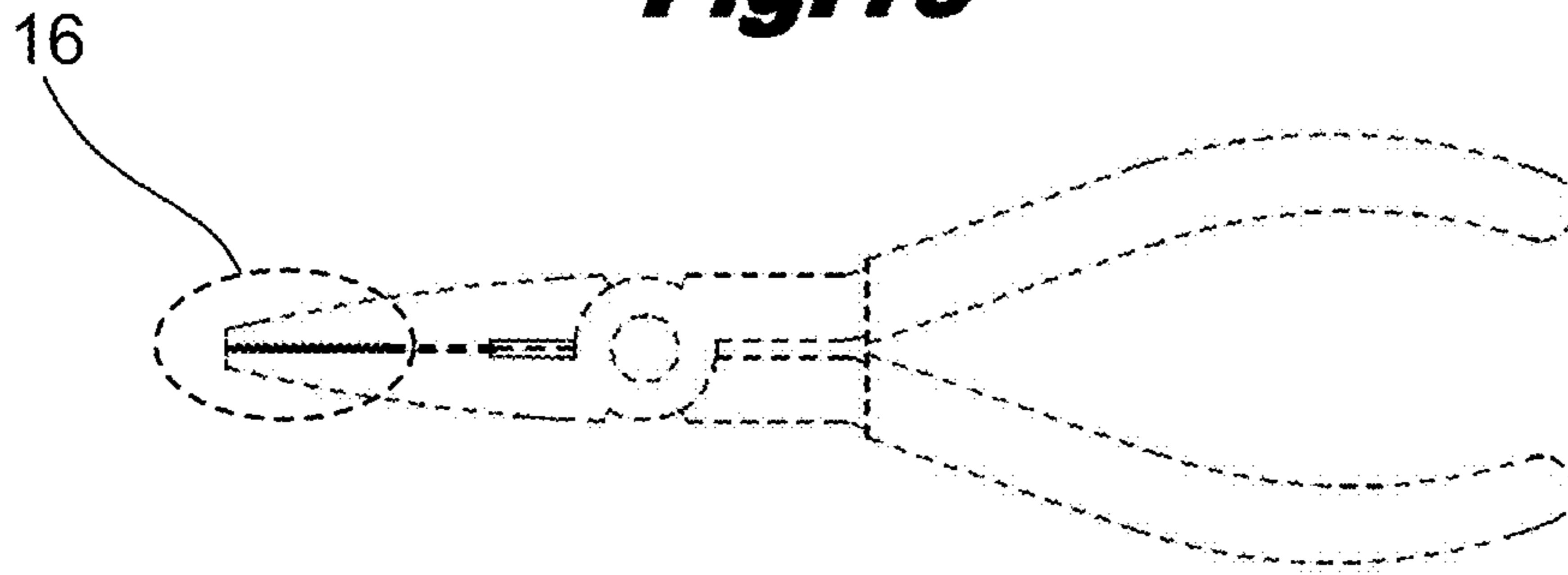

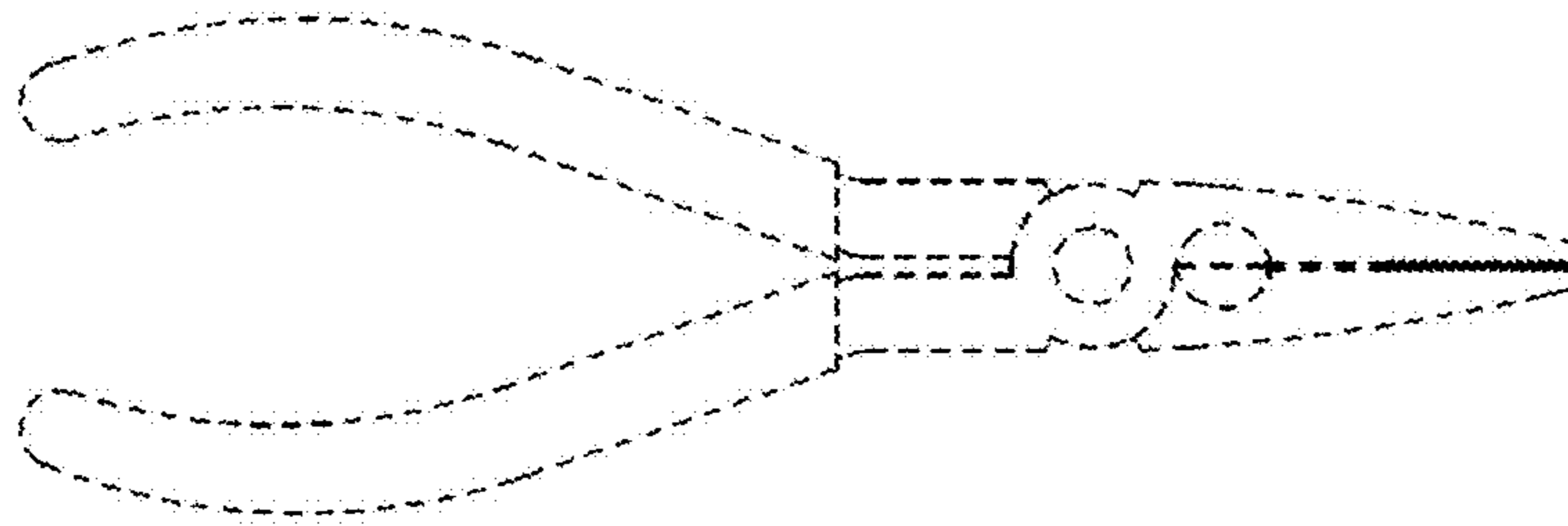

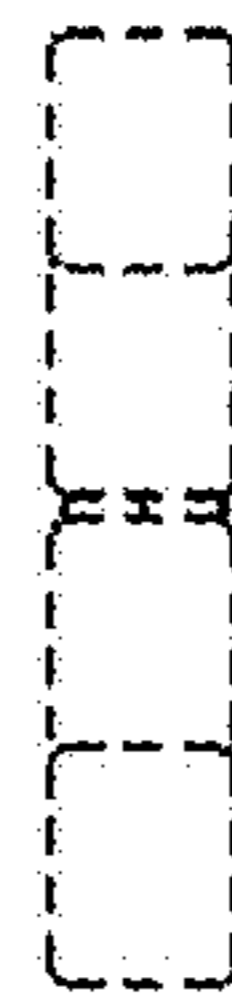

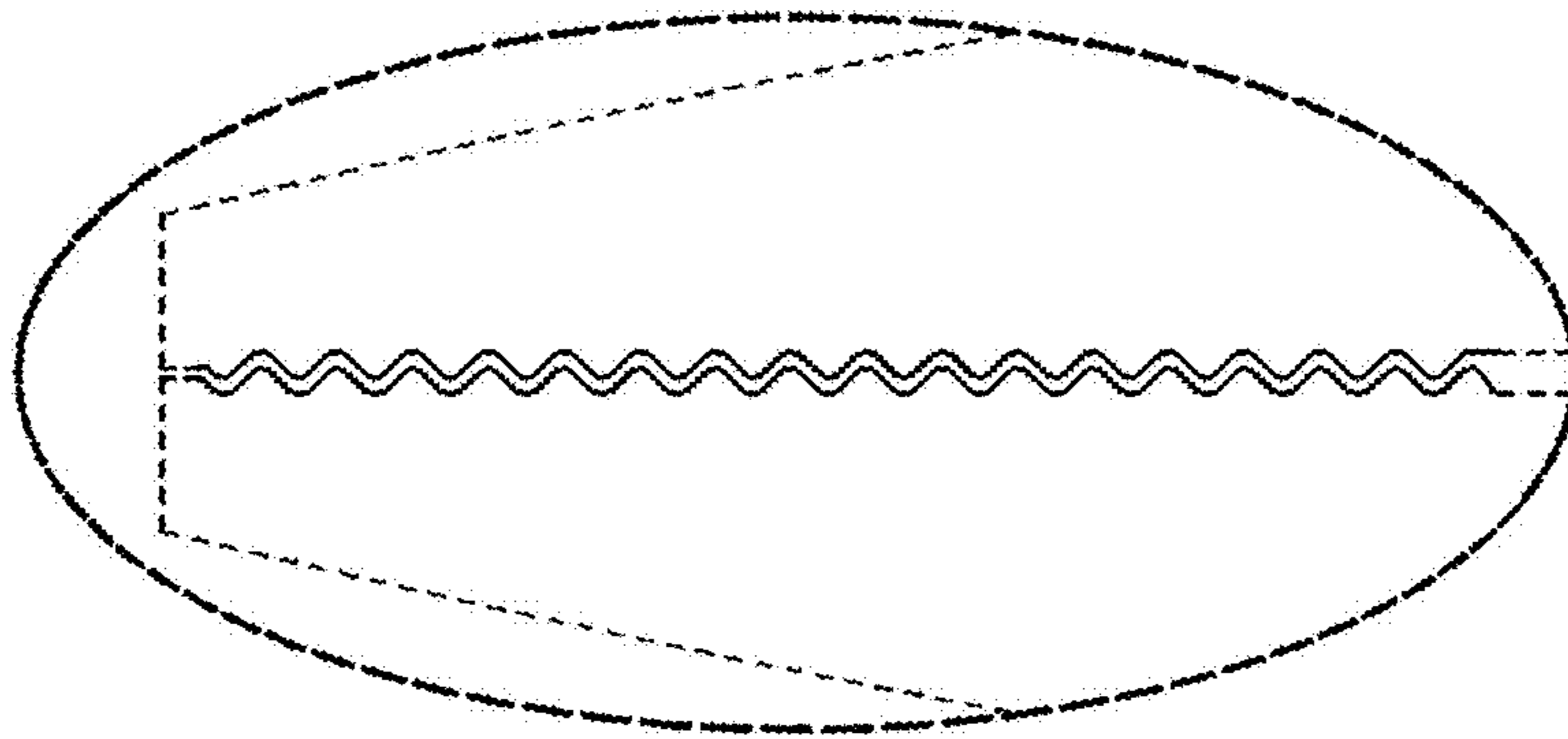

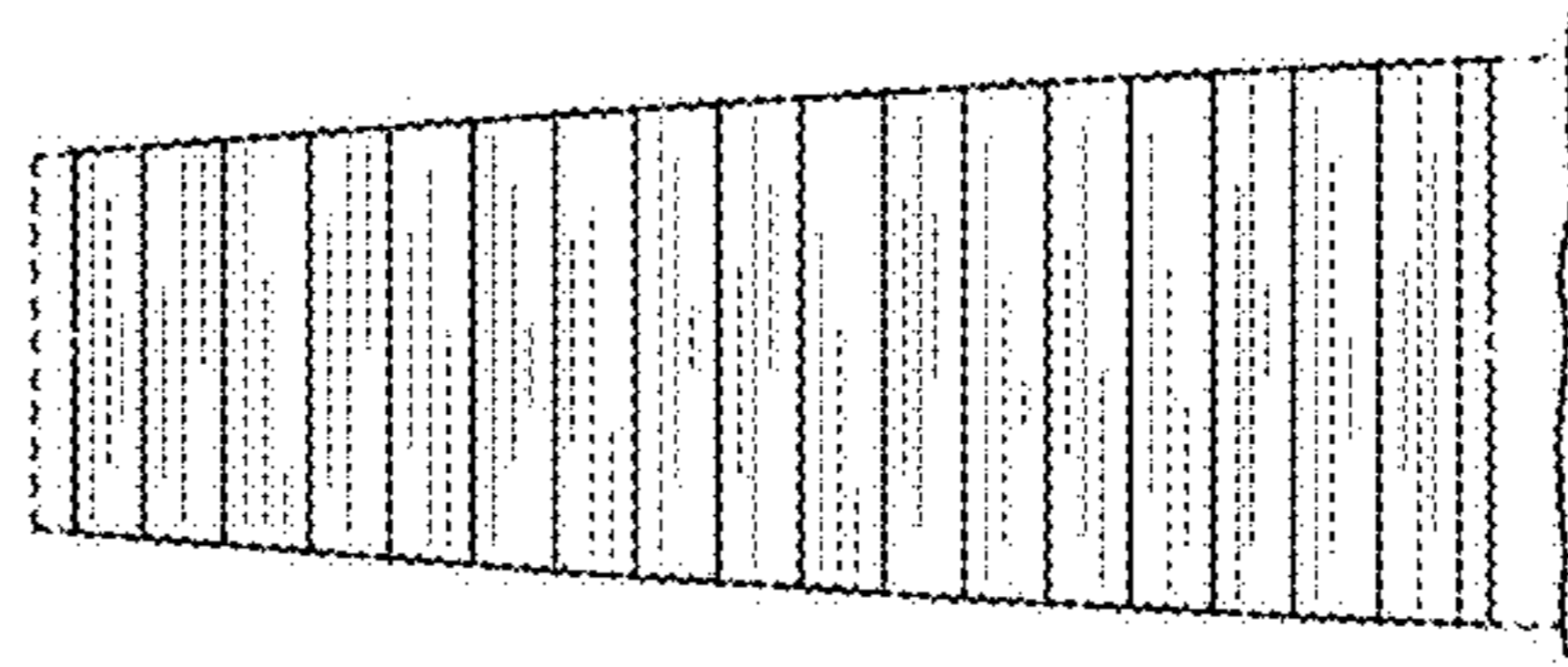
