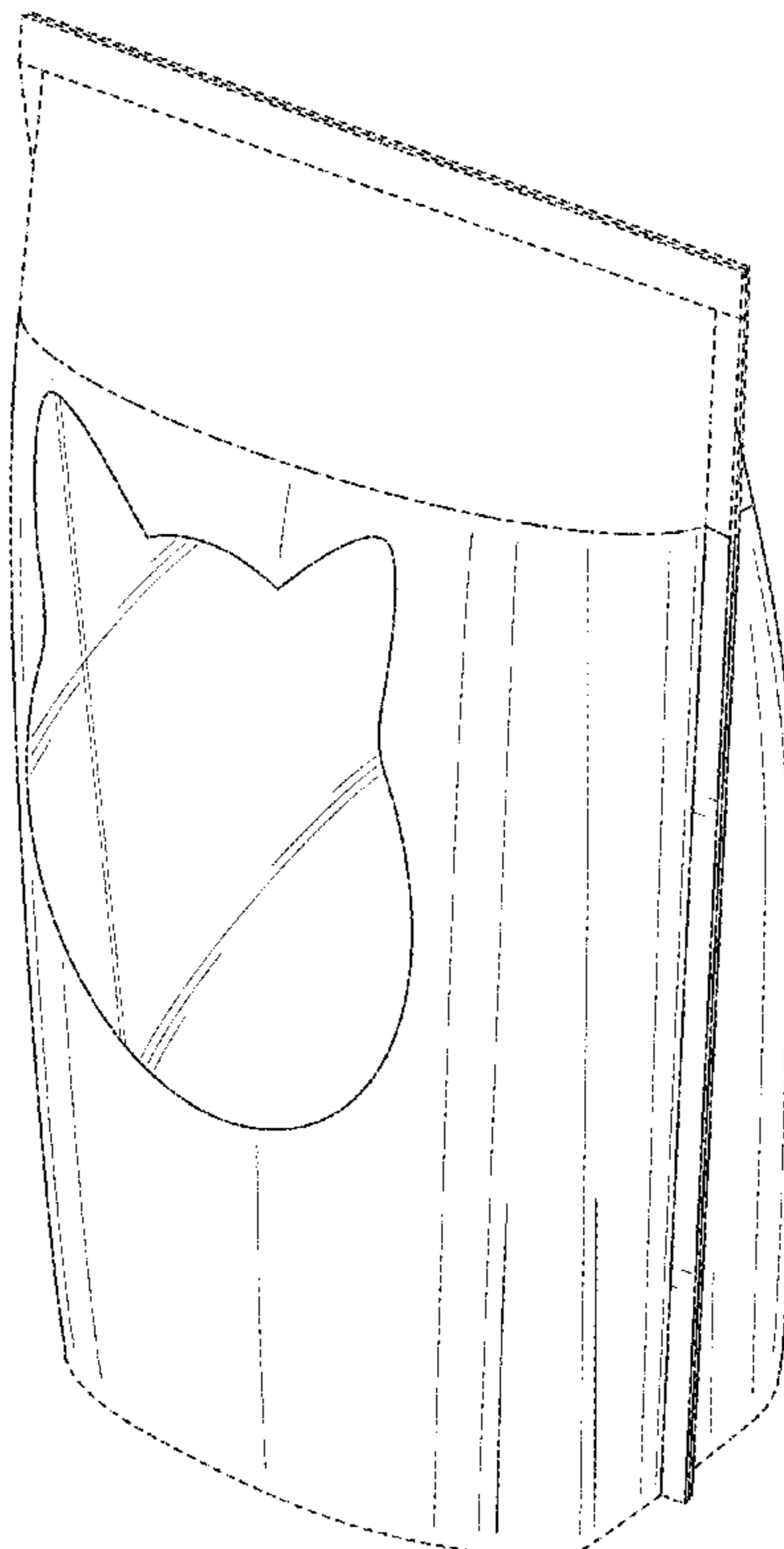
(57) **CLAIM**

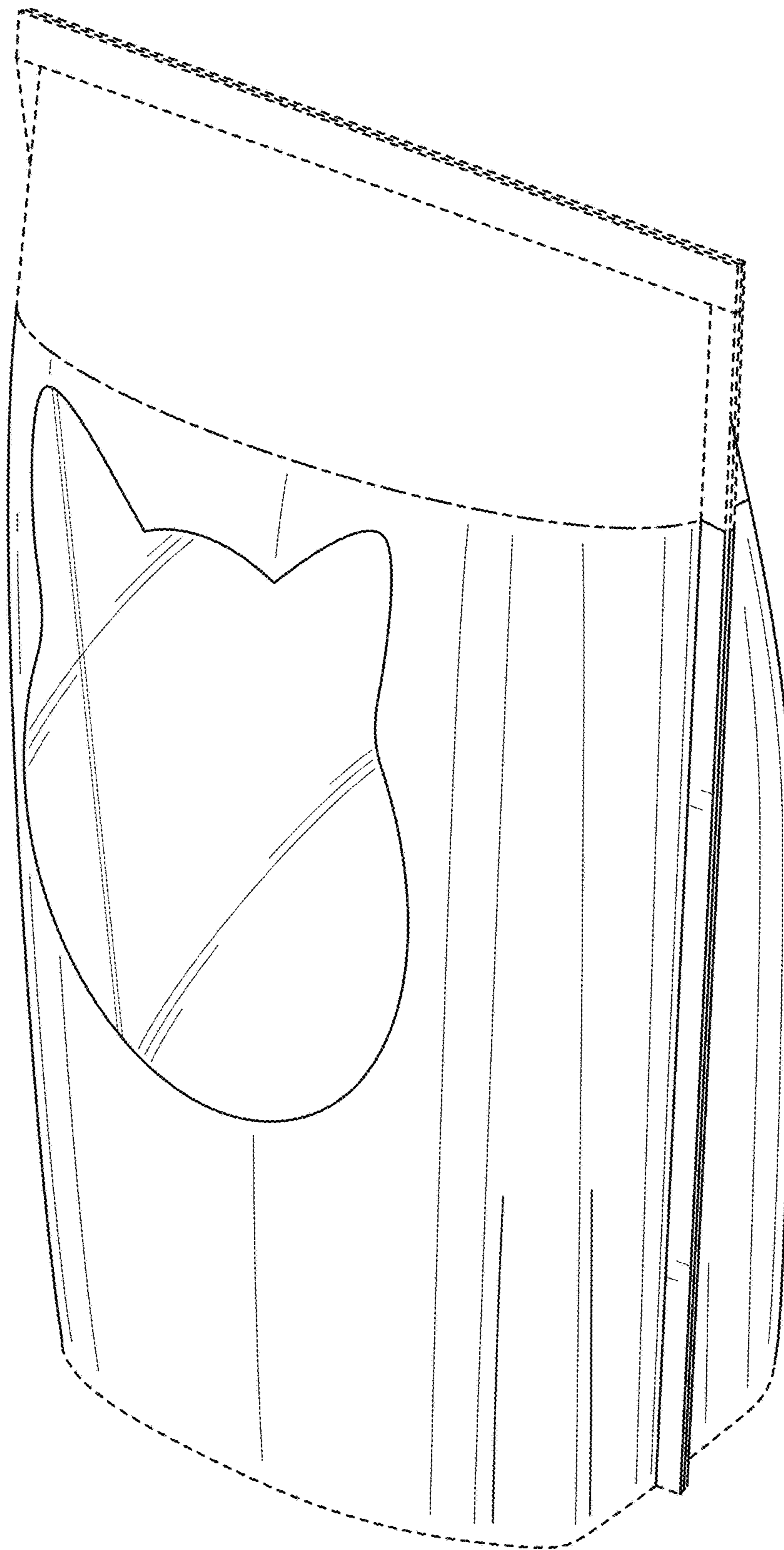
I claim the ornamental design for cat litter packaging, as shown and described.

**DESCRIPTION**

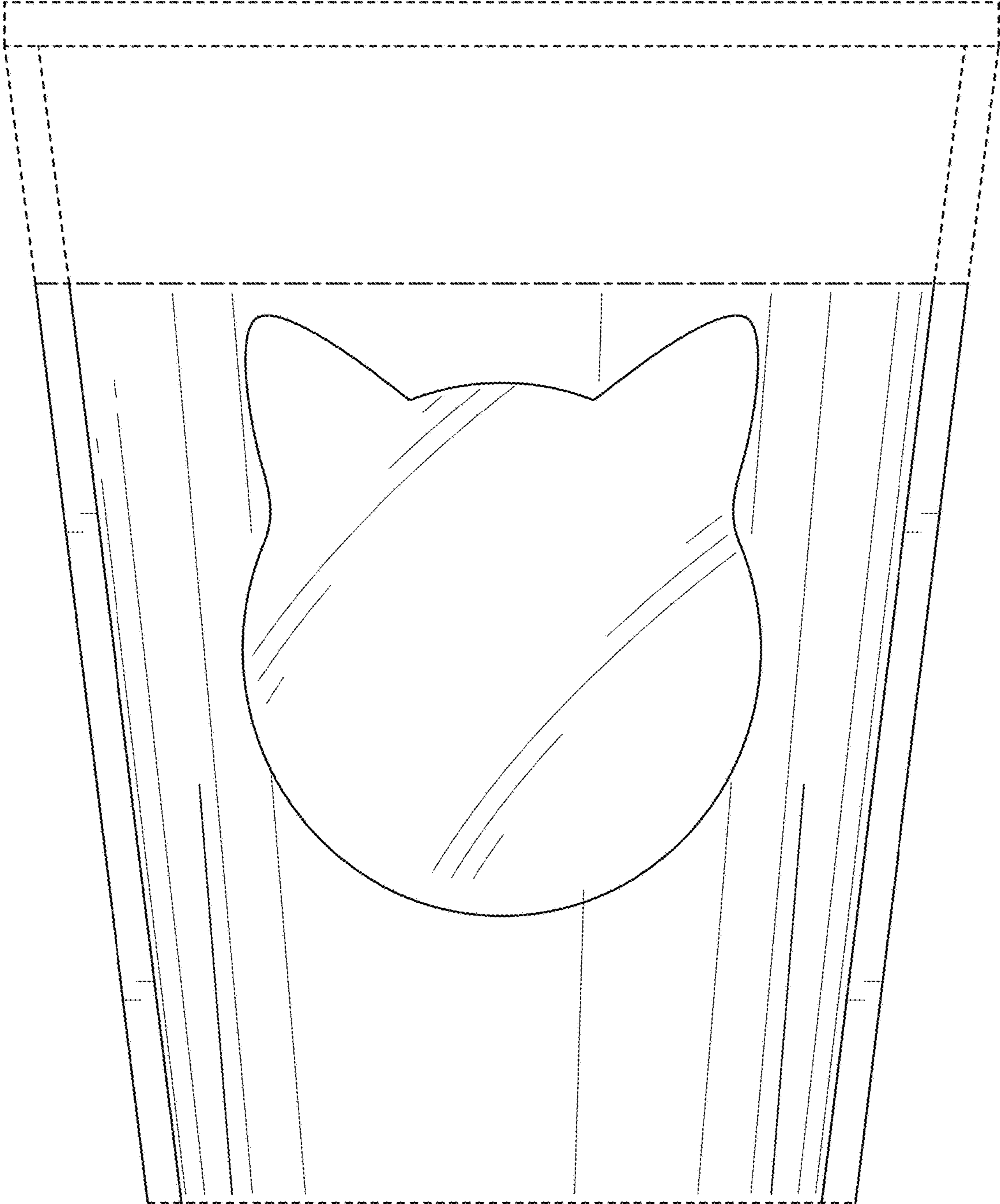
FIG. 1 is a front isometric view of an embodiment of cat litter packaging showing my new design.

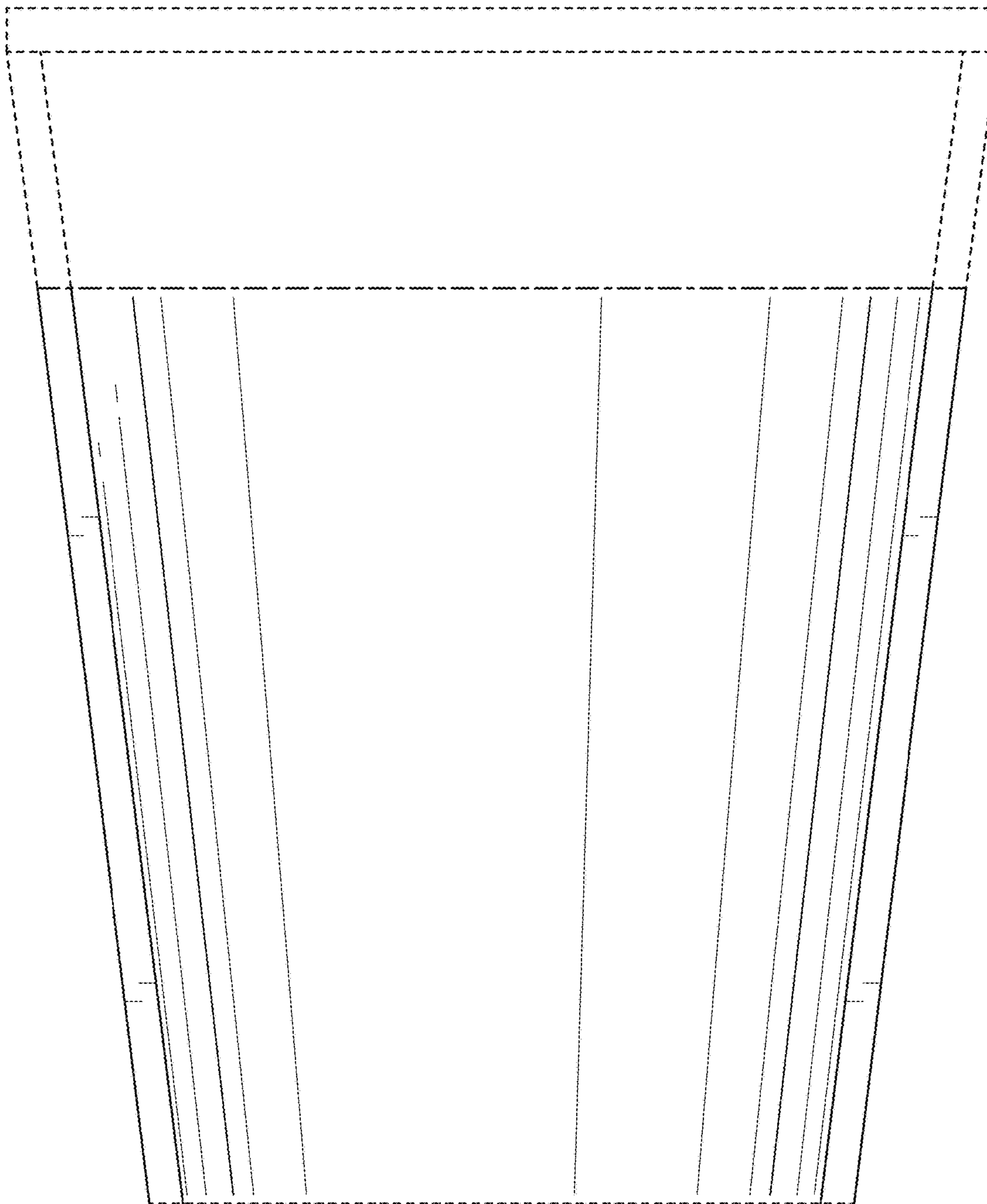

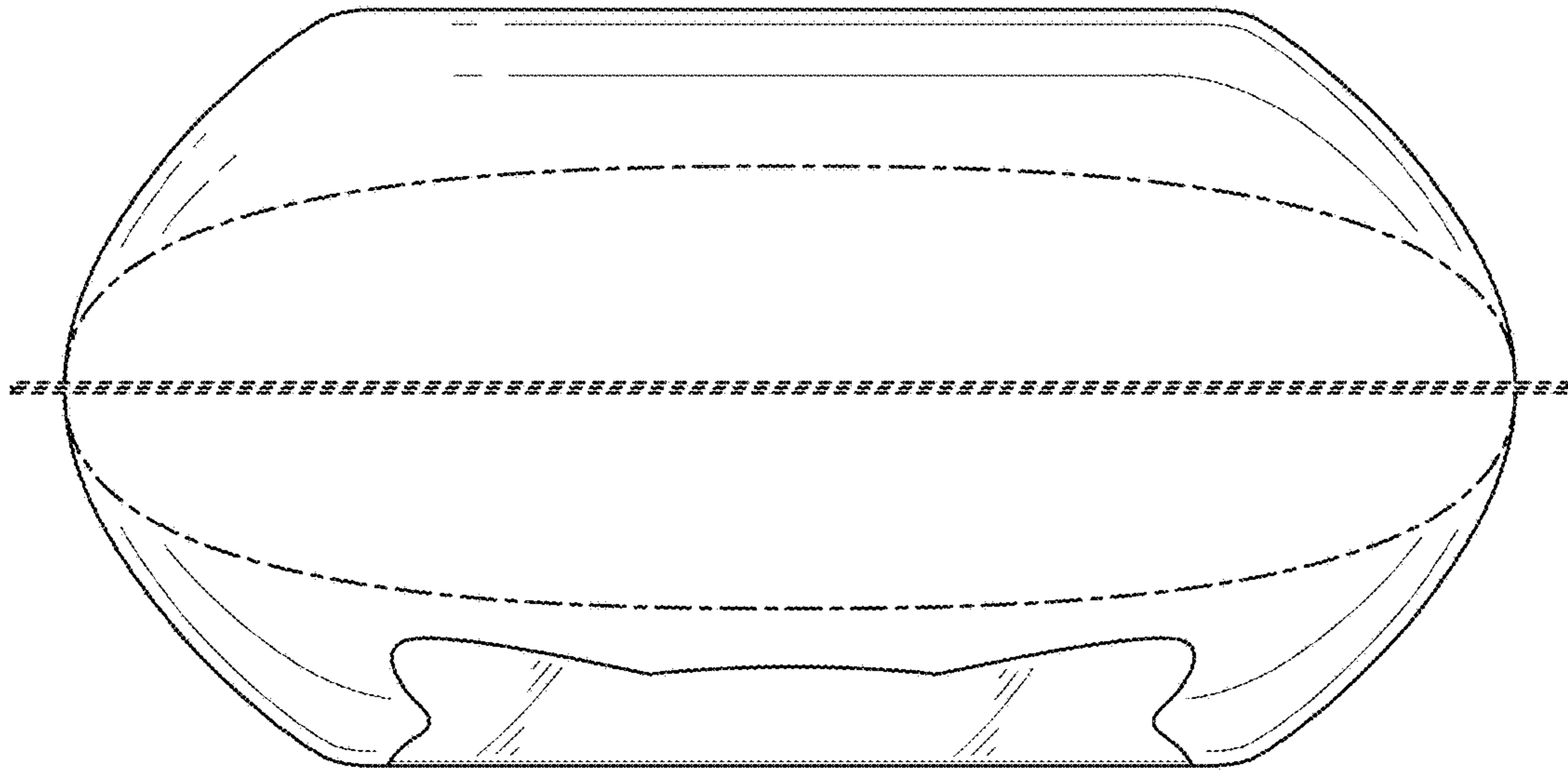
