DESCRIPTION

FIG. 1 is a perspective view of a basketball embedded in a wall.

FIG. 2 is a front elevational view of the basketball embedded in a wall thereof;

FIG. 3 is a top plan view thereof;

FIG. 4 is a bottom plan view;

FIG. 5 is a left side elevational view thereof; and,

FIG. 6 is a right side elevational view thereof.

The broken lines making up the perimeter of the article are shown broken away to indicate that they have no particular length other than what is shown.

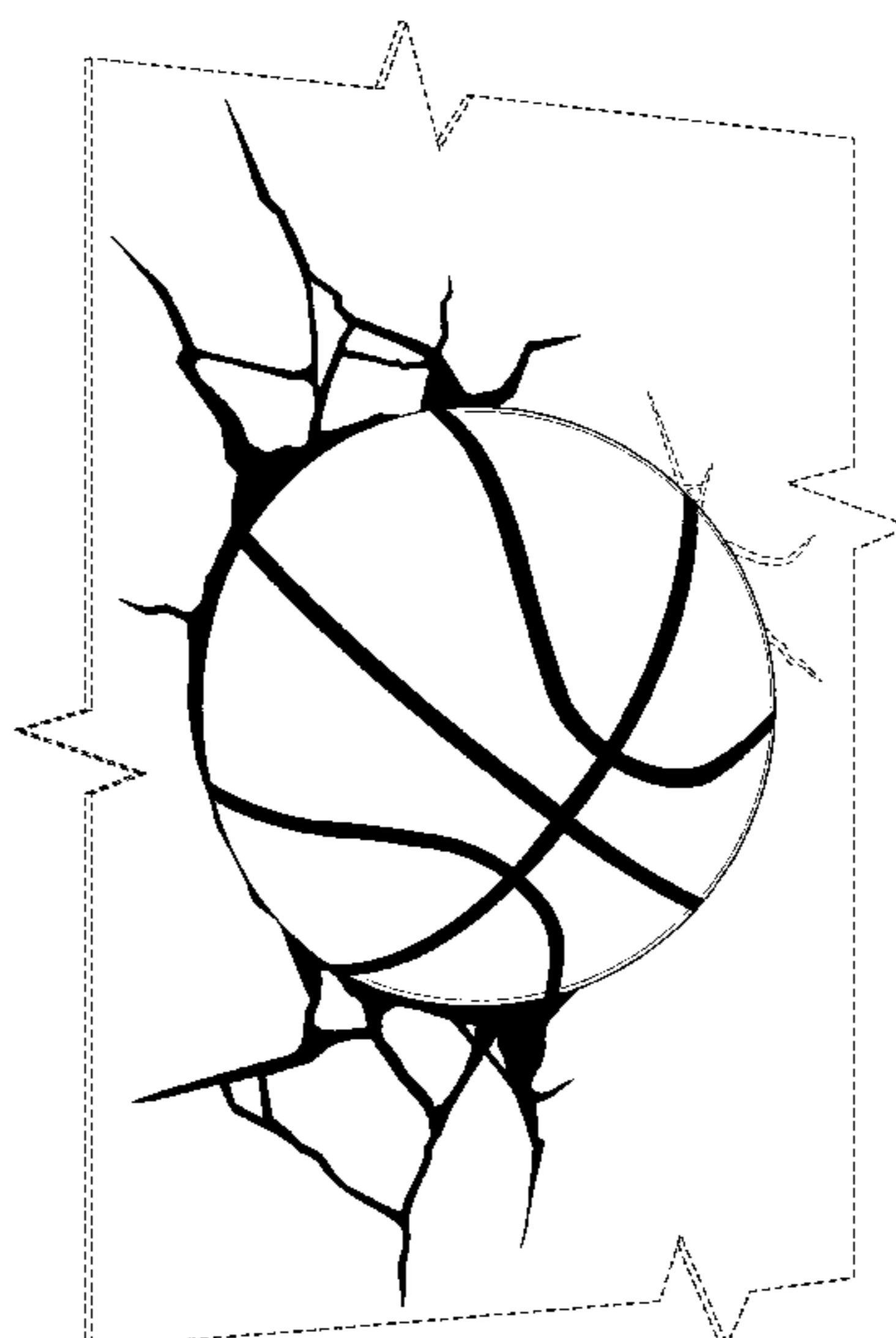
The features shown in broken lines do not form part of the claimed design.

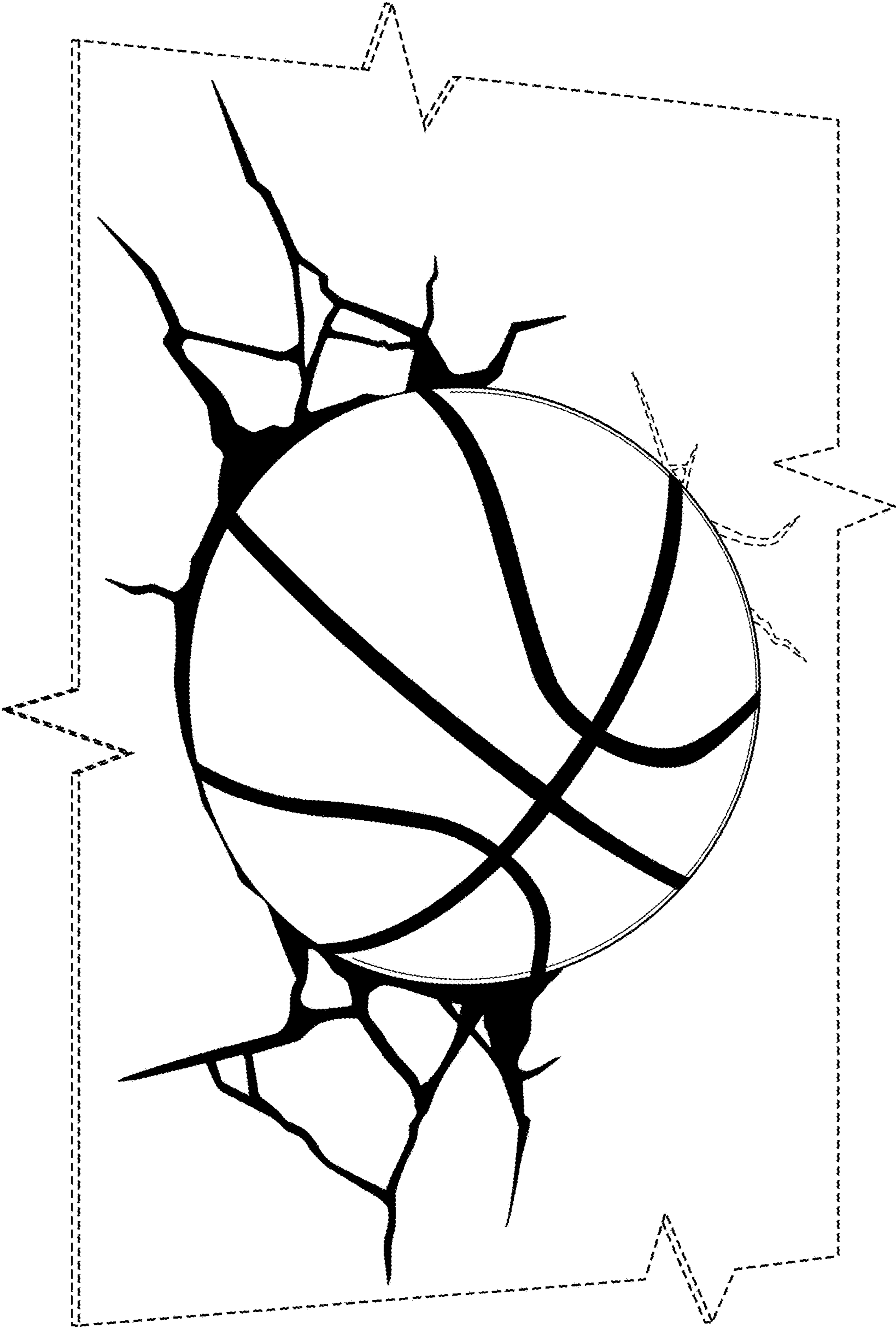

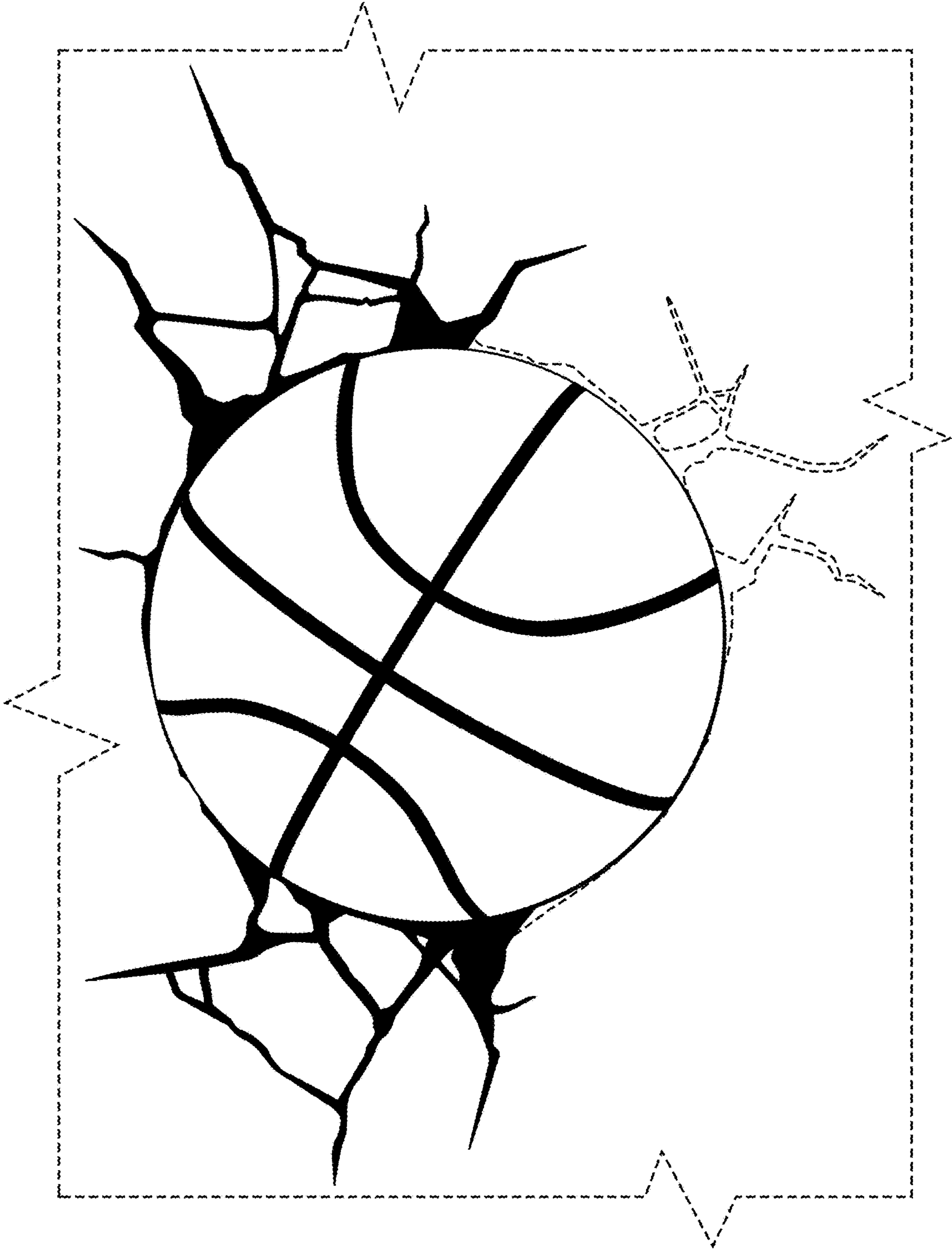

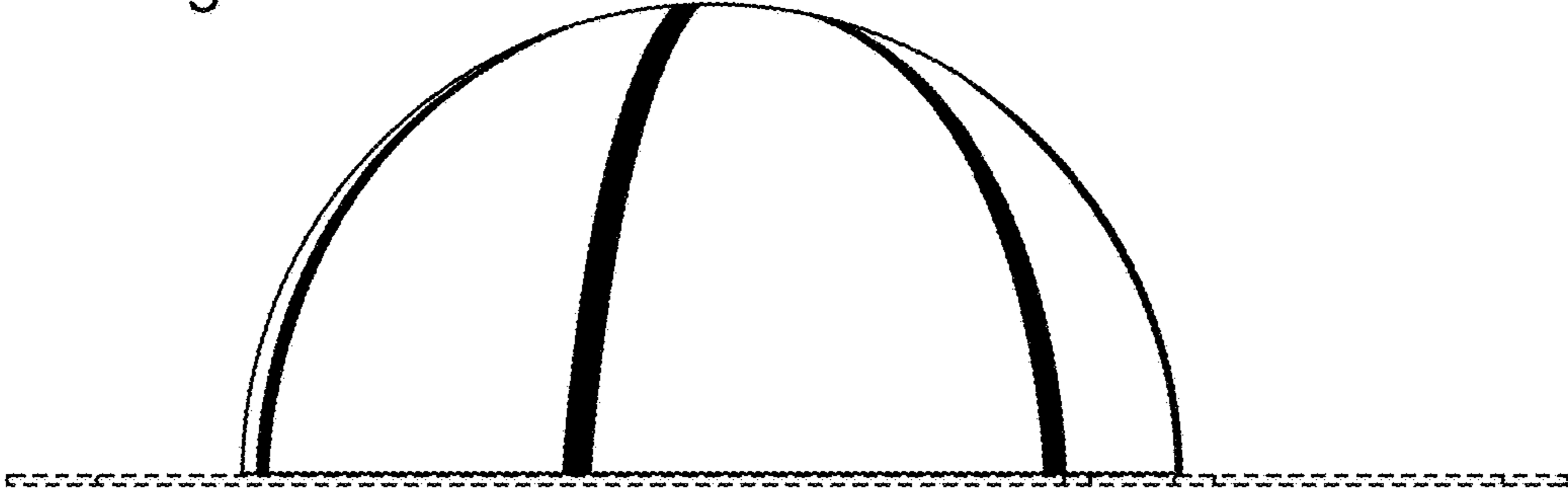

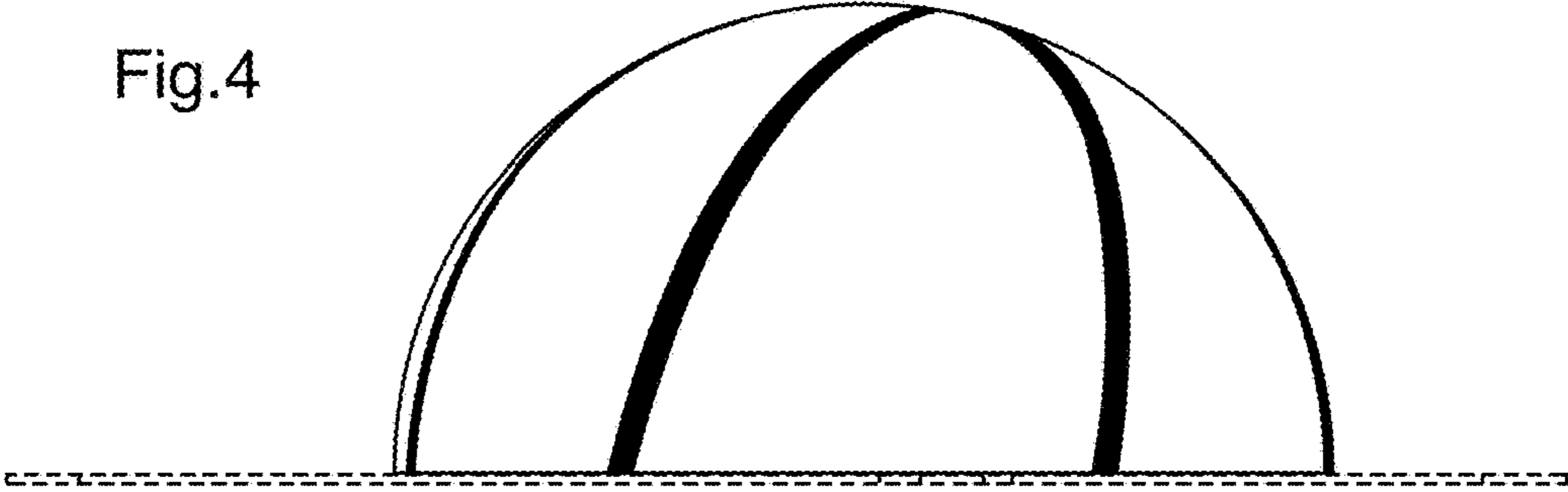

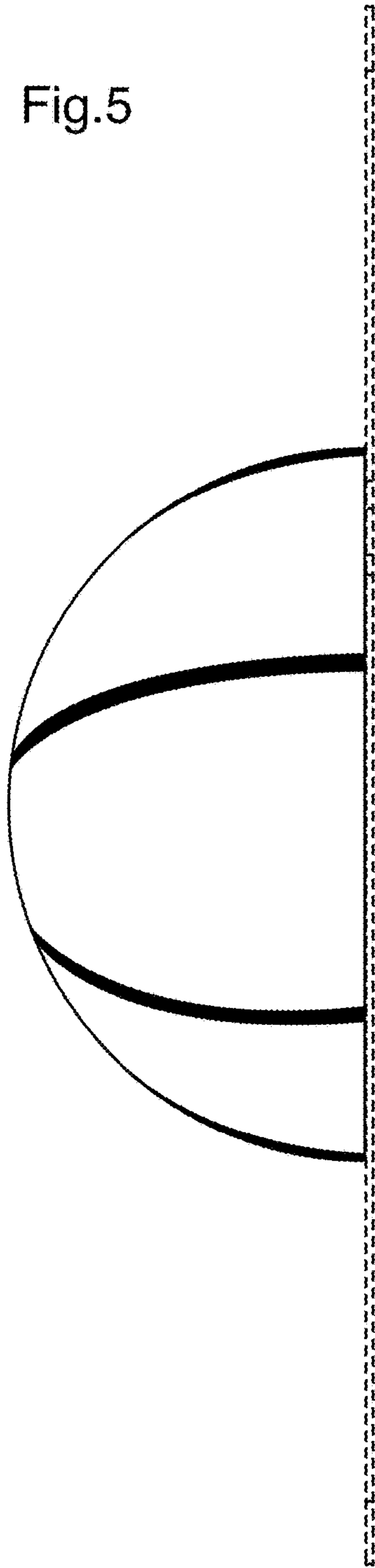
