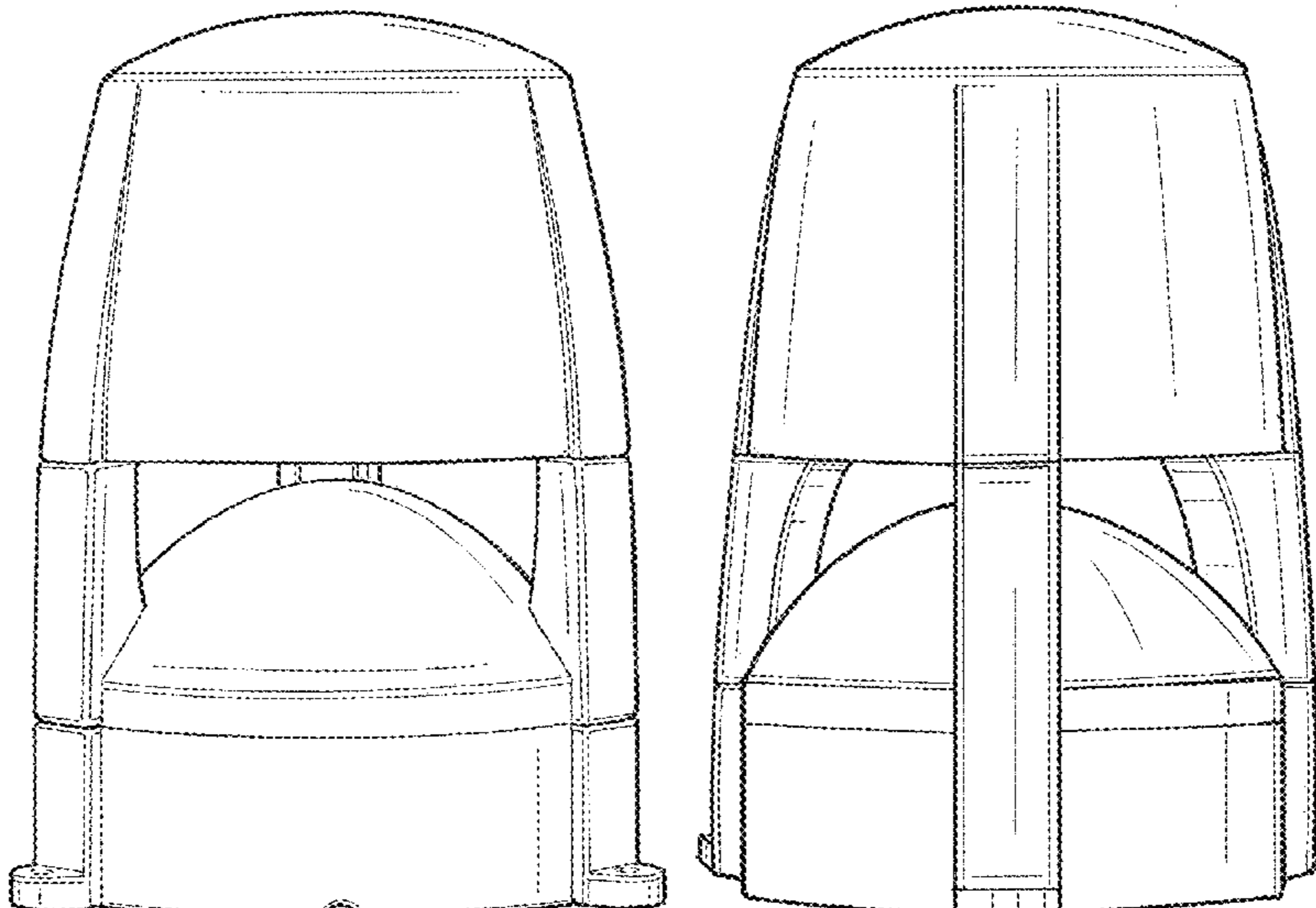
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is a top perspective view of a loudspeaker showing our new design;

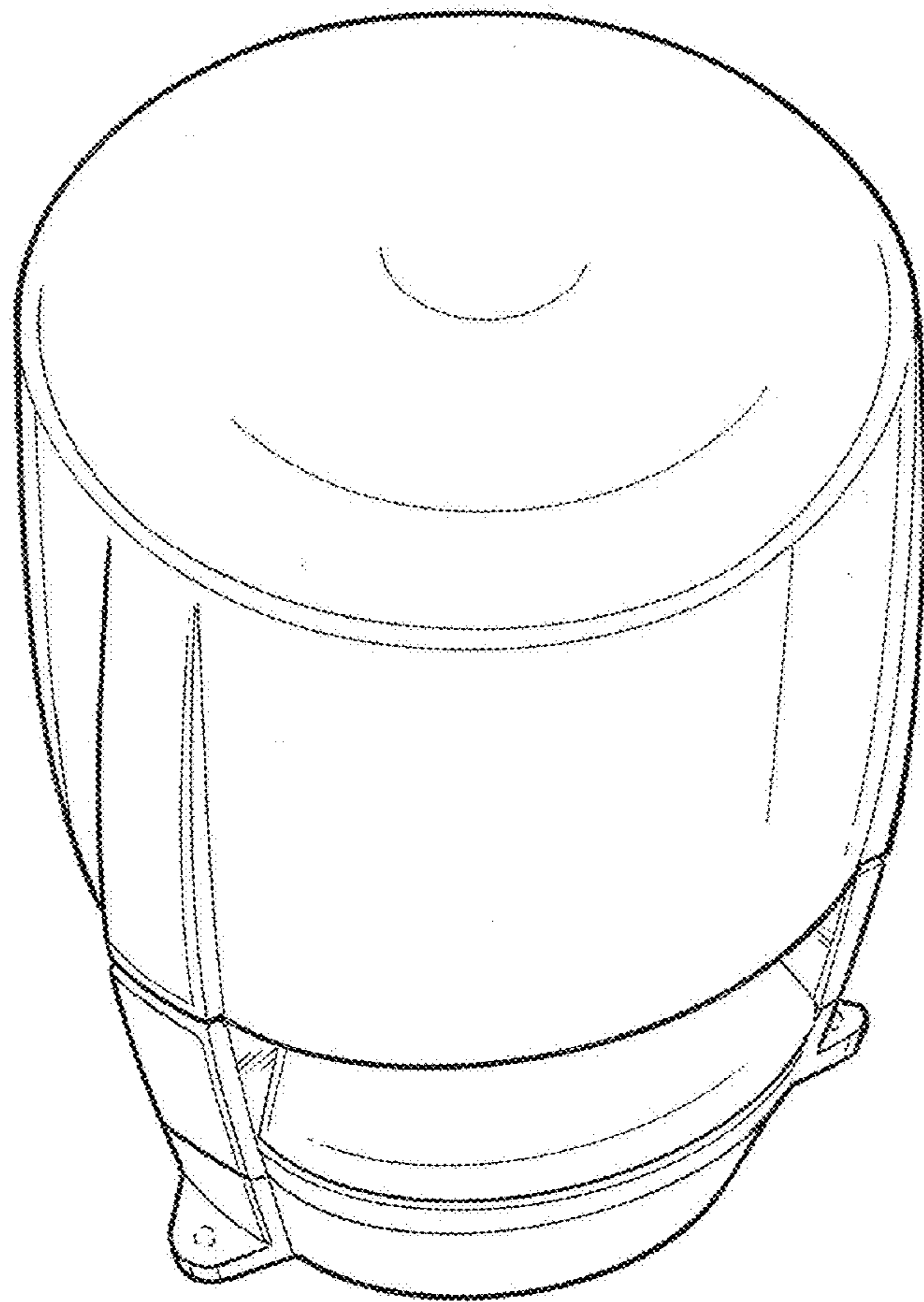

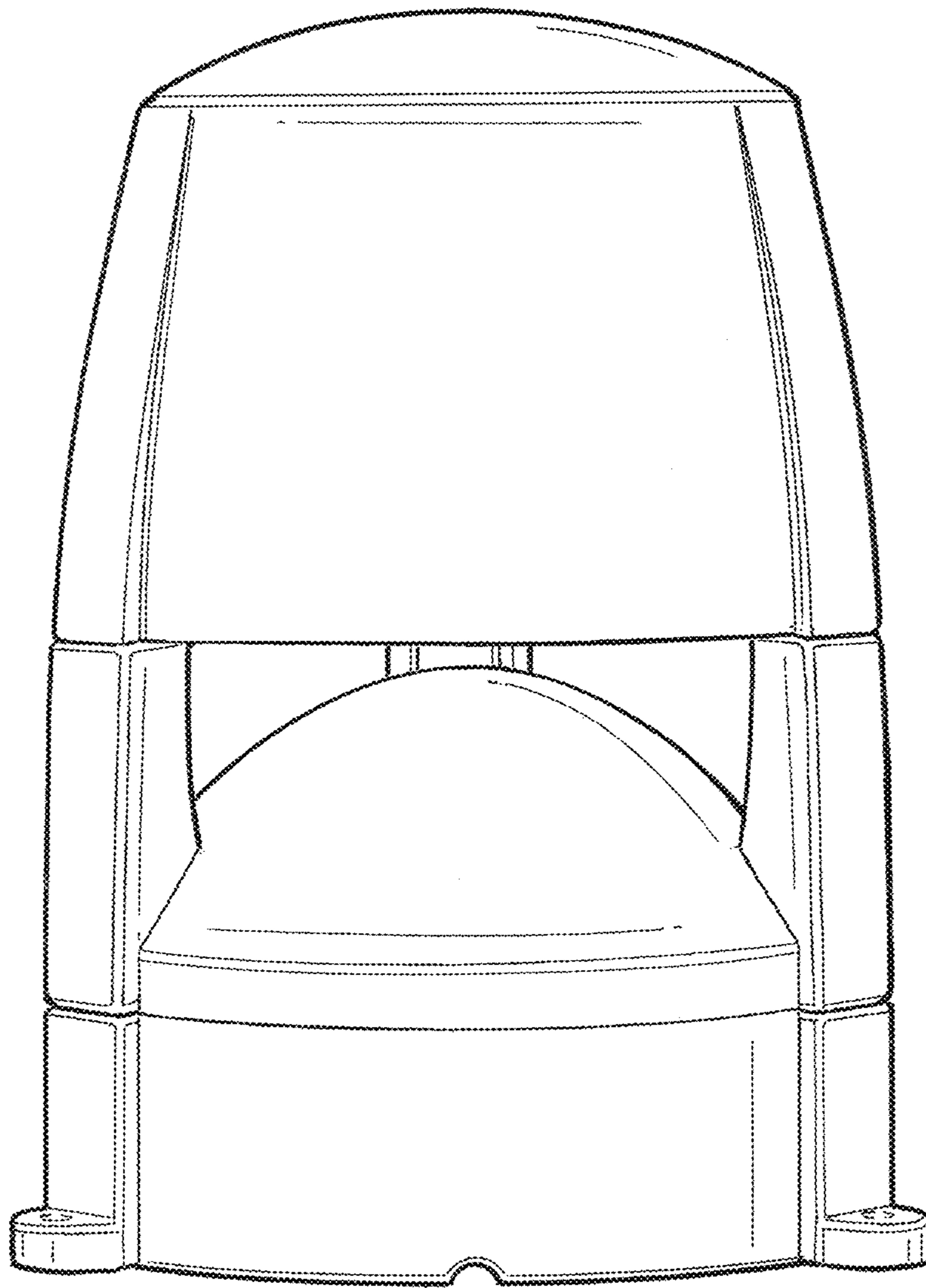

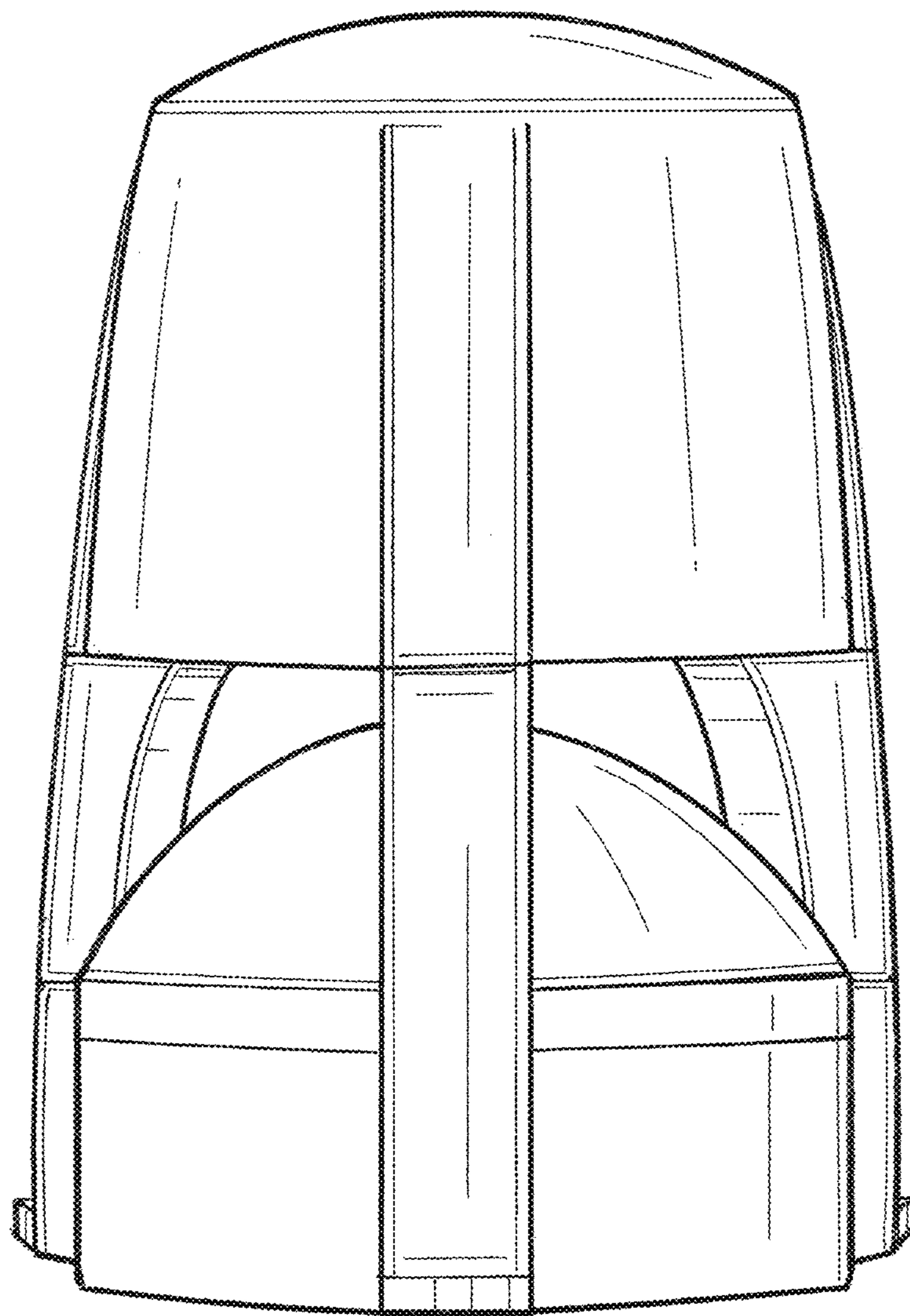

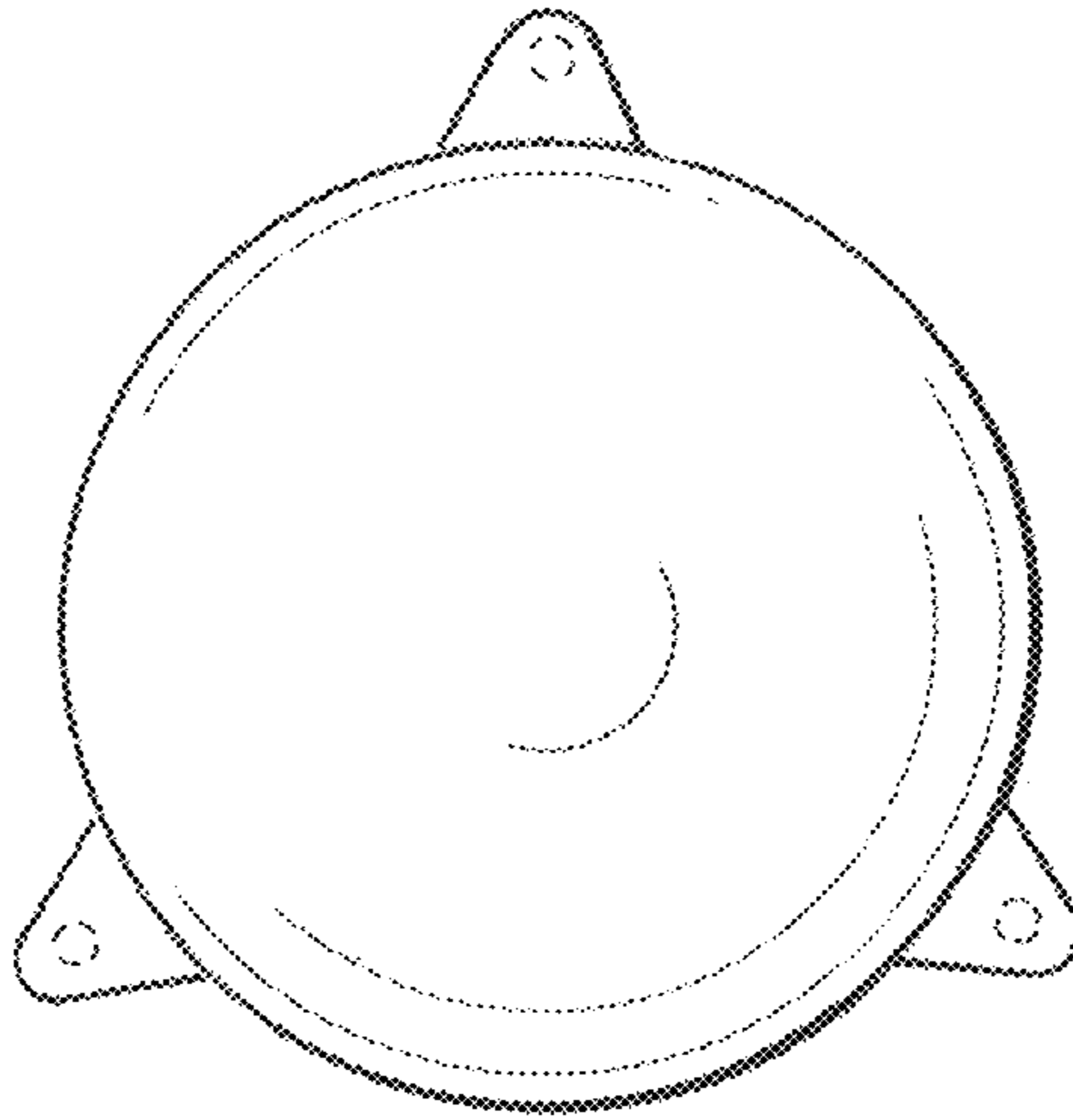
