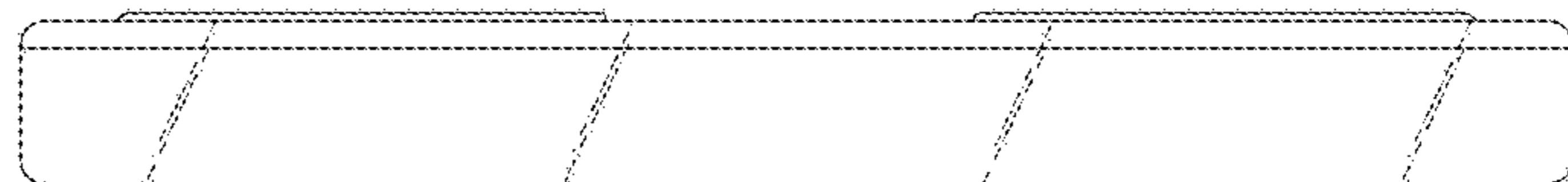
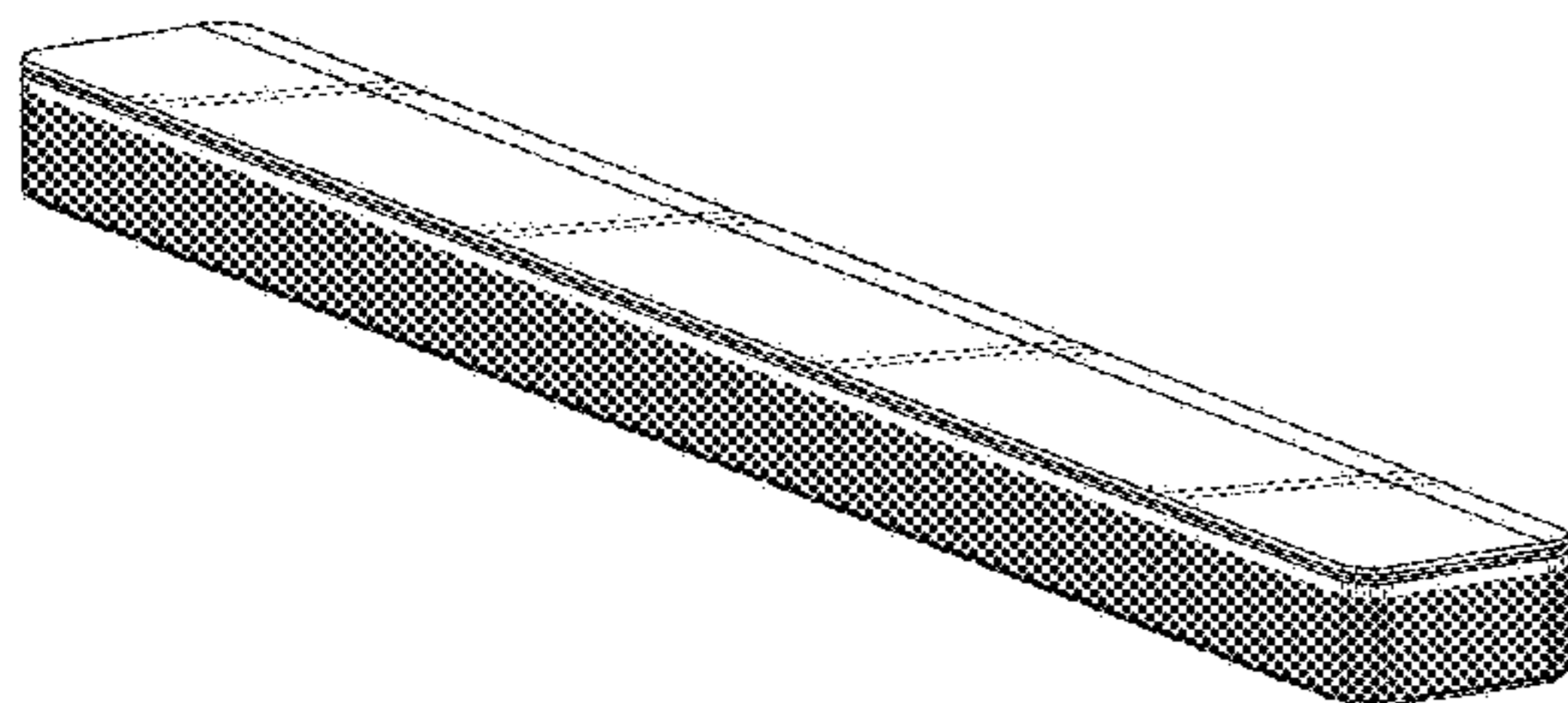

**DESCRIPTION**

FIG. 1 is a perspective view of a soundbar as seen from the front, top and side;

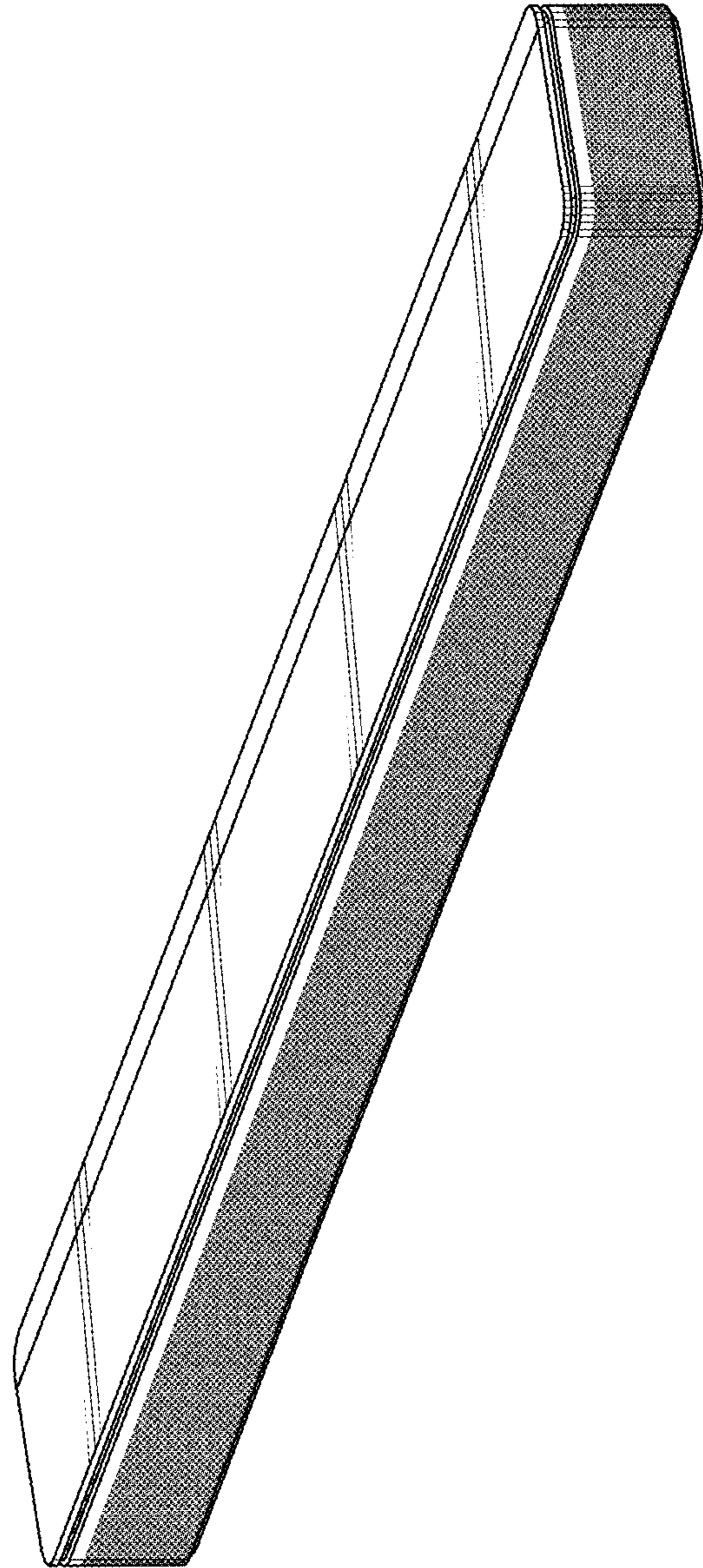

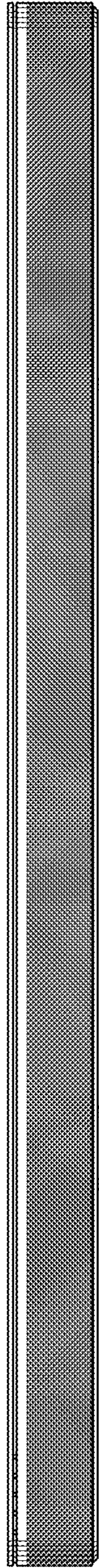

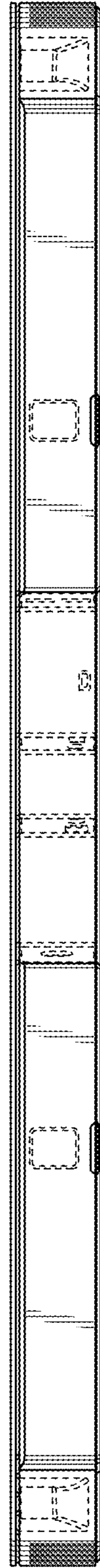

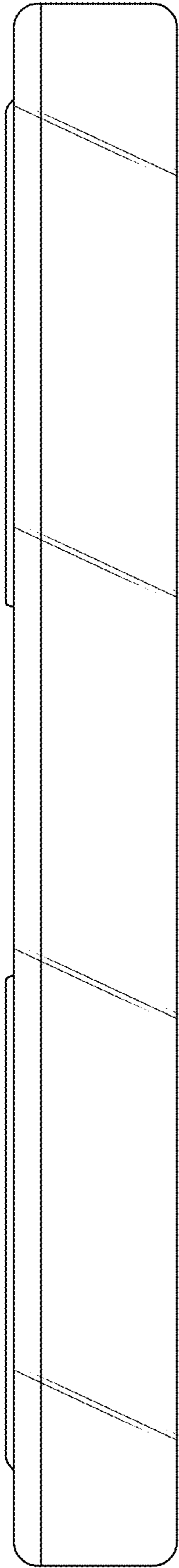

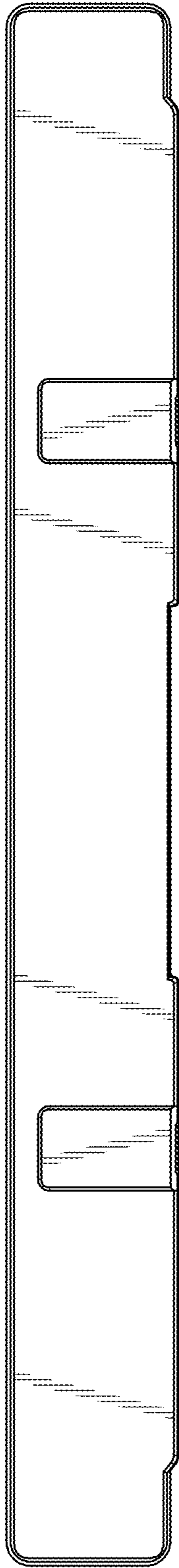

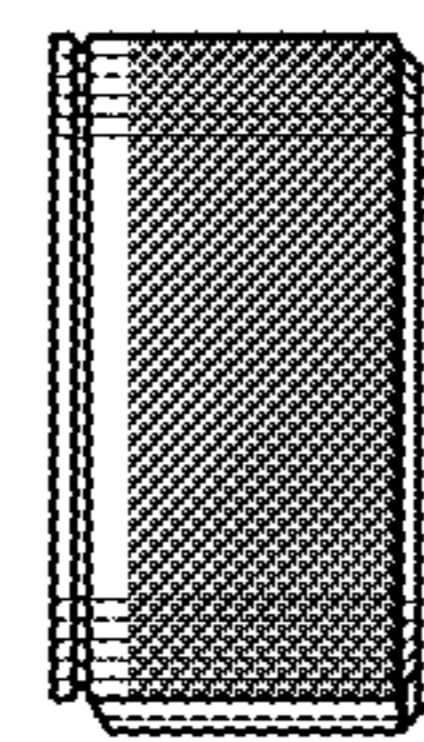

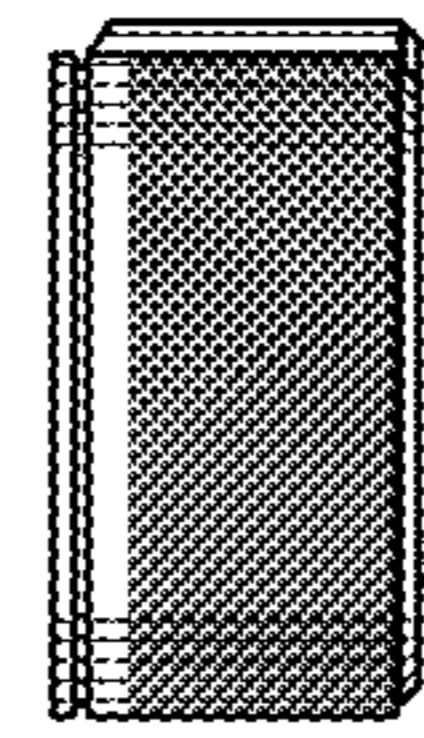
