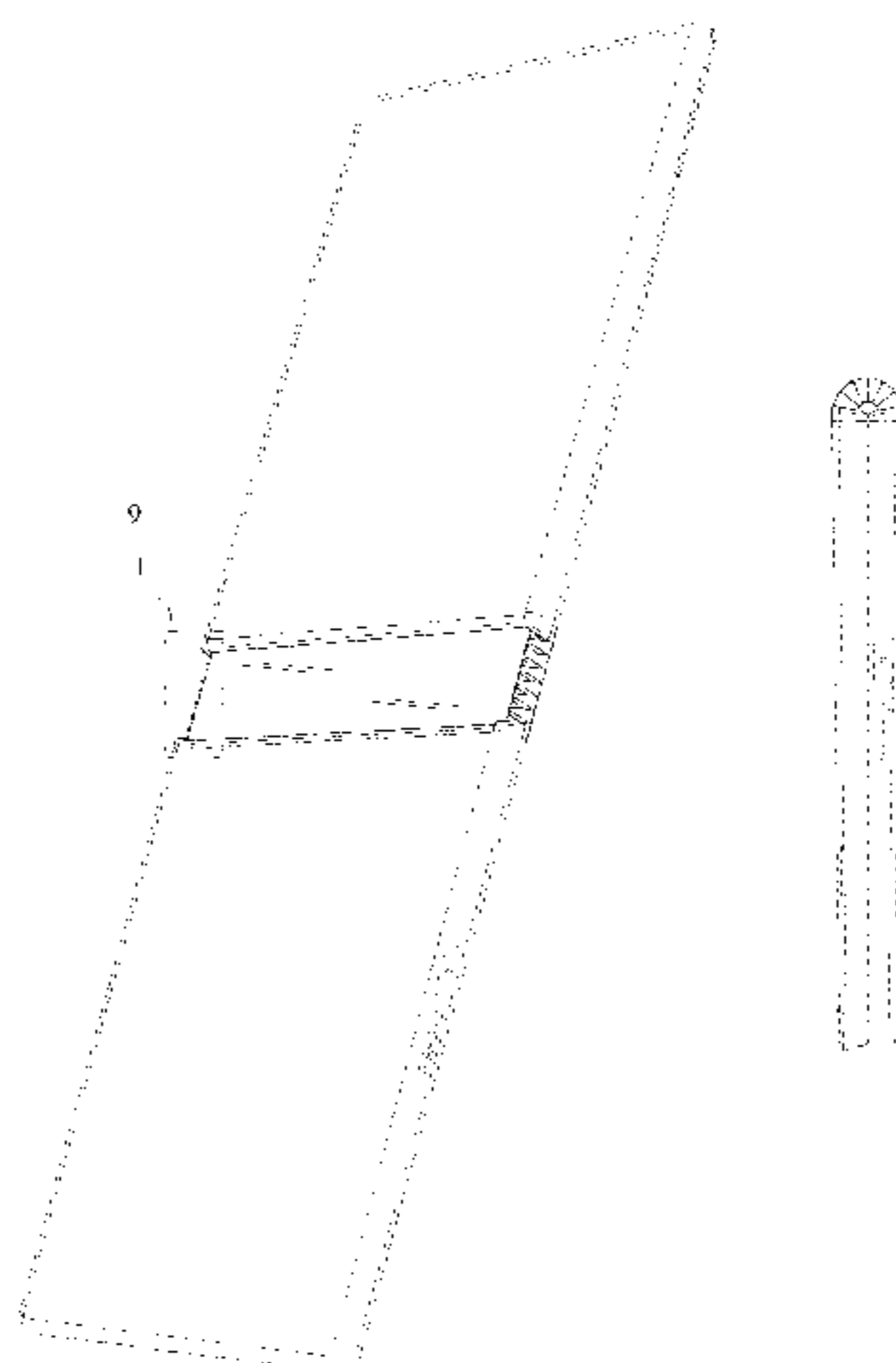
(57) **CLAIM**

We claim the ornamental design for an electronic device, as shown and described.

**DESCRIPTION**

FIG. 1 is a rear perspective view of an electronic device showing our new design;  
 FIG. 2 is a front view thereof;  
 FIG. 3 is a rear view thereof;  
 FIG. 4 is a left-side view thereof;  
 FIG. 5 is a right-side view thereof;  
 FIG. 6 is a top view thereof;  
 FIG. 7 is a bottom view thereof;

 FIG. 9 is an enlarged view of the encircled portion in FIG. 1; and,  
 FIG. 10 is a right-side view of the electronic device shown in a folded position.

 The dot-dot-dash broken lines encircling portions of the claimed design that are illustrated in enlargements form no part of the claimed design.

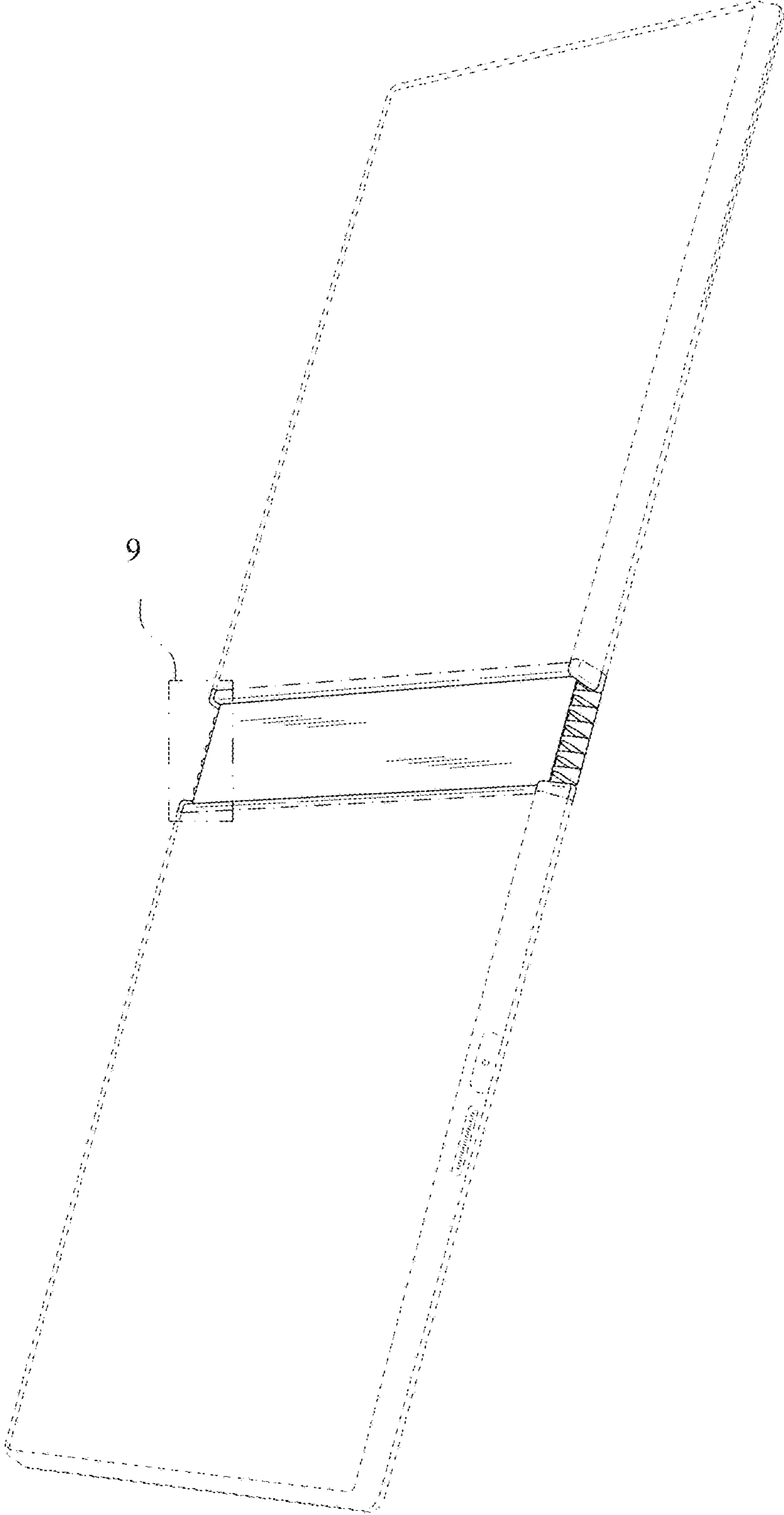

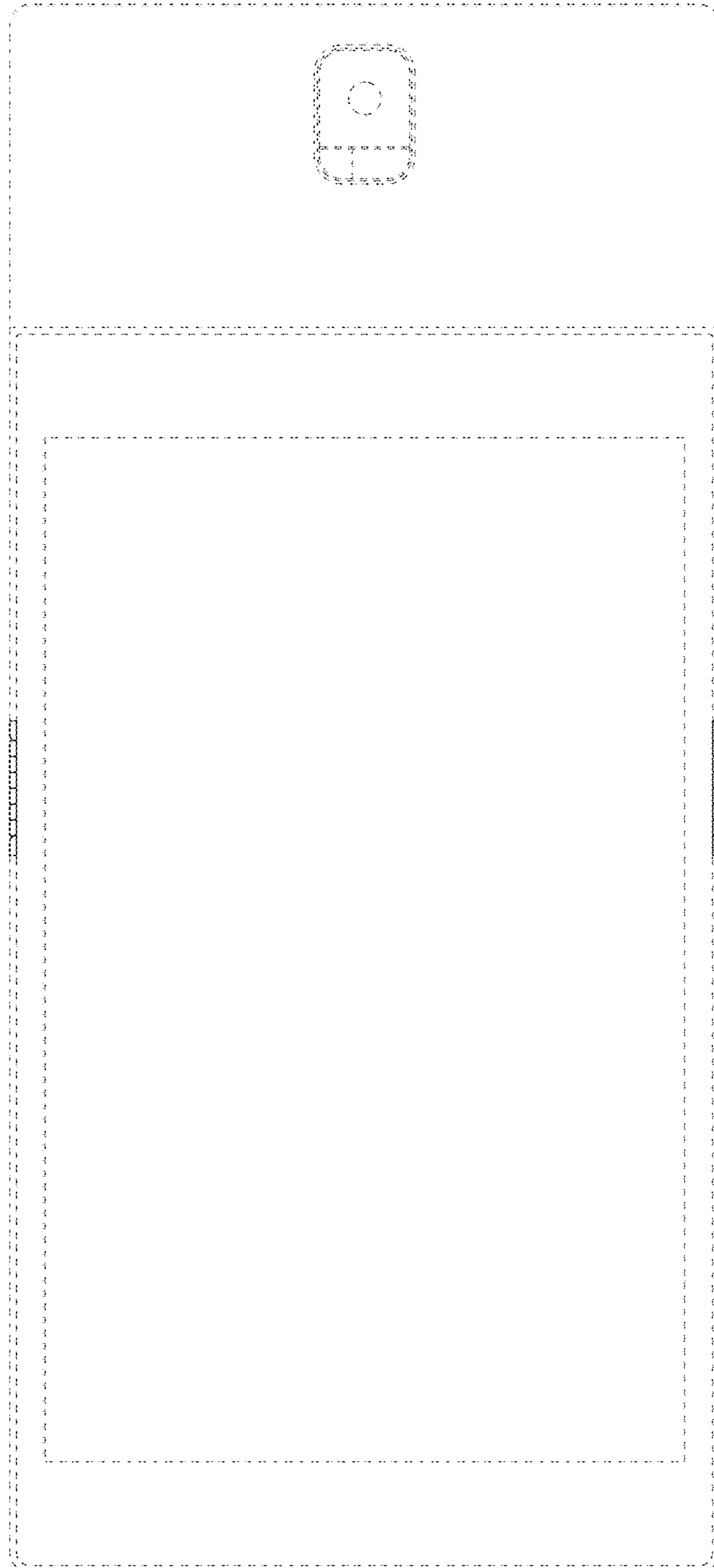

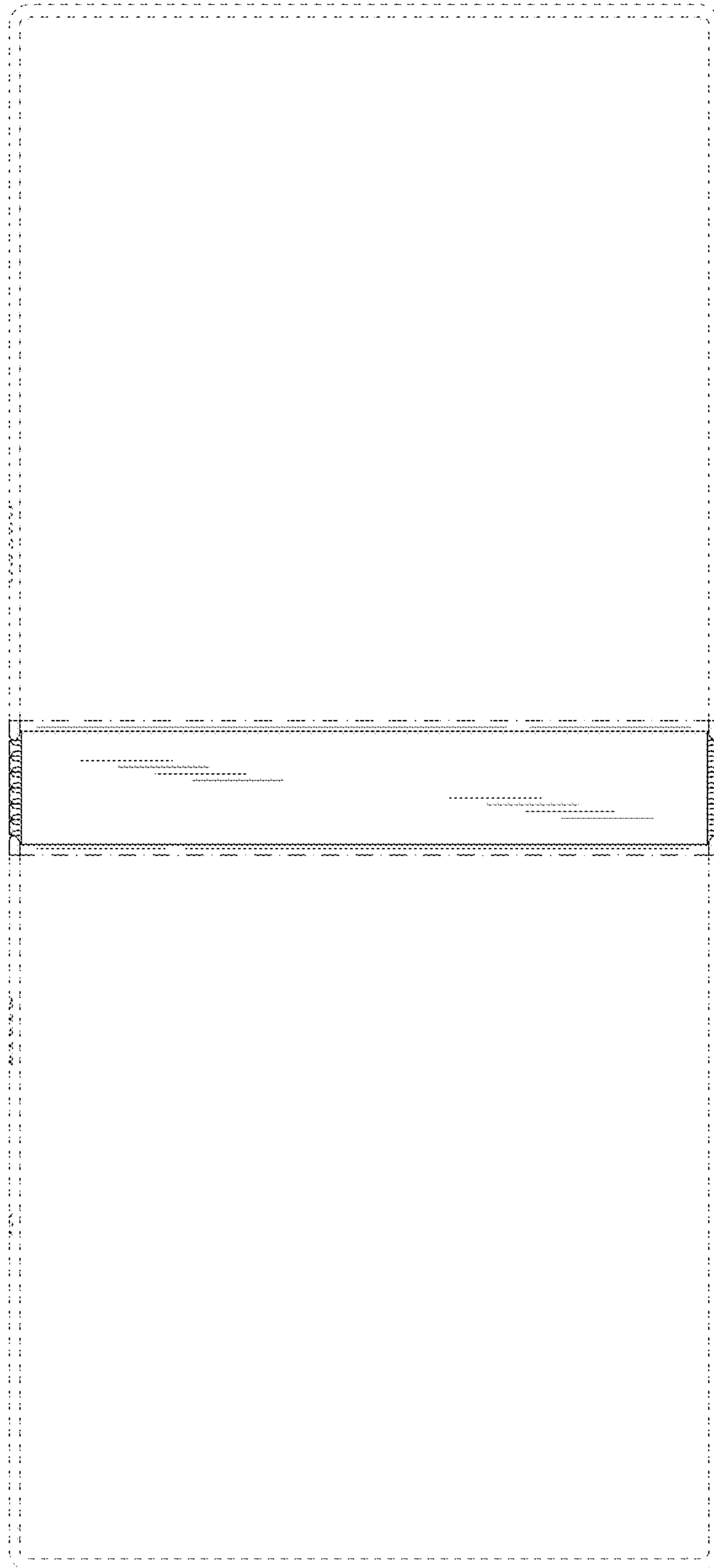

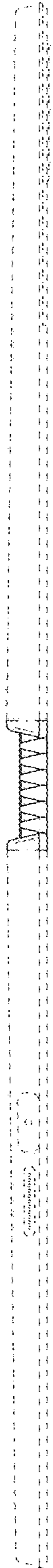

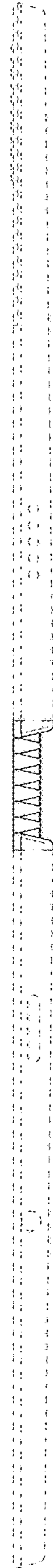

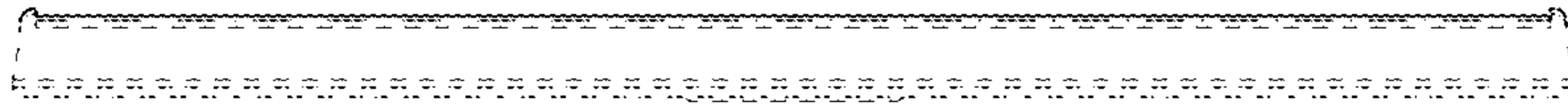

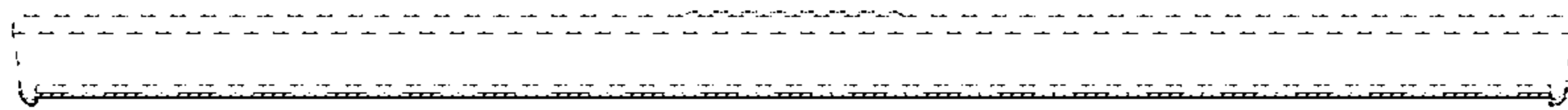

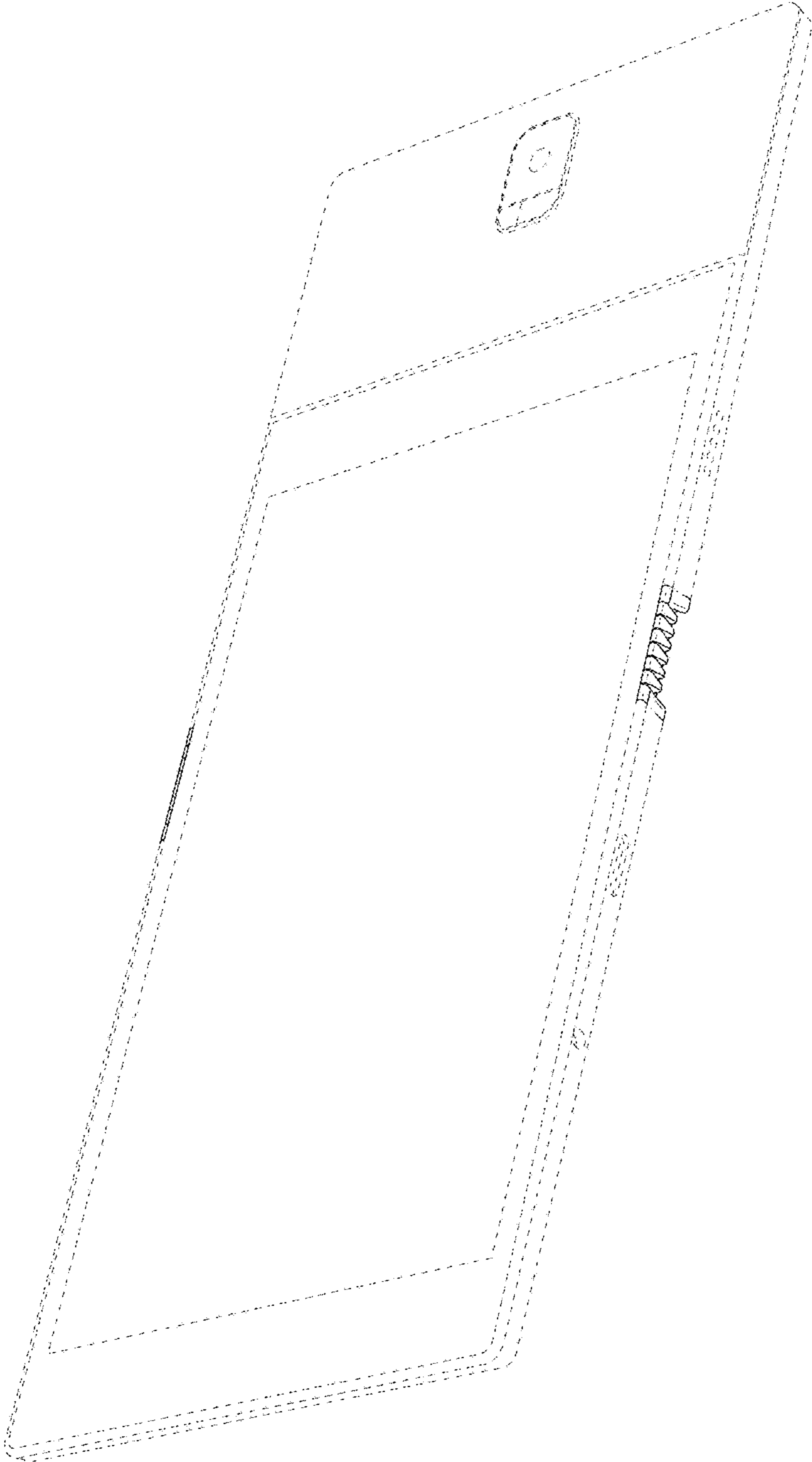

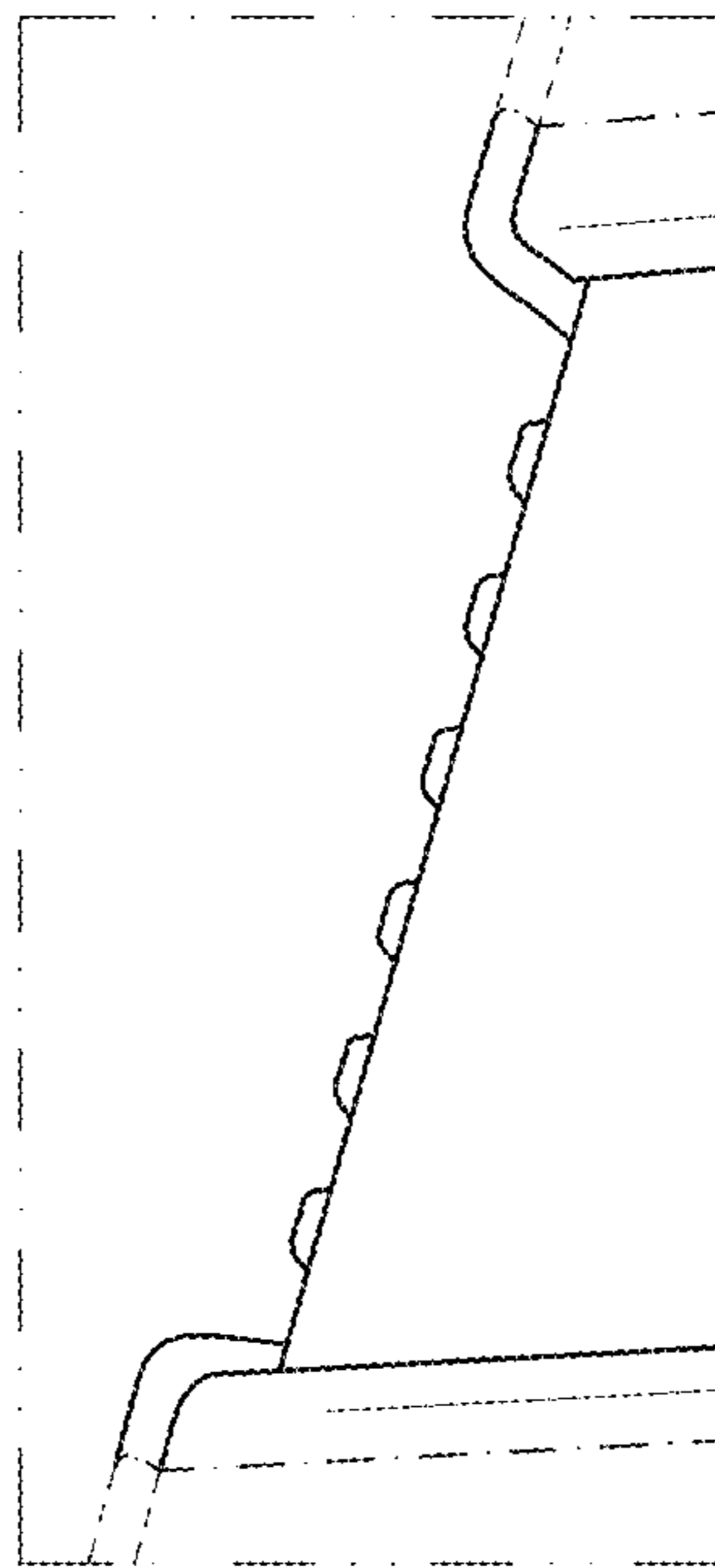
