**DESCRIPTION**

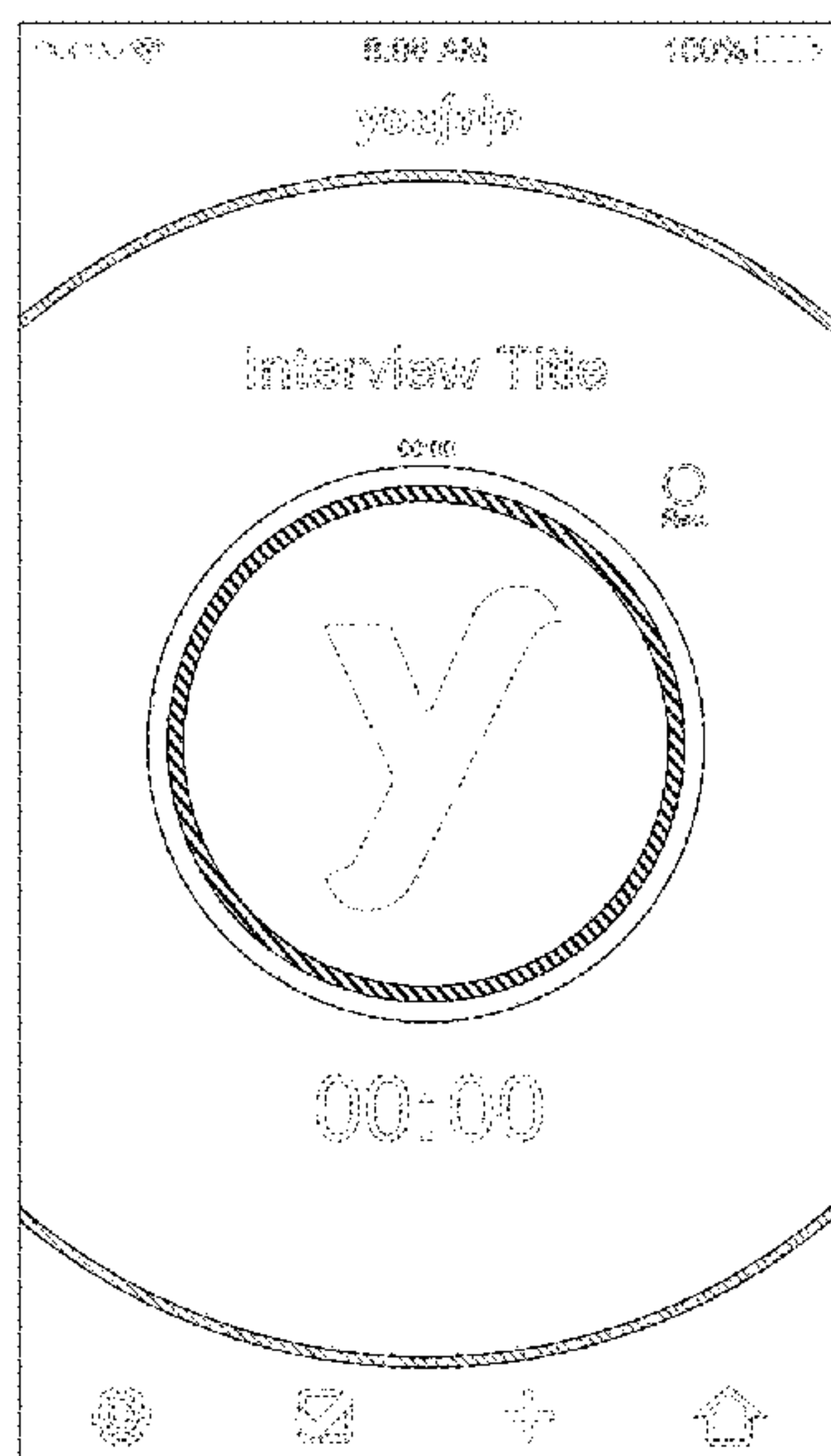

FIG. 7 is a front view of the seventh image thereof.

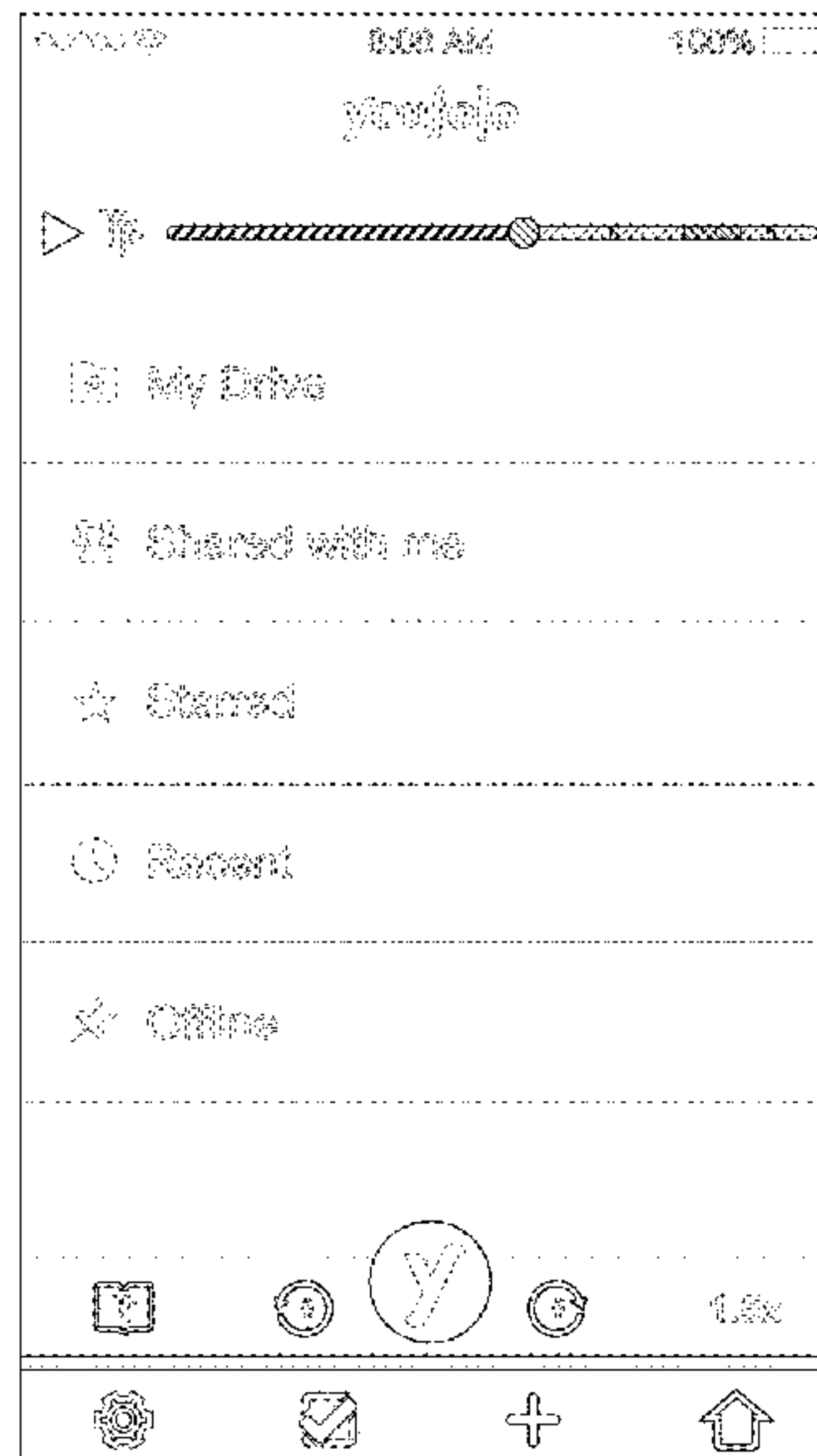

Design is embodied in a display screen for use with a computer.

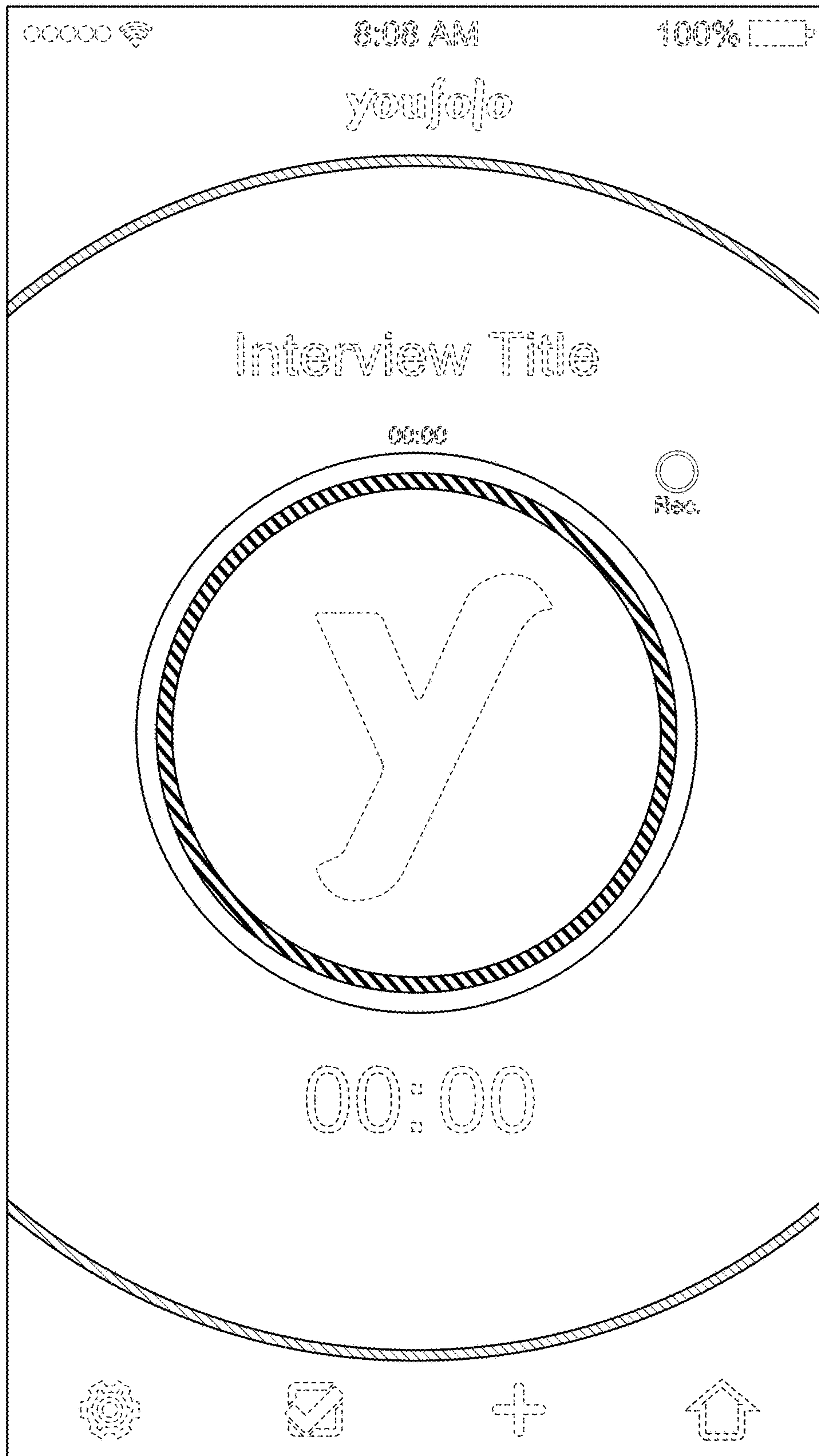

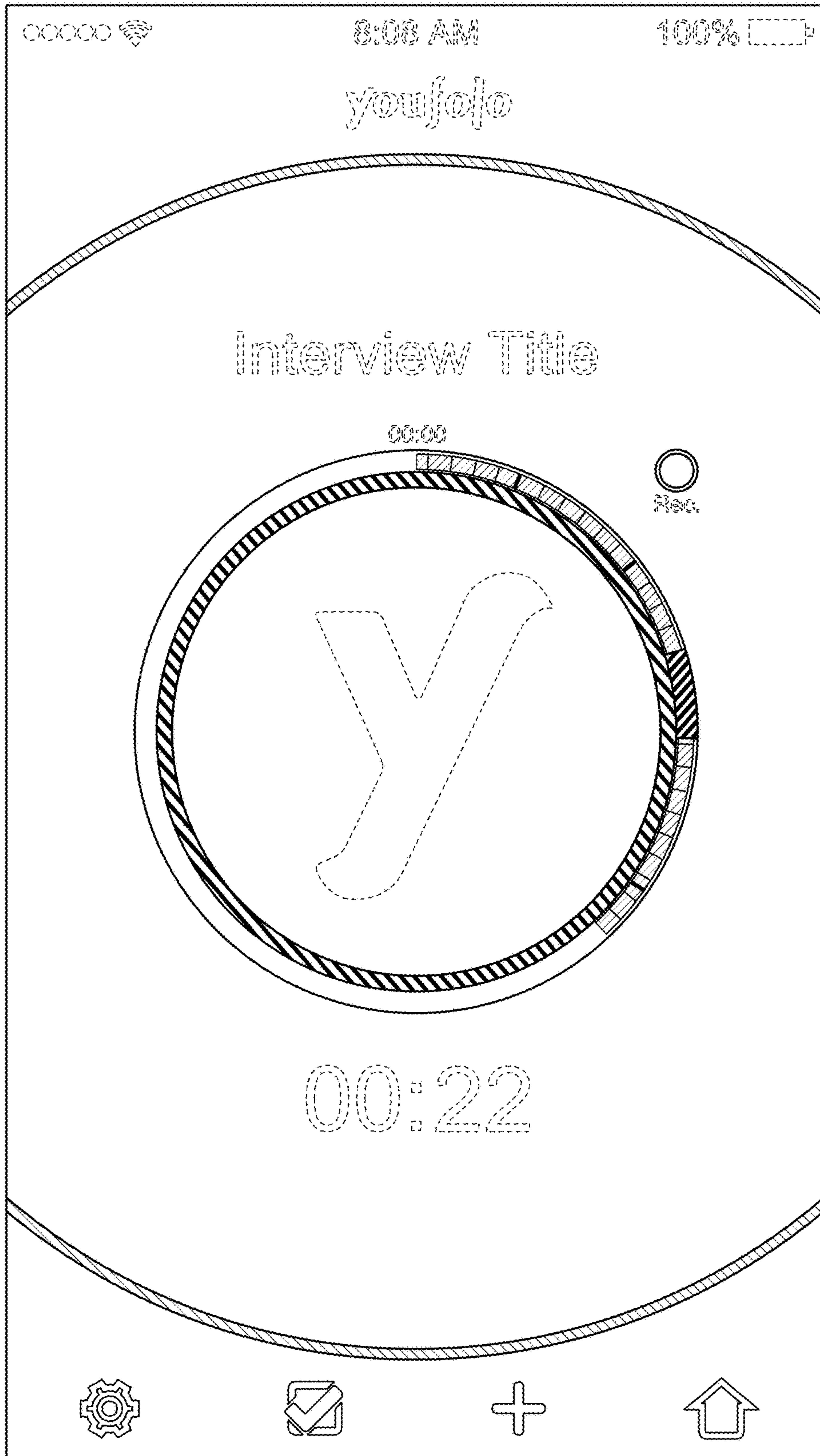


FIG. 2 © 2015 Tavares Brewington



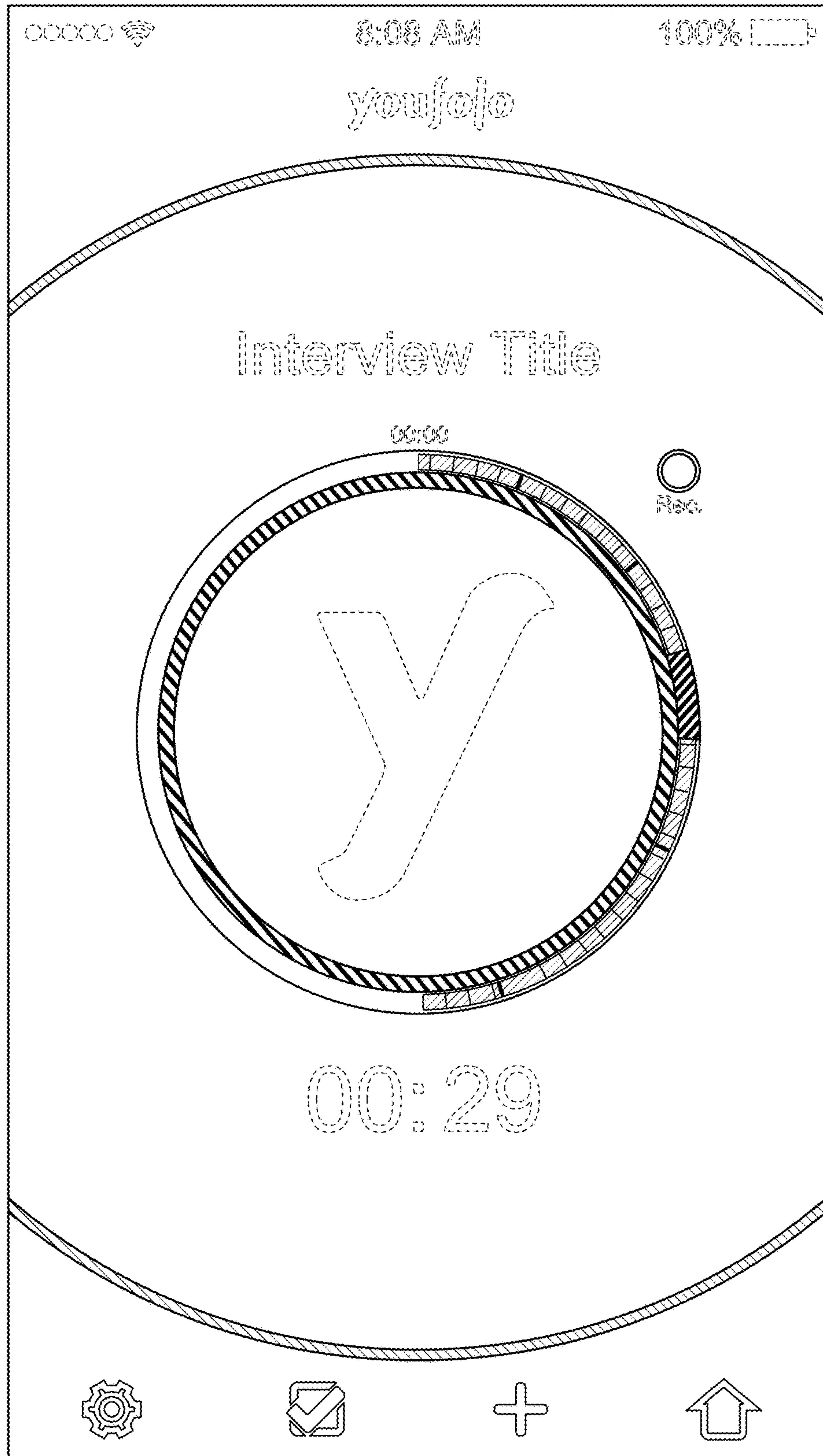

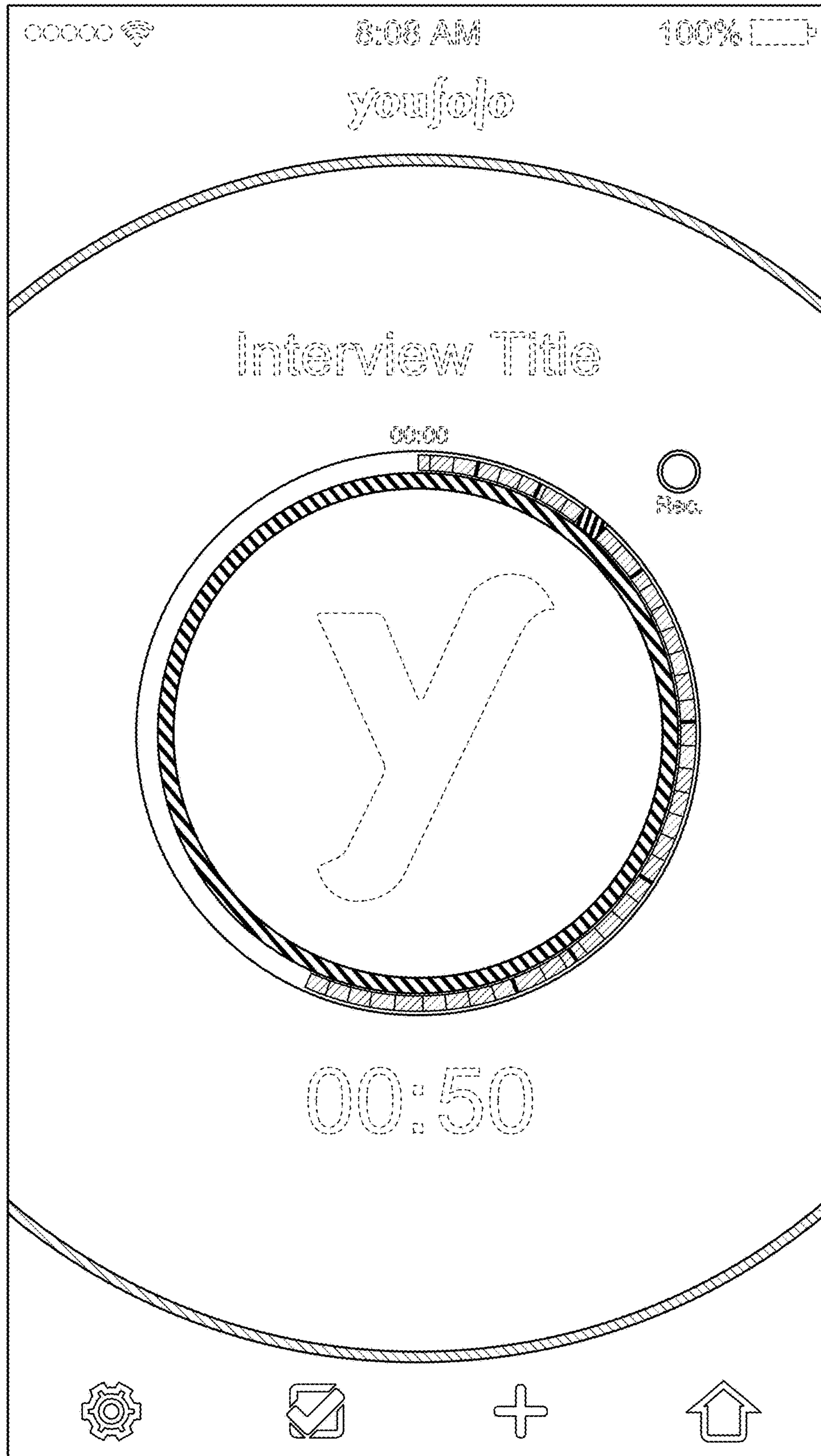


FIG. 4 © 2015 Tavares Brewington

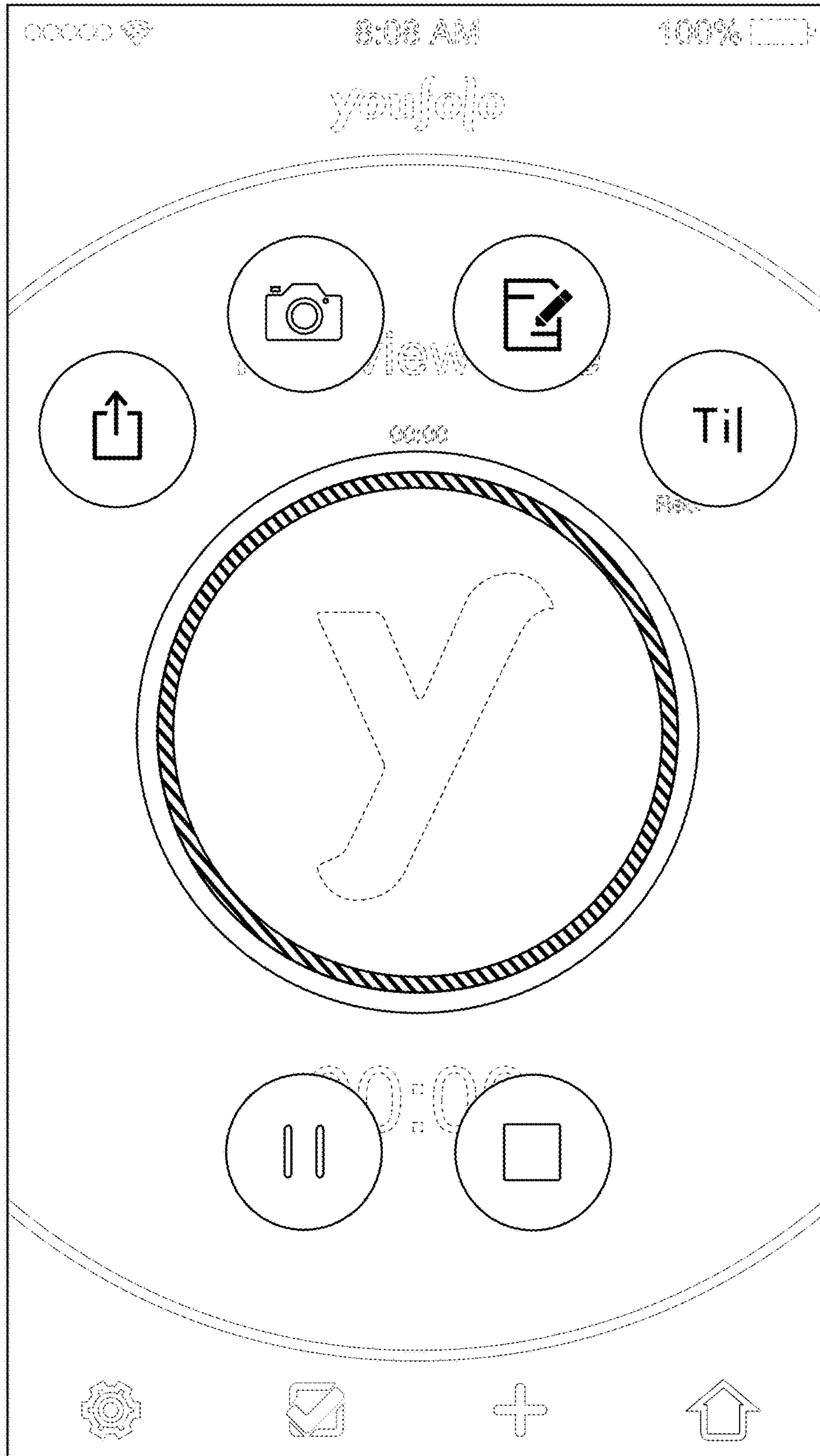


FIG. 5 © 2015 Tavares Brewington

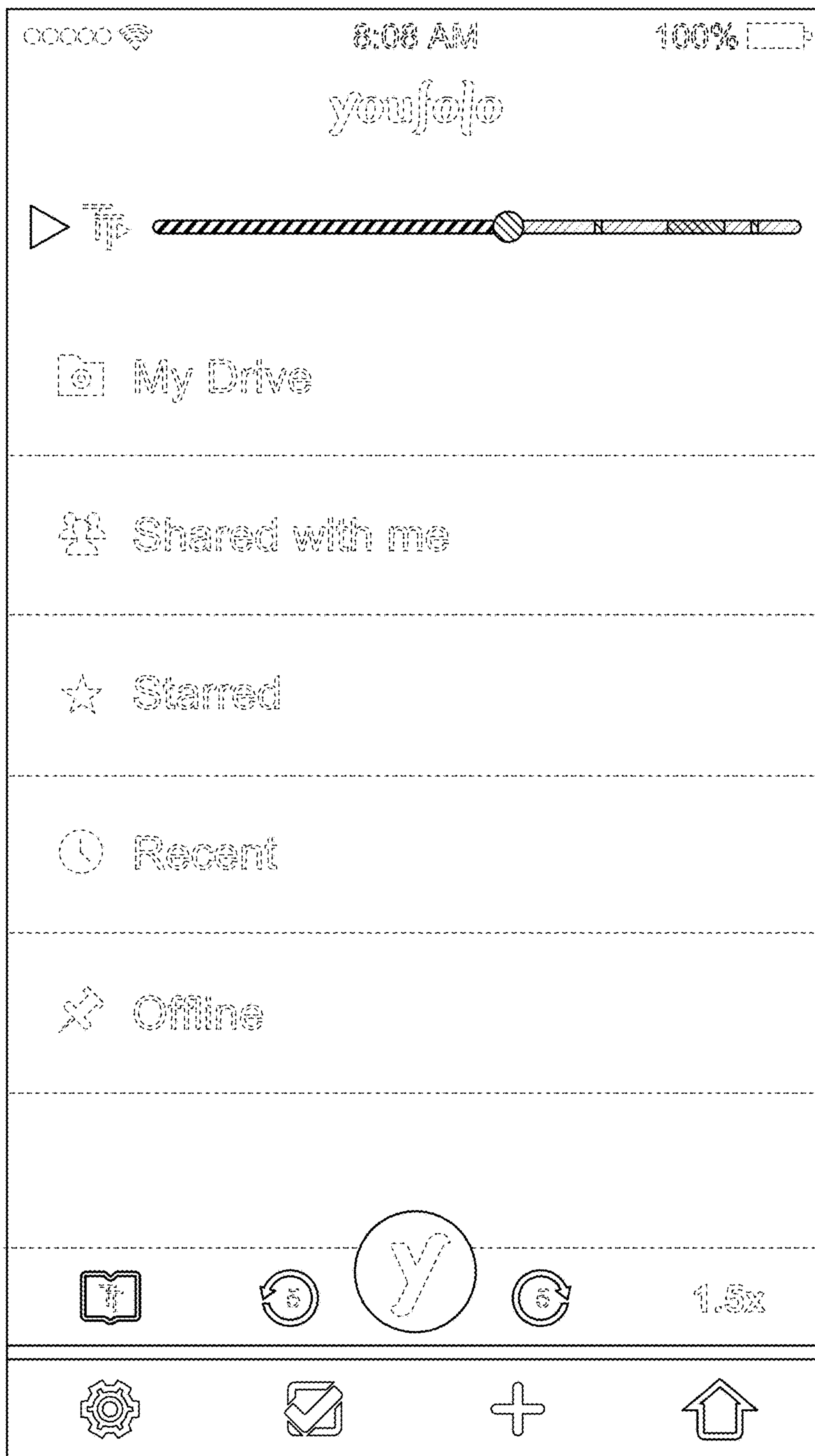


FIG. 7 © 2015 Tavares Brewington
