**DESCRIPTION**

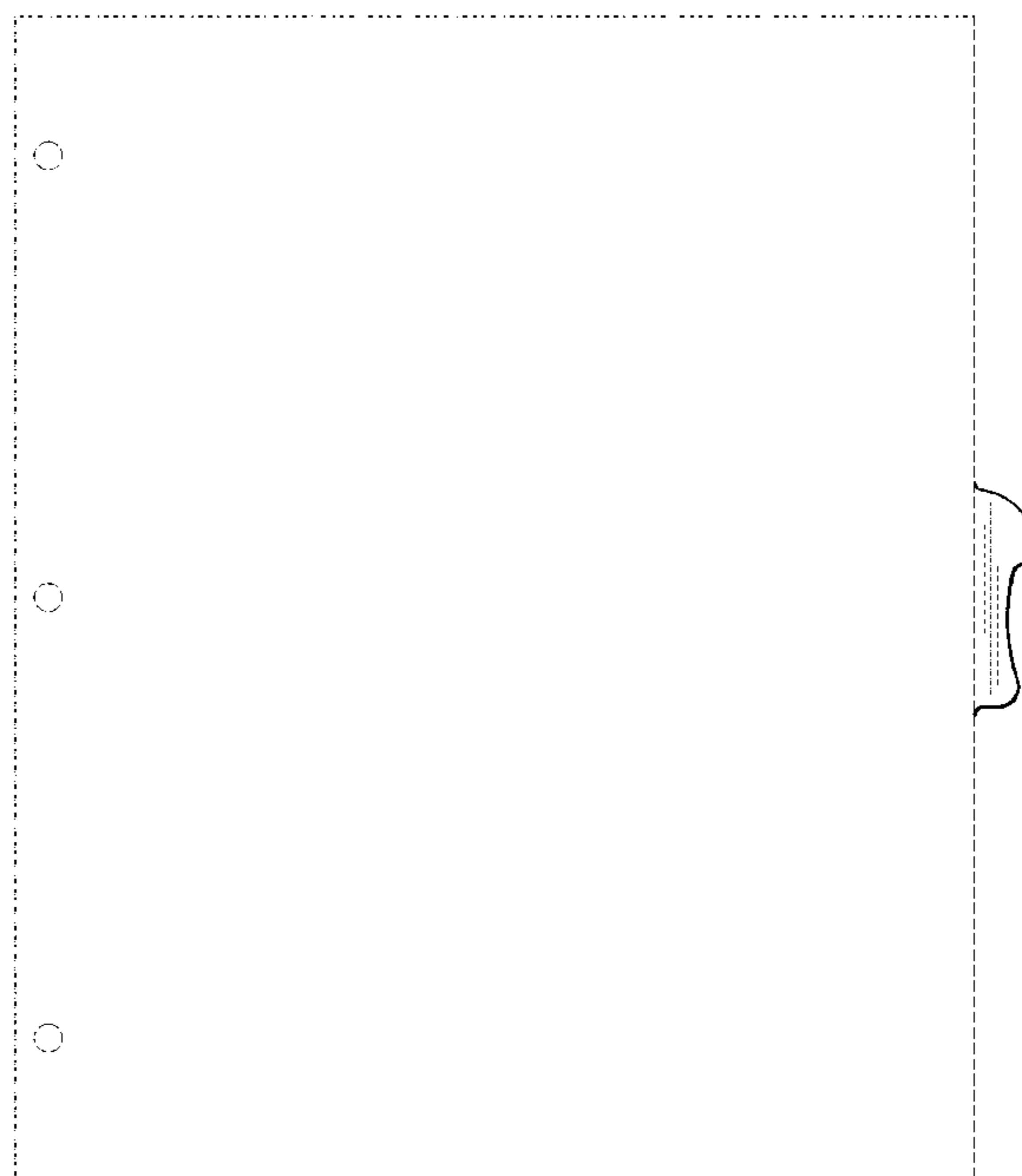
FIG. 1 is a top plan view of a tab showing my new design; and,

The broken lines in FIGS. 1 and 2 are included for the purpose of showing environmental matter that forms no part of the claimed design.

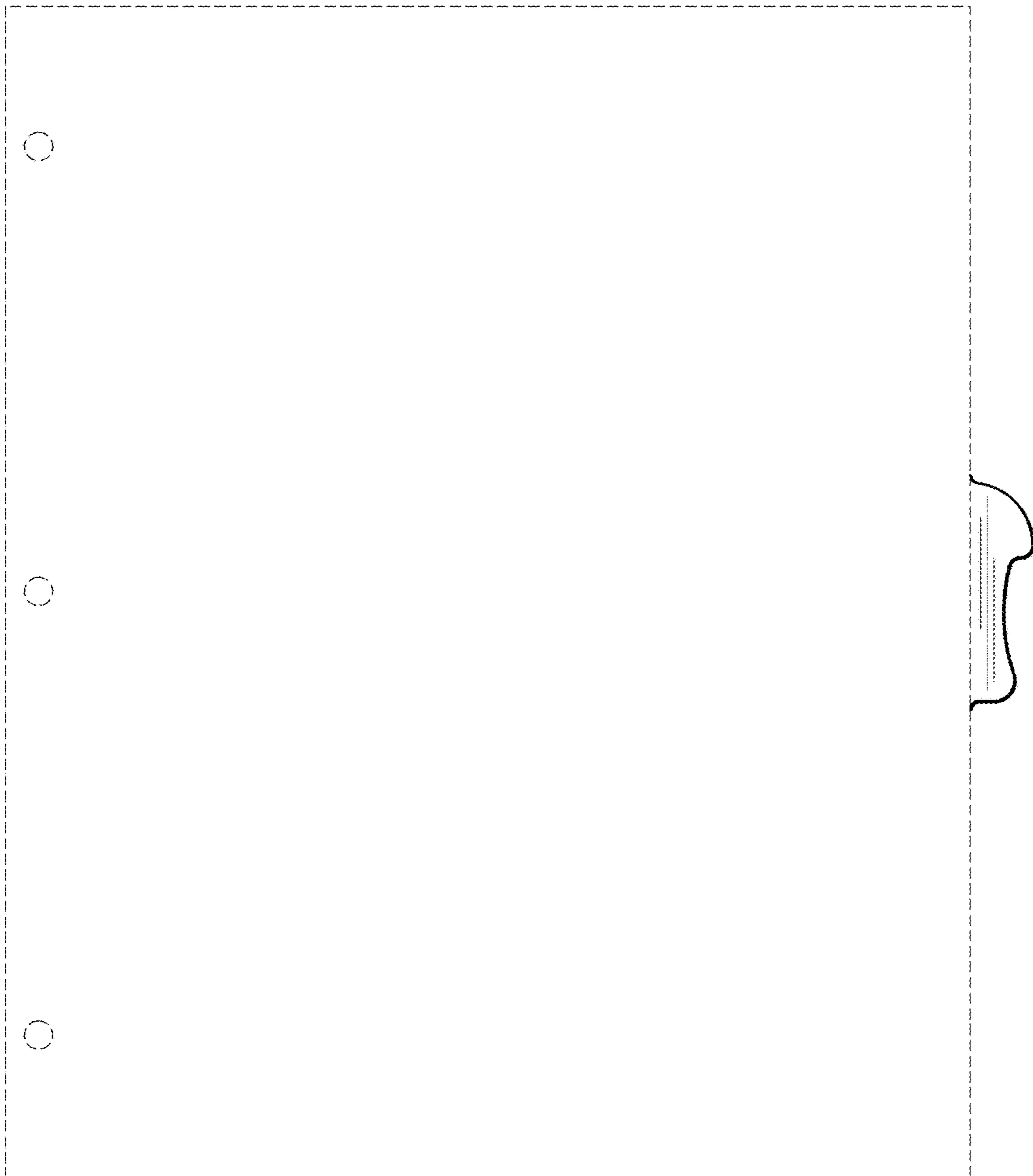

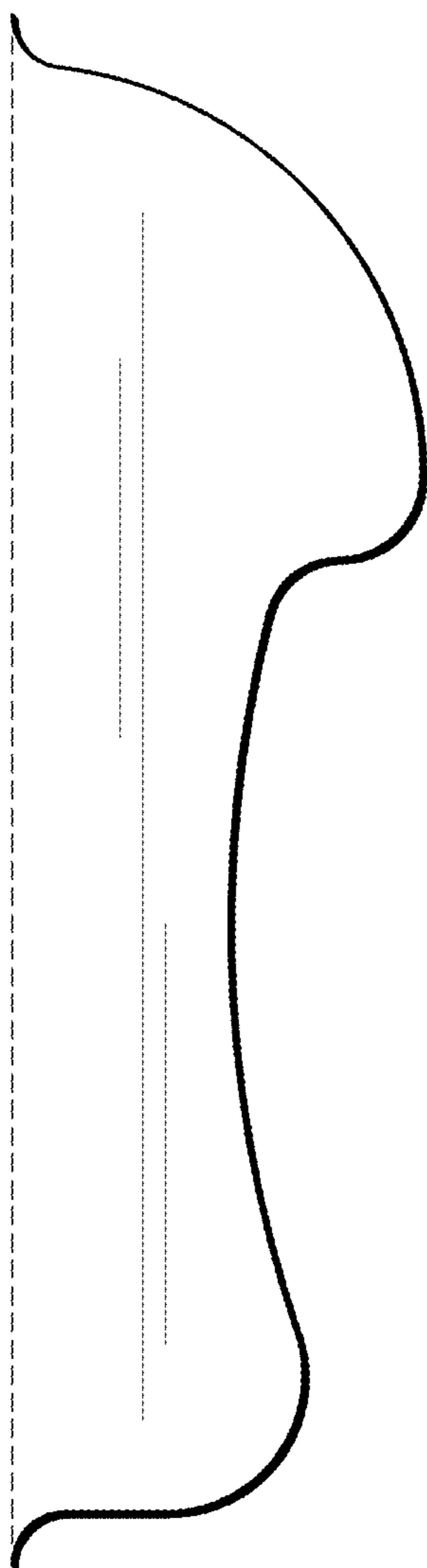
