FIG. 8 is a bottom side plan view thereof.

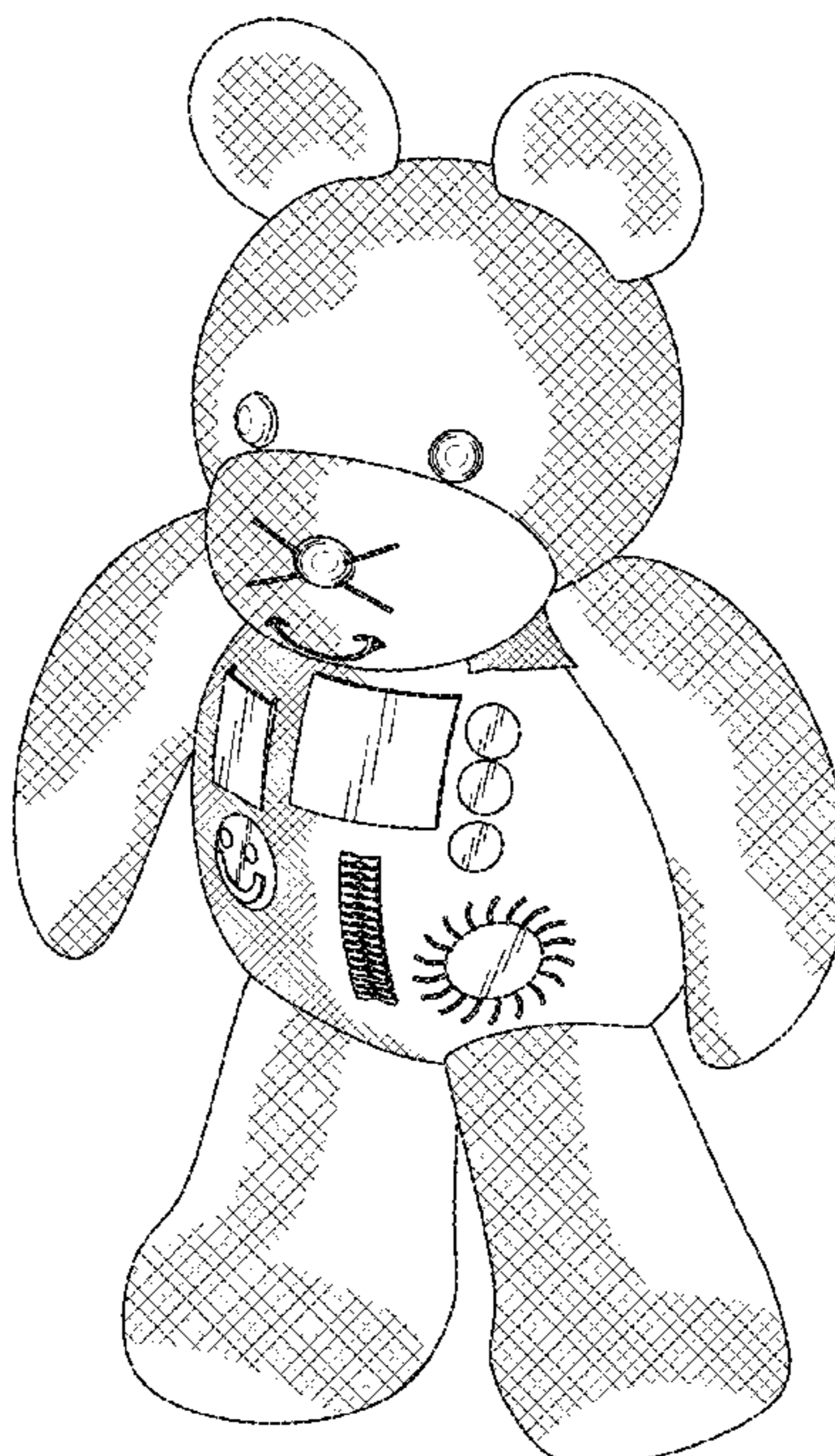

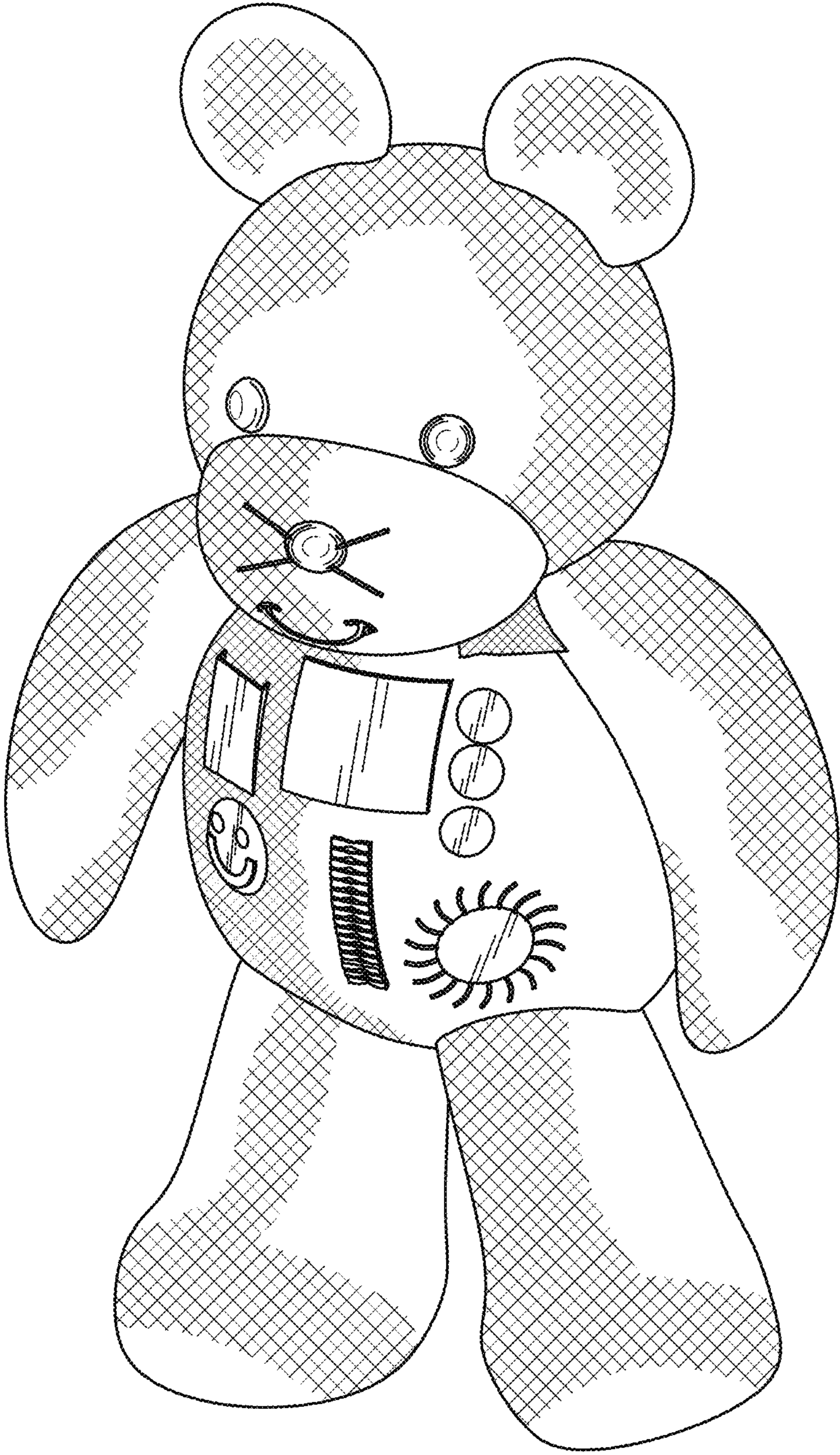

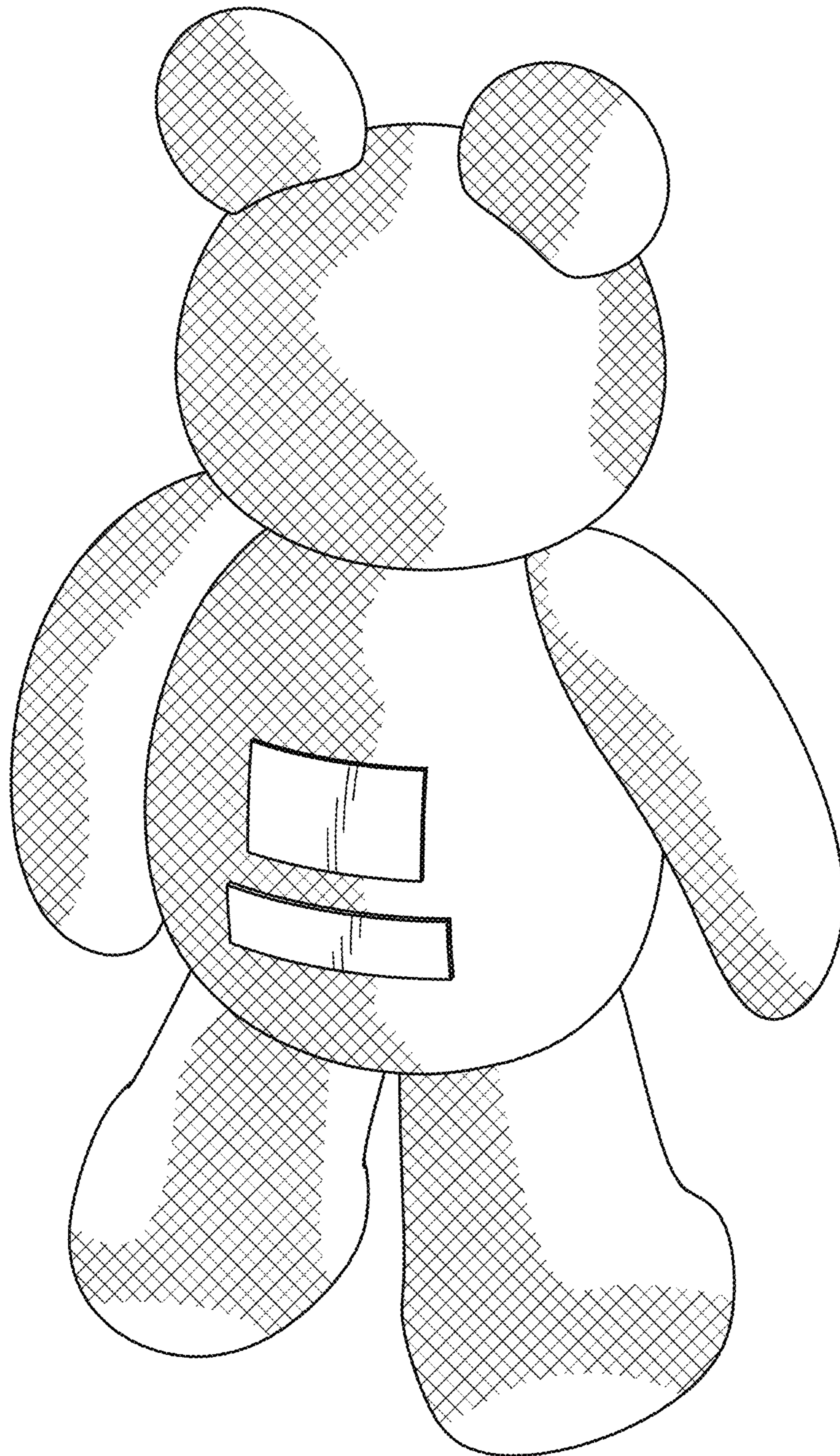

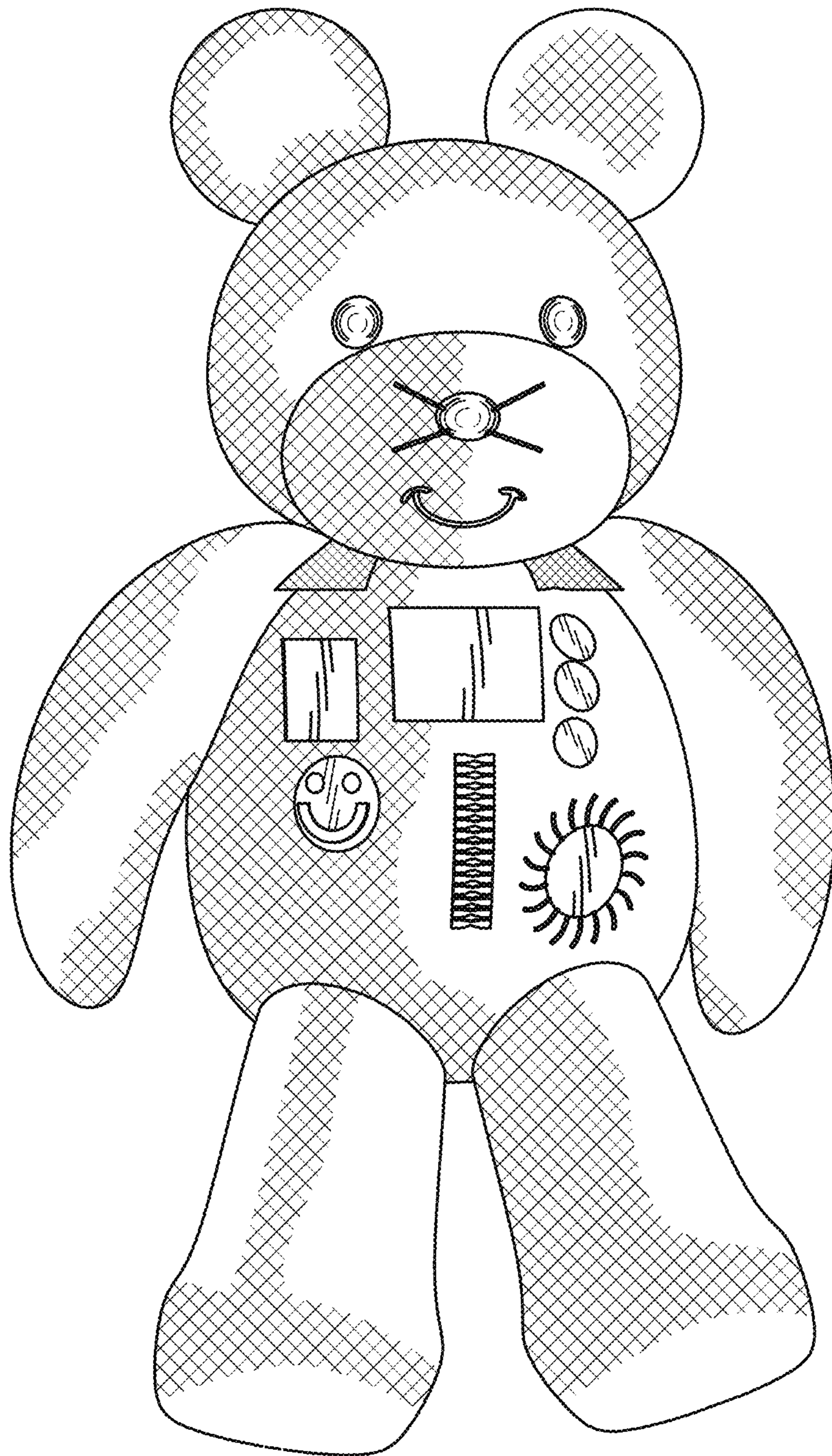

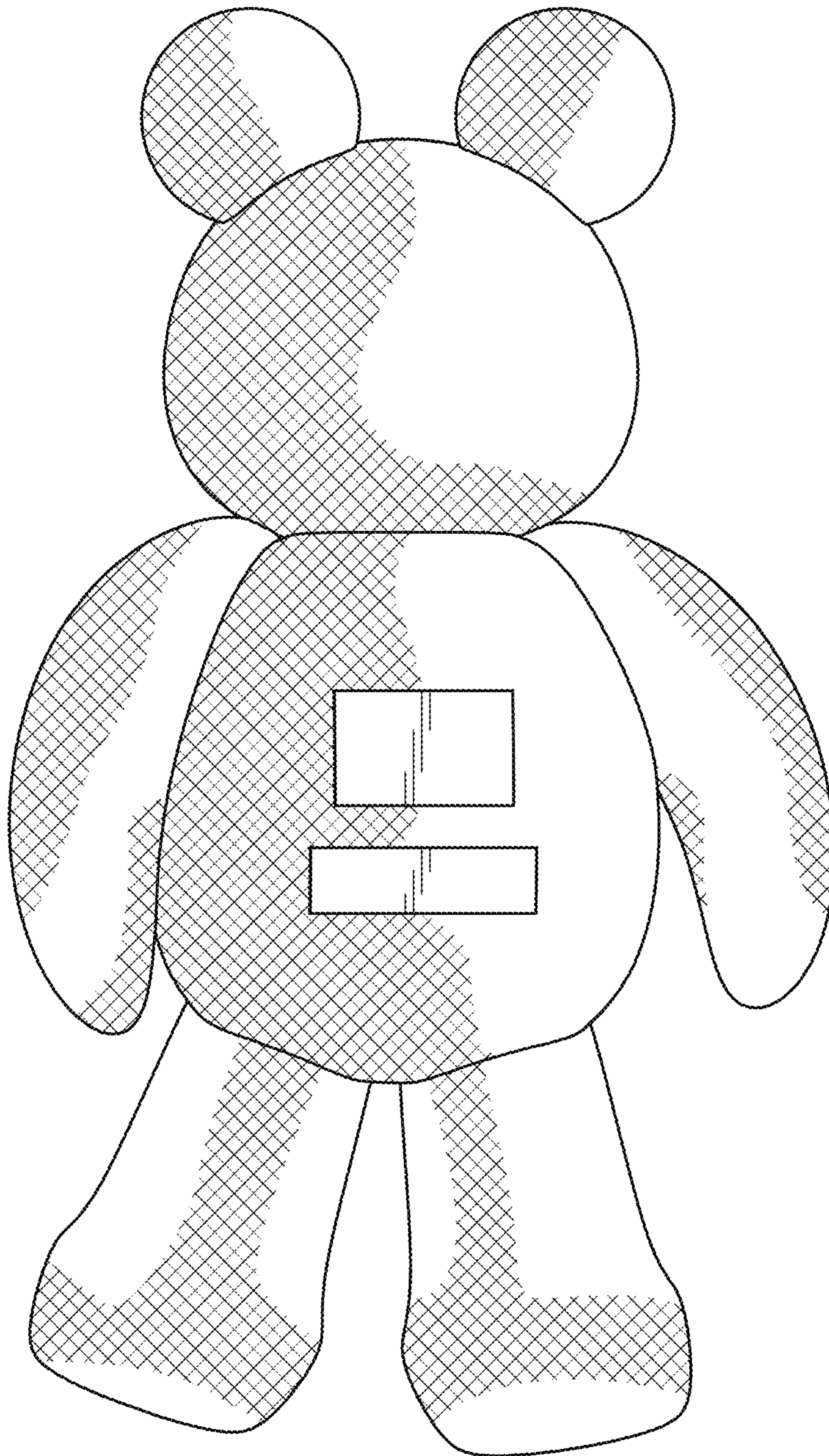

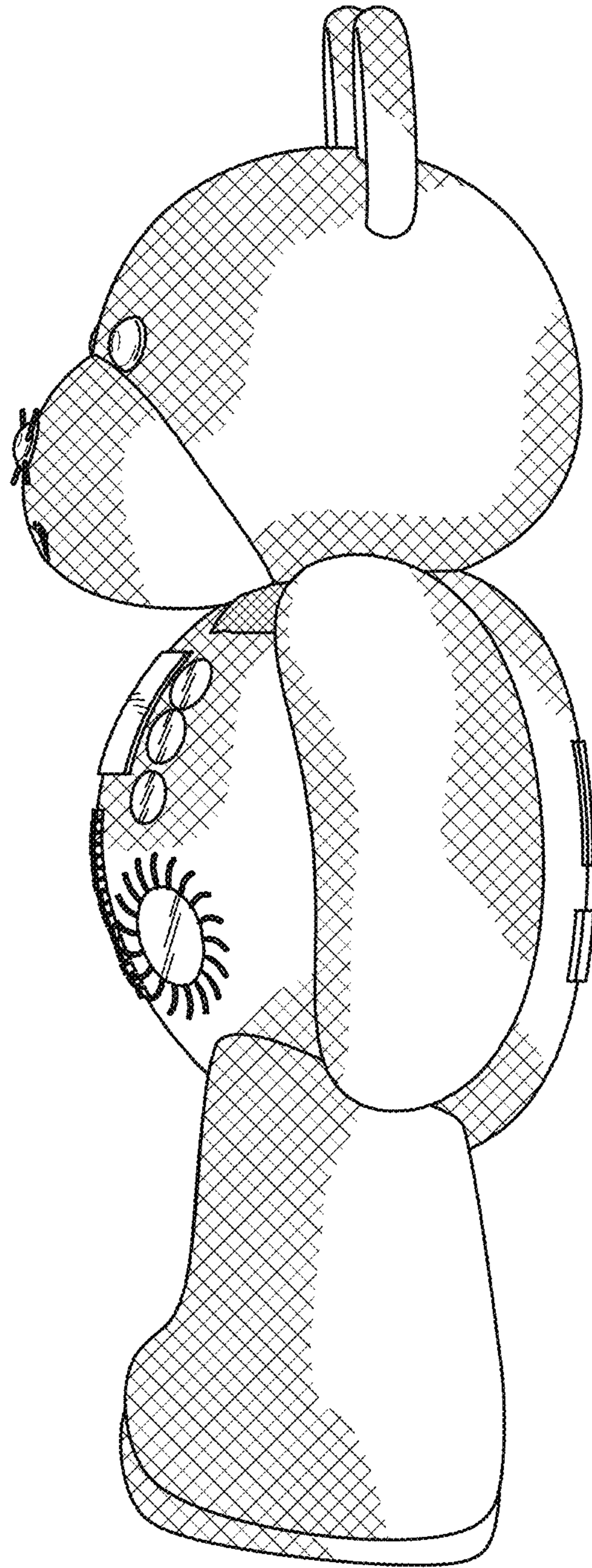

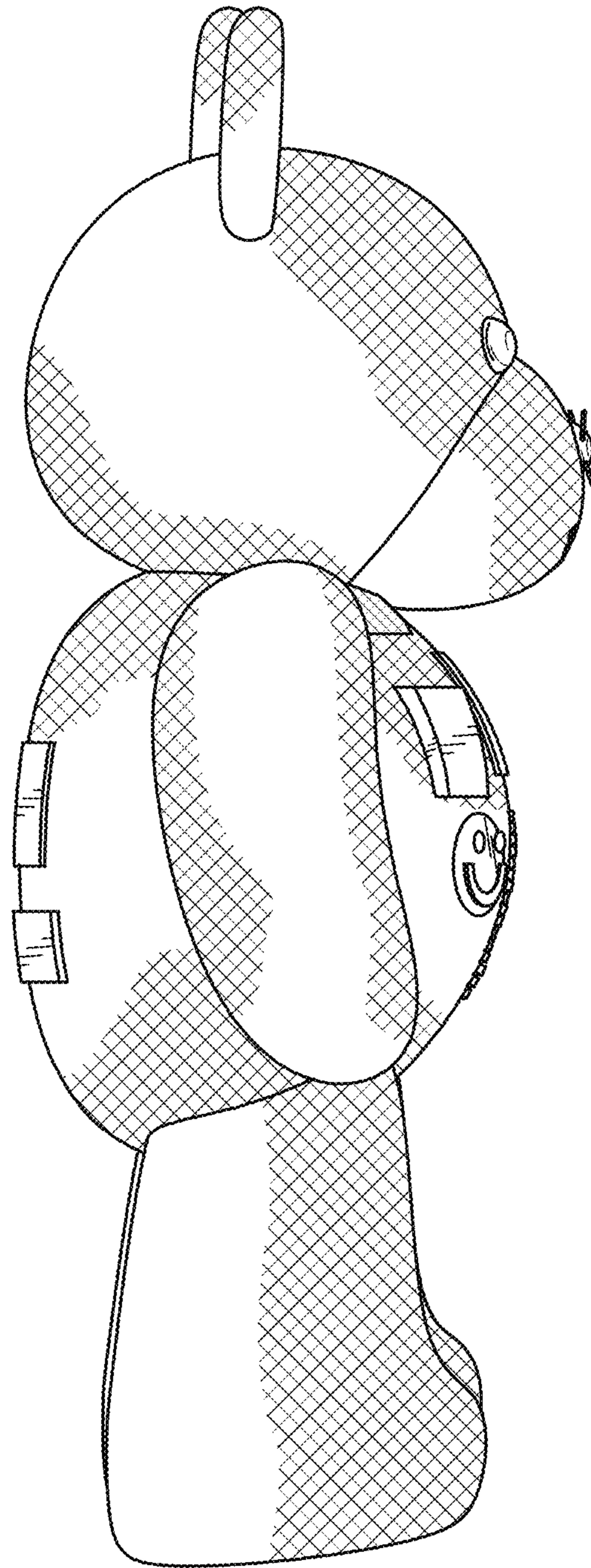

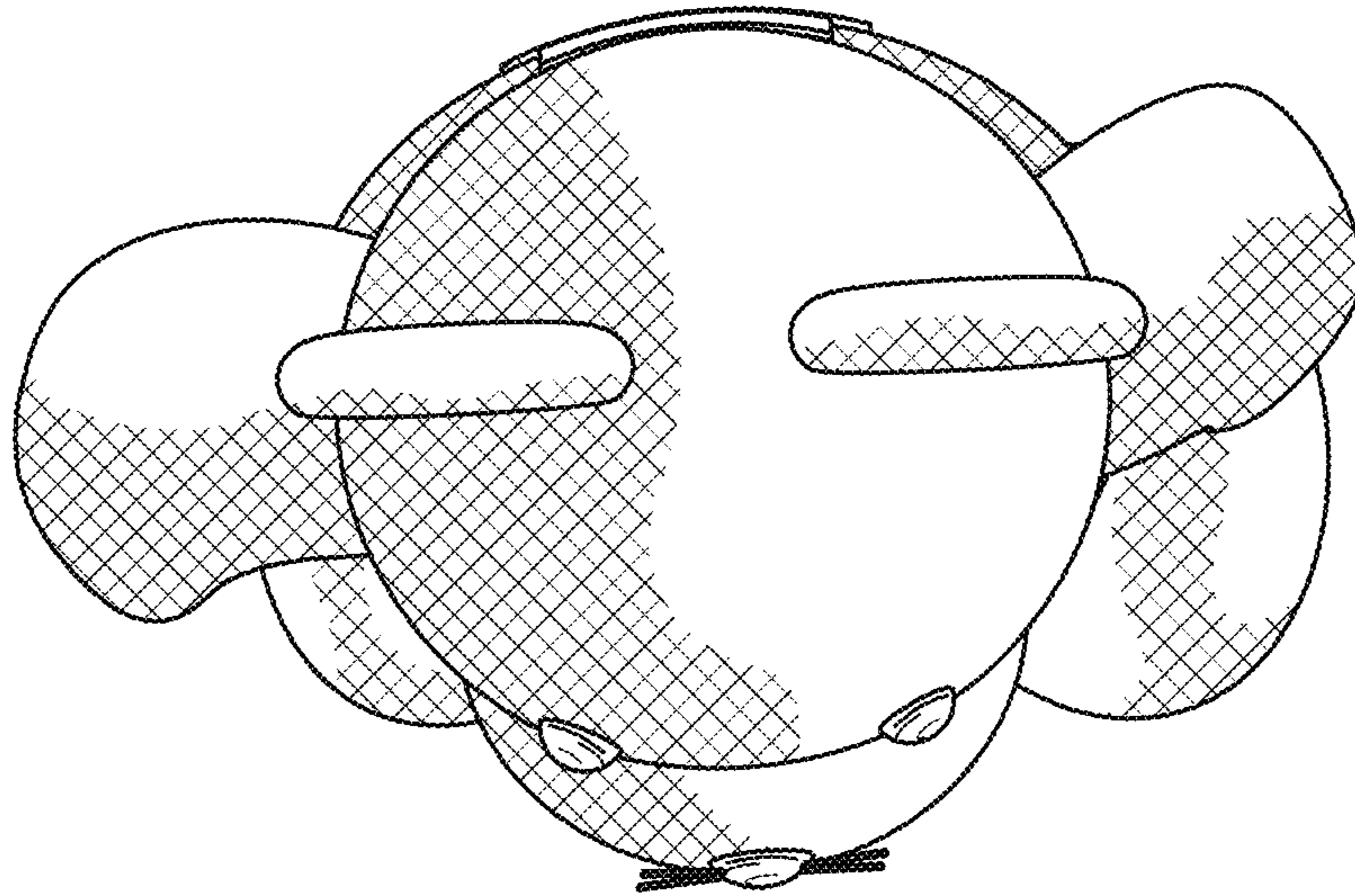

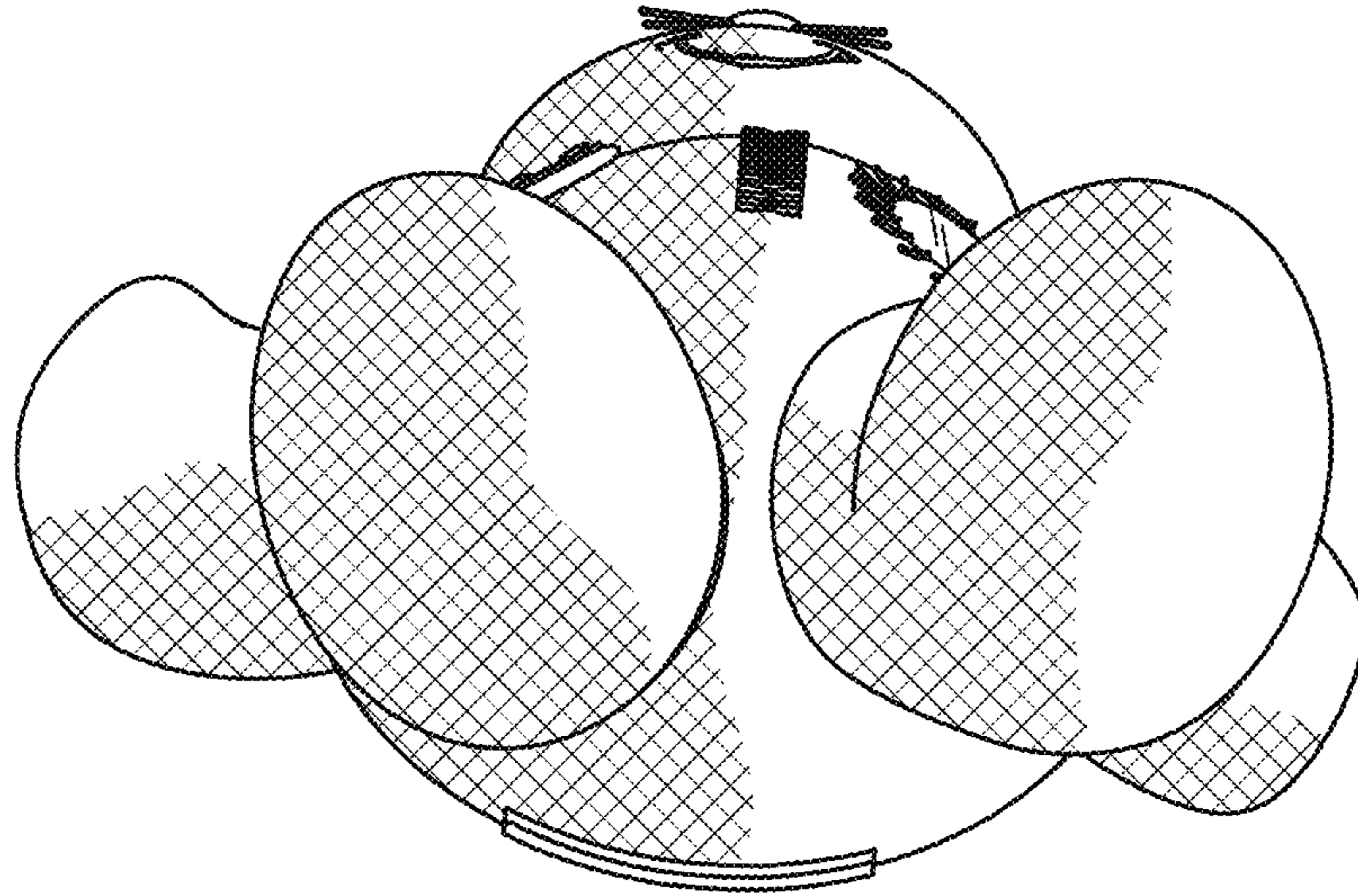
