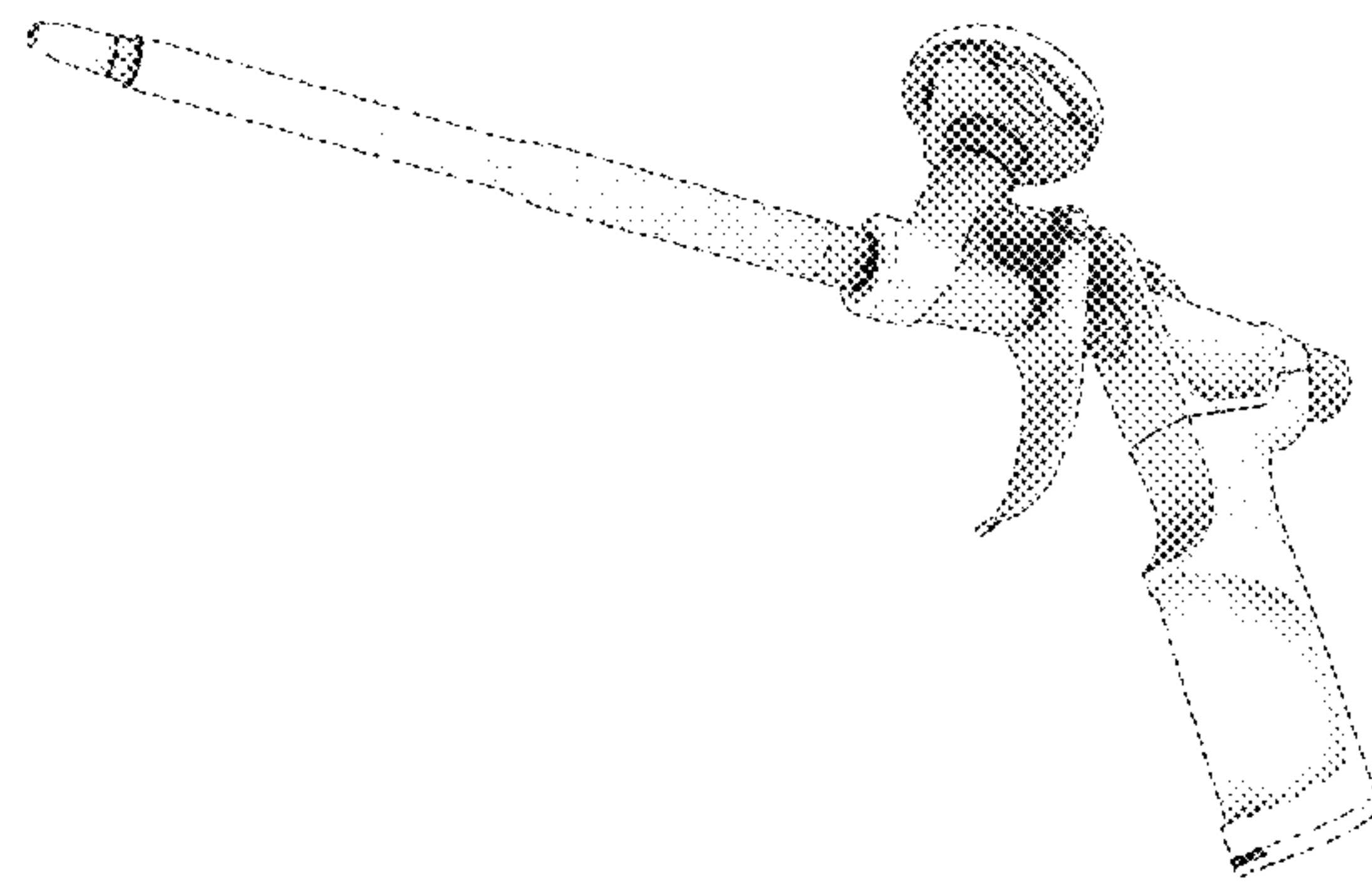
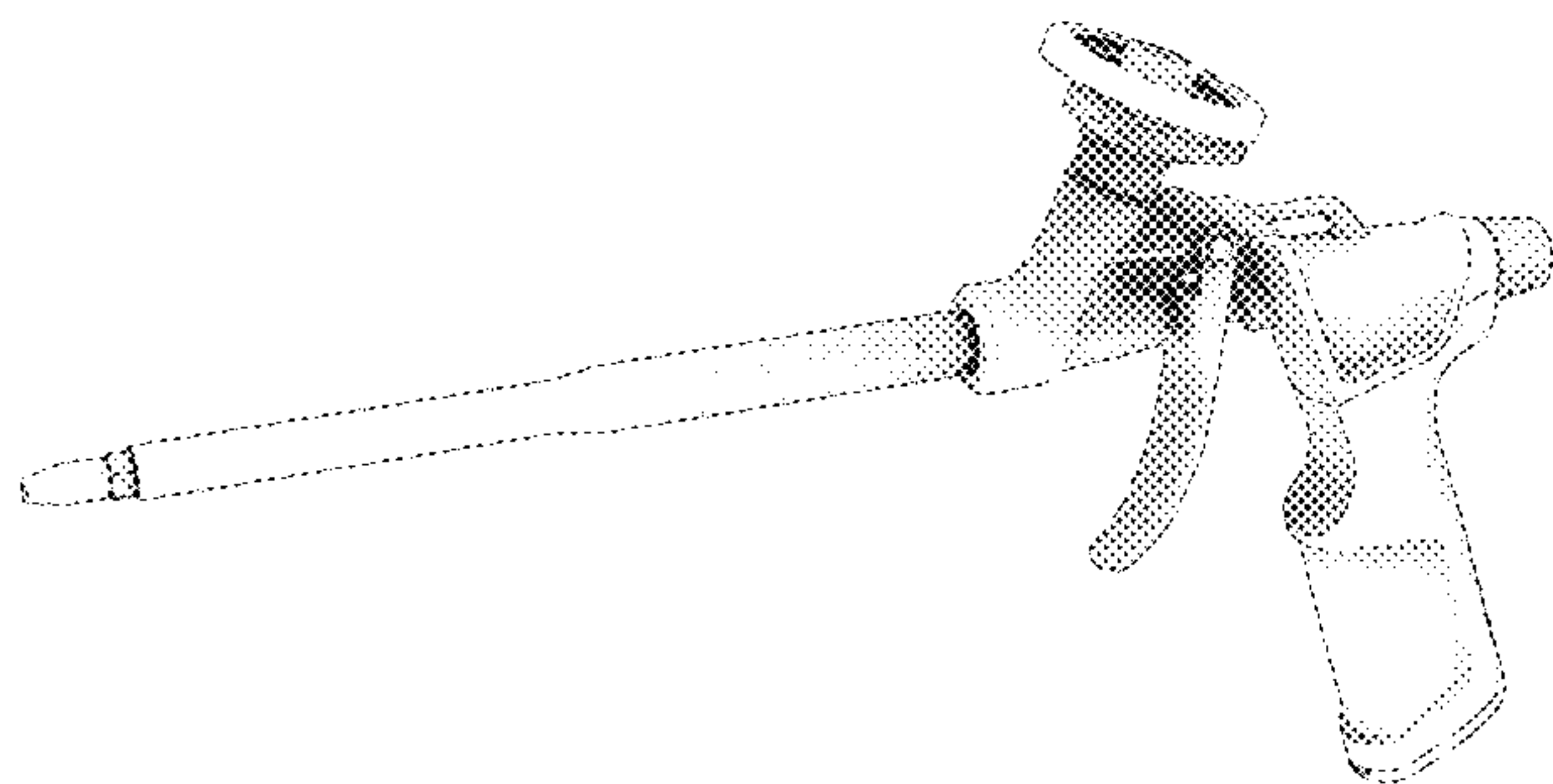
(57) **CLAIM**

The ornamental design for a foam gun, as shown and described.

DESCRIPTION

FIG. 1 is a side and front perspective view of a foam gun, showing our new design;
FIG. 2 is a top view thereof;
FIG. 3 is a side view thereof, with the opposite side view being a mirror image;
FIG. 4 is a rear, side and top perspective view thereof;
FIG. 5 is a side, front and bottom perspective view thereof; and,

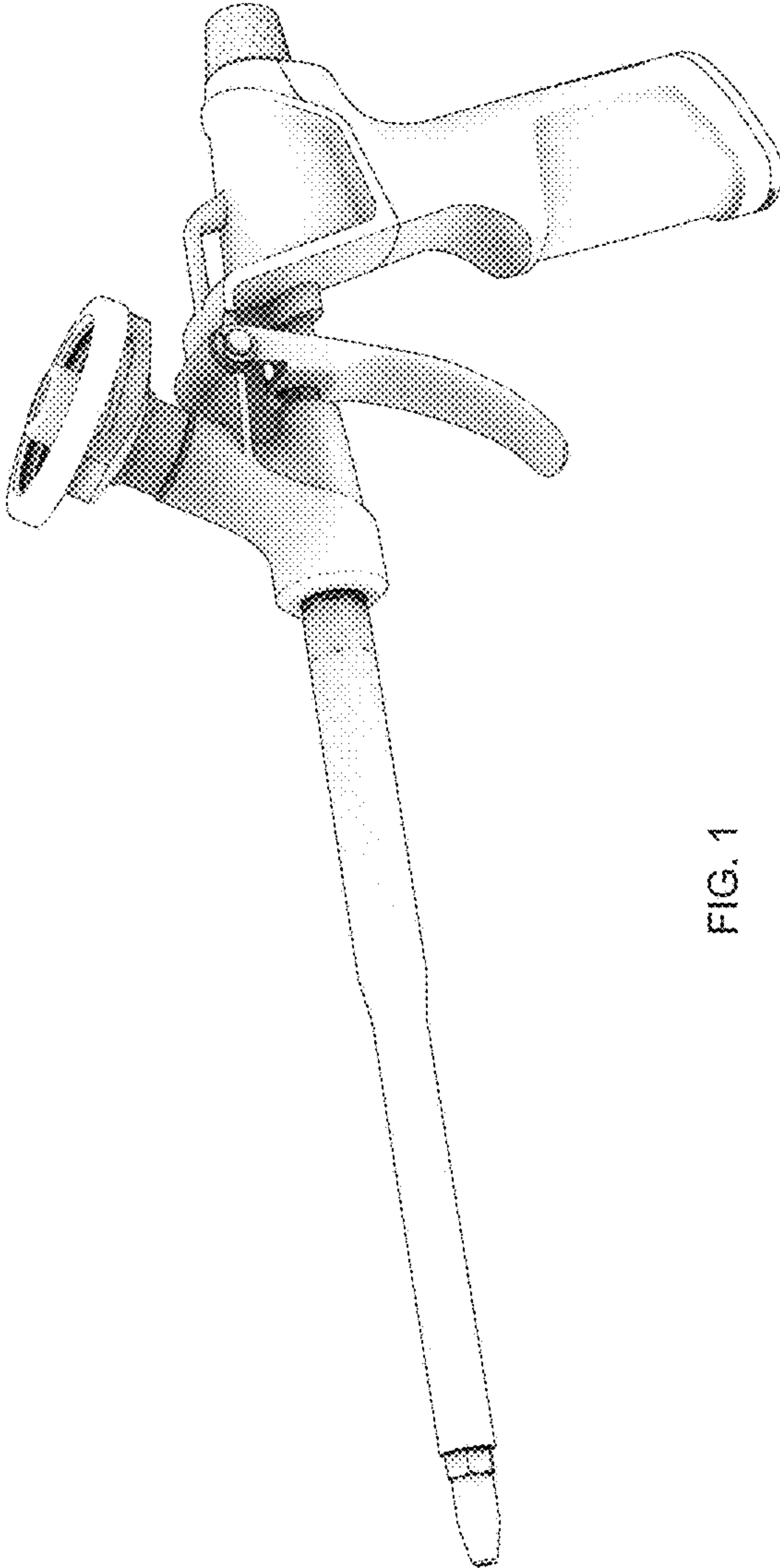

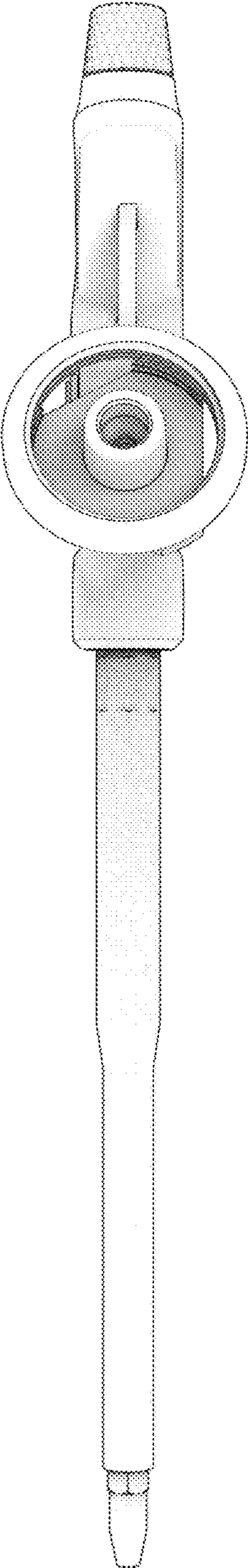

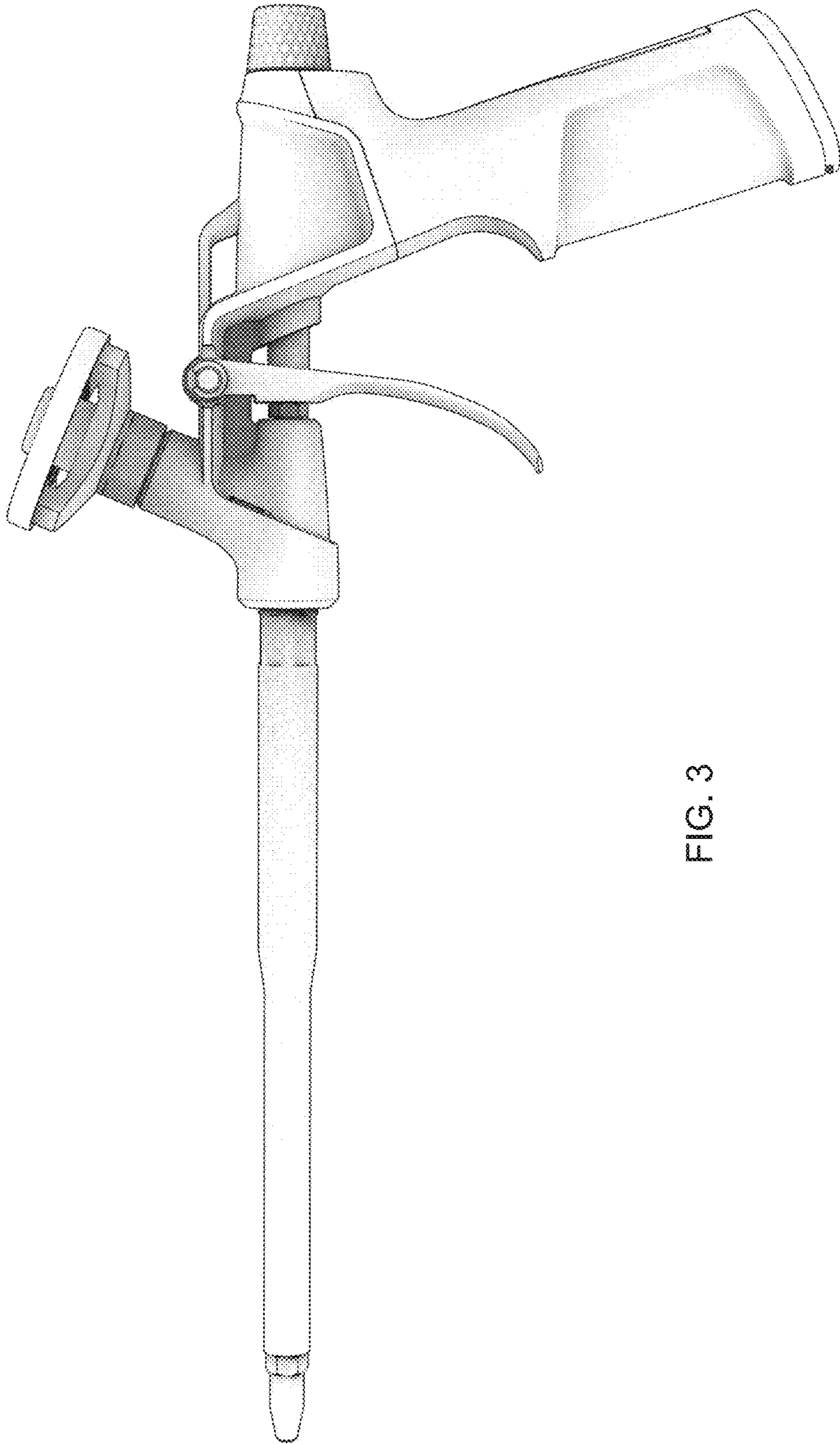

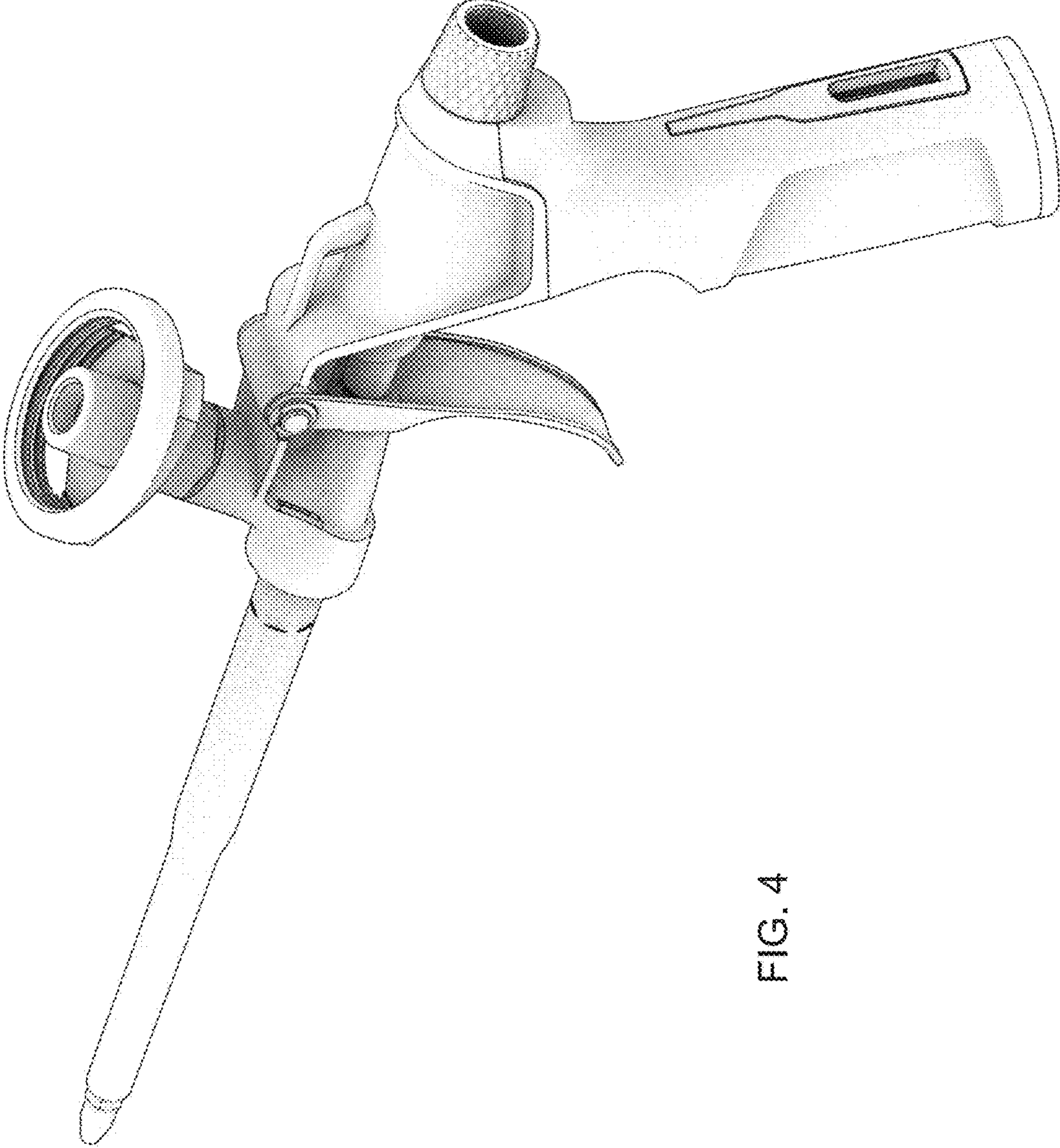

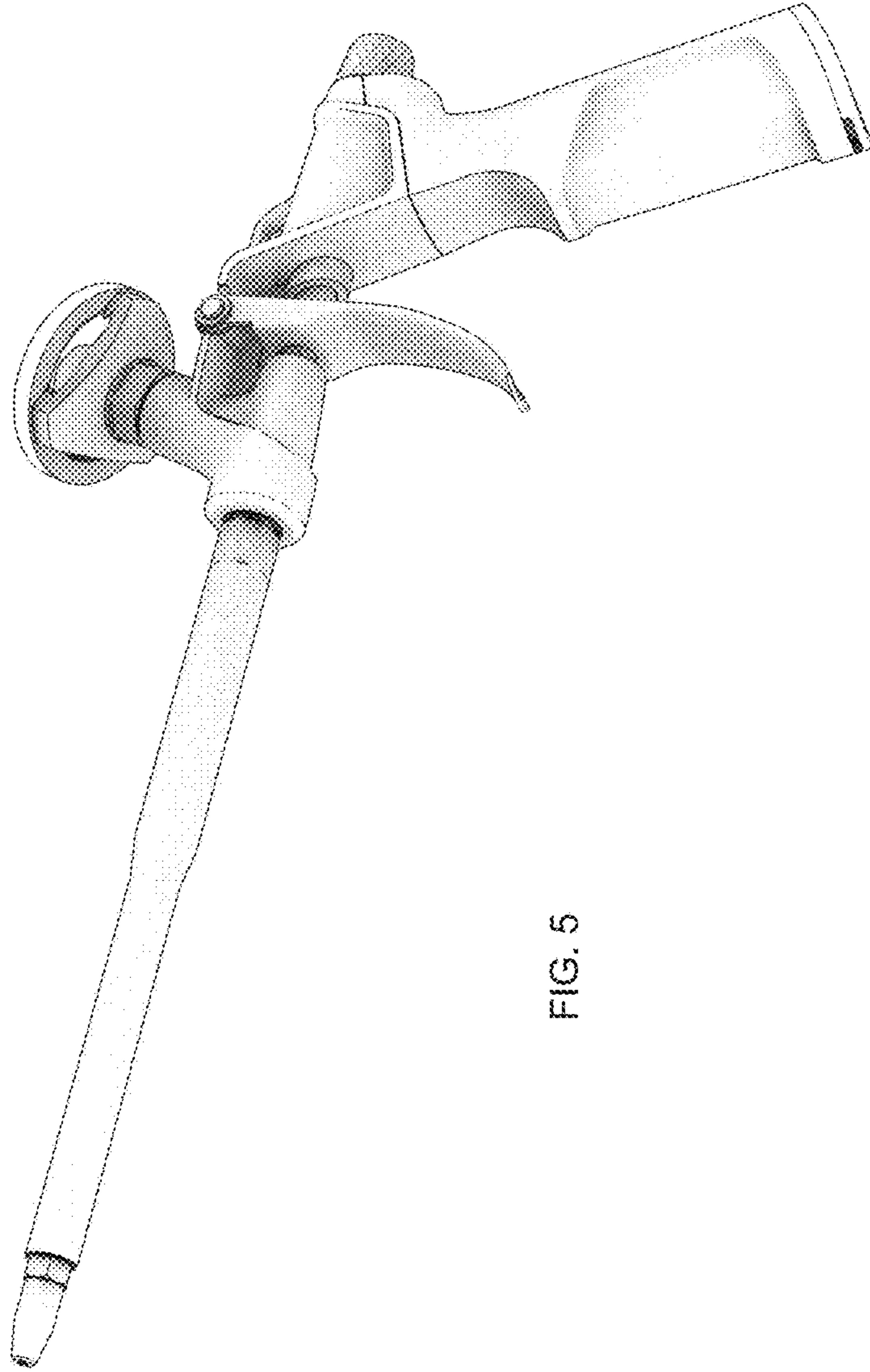

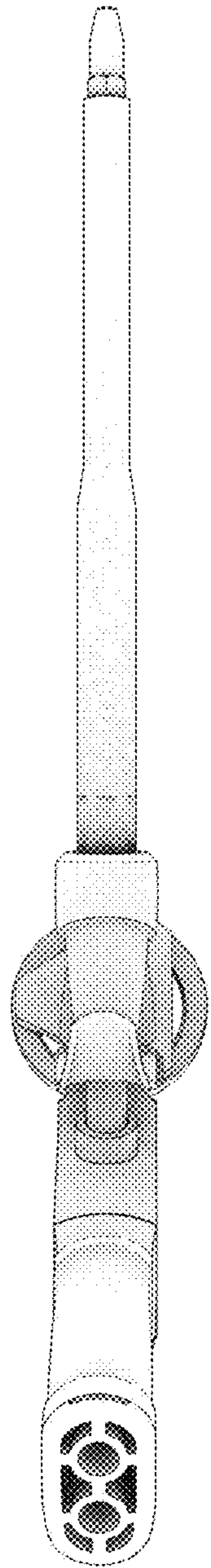
