FIG. 8 is a cross-sectional view thereof along the line 8-8 in FIG. 2.

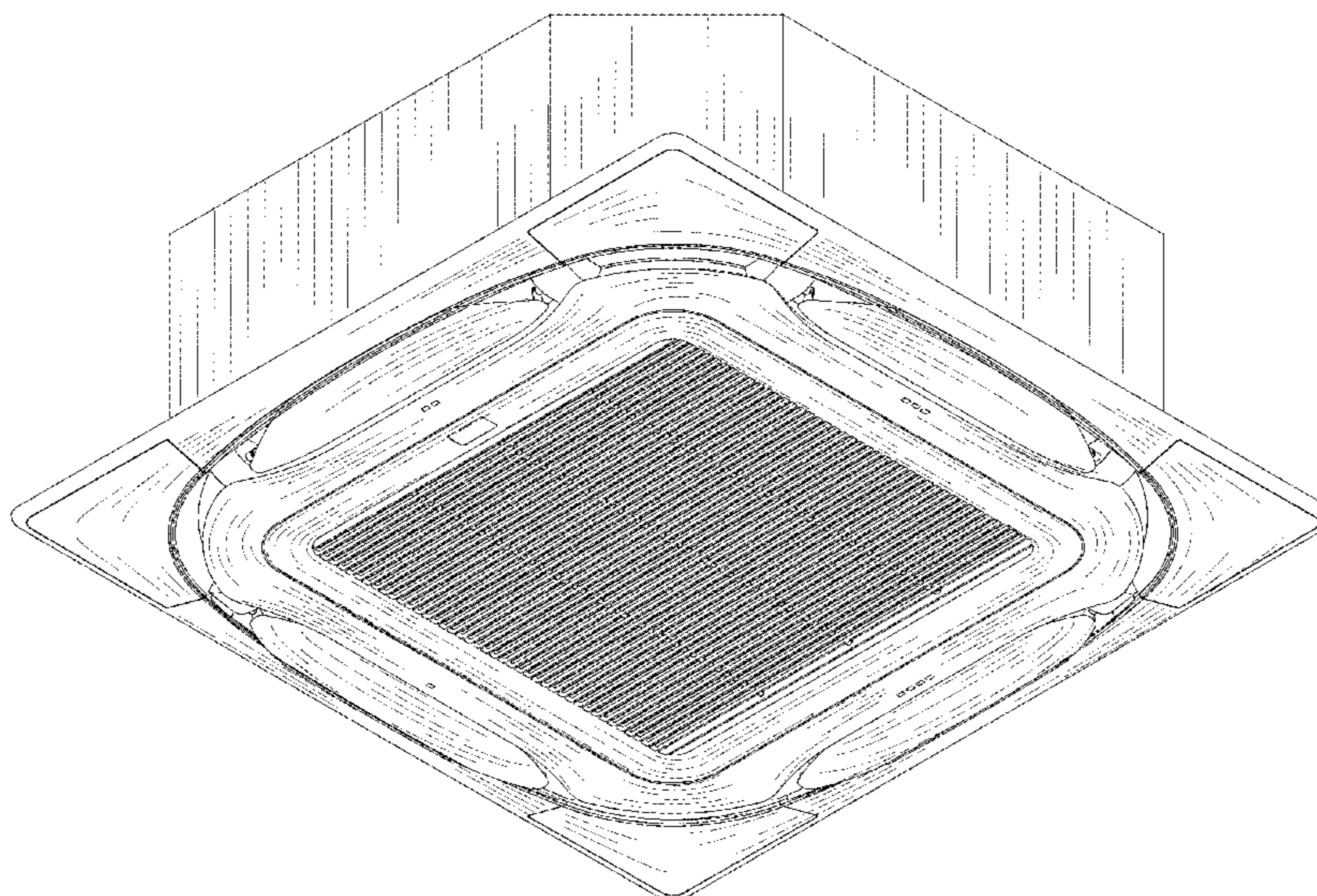

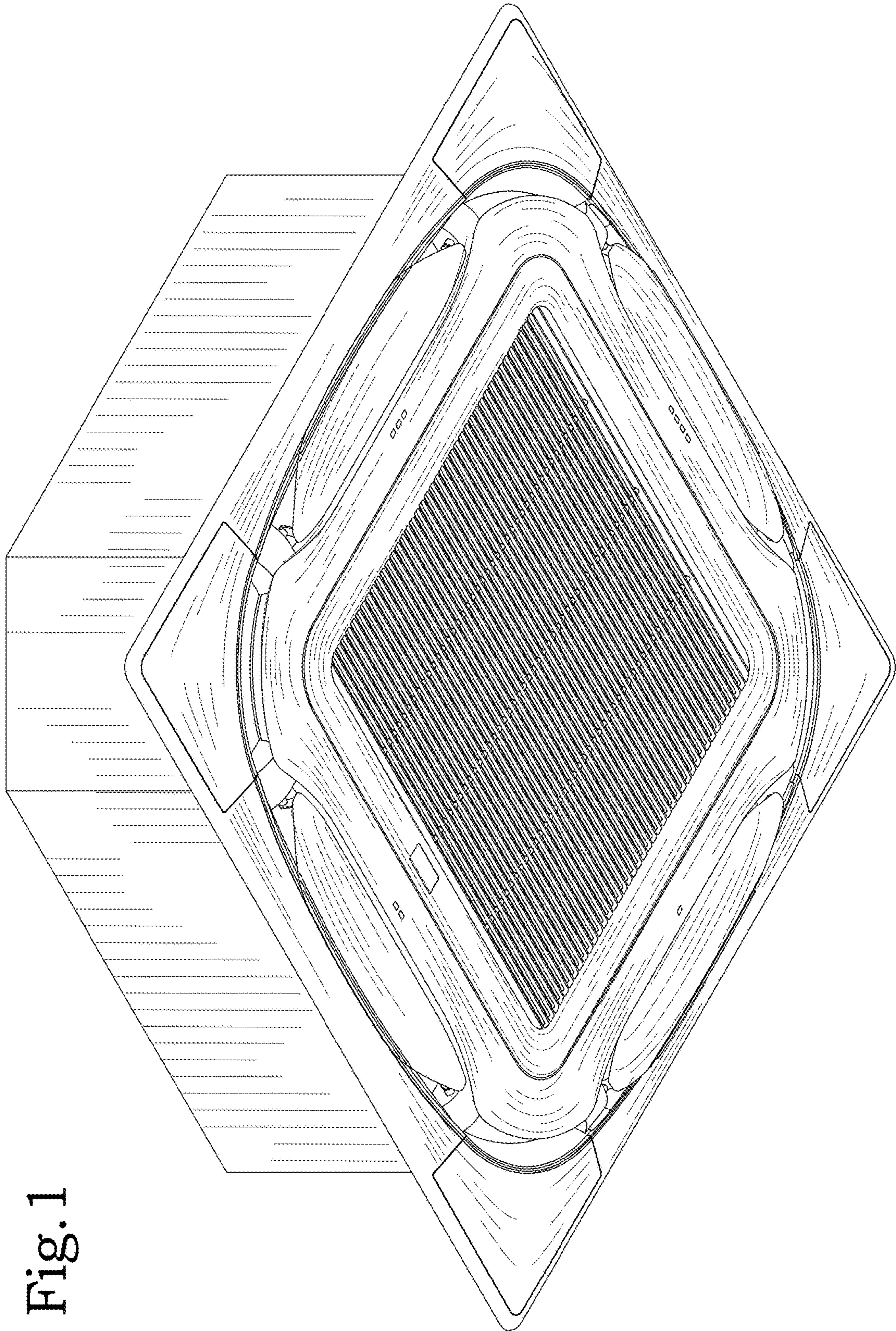

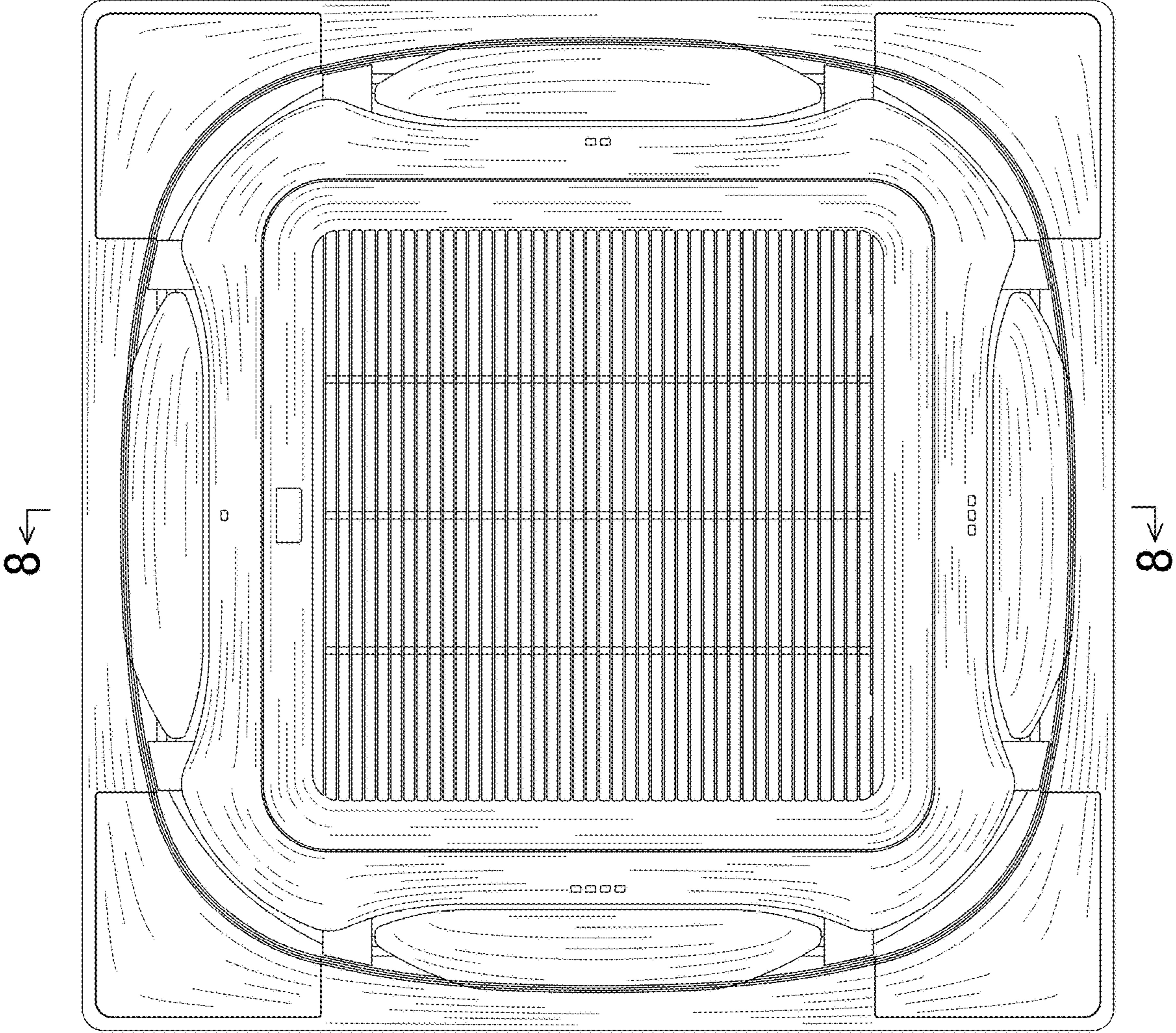

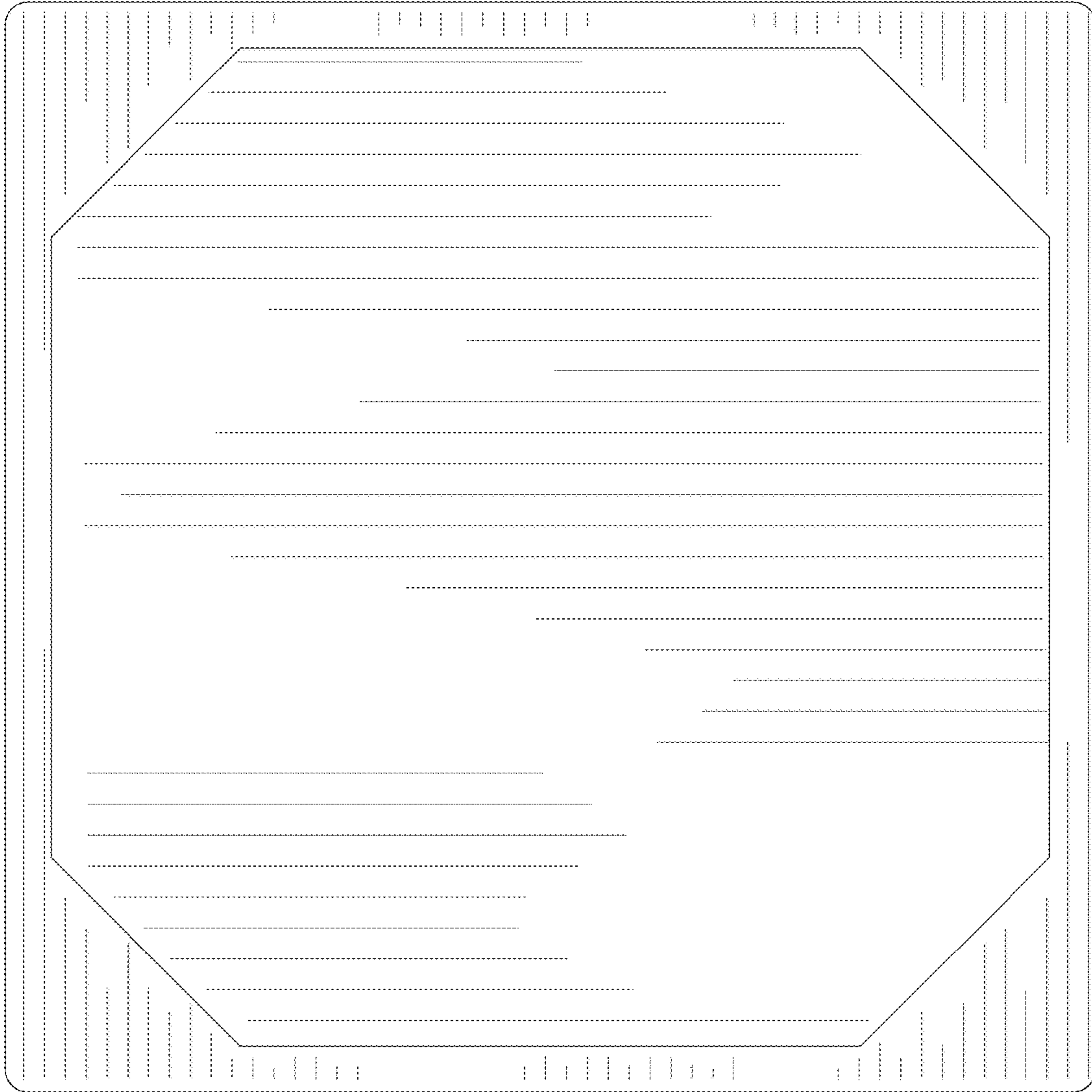

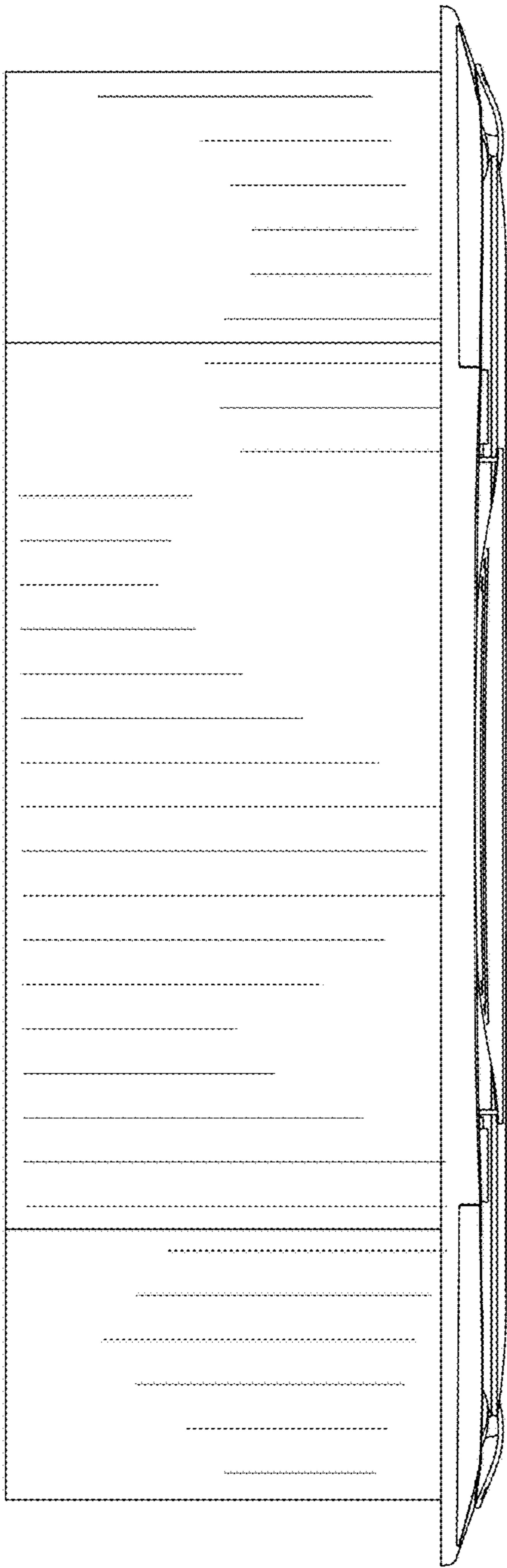

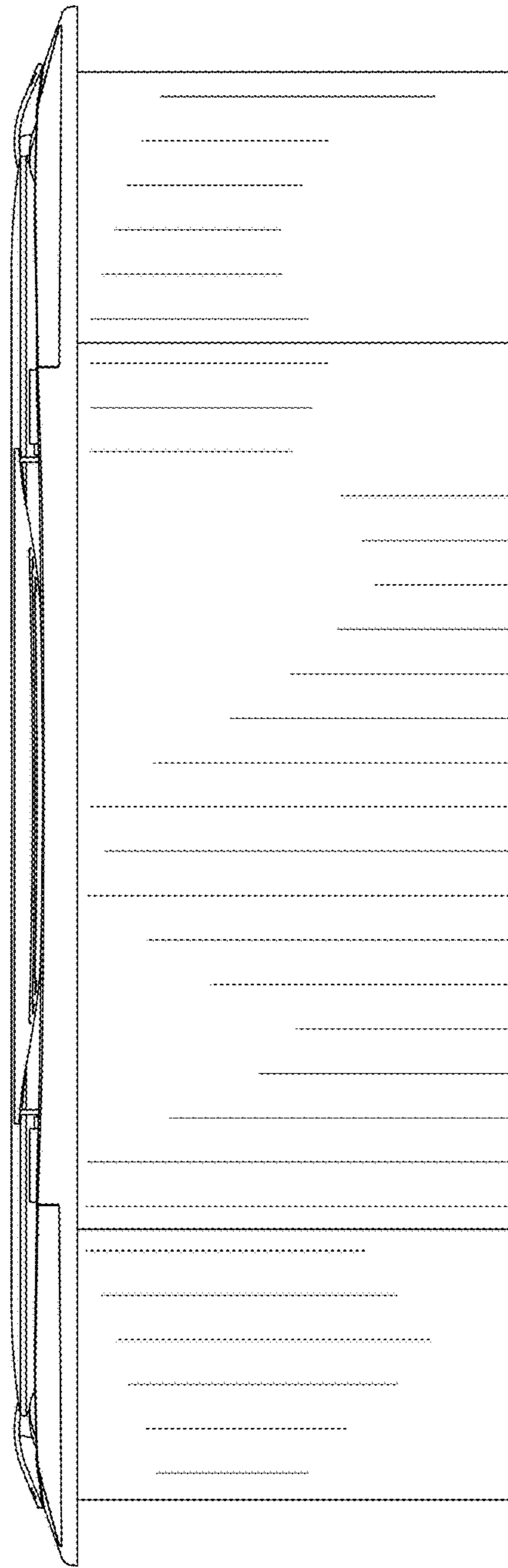

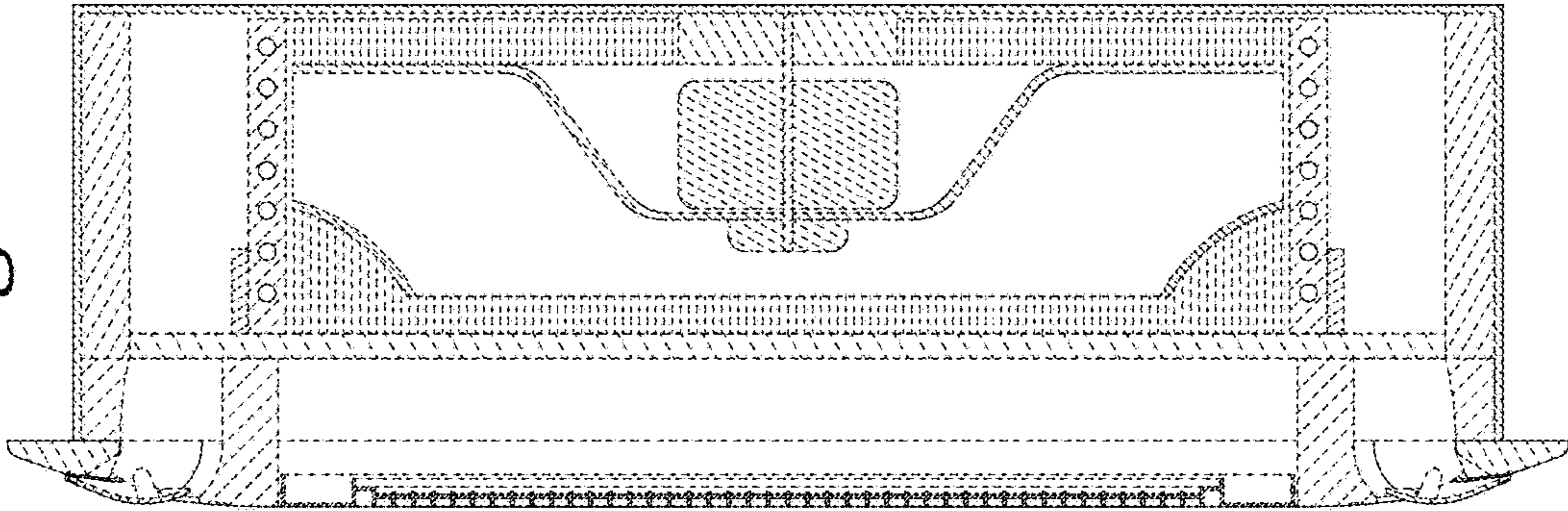

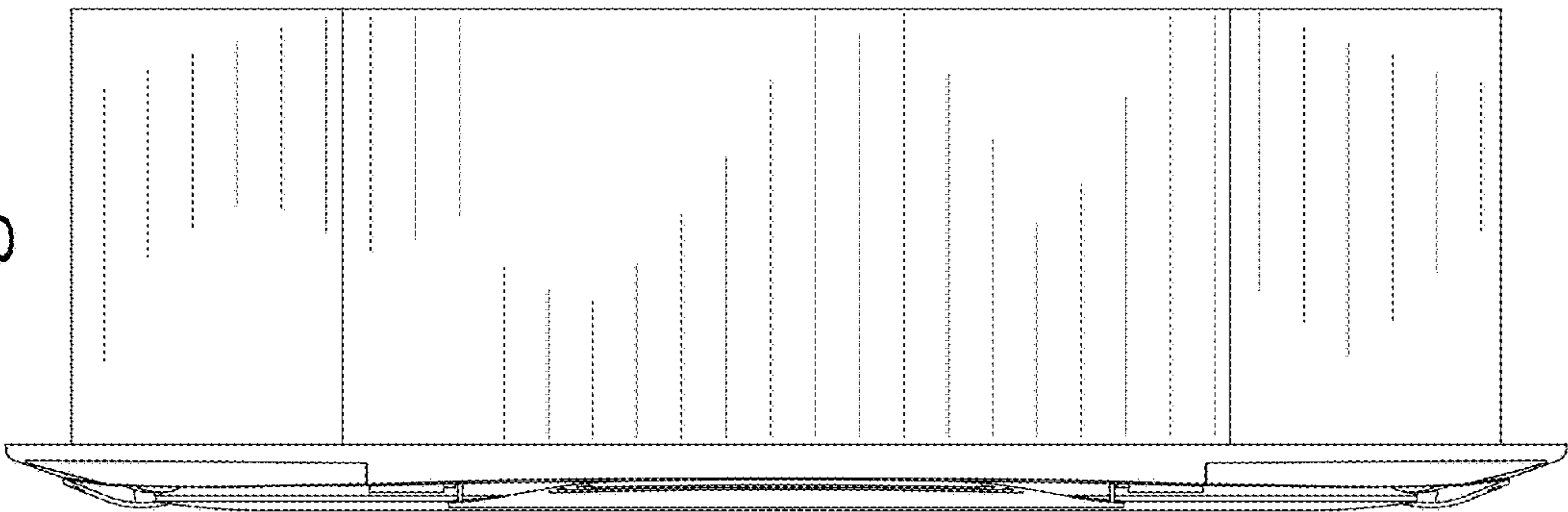
