DESCRIPTION

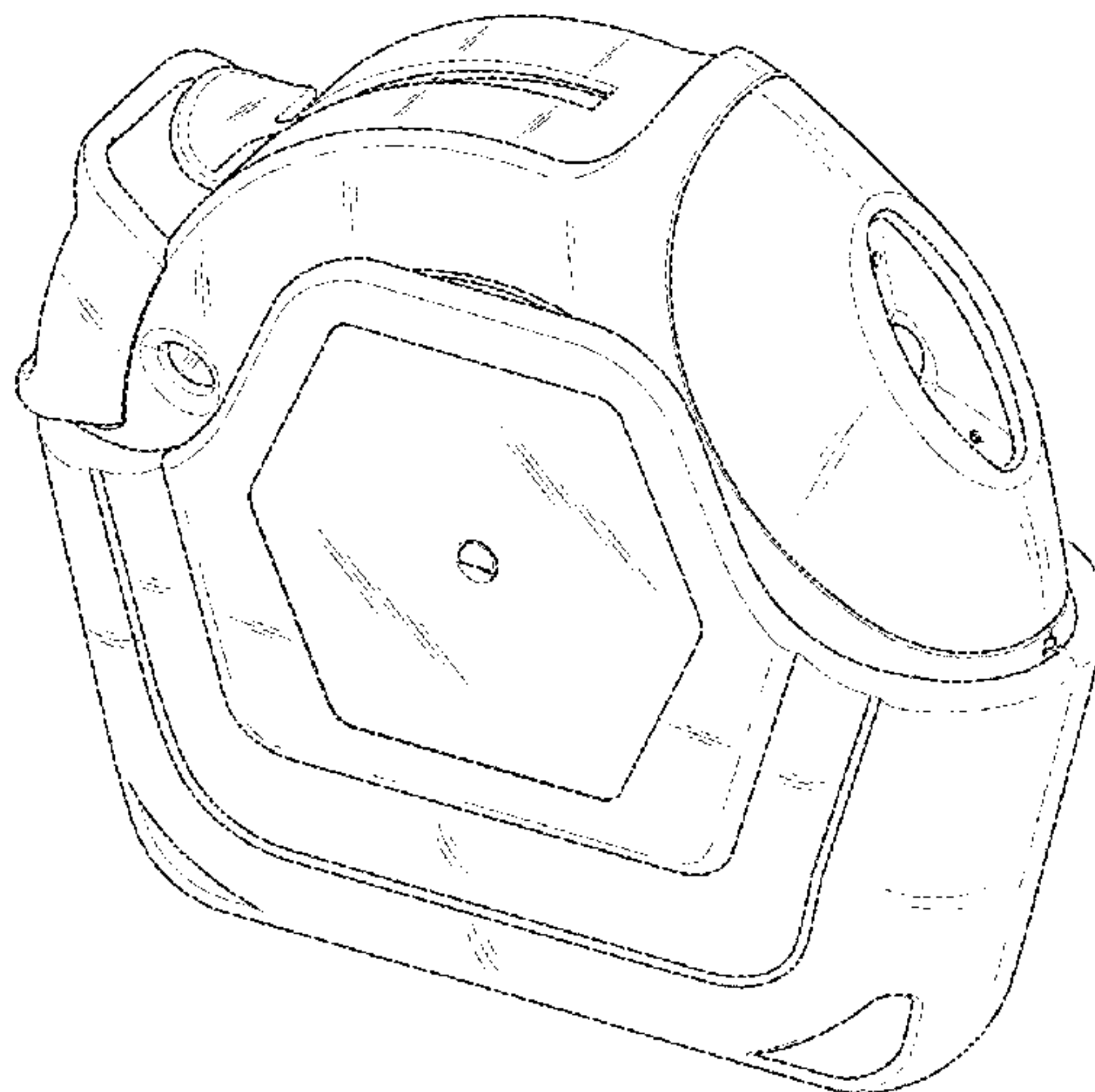
FIG. 1 is a perspective view of a medicine inhaler showing

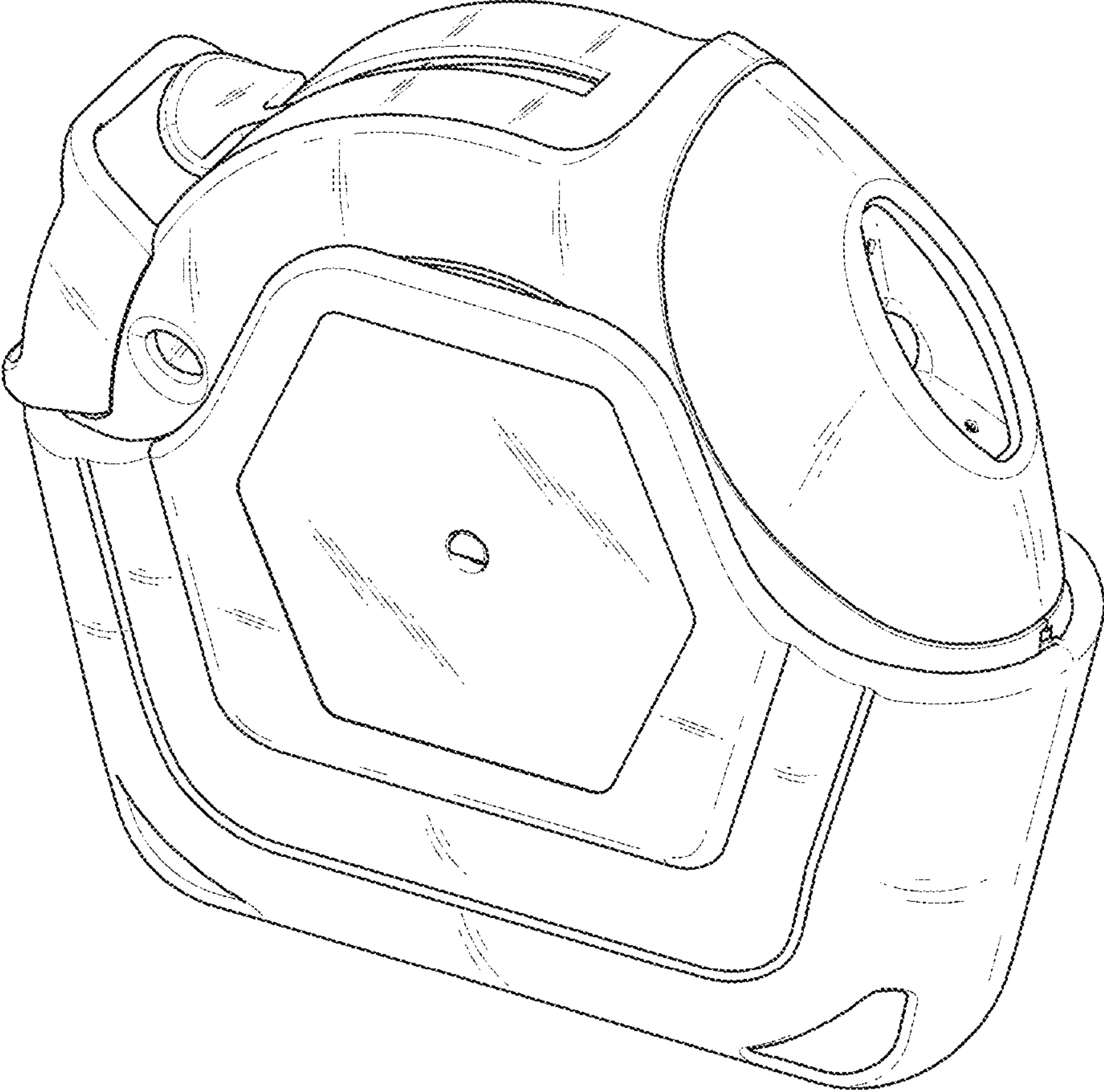

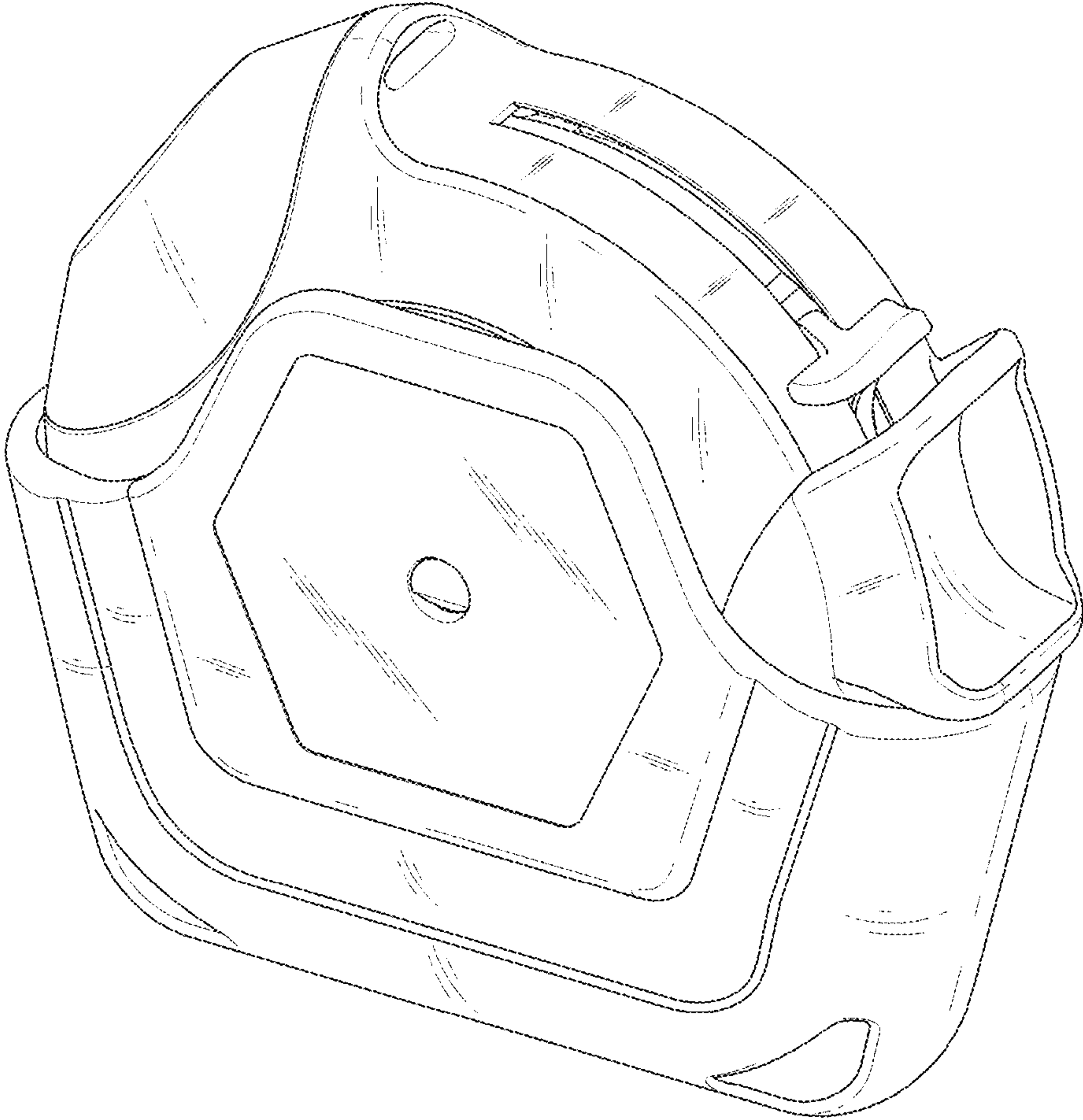

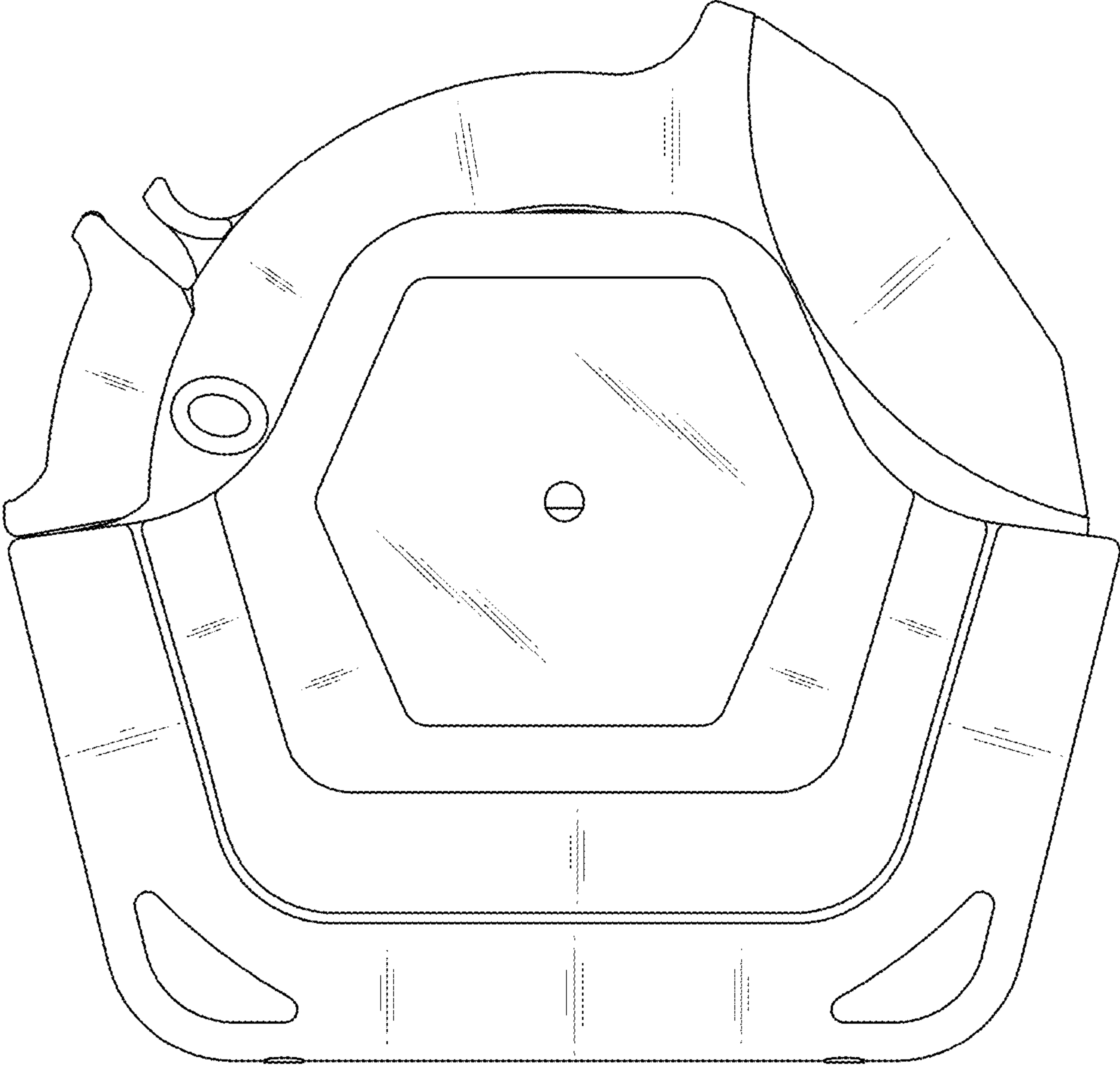

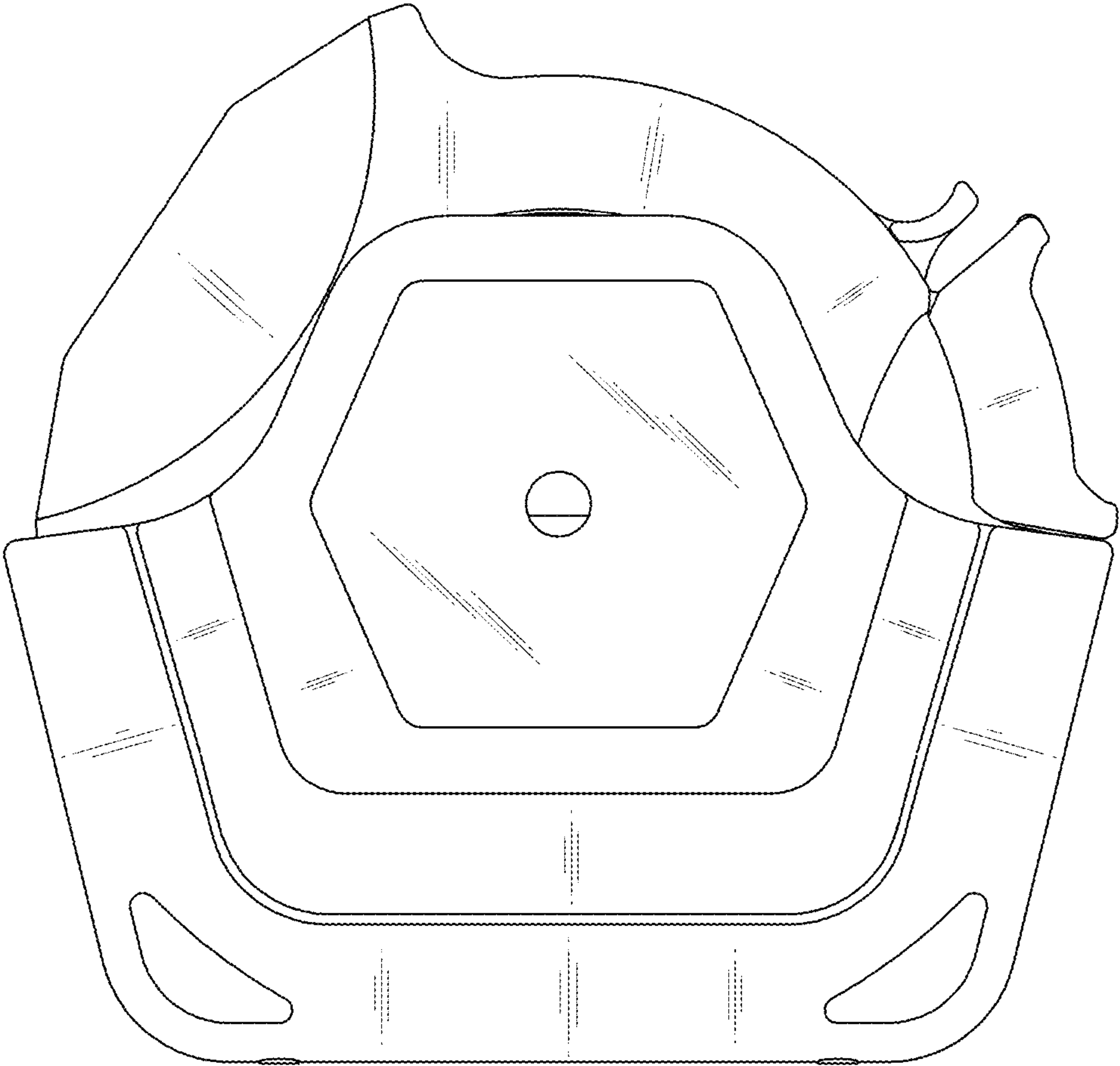

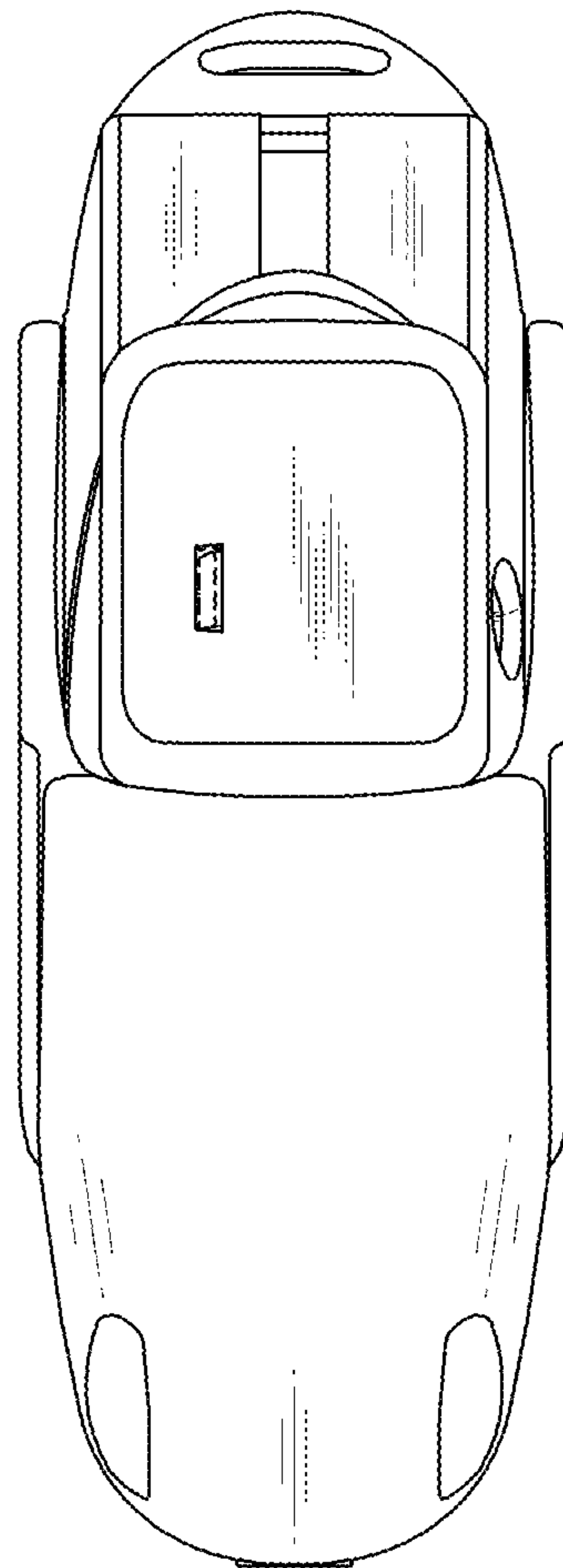

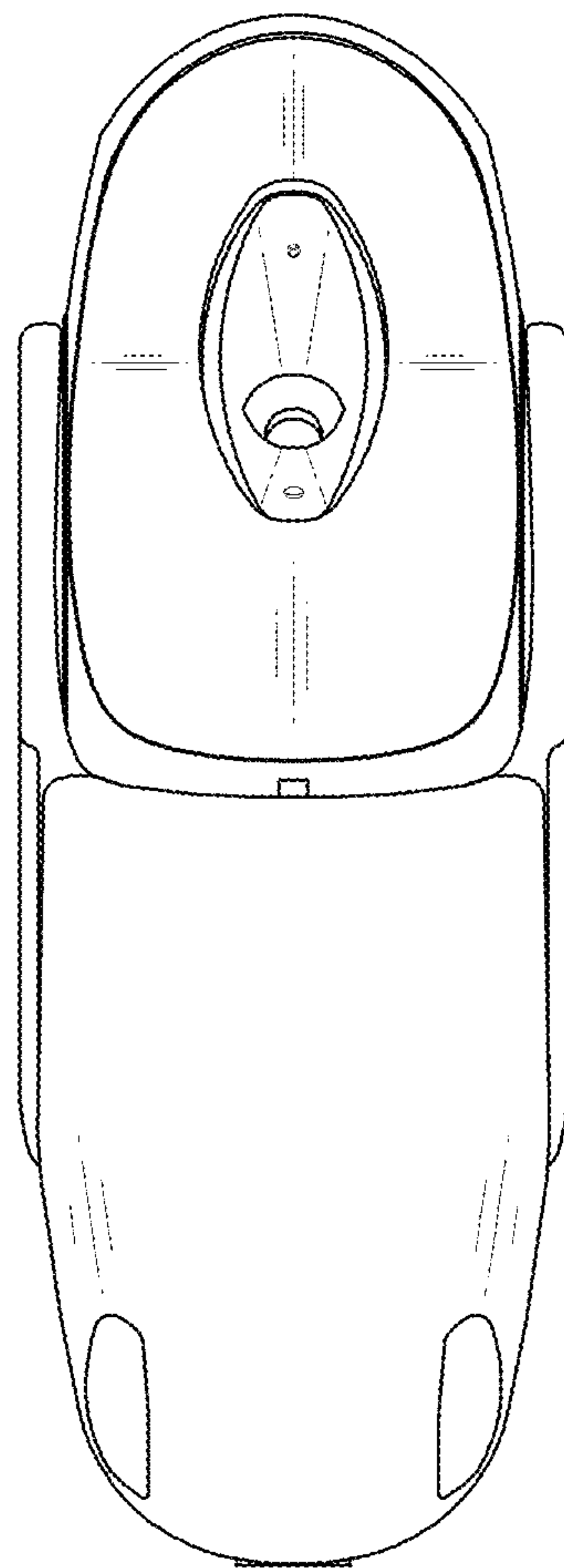

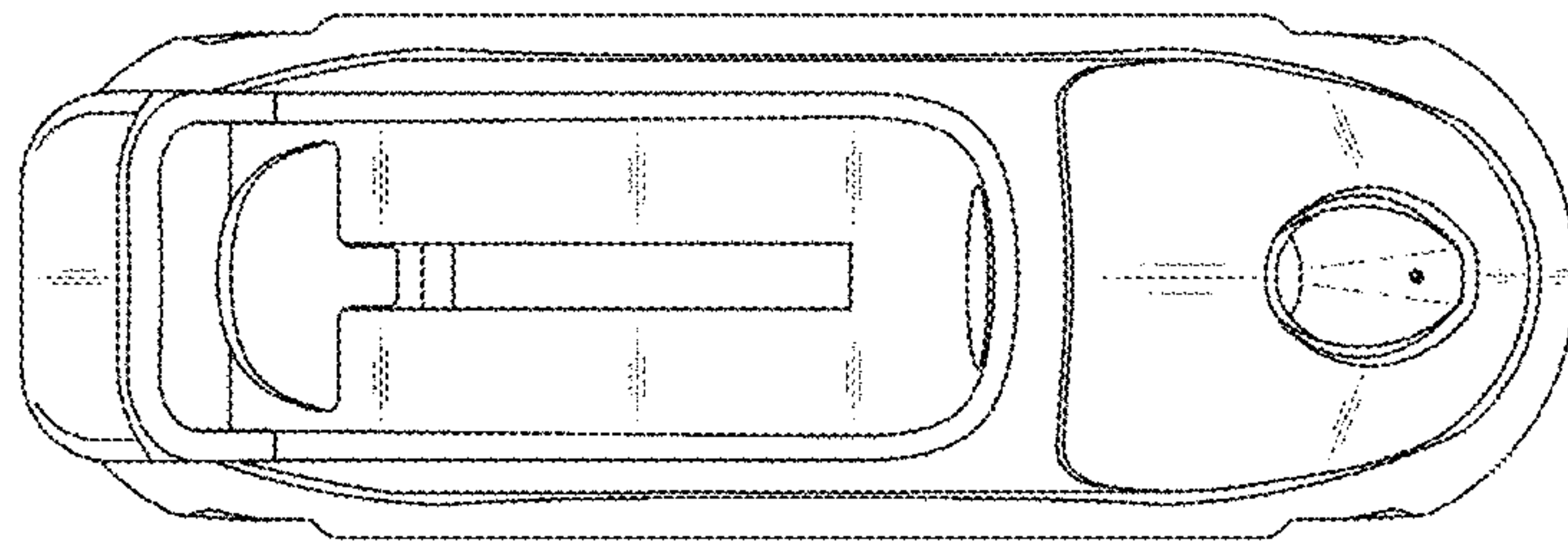
