FIG. 5 is a left side view of the tray of FIG. 1.

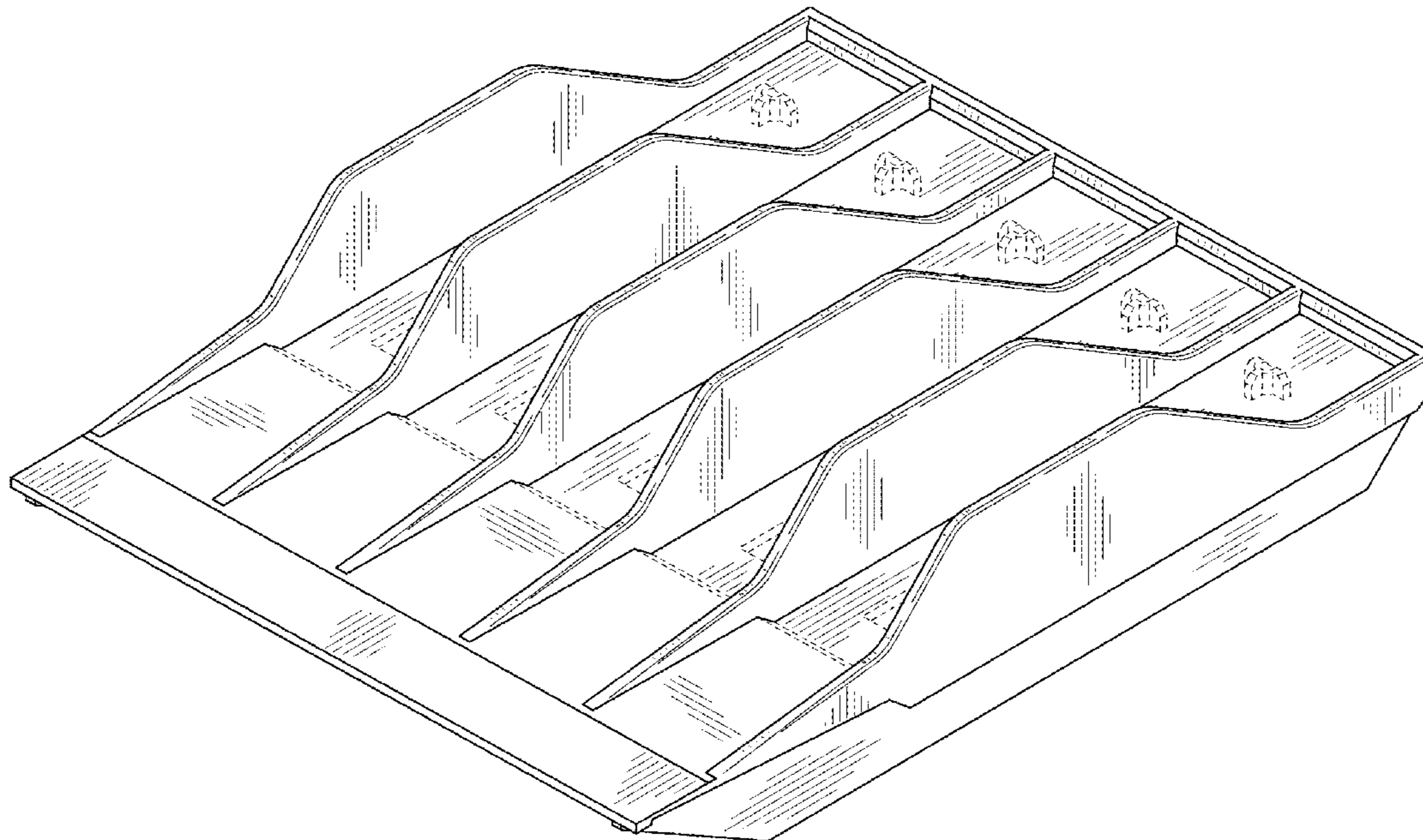
FIG. 6 is a top view of the tray of FIG. 1.

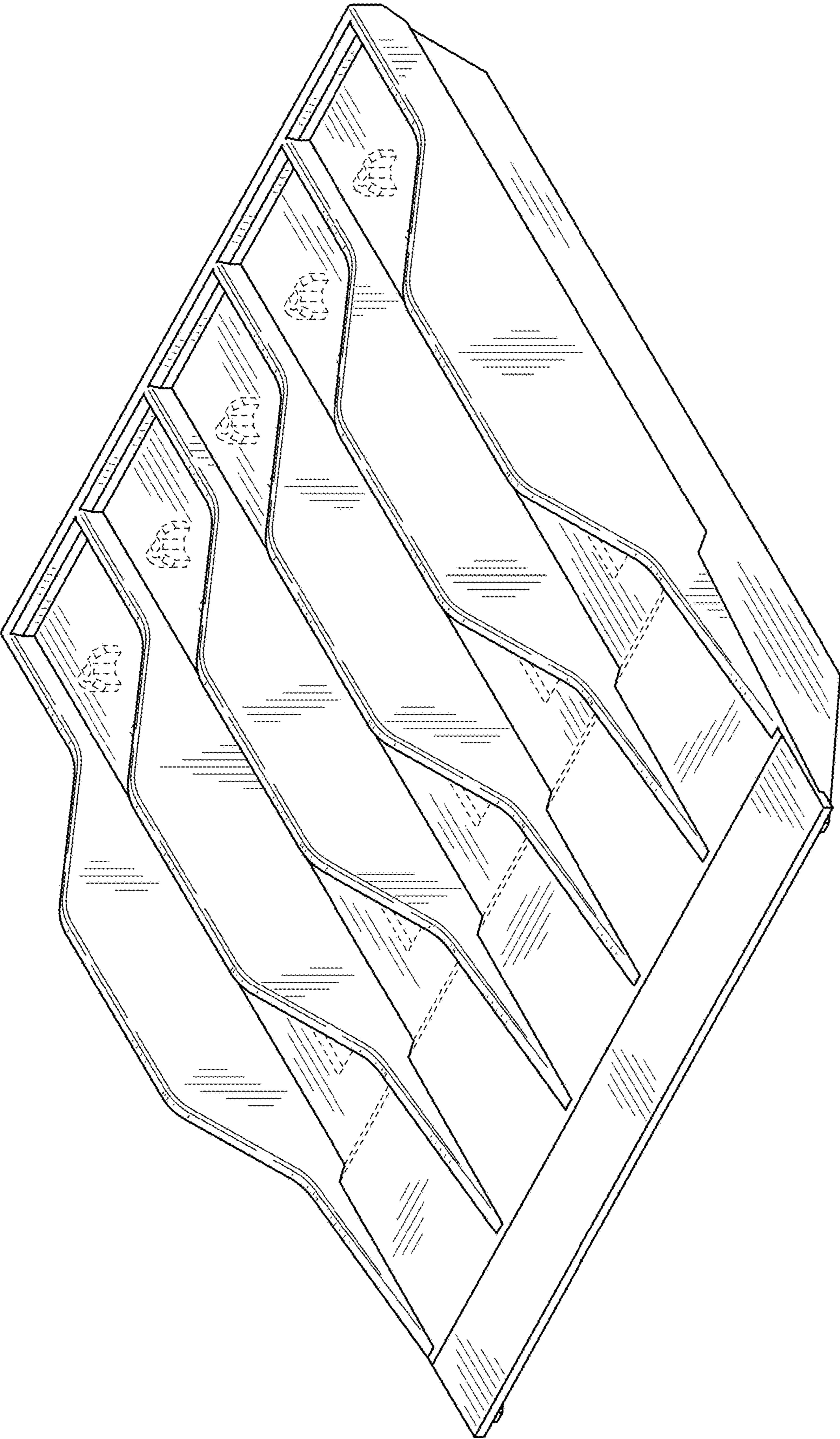

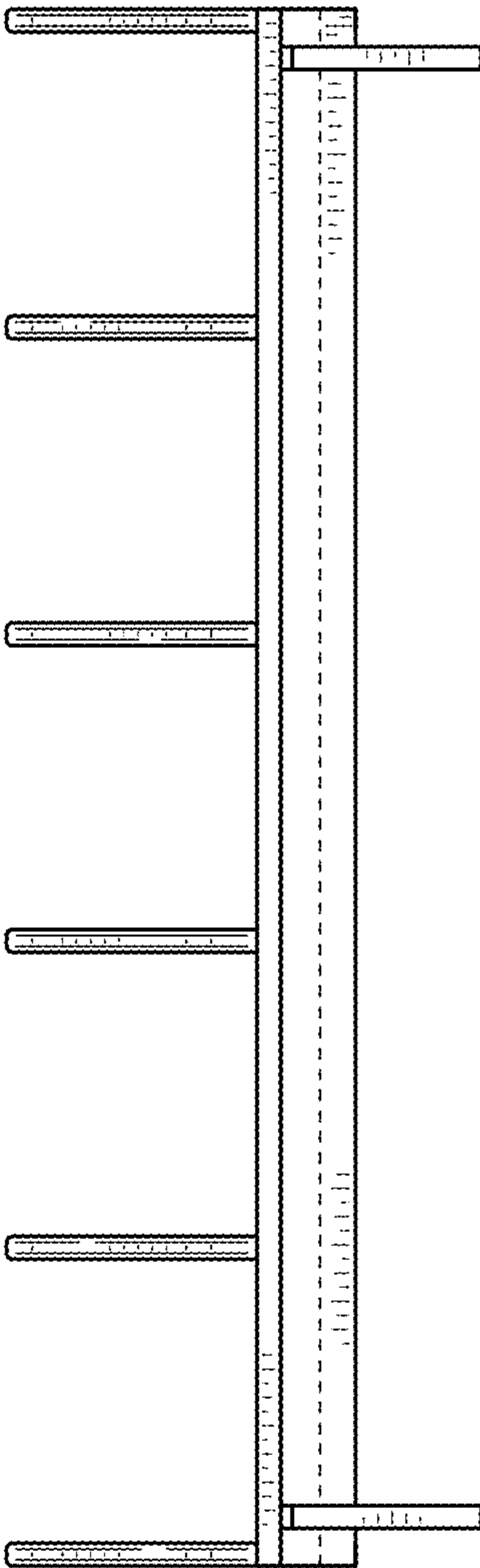

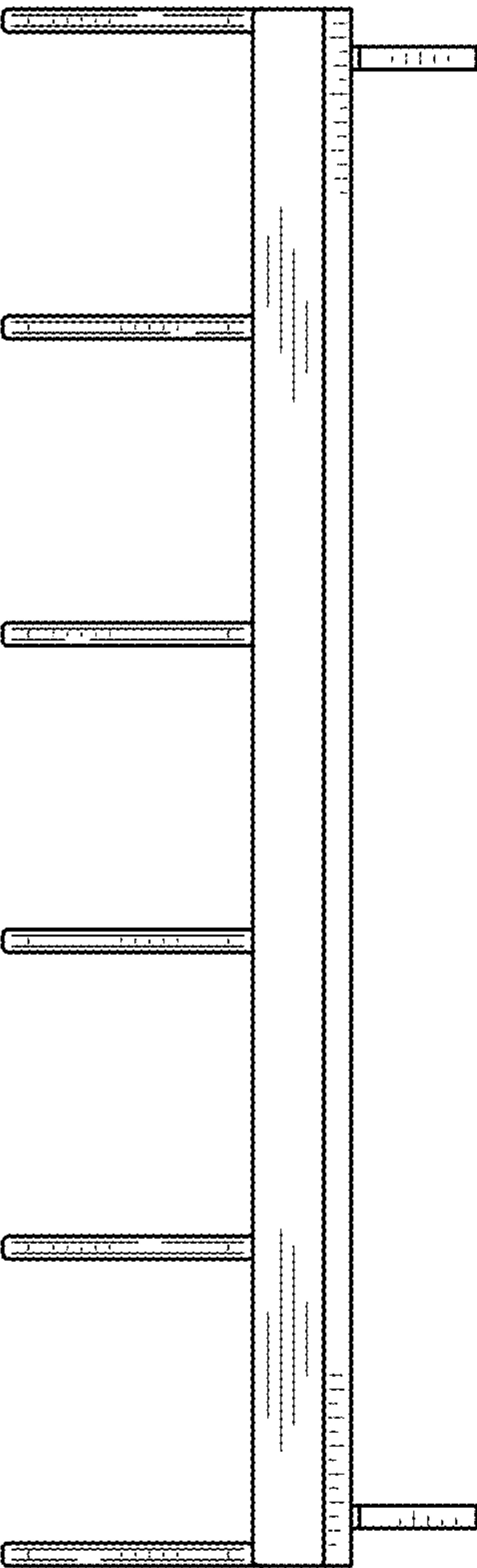

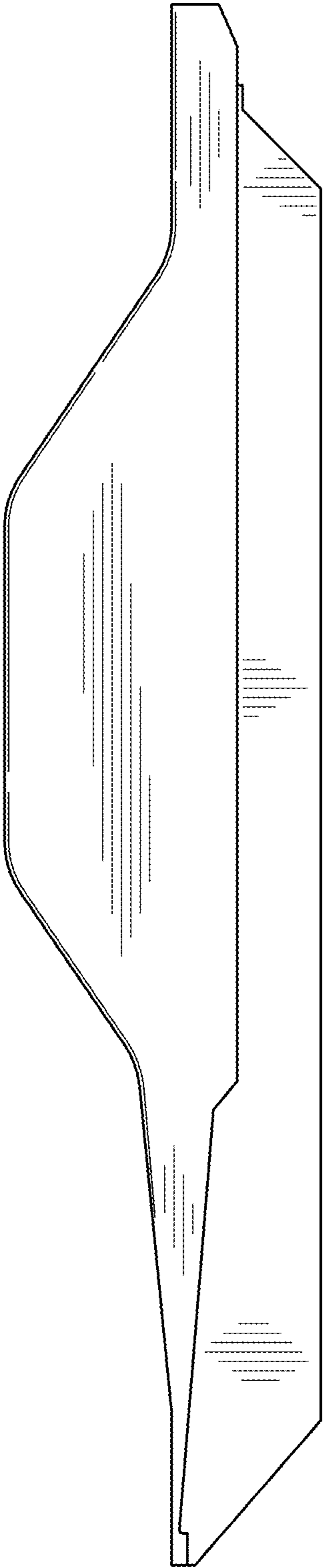

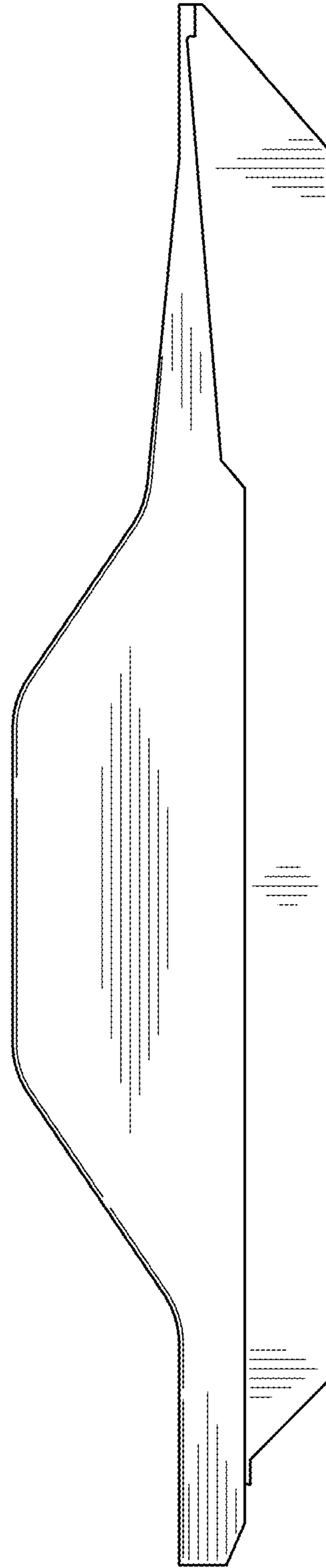

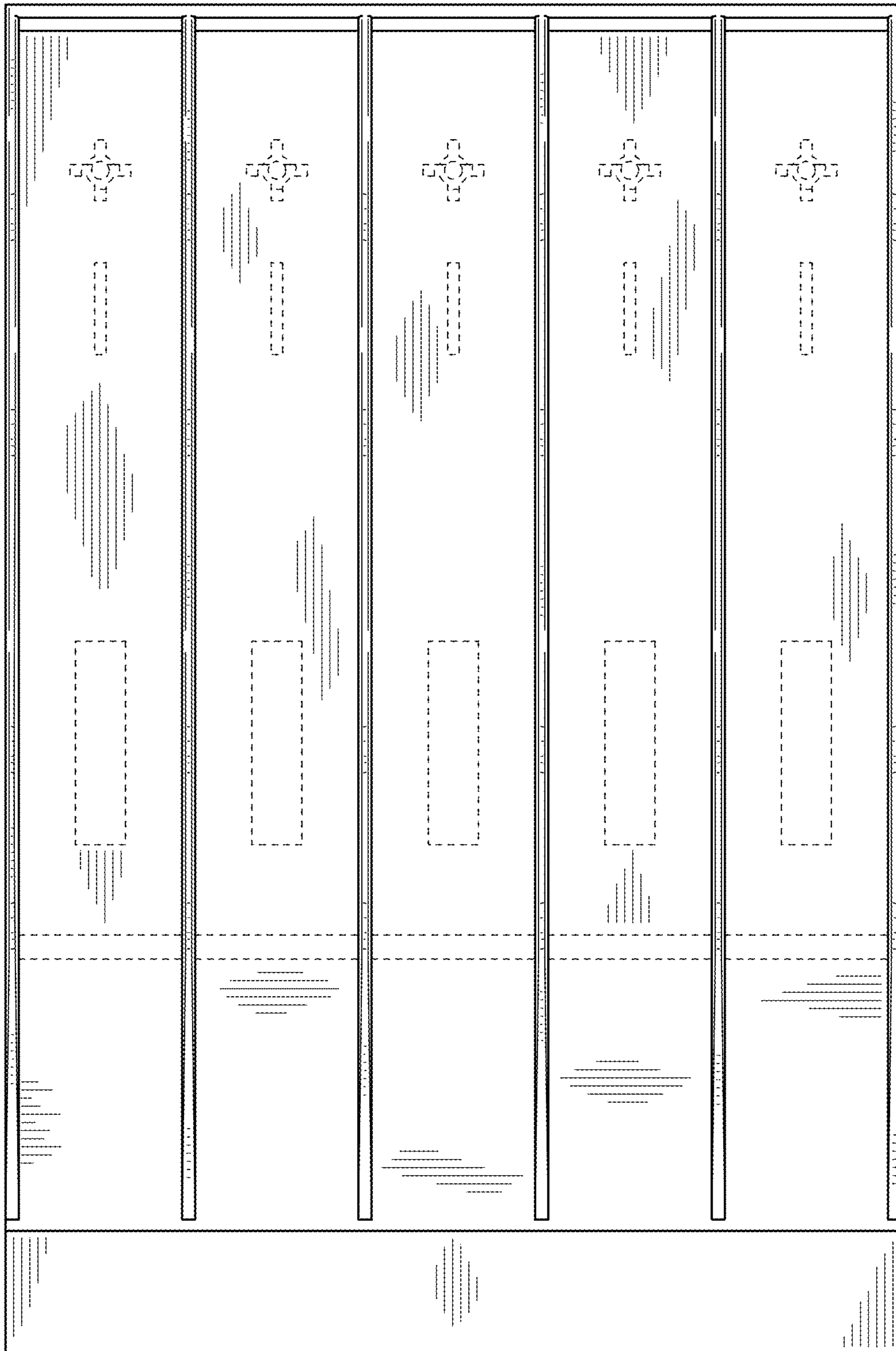

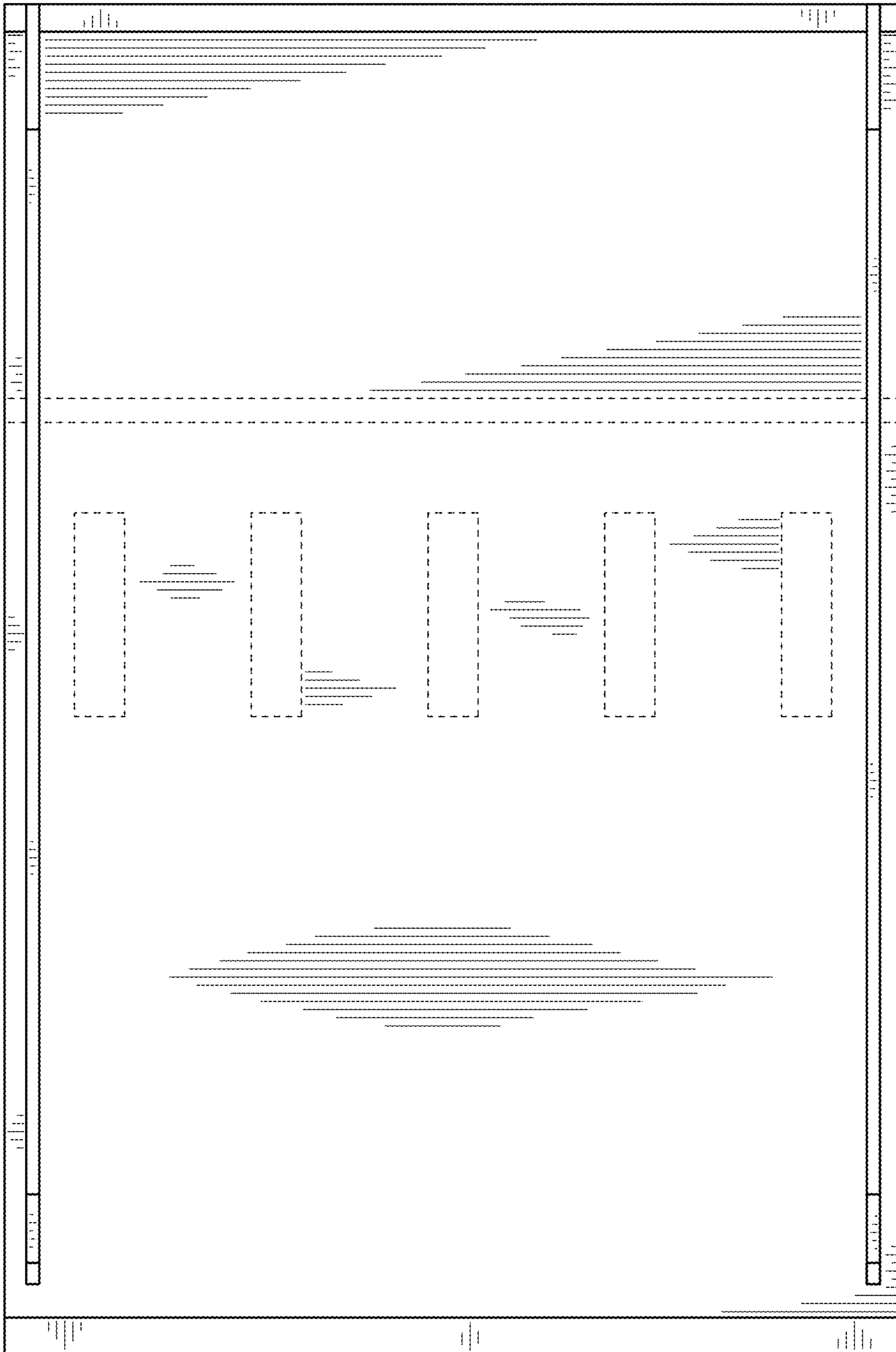

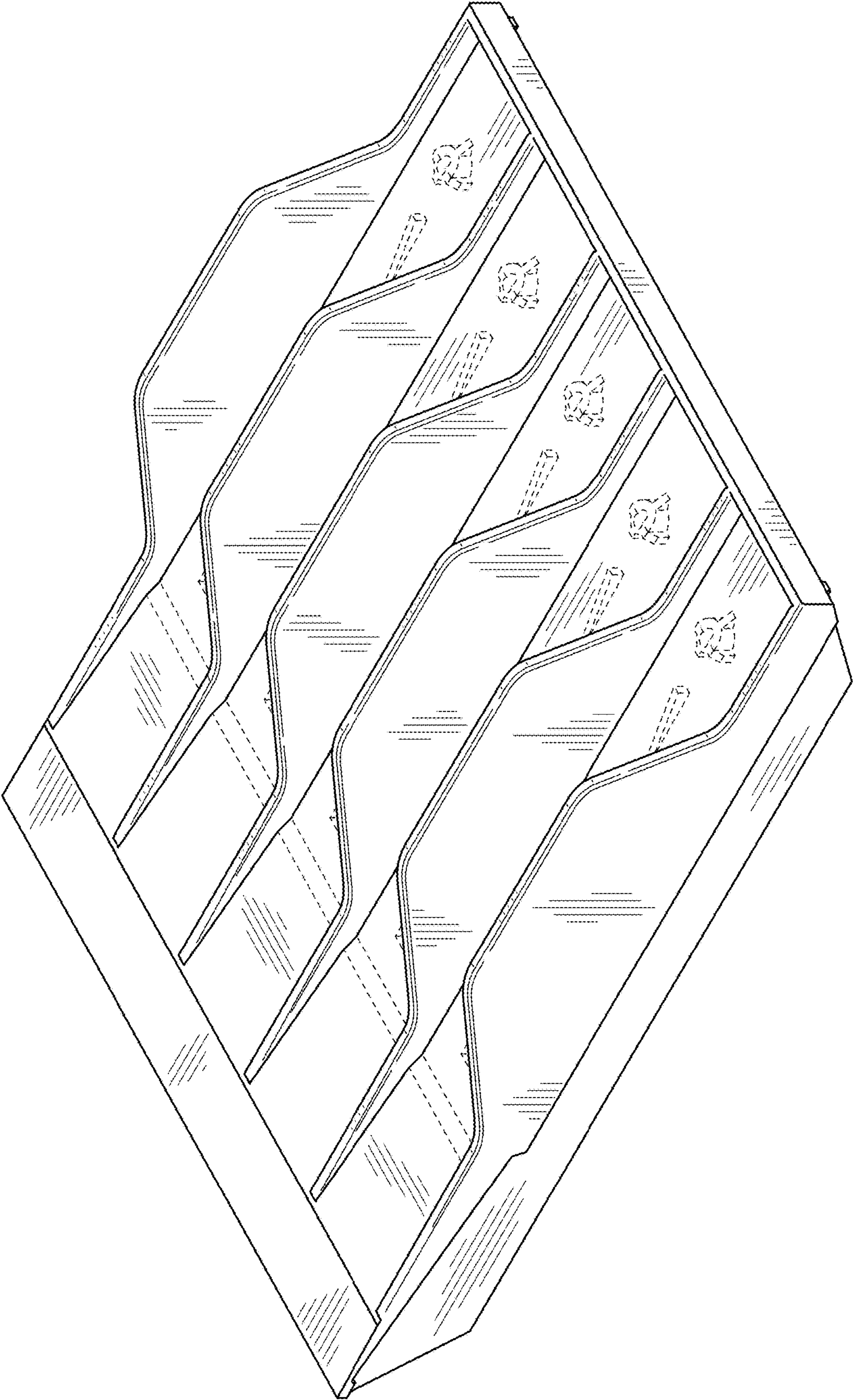
