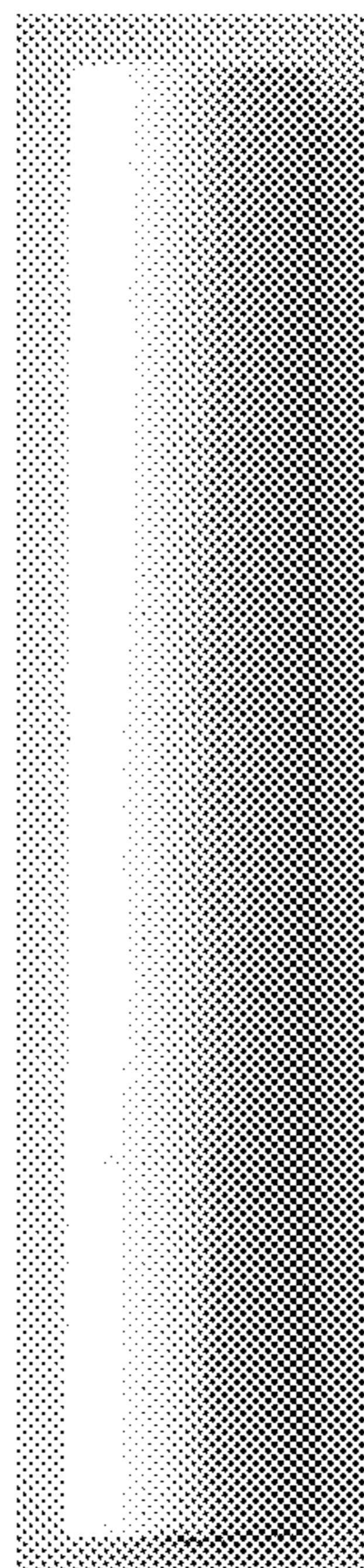
(57) **CLAIM**

The ornamental design for a tobacco stick, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a tobacco stick showing my new design, the rear, left, and right views being substantially identical;
 FIG. 2 is a top view thereof;
 FIG. 3 is an enlarged bottom view thereof;
 FIG. 4 is an enlarged bottom view of a second embodiment thereof, the front, rear, left, right, and top views being substantially identical to those of the first embodiment;
 FIG. 5 is an enlarged bottom view of a third embodiment thereof, the front, rear, left, right, and top views being substantially identical to those of the first embodiment; and,
 FIG. 6 is an enlarged bottom view of a fourth embodiment thereof, the front, rear, left, right, and top views being substantially identical to those of the first embodiment.
 The gray background and shadows form no part of the claimed design.

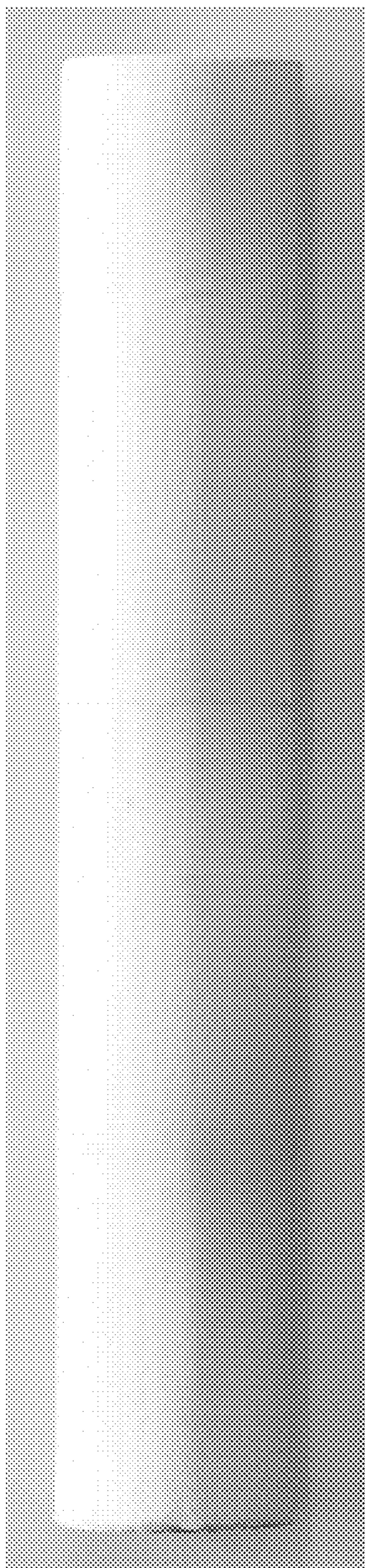

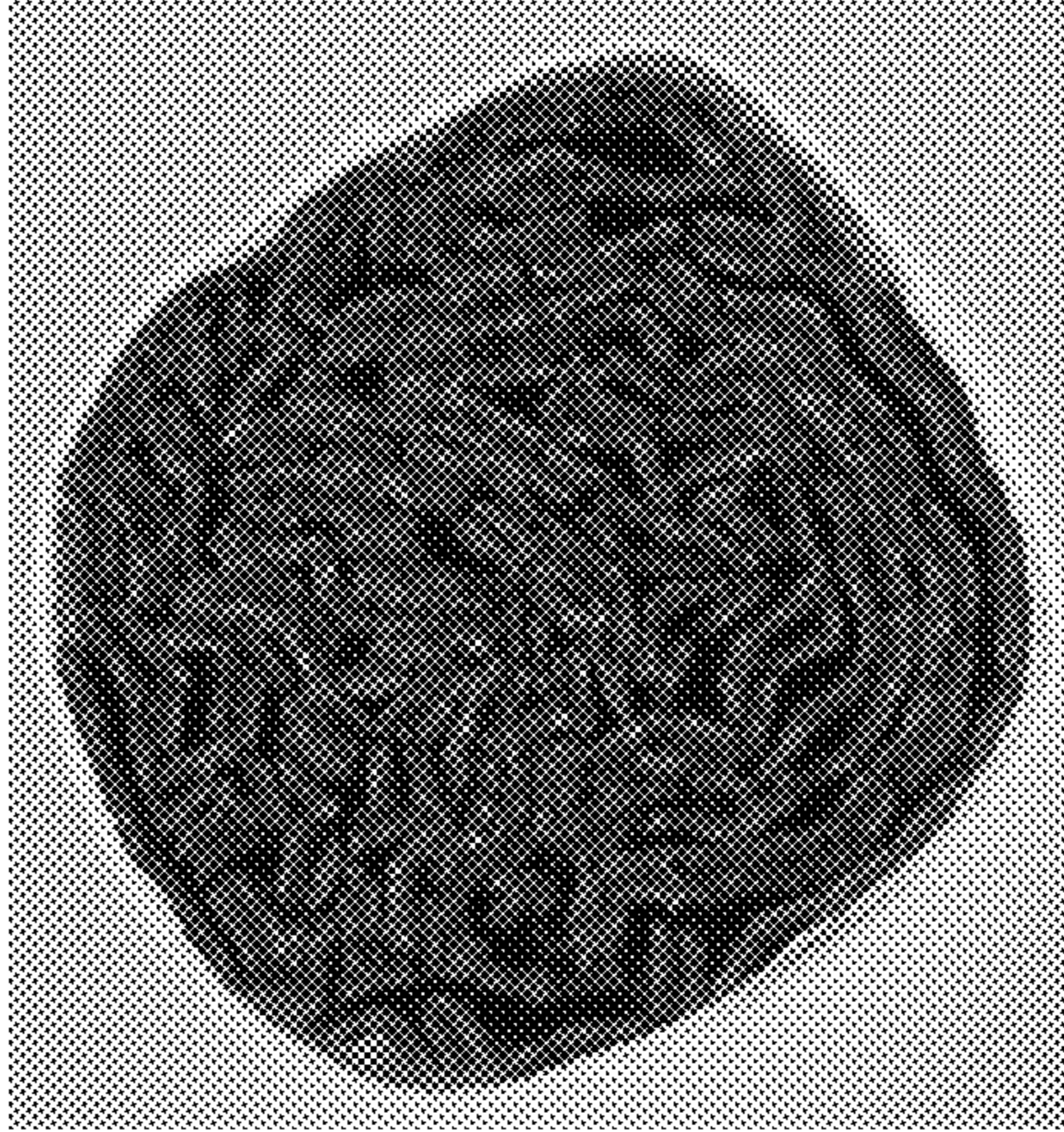

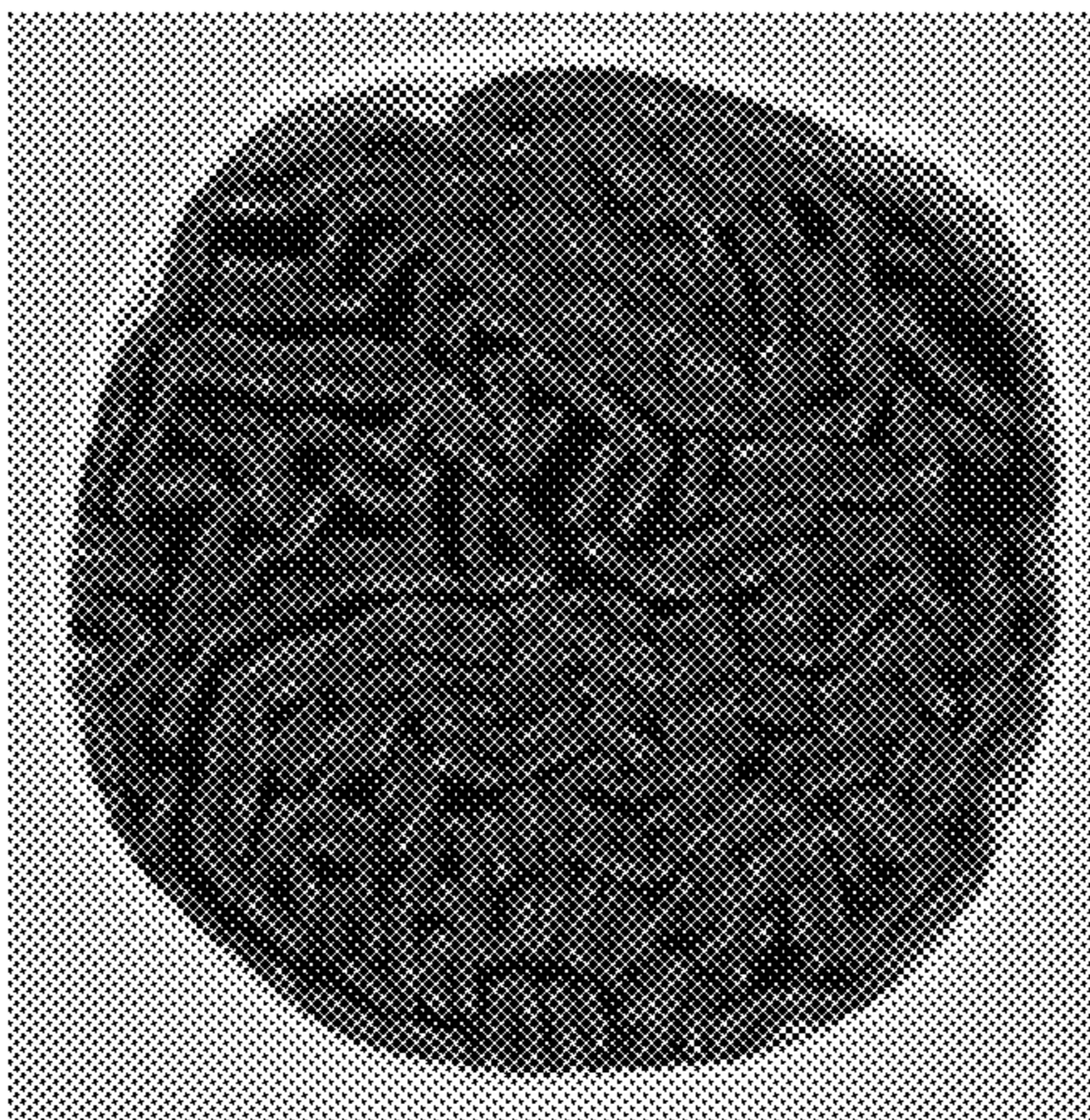

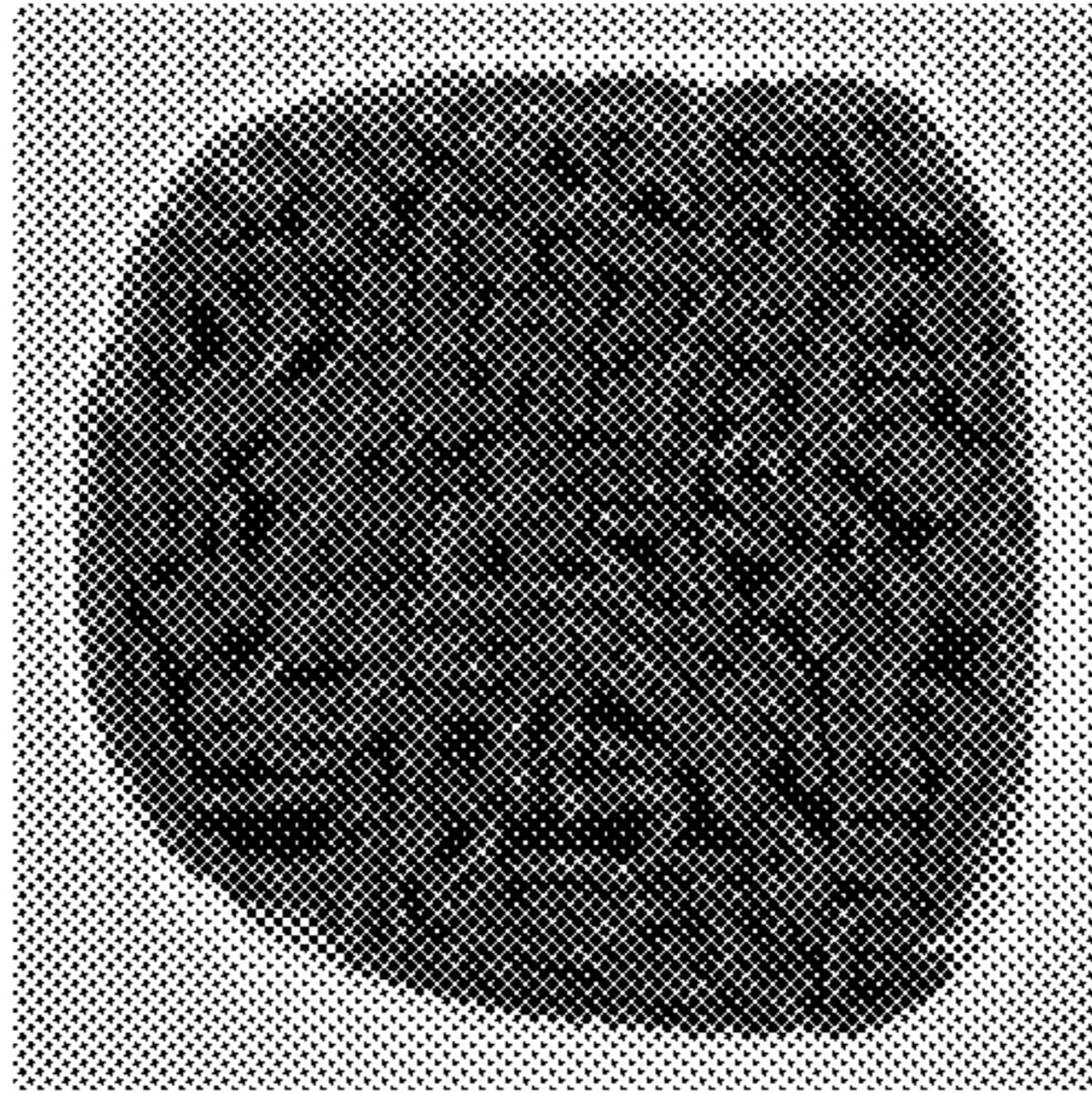

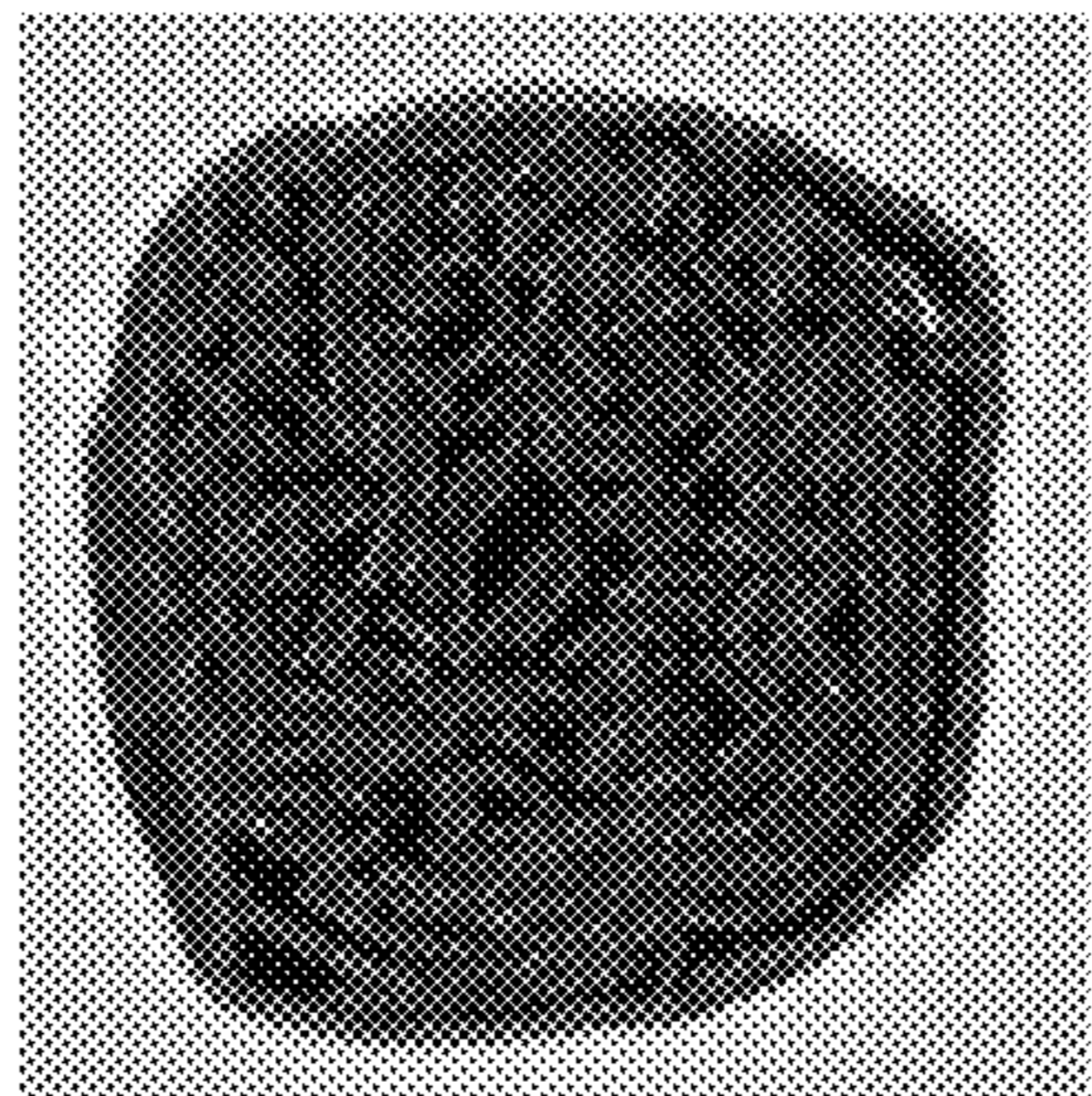
