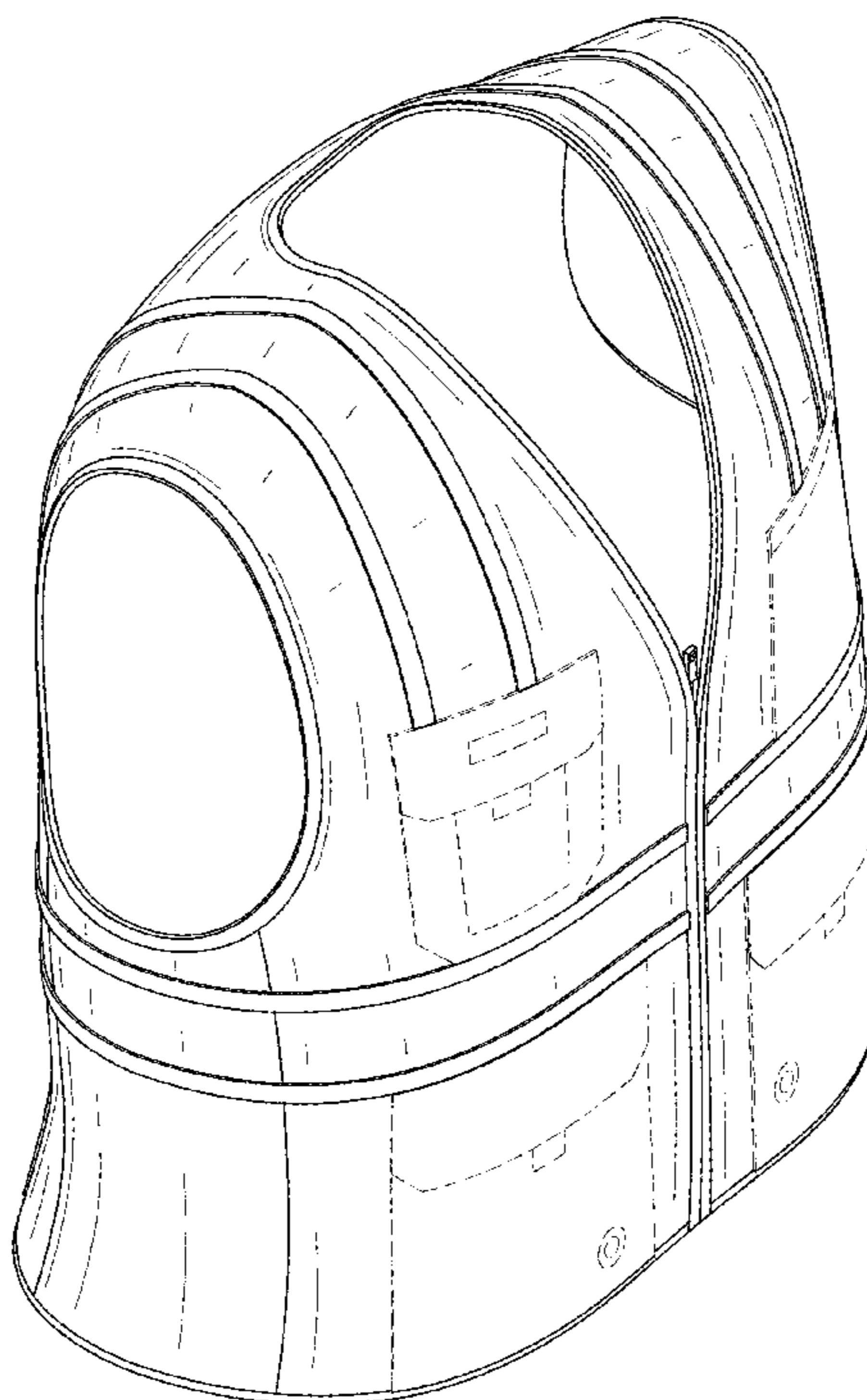

The ornamental design for a safety vest, as shown and described.

DESCRIPTION
FIG. 1 is a front perspective view of a safety vest incorporating our new design;
FIG. 2 is a bottom rear perspective view thereof;
FIG. 3 is a top plan view thereof;
FIG. 4 is a bottom plan view thereof;
FIG. 5 is a left side view thereof;
FIG. 6 is a front view thereof; and,
FIG. 7 is a rear view thereof.

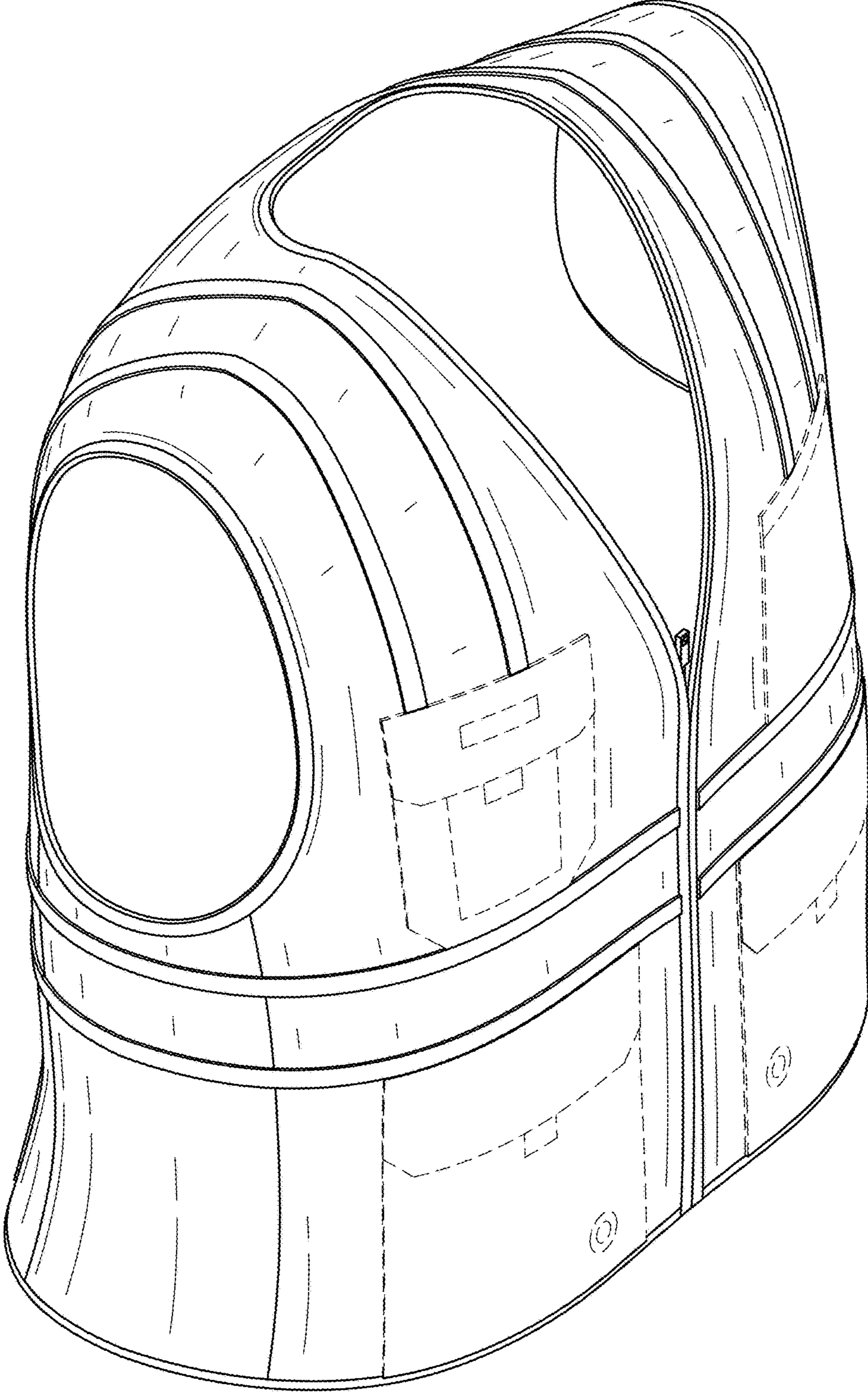

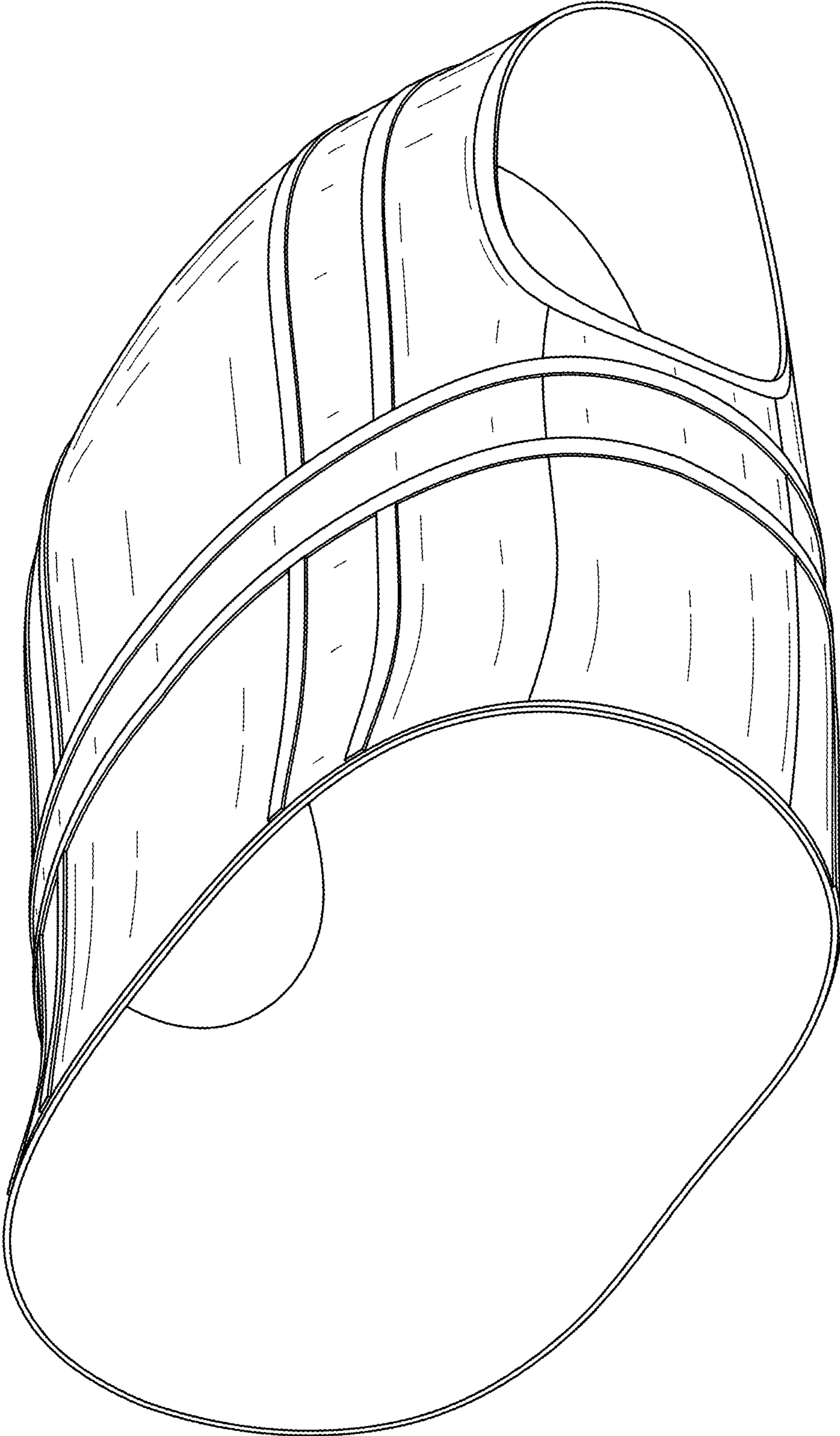

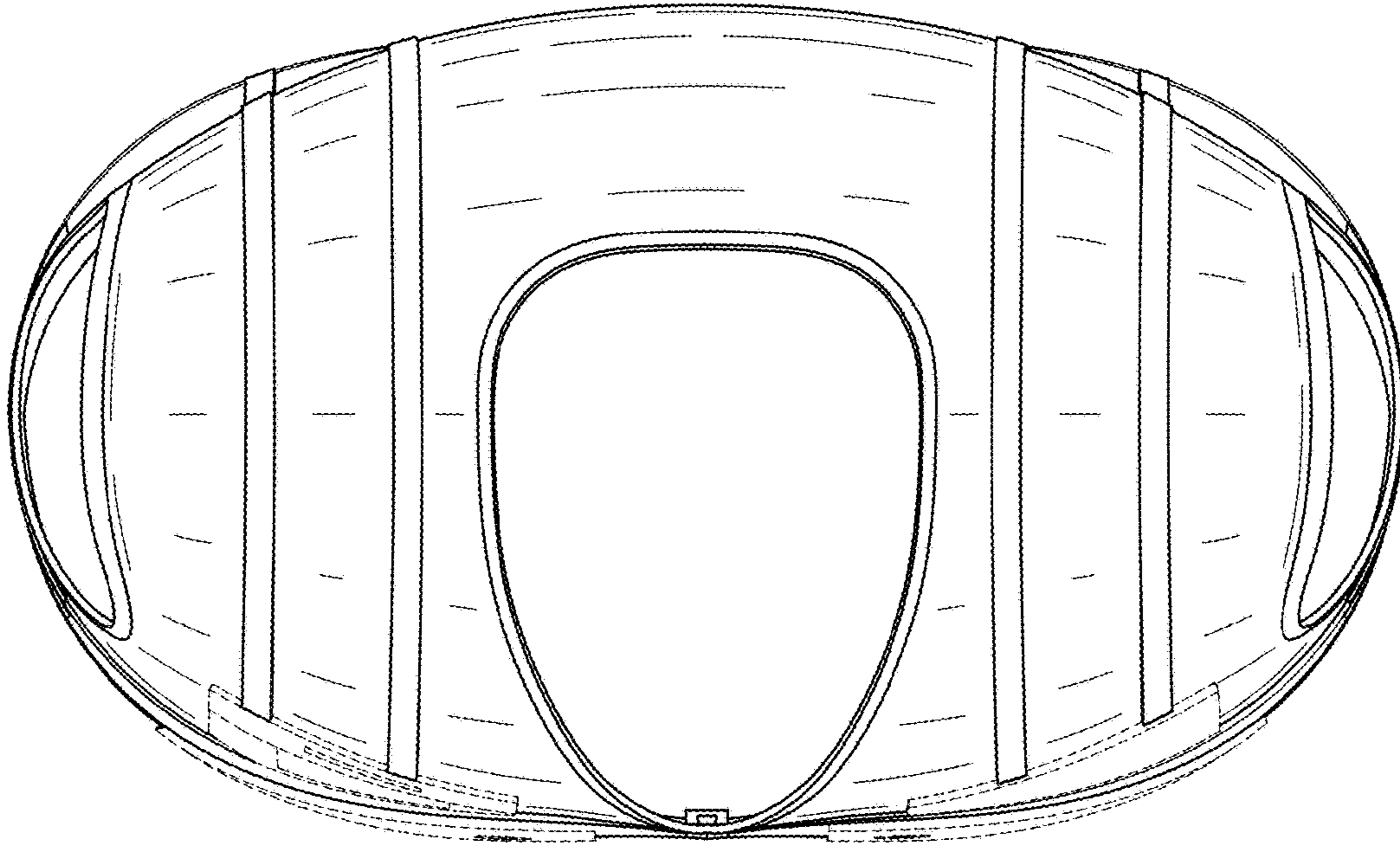

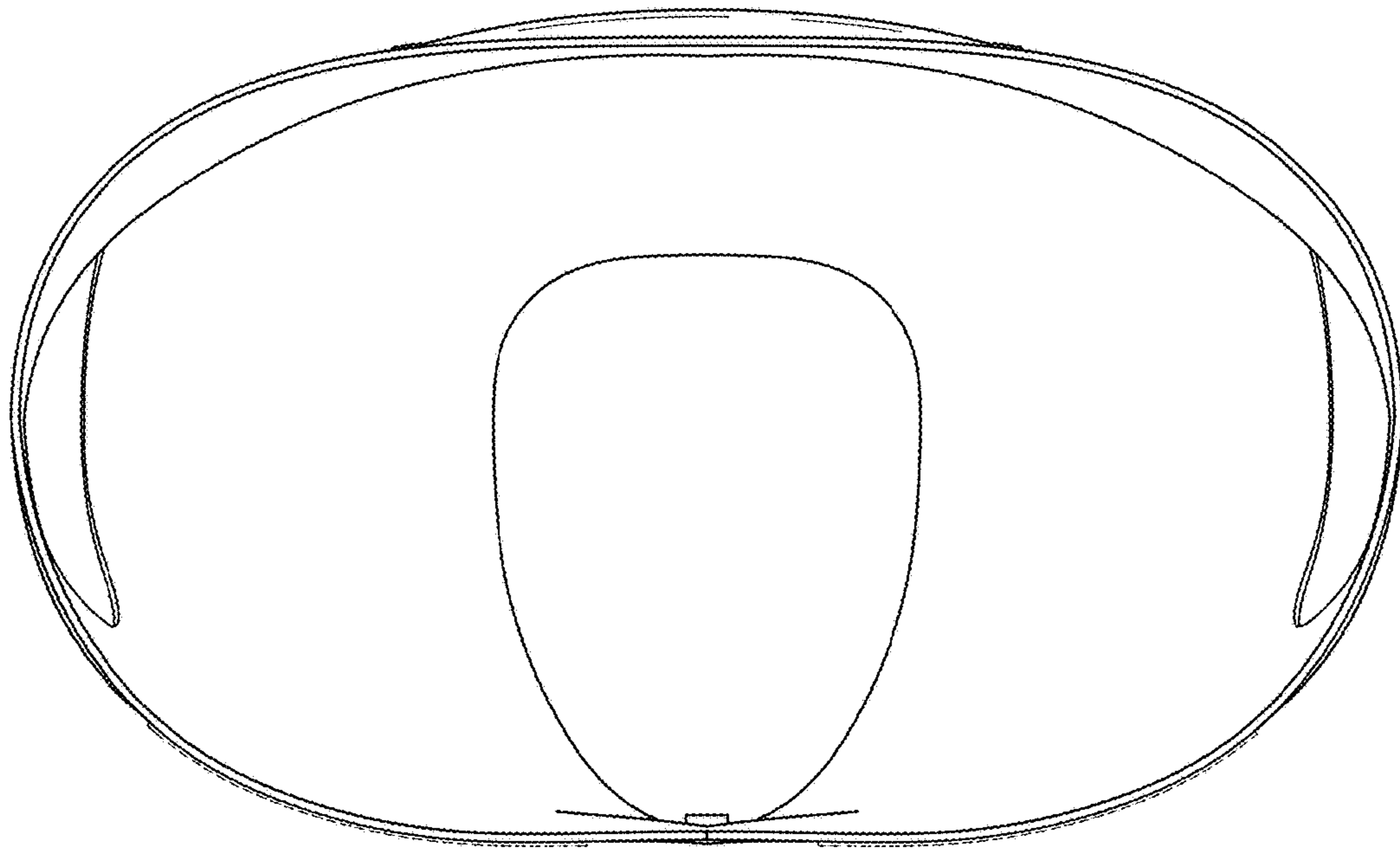

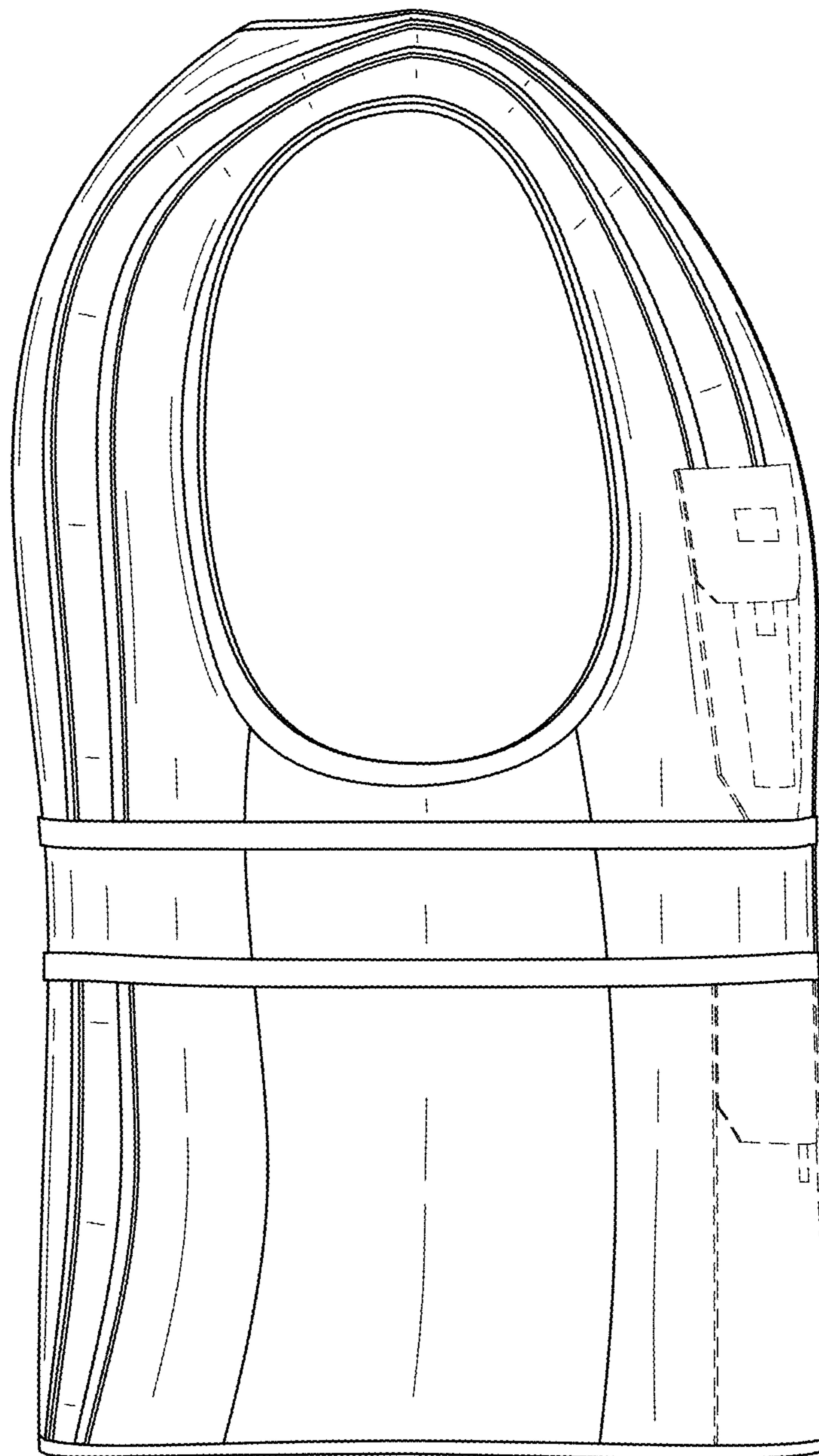

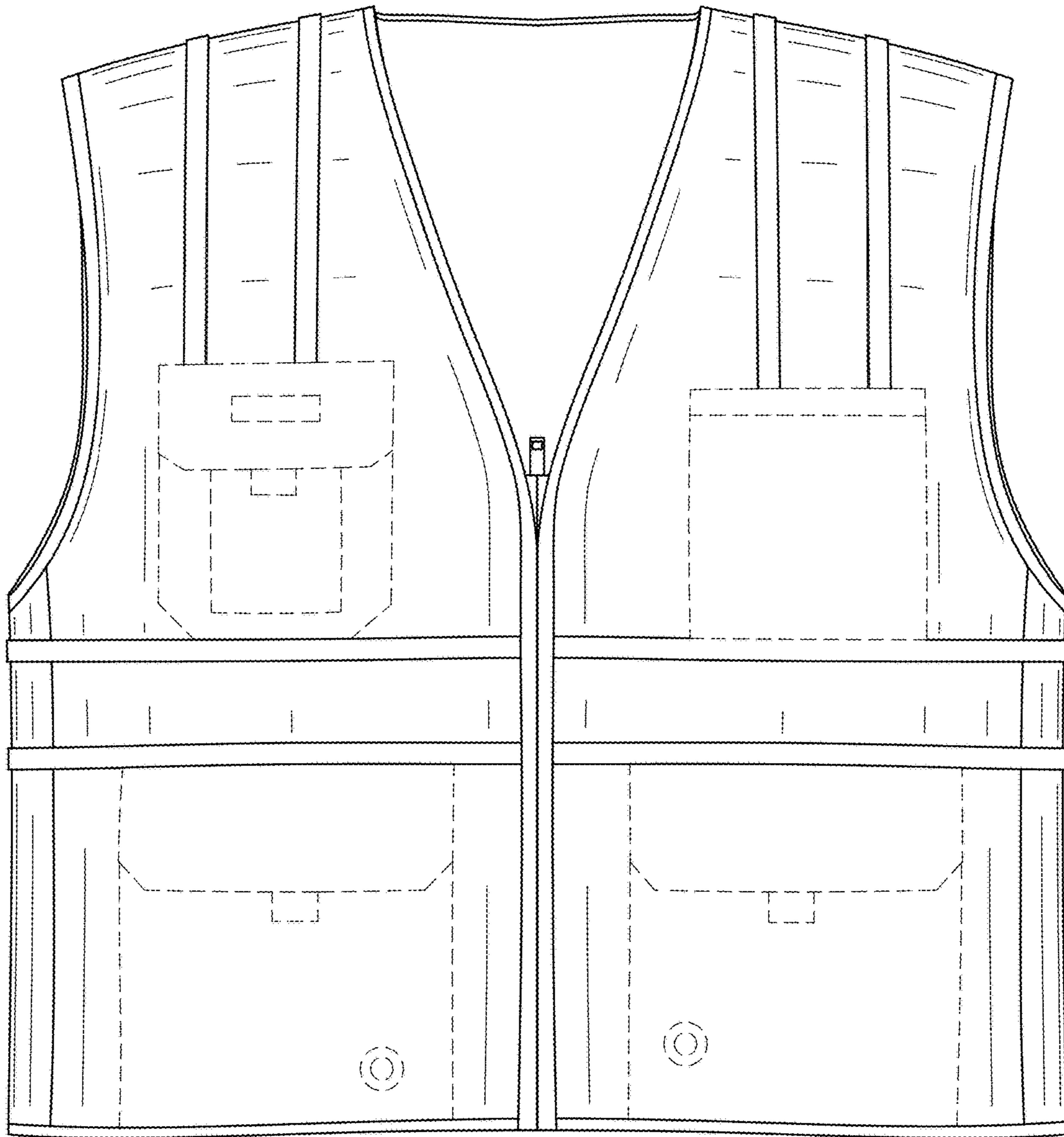

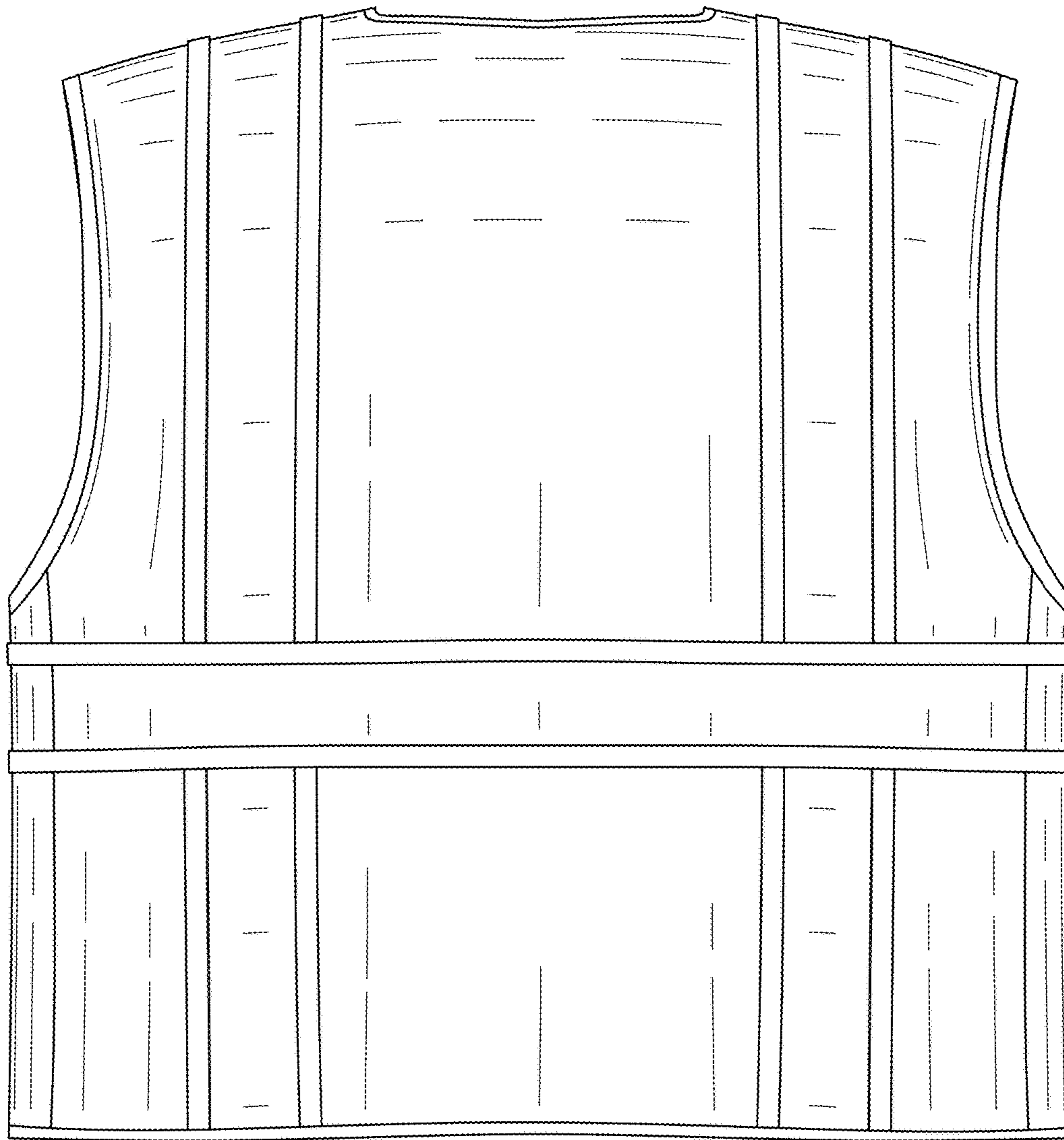
