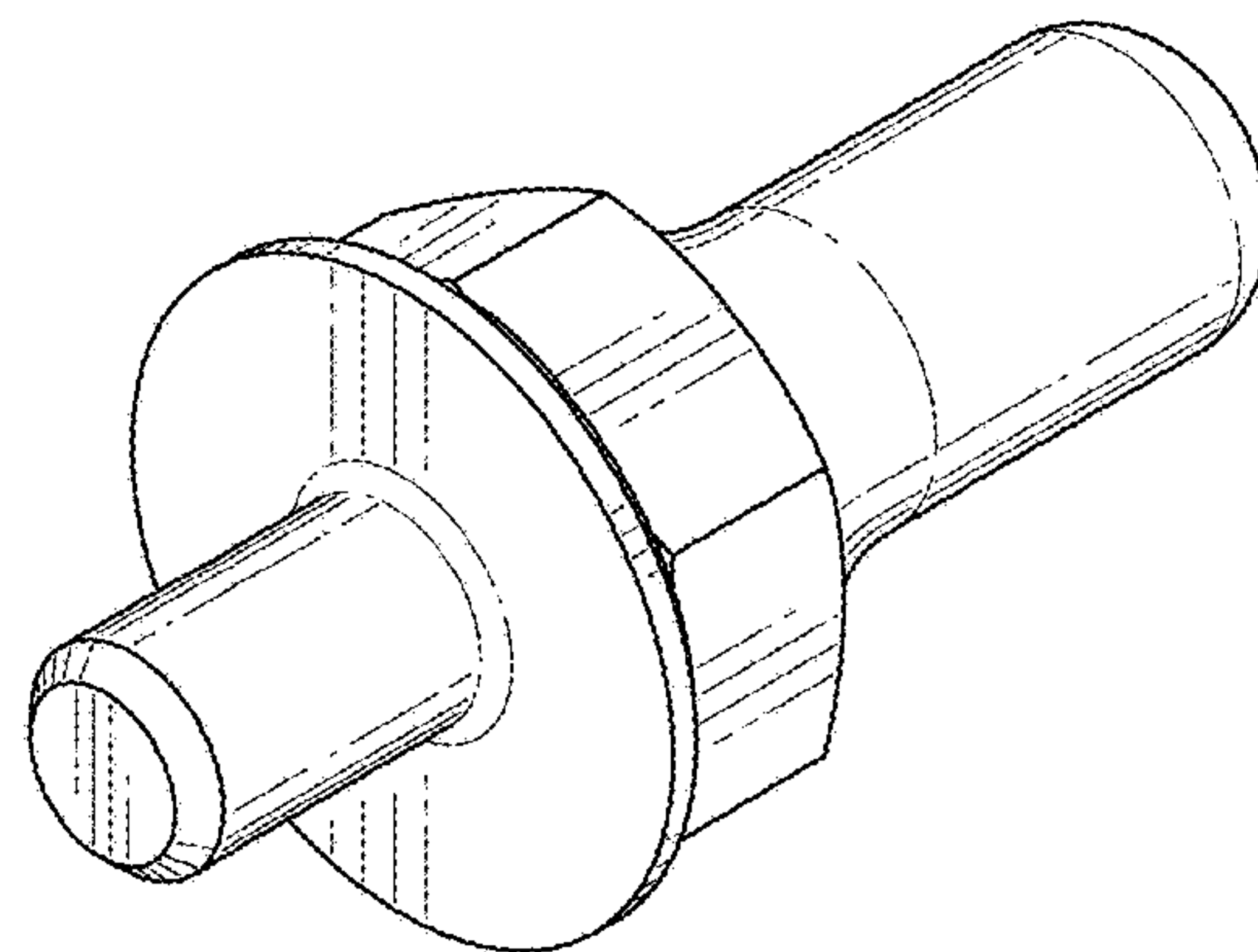
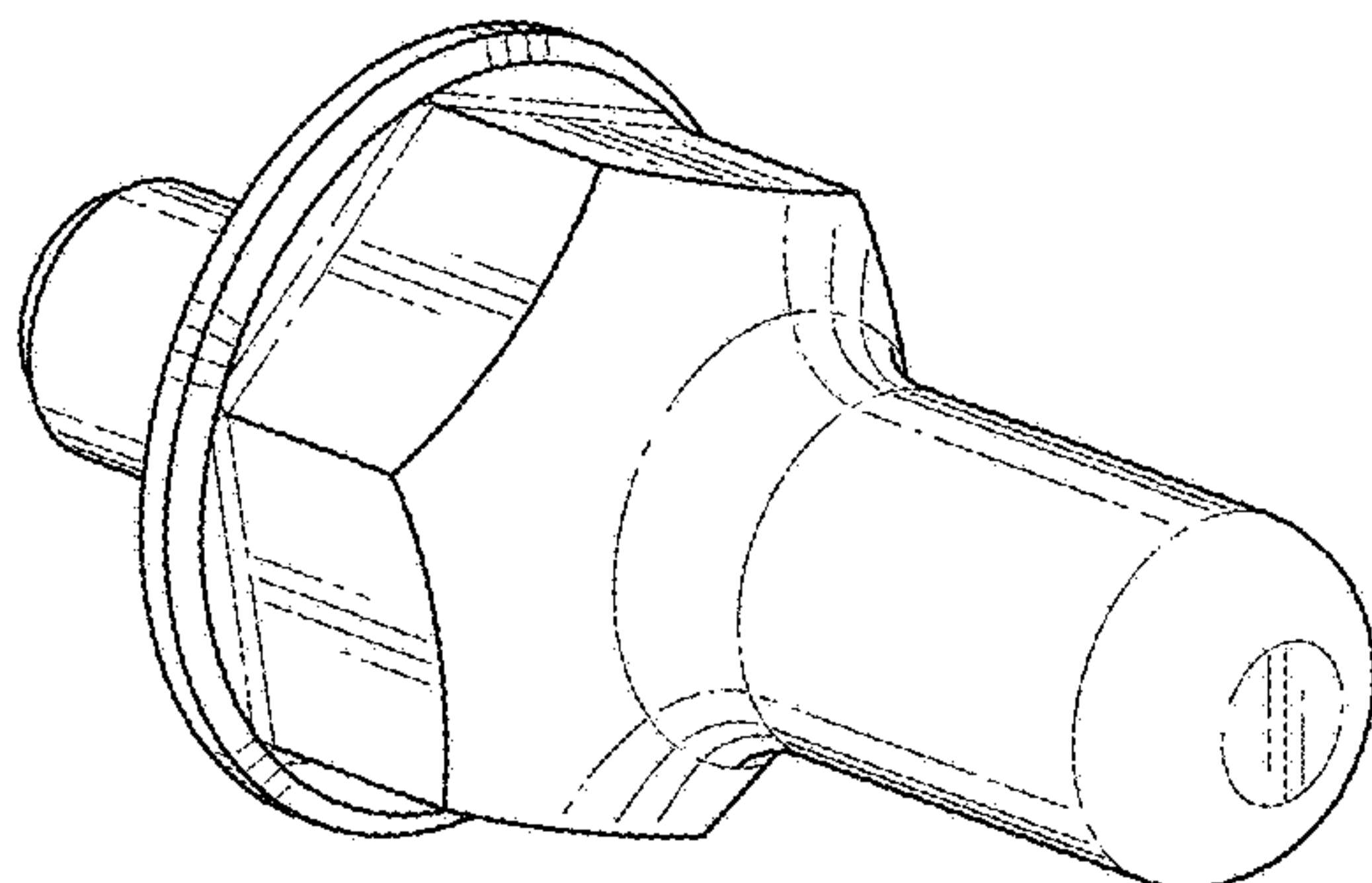
(57) **CLAIM**

The ornamental design for a recreational shoe spike, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a recreational shoe spike showing our new design;
FIG. 2 is a rear perspective view thereof;
FIG. 3 is a bottom view thereof;
FIG. 4 is a side view thereof;
FIG. 5 is an opposite side view thereof;
FIG. 6 is a front view thereof;
FIG. 7 is a rear view thereof;
FIG. 8 is a top view thereof; and,
FIG. 9 is a perspective view thereof, shown in a used condition with a shoe shown in broken lines.
The broken lines of a cross shoe in FIG. 9 form no part of the claimed design.

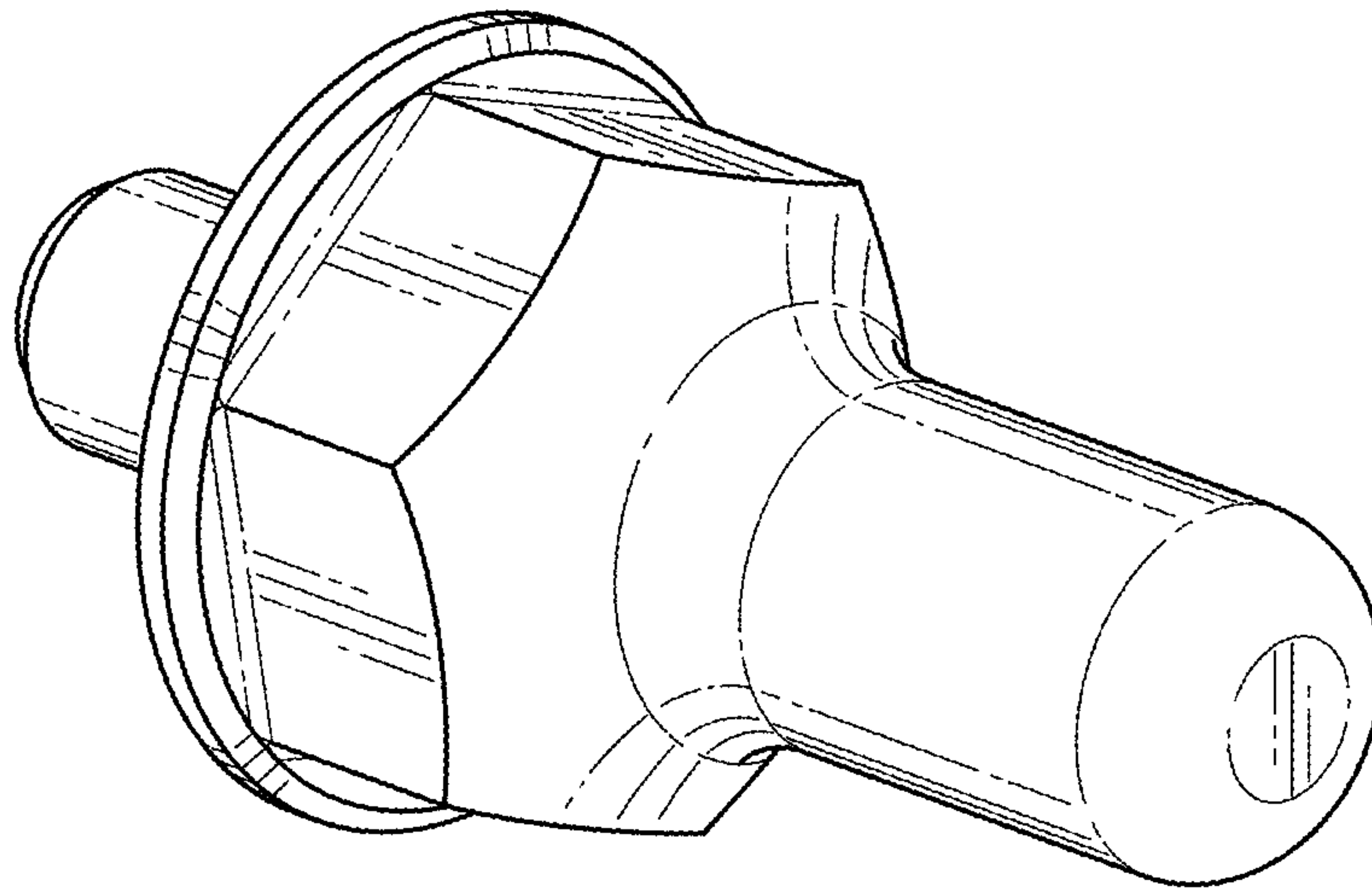

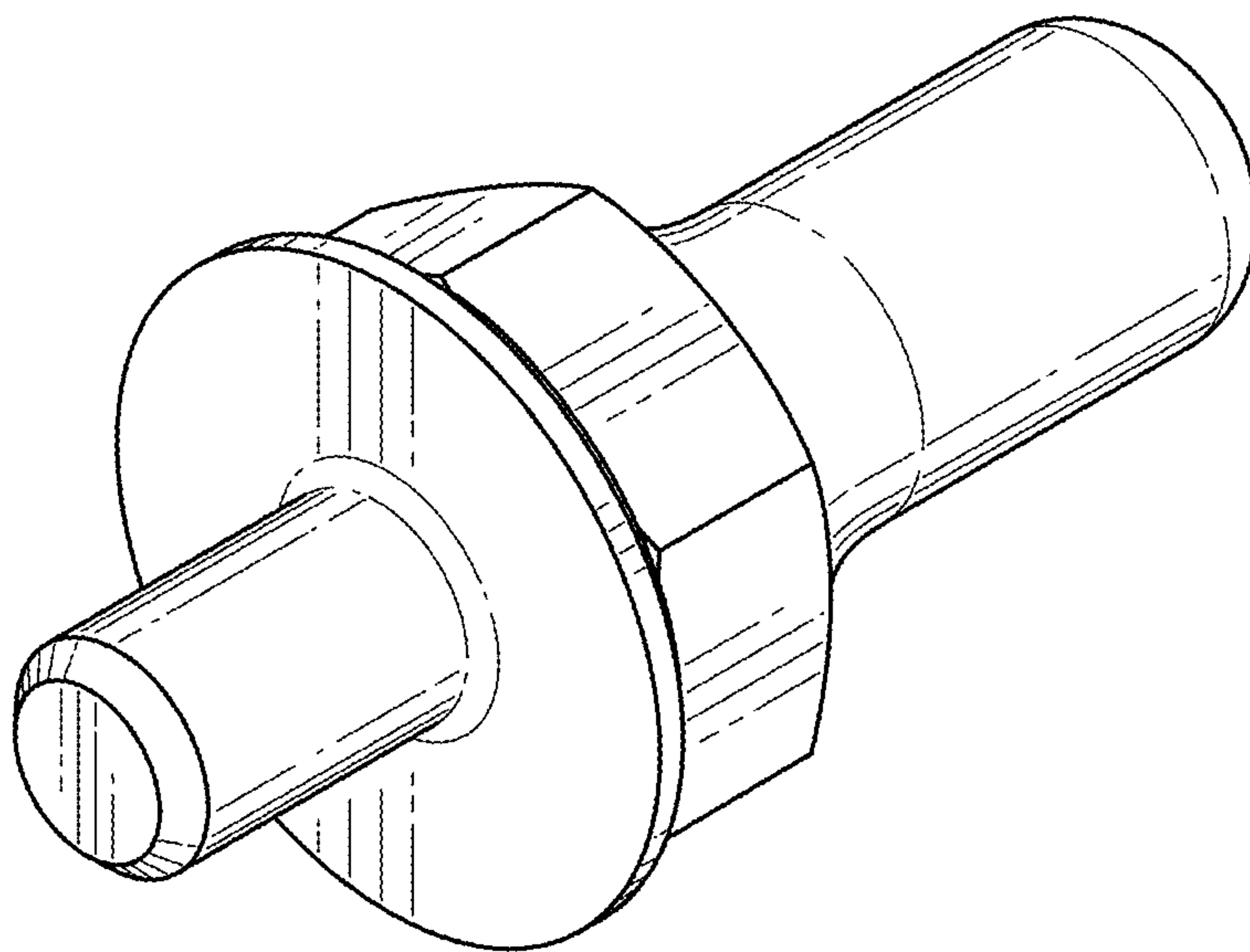

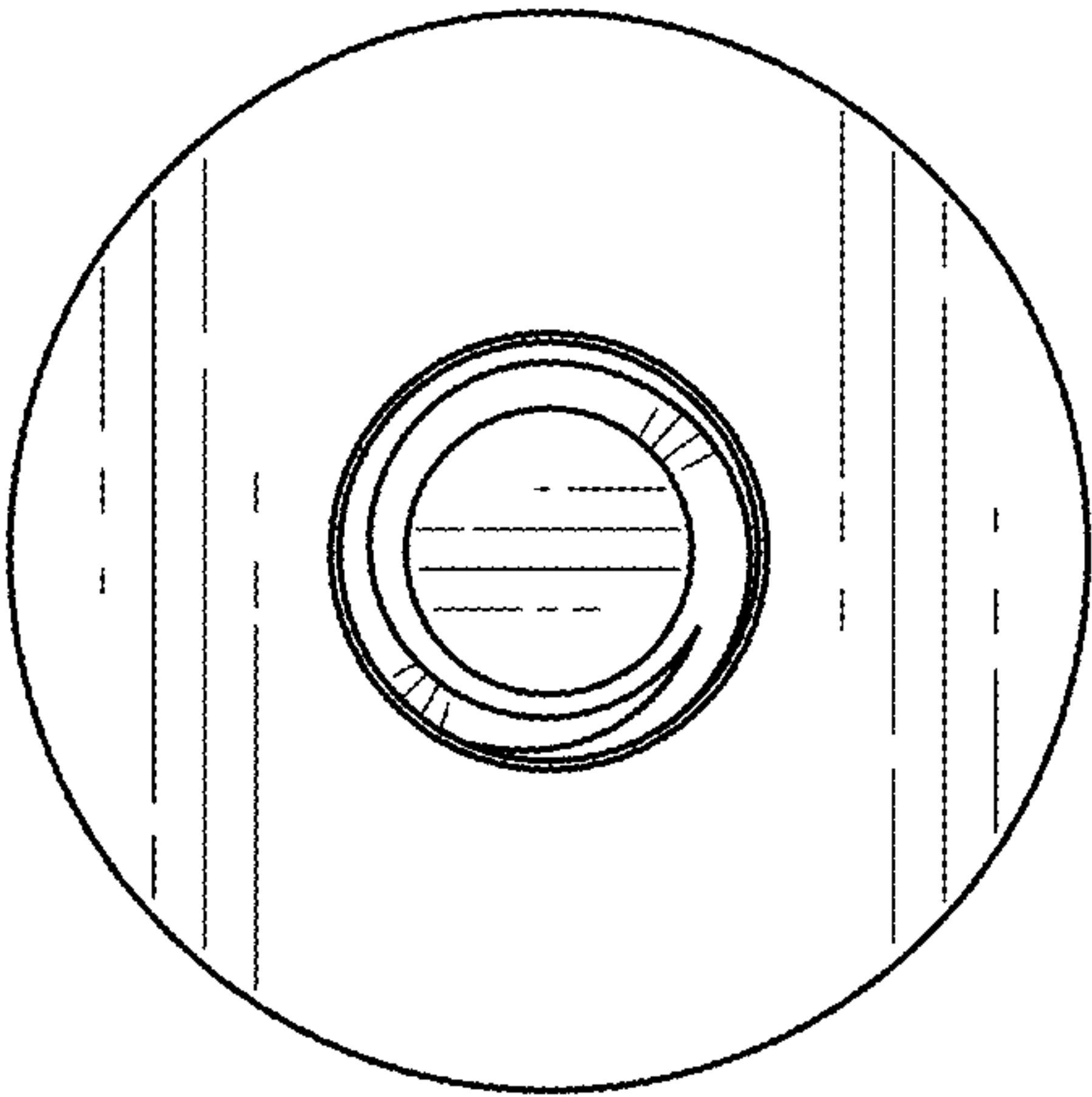

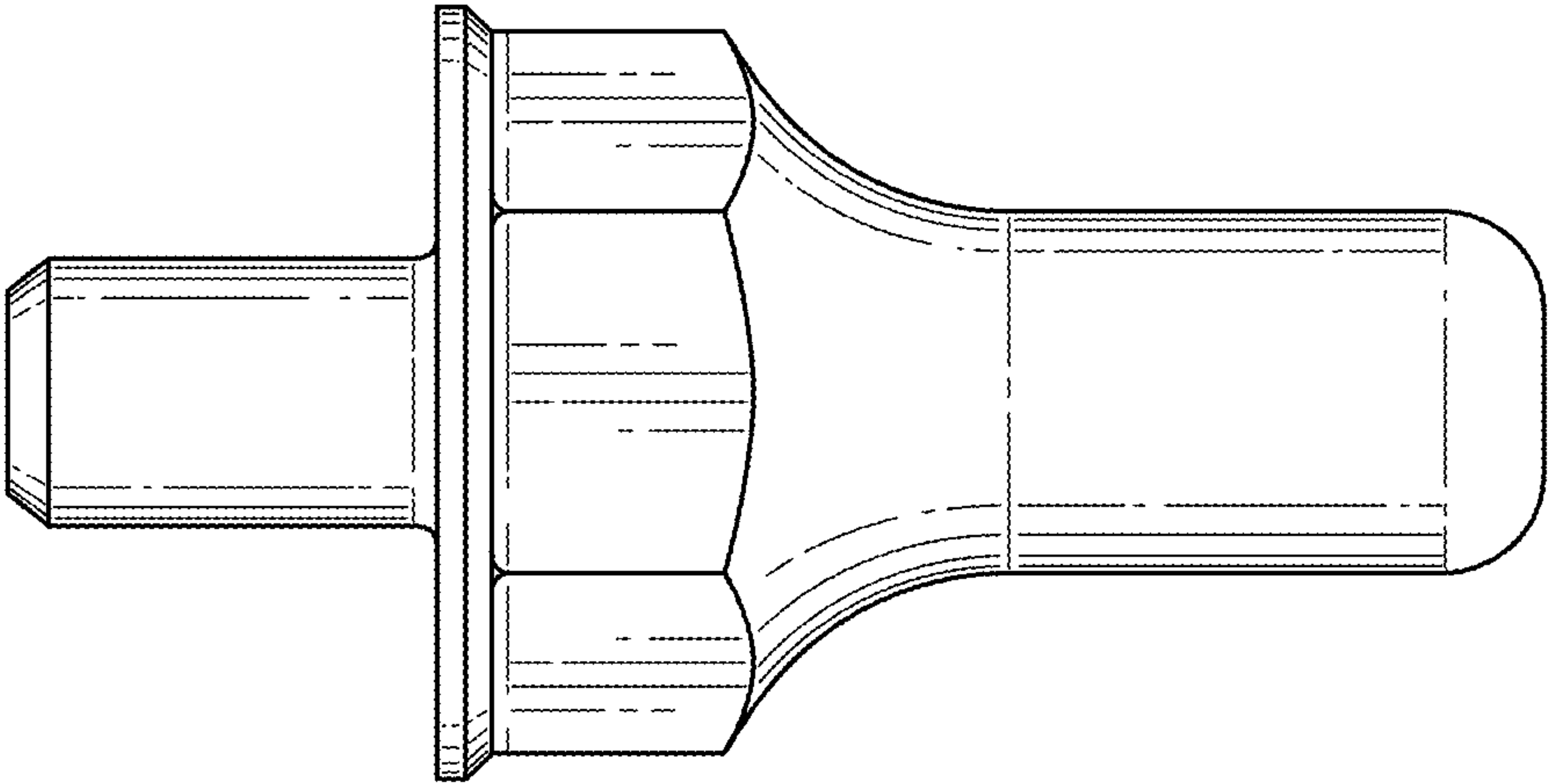

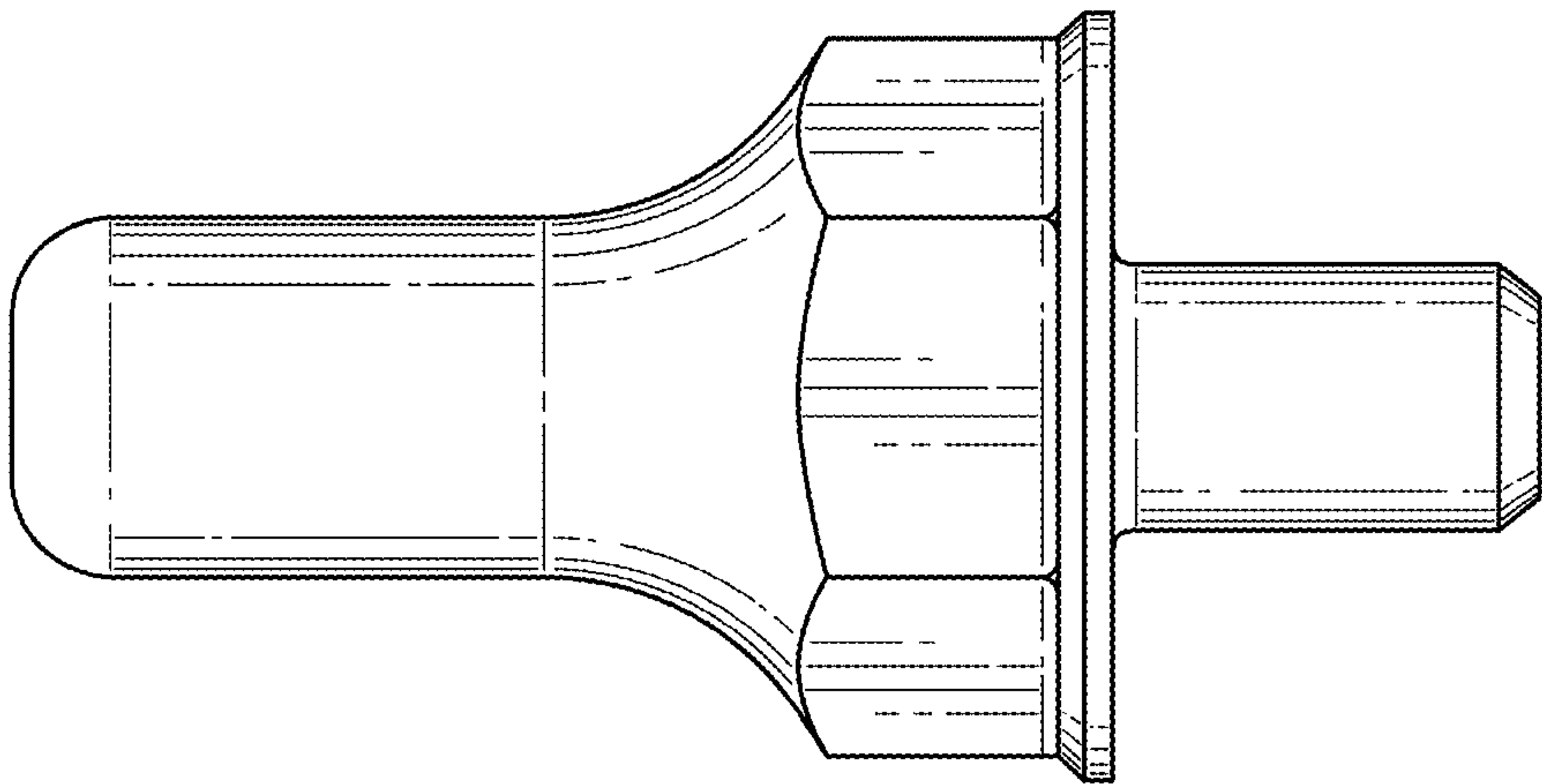

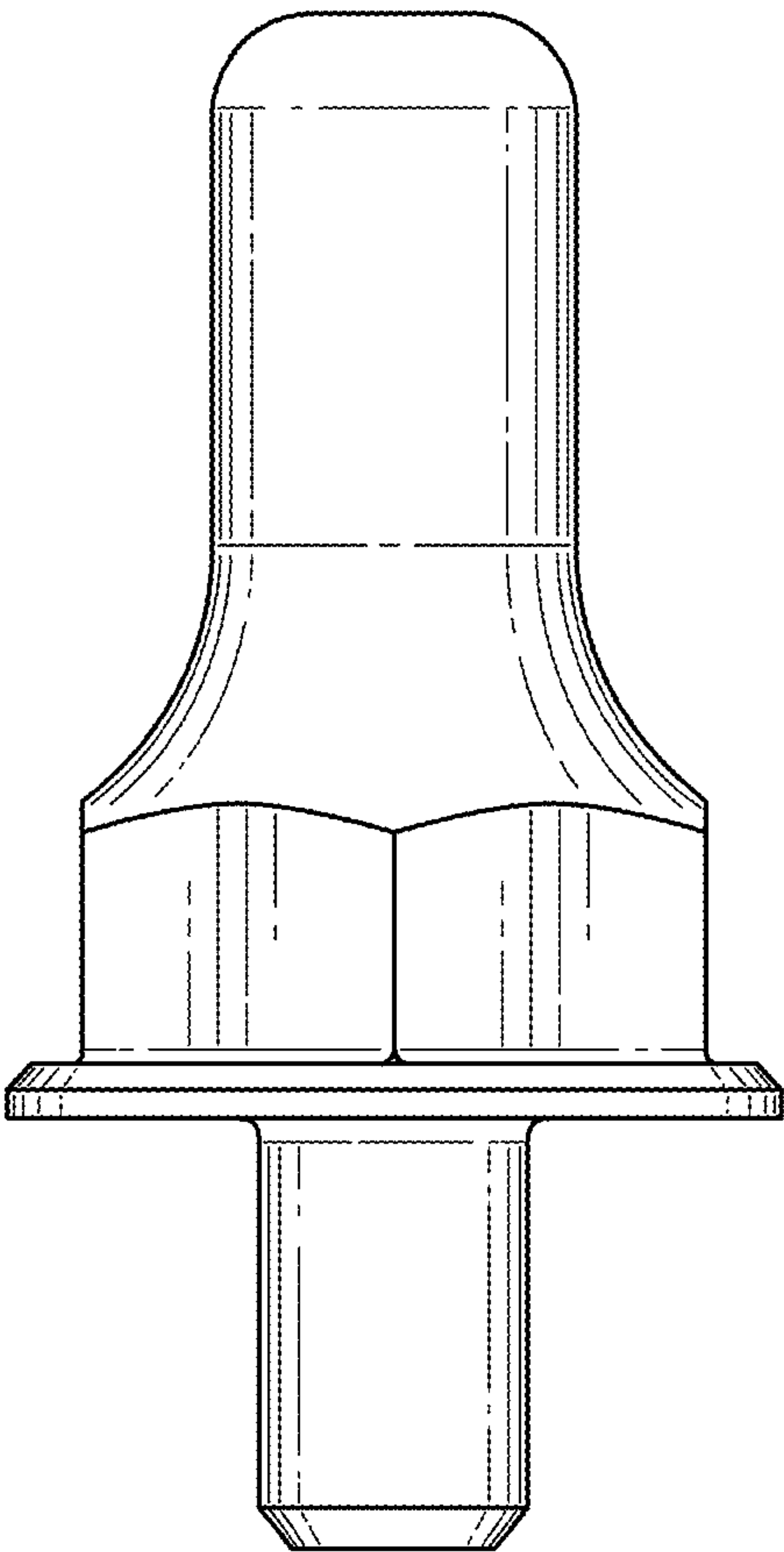

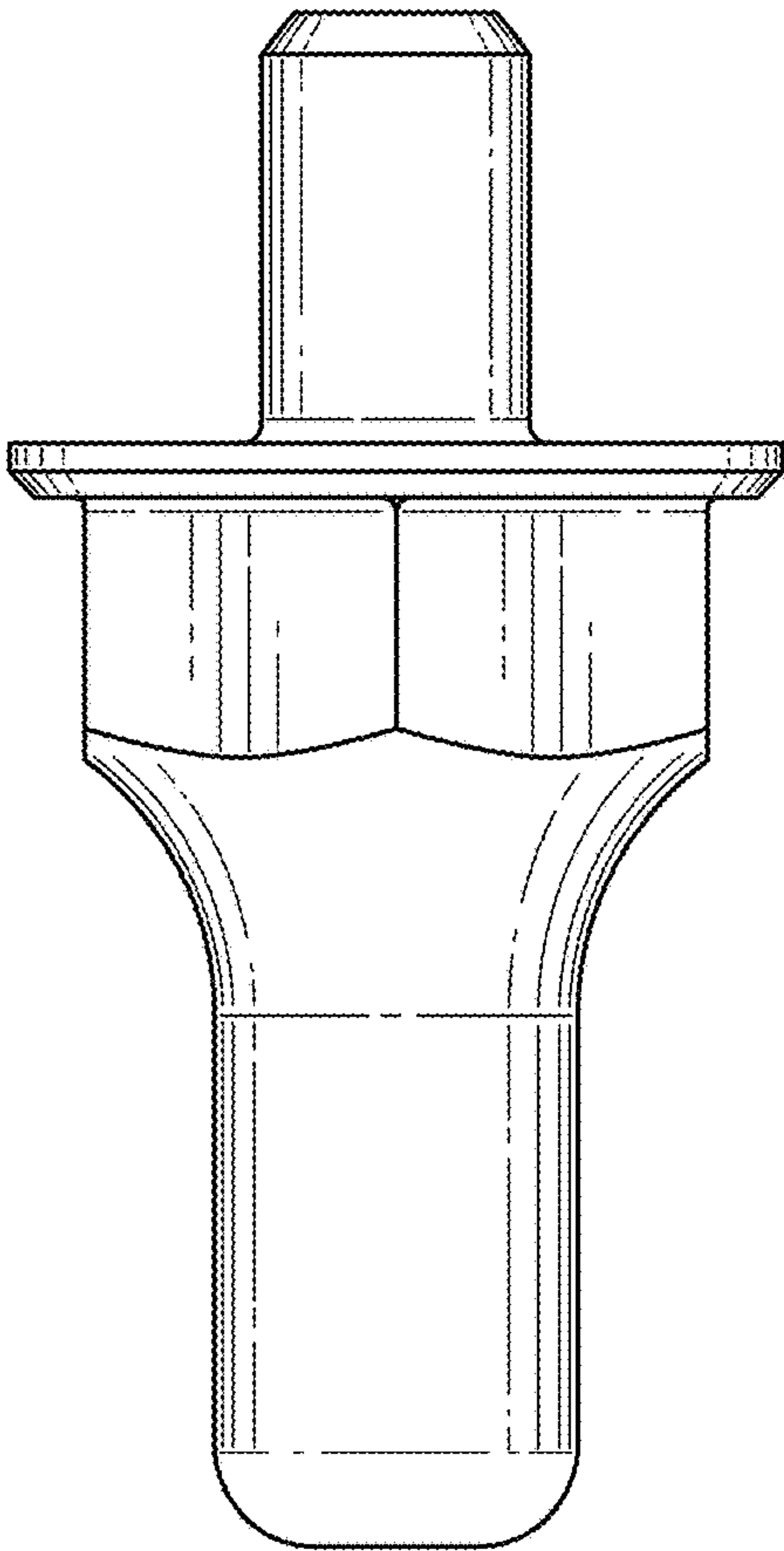

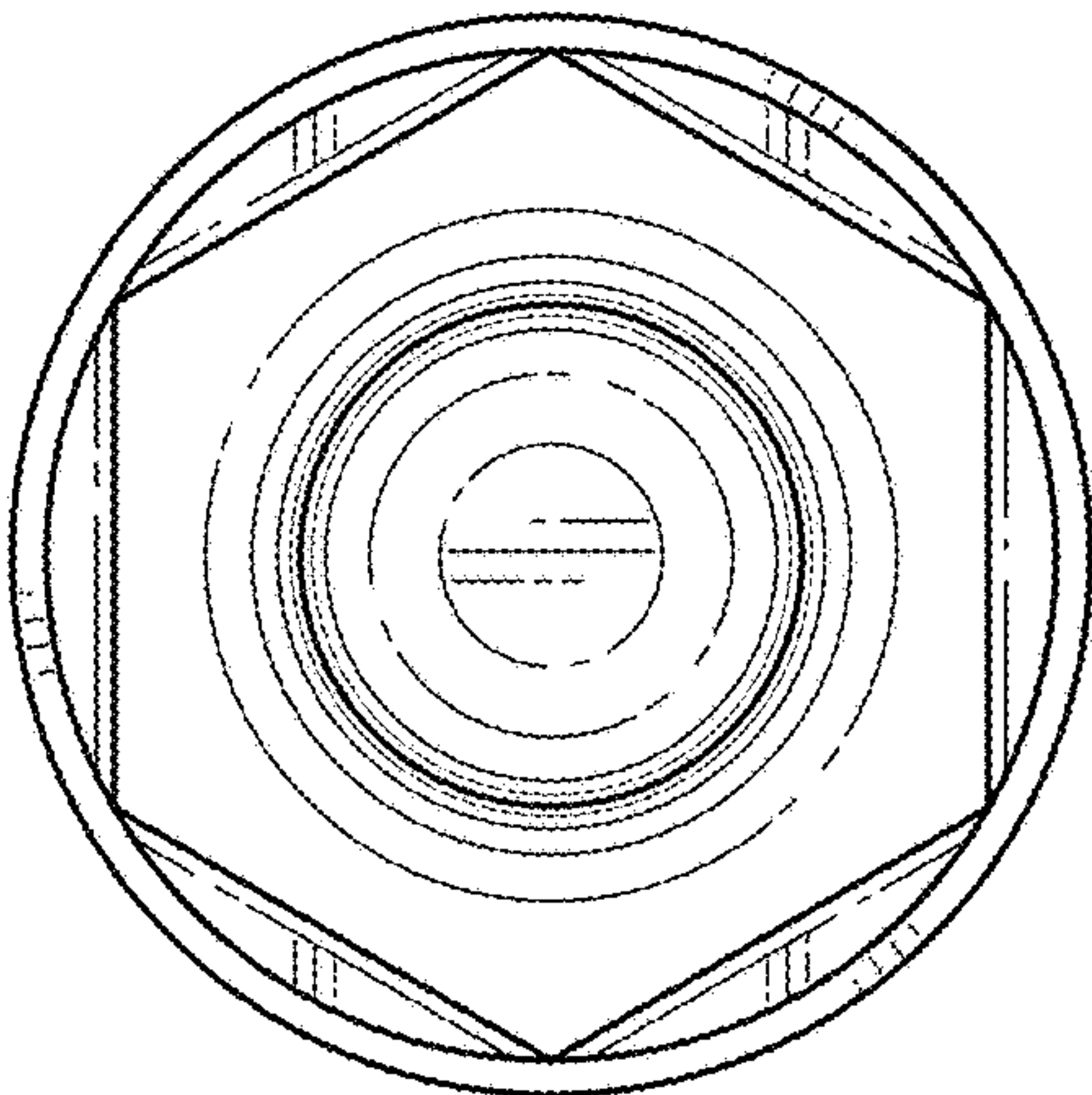

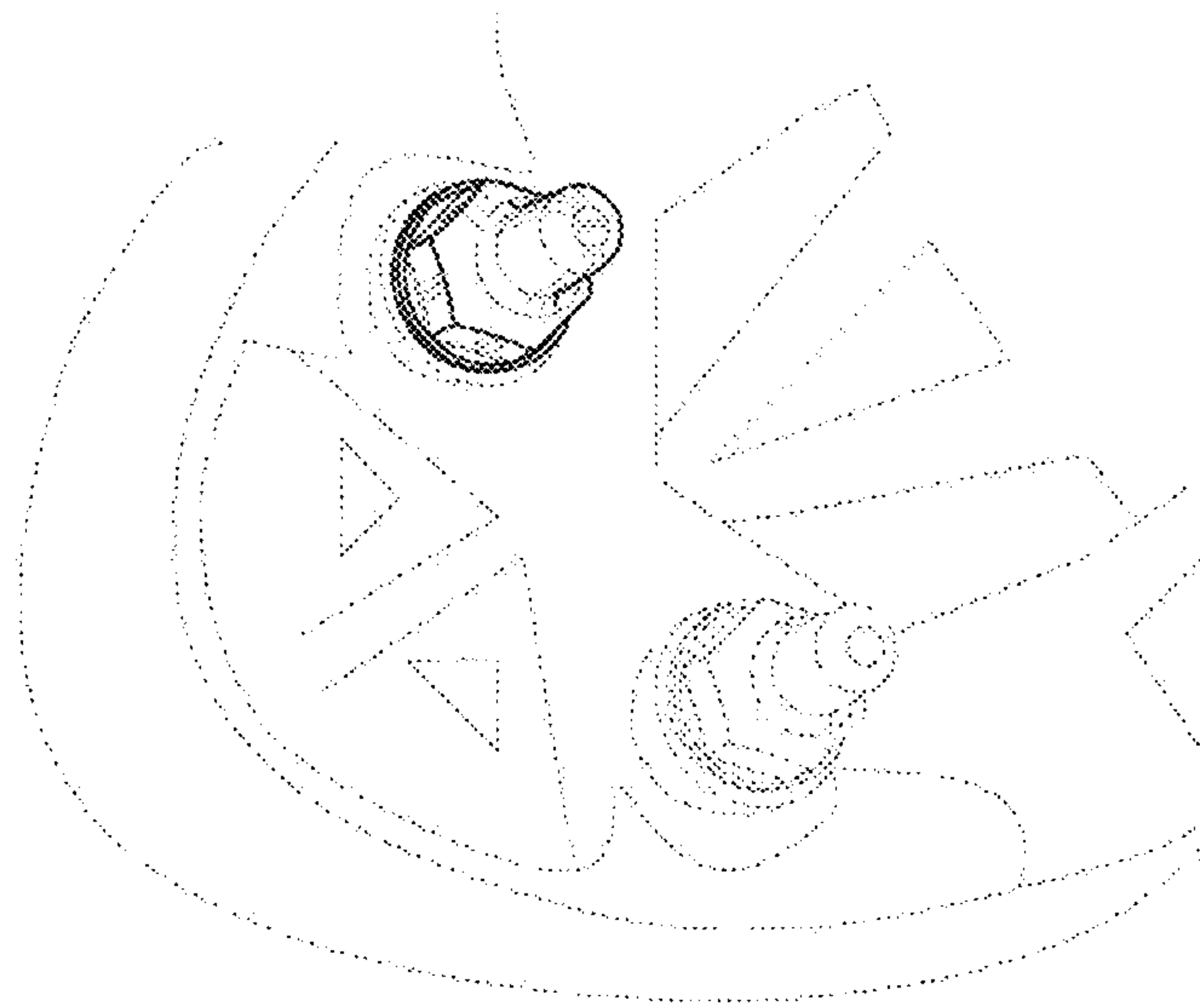
