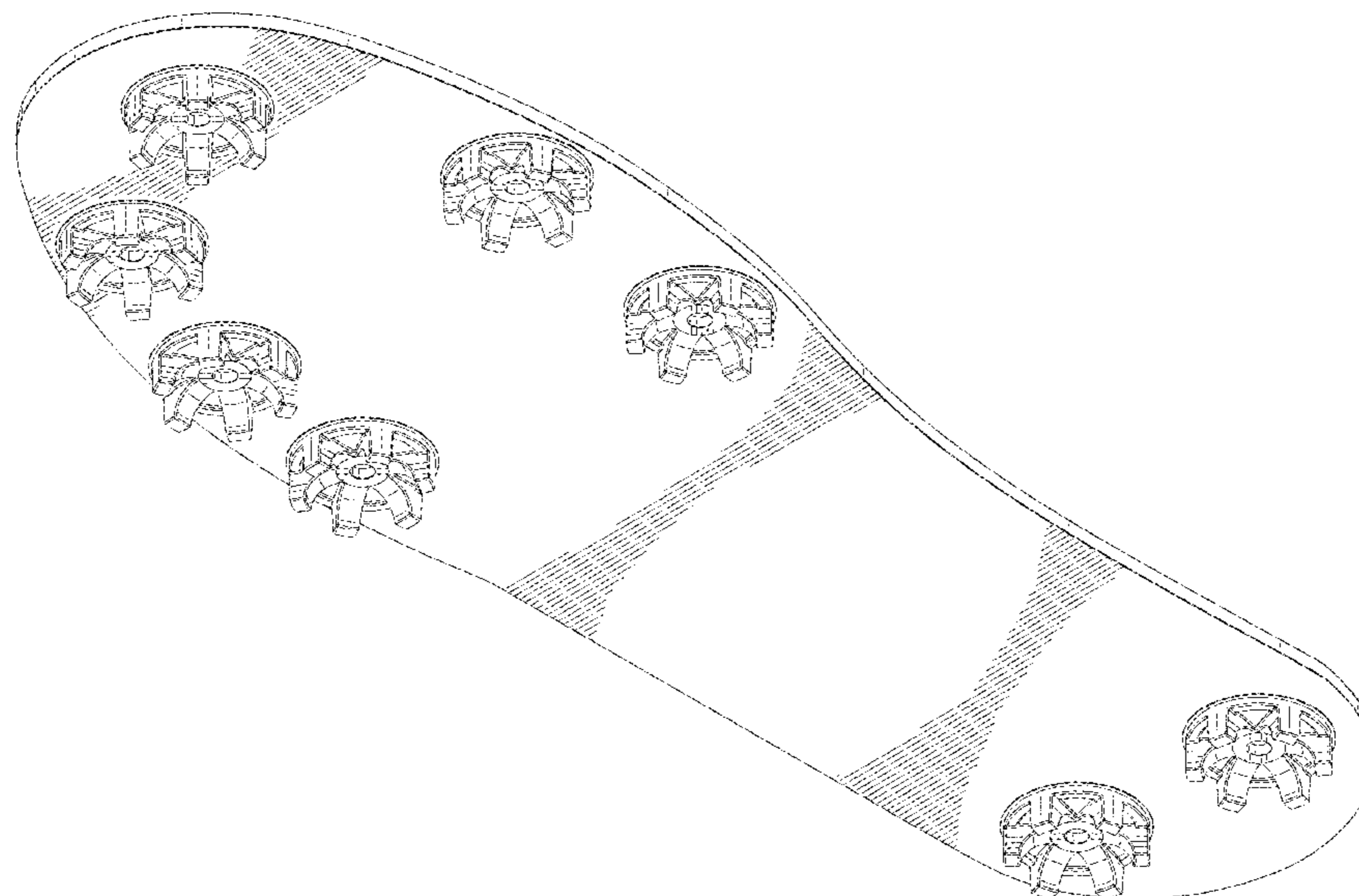
(57) **CLAIM**

The ornamental design for a removable stick on golf cleats for footwear, as shown and described.

**DESCRIPTION**

FIG. 1 is an isometric view of a removable stick on golf cleats for footwear showing my new design; FIG. 2 is a front elevation view thereof; FIG. 3 is a rear elevation view thereof; FIG. 4 is a right side elevation view thereof; FIG. 5 is a left side elevation view thereof; FIG. 6 is a top view thereof; and, FIG. 7 is a bottom view thereof.

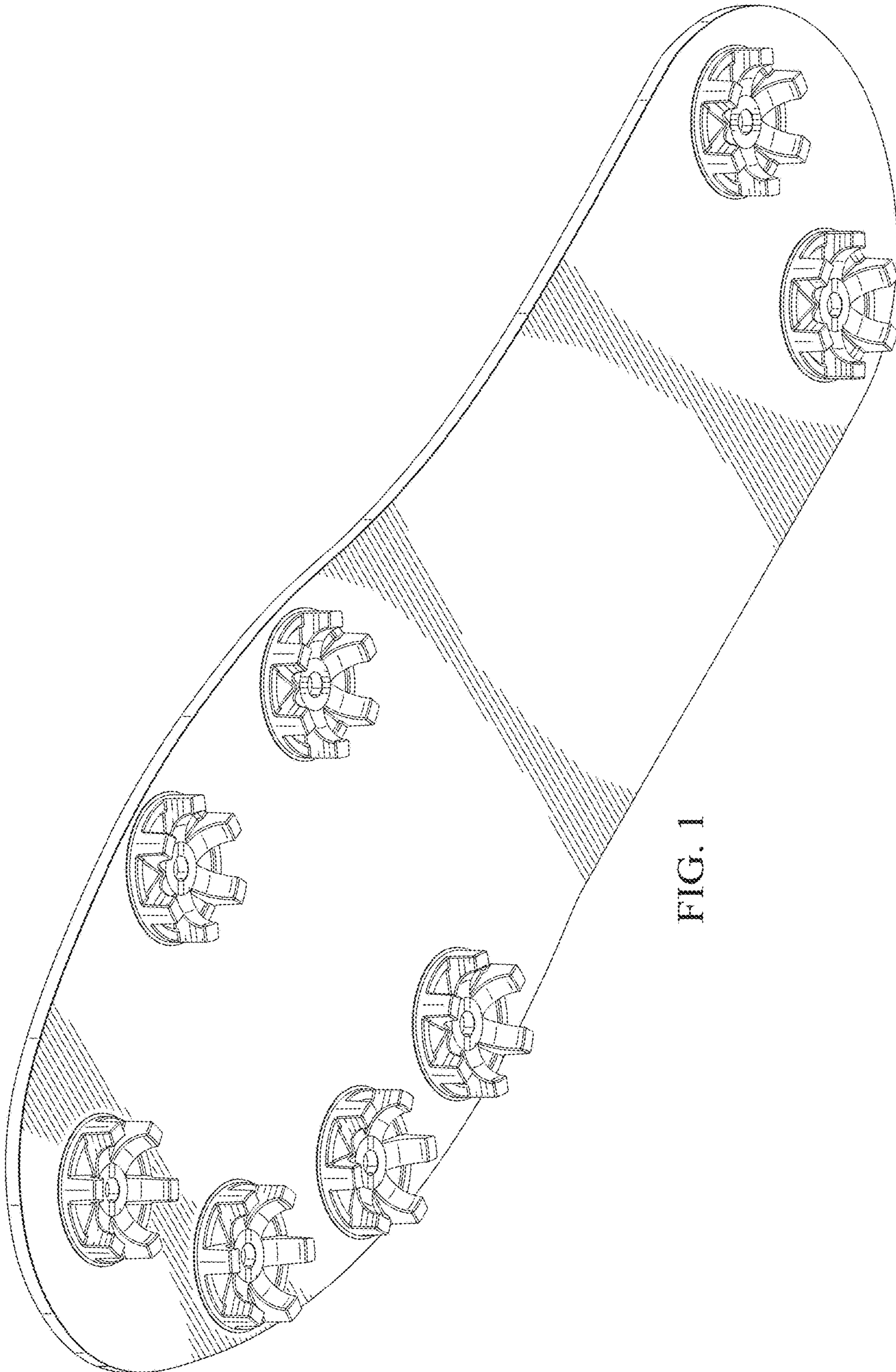

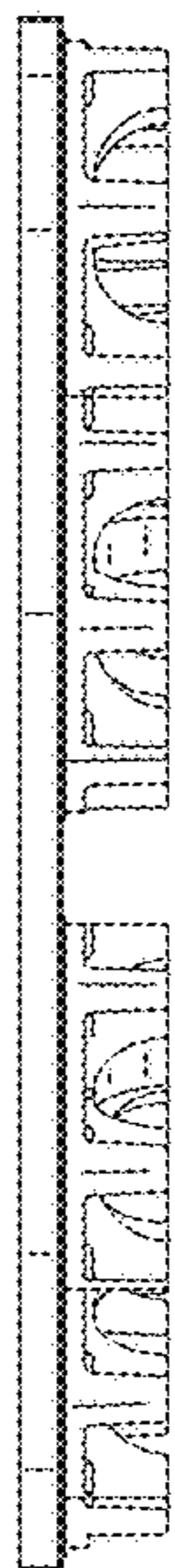

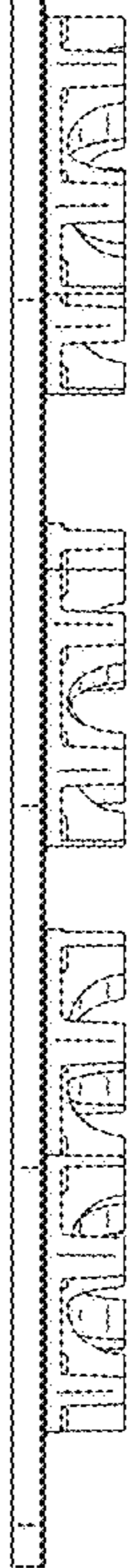

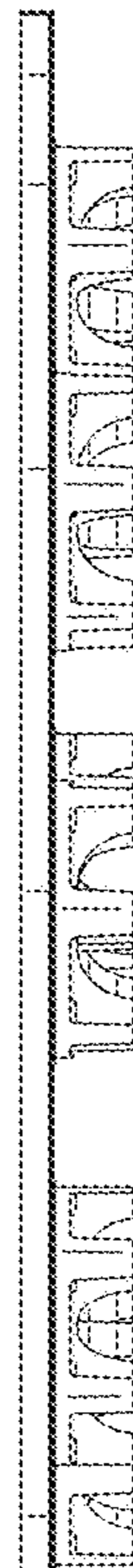
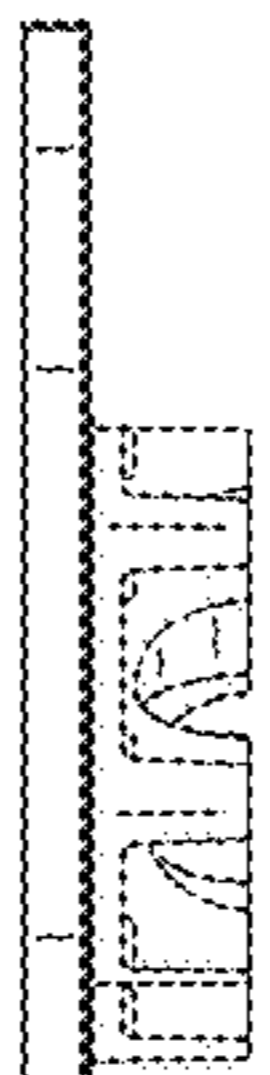

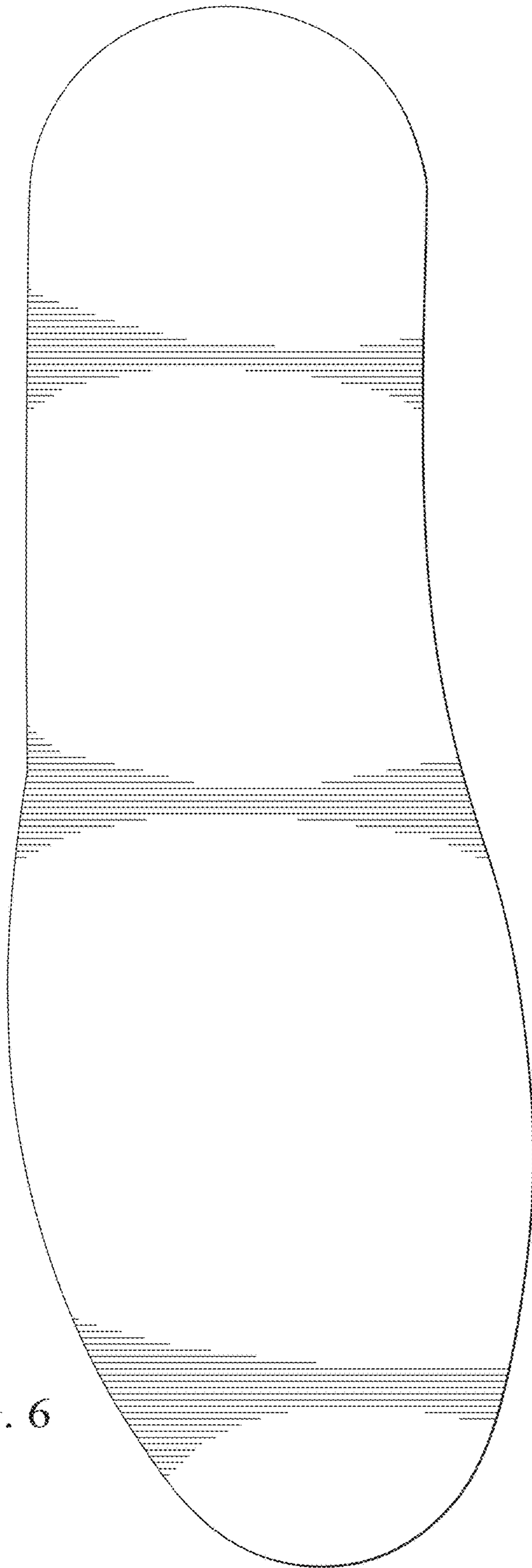

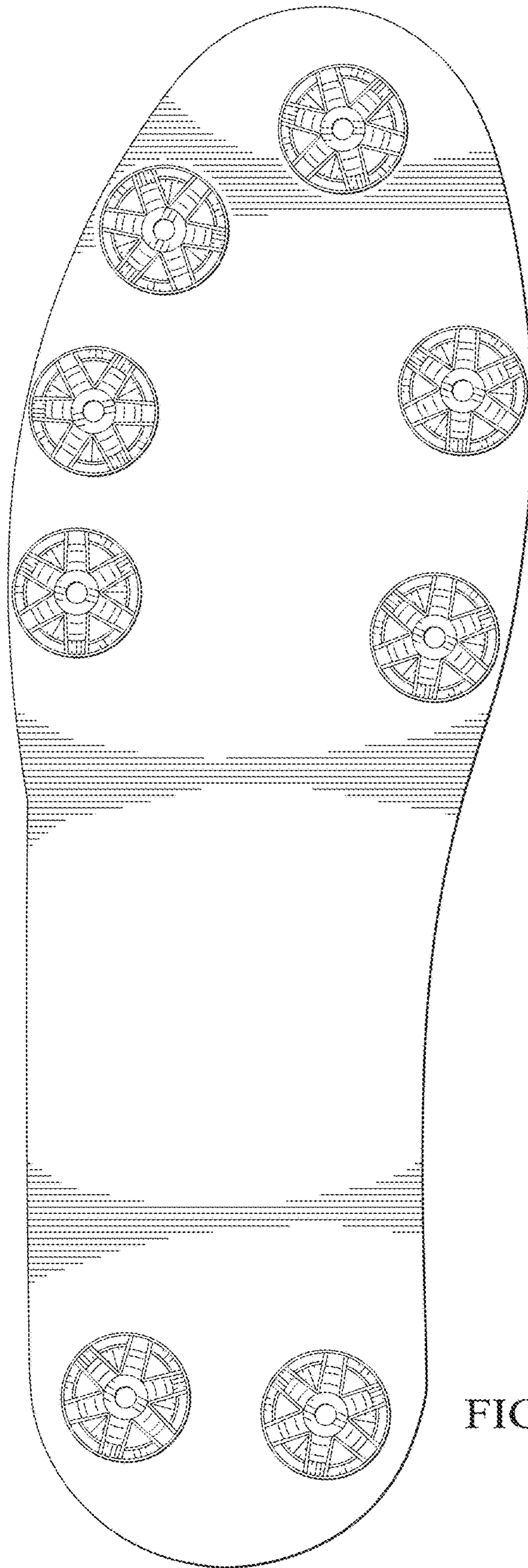
