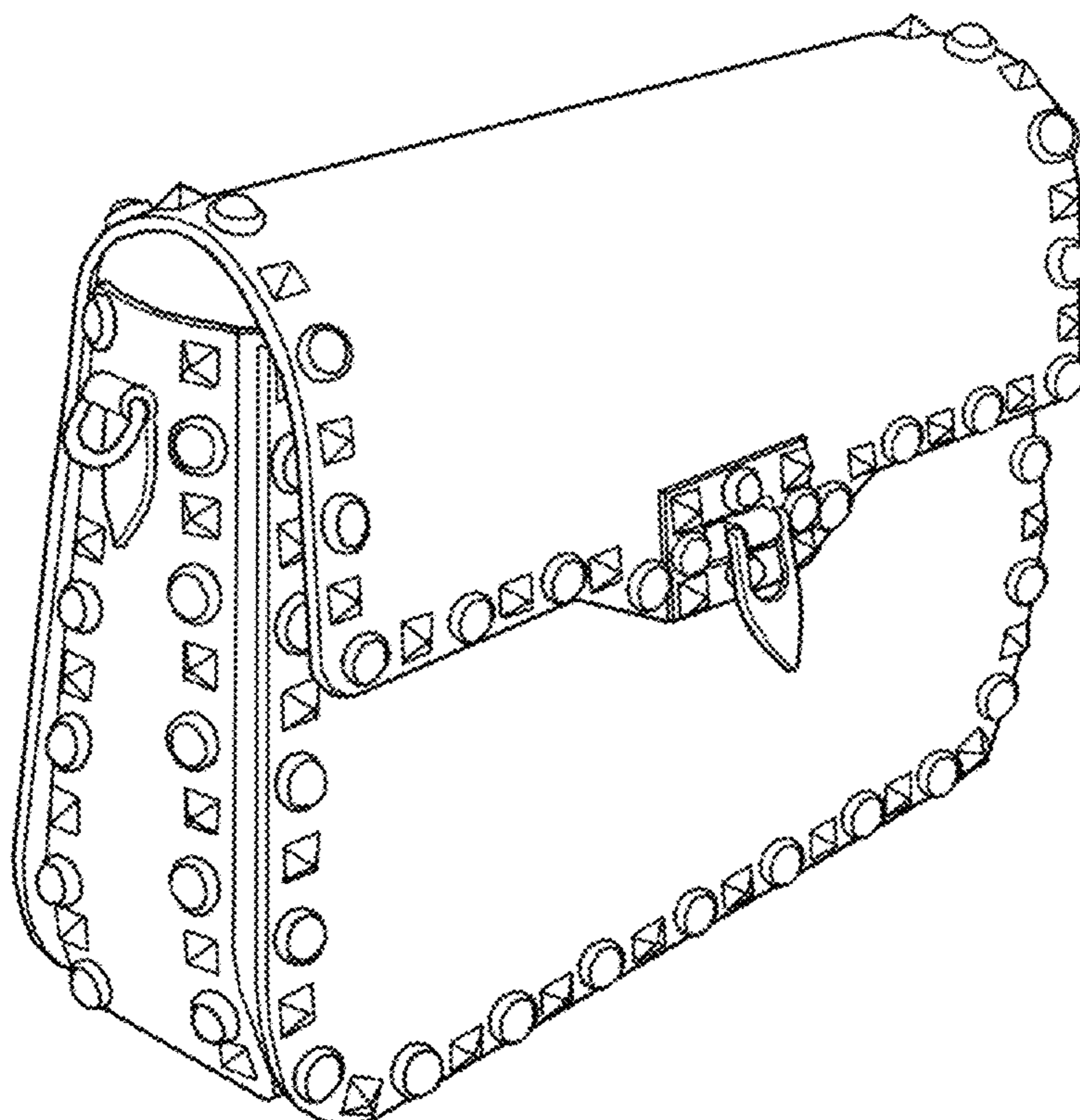
(57) **CLAIM**

The ornamental design for a bag, as shown and described.

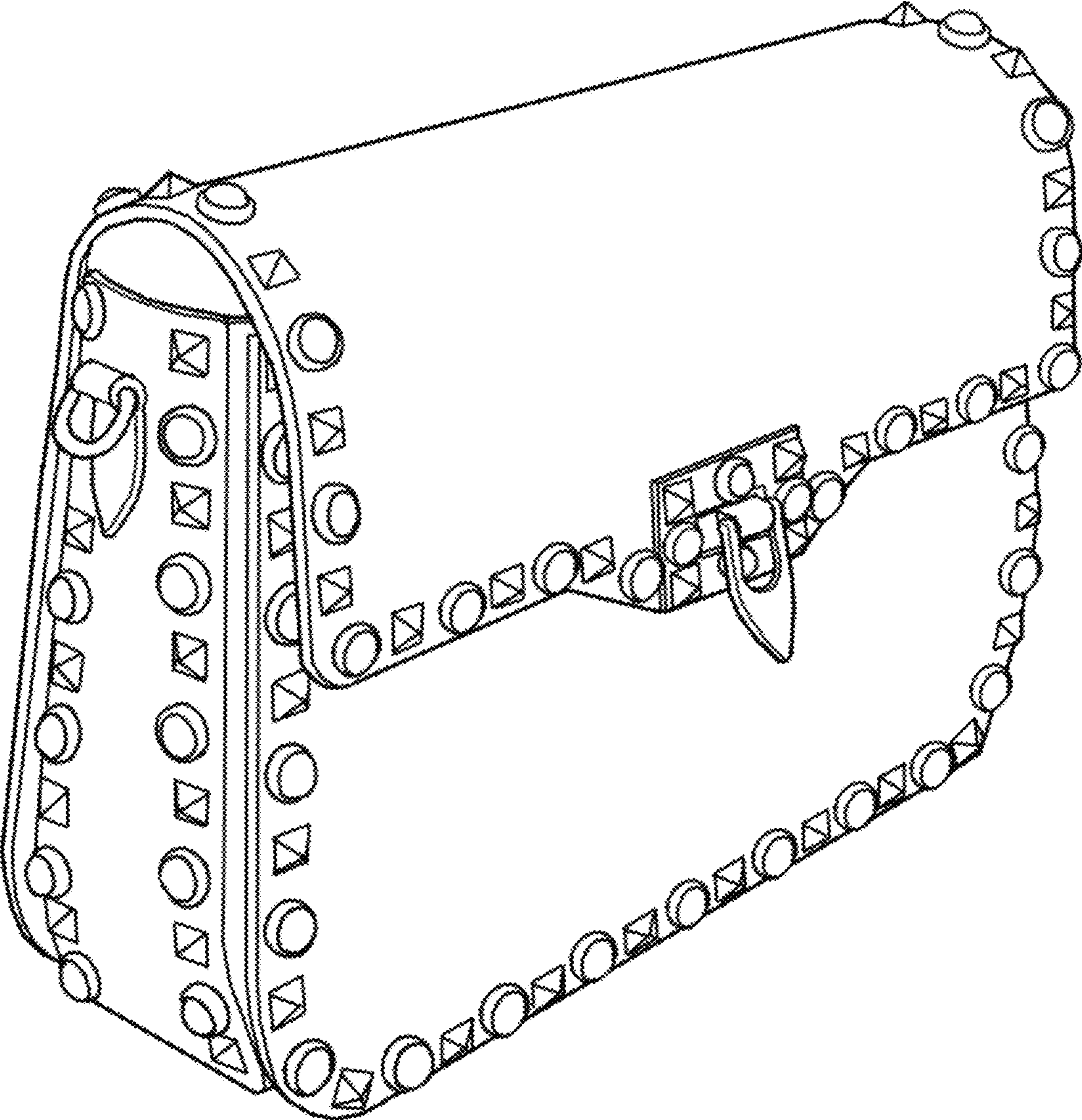
DESCRIPTION

1.7 is a bottom plan view thereof.

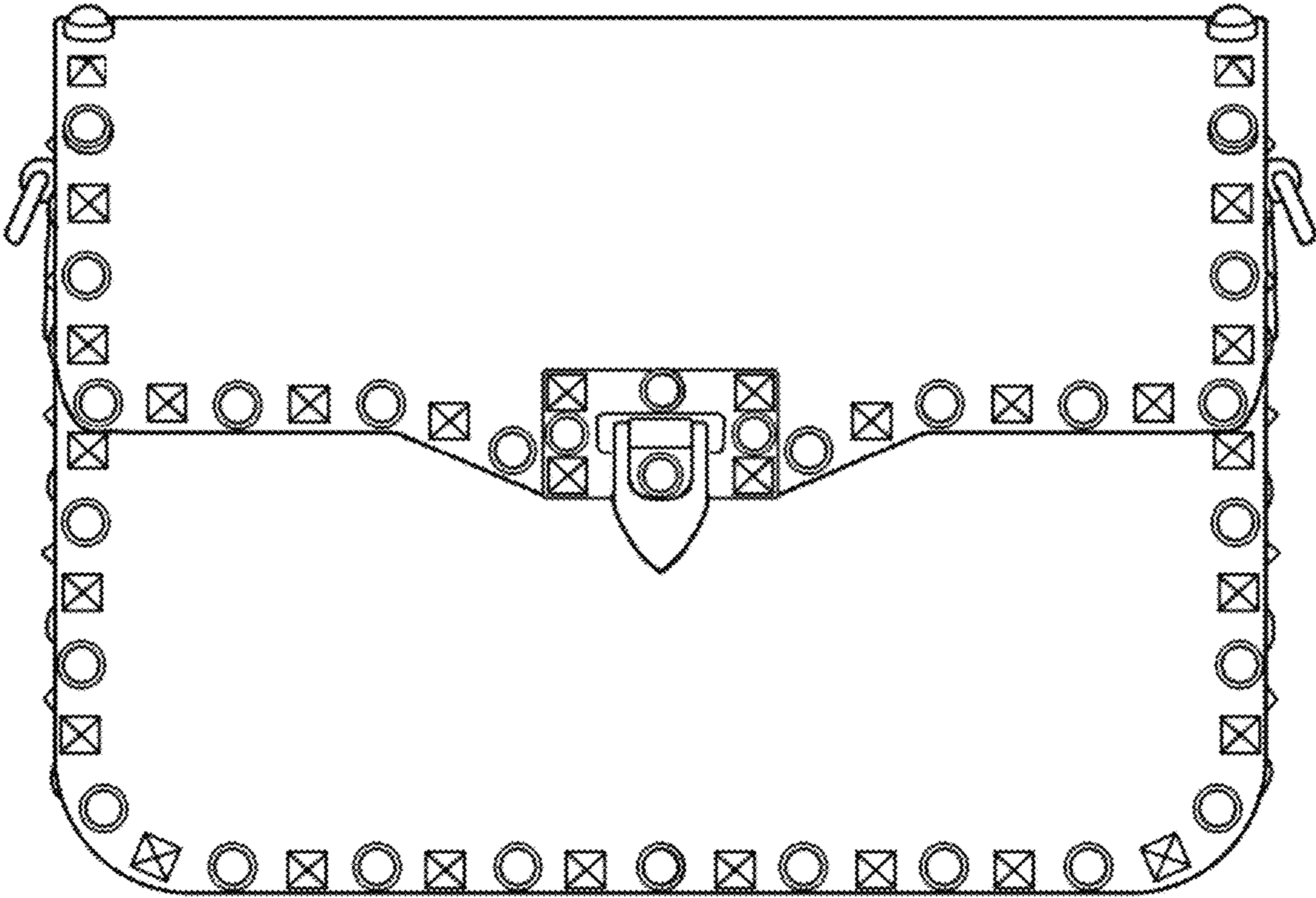

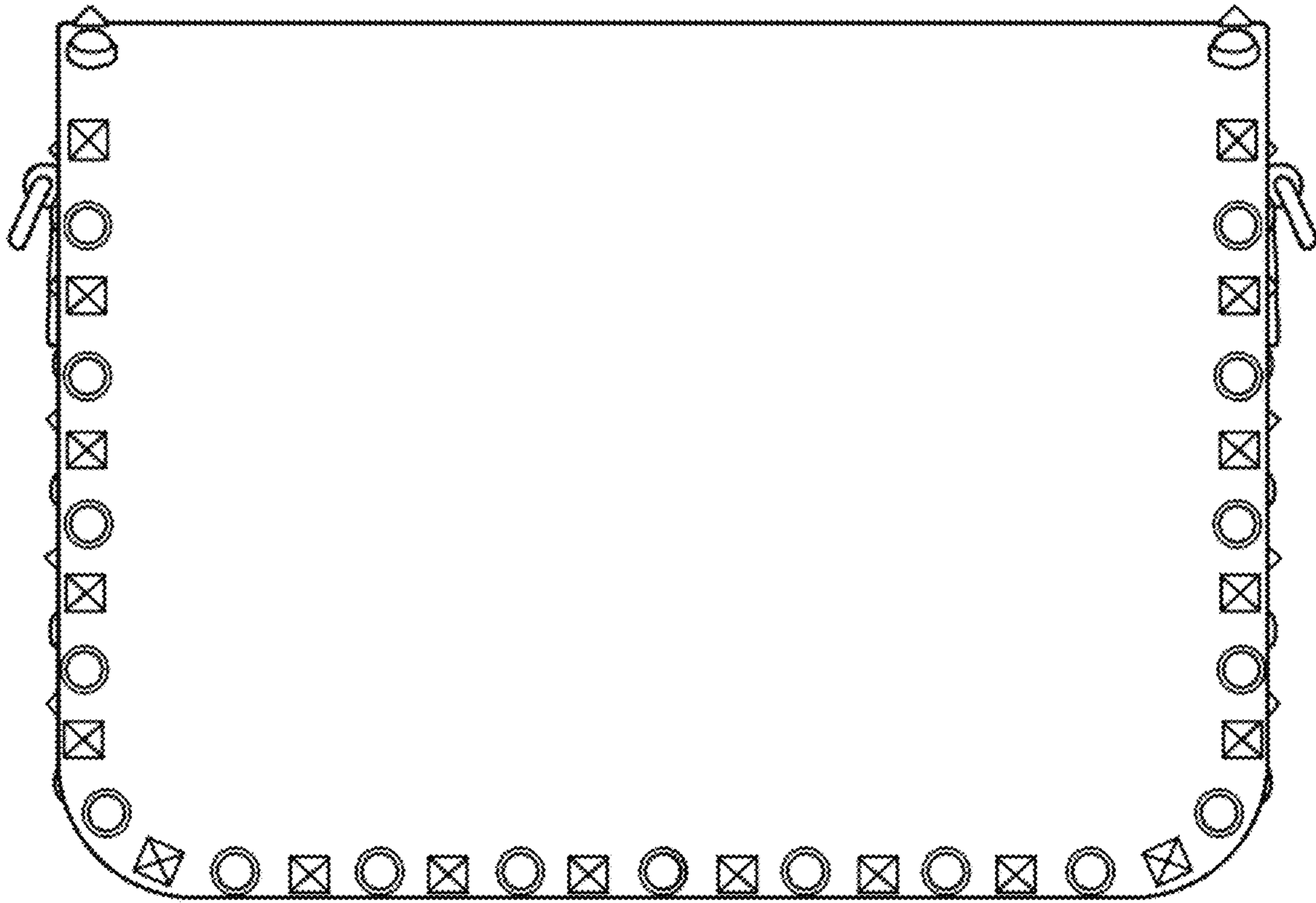

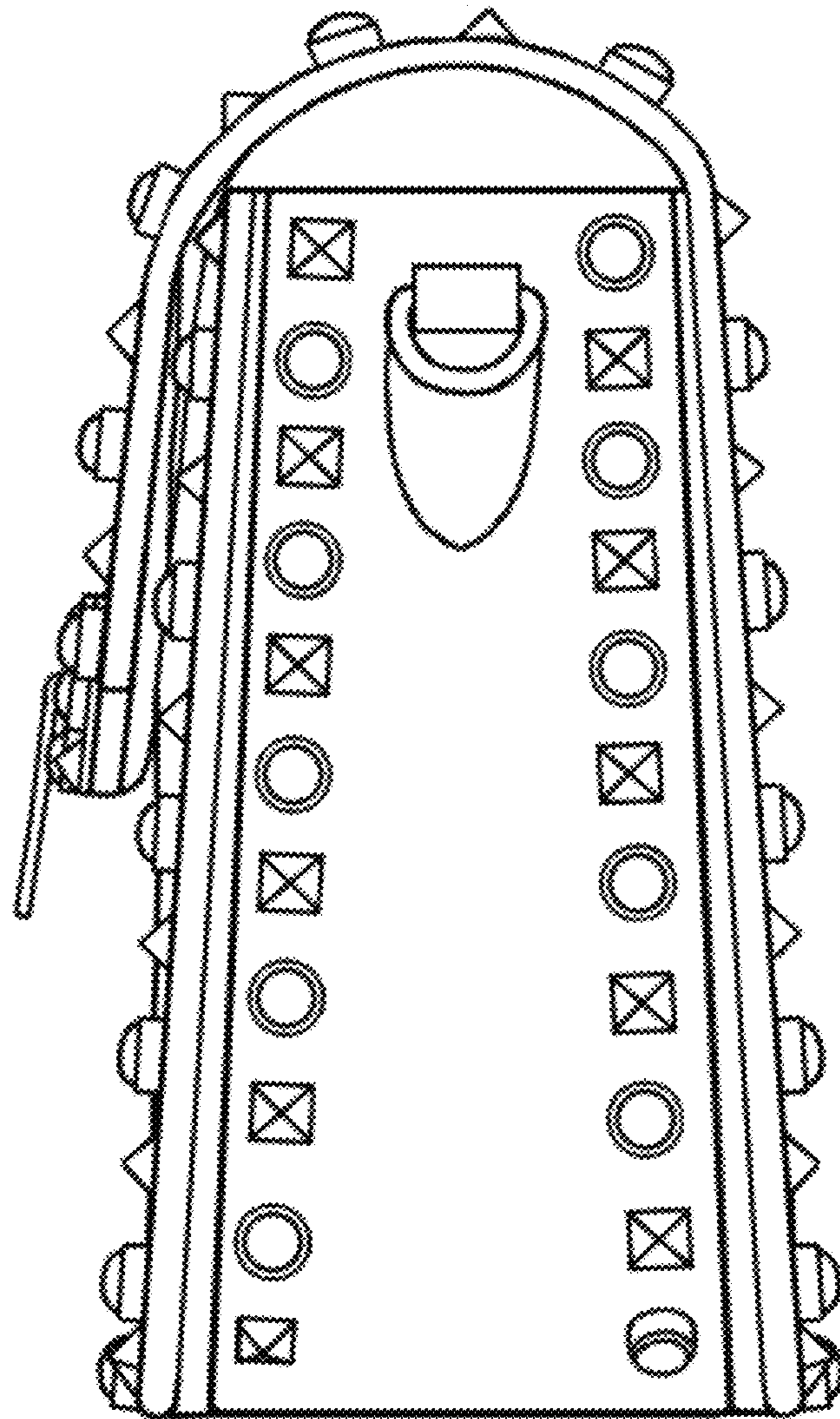

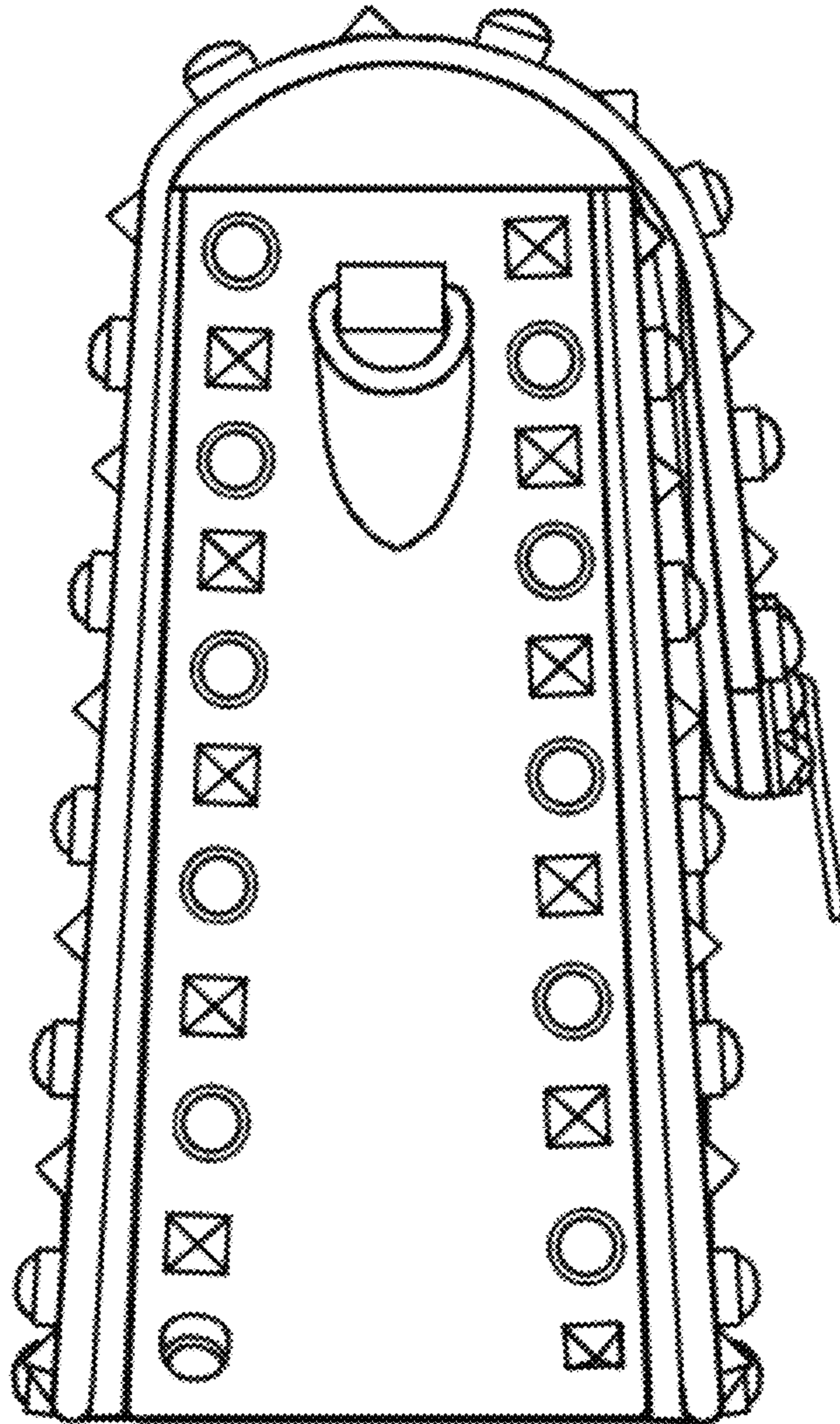

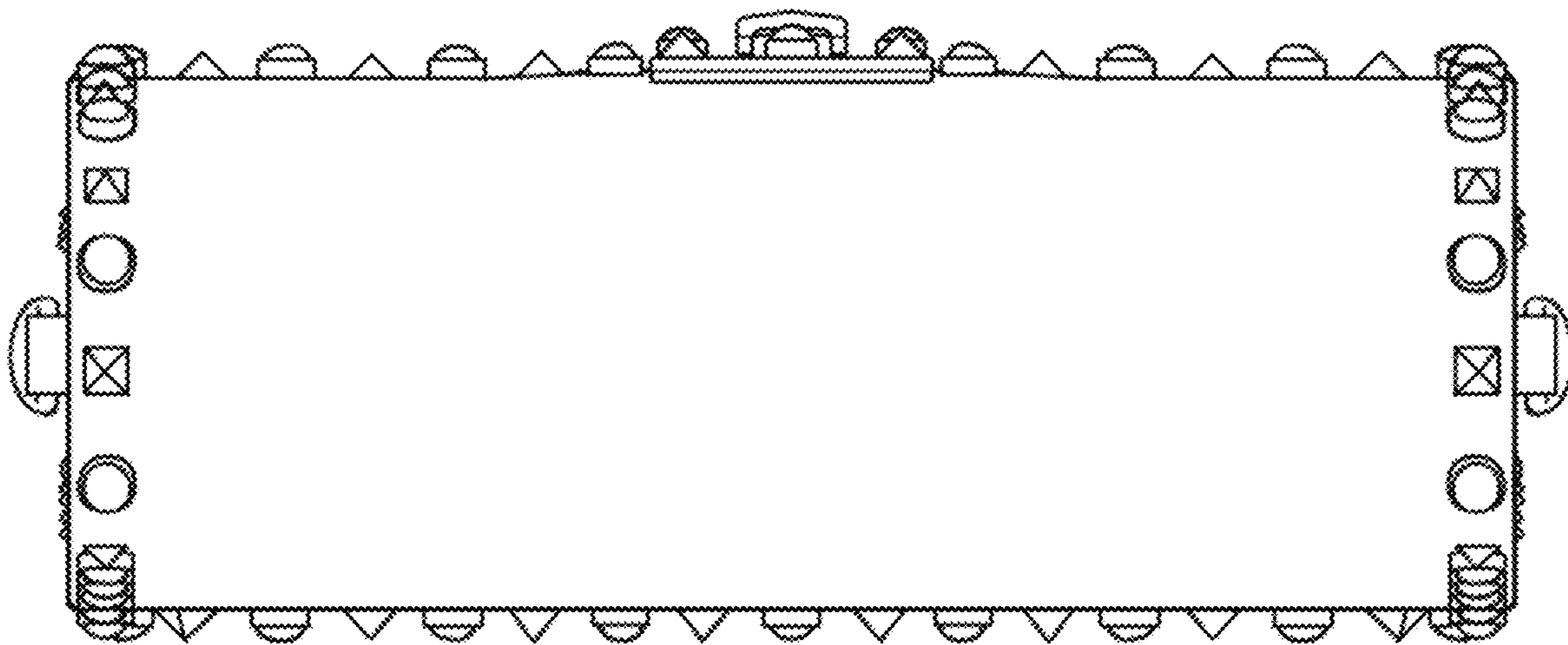
