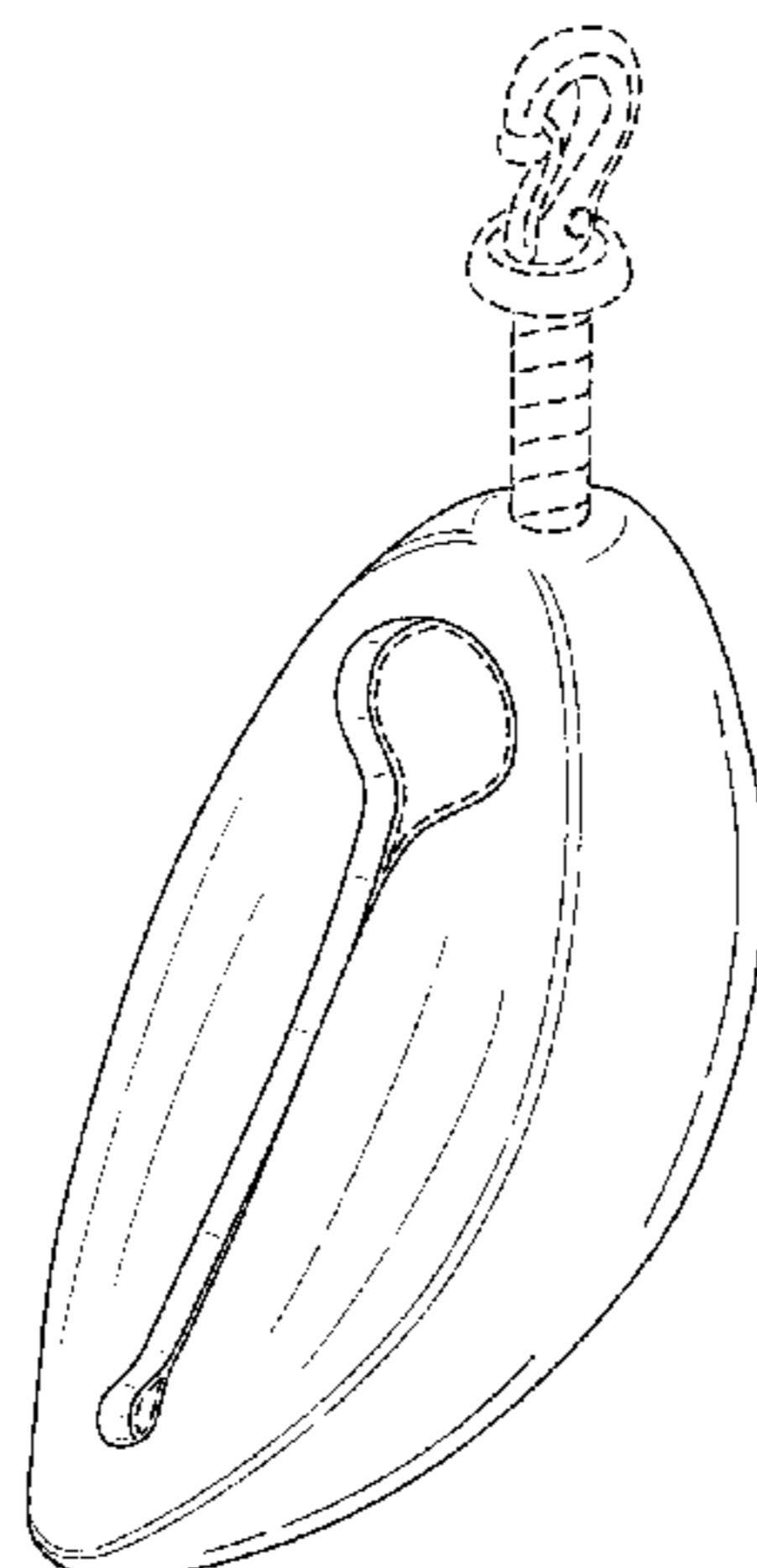


FIG. 7 is a top plan view showing the doll carrier of my invention; and,

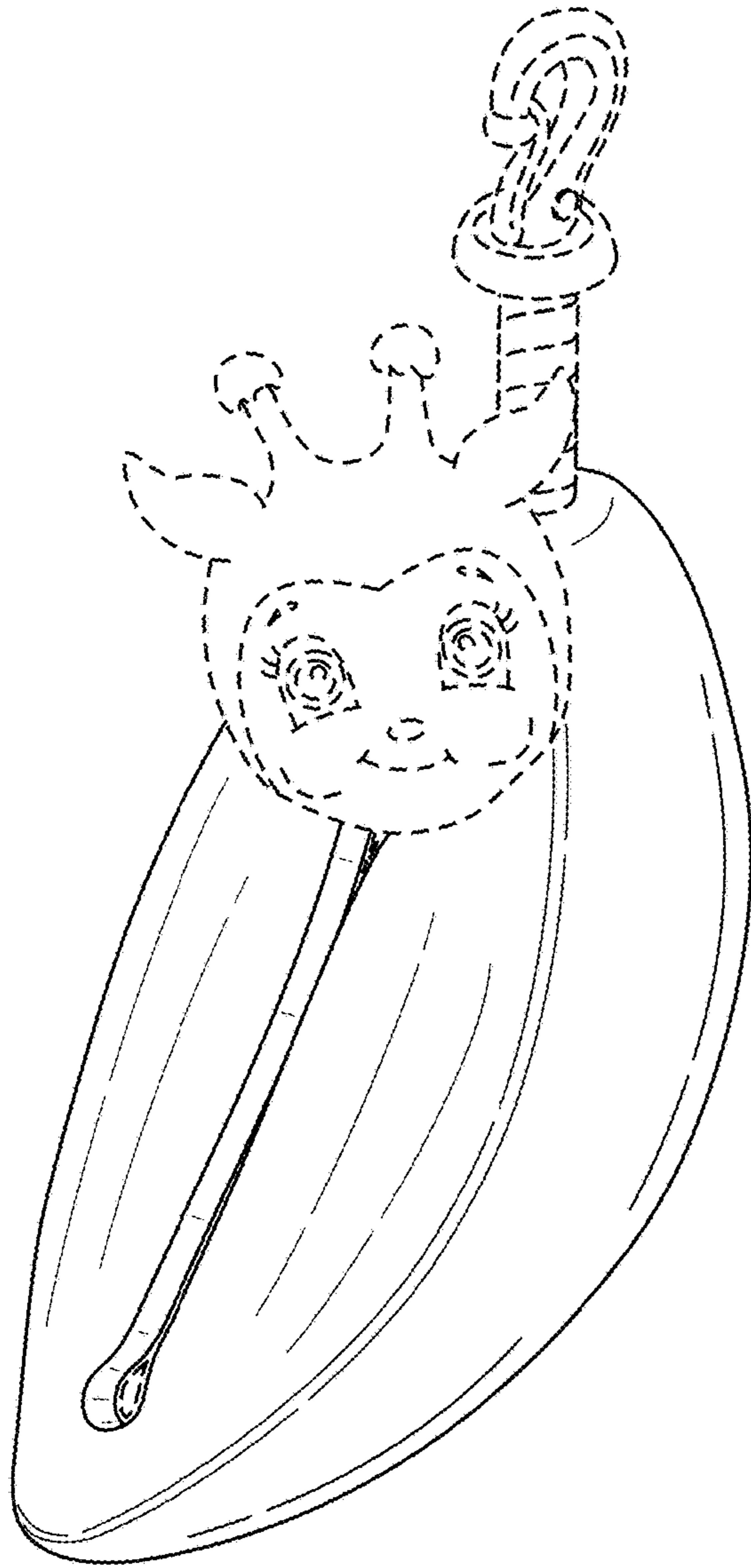

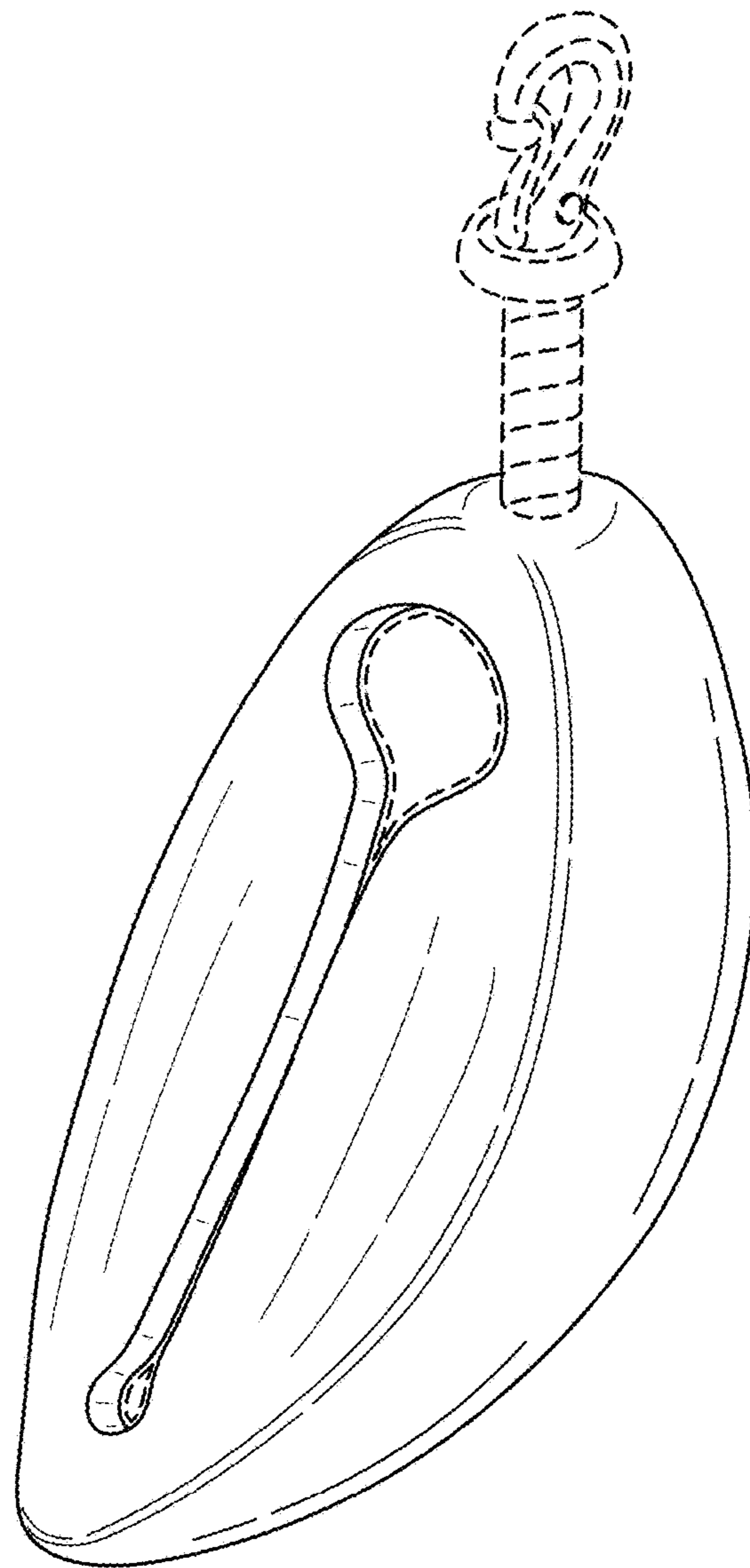

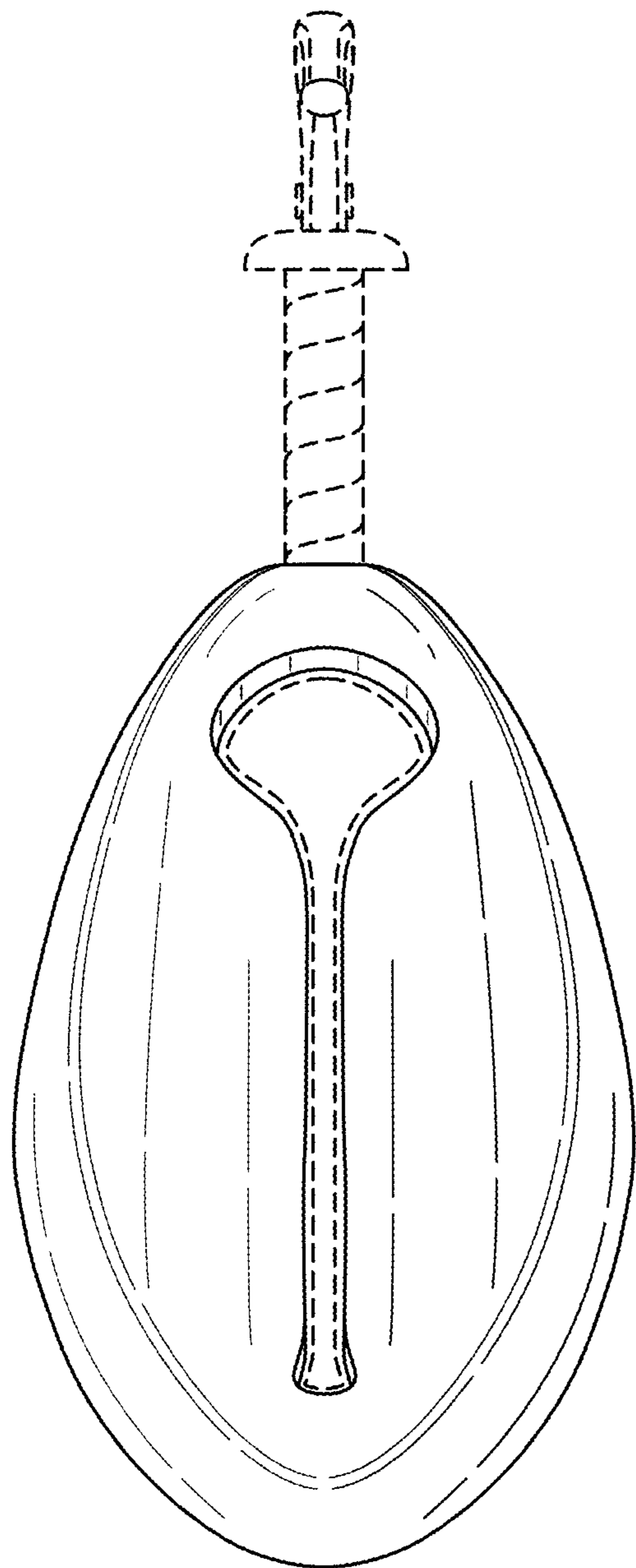

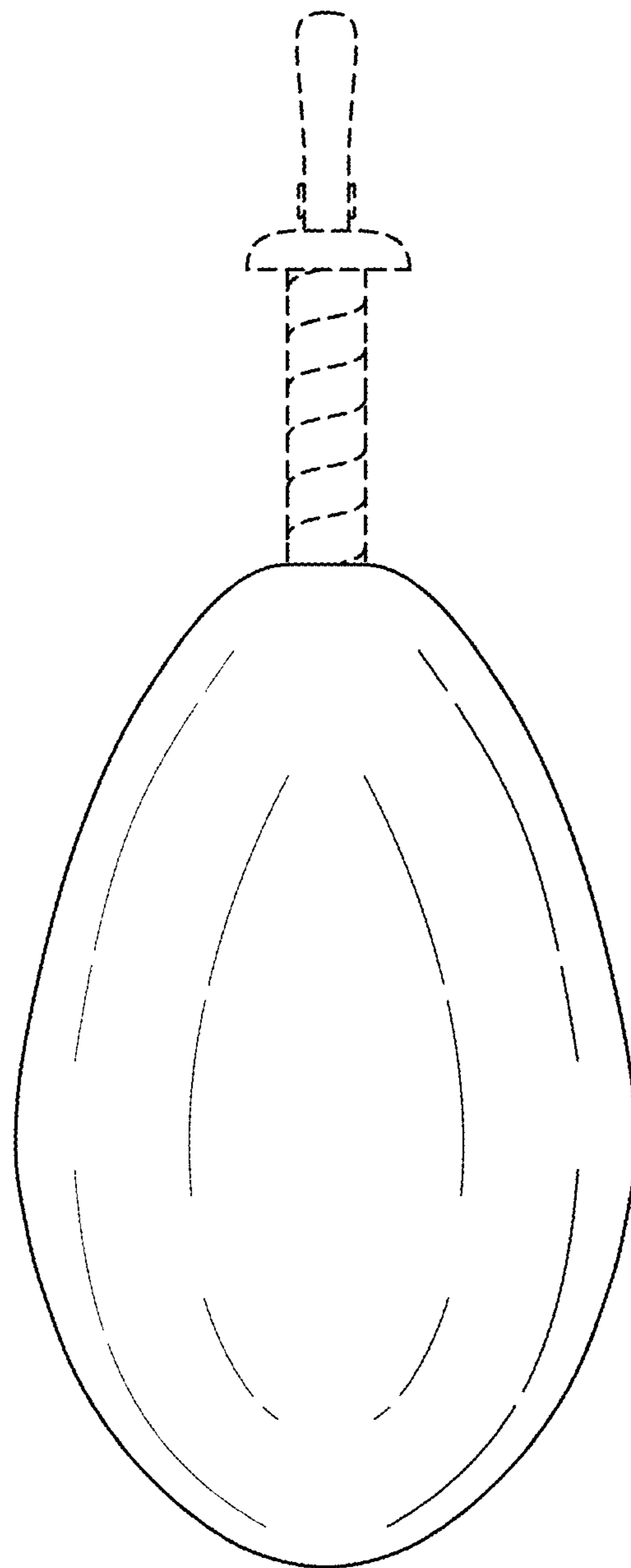

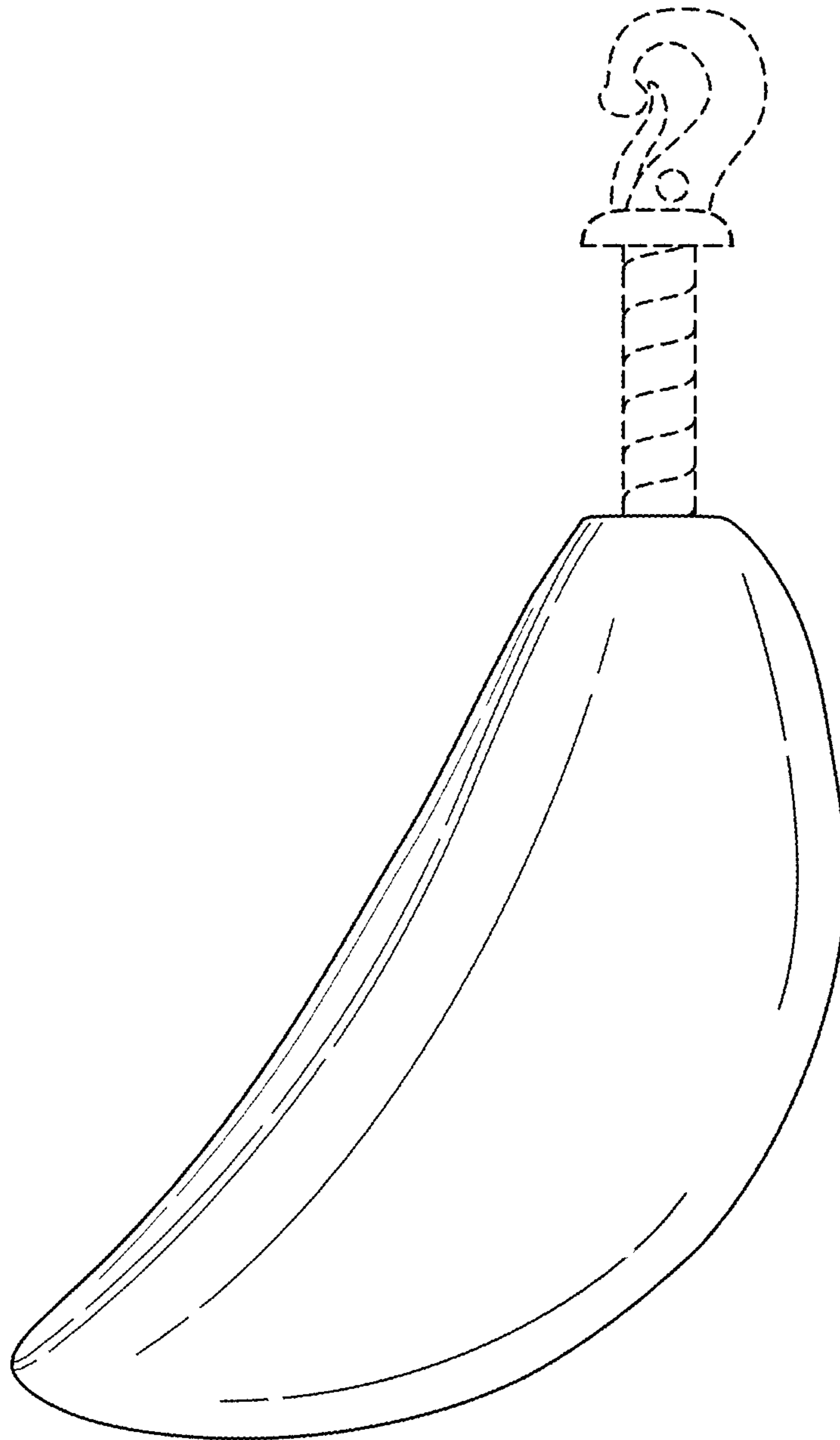

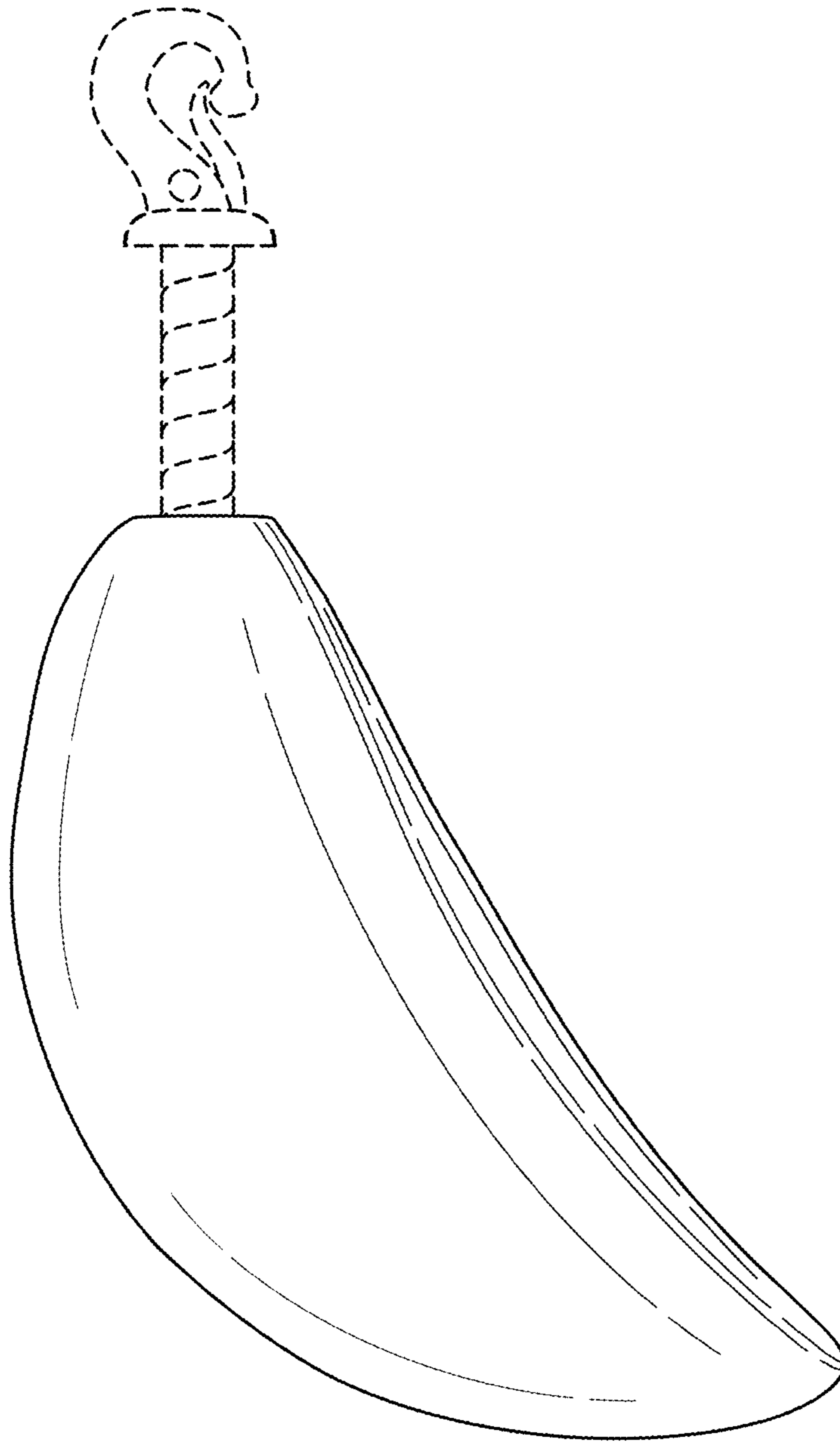

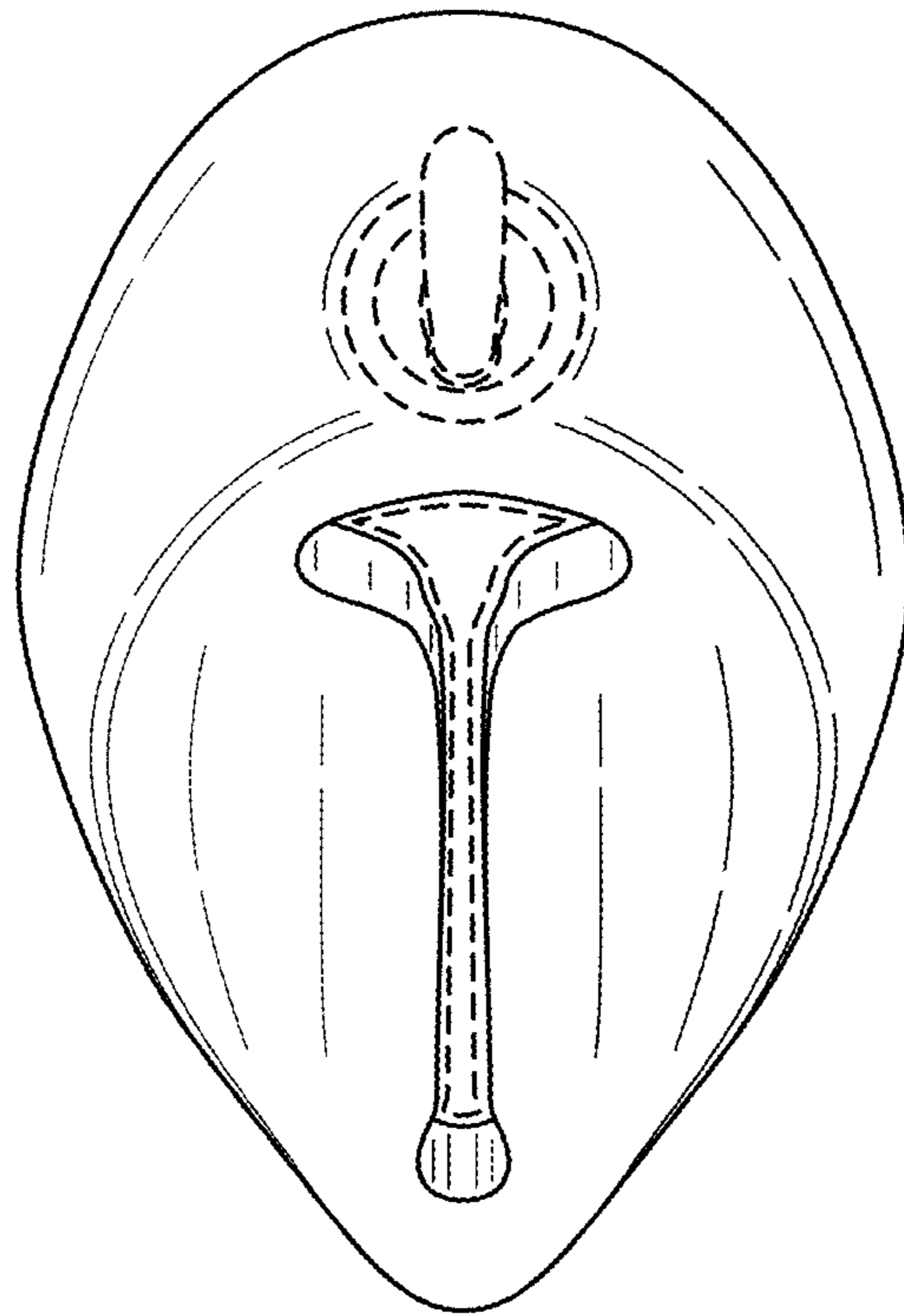

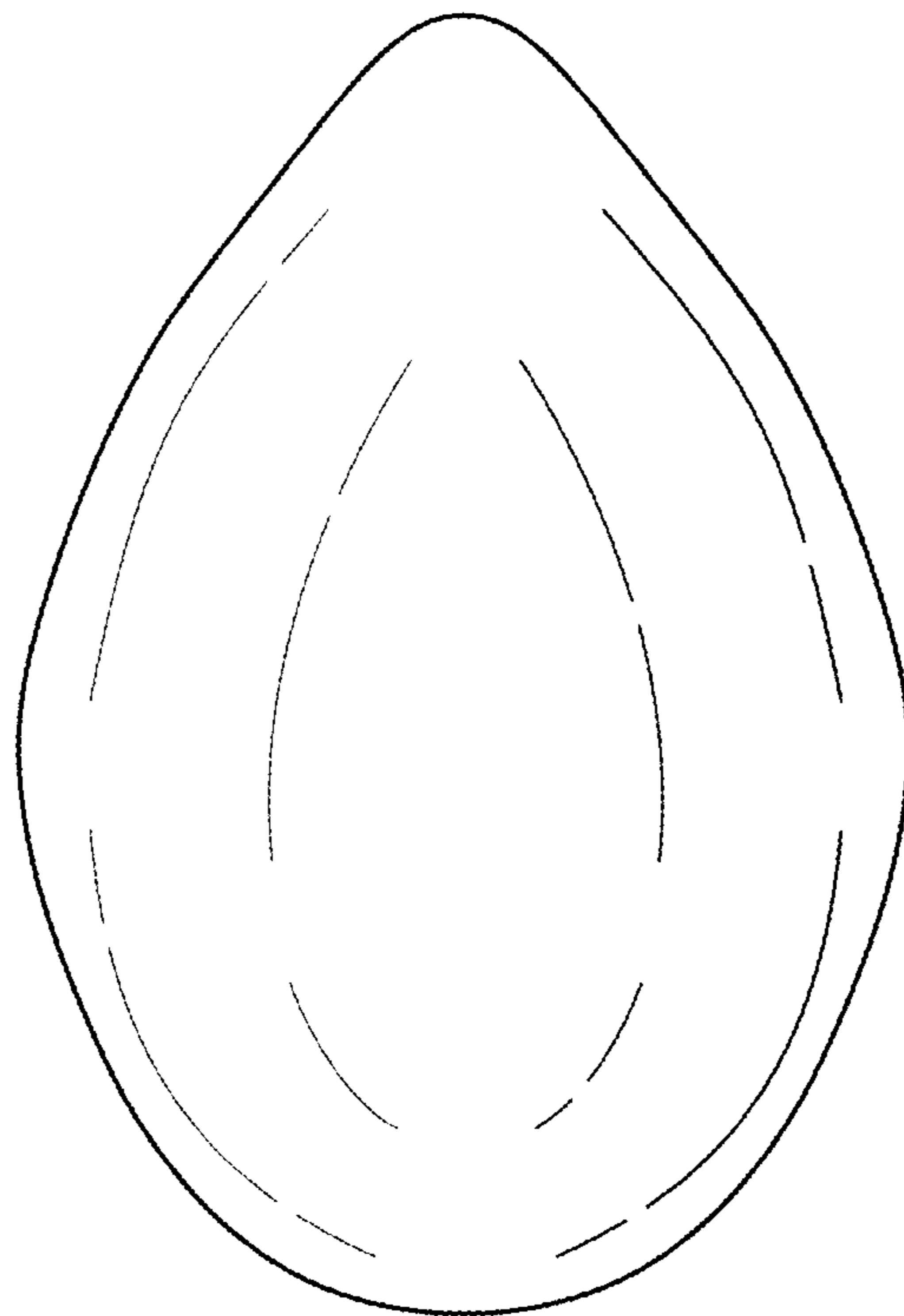
