DESCRIPTION

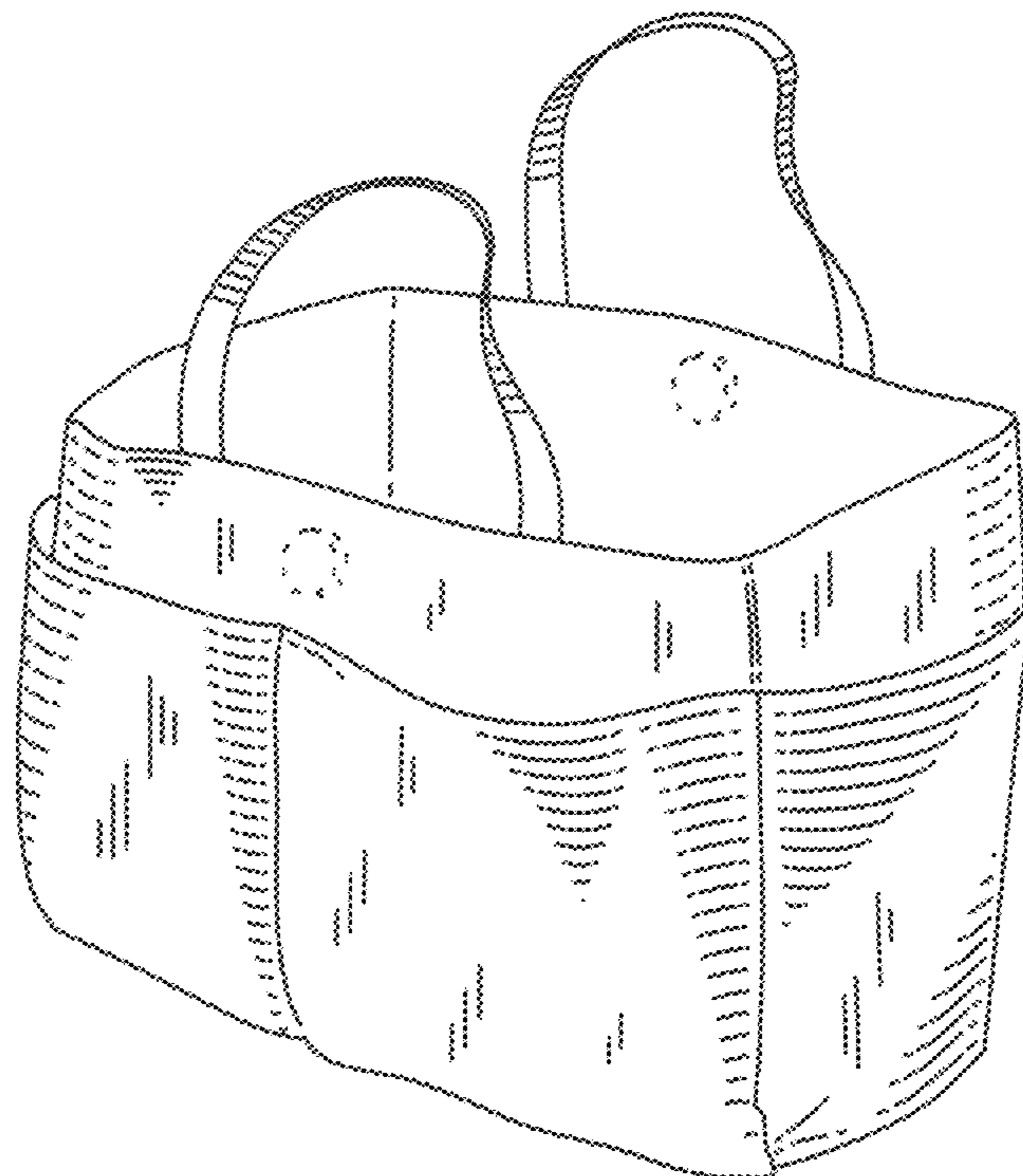

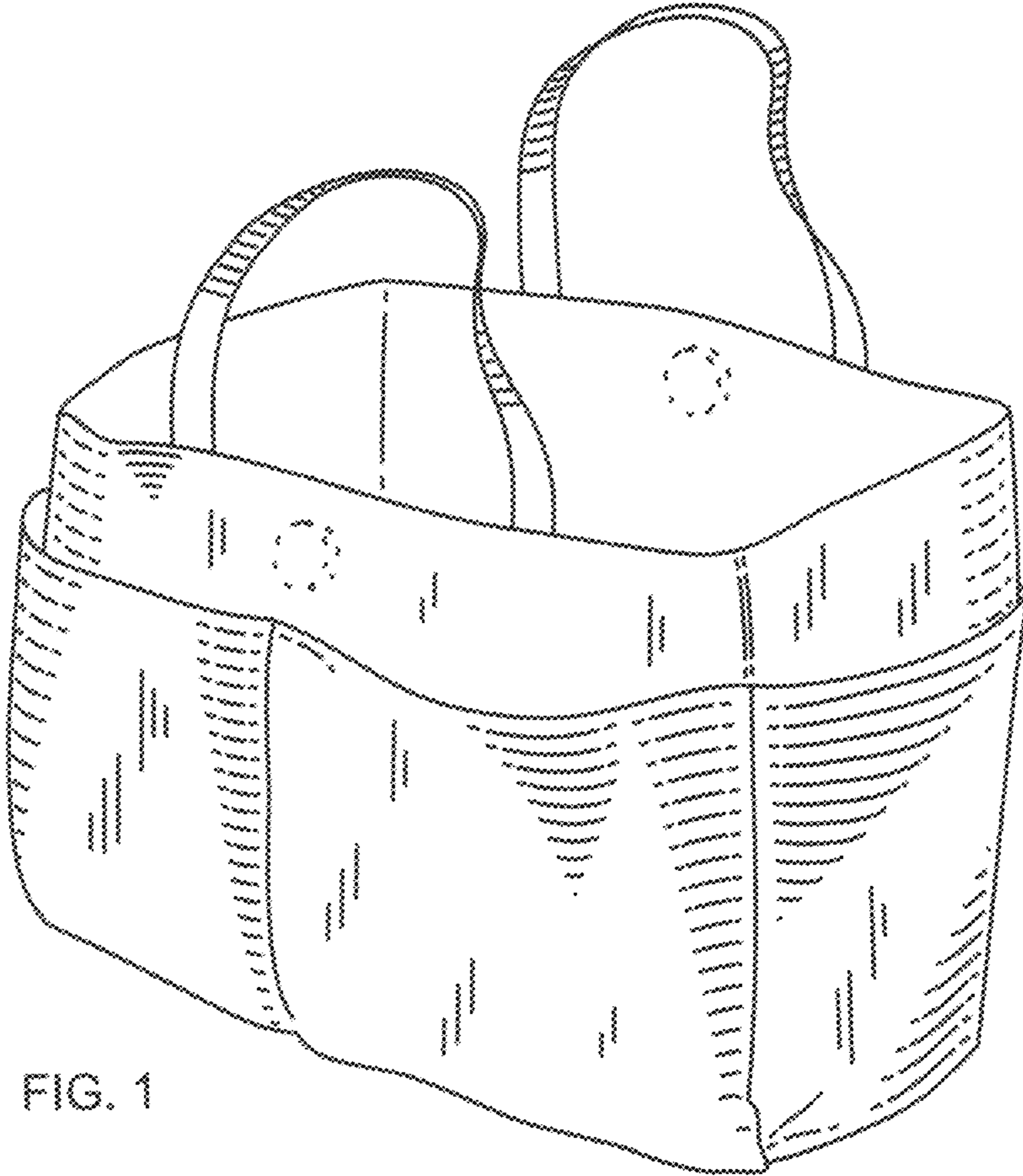

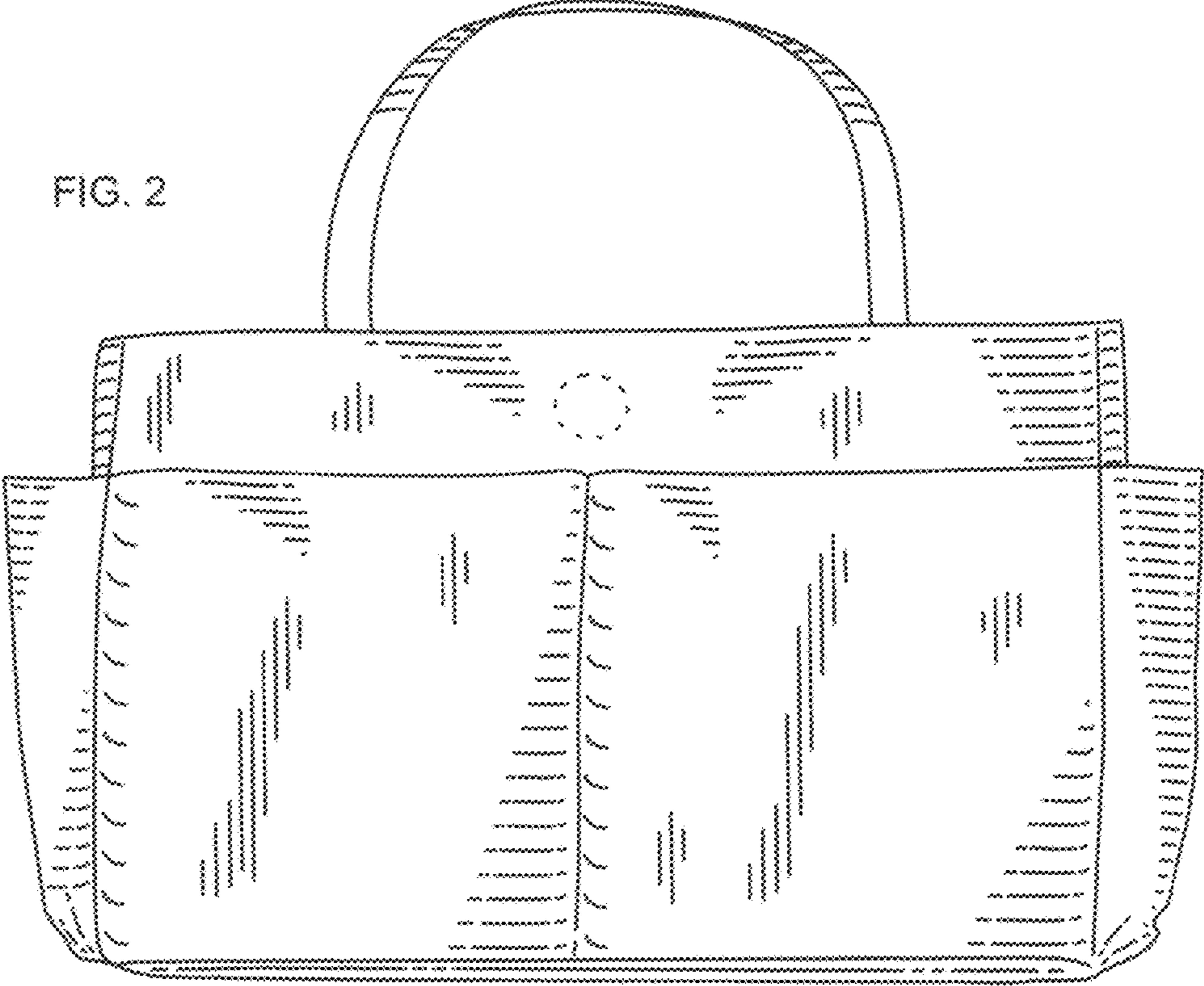
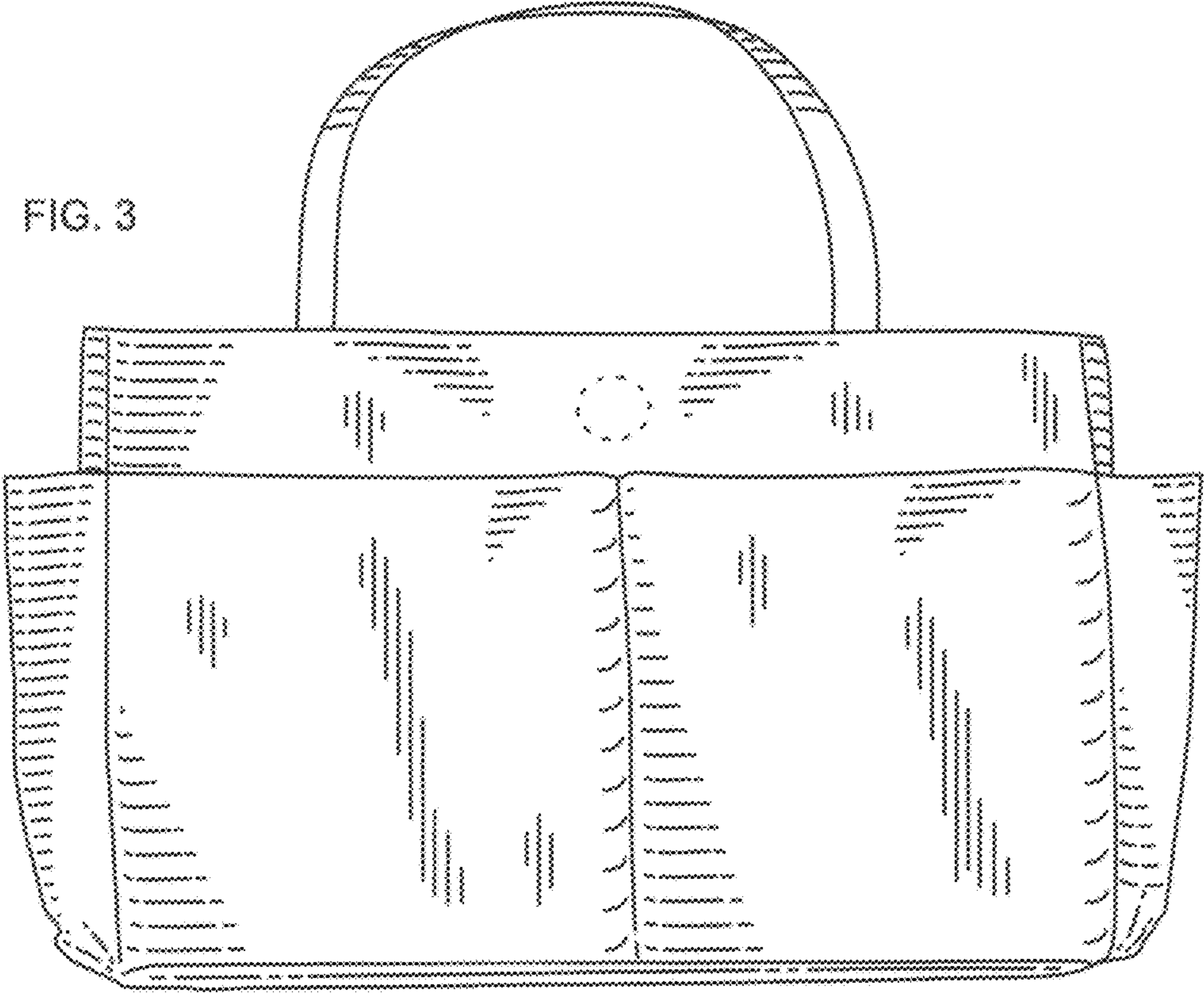

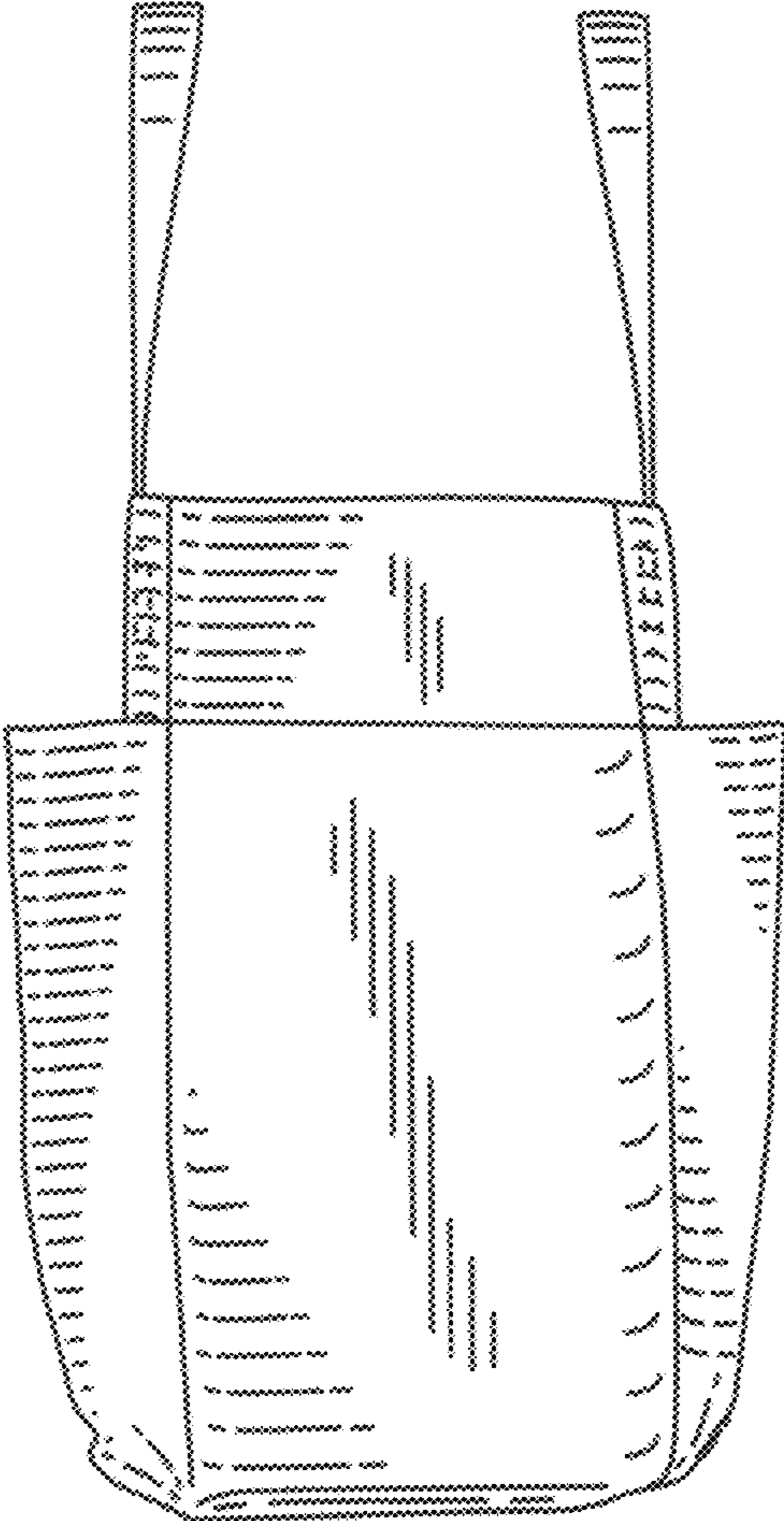

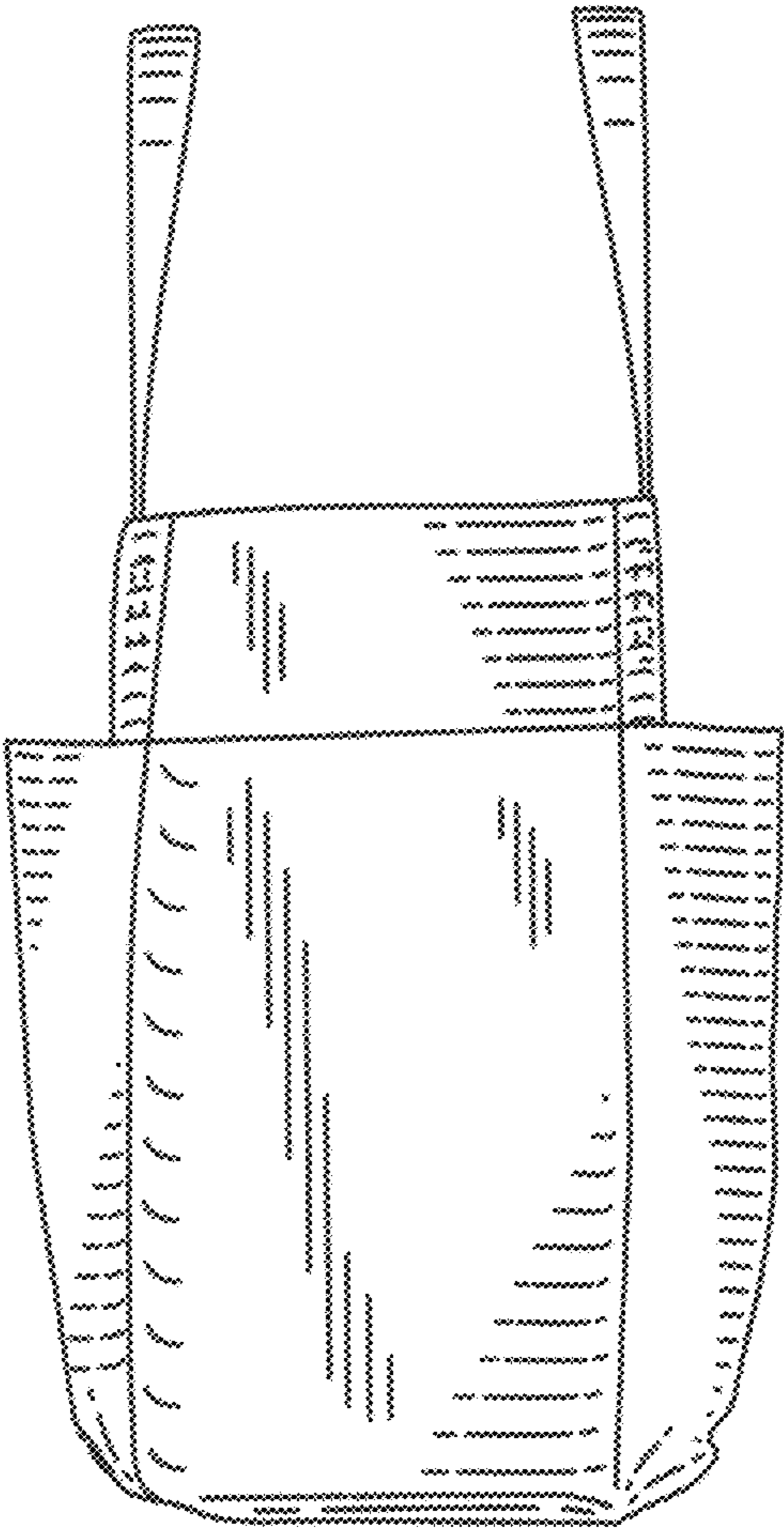

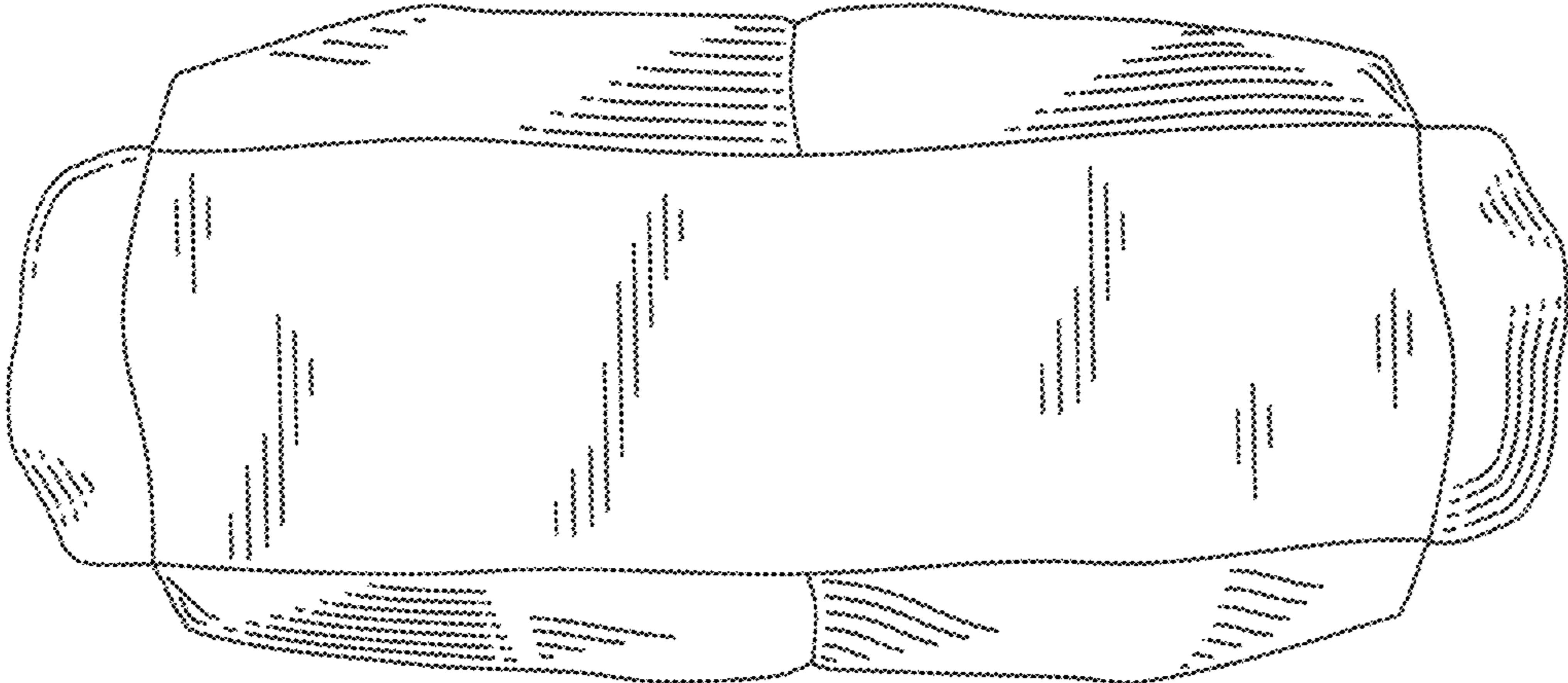
